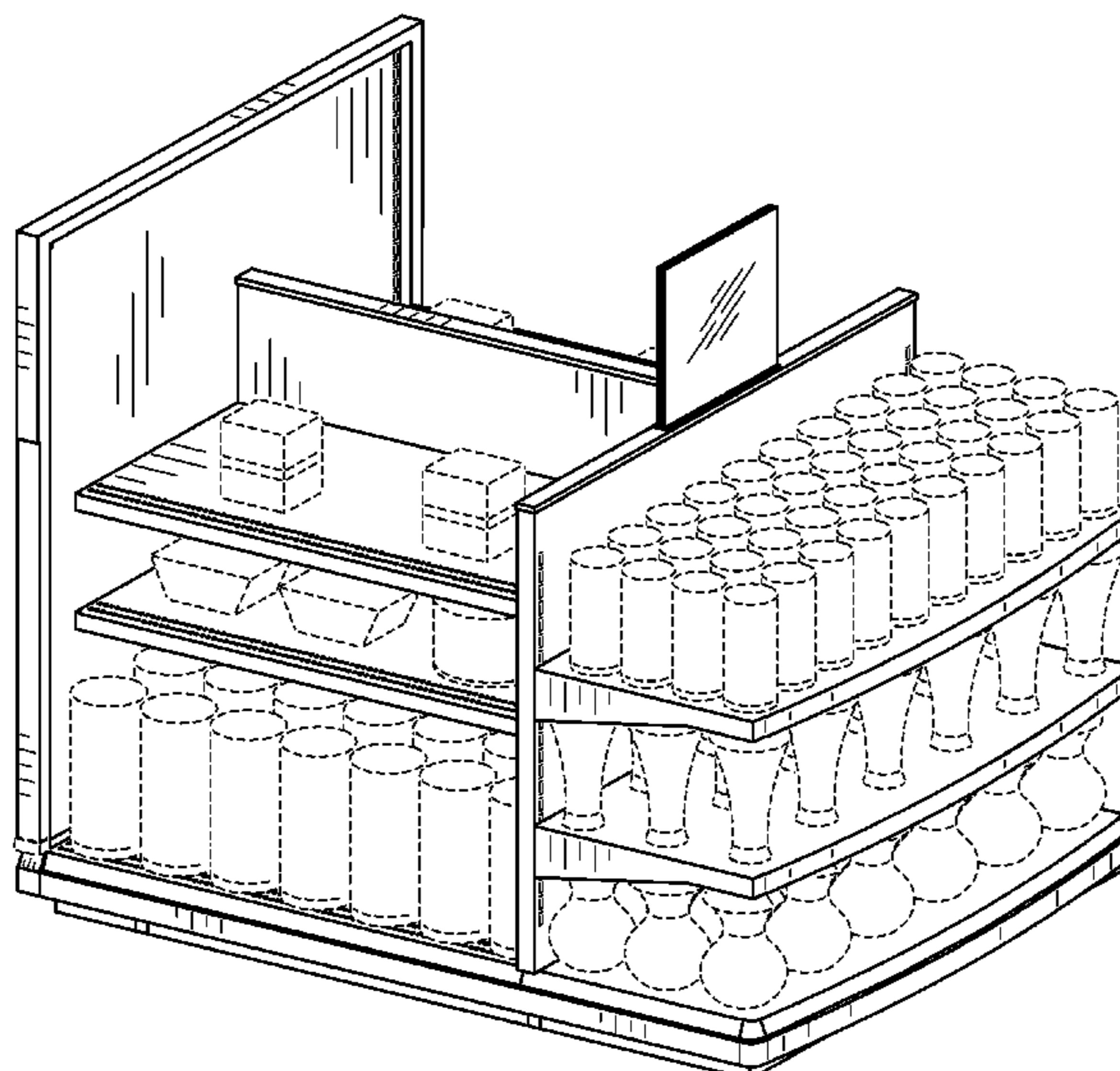
(57) **CLAIM**

The ornamental design for a display fixture, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a display fixture.  
 FIG. 2 is a front elevation of the display fixture of FIG. 1.  
 FIG. 3 is a rear elevation of the display fixture of FIG. 1.  
 FIG. 4 is a left elevation view of the display fixture of FIG. 1.  
 FIG. 5 is a right elevation view of the display fixture of FIG. 1.  
 FIG. 6 is a top plan view of the display fixture of FIG. 1.  
 FIG. 7 is a bottom plan view of the display fixture of FIG. 1; and,  
 FIG. 8 is another perspective view of the display fixture of FIG. 1 shown without environmental structure. The shelving units on both sides of the display fixture are symmetrical with respect to shape, configuration and ornamental design. The broken lines showing is included for the purpose of illustrating environment and forms no part of the claimed design.

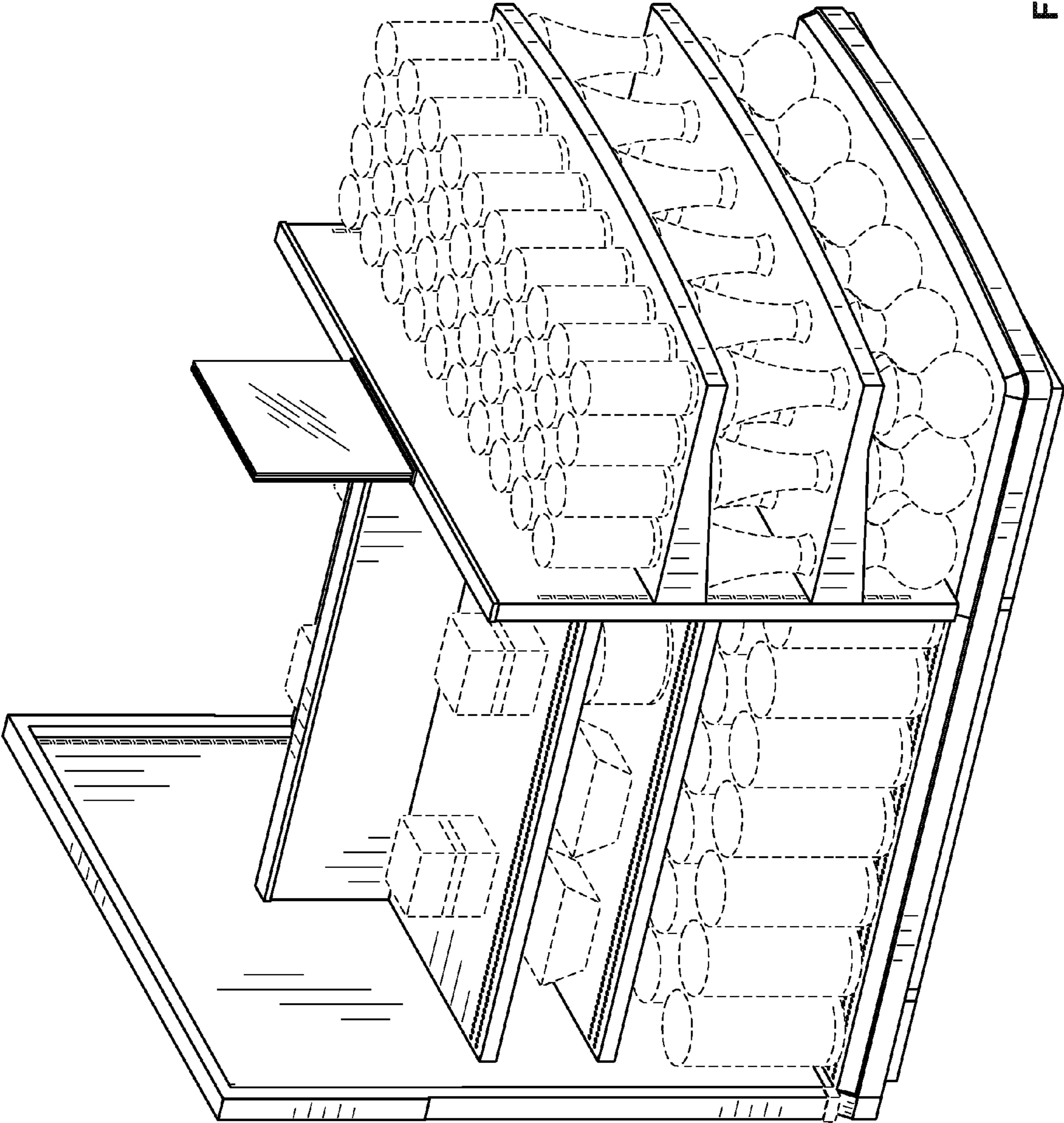

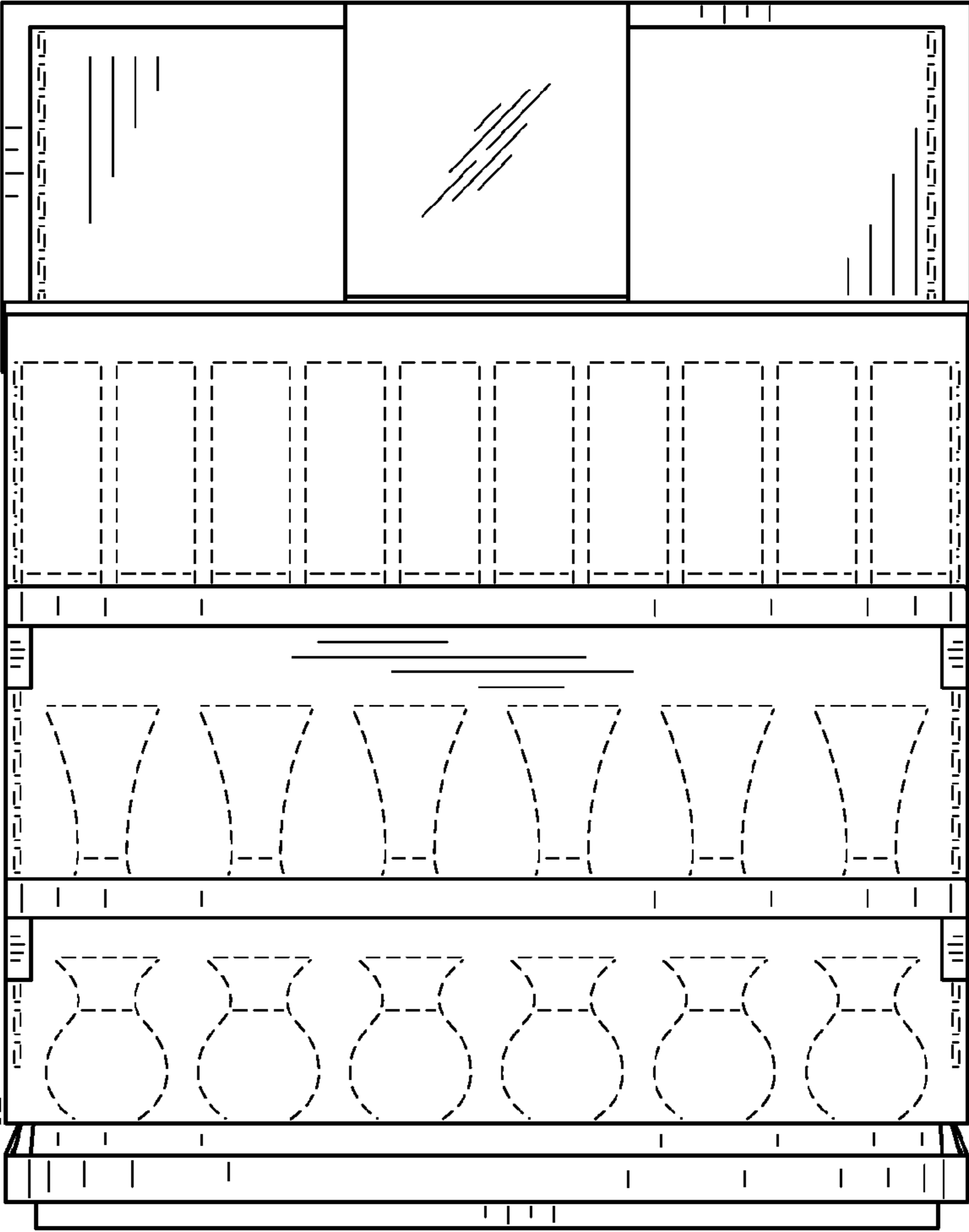

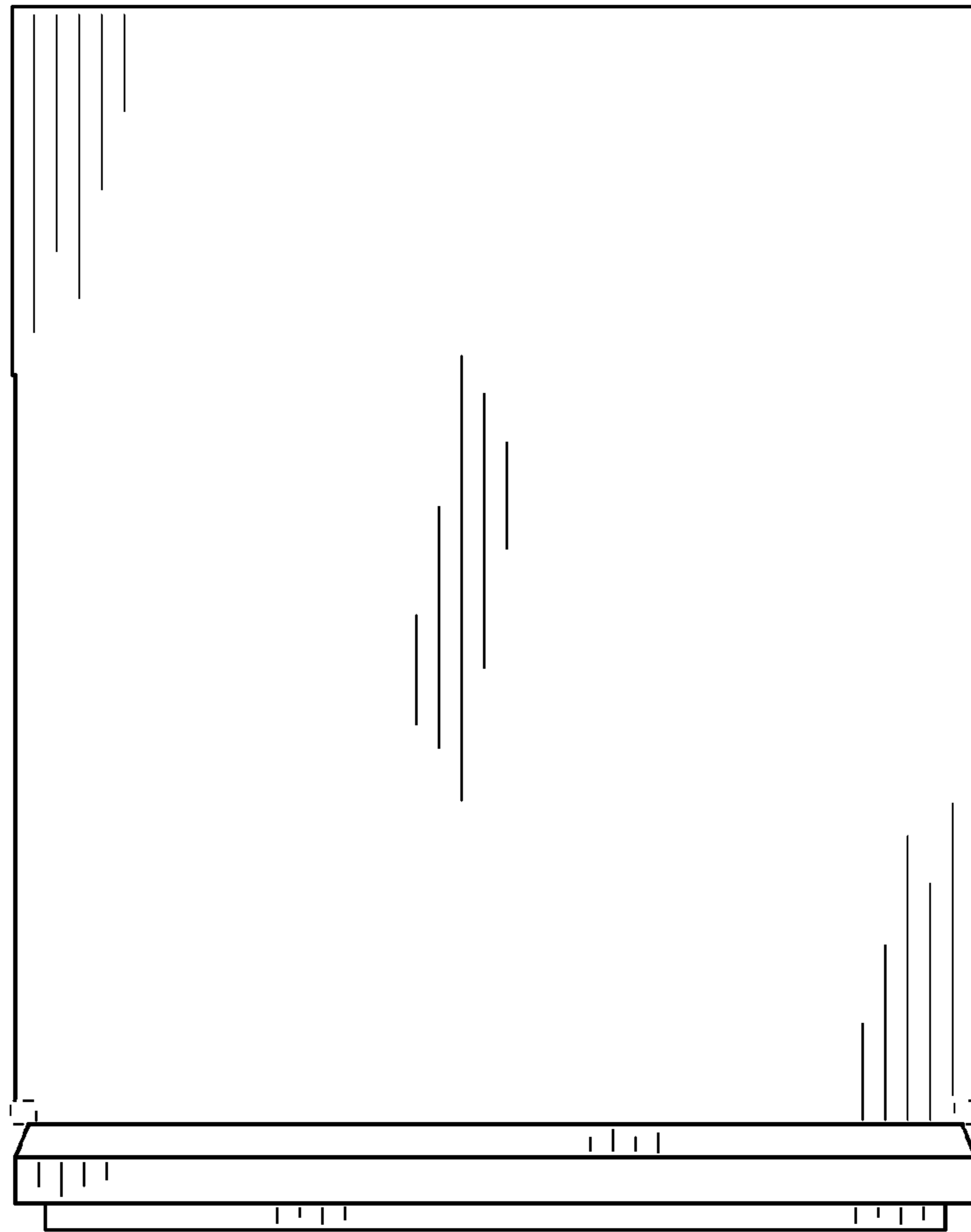

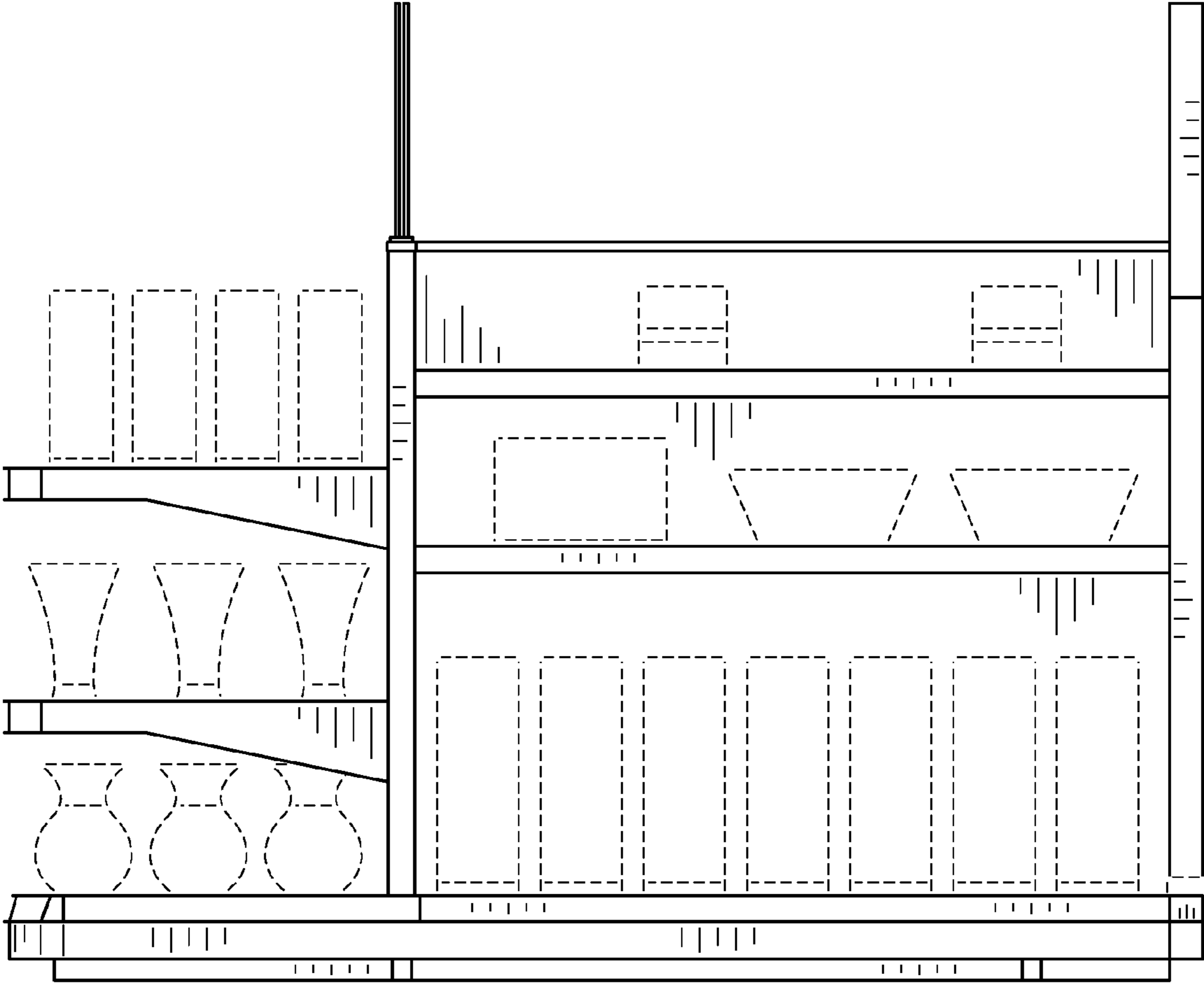

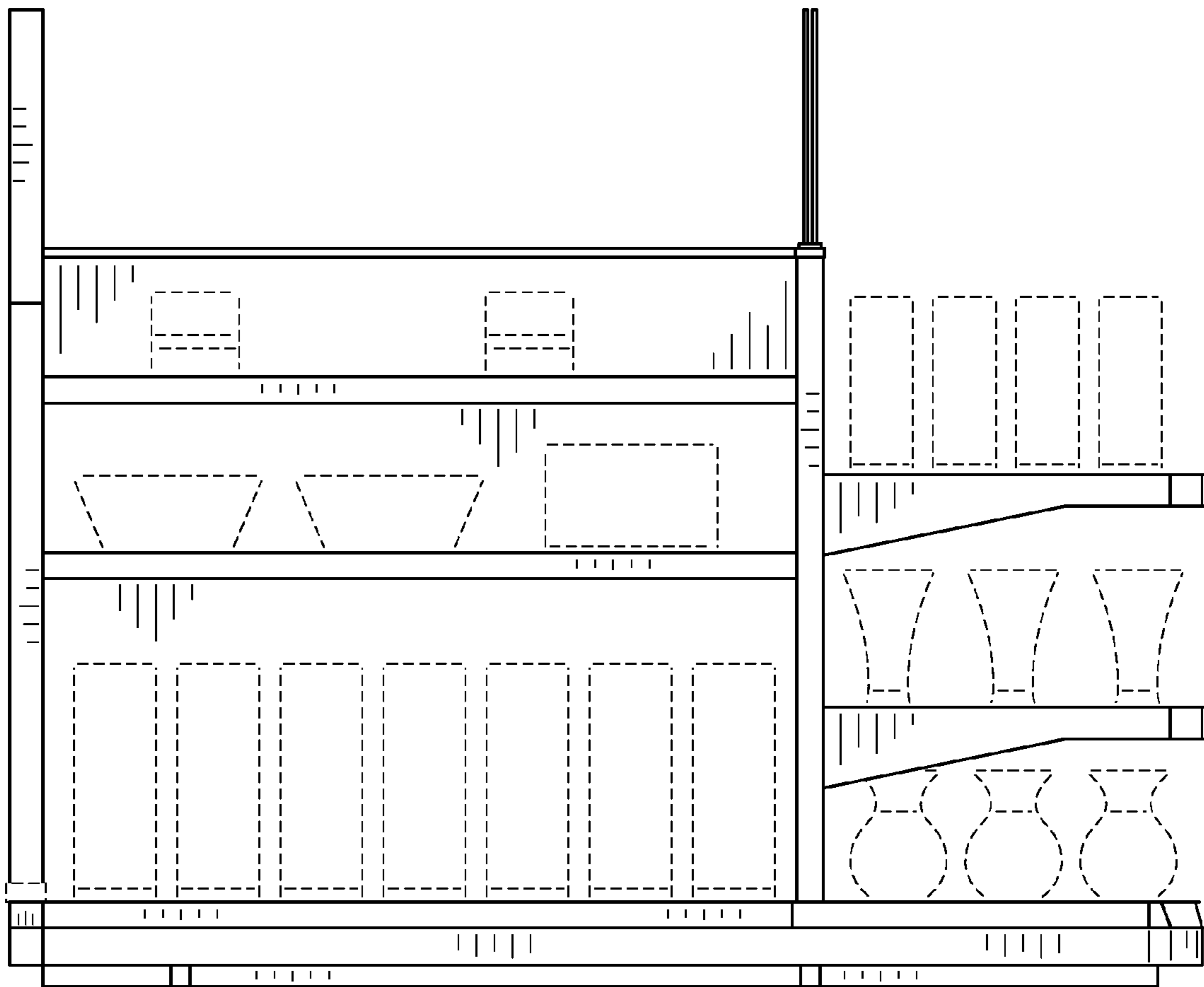

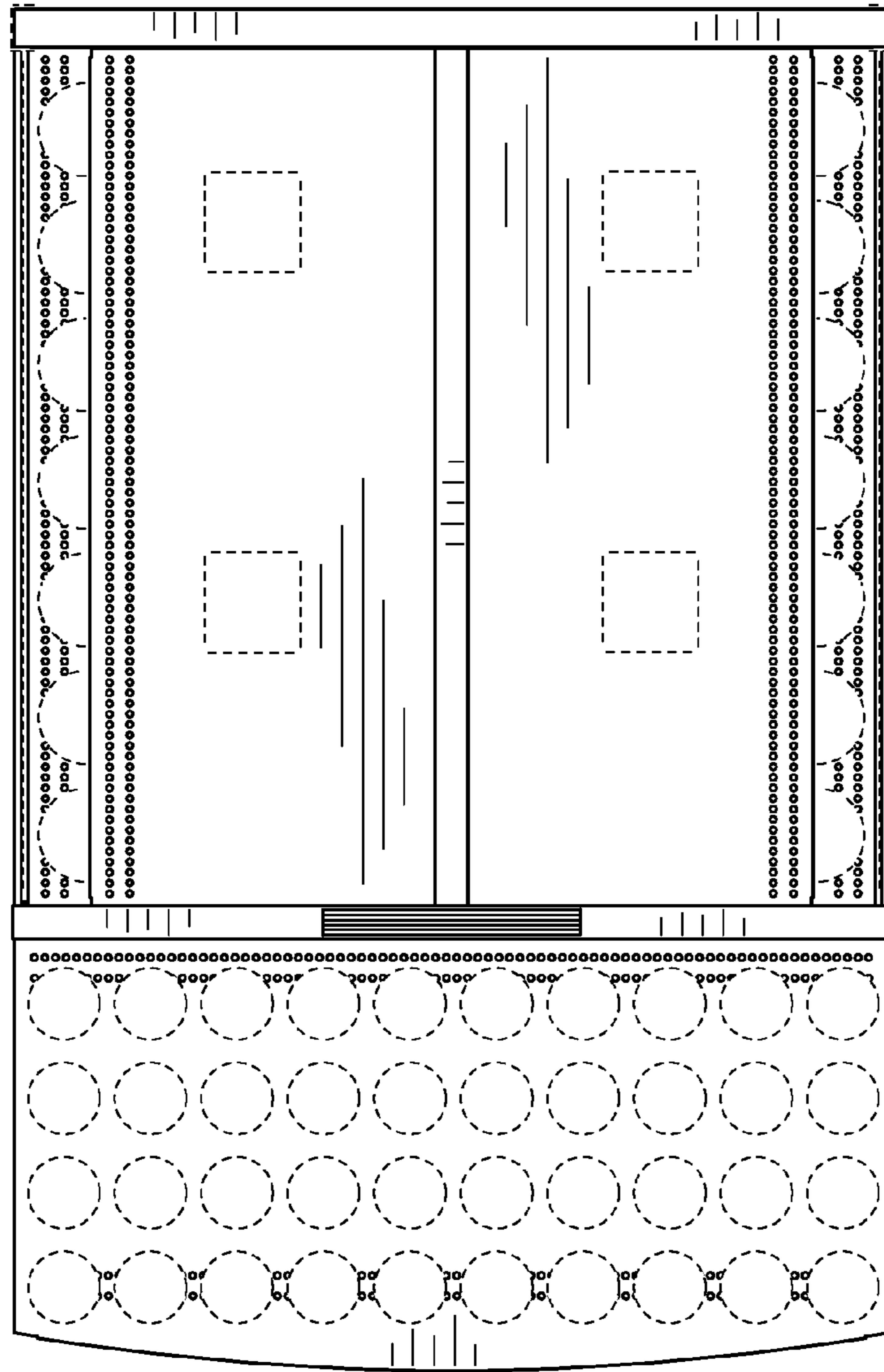

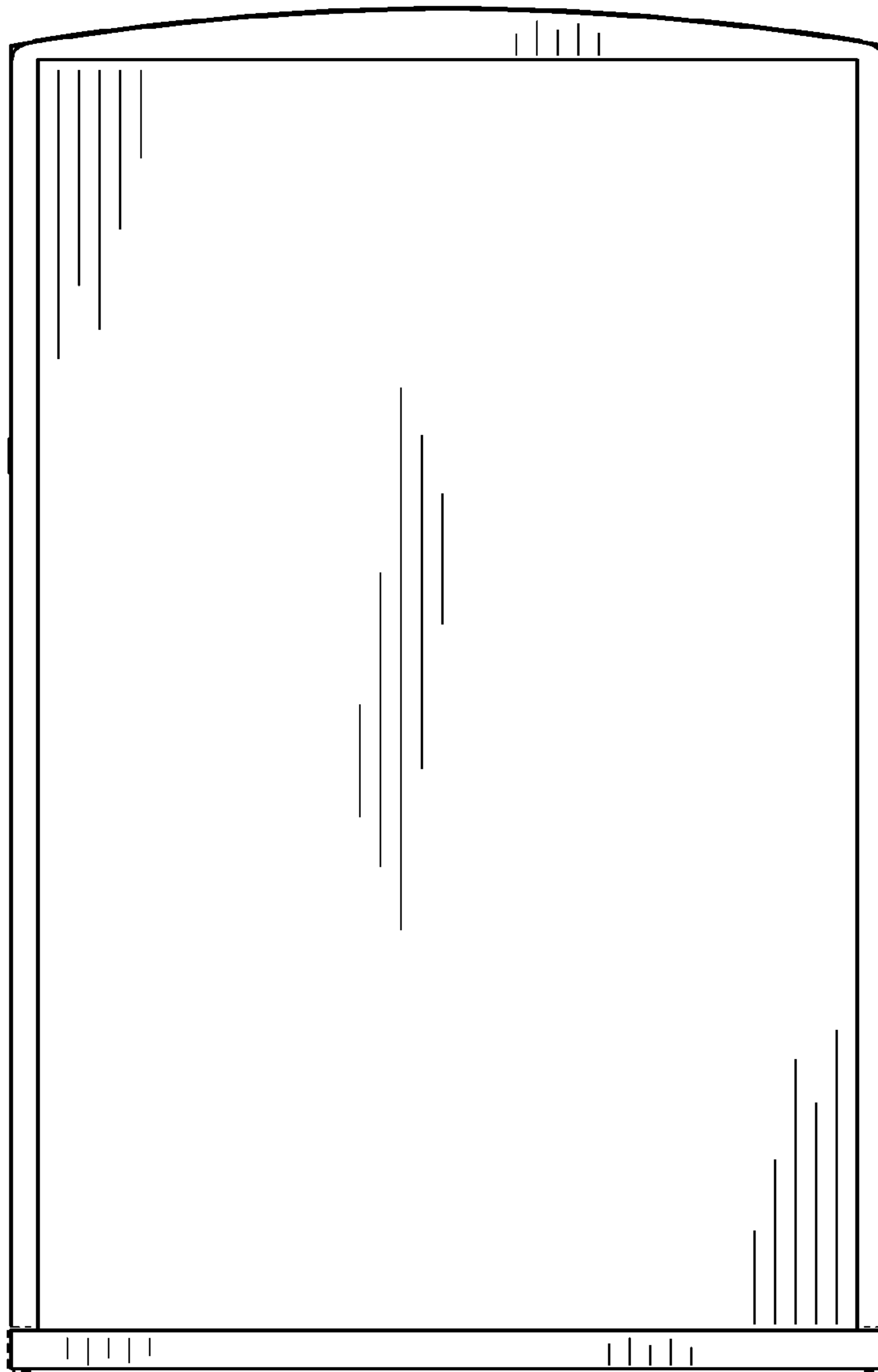

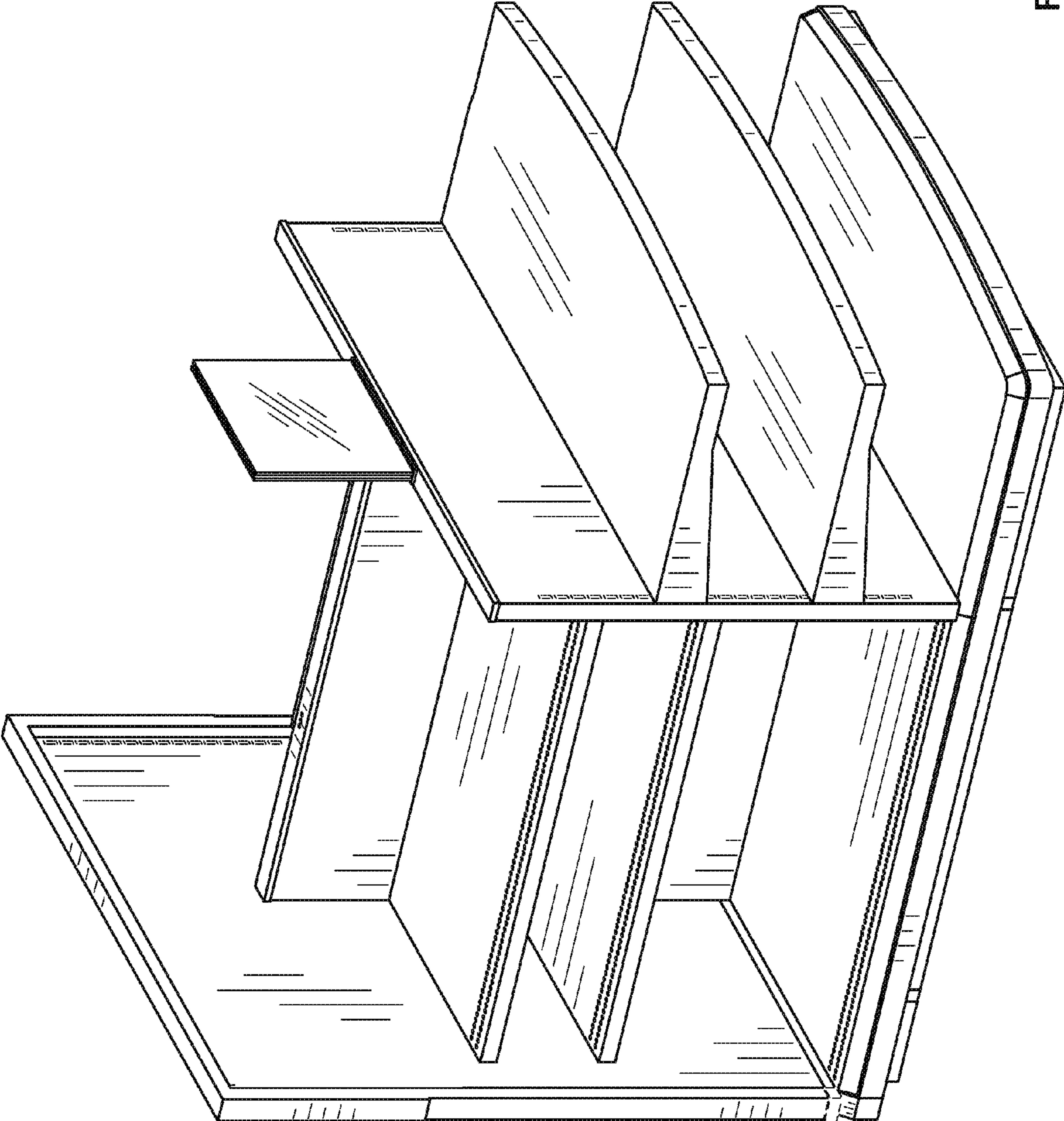
