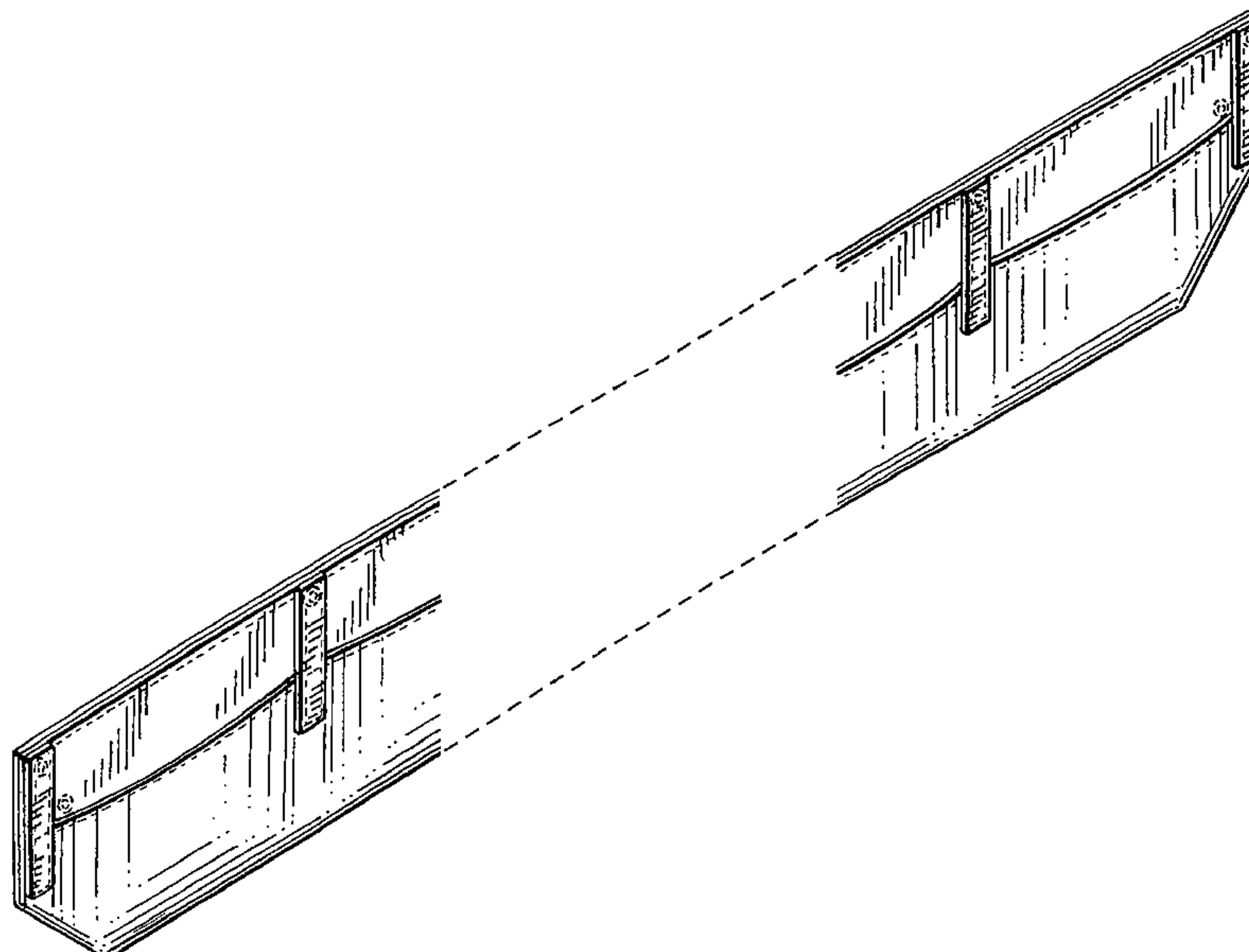
(57) **CLAIM**

The ornamental design for a vertical hanging planter, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left side perspective view of a vertical hanging planter;
FIG. 2 is a right side elevational view thereof, the left side elevational view being a mirror image thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a top plan view thereof; and,
FIG. 5 is a bottom plan view thereof.
The broken lines showing structural features and environmental structure are included for the purpose of illustrating non-claimed subject matter and form no part of the claimed design.

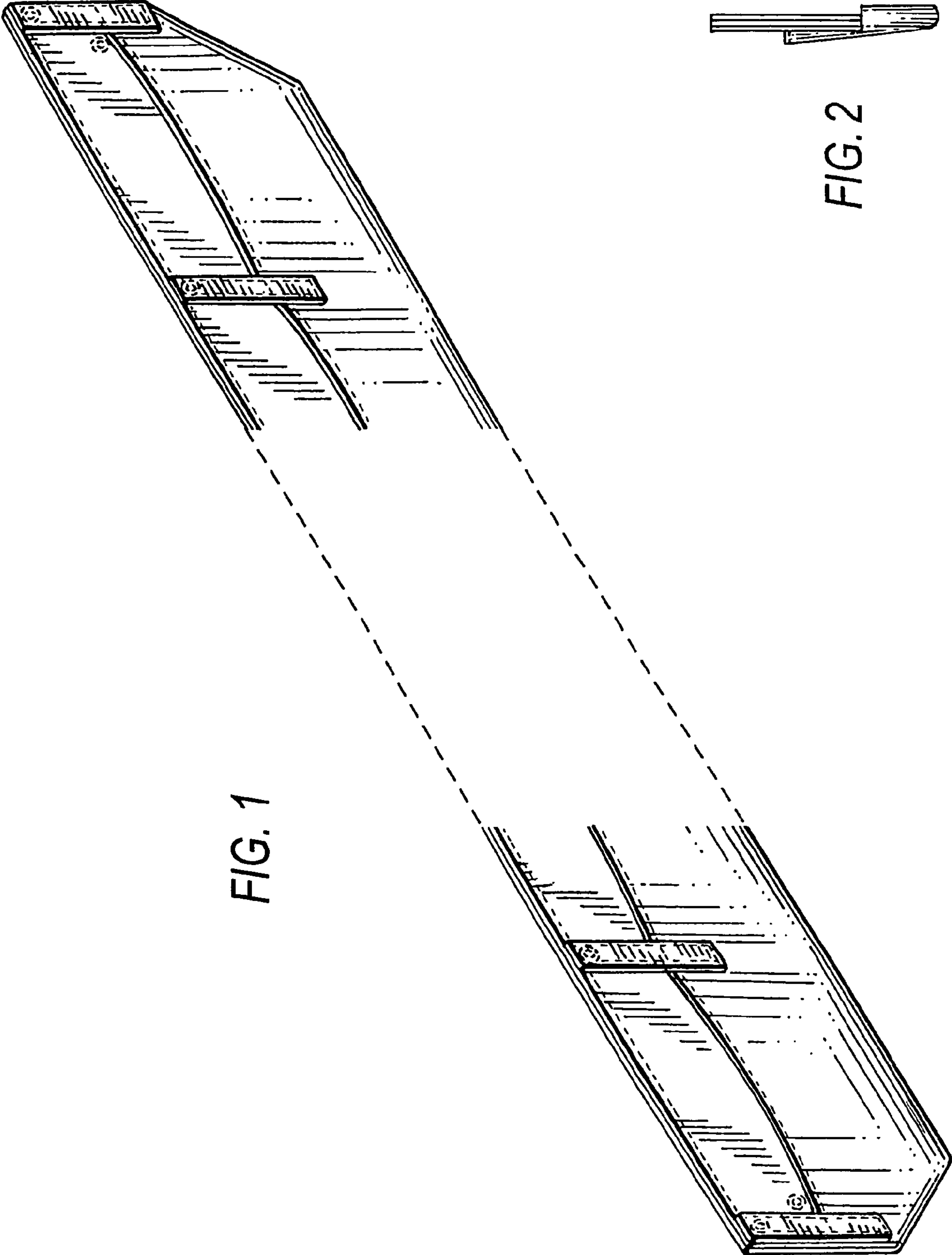

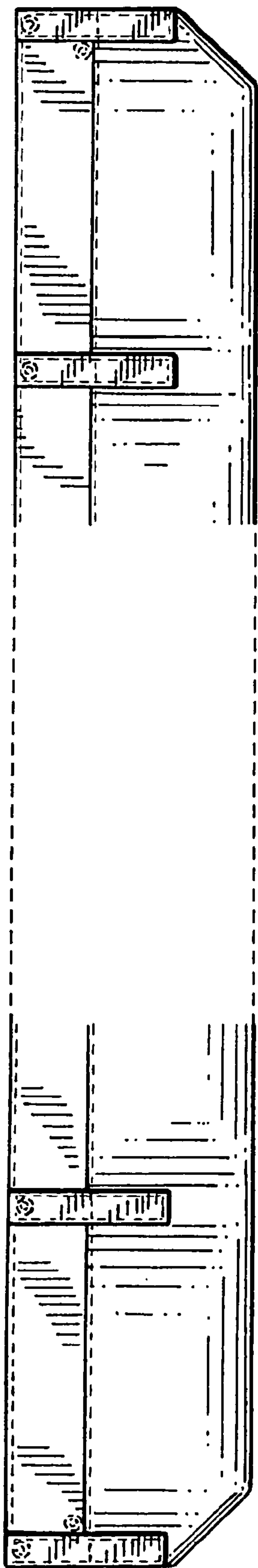

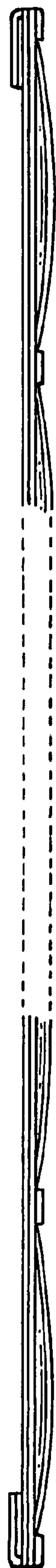
