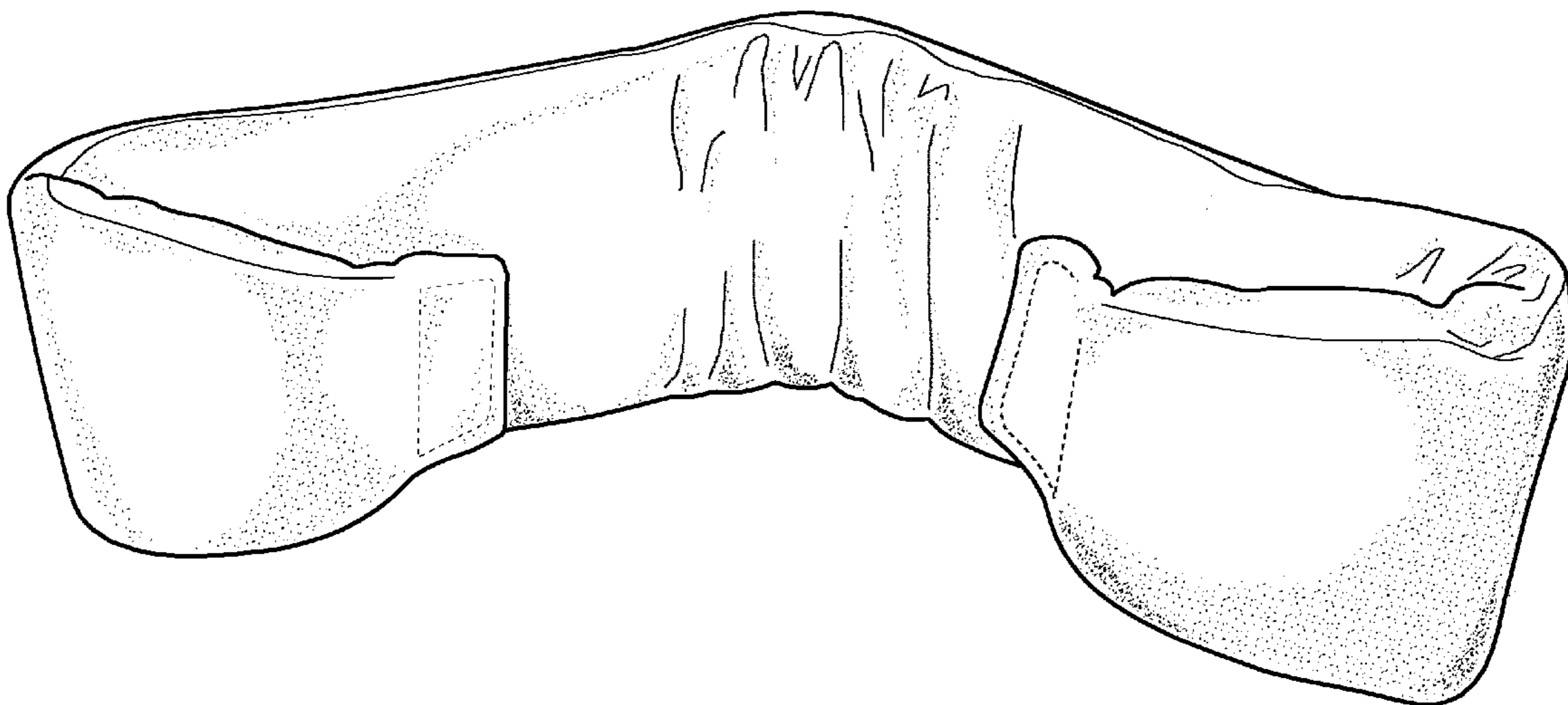
(57) **CLAIM**

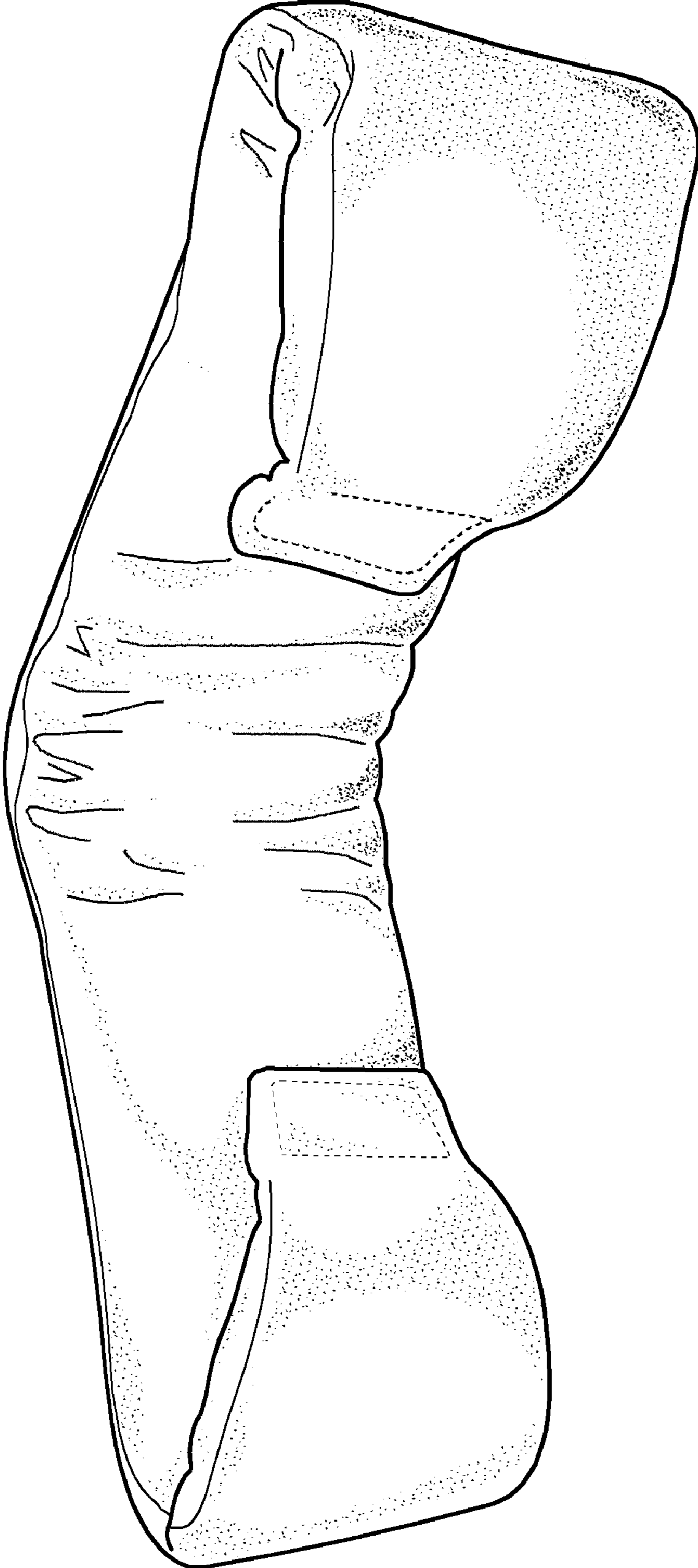
The ornamental design for a neck pad, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view showing our new neck pad; FIG. 2 is a top view thereof, the bottom view being a mirror image of the top view; FIG. 3 is a right side view thereof, the left side view being a mirror image of the right side view; FIG. 4 is a front view thereof; FIG. 5 is a rear view thereof; and, FIG. 6 is a rolled-up perspective view thereof. In the drawings, the broken lines represent stitching.

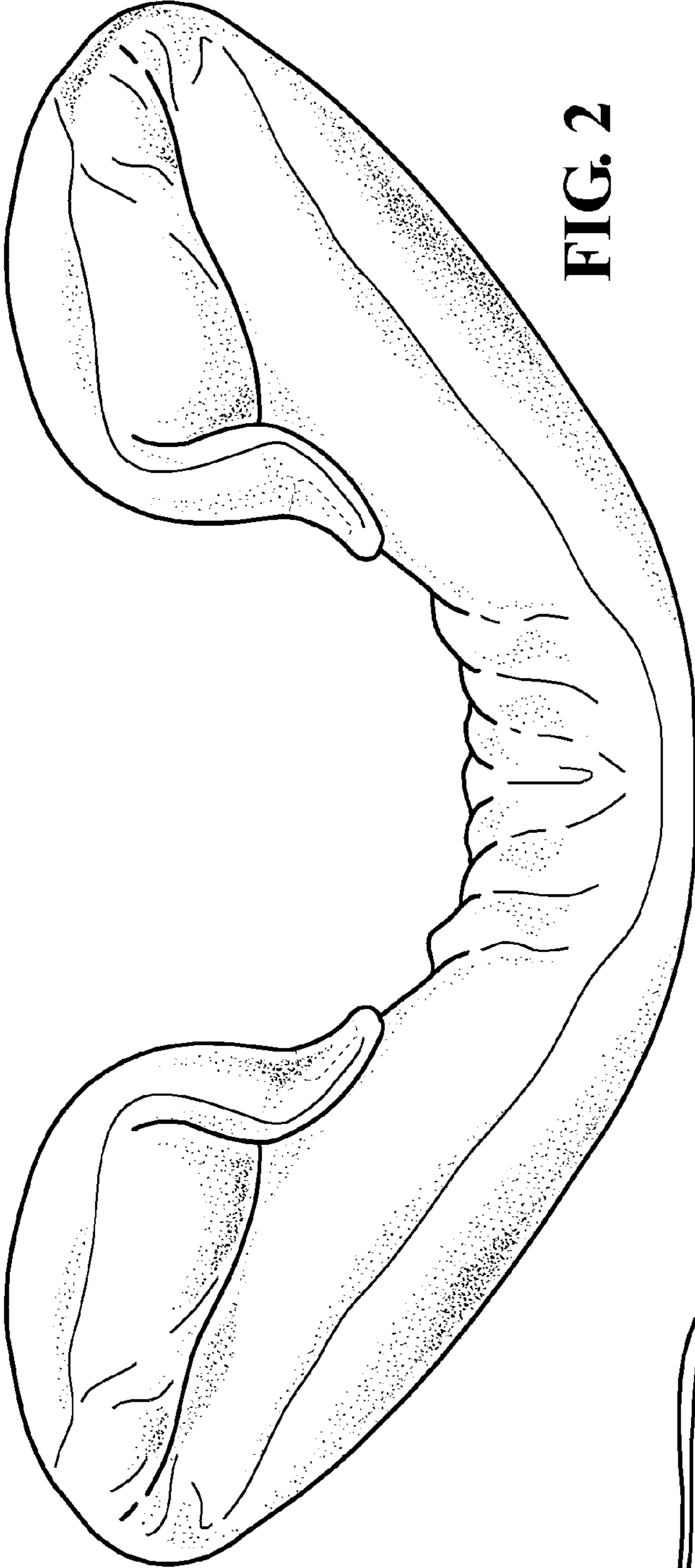

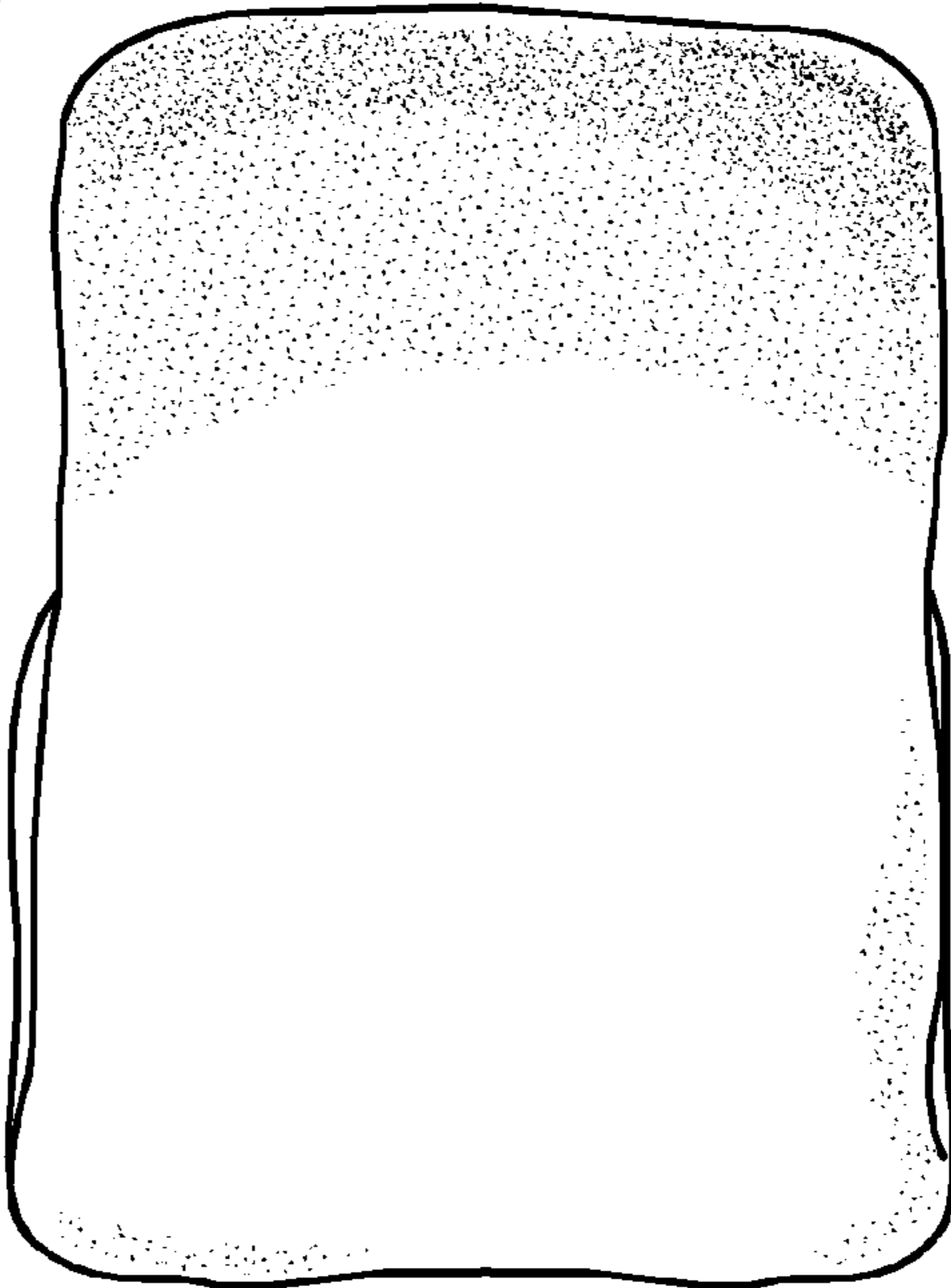
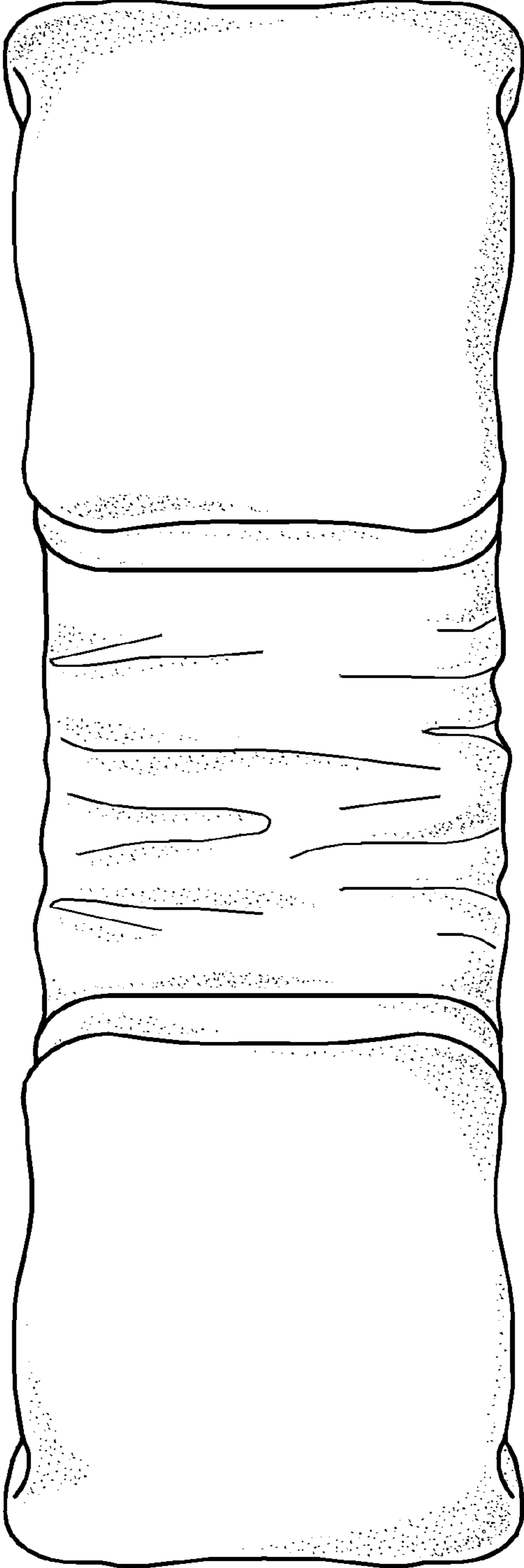
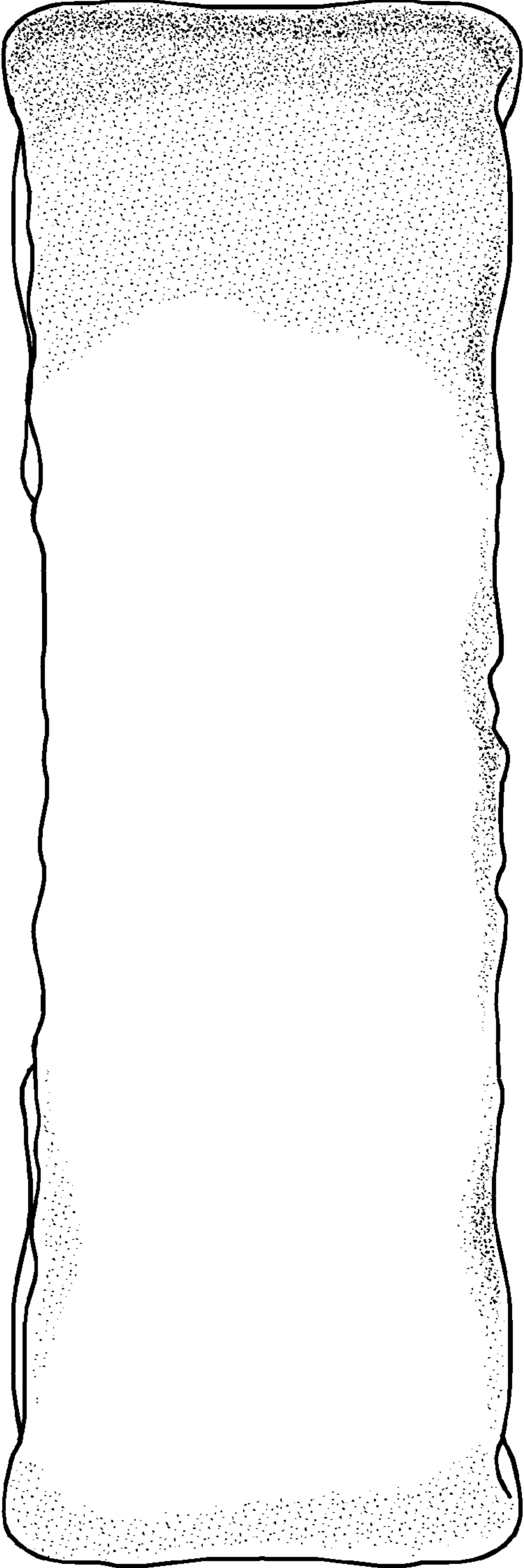

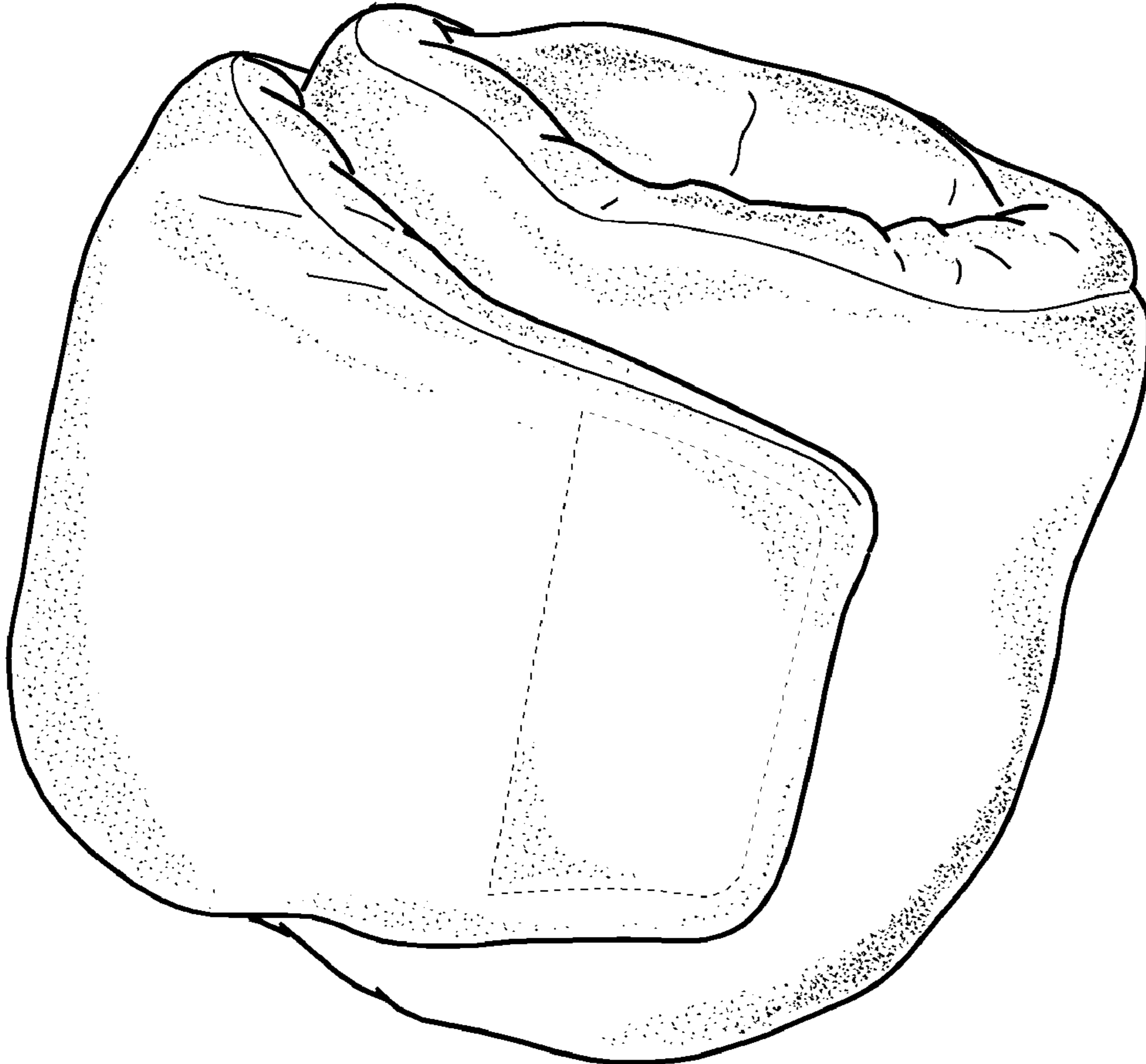
