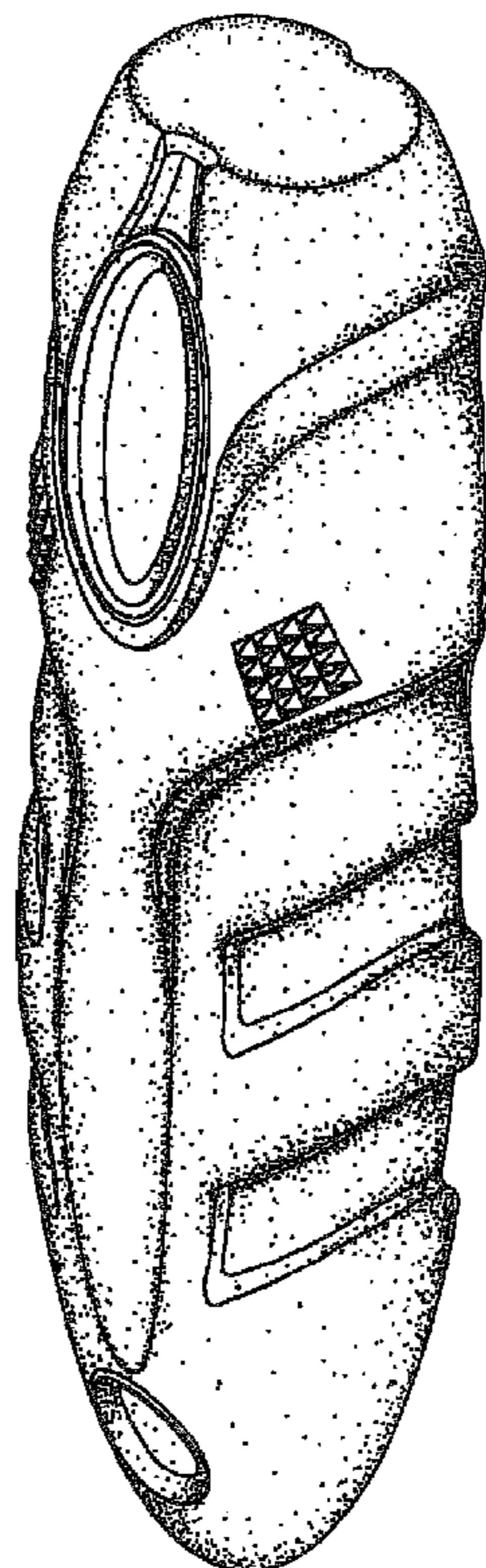
(57) **CLAIM**

The ornamental design for a handle of a tool, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a handle of a tool showing my new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a left side elevational view thereof;
 FIG. 5 is a right side elevational view thereof;
 FIG. 6 is a top plan view thereof; and
 FIG. 7 is a bottom plan view thereof;
 FIG. 8 is a perspective view thereof, shown in environmental use;
 FIG. 9 is another perspective view thereof, shown in an alternate environmental use; and
 FIG. 10 is another perspective view thereof, shown in an alternate environmental use.
 The broken lines in FIGS. 8 to 10 are intended to show features that are environmental only and form no part of the claimed design.

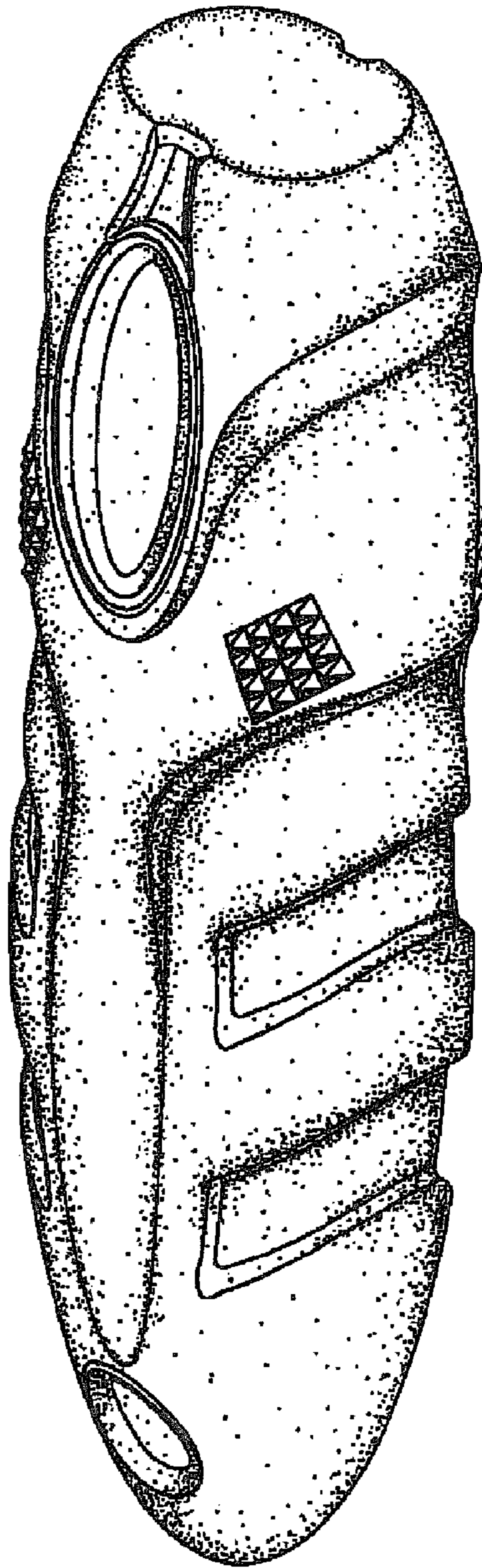

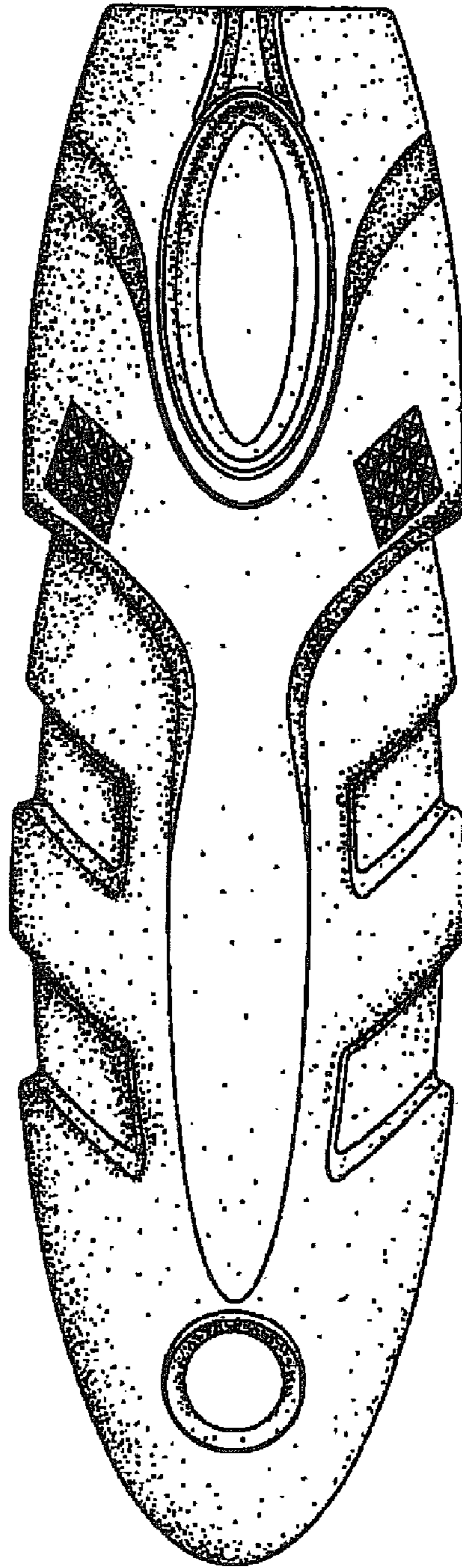

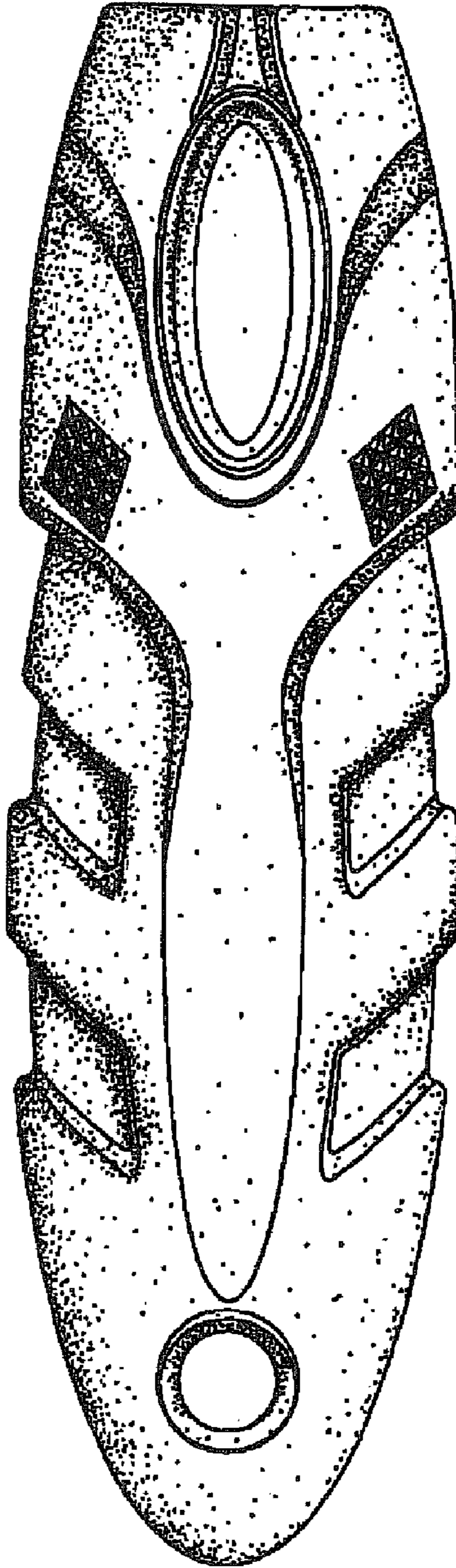

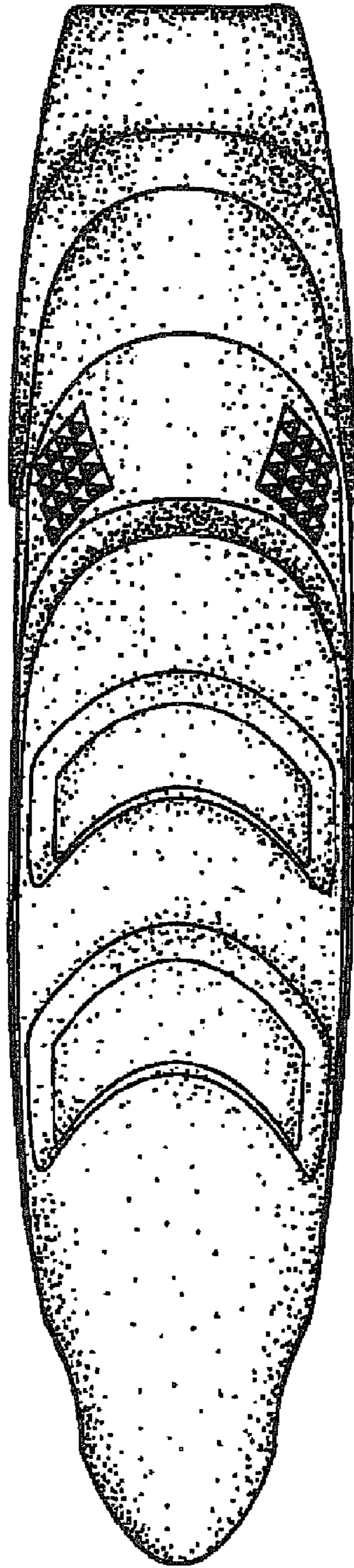

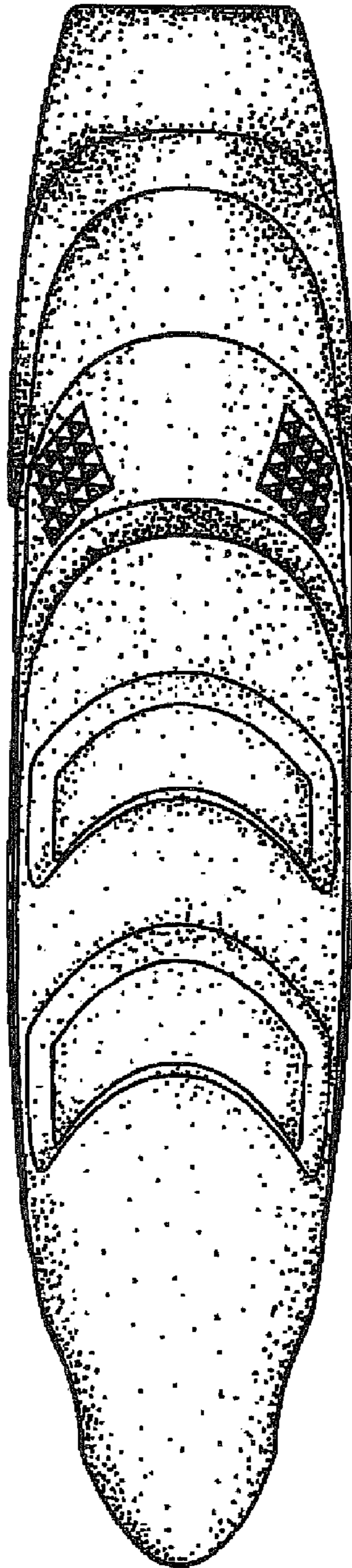

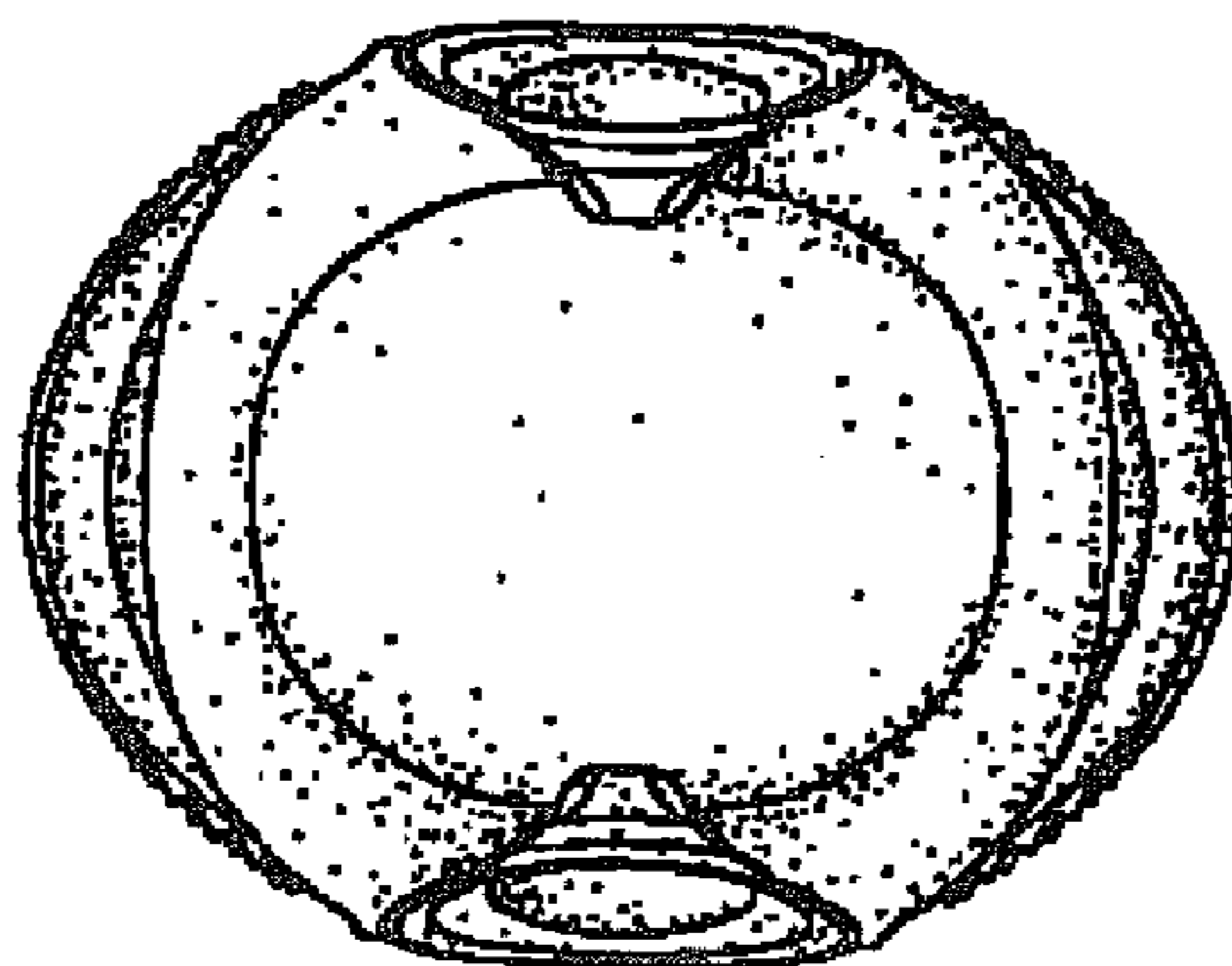

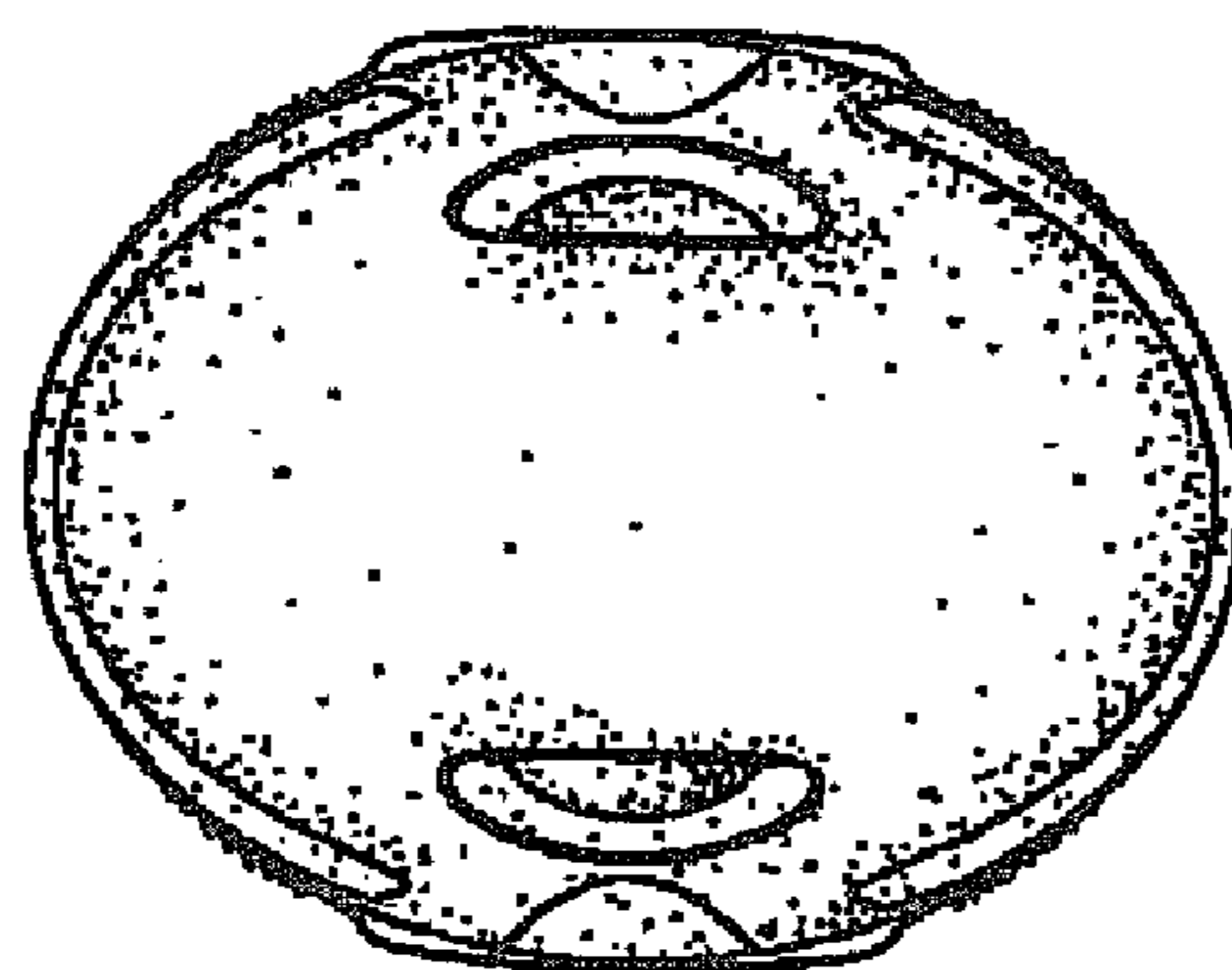

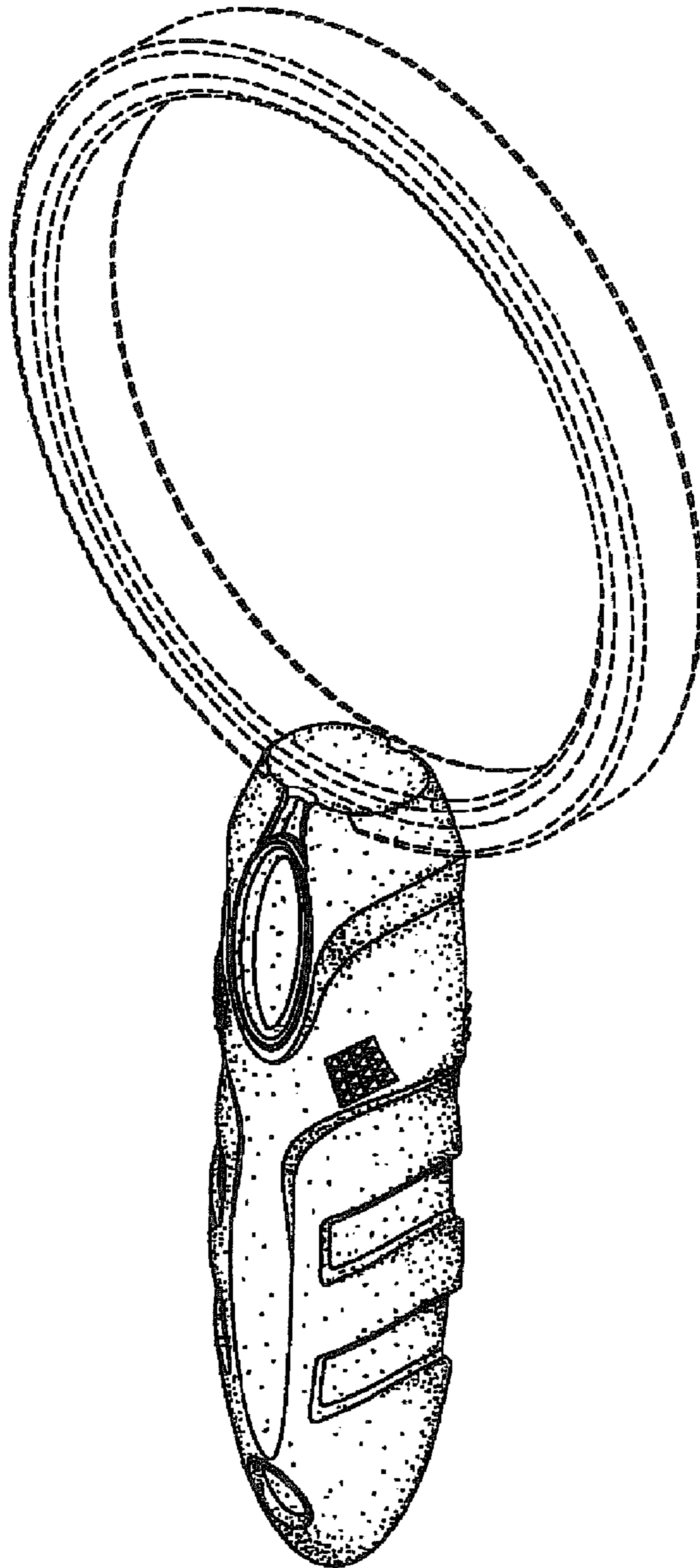

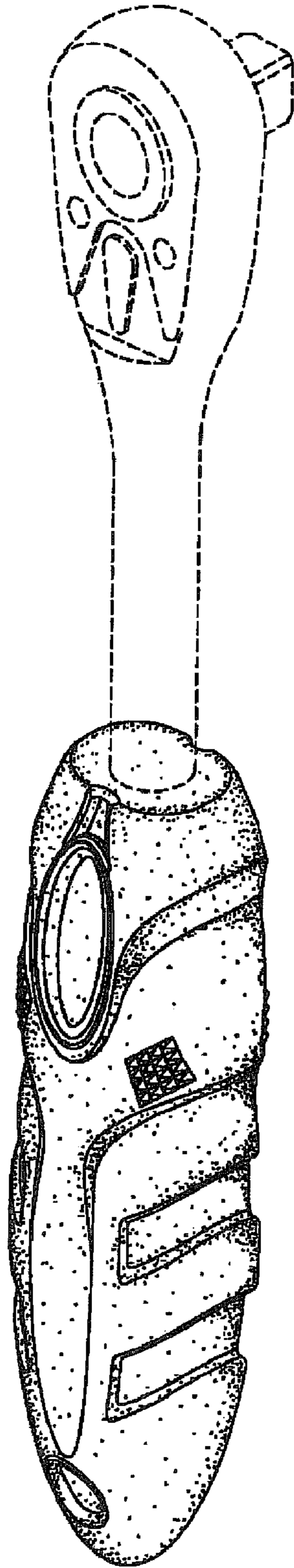

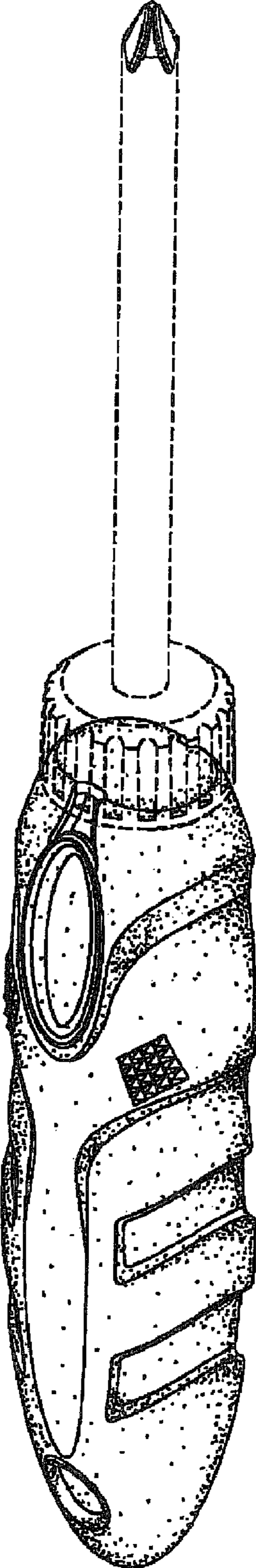
