The ornamental design for a plastic container as shown and described.

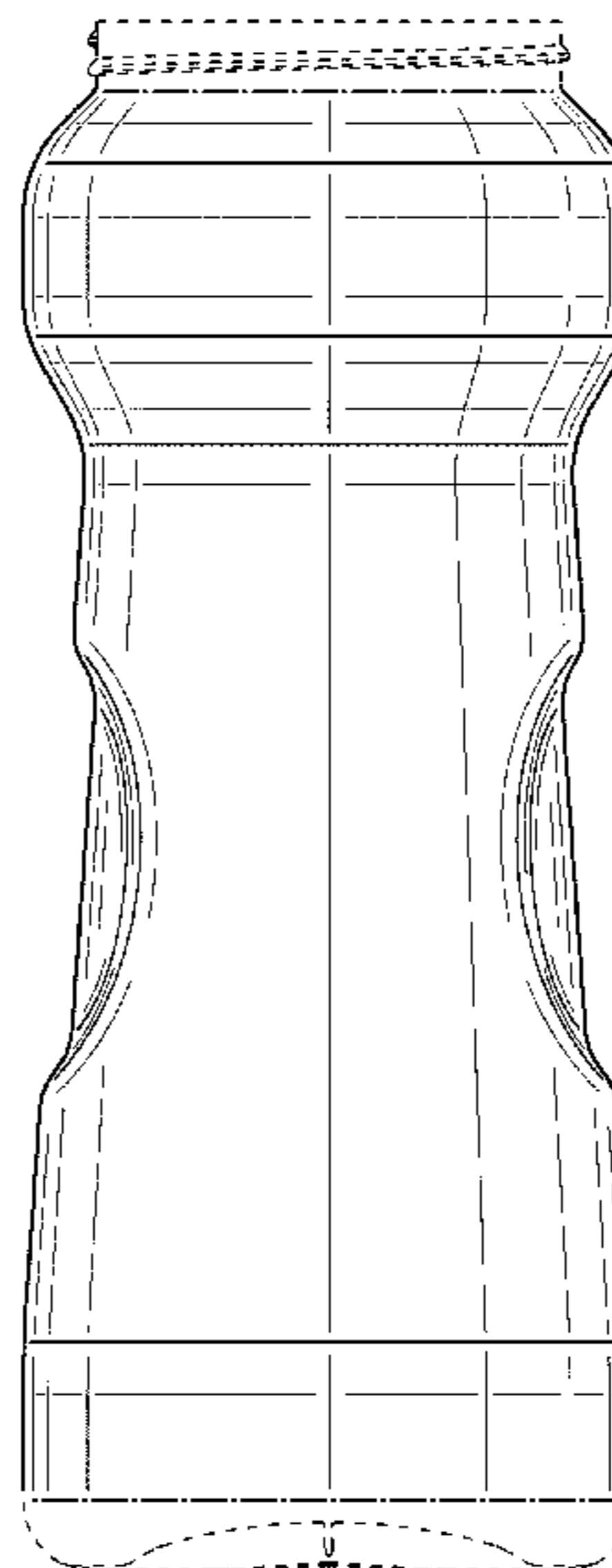
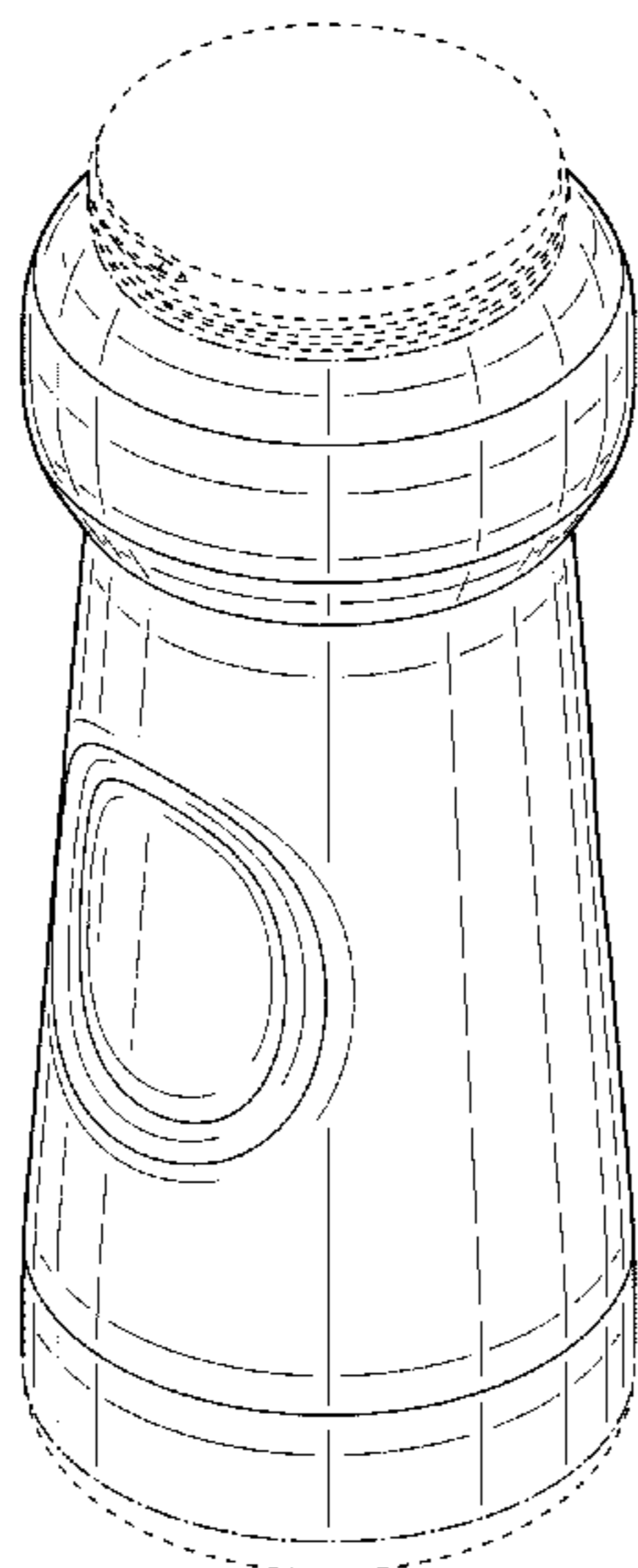
DESCRIPTION

FIG. 1 is a perspective view of a plastic container showing my new design as viewed from the top, front, and right side; FIG. 2 is a front view of the container; FIG. 3 is a rear view of the container; FIG. 4 is a right side view of the container; FIG. 5 is a left side view of the container; FIG. 6 is a top plan view of the container; and, FIG. 7 is a bottom view of the container.

The dash-dash-dash-dash broken lines shown in the drawings are included for the purpose of showing environmental structure that forms no part of the claimed design.

The dot-dash-dot-dash broken lines shown in the drawings represent the boundary lines if the claimed design.

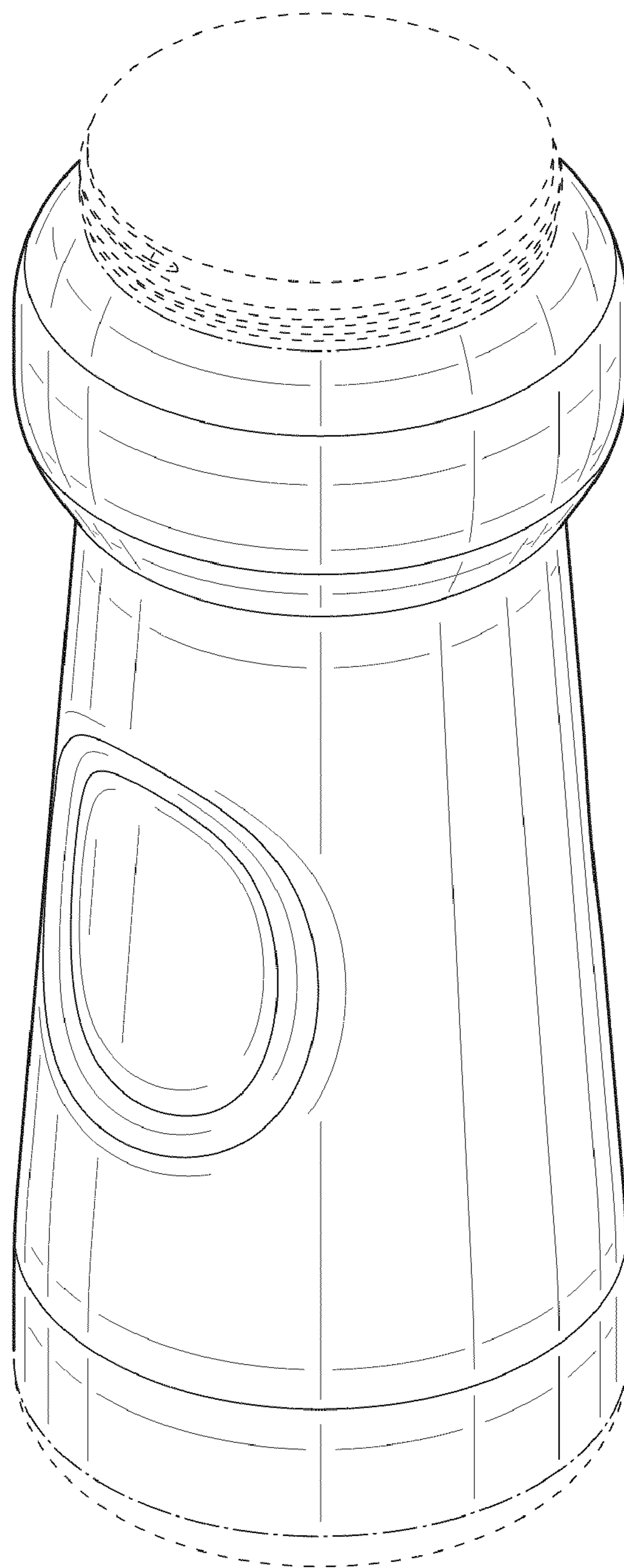

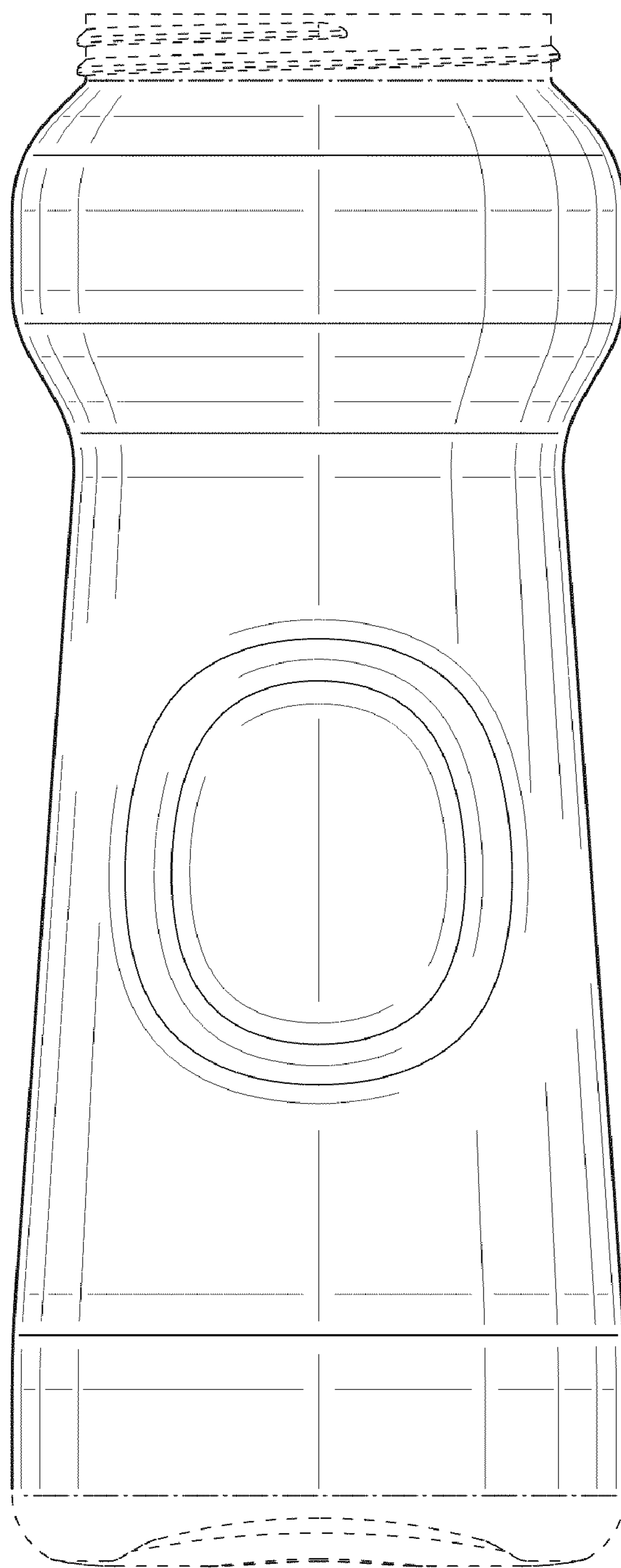

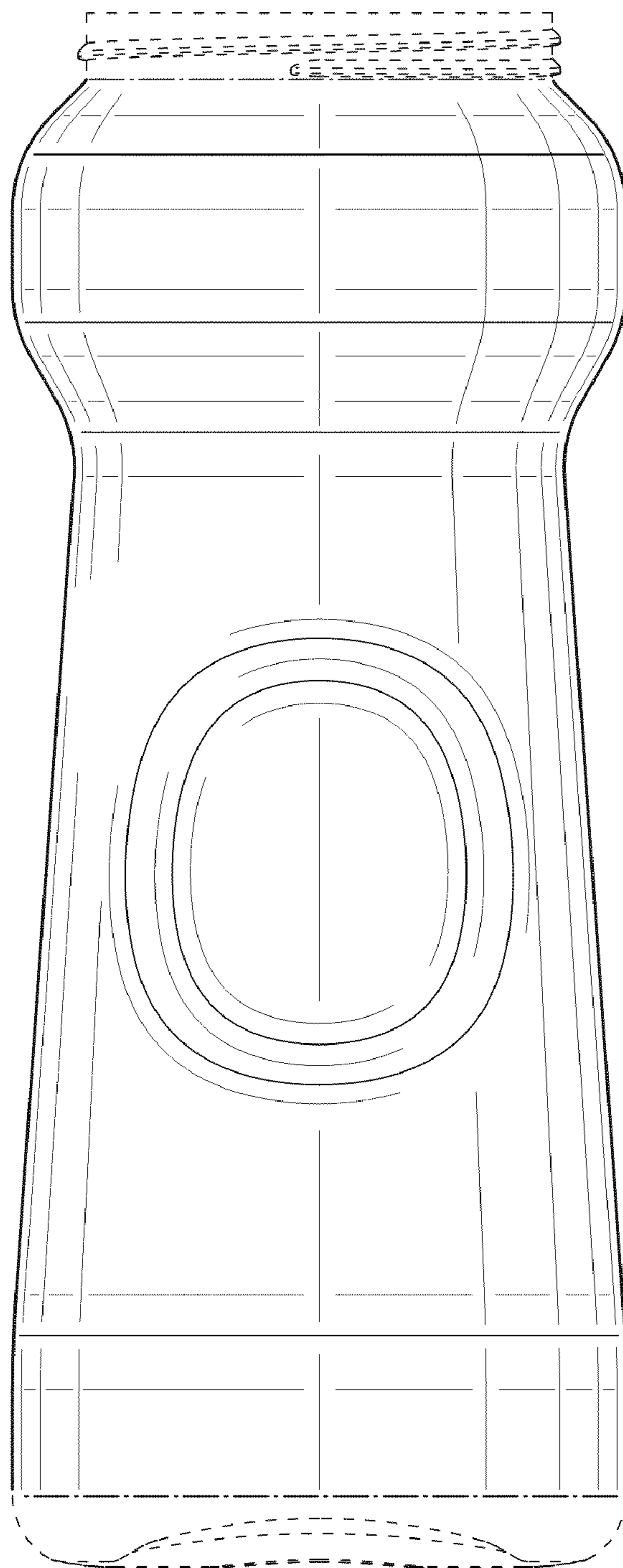

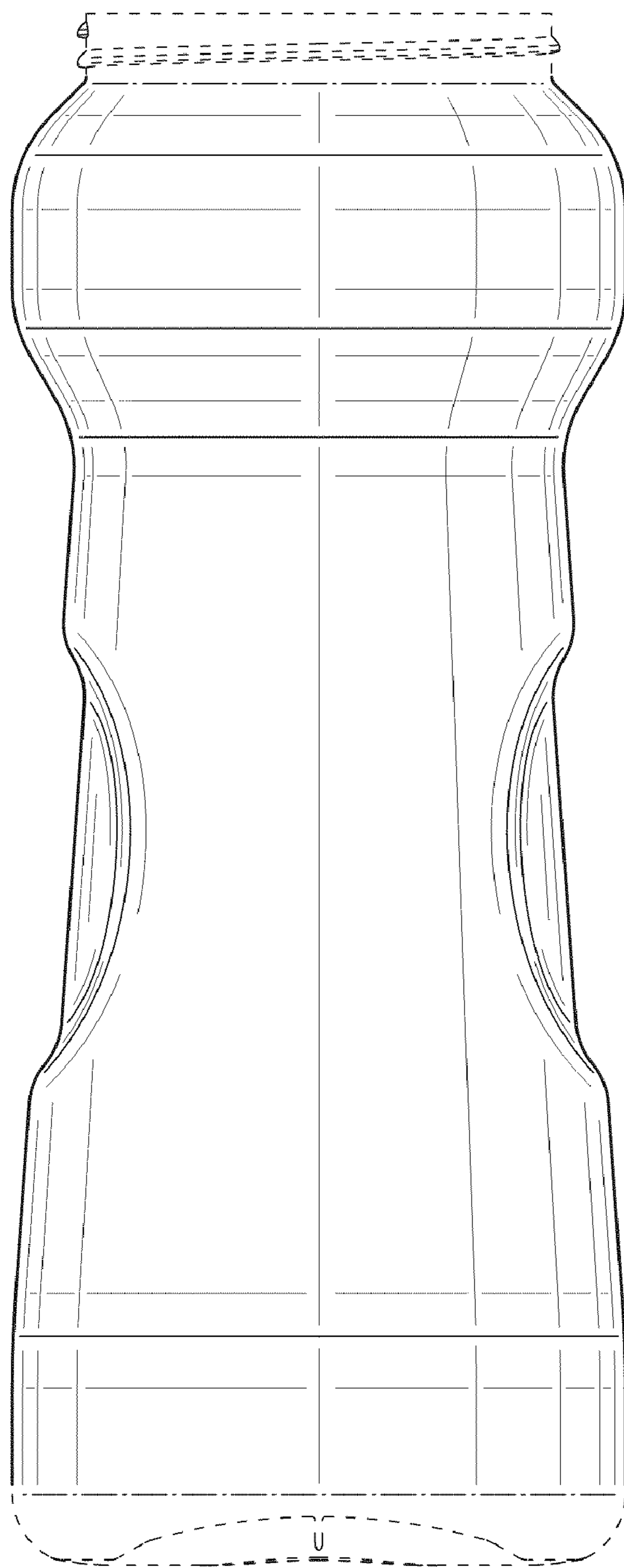

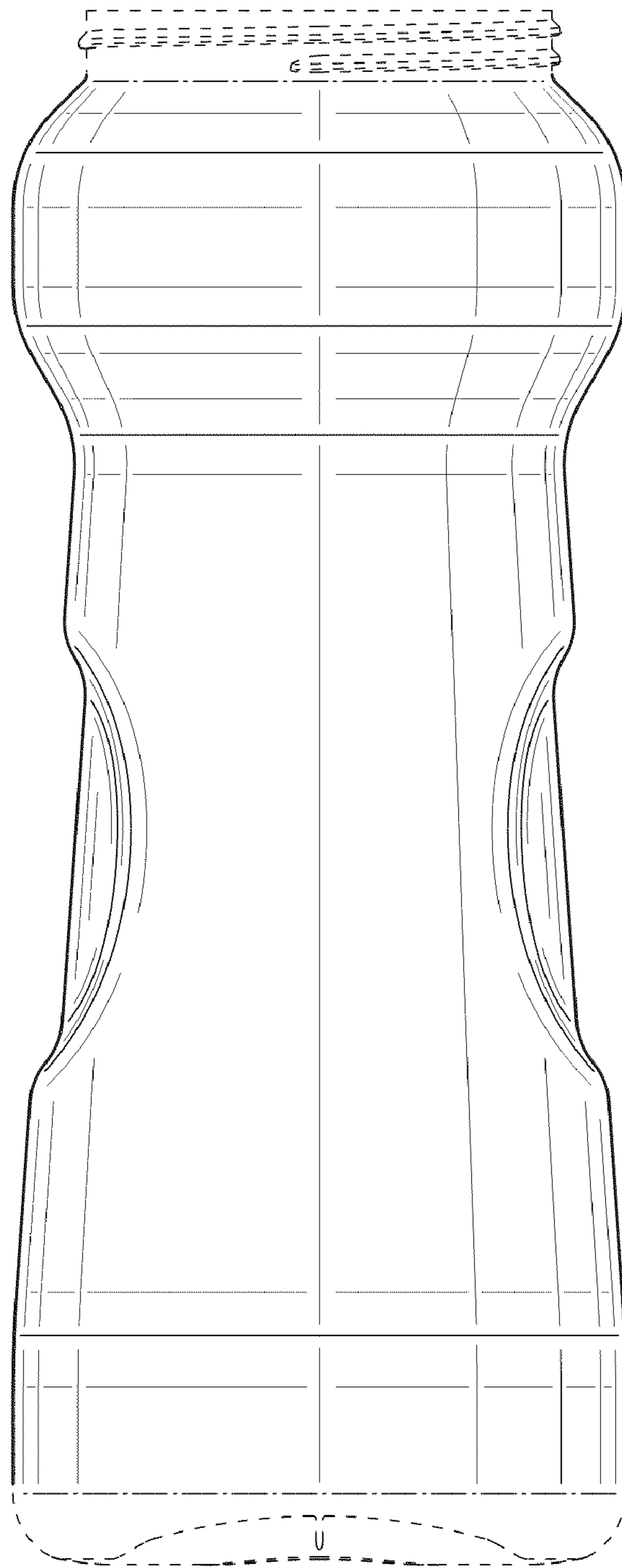

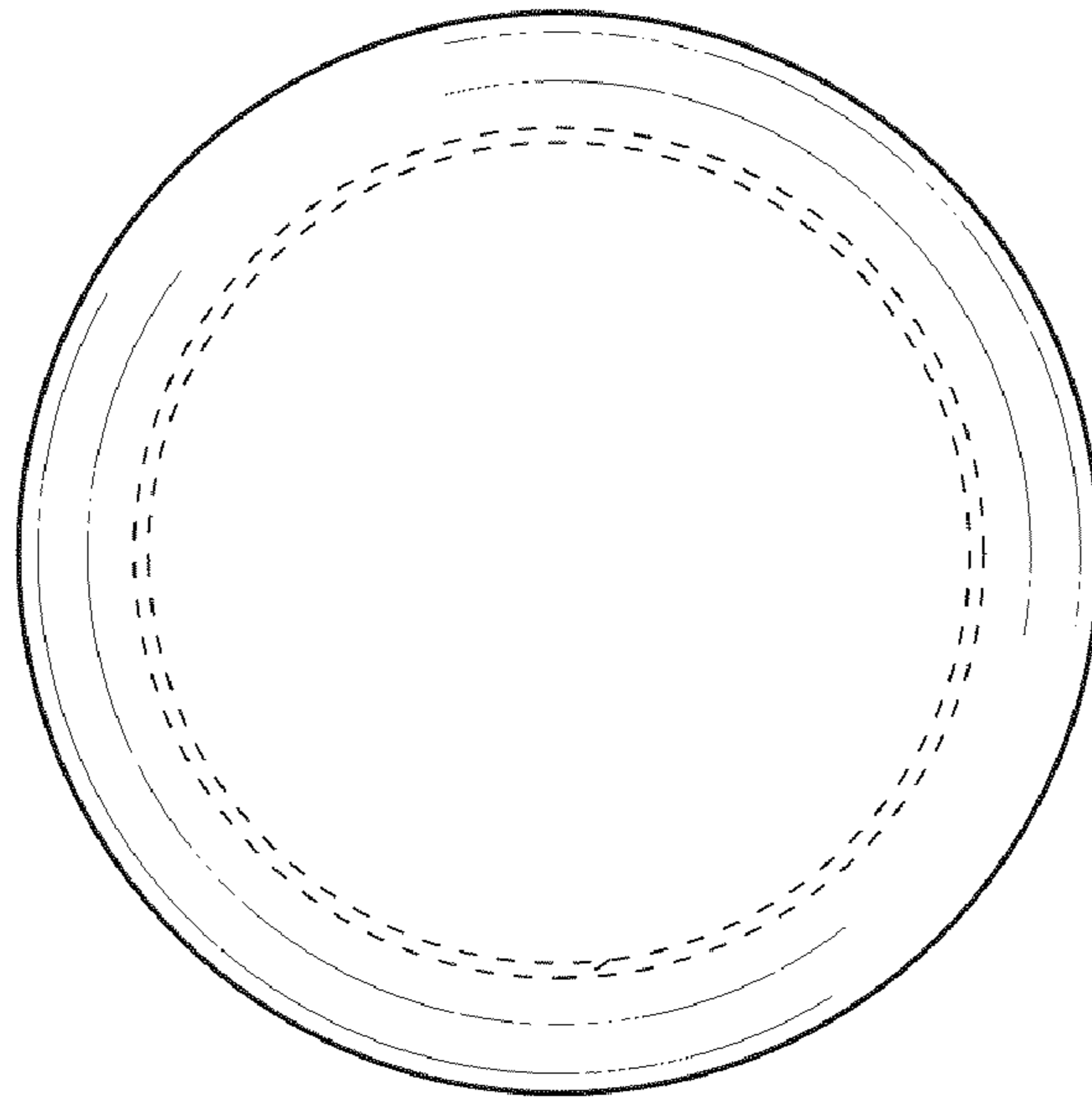

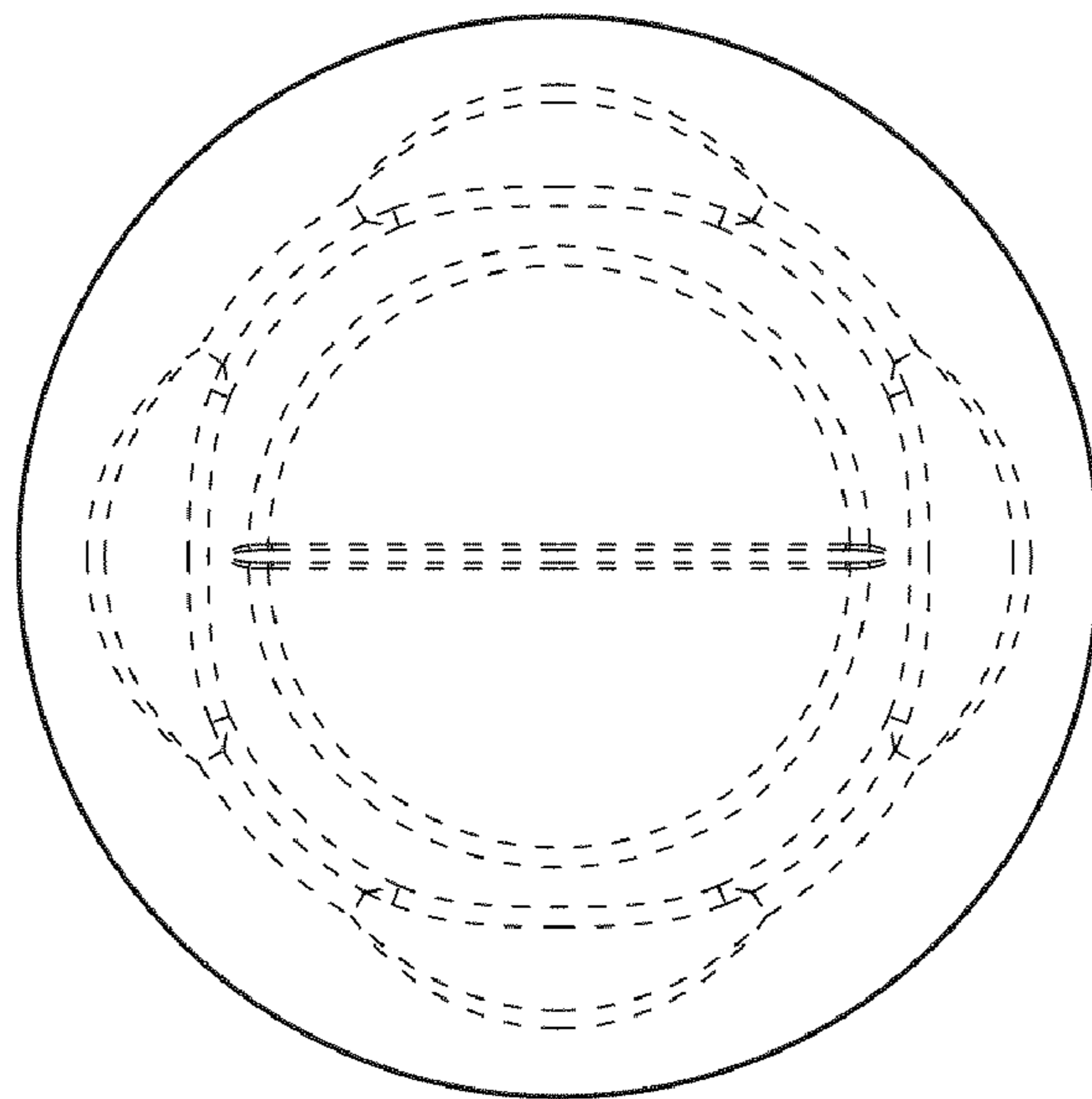
