FIG. 1.

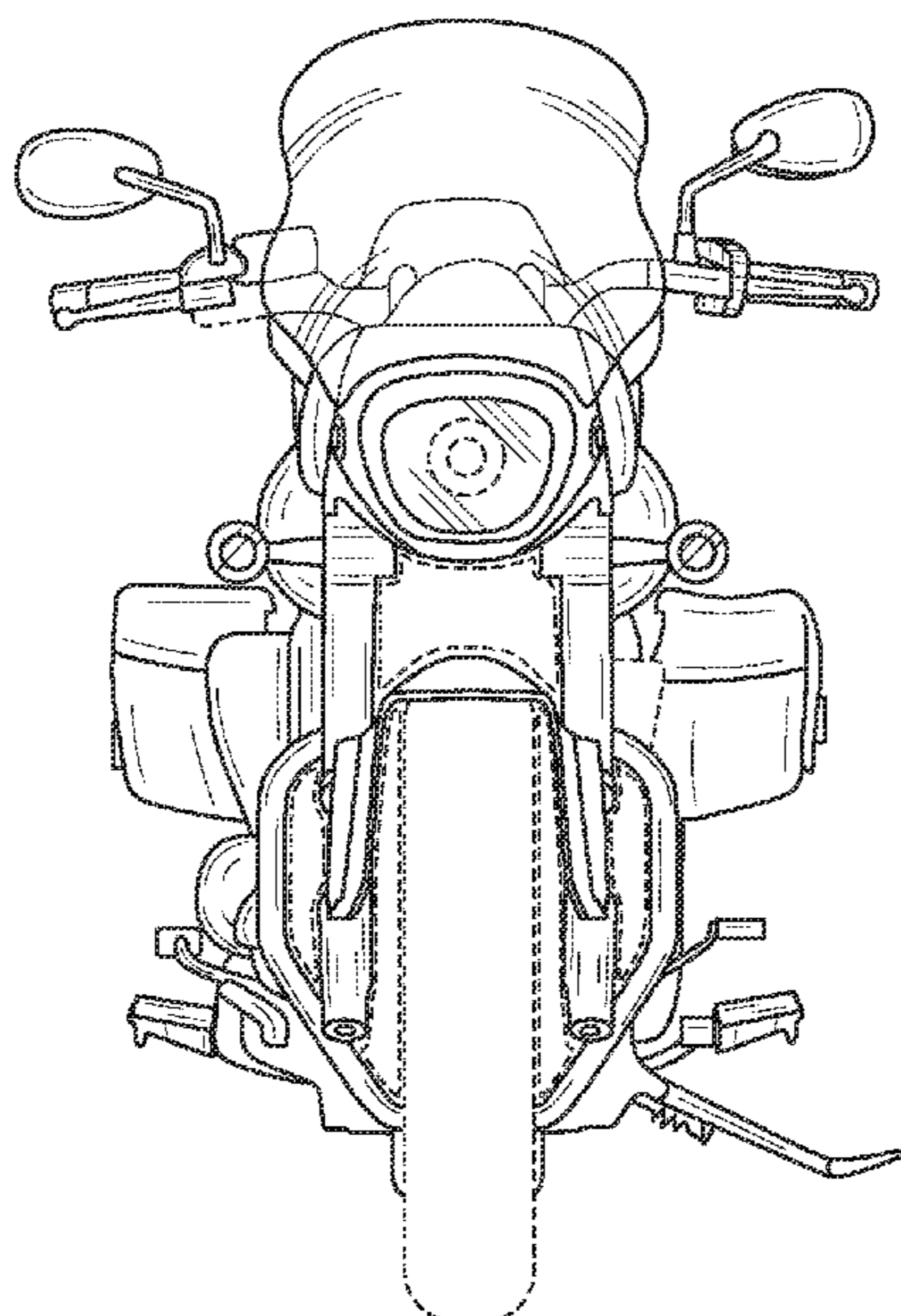
FIG. 7 is a rear perspective view as seen from the left side of

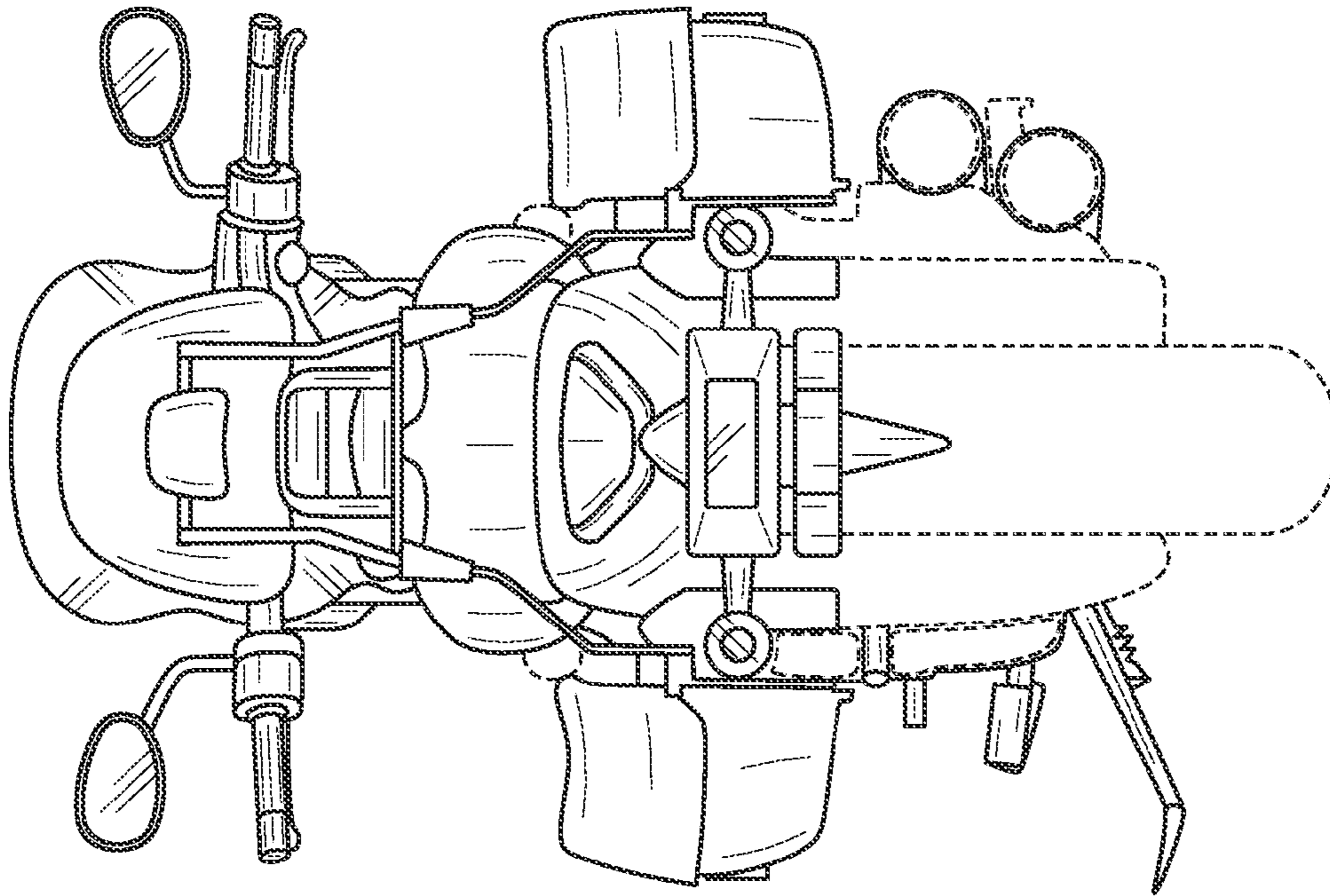

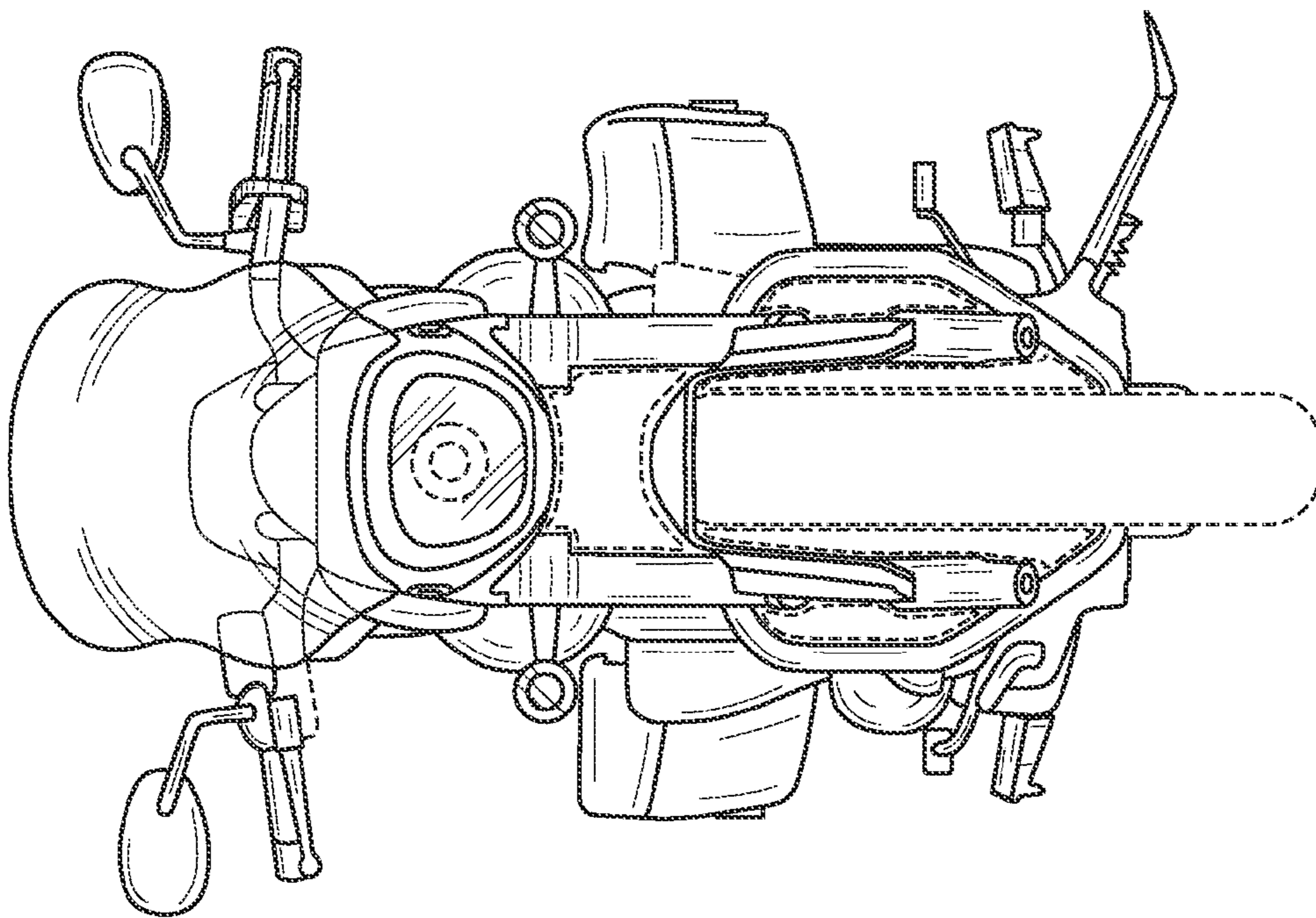

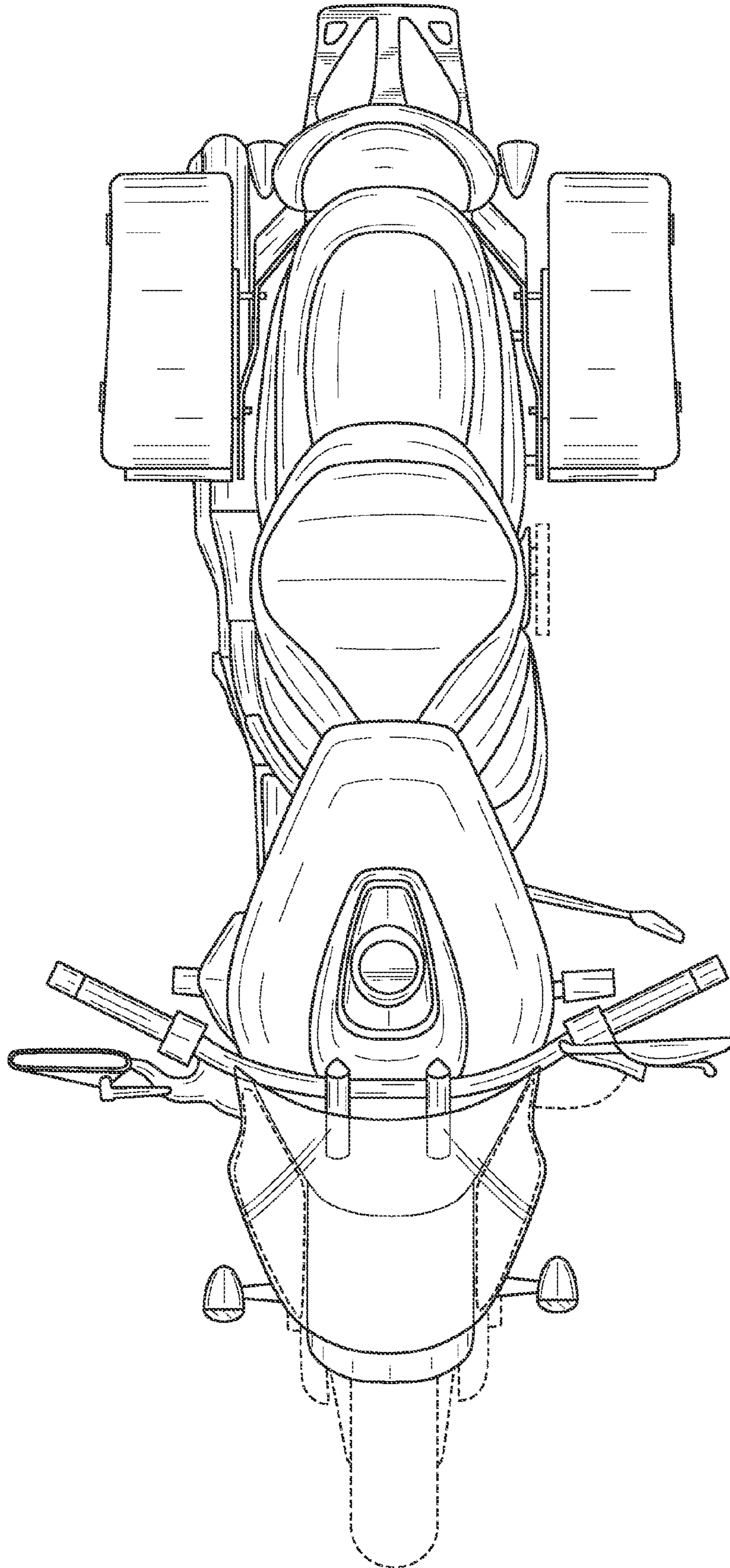

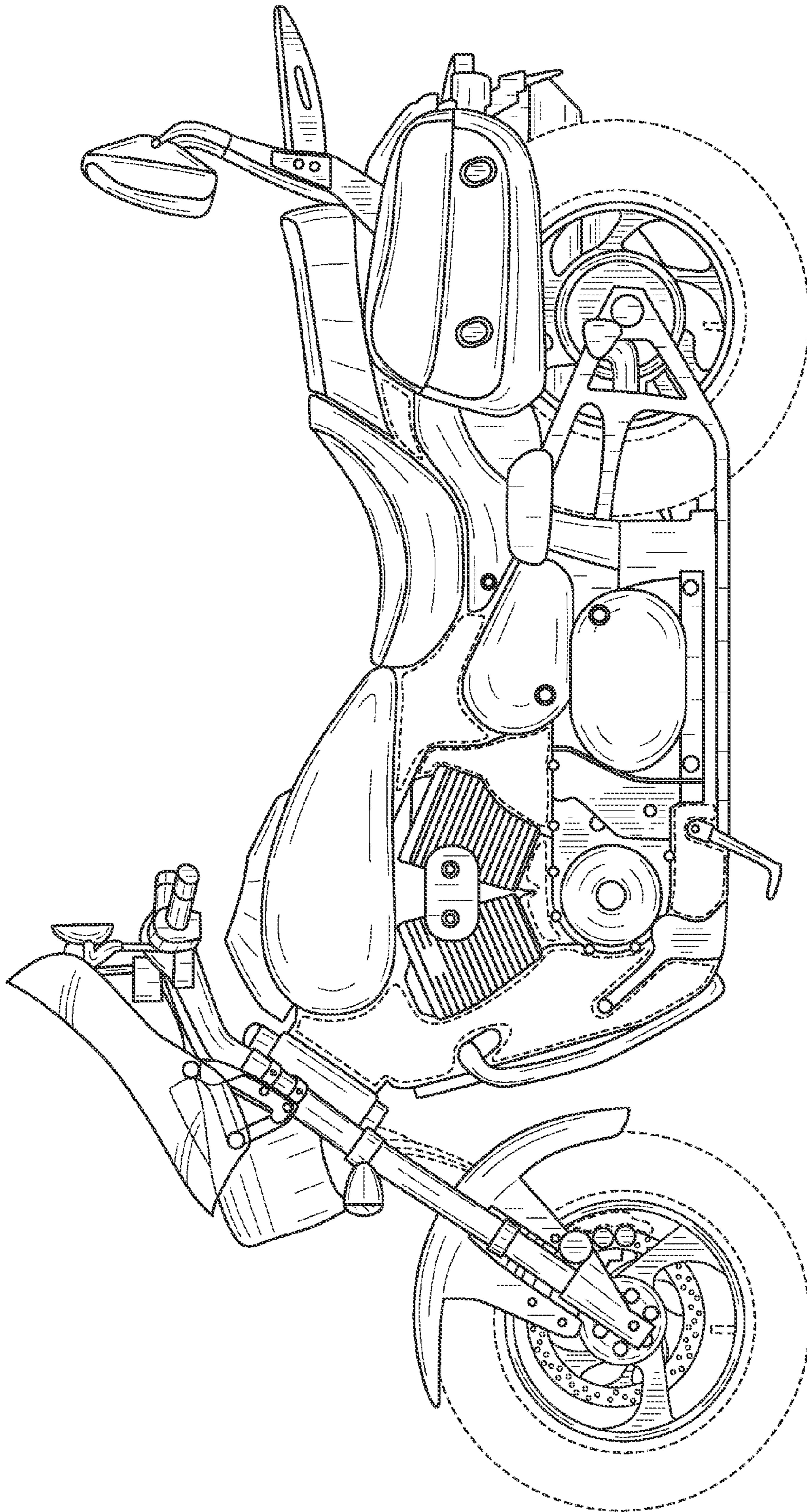

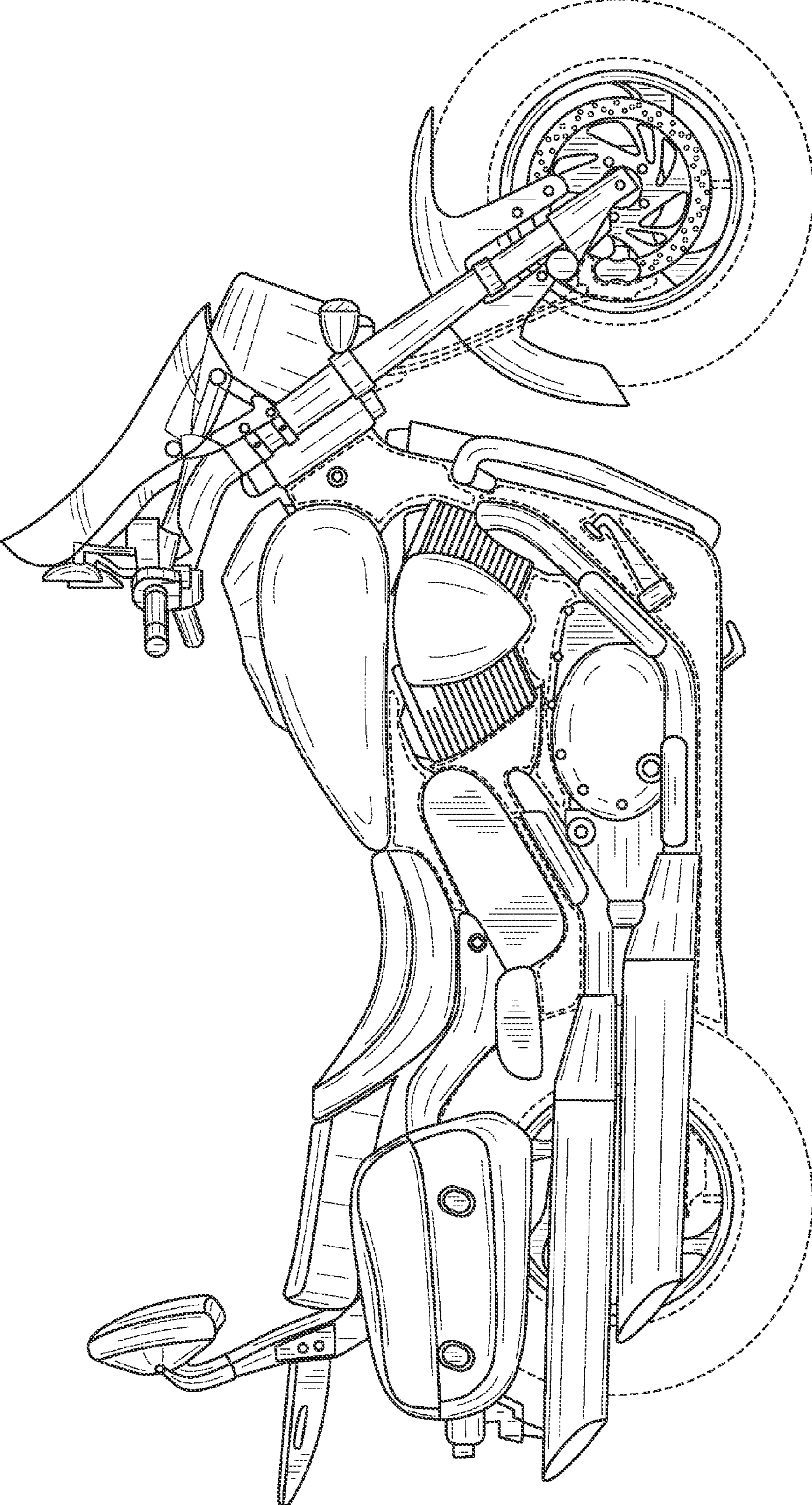

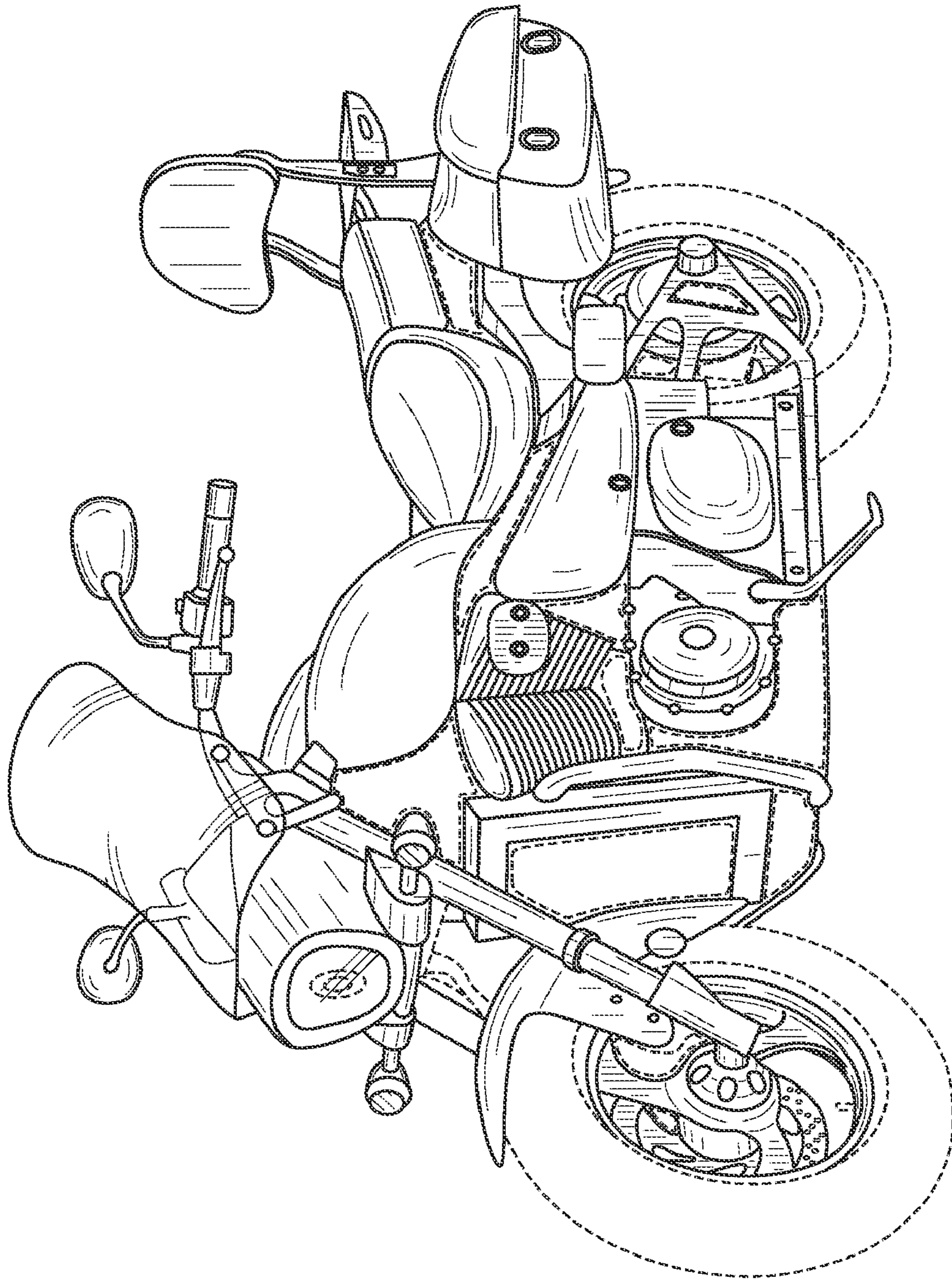

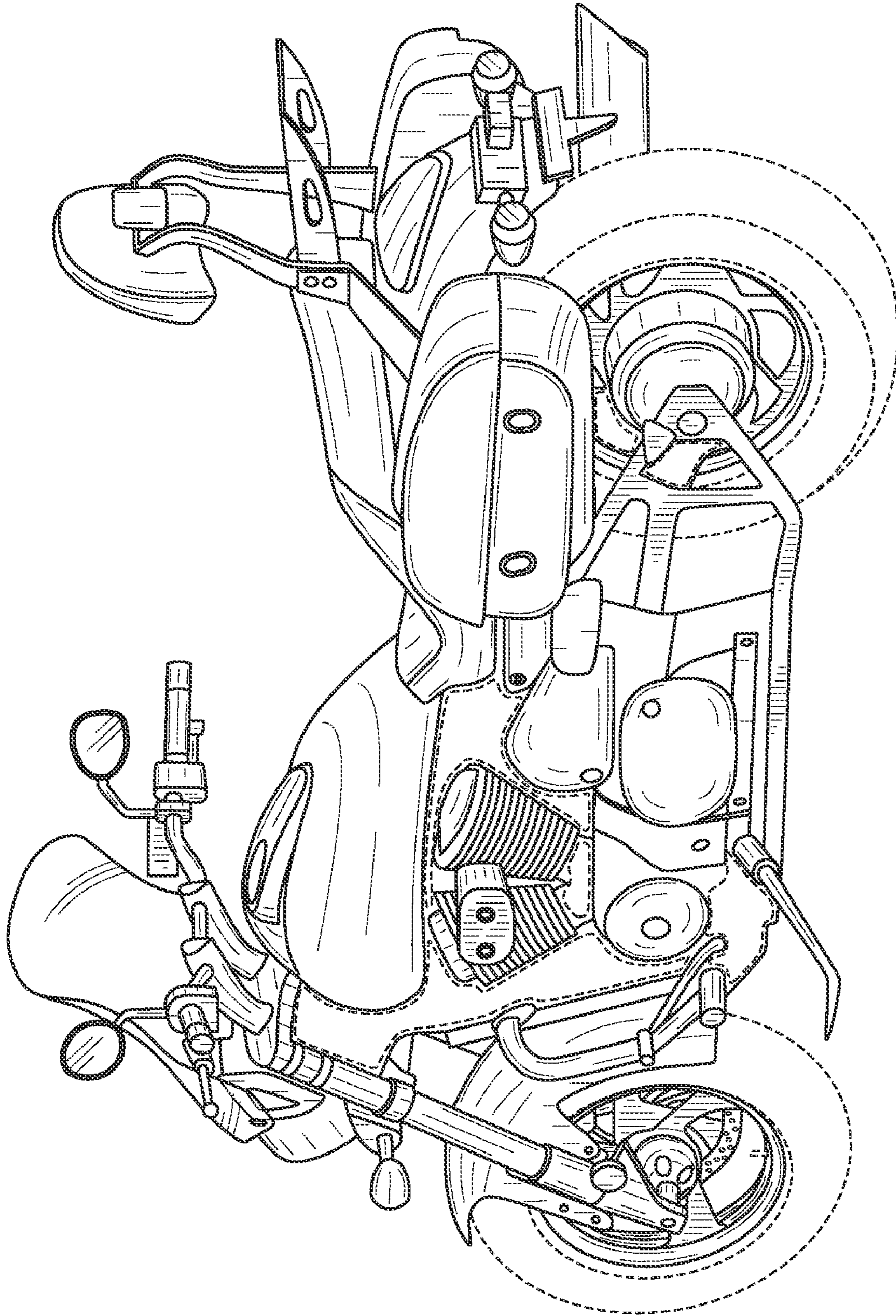

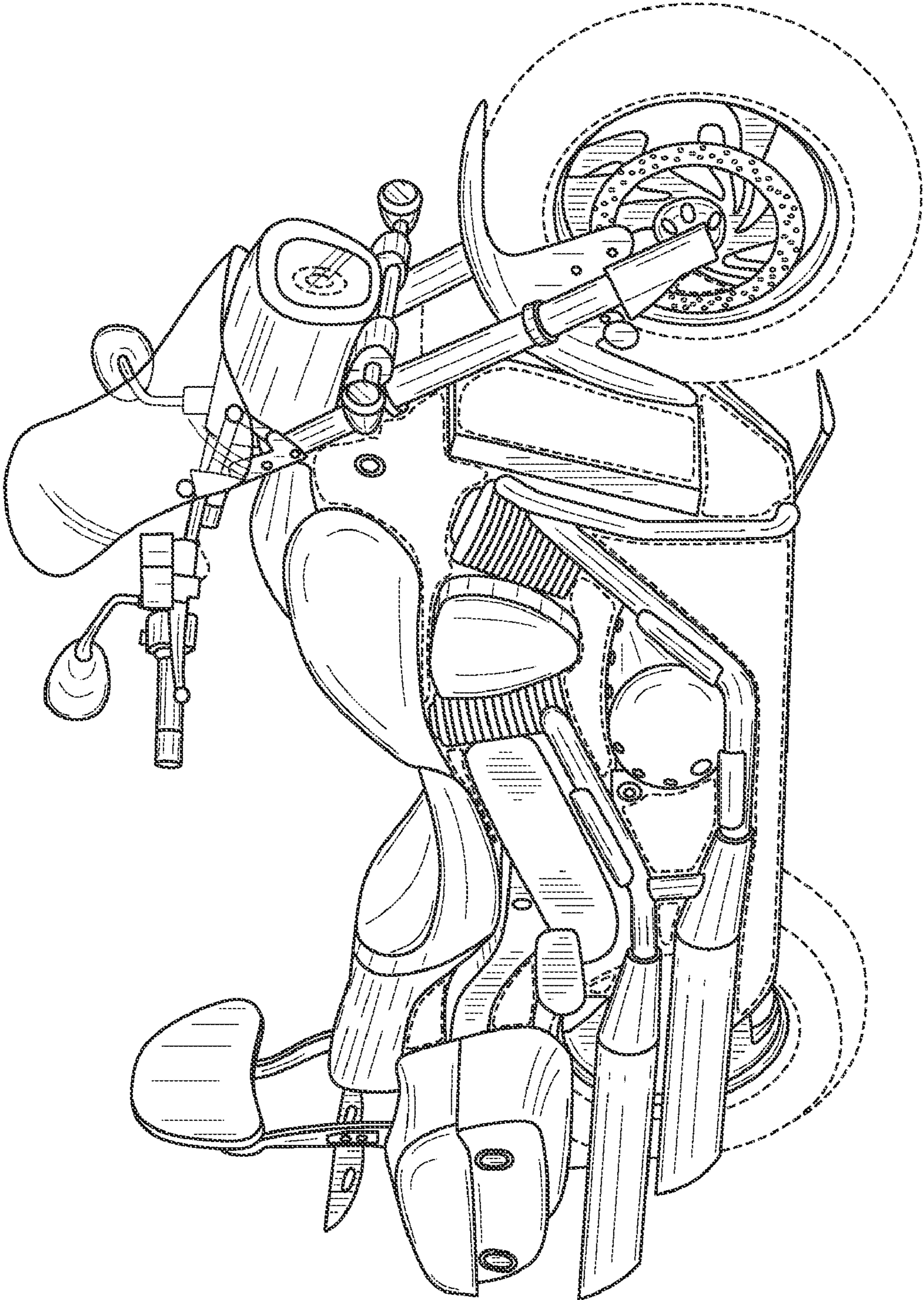

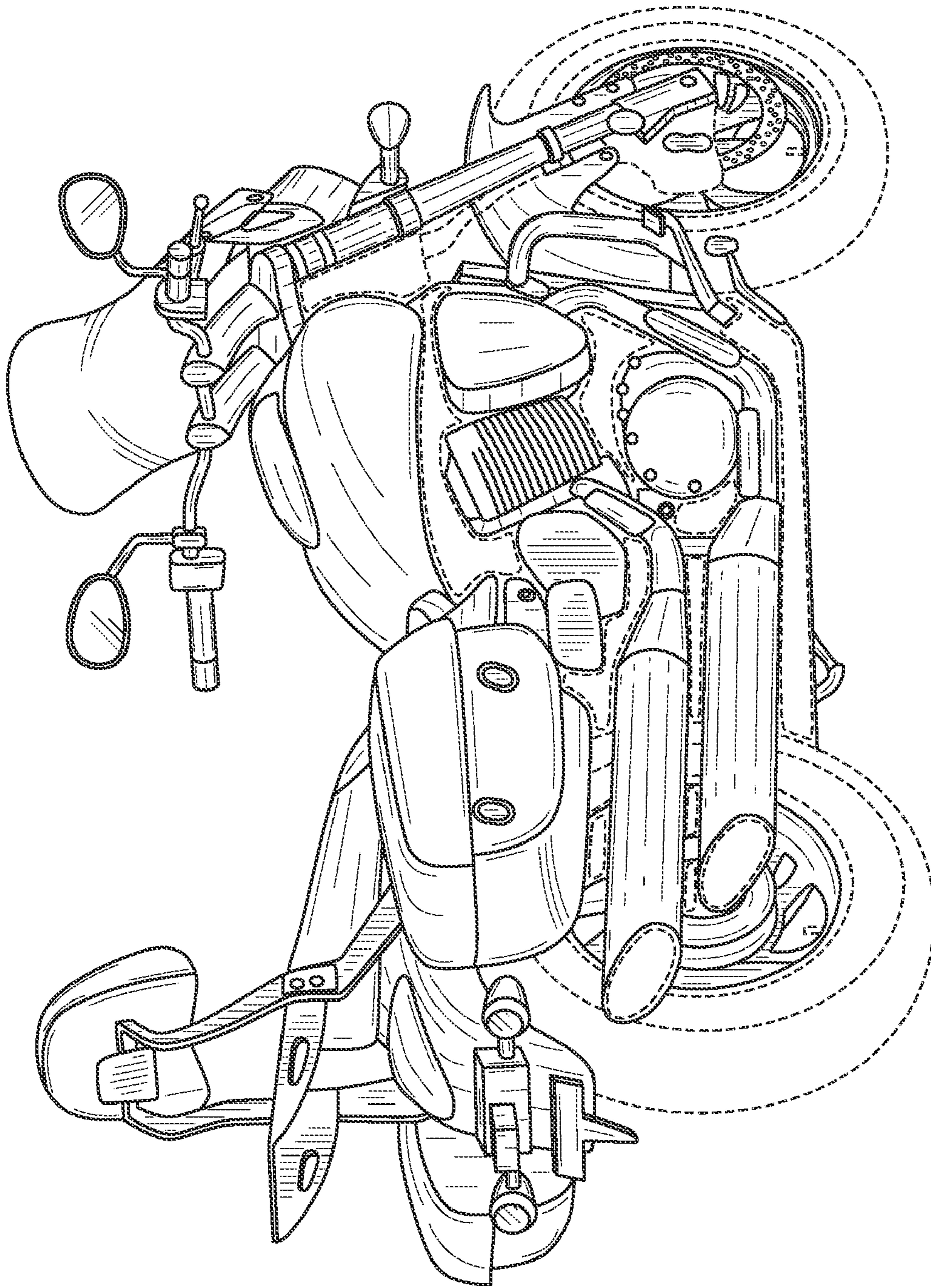
