(57) **CLAIM**

The ornamental design for a front bumper for automobile, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from the front and left side of a front bumper for automobile.

FIG. 2 is a front elevation view thereof.

FIG. 3 is a top plan view thereof; and,

FIG. 4 is a right side elevation view thereof.

The portion of the front bumper shown in broken lines is for the purpose of showing background structure only and forms no part of the claimed design.

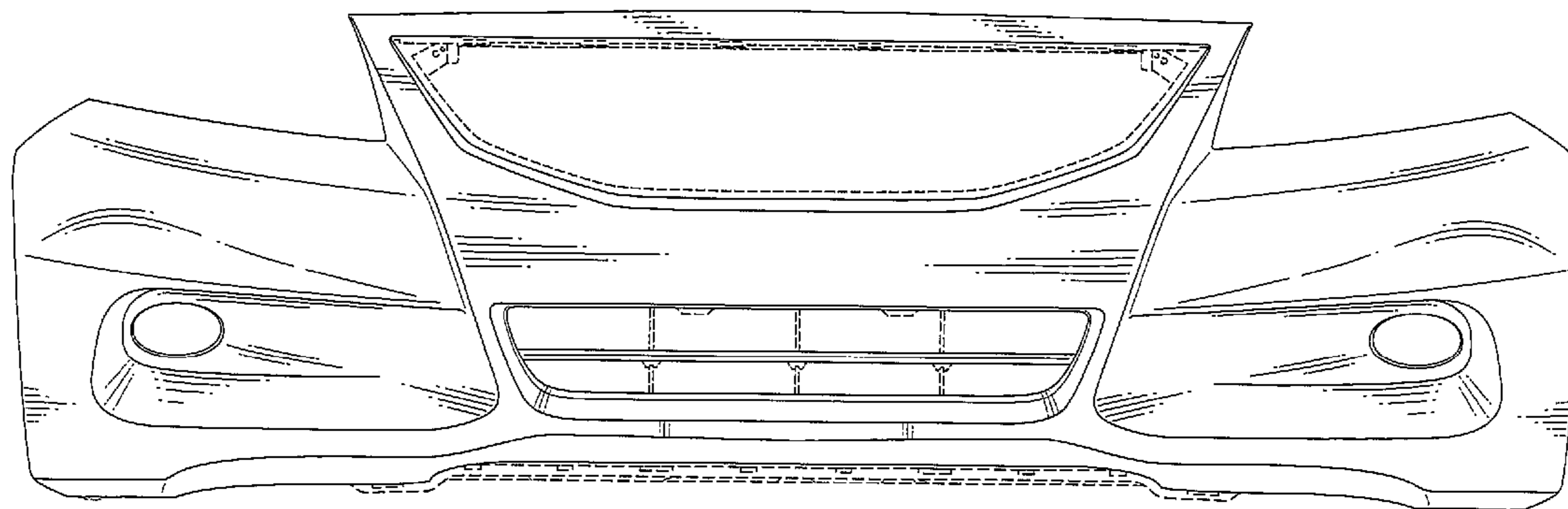

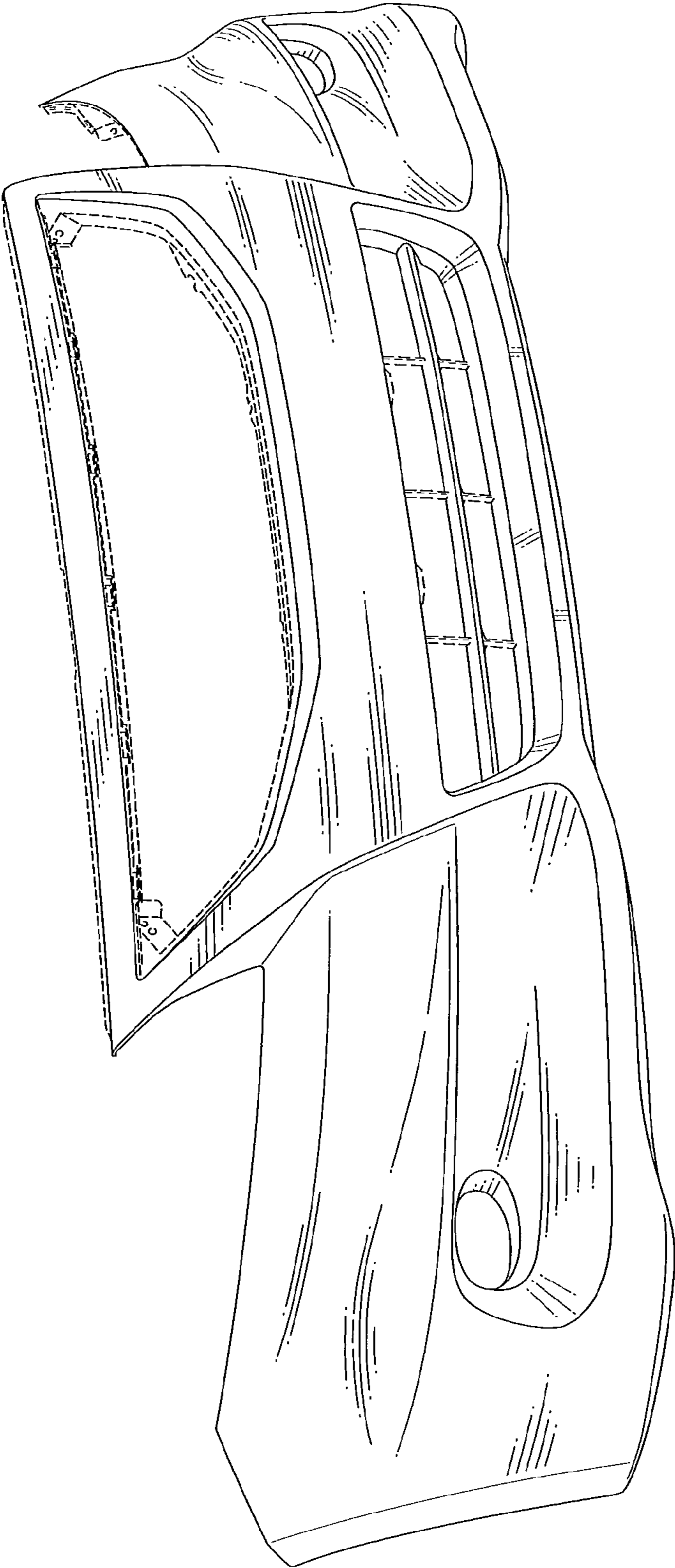

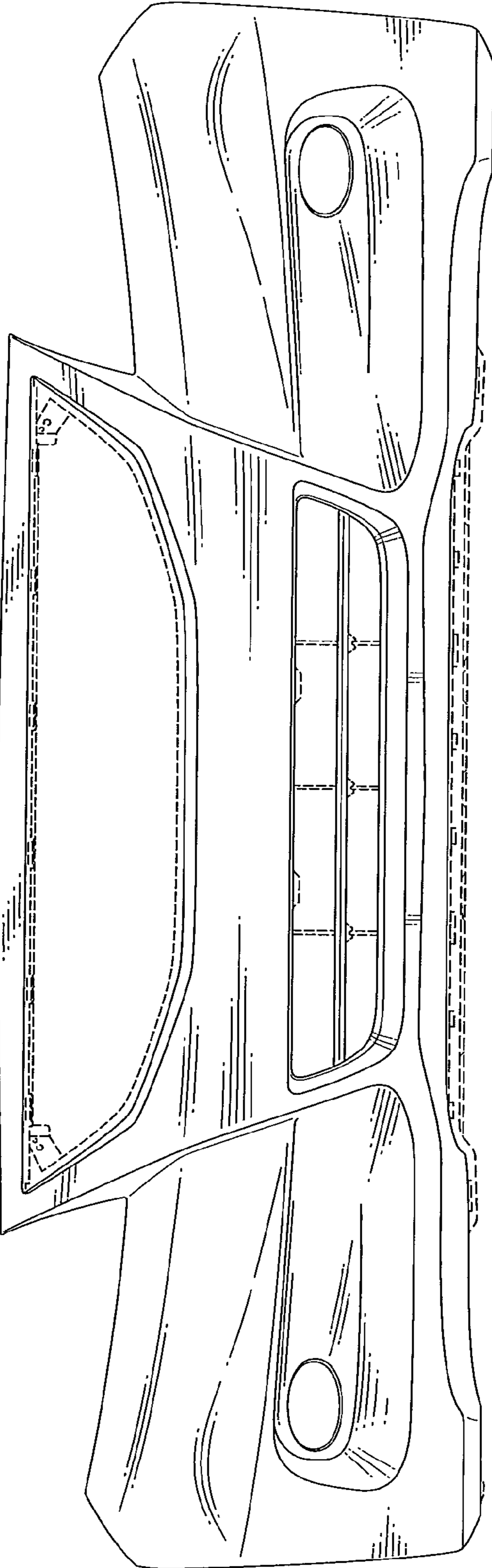

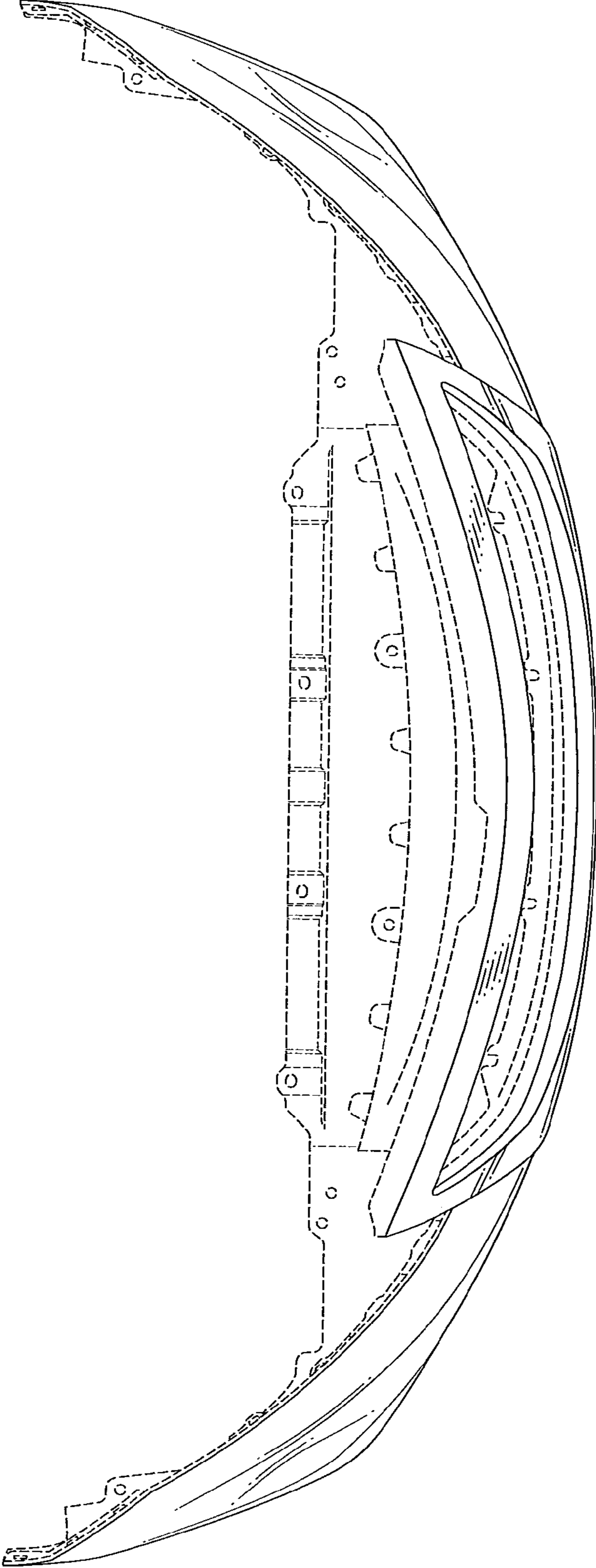
