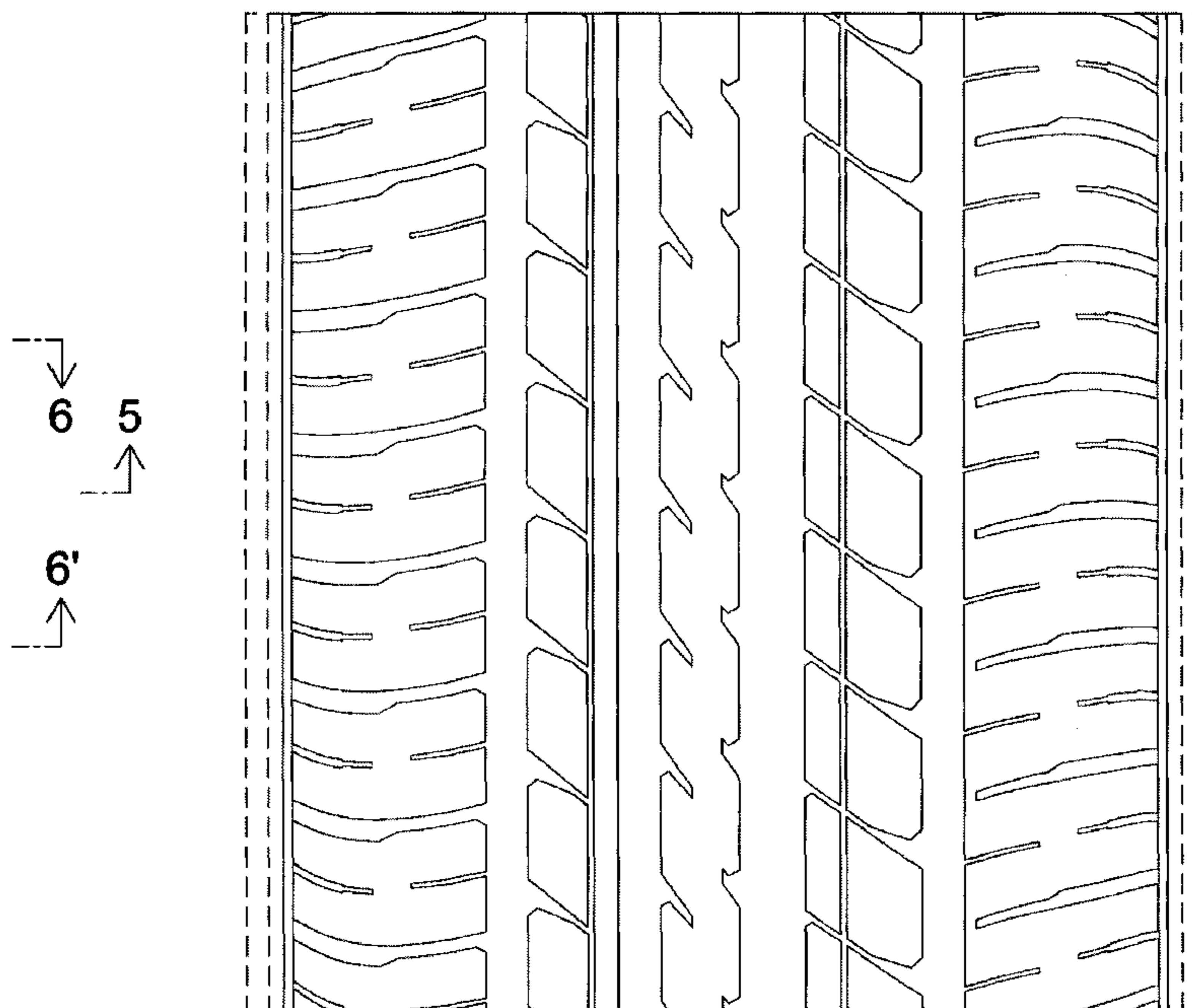
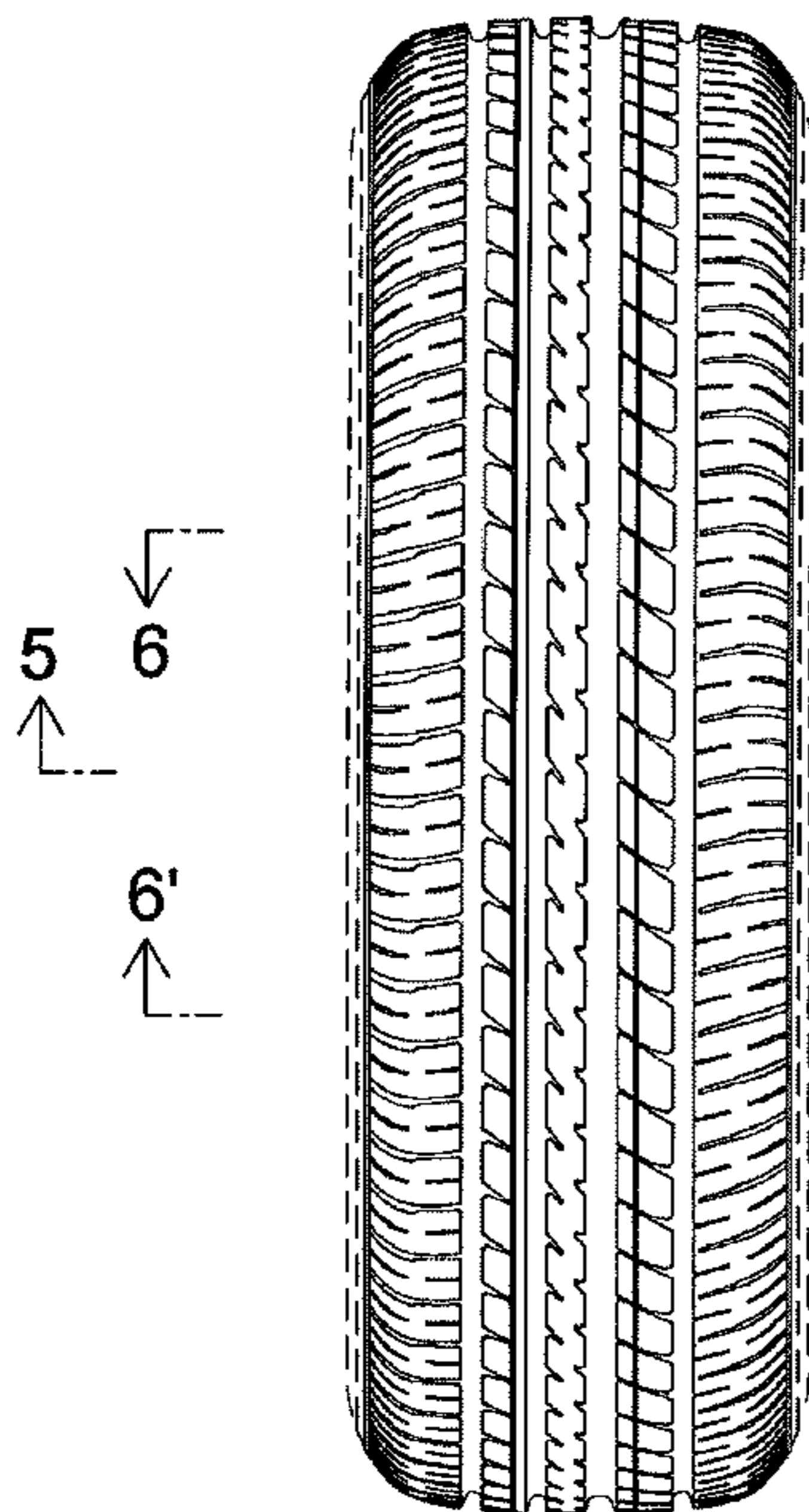
The ornamental design for an automobile tire, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tire showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is an enlarged cross-sectional view taken along line 5—5 in FIG. 2; and, FIG. 9 is an enlarged section view taken along line 6—6 and 6'—6' in FIG. 2.

The broken lines illustrate environmental structure and form no part of the claimed design.

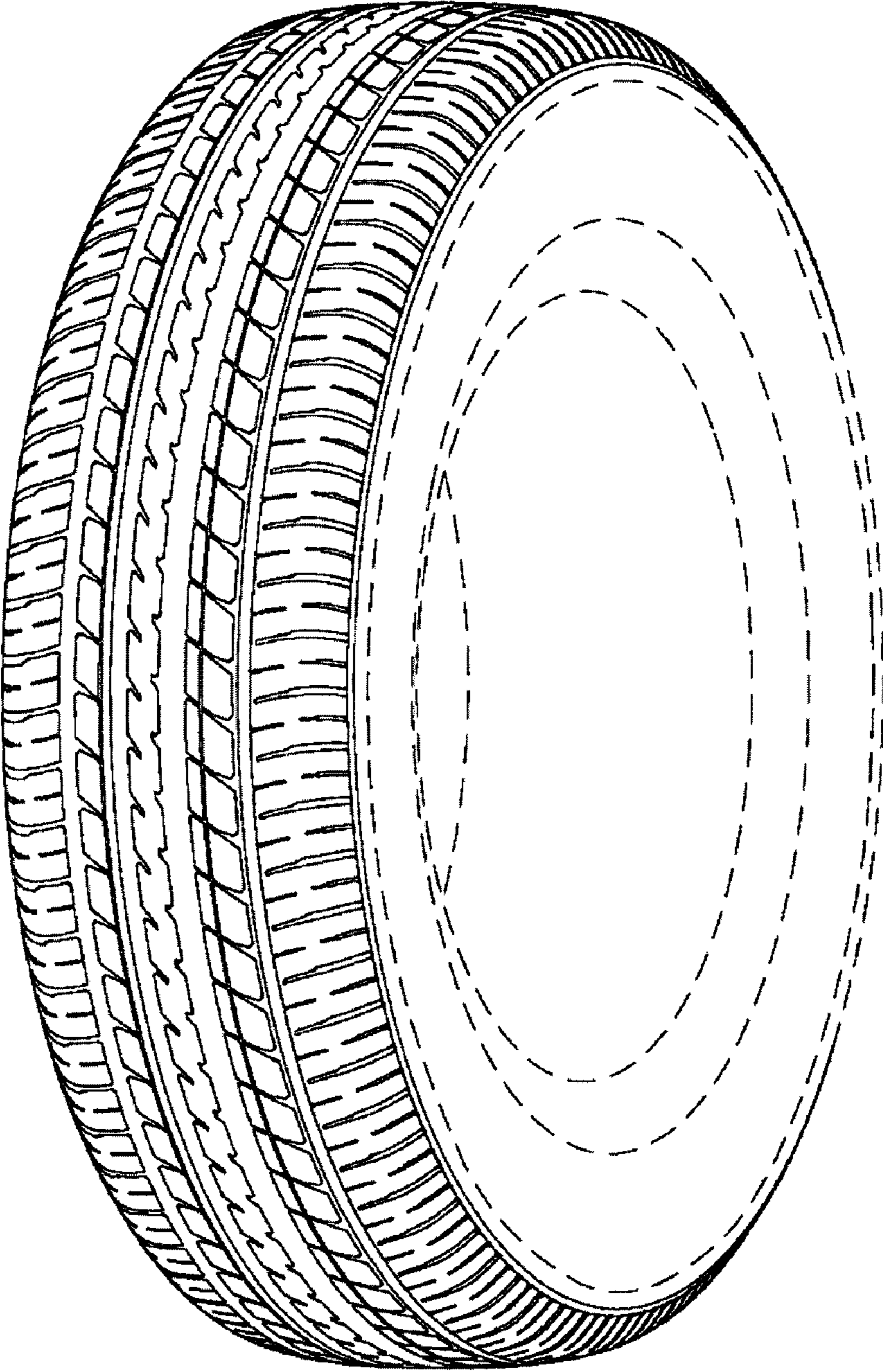

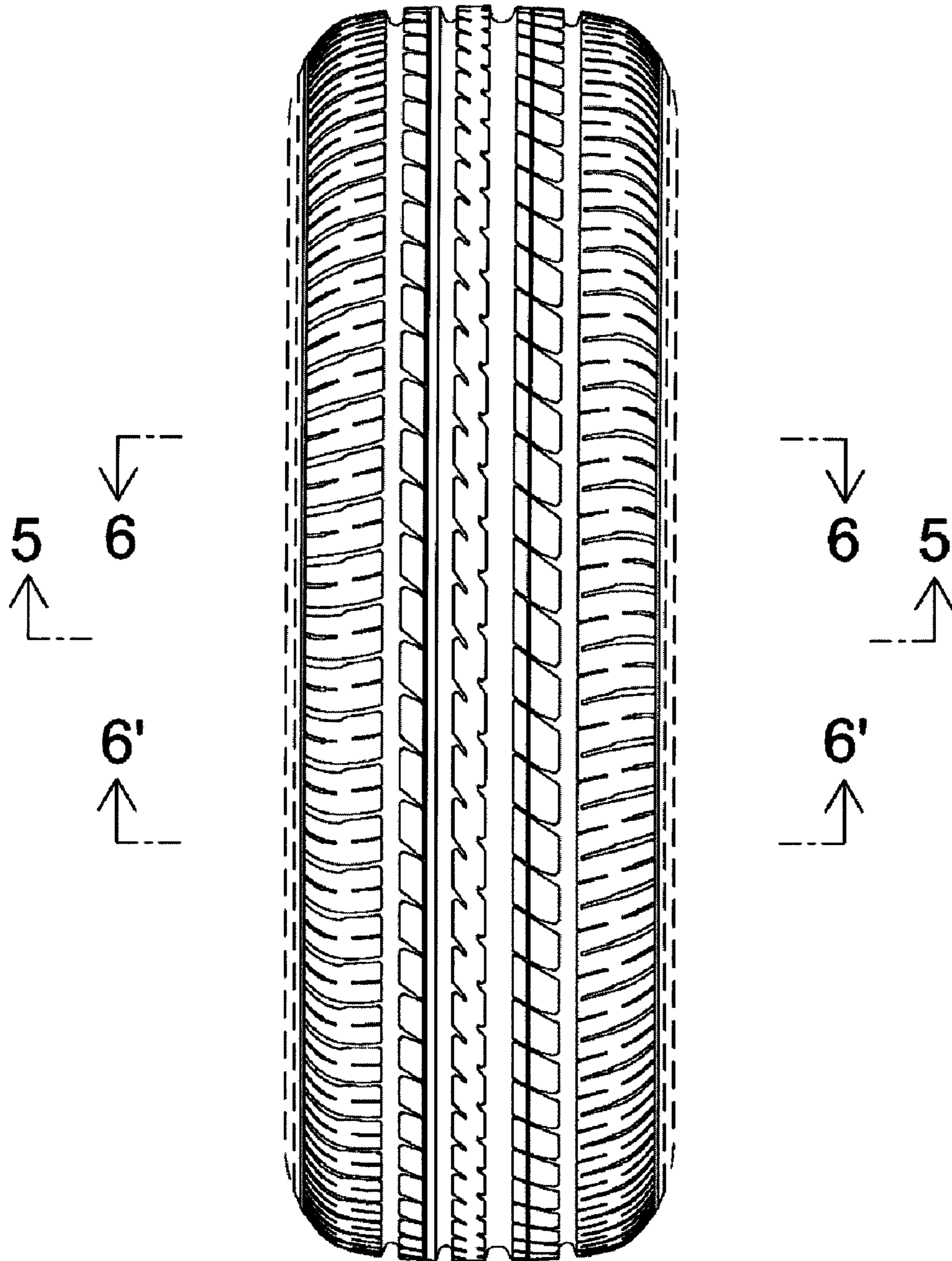

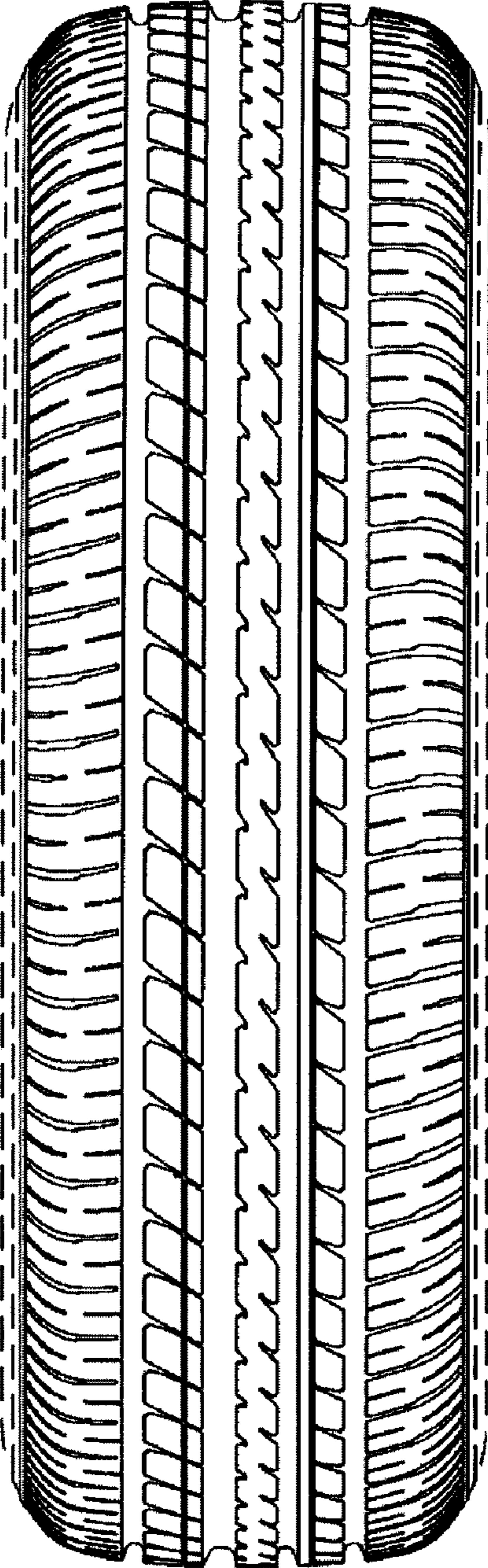

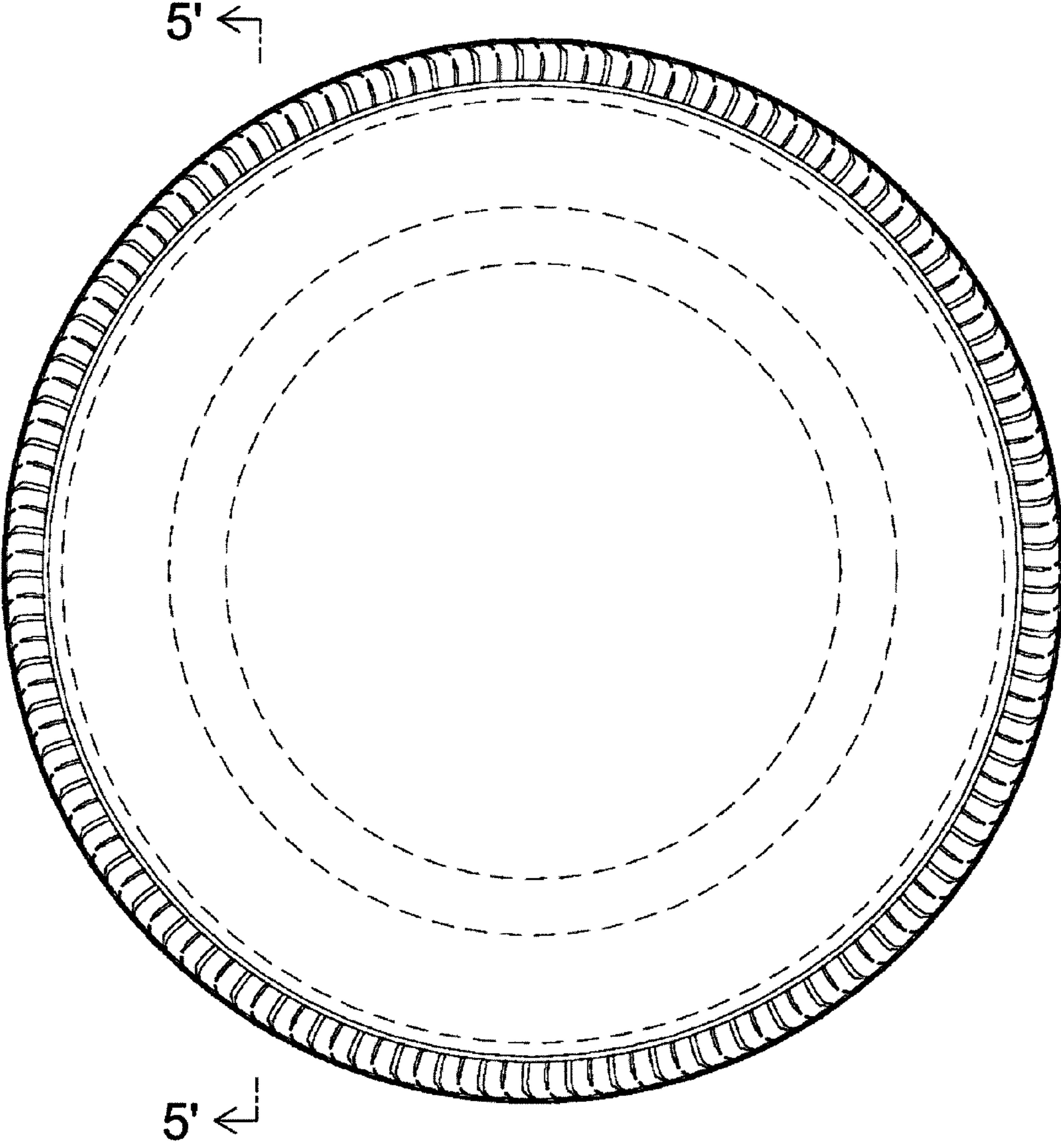

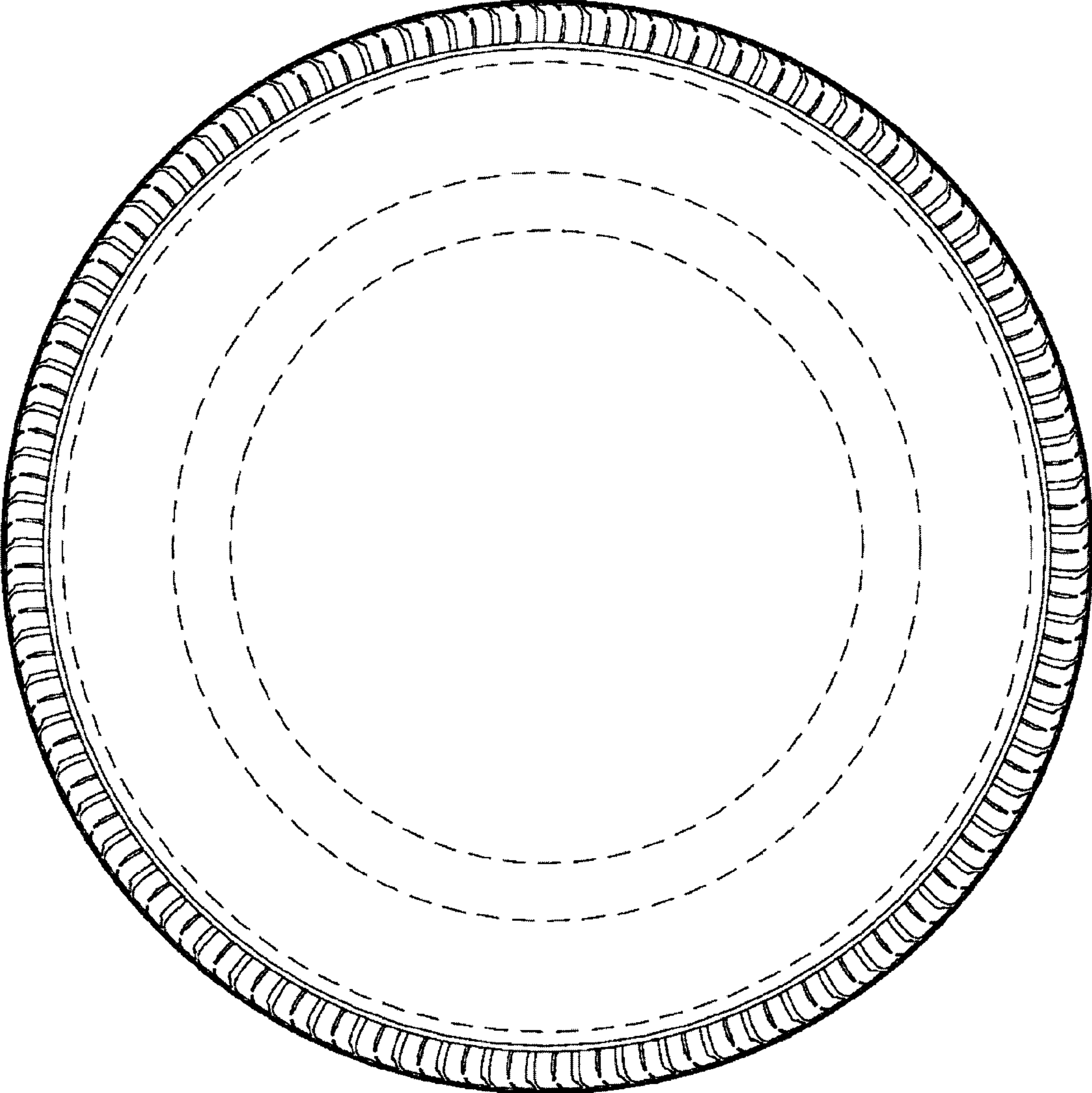

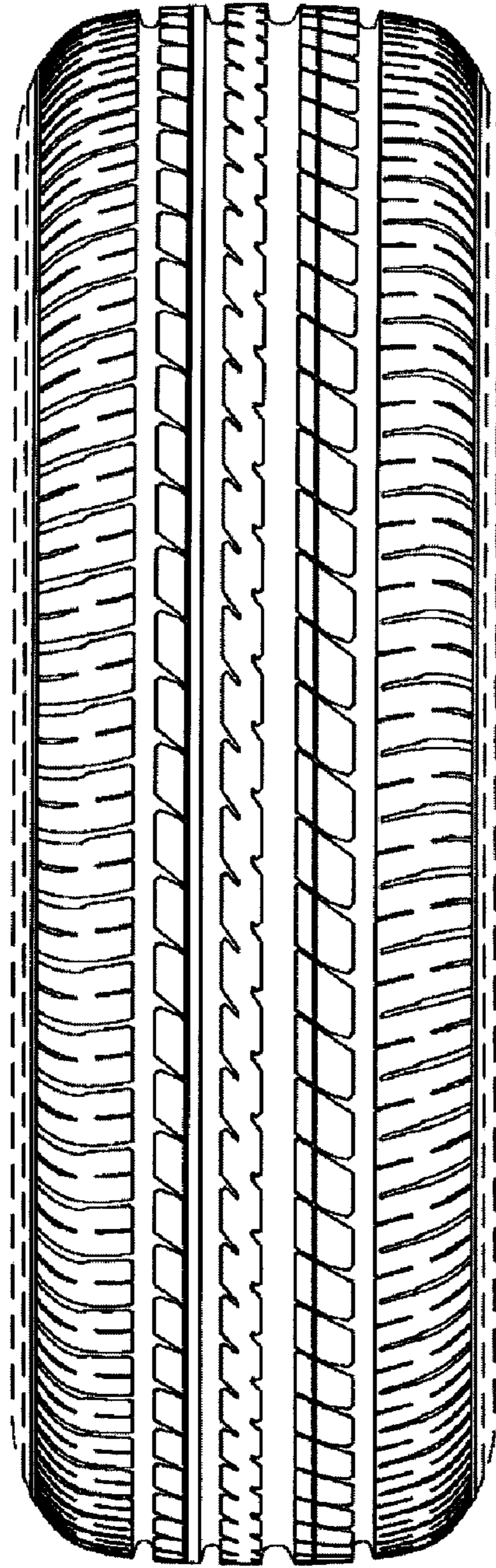

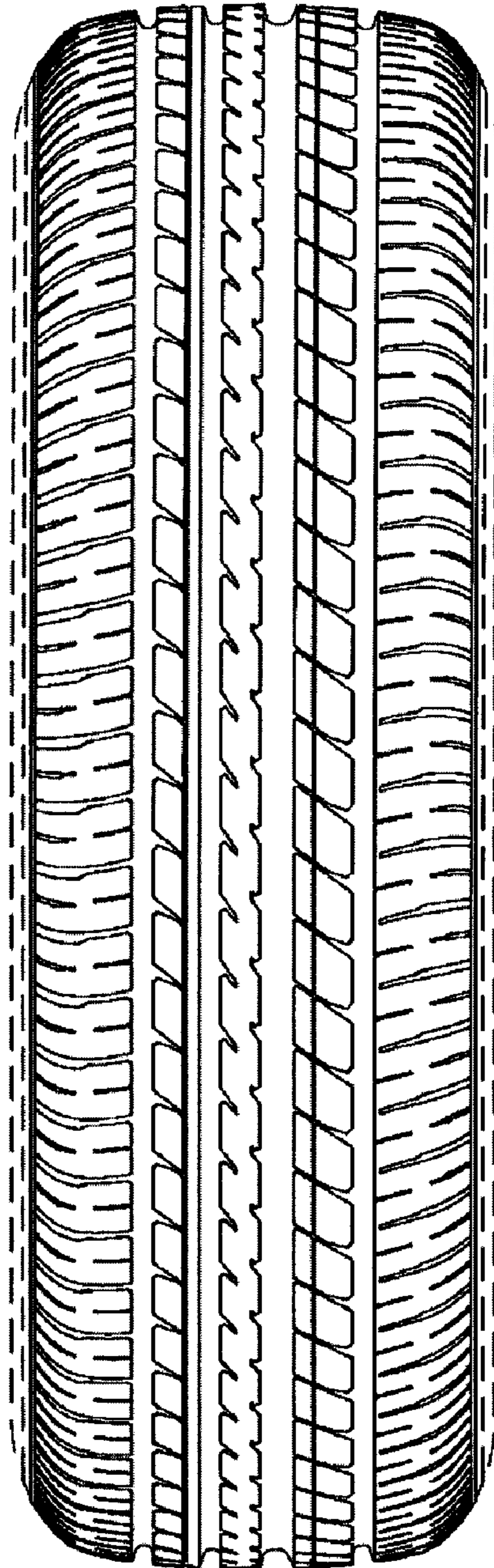

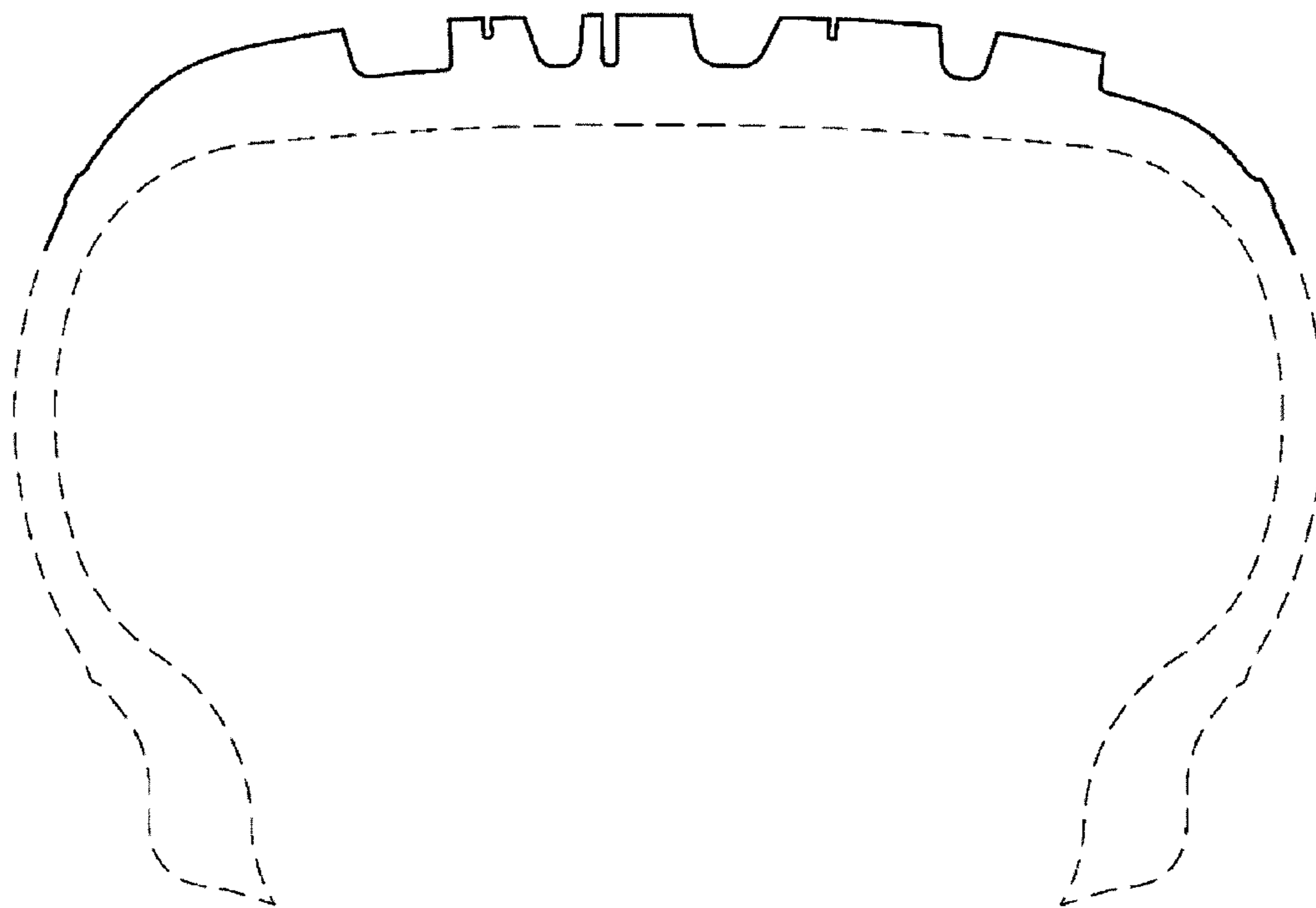

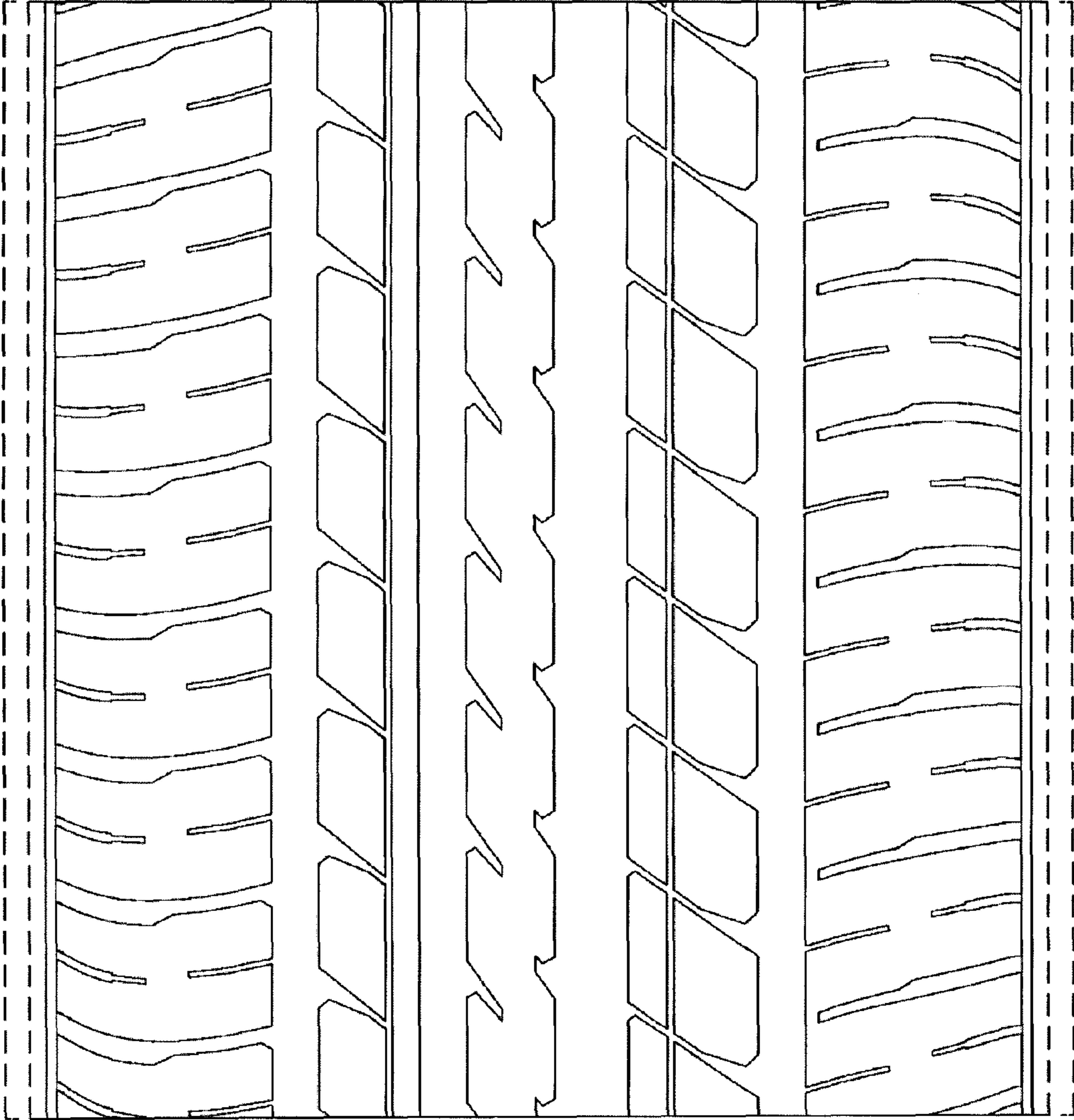
