The ornamental design for a modem, as shown and described.

DESCRIPTION

FIG. 1 is a bottom view of a modem;
FIG. 2 is a right side view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a back view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a front perspective view thereof.
The USB connector, shown only in rear elevation in FIG. 5 is recessed slightly inward from the rear surface.

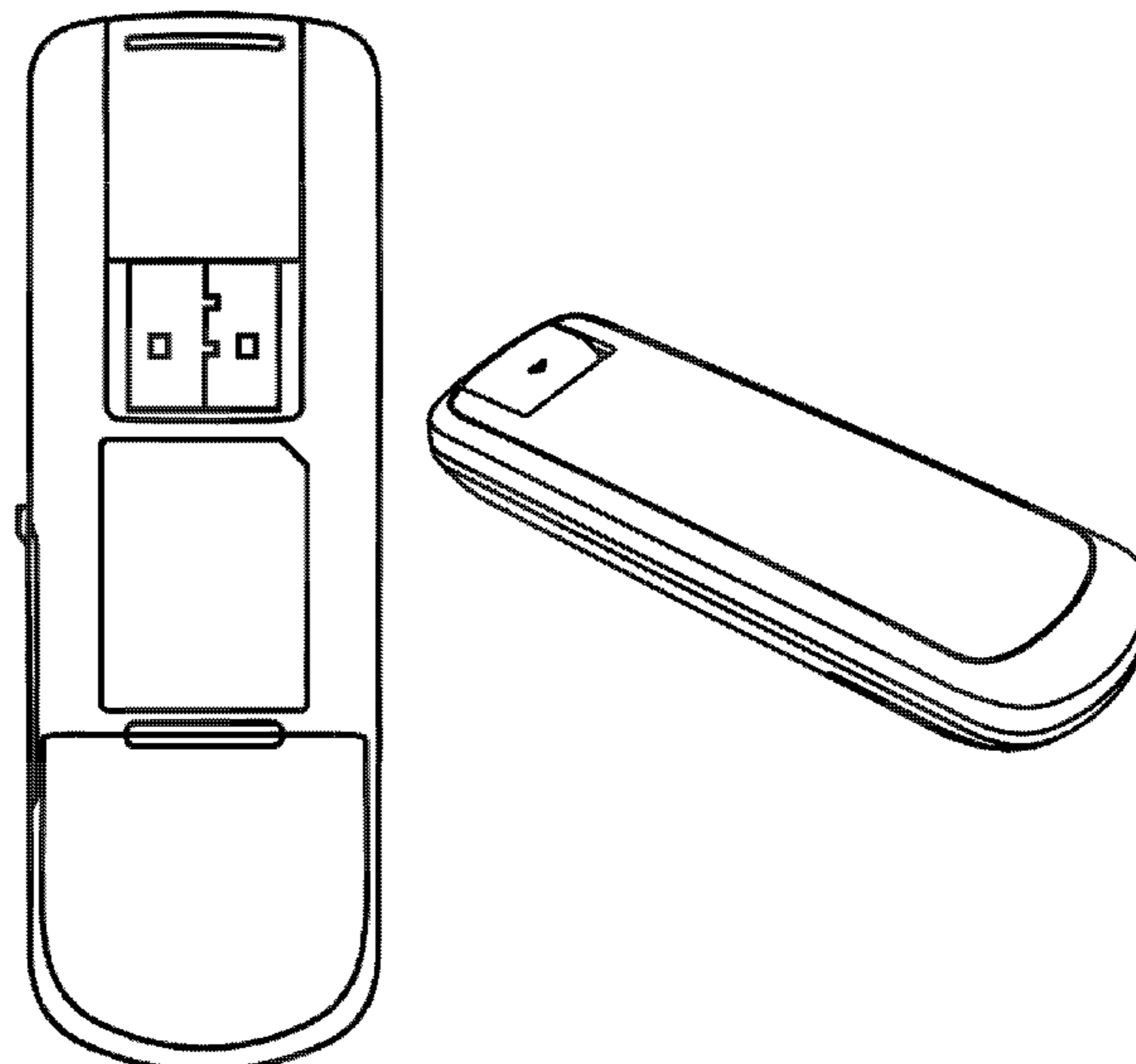

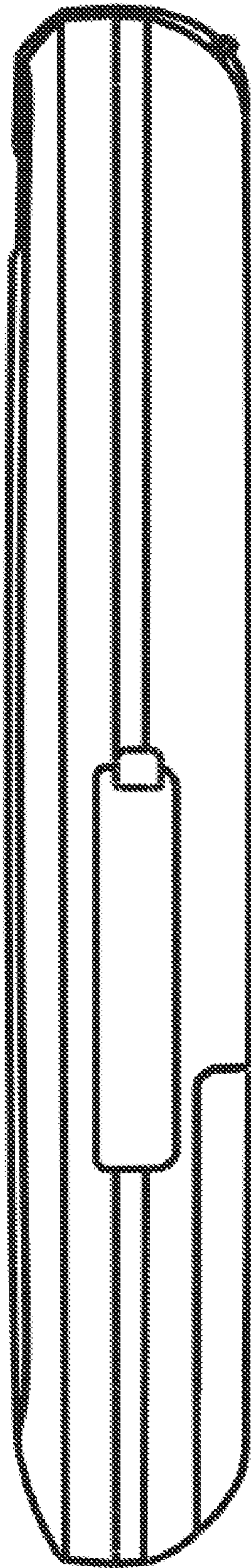

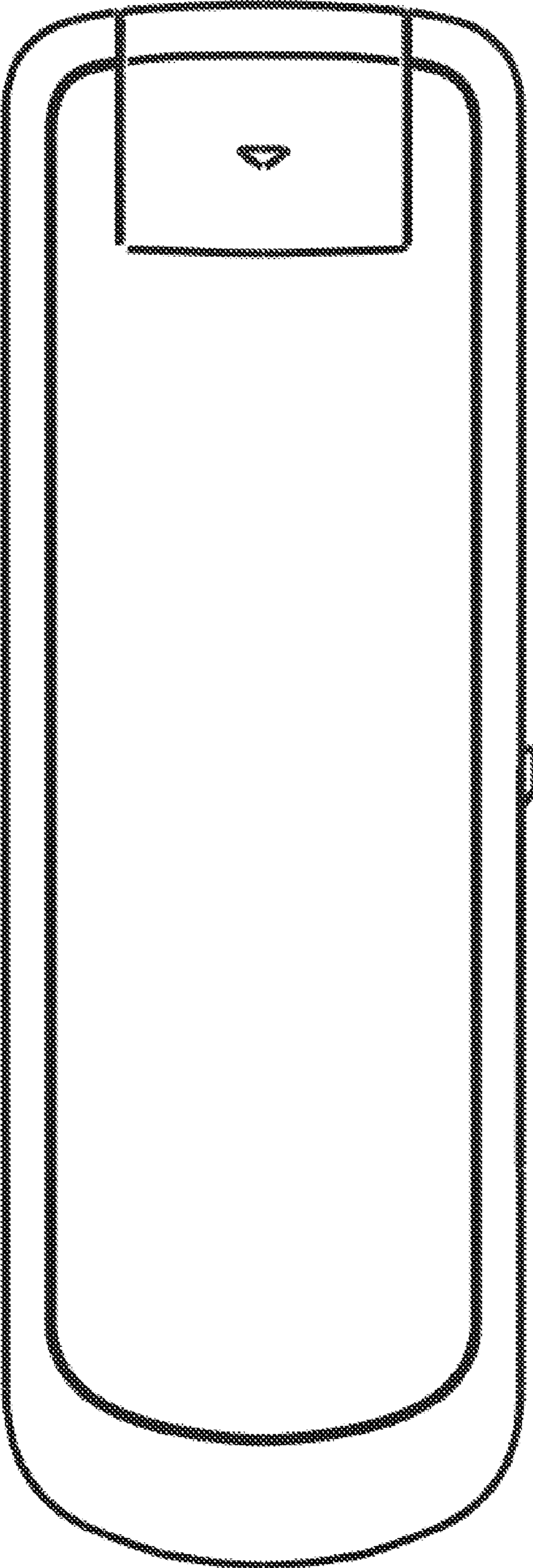

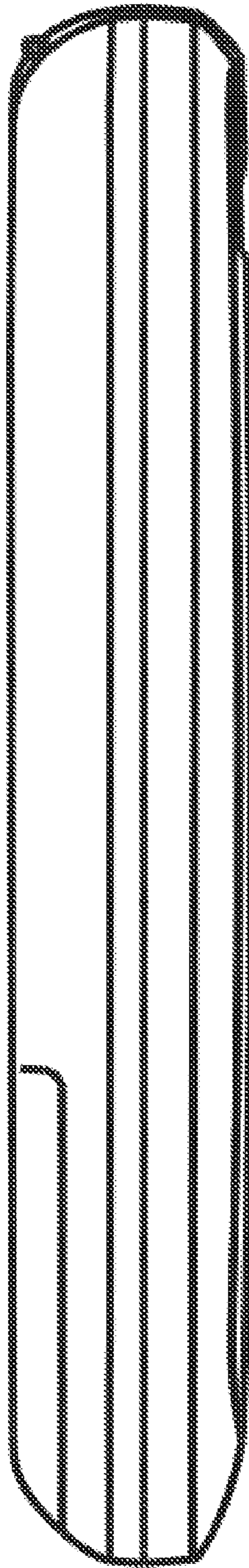

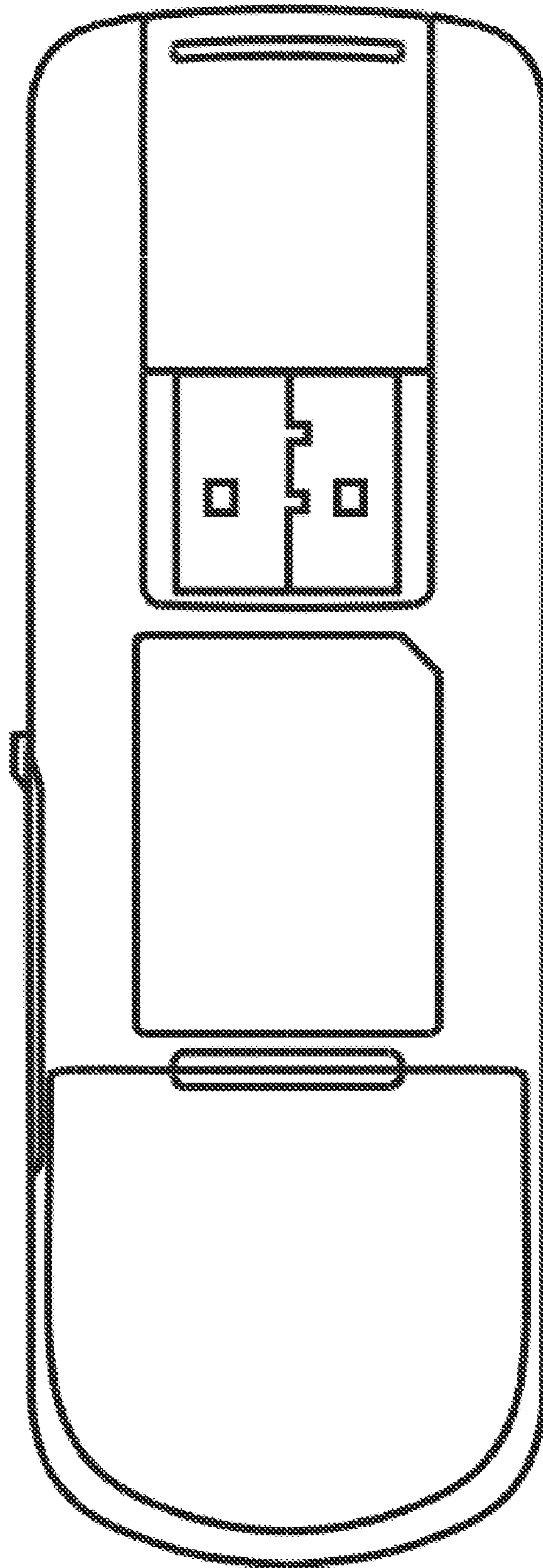

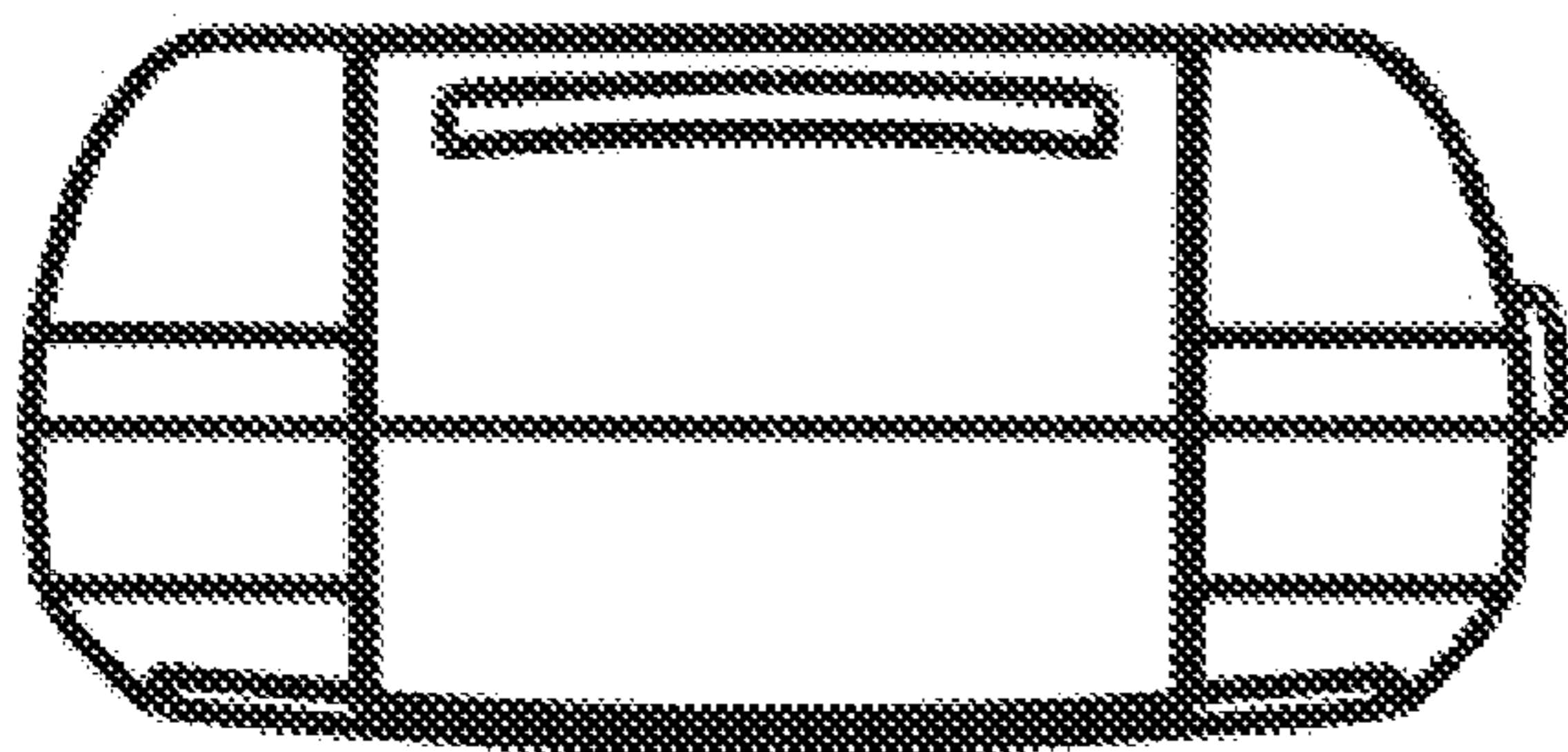

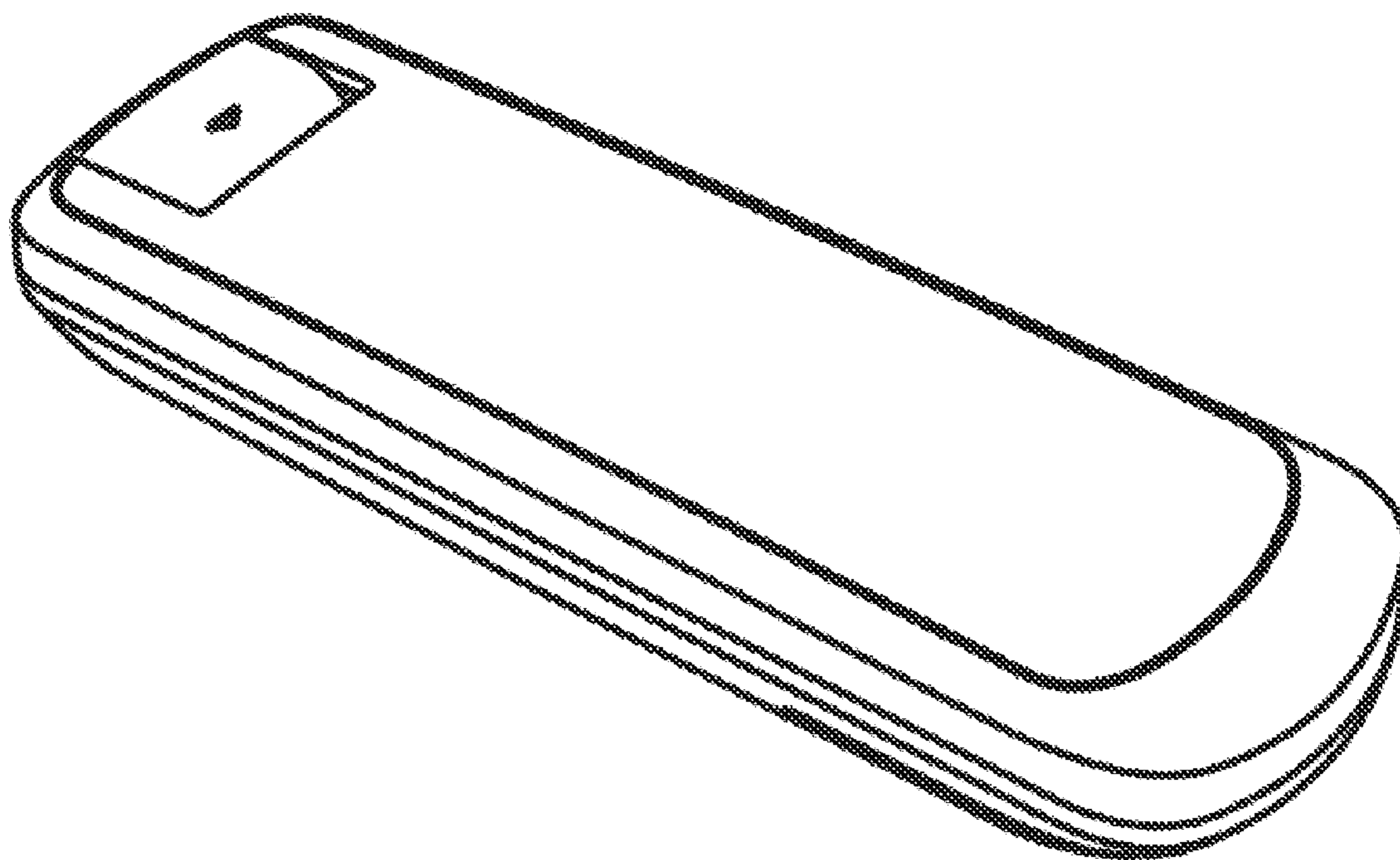
