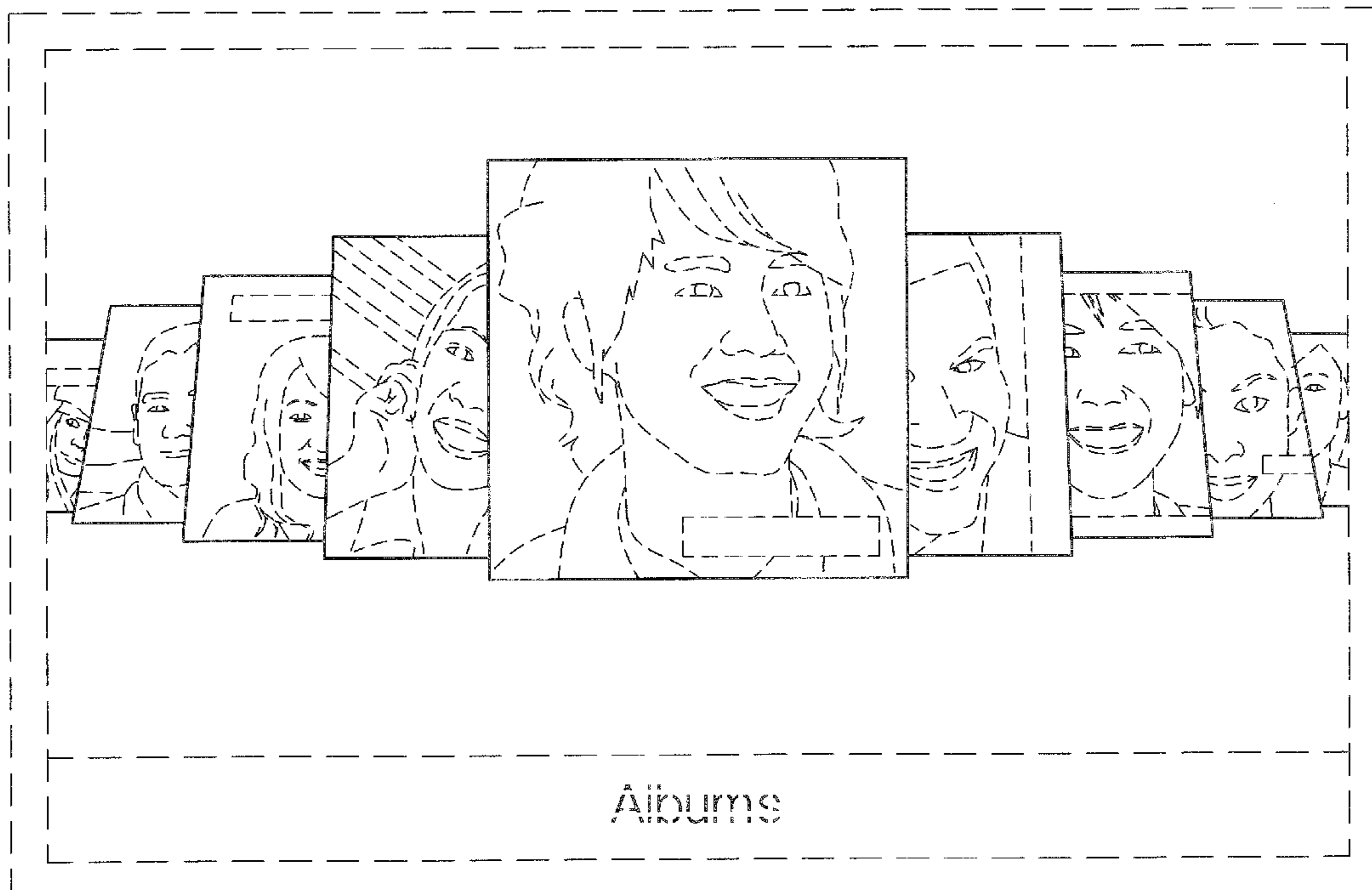
The ornamental design for a transitional graphic user inter-  
face for a display screen, as shown and described.

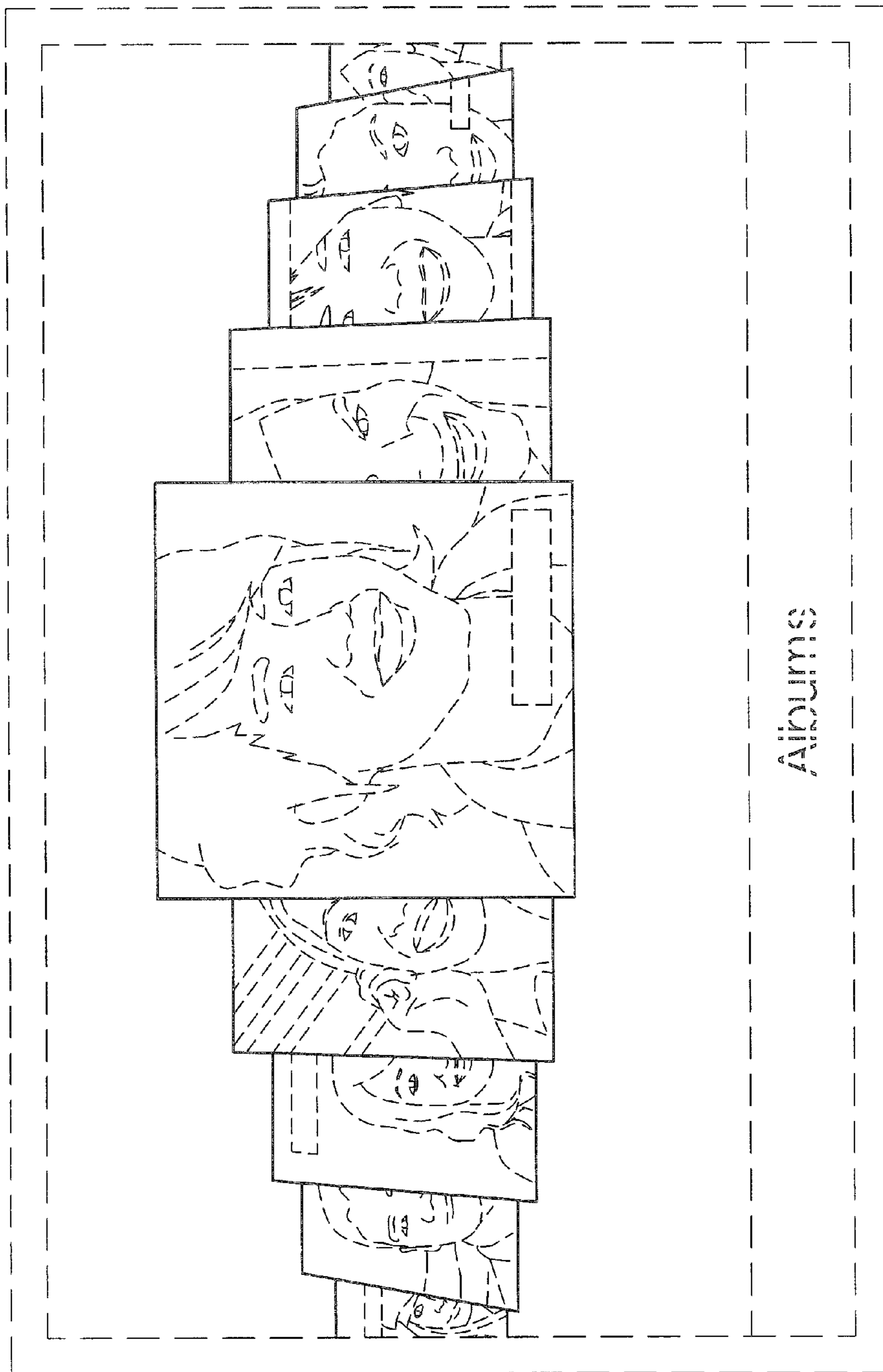
**DESCRIPTION**

FIG. 1 is a front view of a transitional graphic user interface  
for a display screen showing our new design;  
FIG. 2 is a front view of the second image thereof;  
FIG. 3 is a front view of the third image thereof;  
FIG. 4 is a front view of the fourth image thereof; and,  
FIG. 5 is a front view of the fifth image thereof.

The broken line showings of the display screen, patterns, and  
characters are for illustrative purposes only and form no part  
of the claimed design. The appearance of the transitional  
image sequentially transitions between the images shown in  
FIGS. 1-5. The process or period in which one image transi-  
tions to another image forms no part of the claimed design.

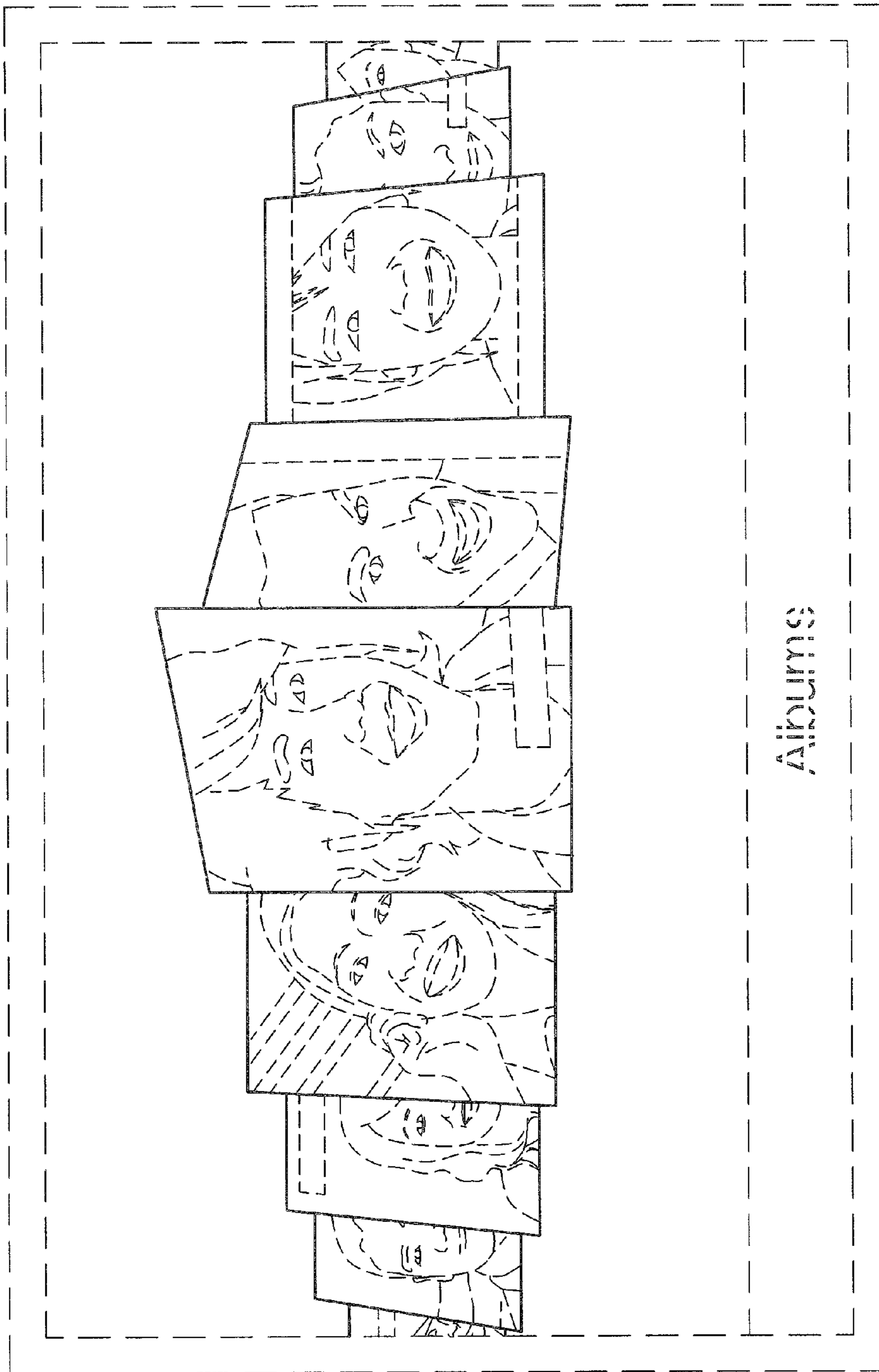

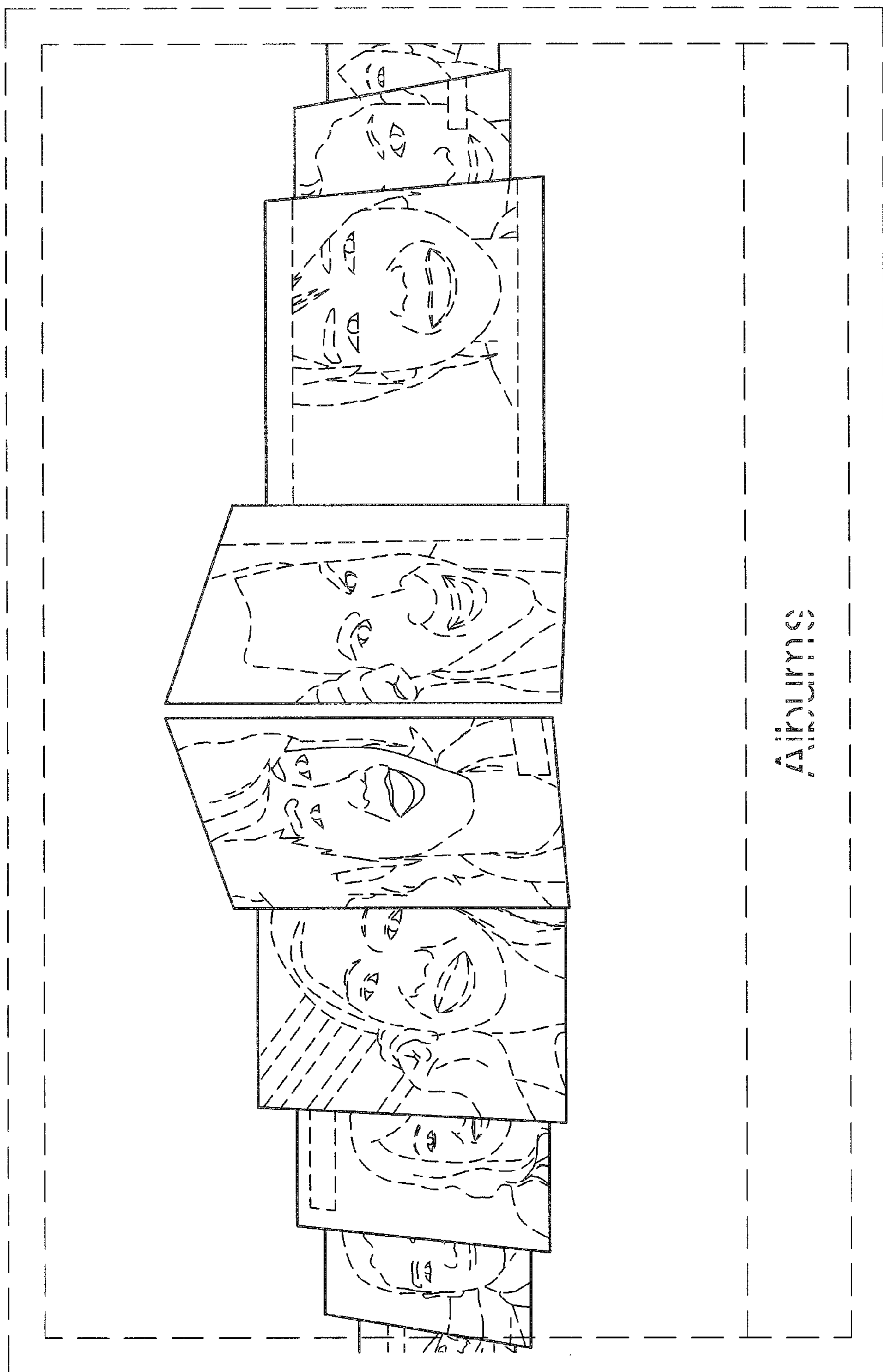
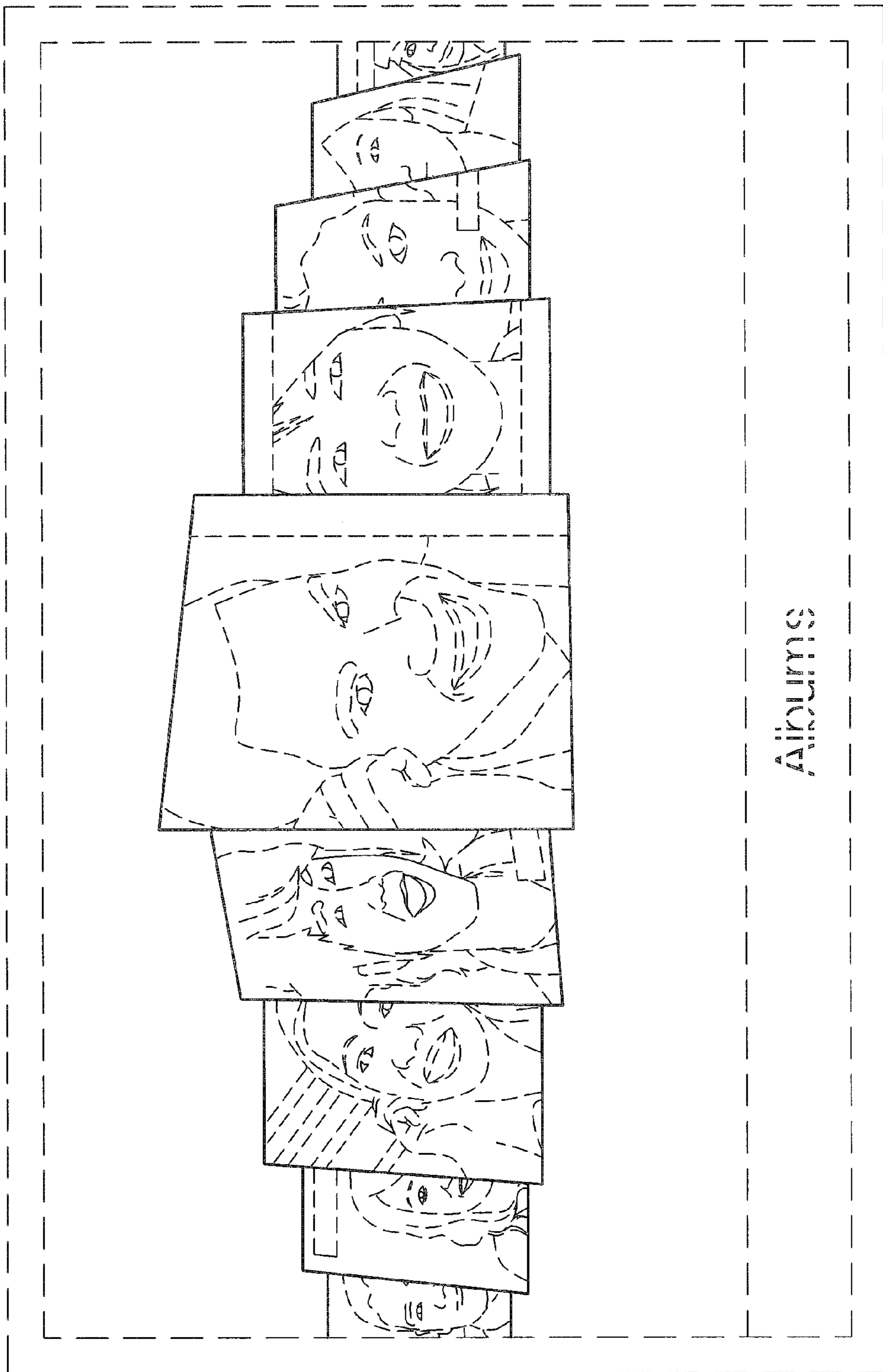

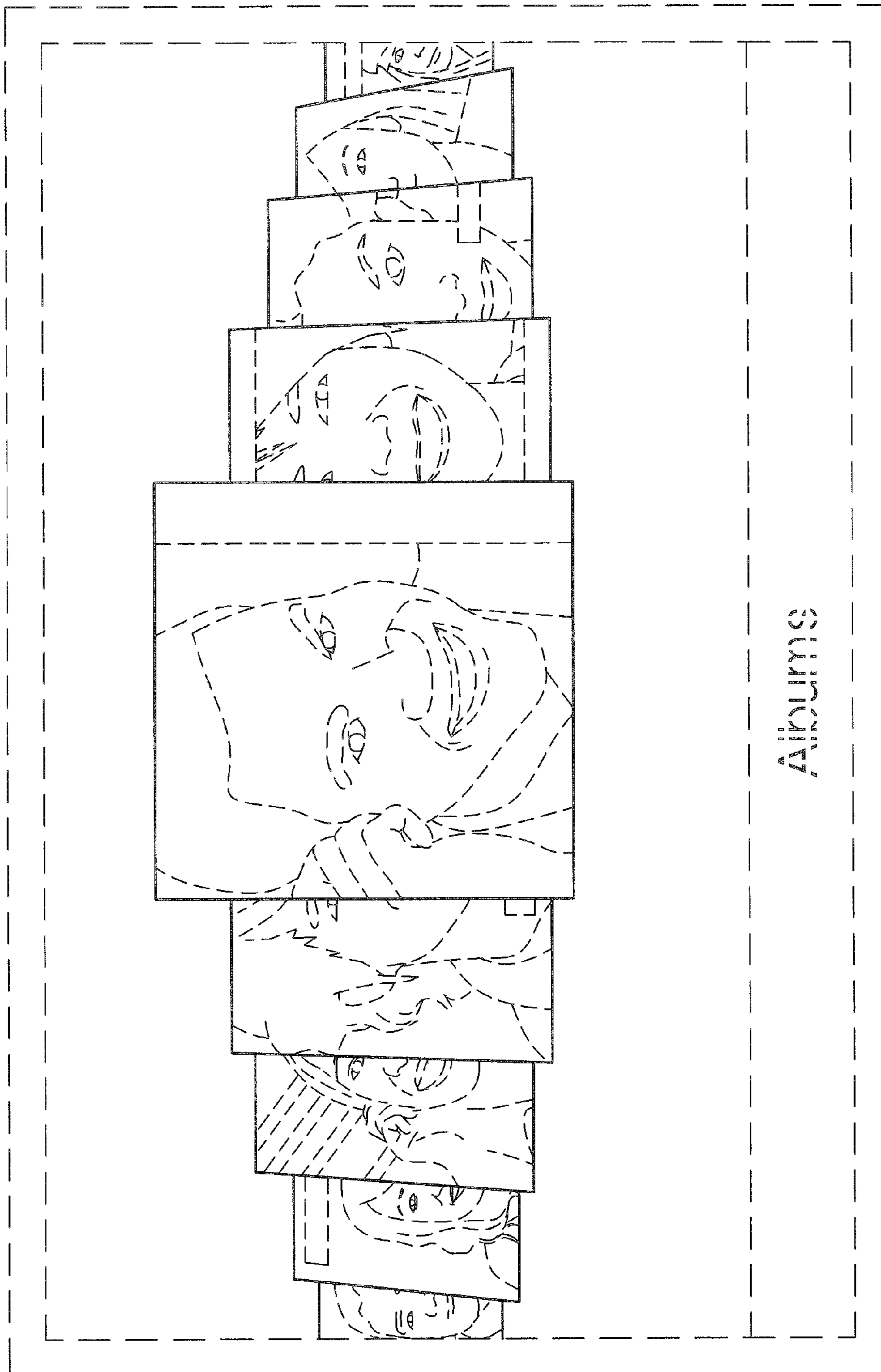
