(57) **CLAIM**

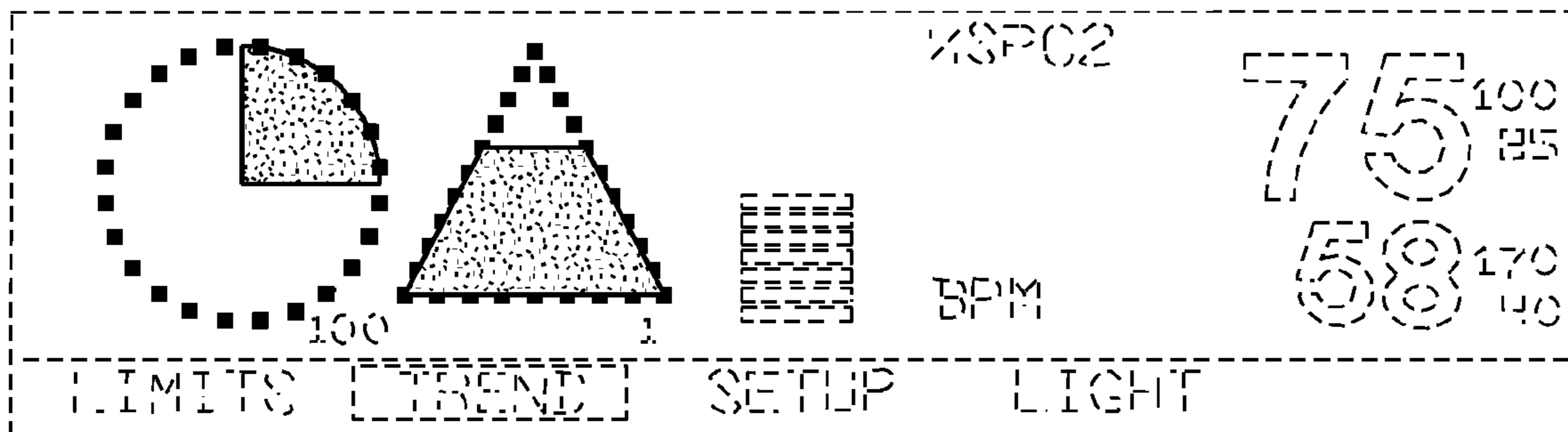
The ornamental design for a portion of a display screen with indicator icons, as shown and described.

**DESCRIPTION**

The FIGURE is a front view of a portion of a display screen with indicator icons shown in the environment of a pulse oximetry monitor, where the circular indicator is about one quarter full and the triangular indicator is about three quarters full.

The broken line showings of the portion of the display screen and various regions thereof are included for the purpose of illustrating unclaimed portions of the portion of a display screen with indicator icons and form no part of the claimed design.
