FIG. 2 is a front elevational view thereof.

FIG. 3 is a rear elevational view thereof.

FIG. 4 is a right side elevational view thereof.

FIG. 5 is a left side elevational view thereof.

FIG. 6 is a top plan view thereof.

FIG. 7 is a bottom plan view thereof.

FIG. 8 is a top, rear perspective view thereof.

FIG. 9 is a top, rear perspective view of a second embodiment of the desktop figurine of FIG. 1.

FIG. 10 is a top, front perspective view thereof.

FIG. 11 is another top, front perspective view thereof; and,

FIG. 12 is another top, rear perspective view thereof.

The broken lines in the drawings showing the lower part of the desktop figurine, the small rectangle on the rear, the cord around the neck, and the large rectangular insert on the rear are included for the purpose of illustrating features that form no part of the claimed design.

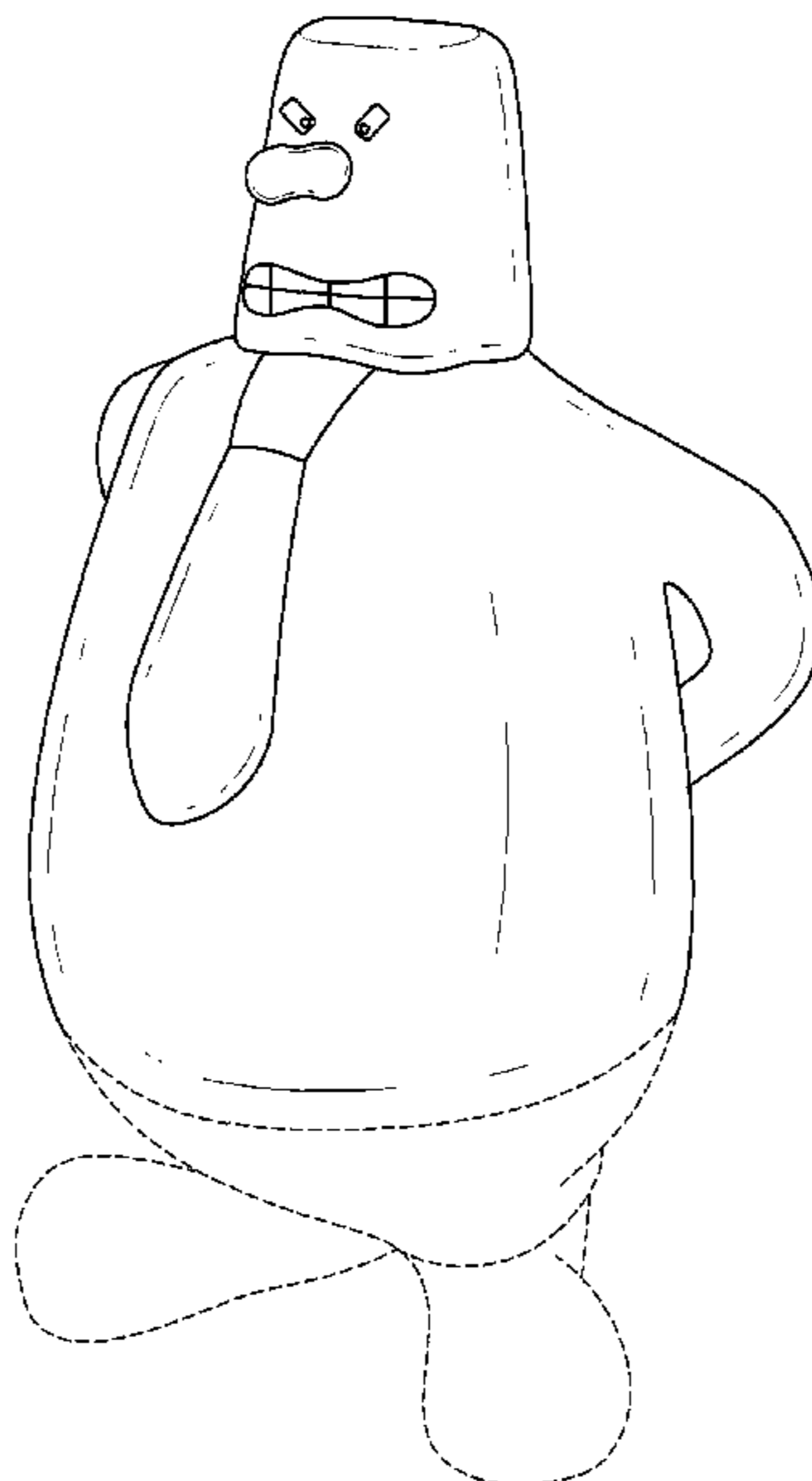

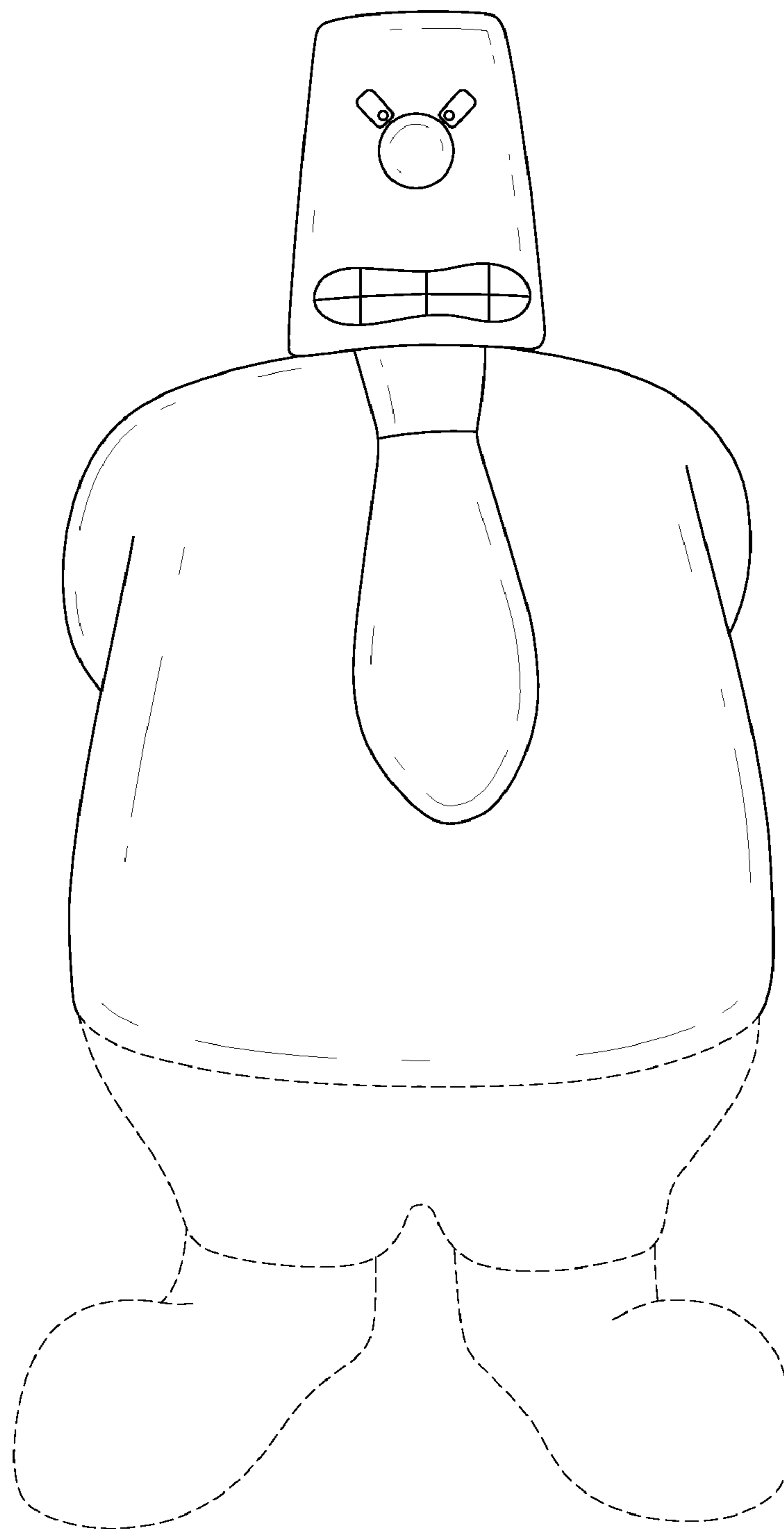

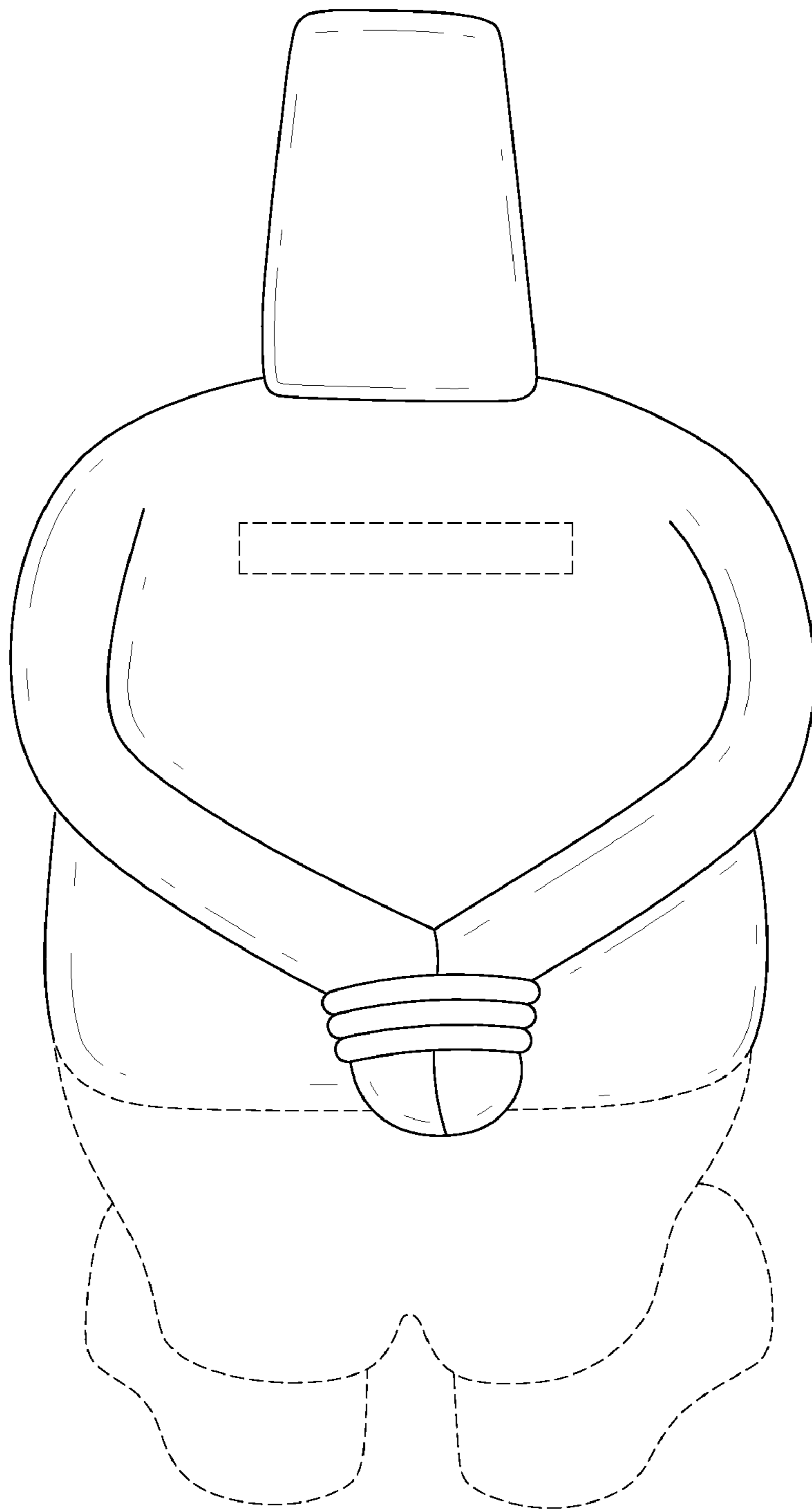

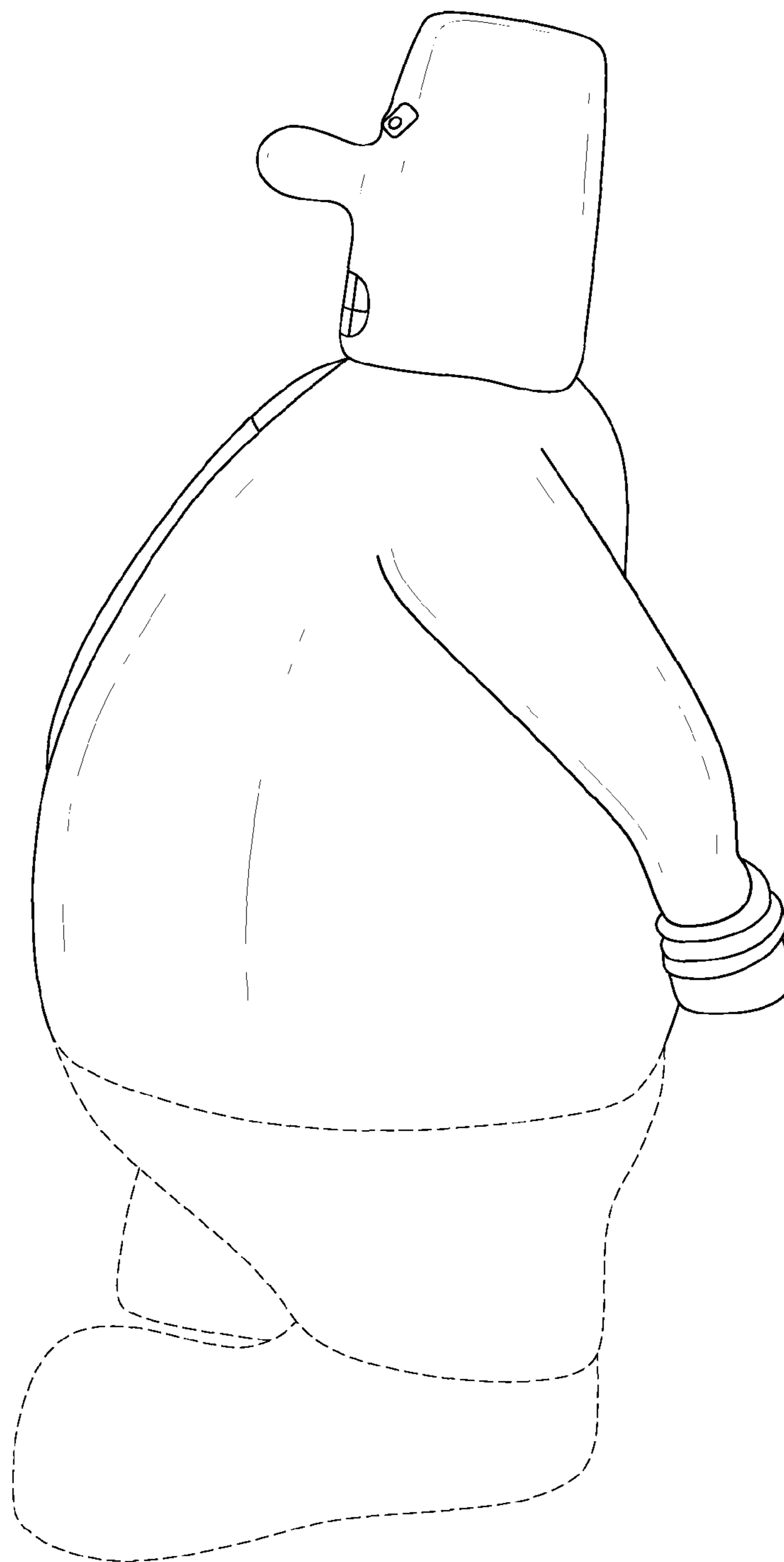

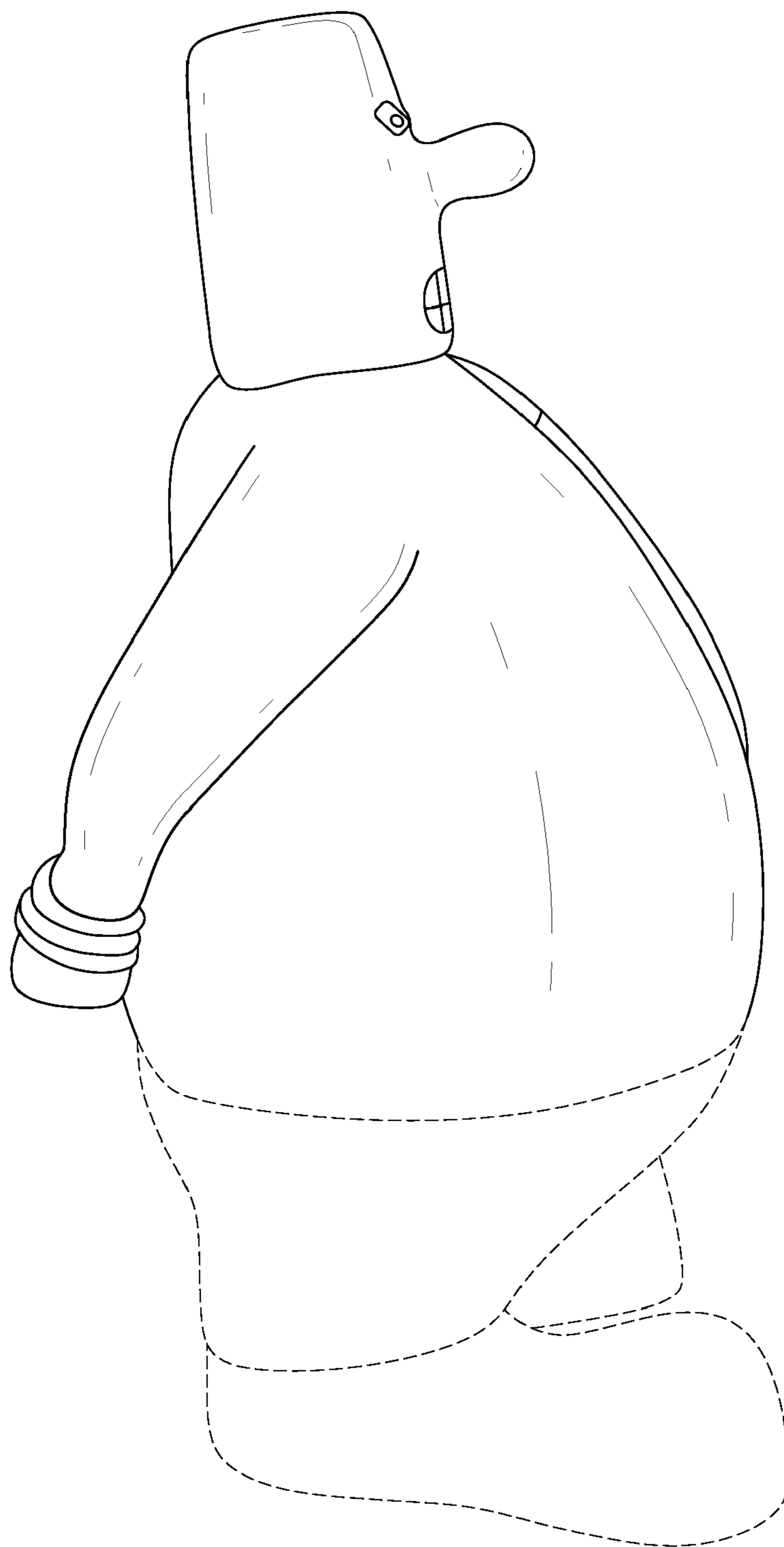

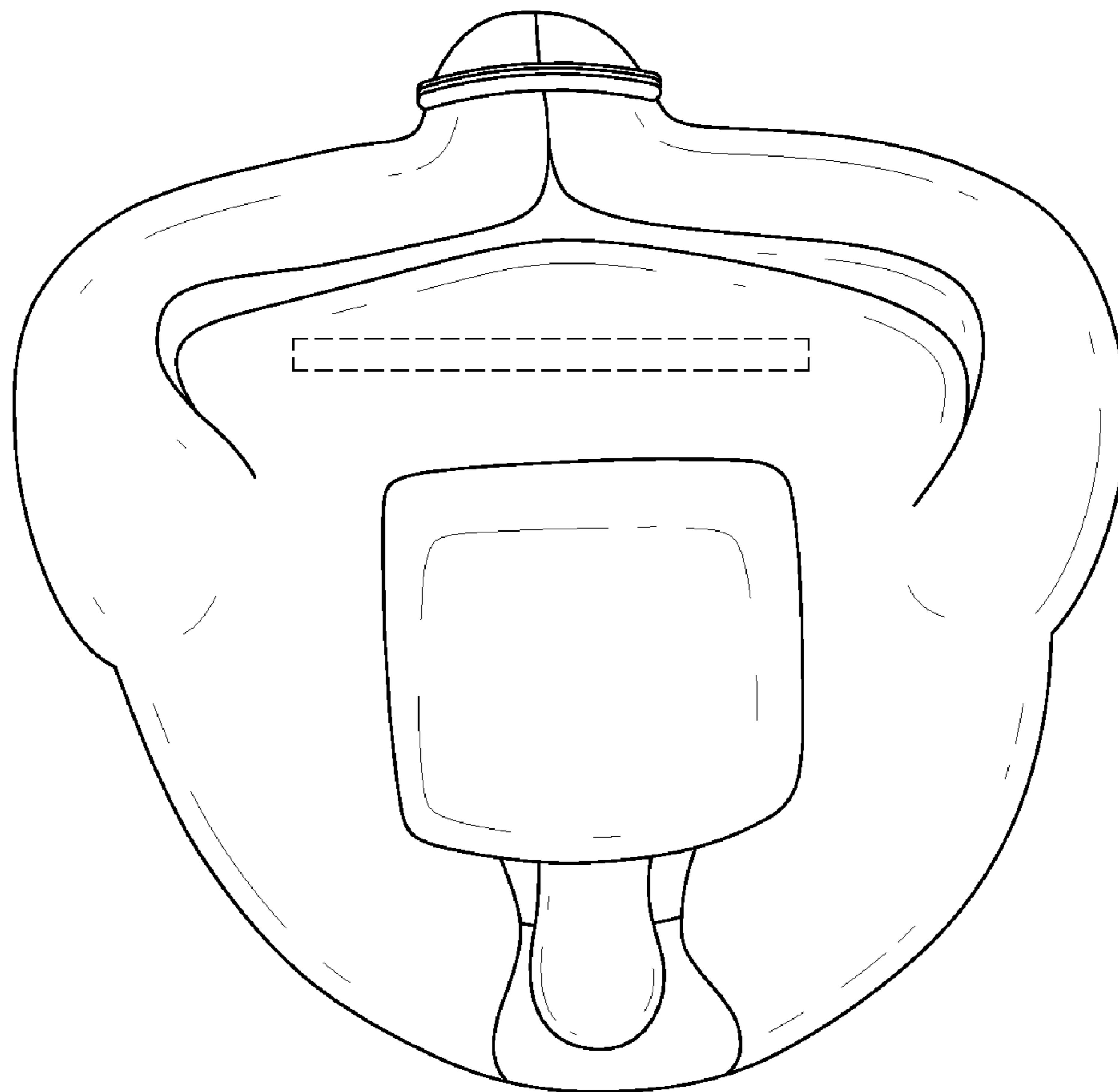

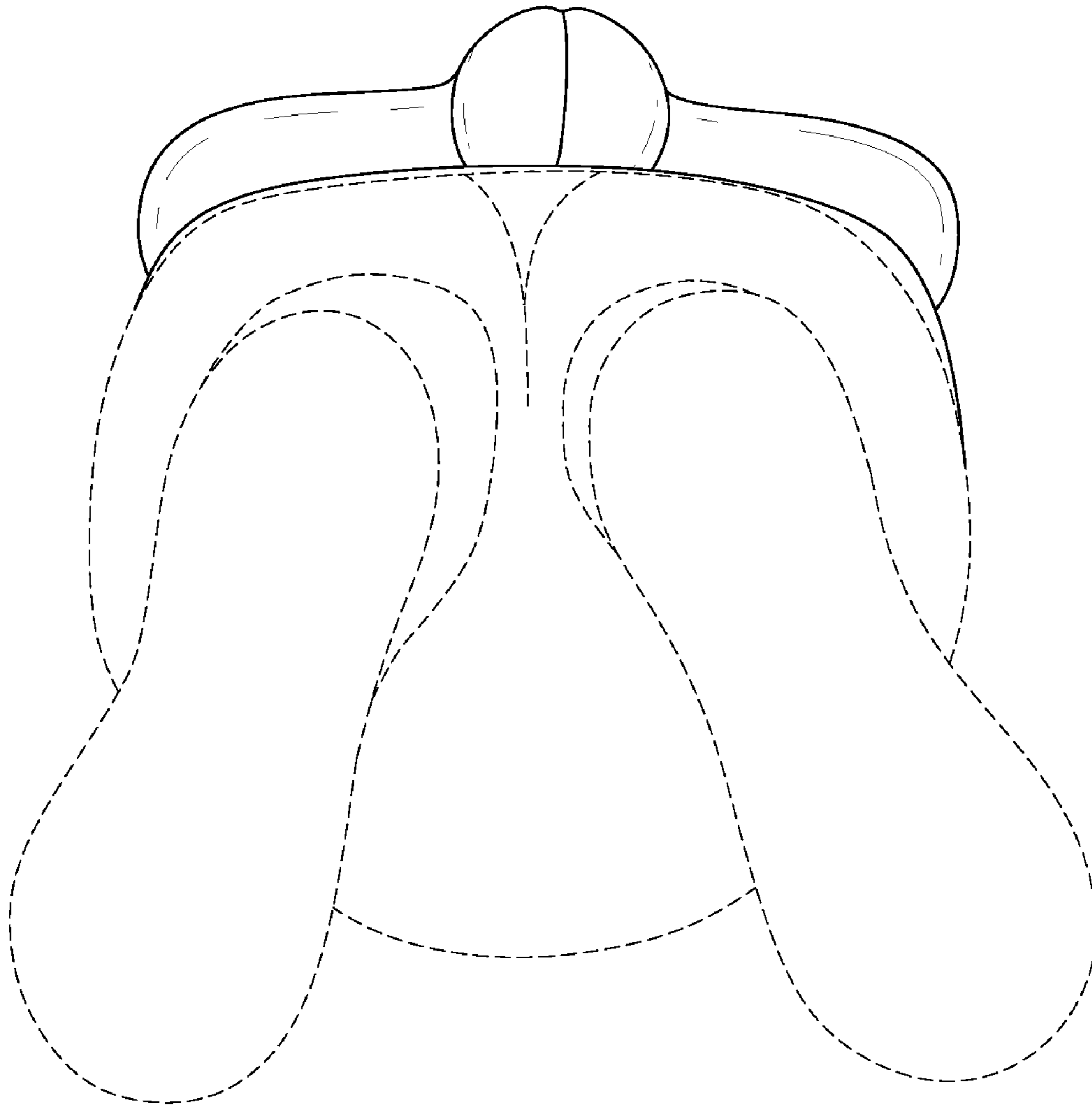

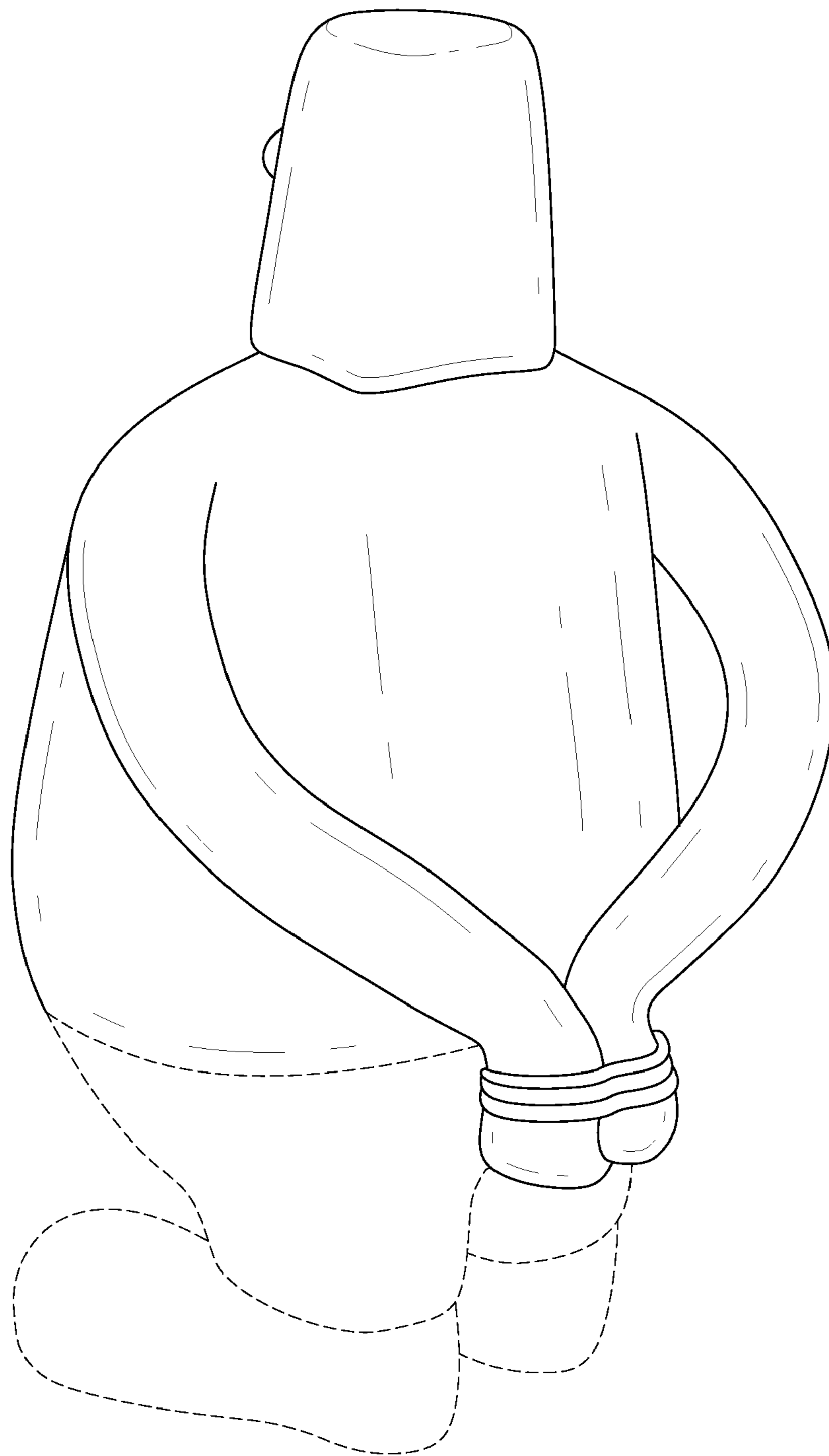

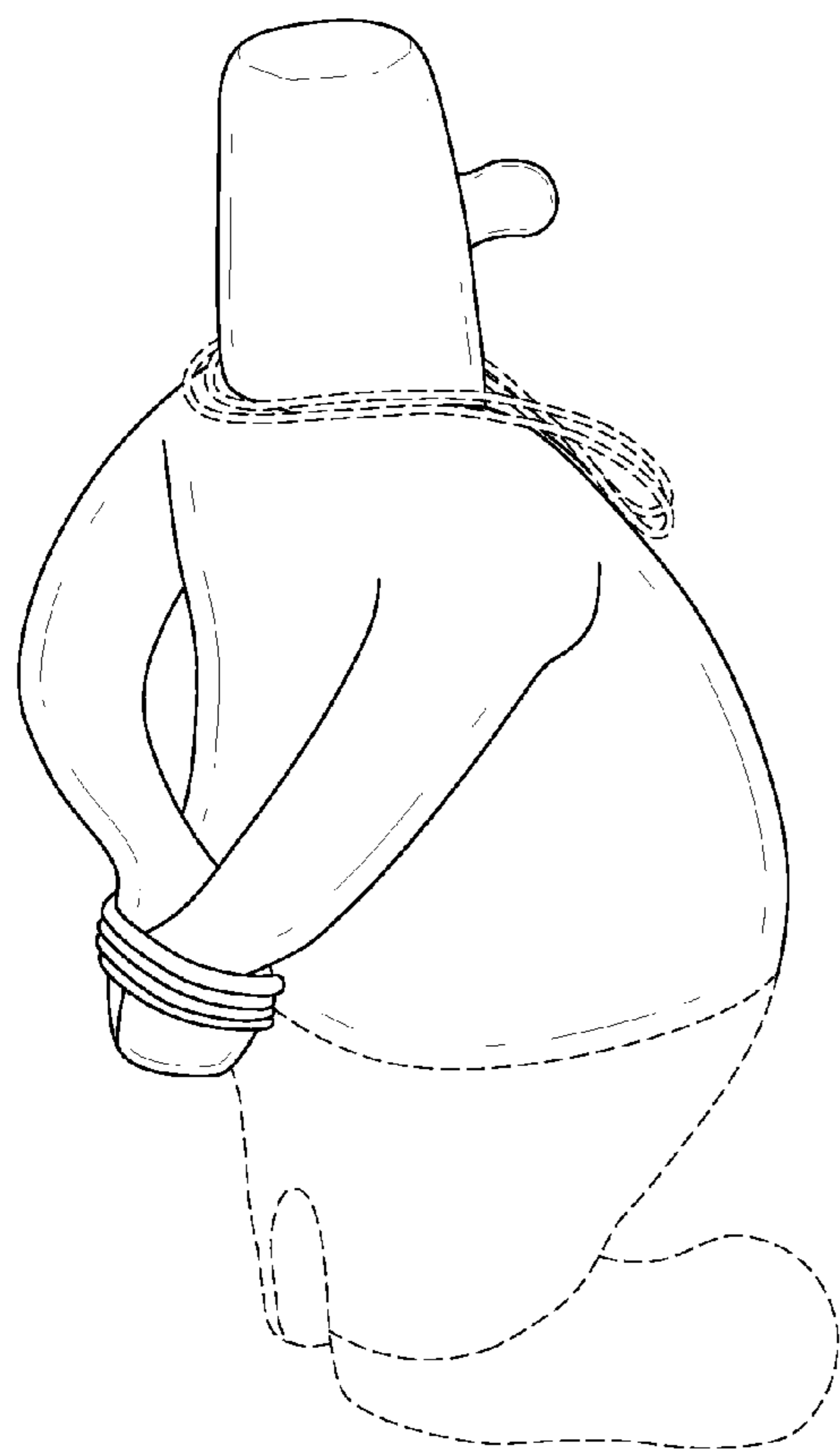

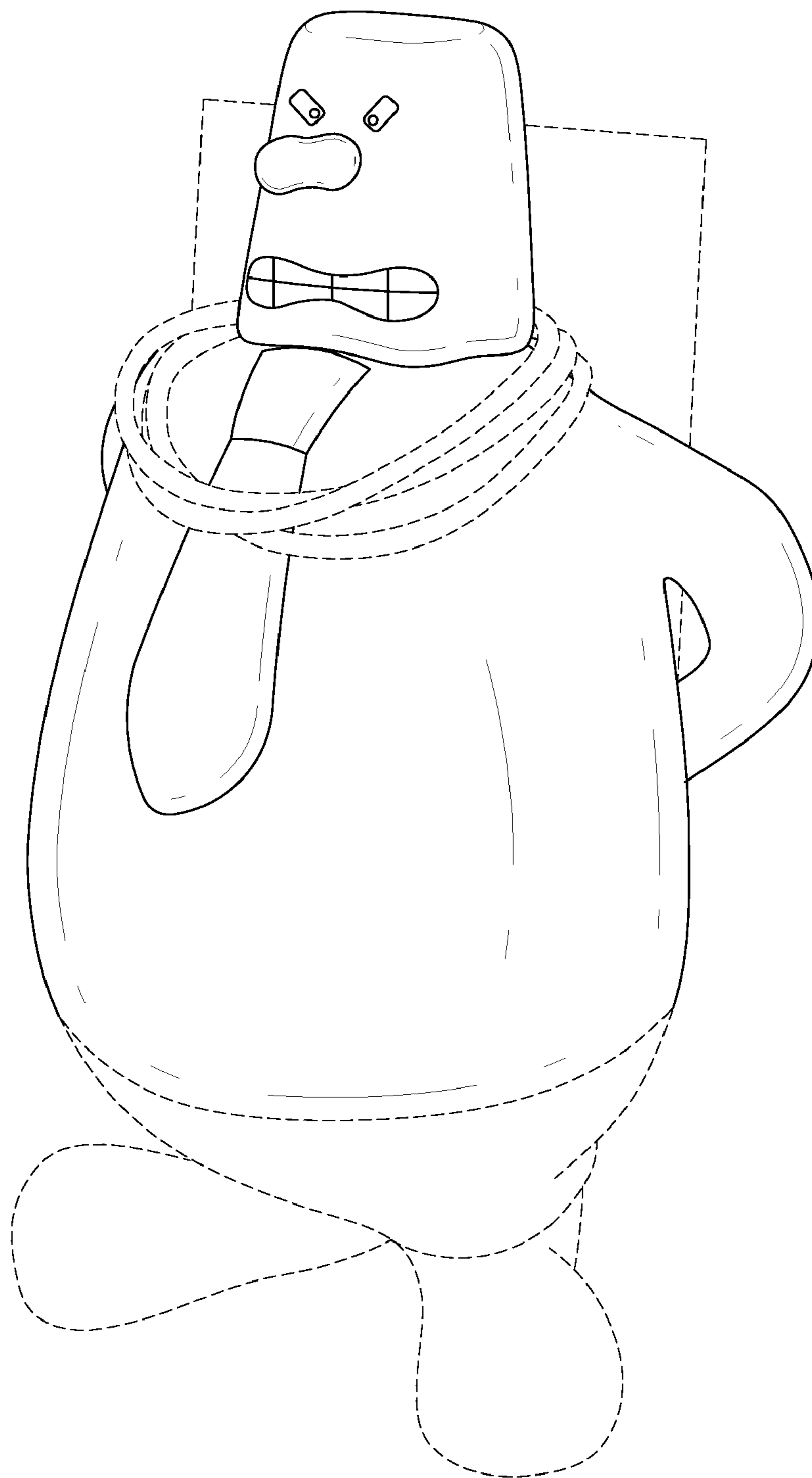

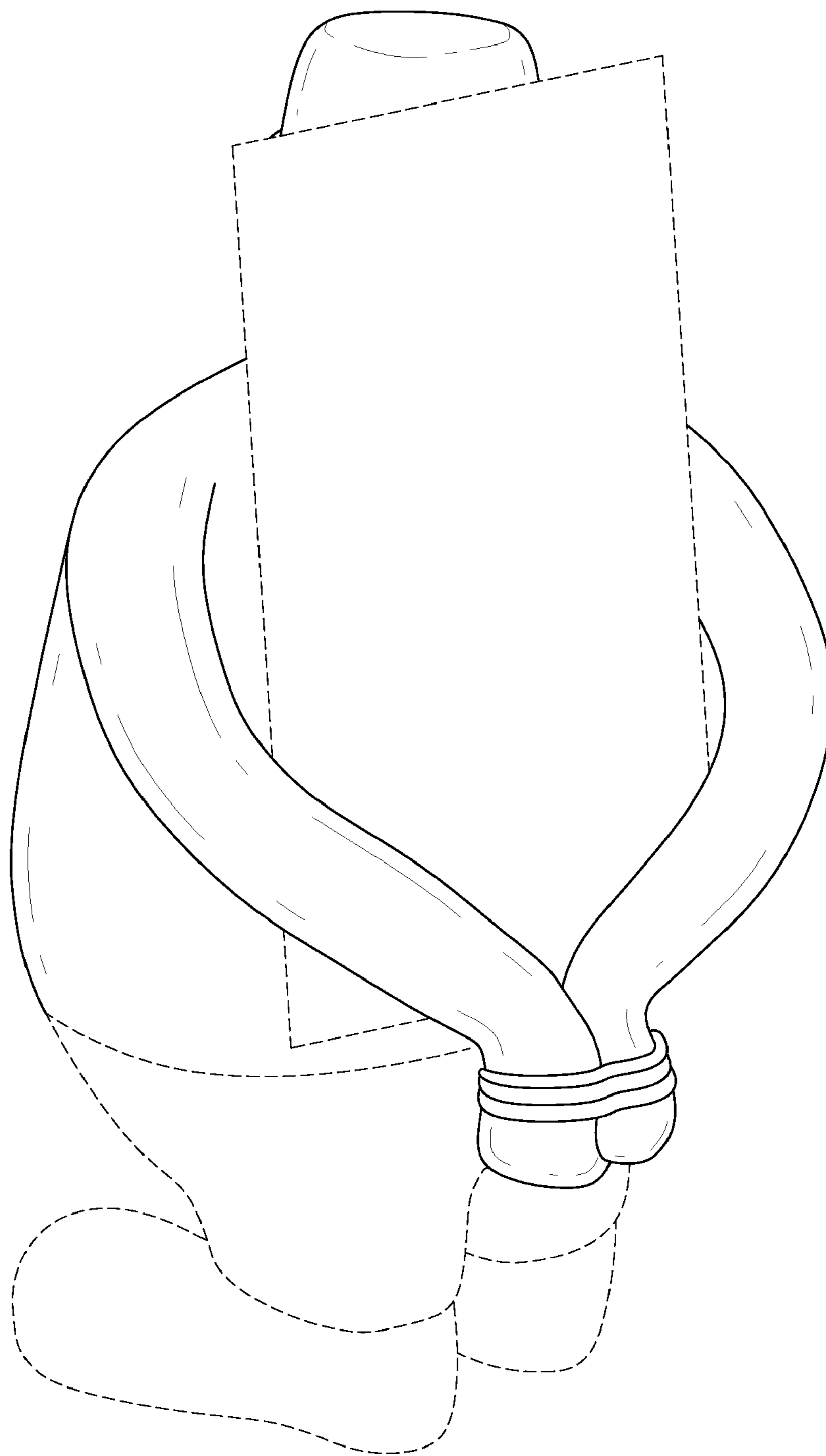
