I claim the ornamental design for a golf ball mark repair tool, as shown and described.

**DESCRIPTION**

FIG. 2 is a bottom perspective view thereof;

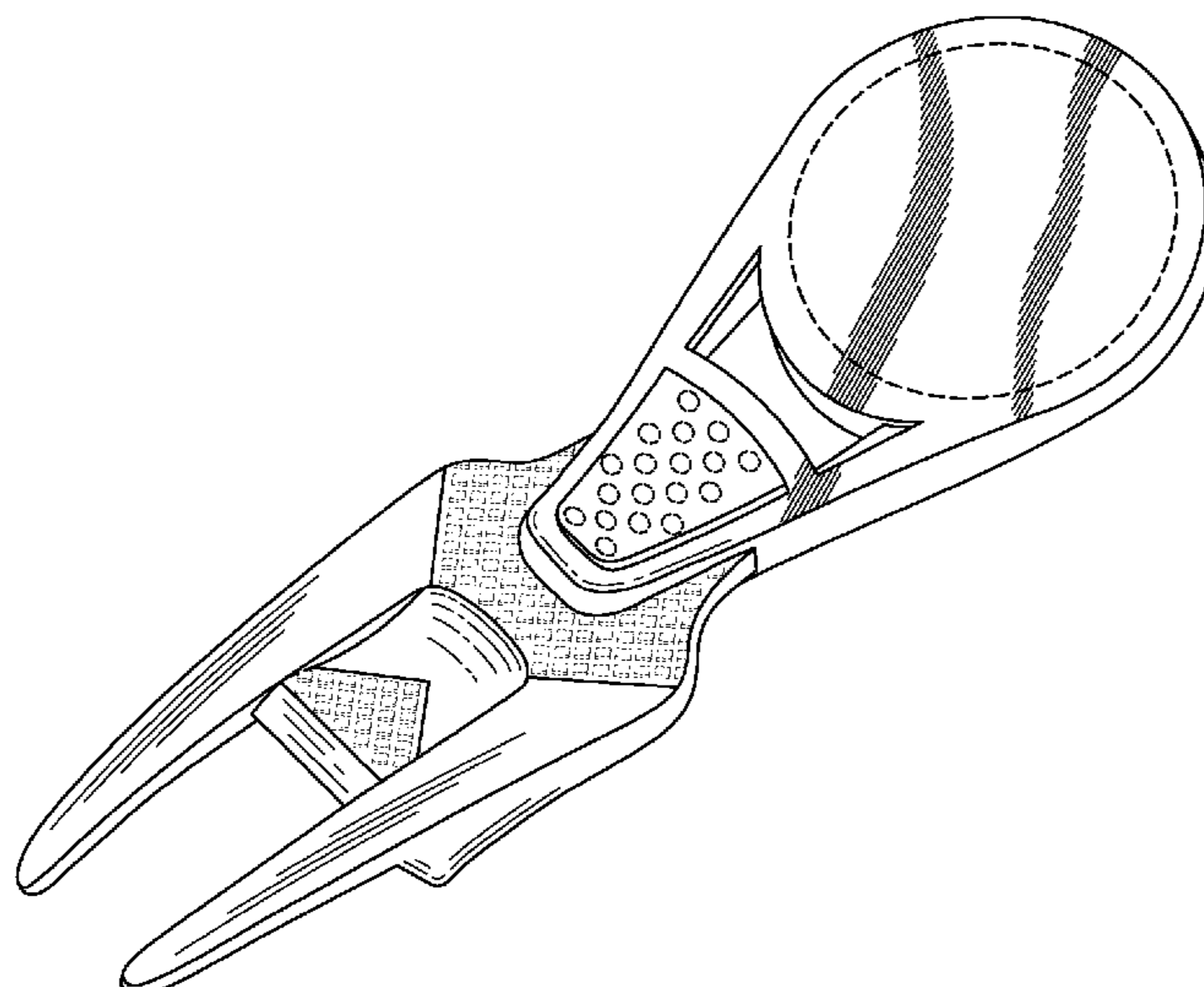
FIG. 3 is a top plan view thereof;

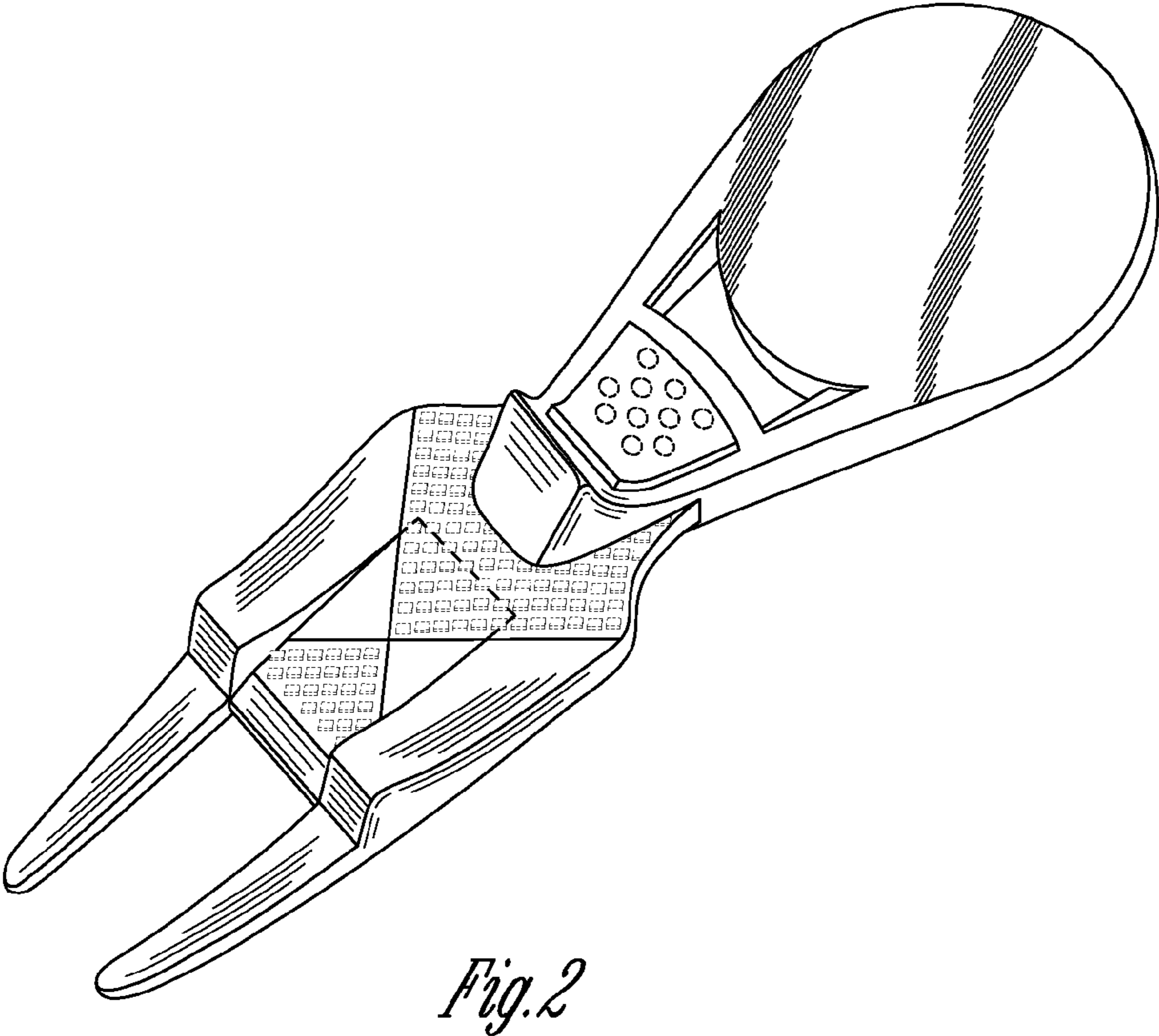
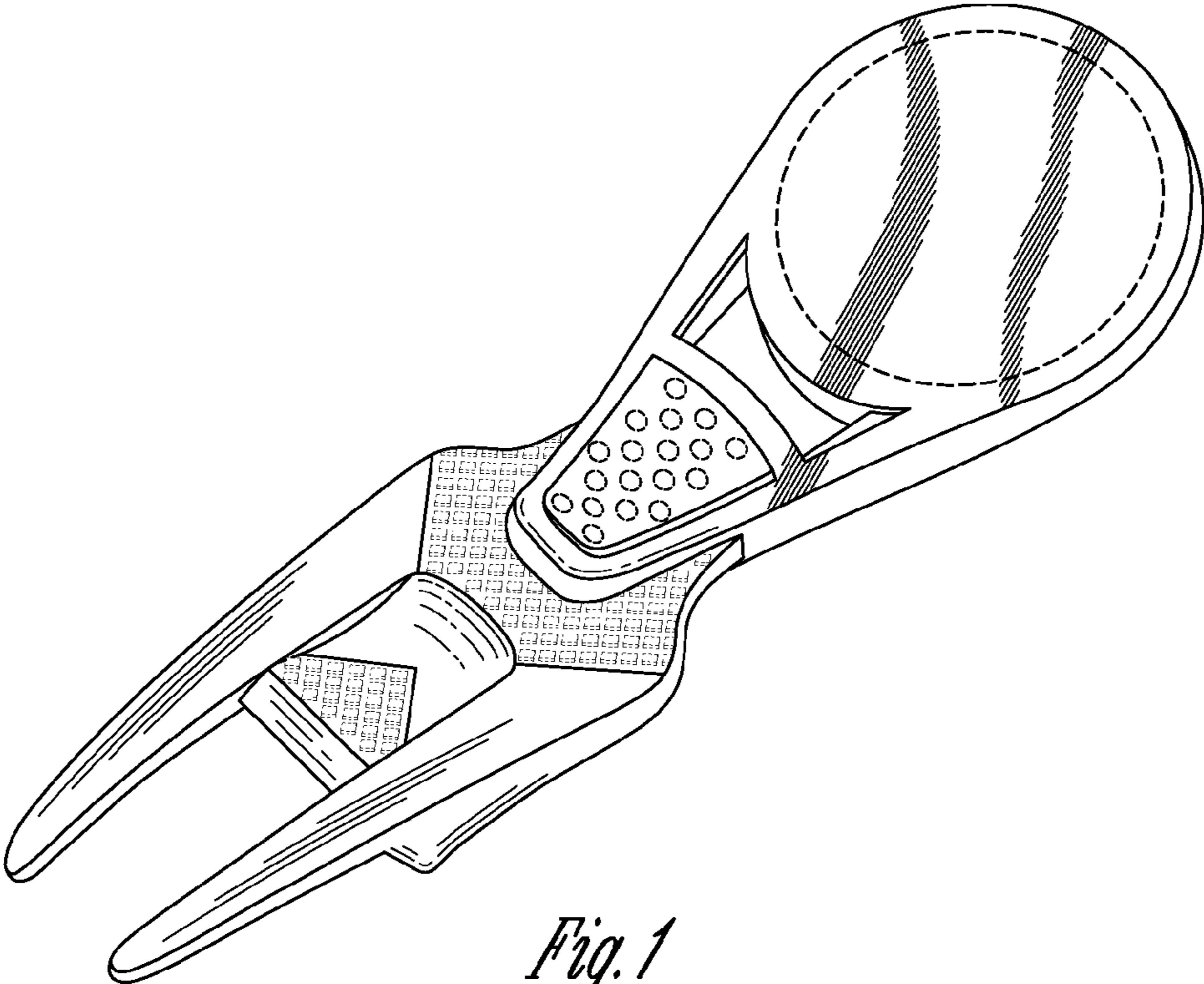

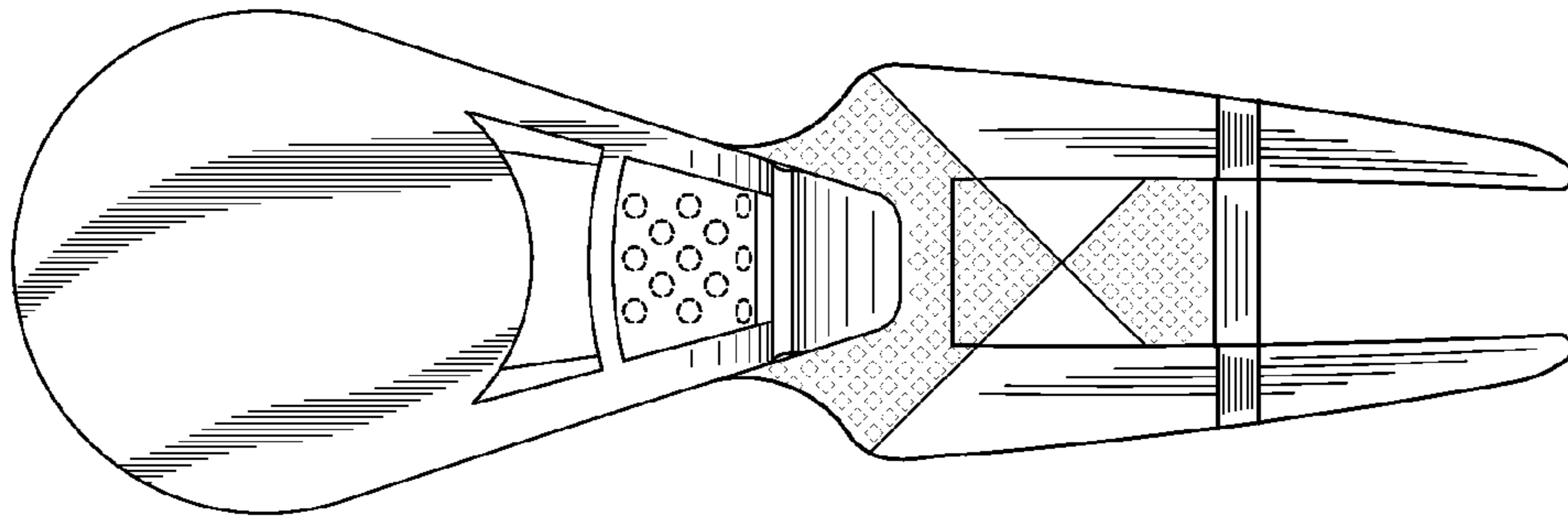

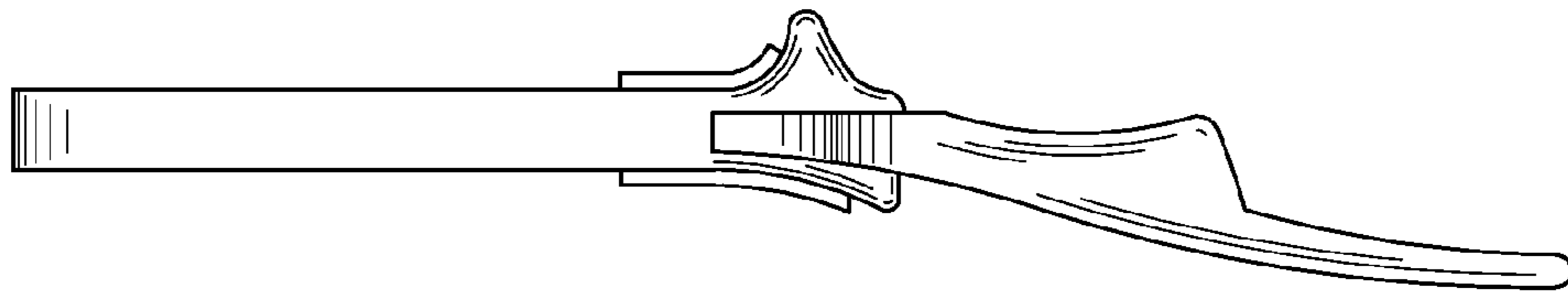

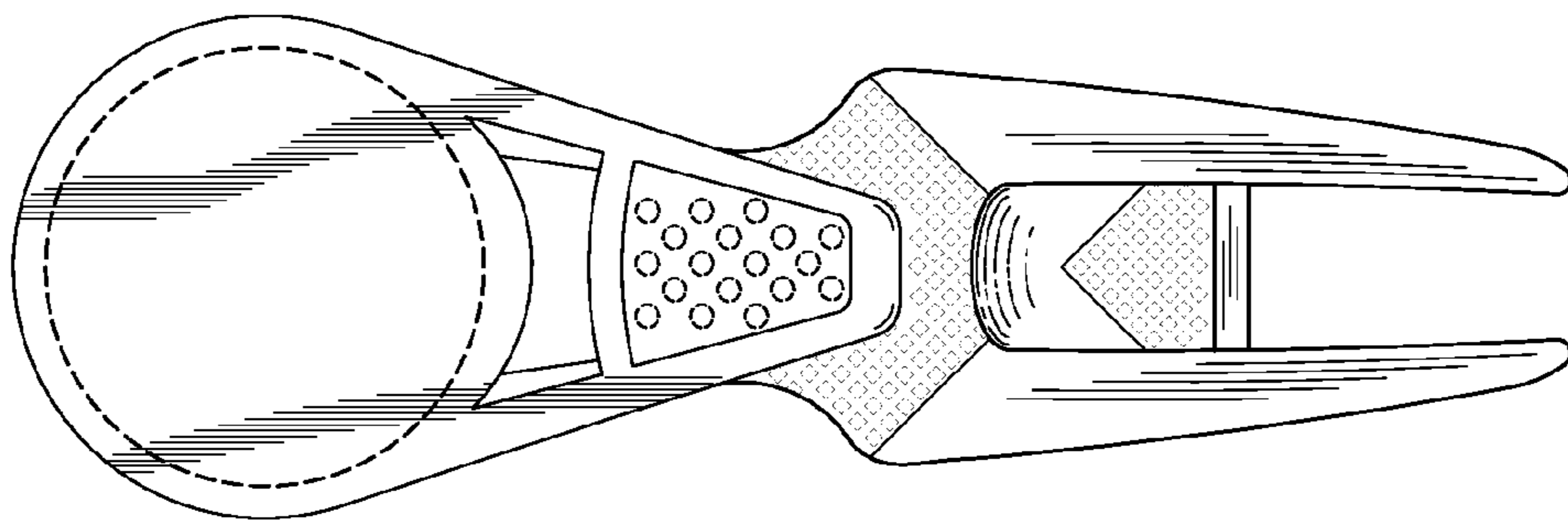
