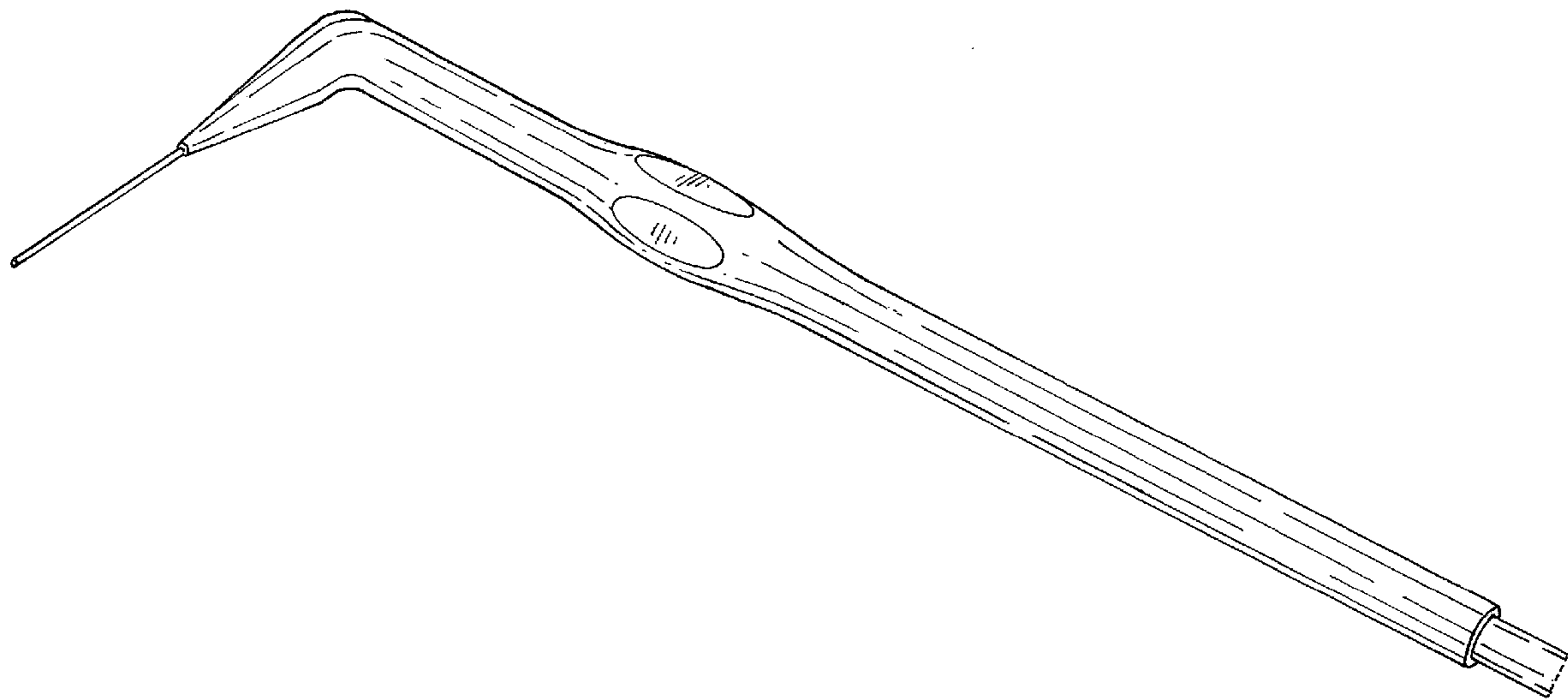
(57) **CLAIM**

The ornamental design for a medical instrument, as shown and described.

**DESCRIPTION**

FIG. 1 is a left side perspective view of a medical instrument in accordance with the new design;  
FIG. 2 is a left side elevation view thereof, the right side elevation view being a mirror image thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a rear elevation view thereof; and,  
FIG. 6 is a front elevation view thereof.  
The broken lines showing portions of the medical instrument are included for the purpose of illustrating environmental structure and form no part of the claimed design.

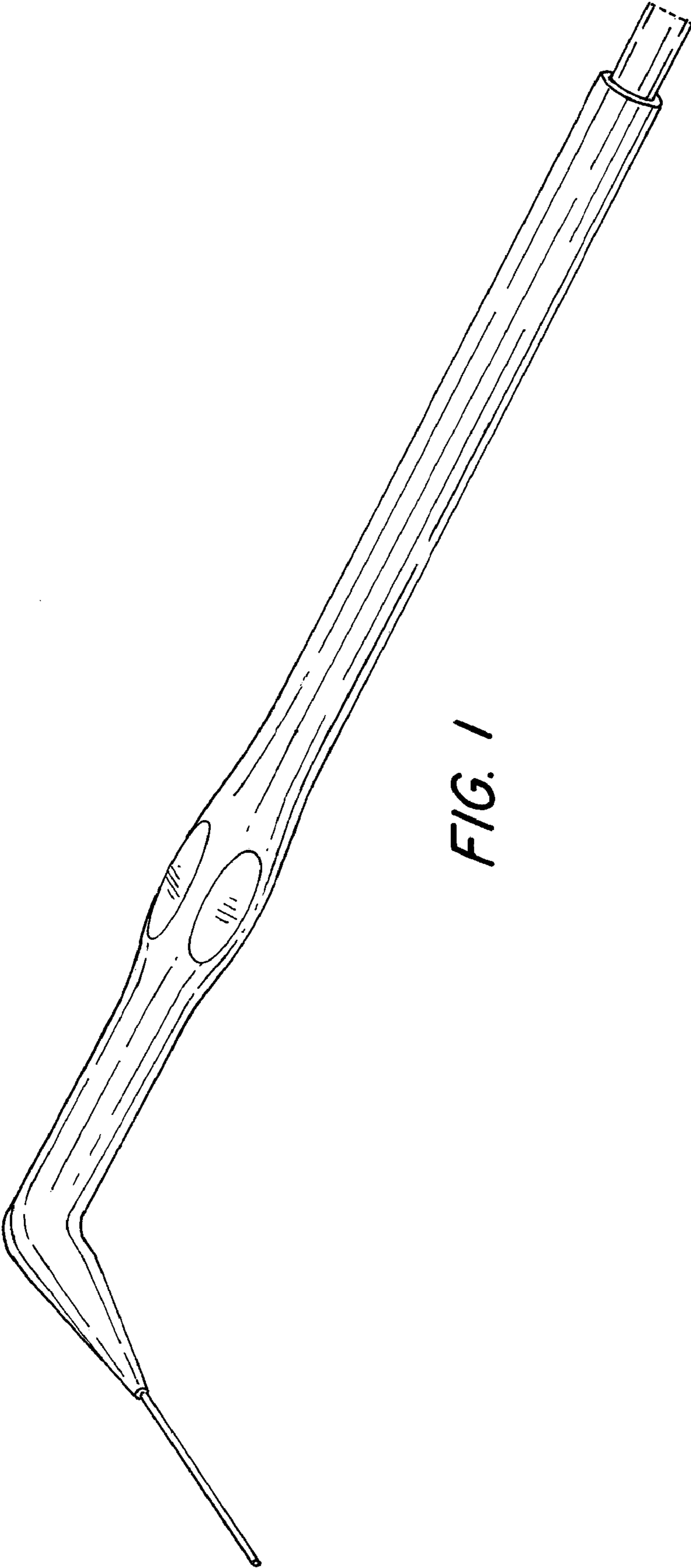
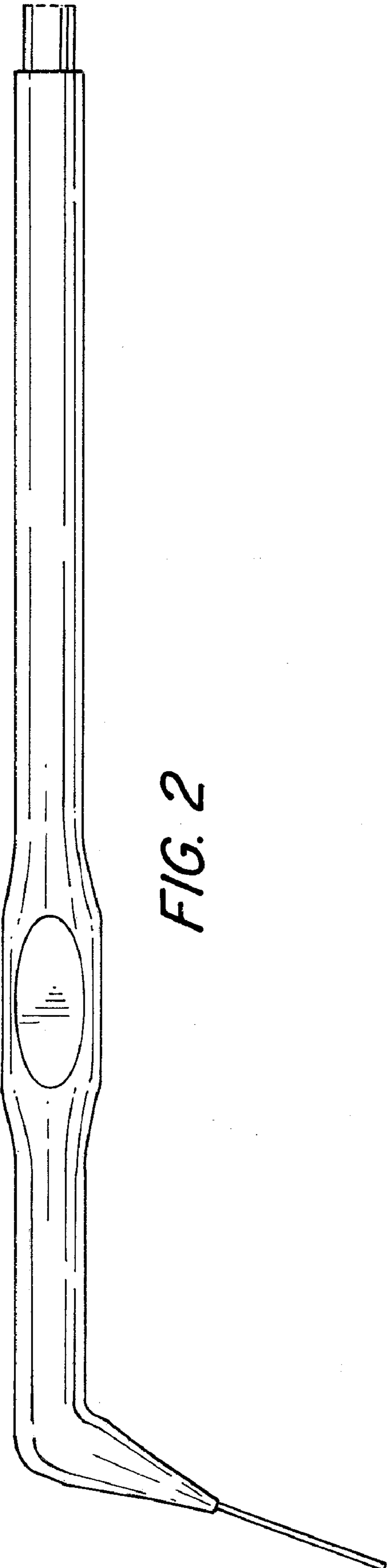
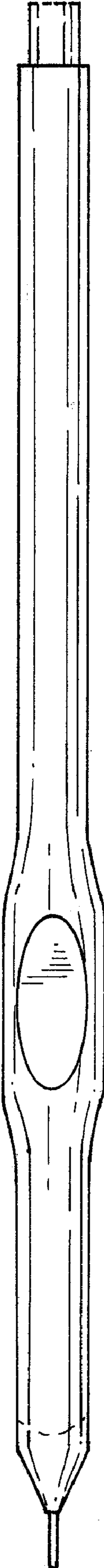


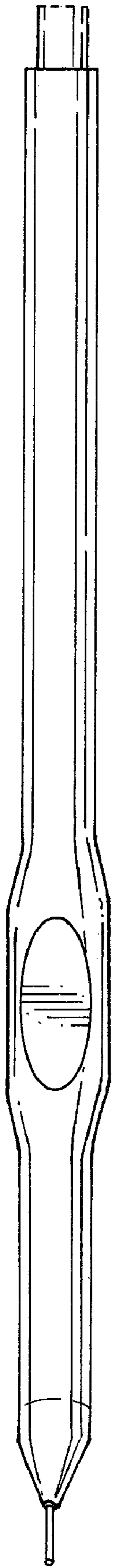

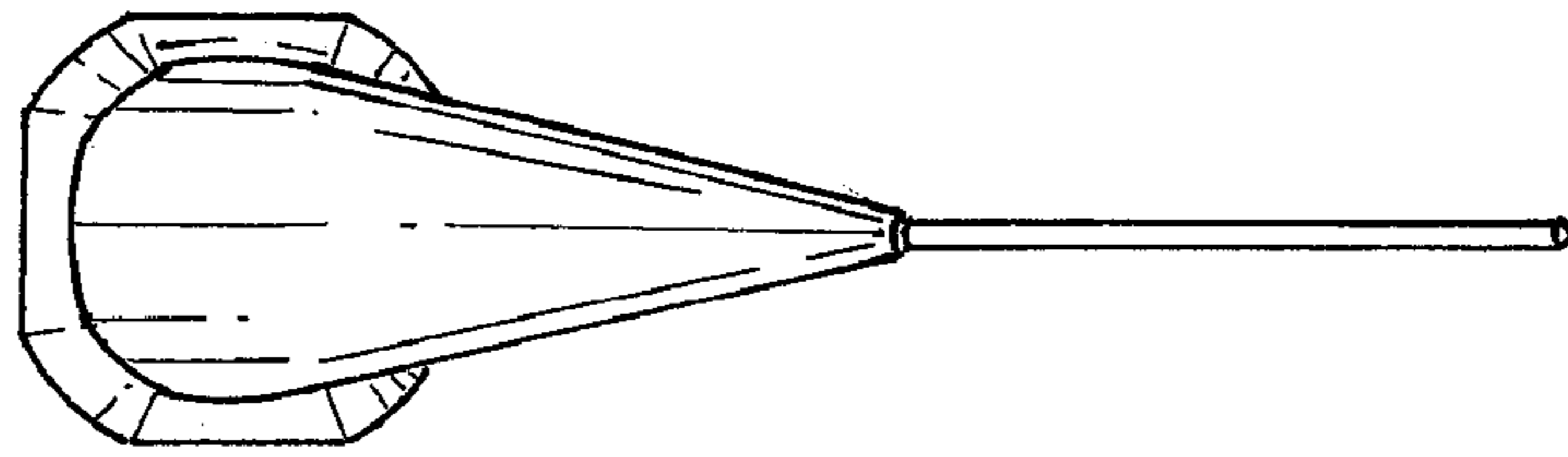

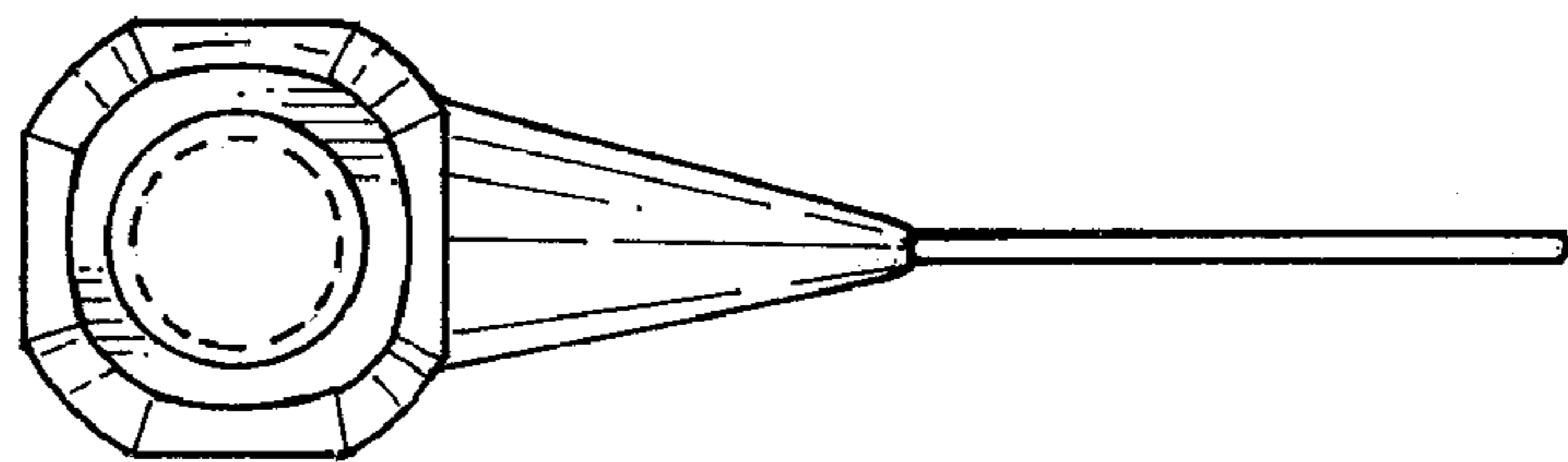
