(57) **CLAIM**

I claim the ornamental design for a personal massager, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a personal massager.

FIG. 2 is a rear elevation view of the personal massager illustrated in FIG. 1.

FIG. 3 is a front elevation view of the personal massager illustrated in FIG. 1.

FIG. 4 is a top plan view of the personal massager illustrated in FIG. 1.

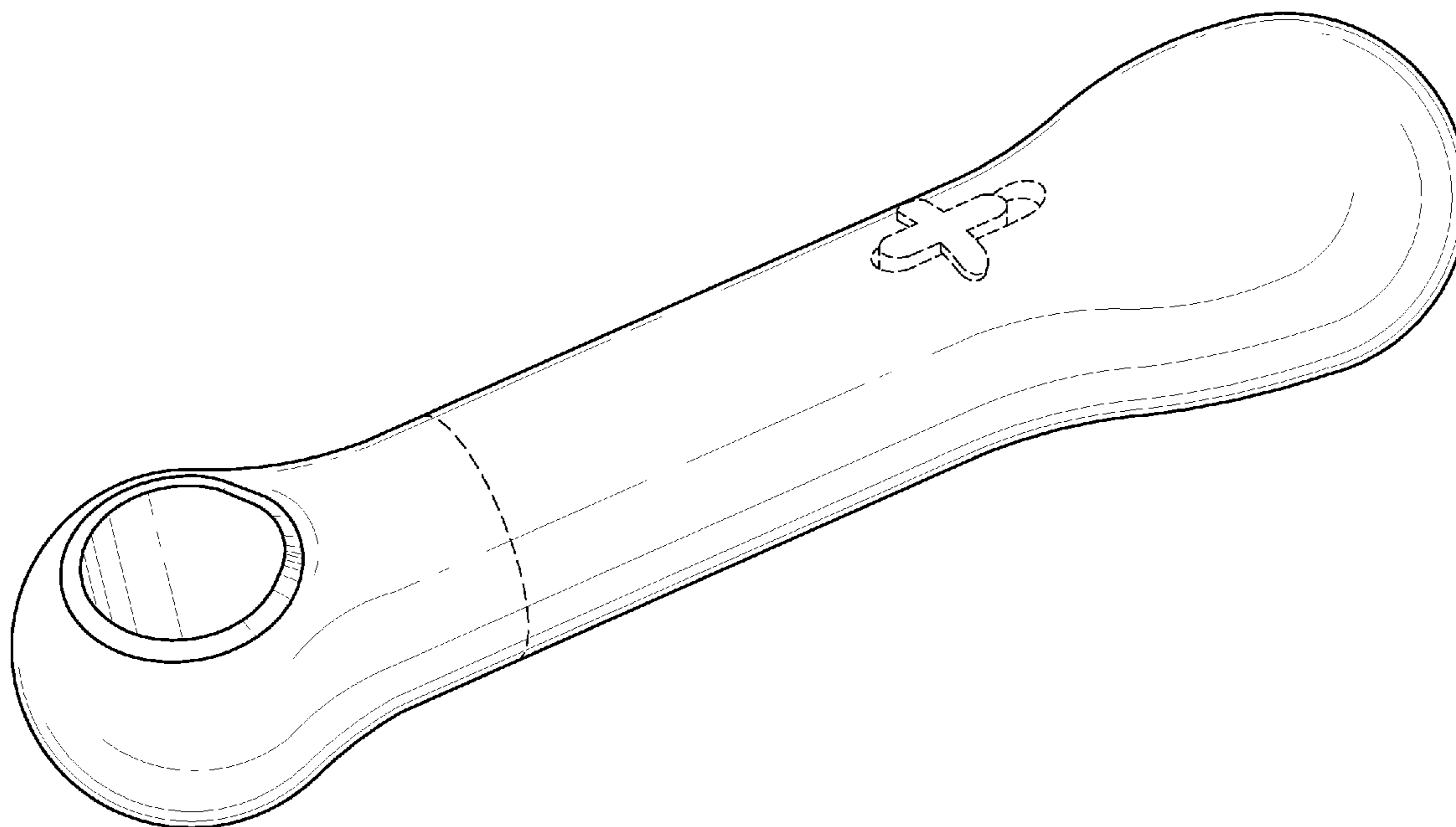
FIG. 5 is a bottom plan view of the personal massager illustrated in FIG. 1.

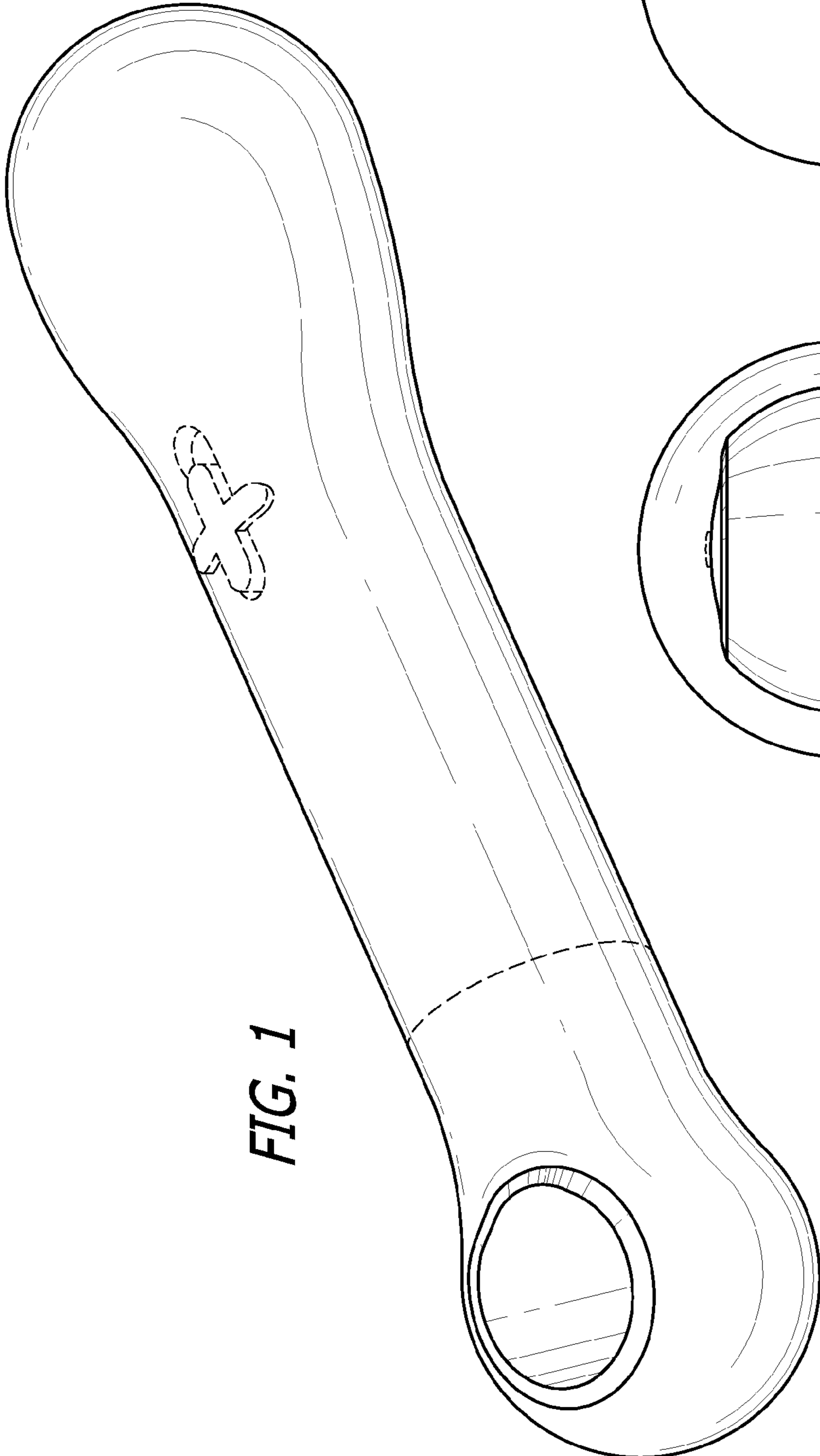

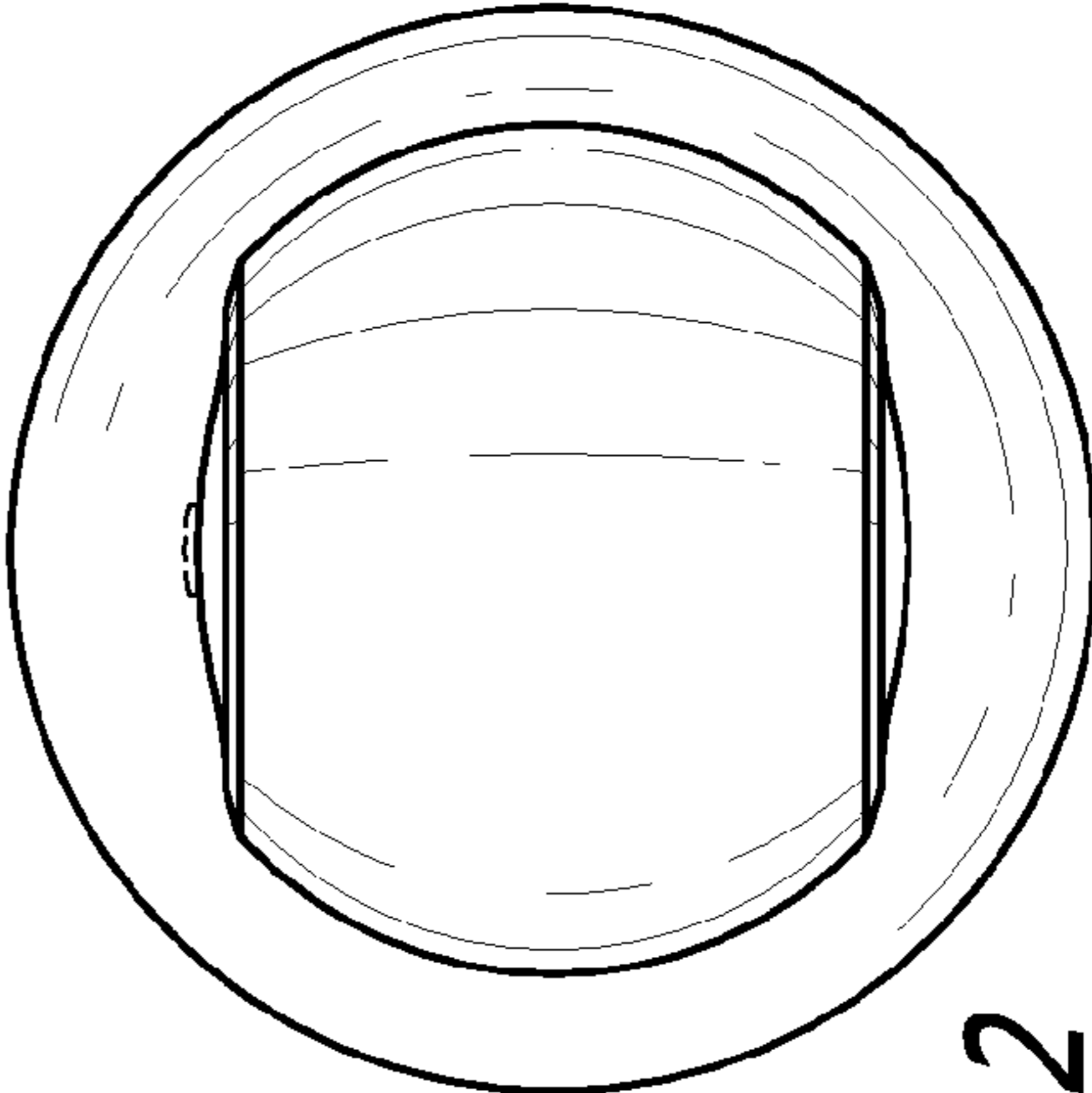

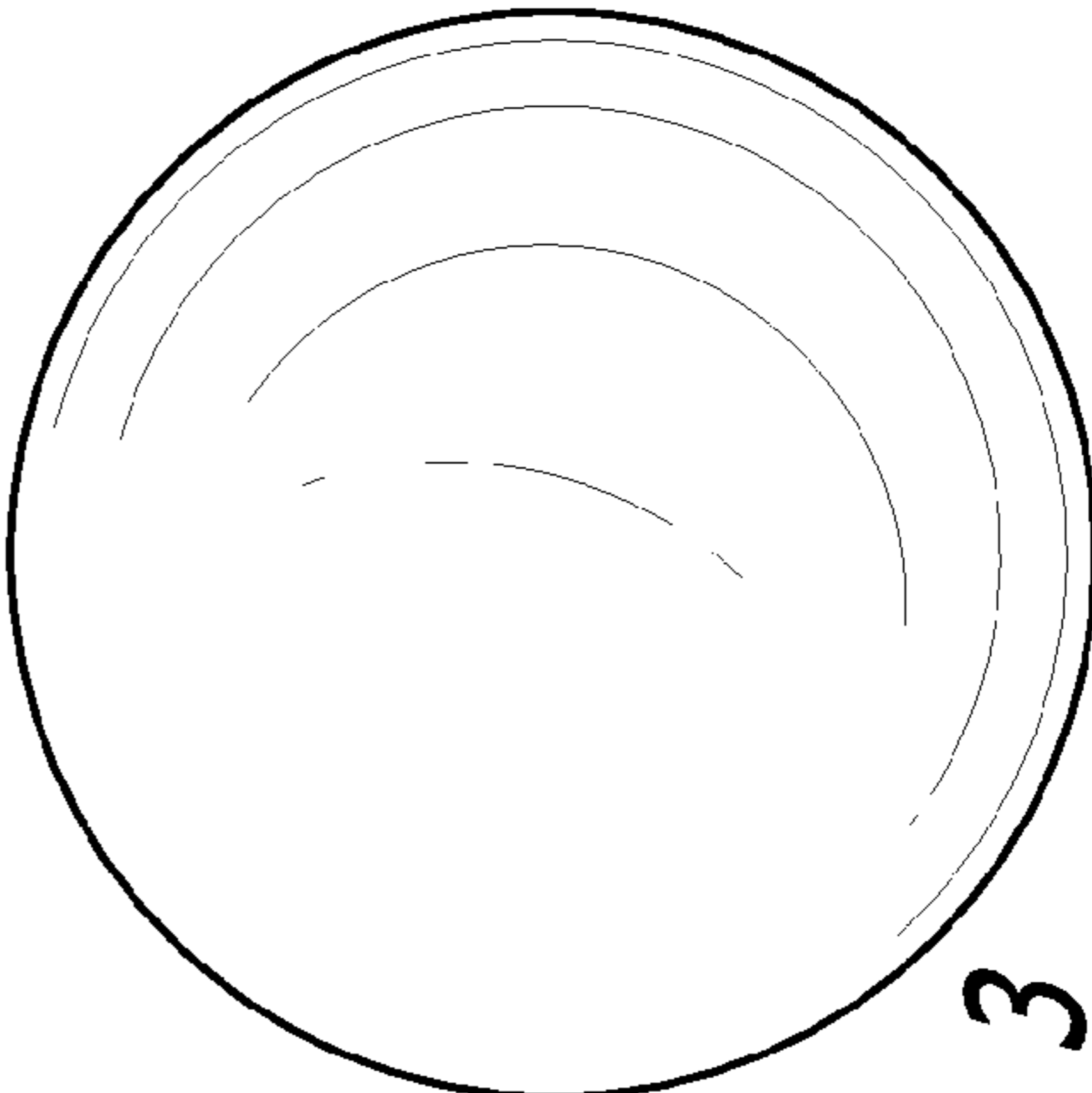
