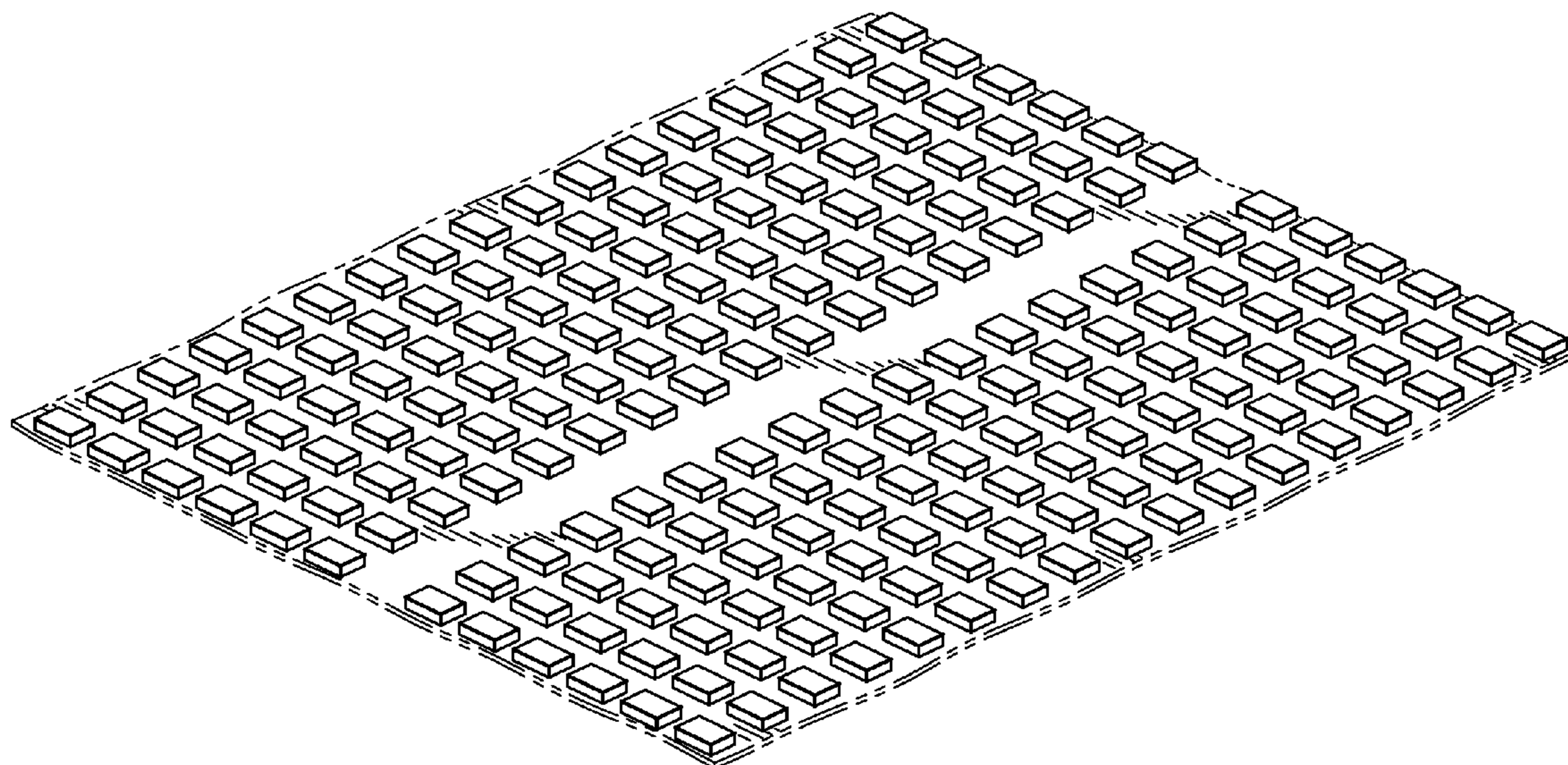
(57) **CLAIM**

The ornamental design for a reagent card, as shown and
described.

DESCRIPTION

FIG. 1 is a top perspective view of a reagent card, showing a
first embodiment of my new design;
FIG. 2 is a top view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a side view, the opposite side being a mirror image
thereof;
FIG. 5 is a top perspective view of a reagent card, showing a
second embodiment of my new design;
FIG. 6 is a top view thereof;
FIG. 7 is a rear view thereof;
FIG. 8 is a front view thereof;
FIG. 9 is a left side view thereof; and,
FIG. 10 is a right side view thereof.
The alternating short and long dash lines in all views repre-
sent the boundaries of the claim, and the dash lines in FIGS.
5-10 are included for the purpose of illustrating unclaimed
portions of the reagent card. None of the broken lines form a
part of the claimed designed.

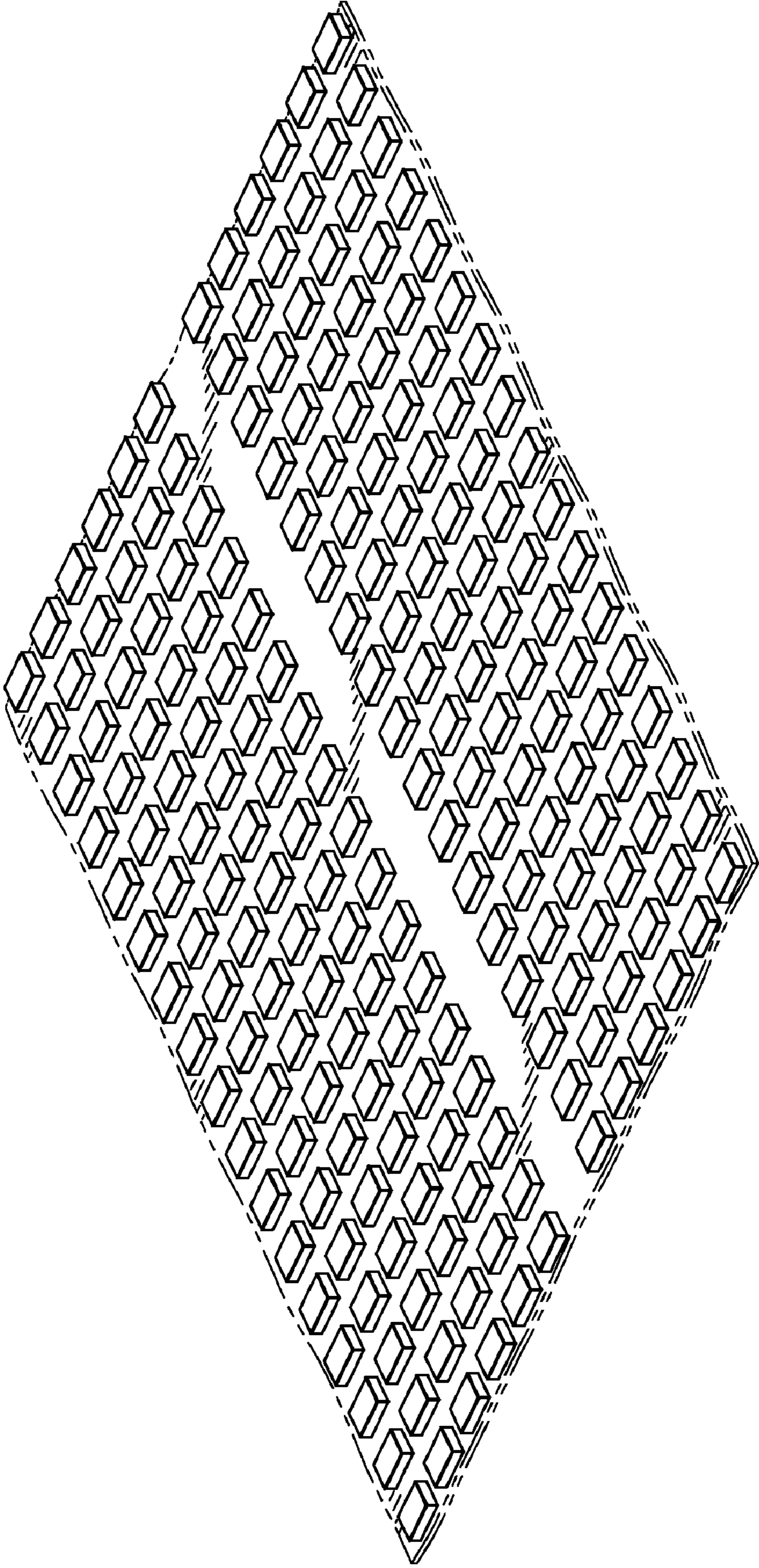

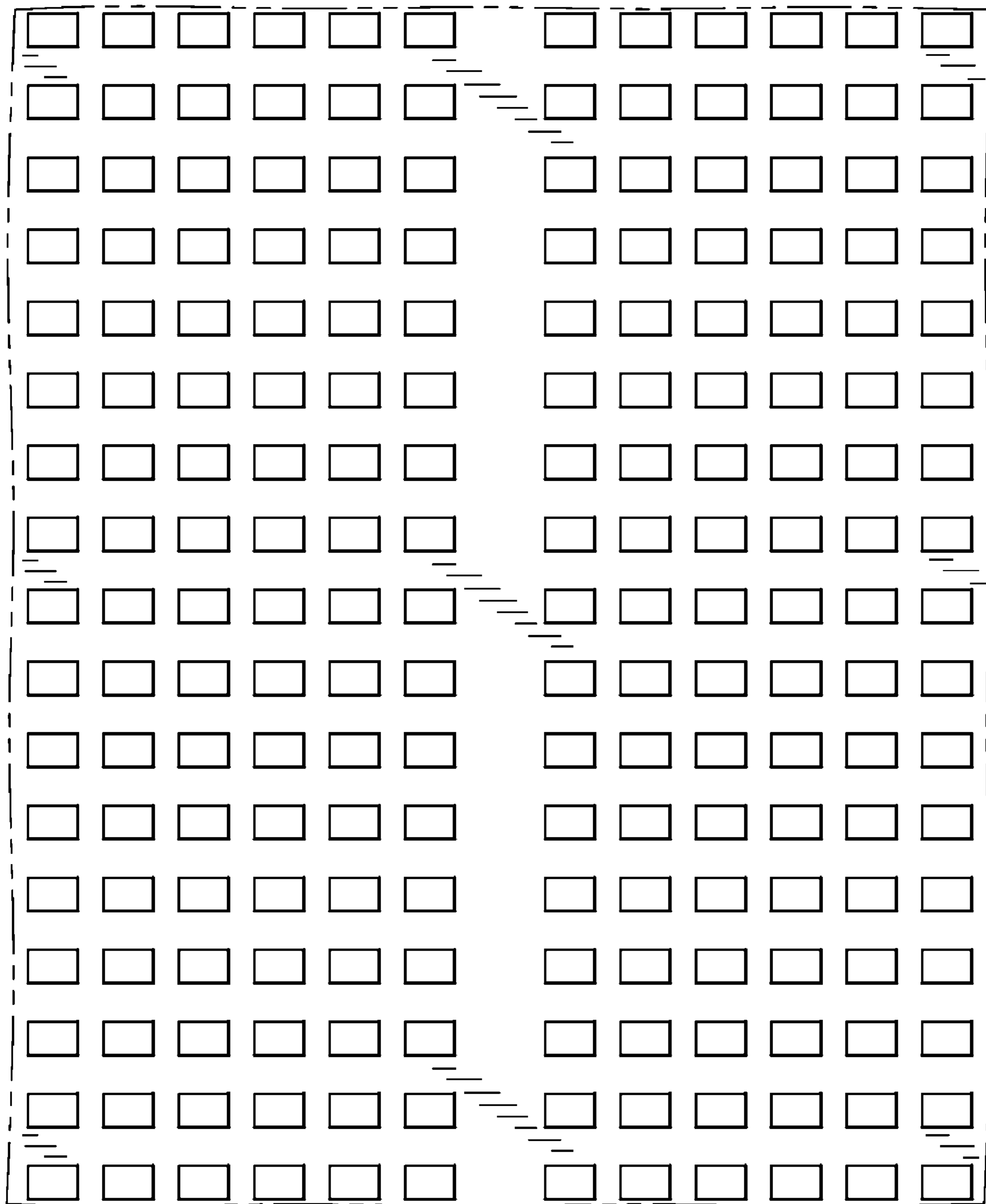

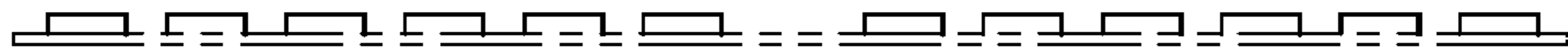

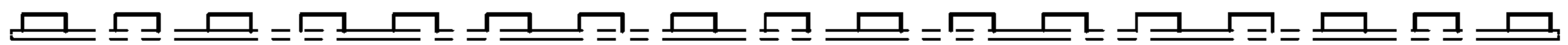

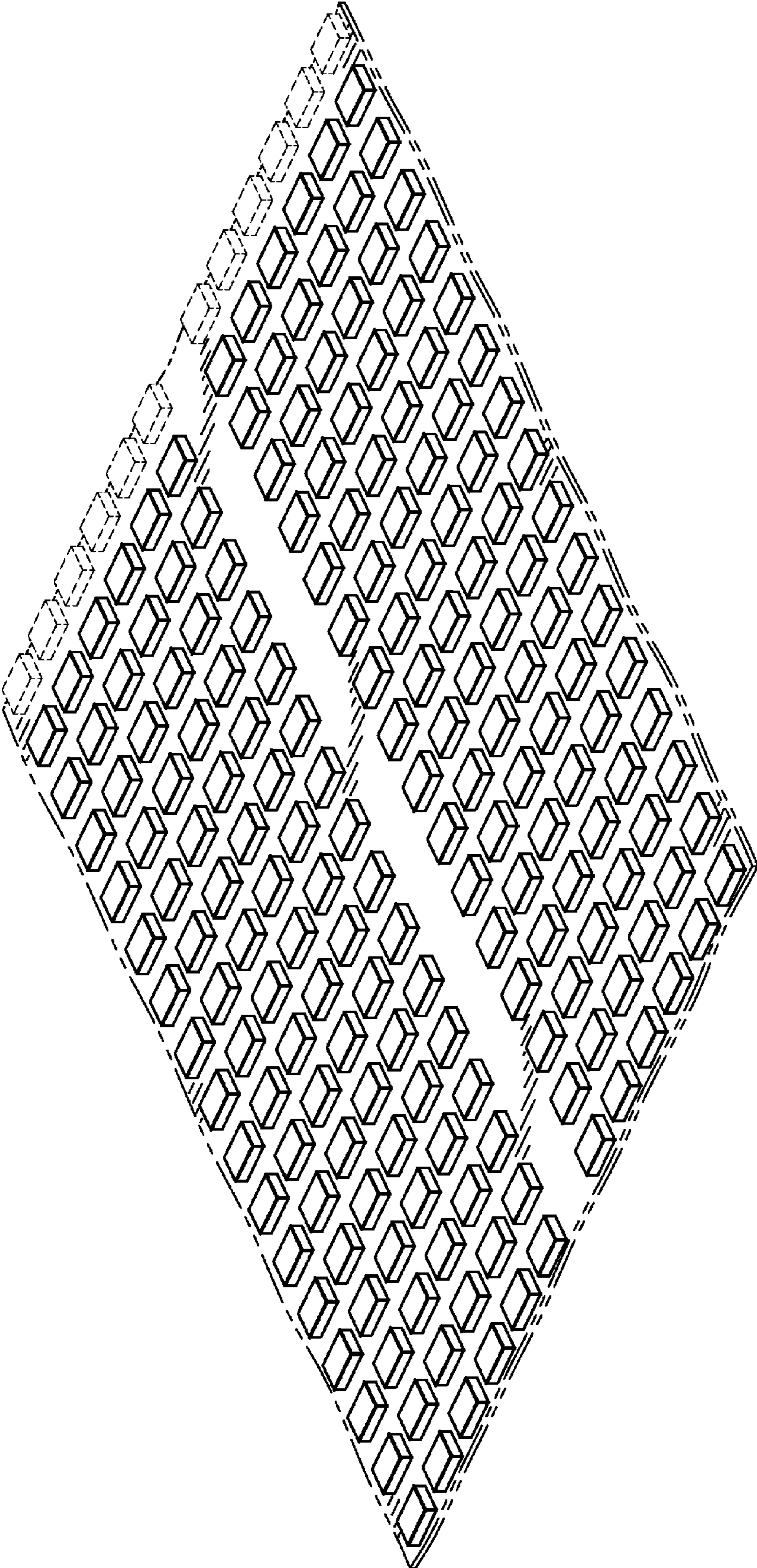

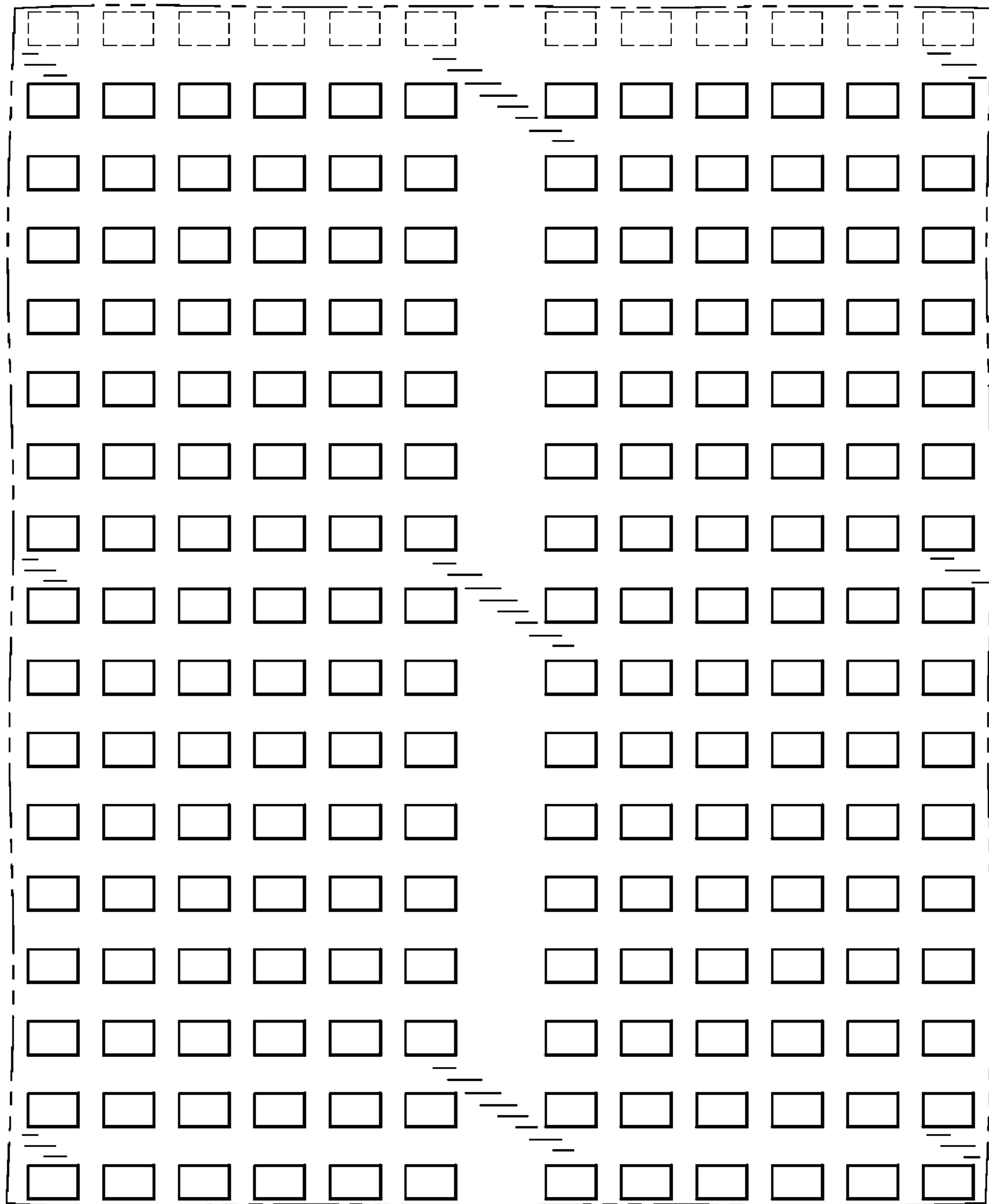

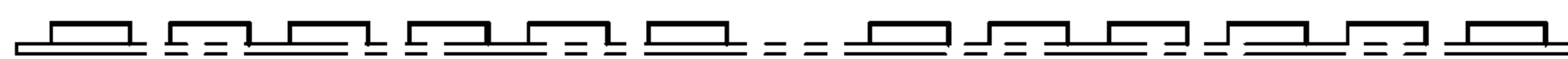

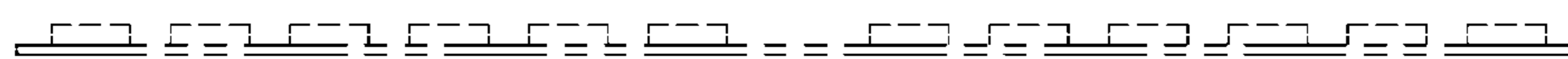

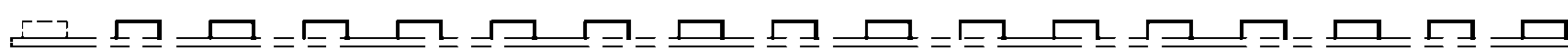

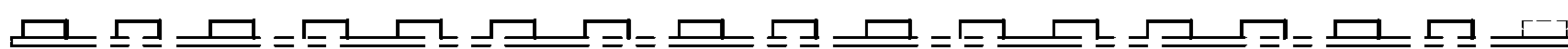
