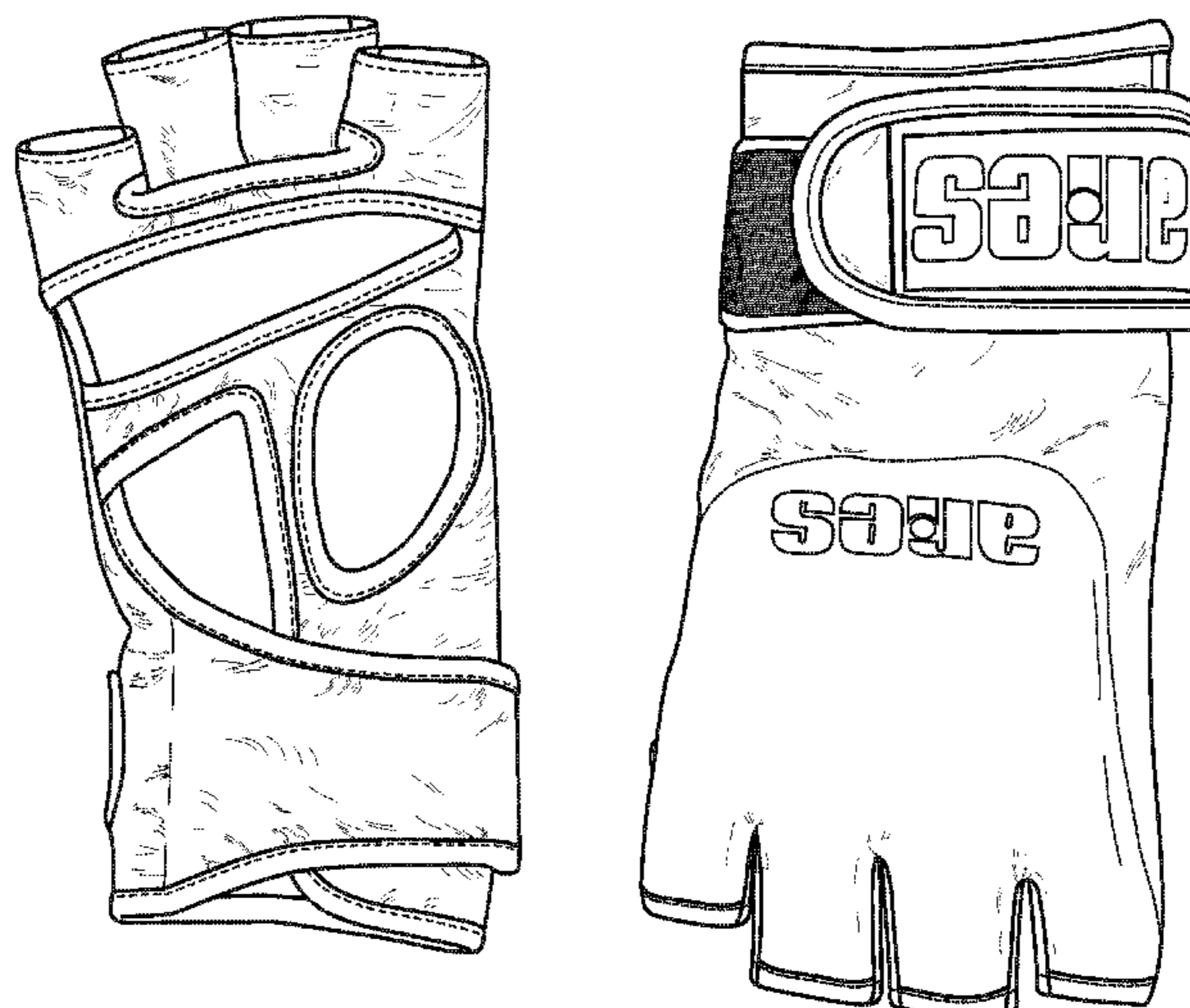
(57) **CLAIM**

The ornamental design for a mixed martial arts glove, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a mixed martial arts glove; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left-side elevational view thereof; FIG. 5 is a right-side elevational view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a bottom plan view thereof showing the outside strap unfastened and the inside strap fastened; and, FIG. 9 is a bottom plan view thereof showing the outside strap unfastened and the inside strap fastened. The broken line shown outside of the glove in FIG. 1 illustrates the environment in which the mixed martial arts glove is used. The broken lines that run along the edges of the openings and straps of the claimed design represent features of the article that form no part of the claimed design. The dark patterned areas on the straps are hook-and-loop fasteners.

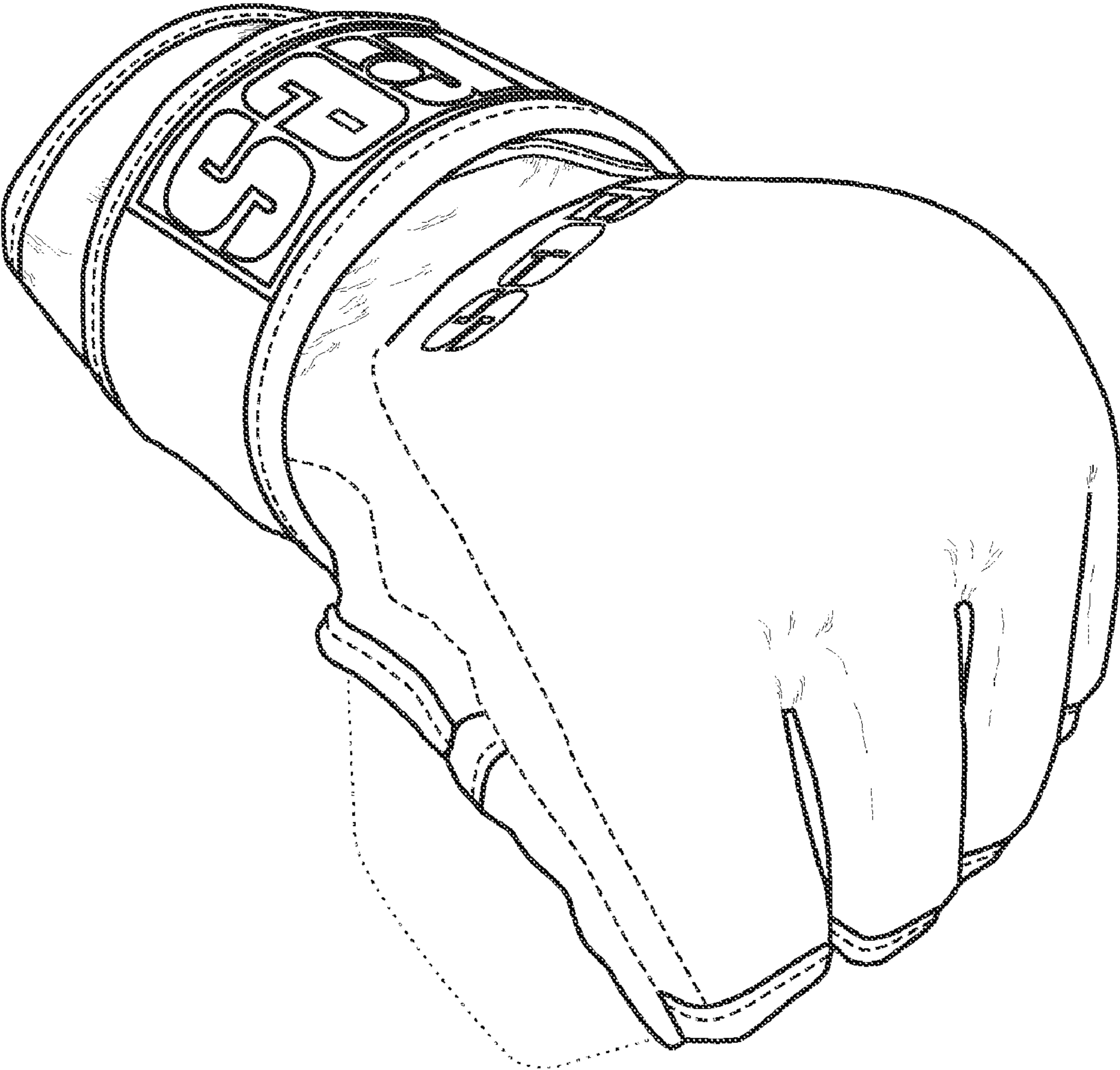

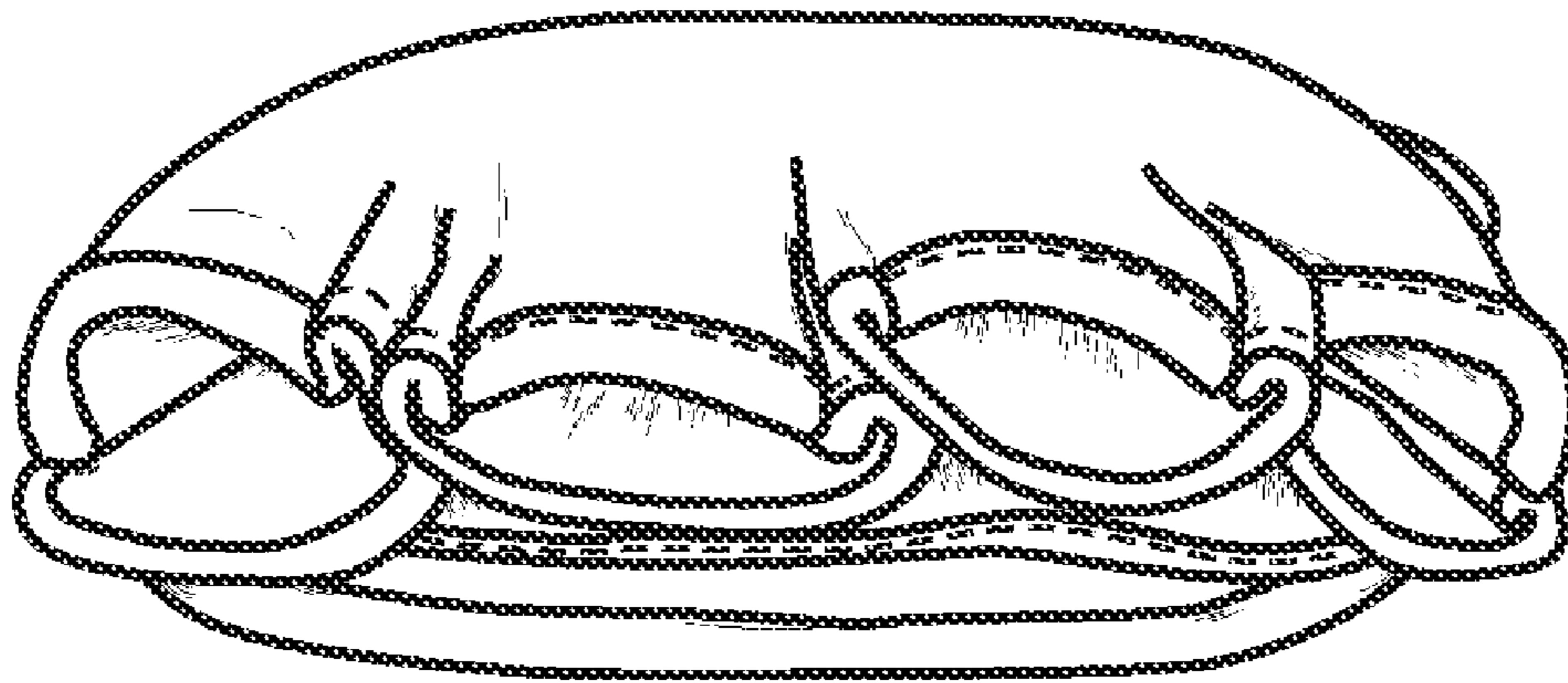

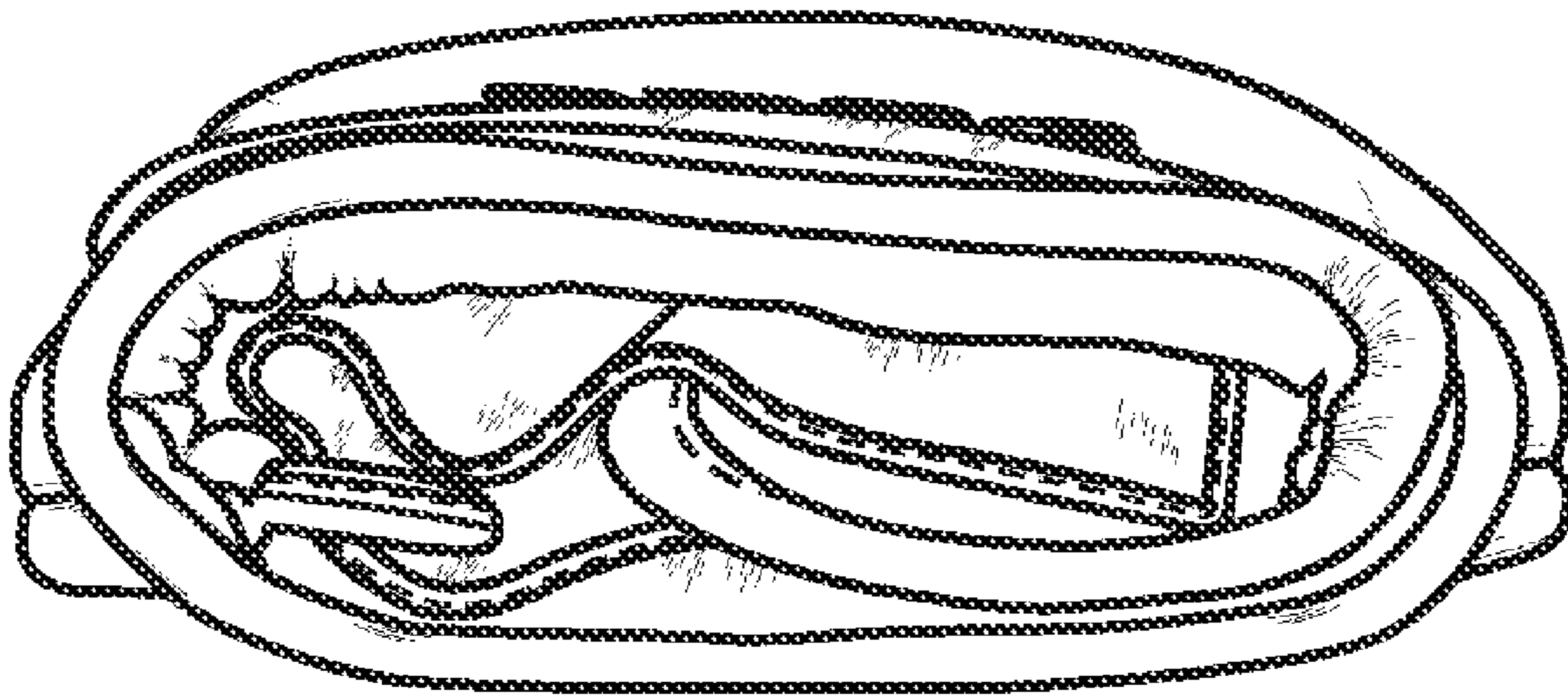

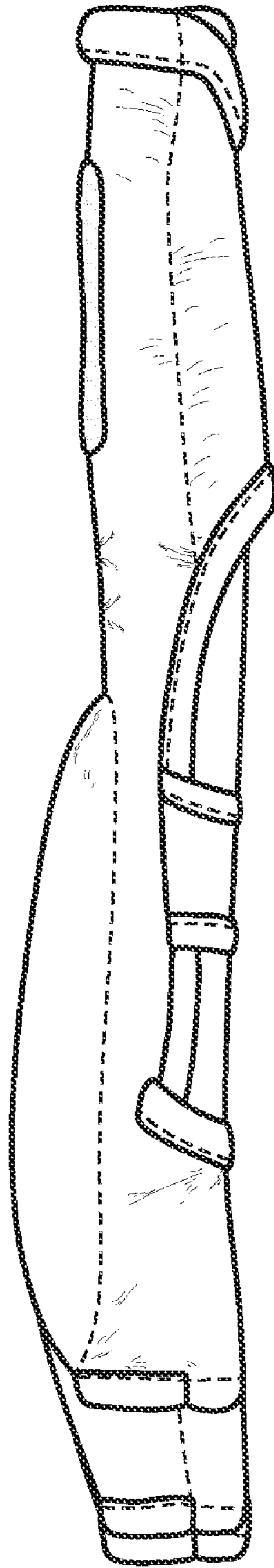

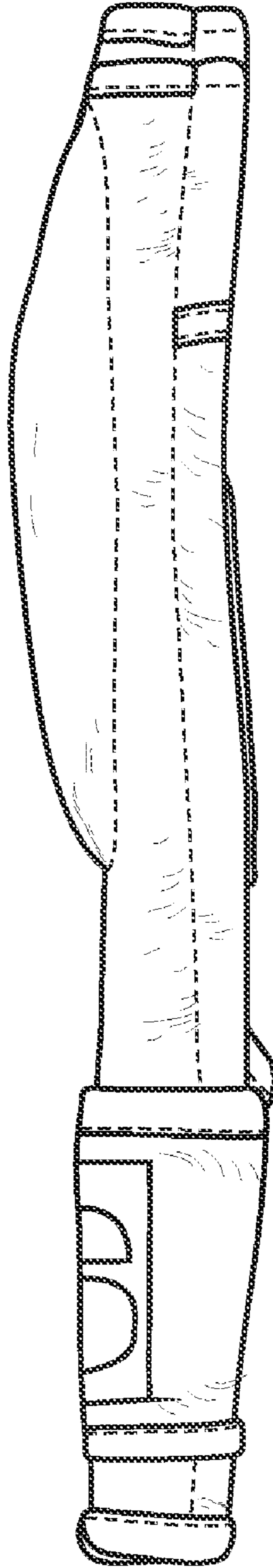

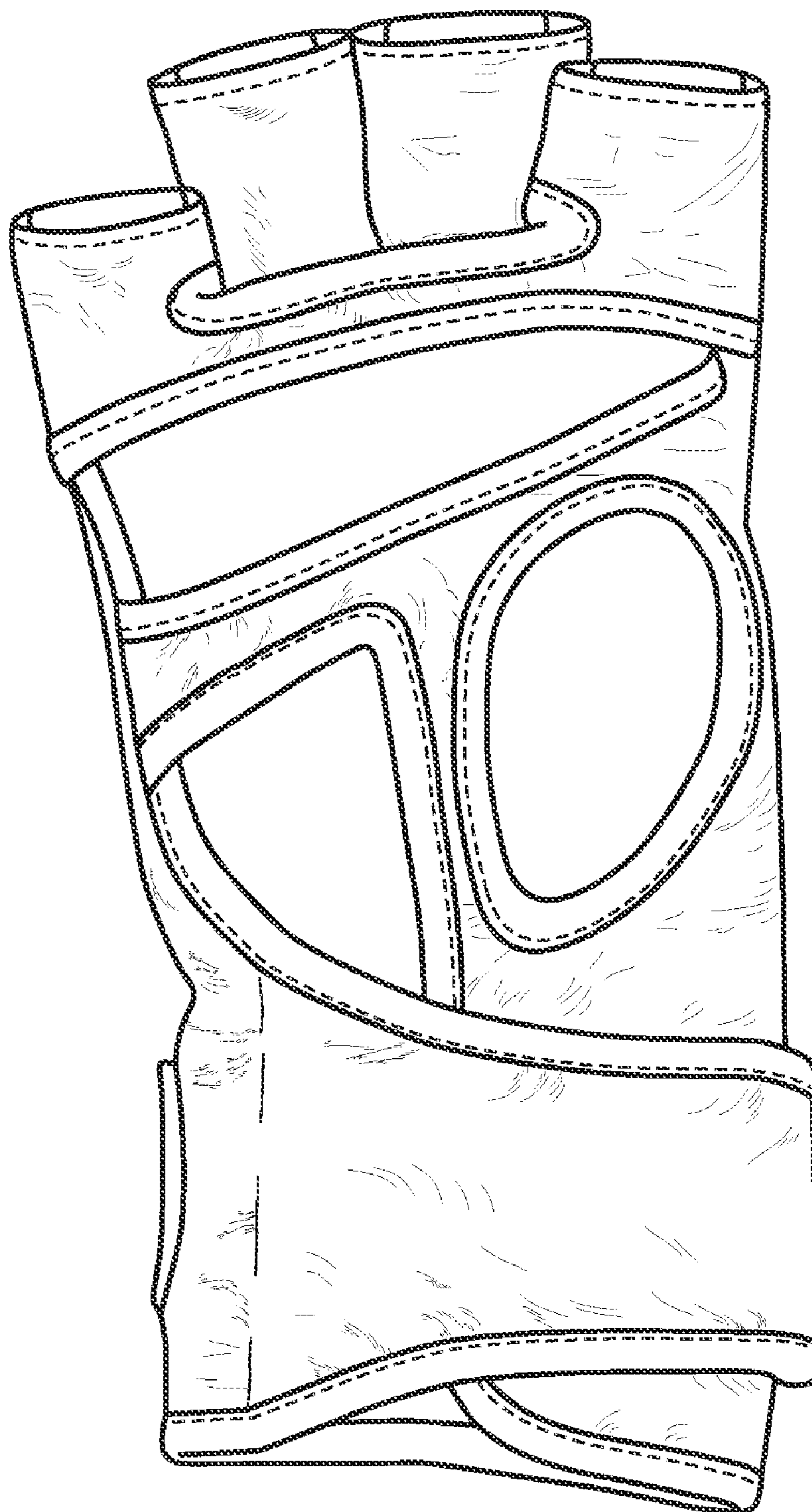

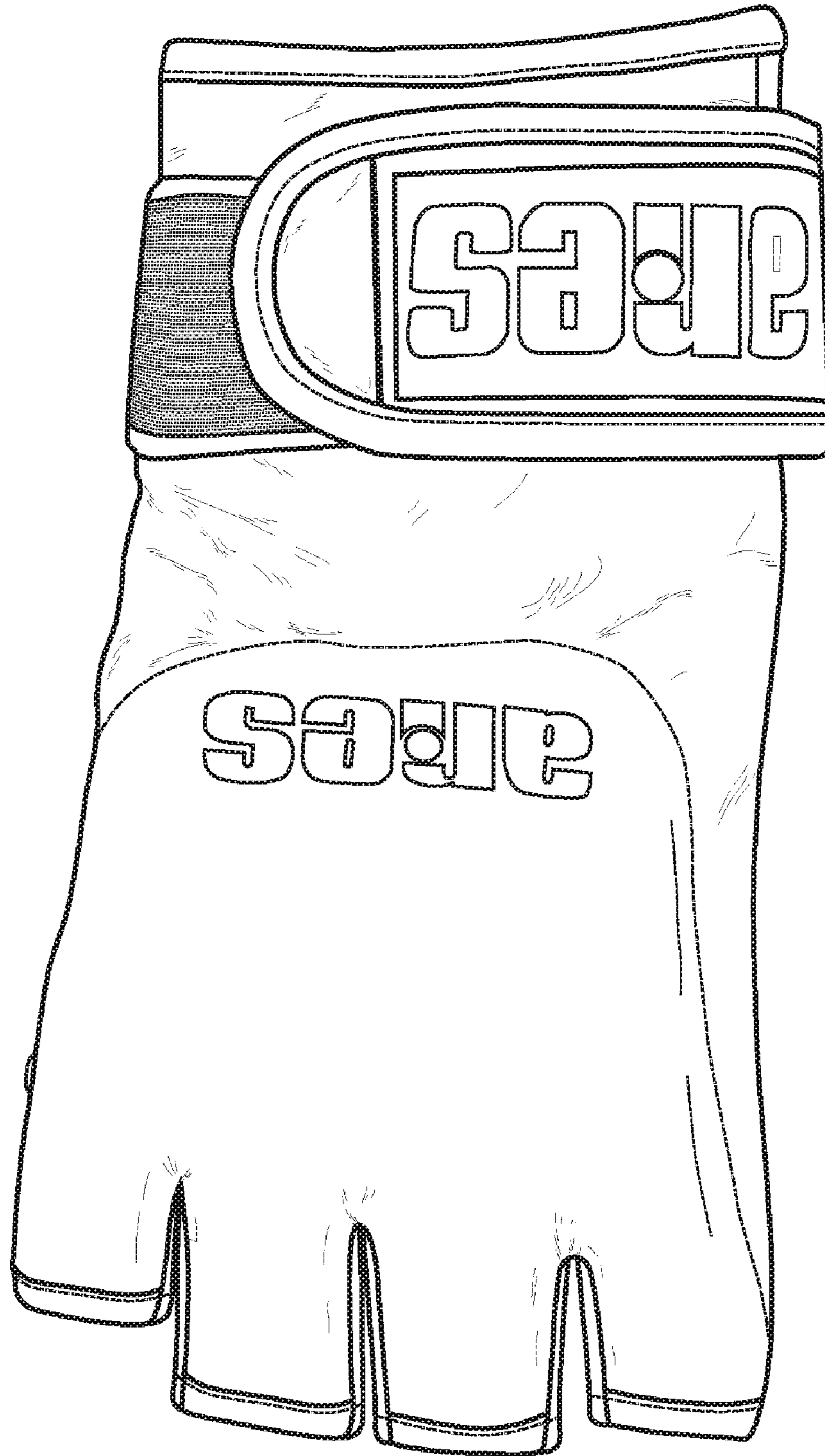

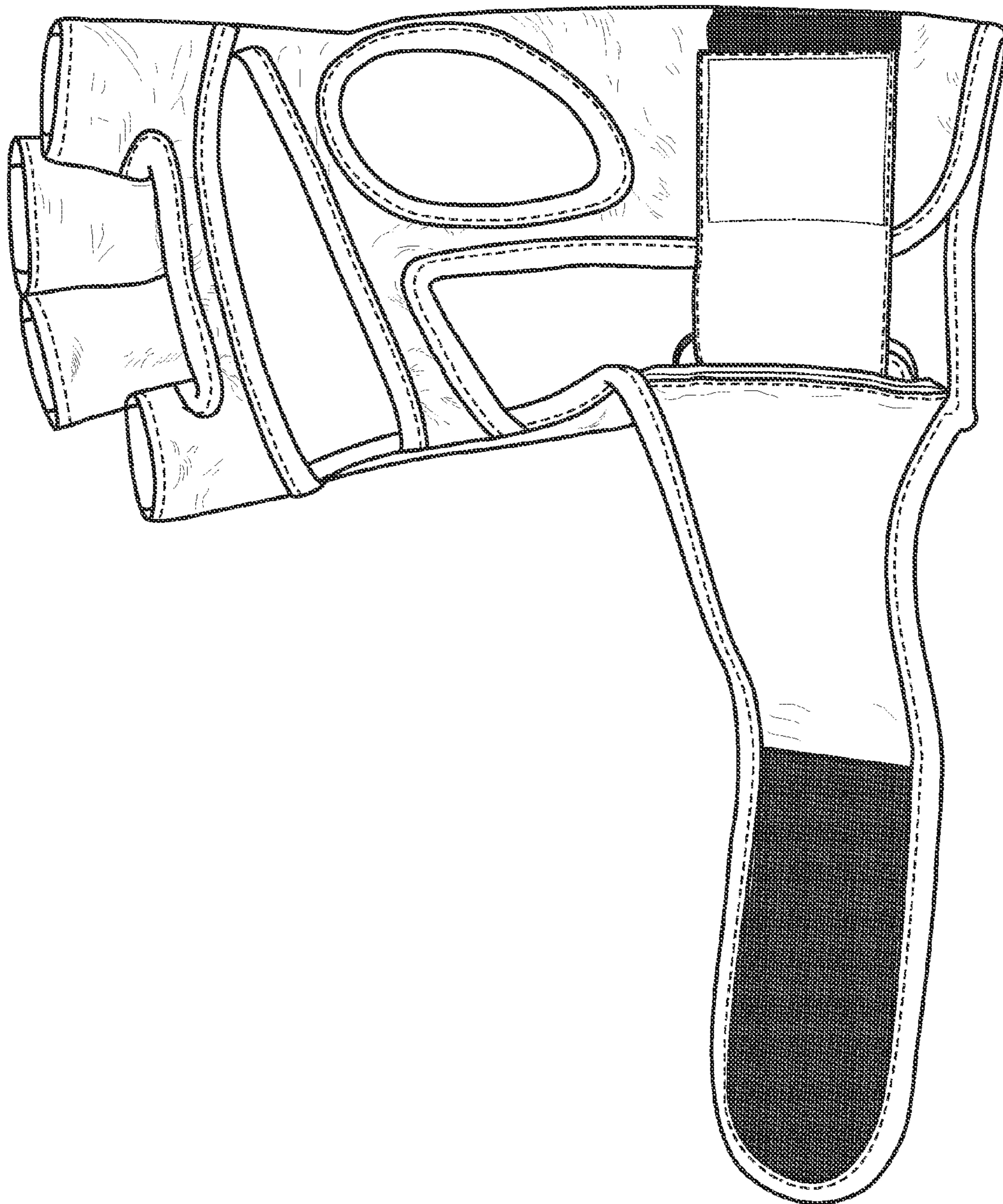

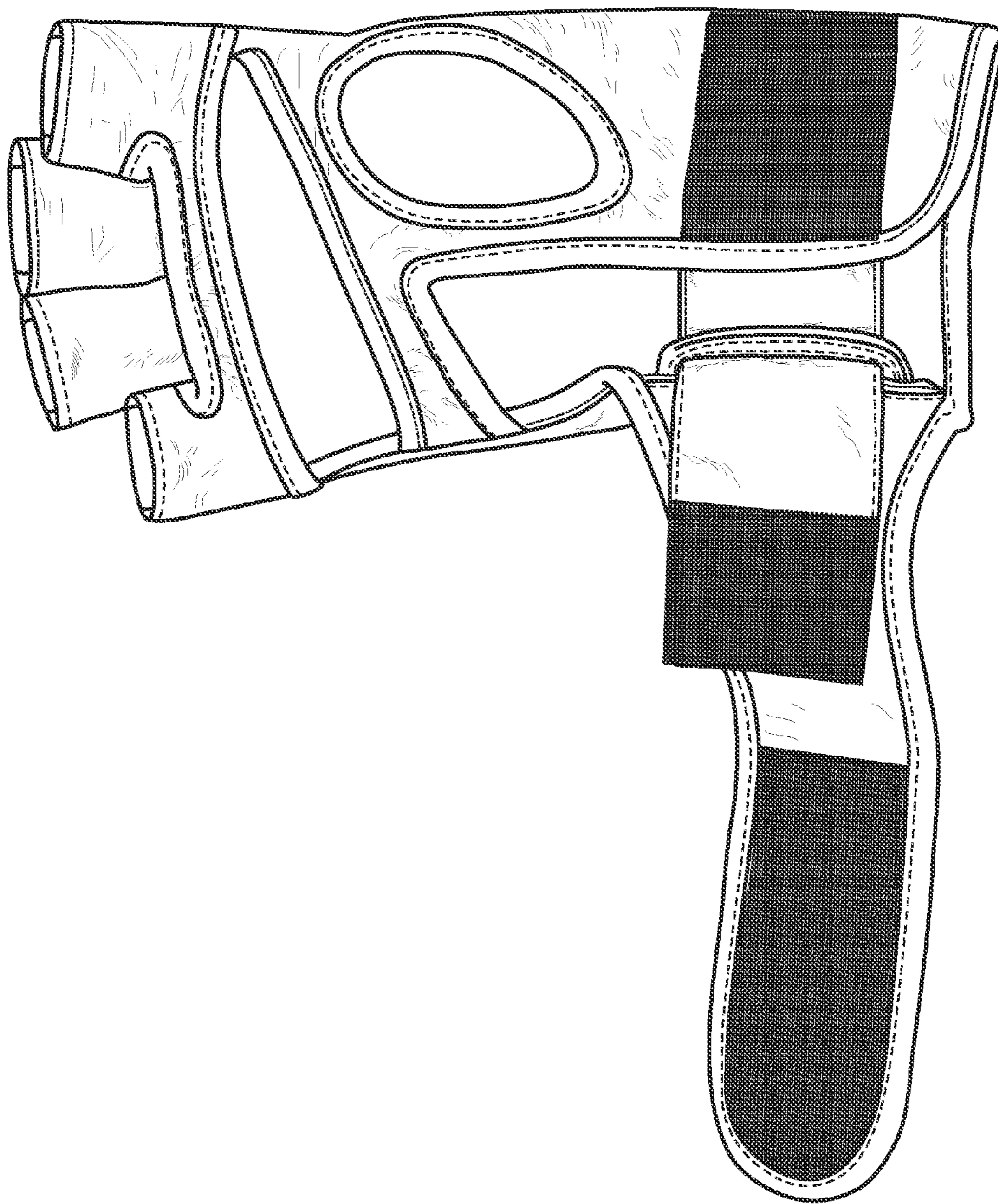
