DESCRIPTION

FIG. 7 is a perspective view of the pillow insert shown separately for ease of illustration;

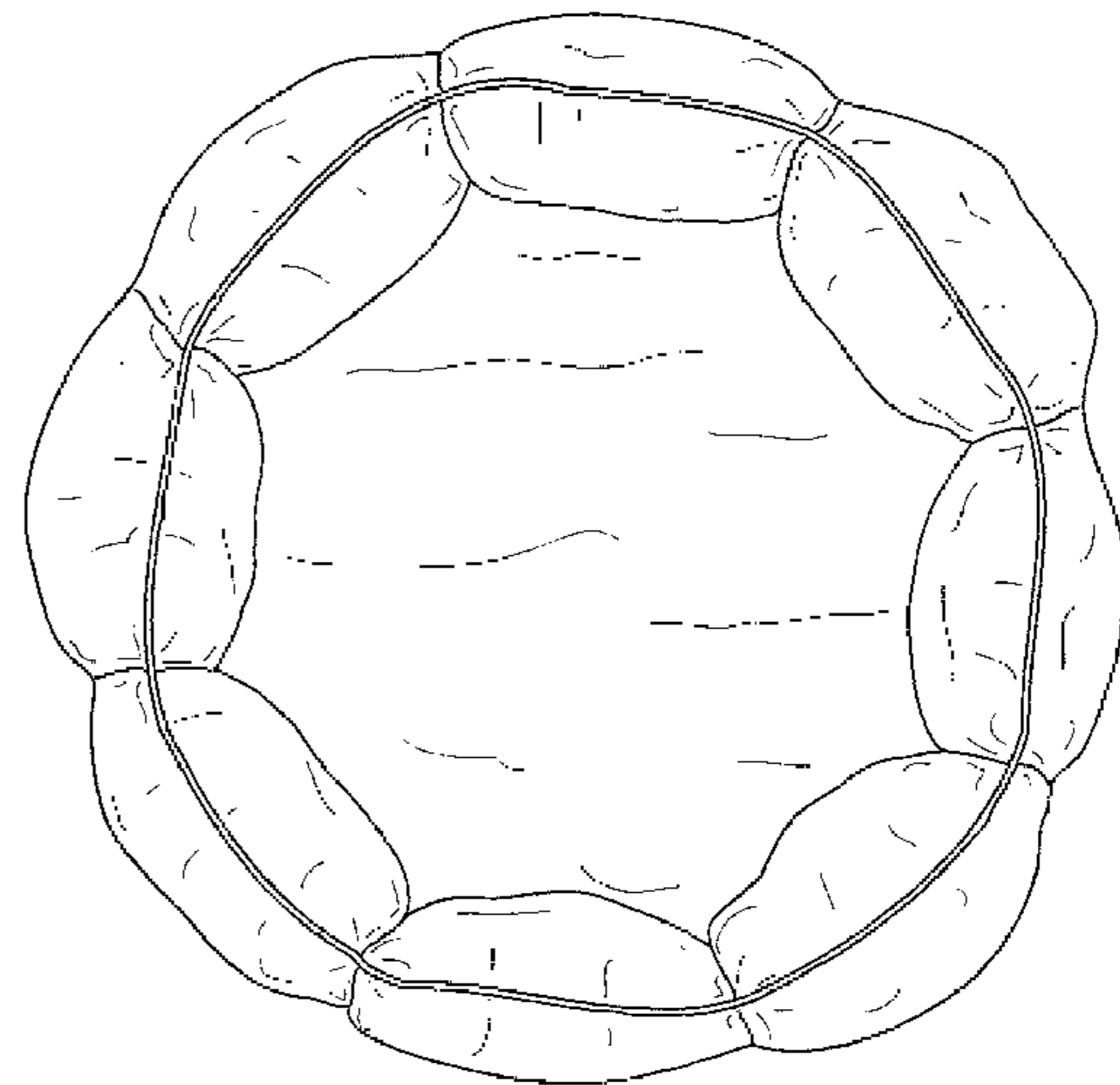
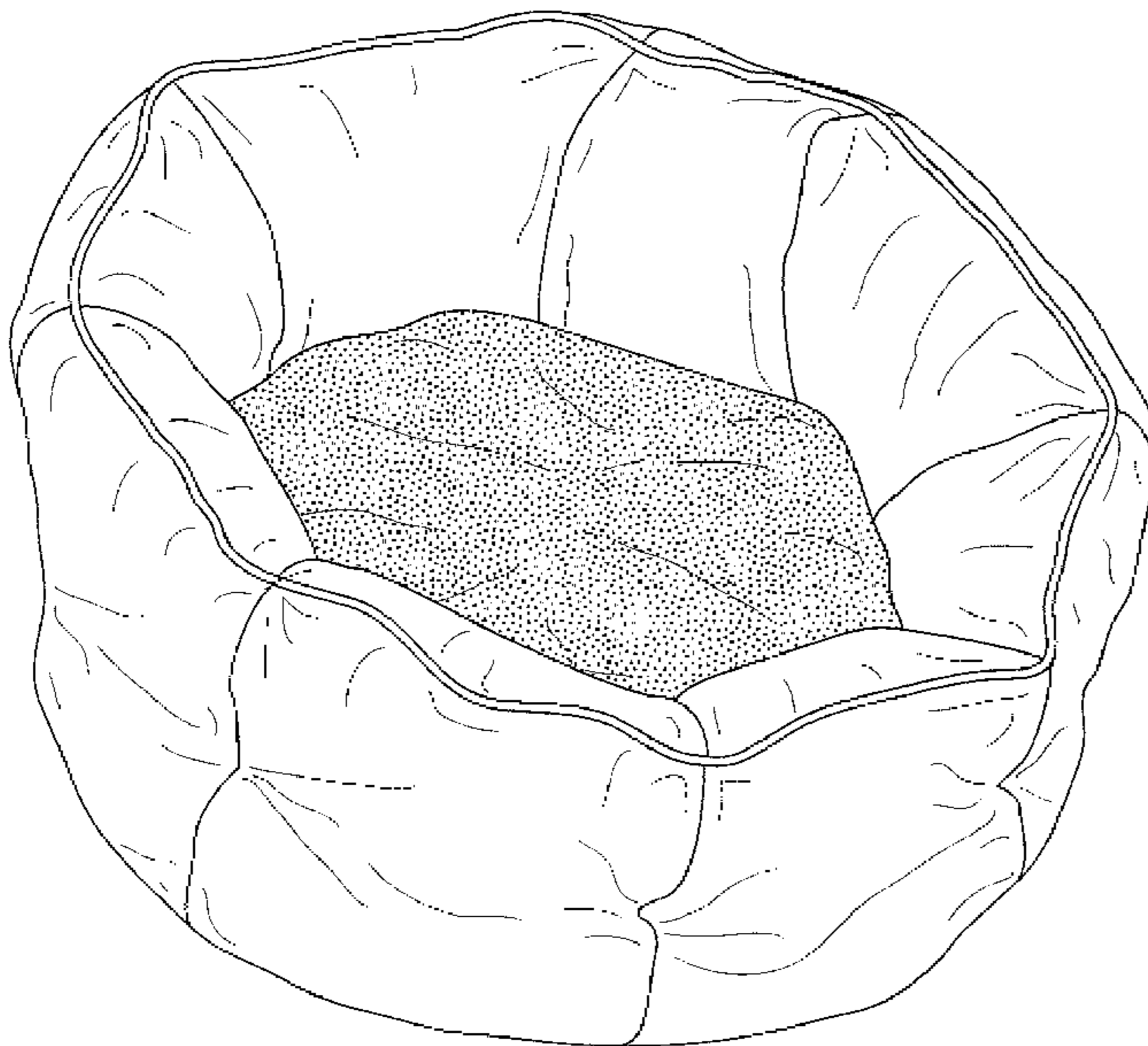
FIG. 8 is a right side view of FIG. 7;

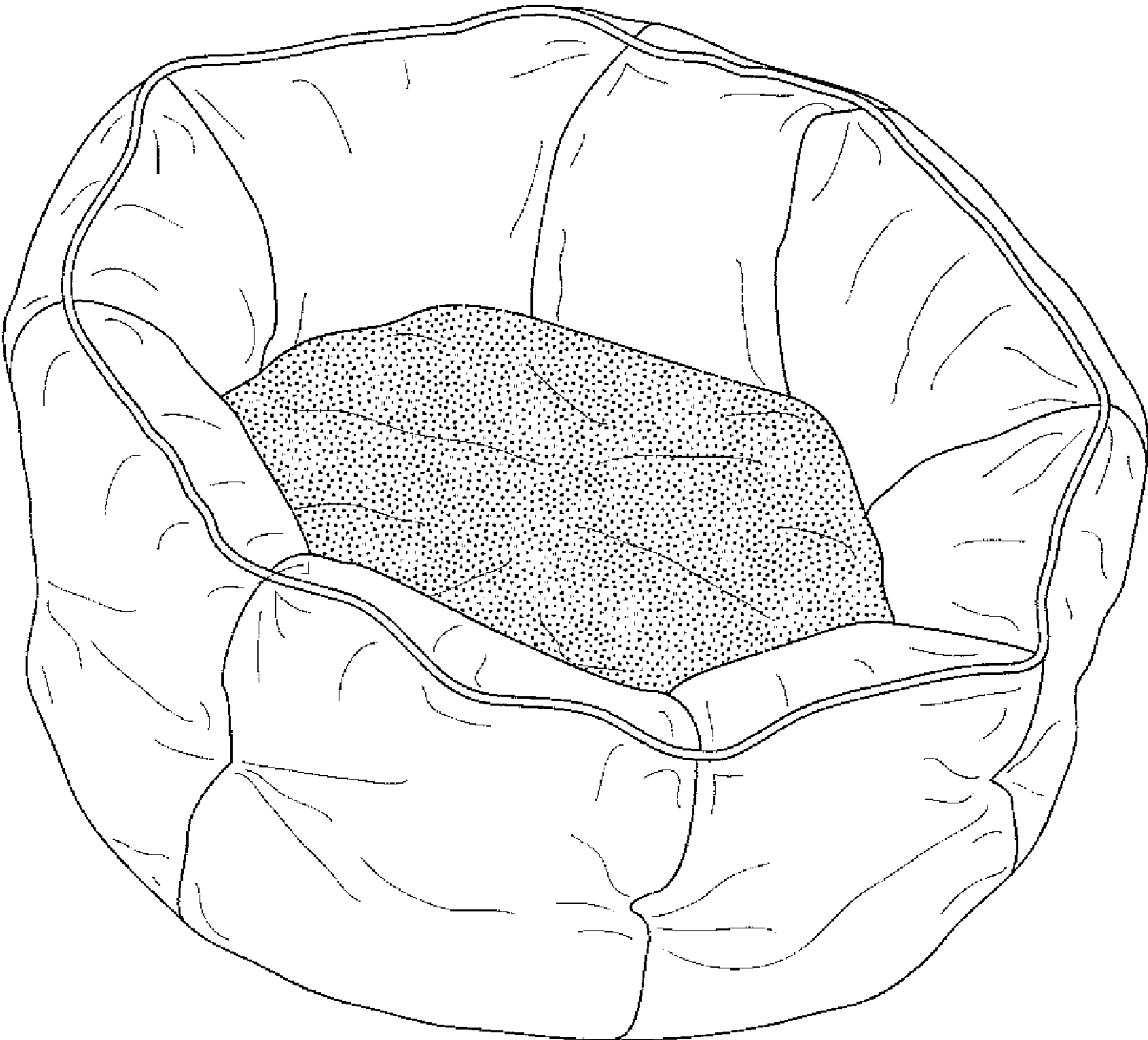

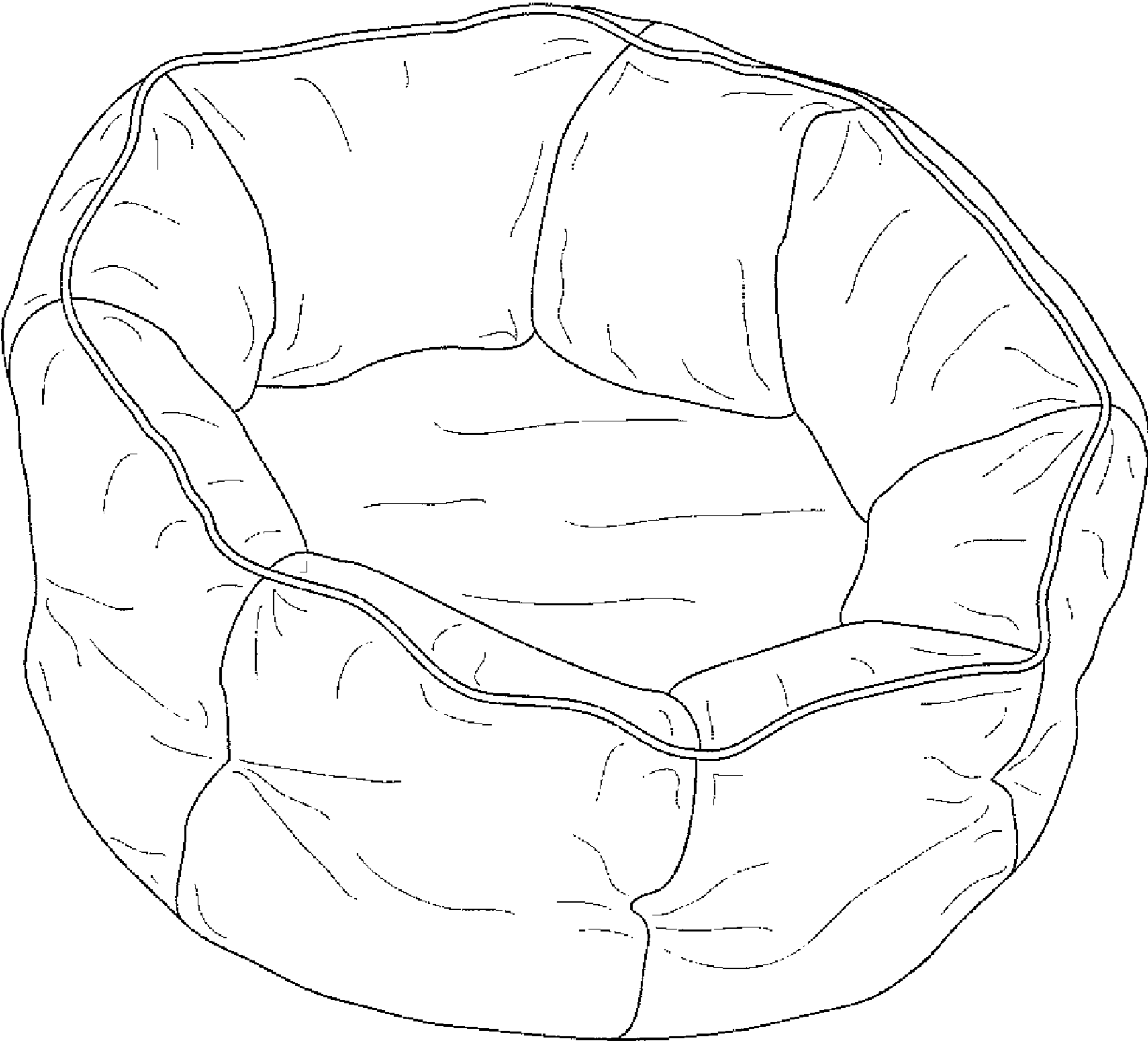

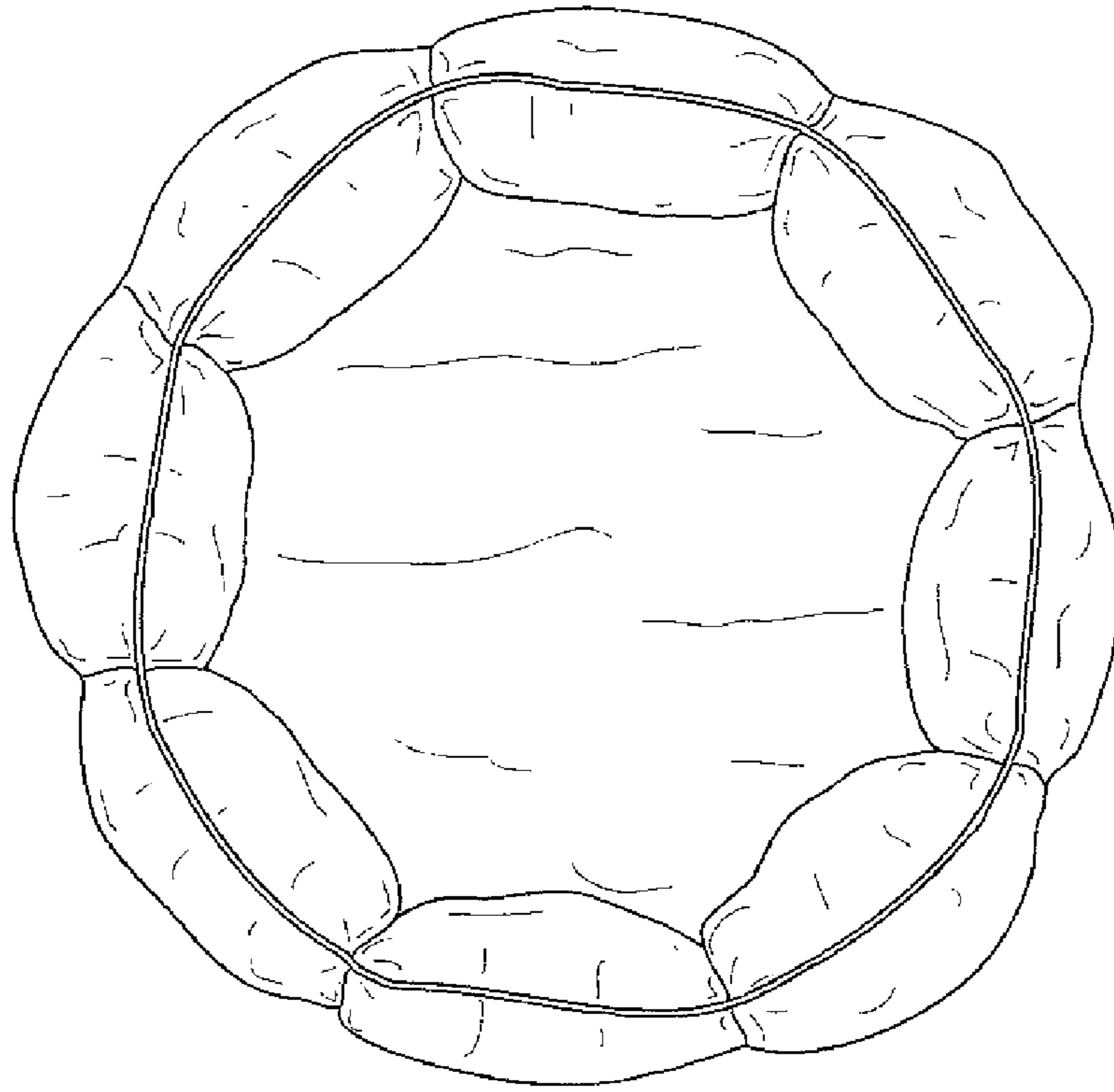

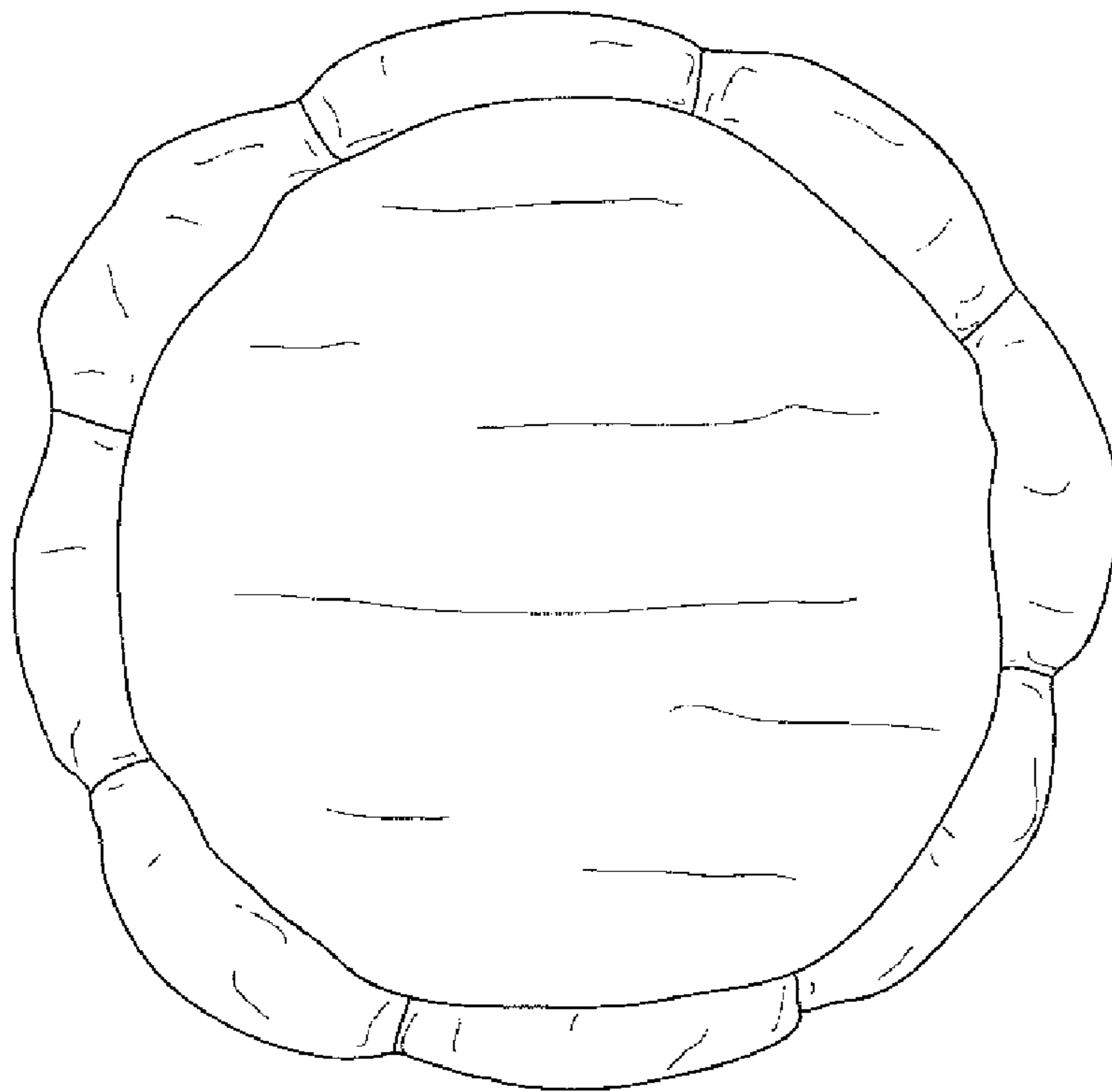

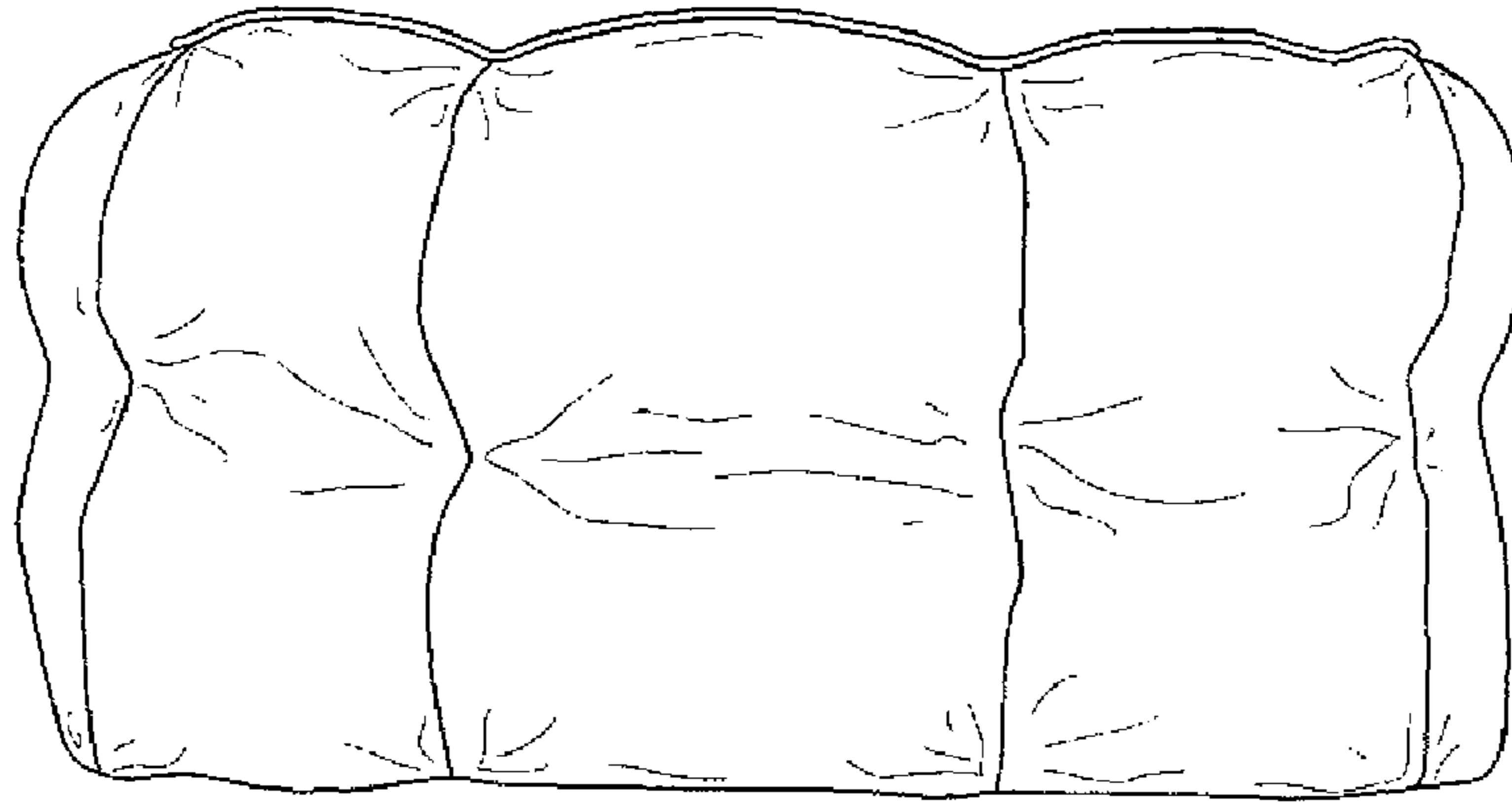

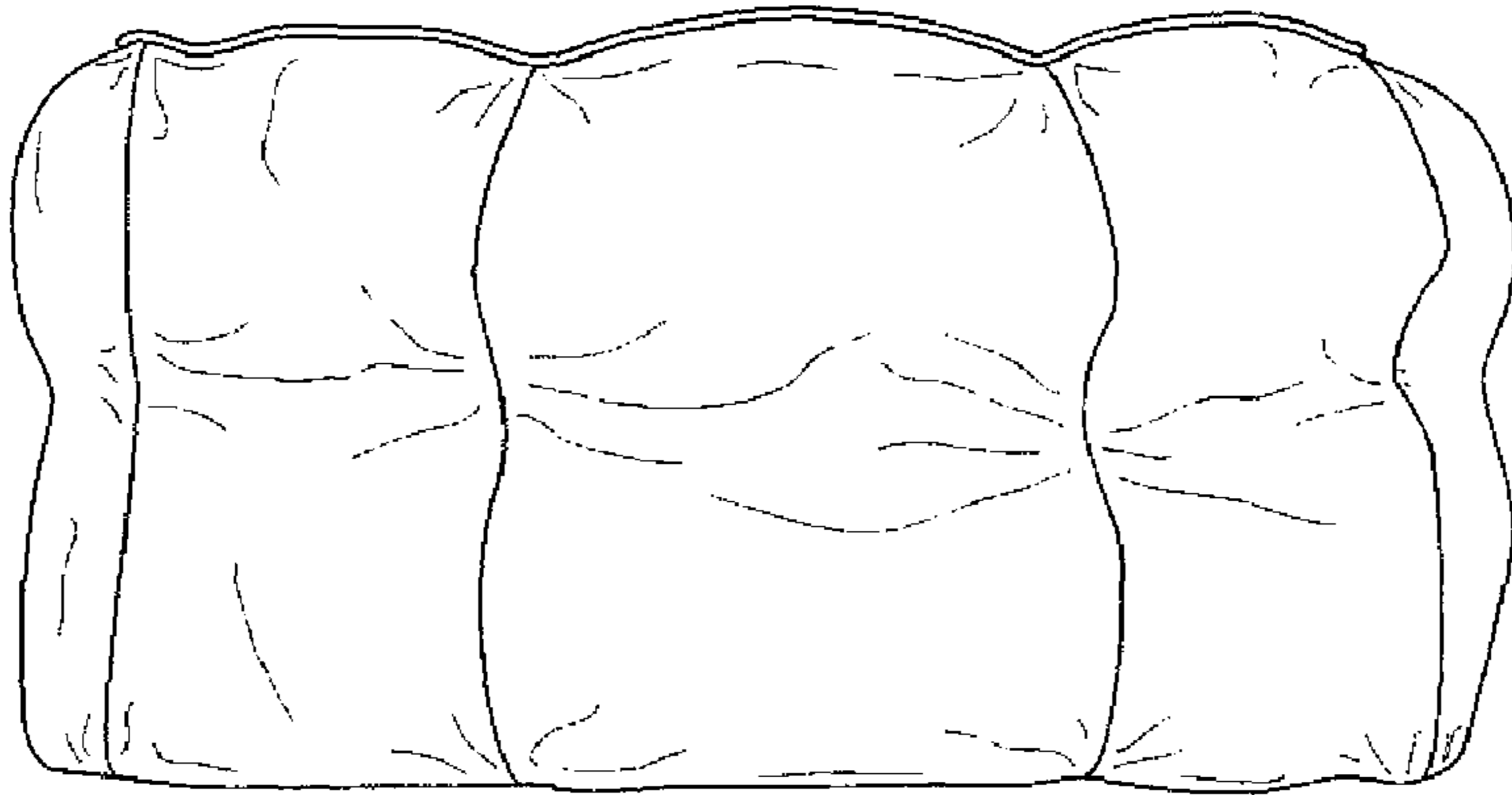

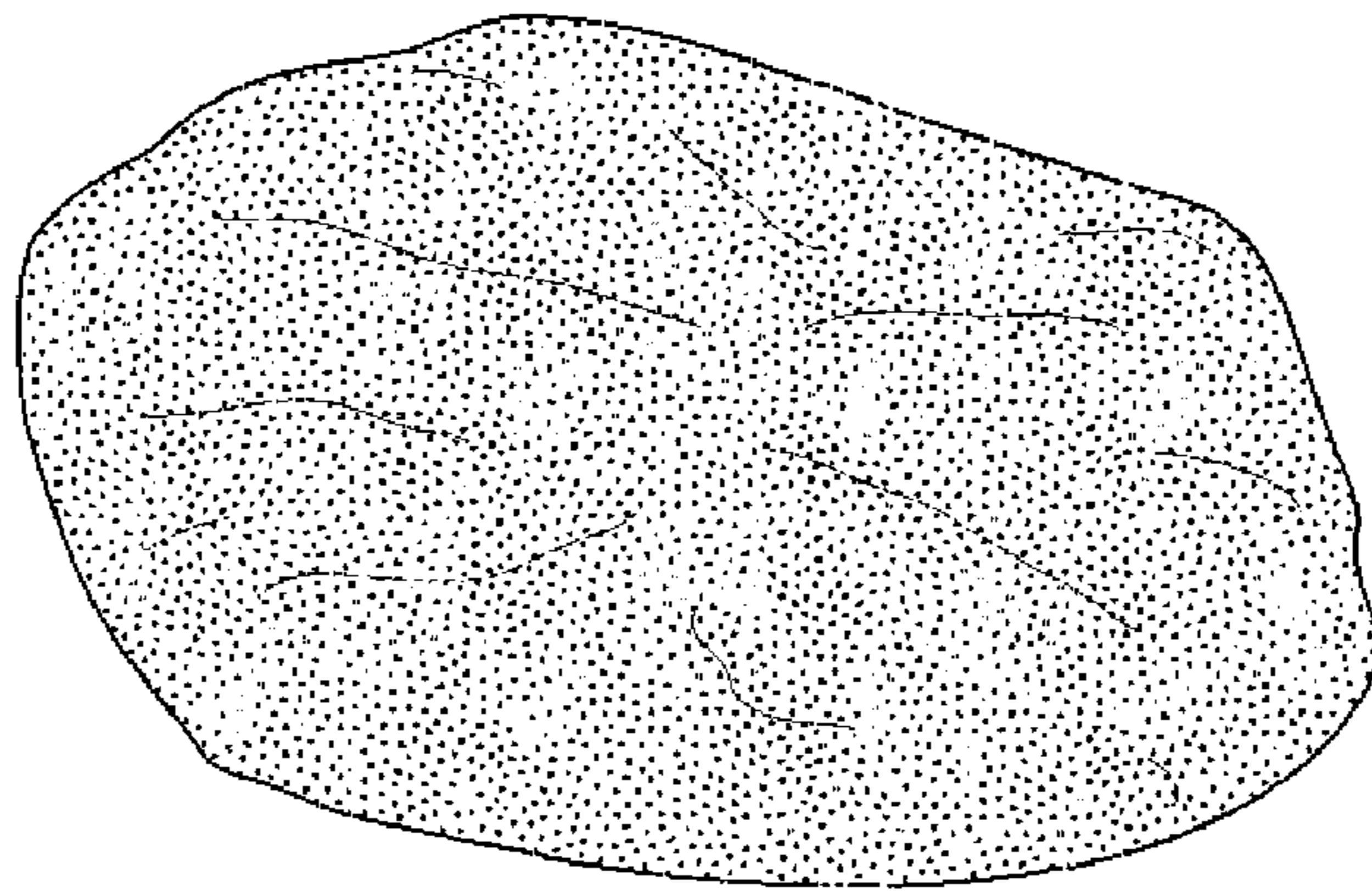

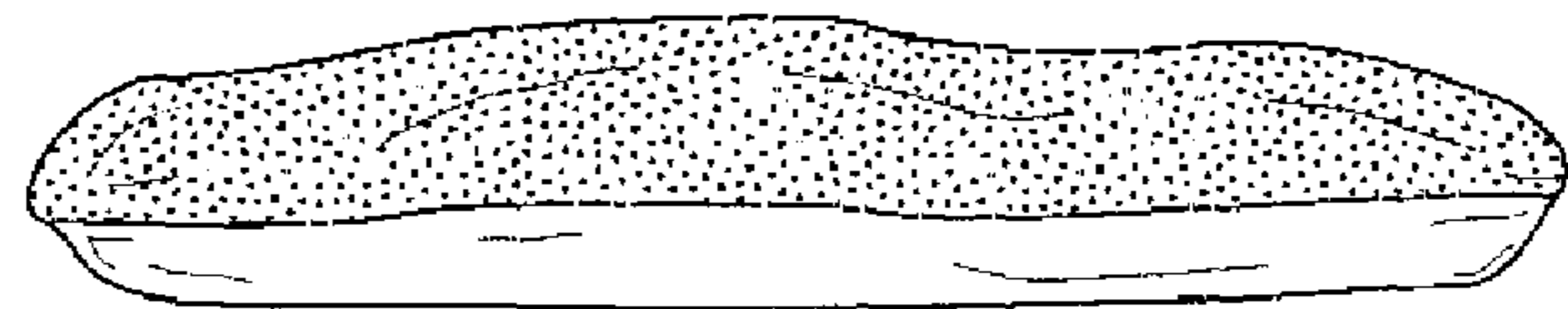

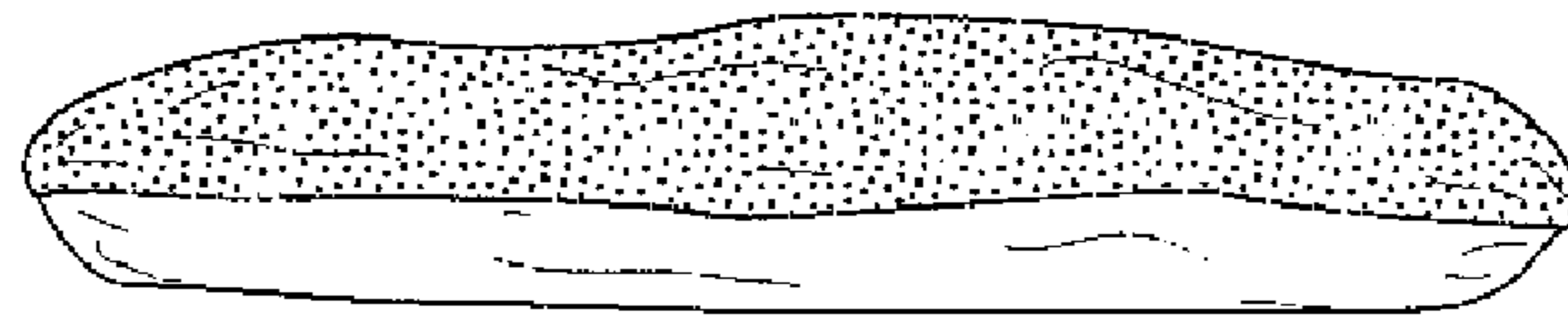

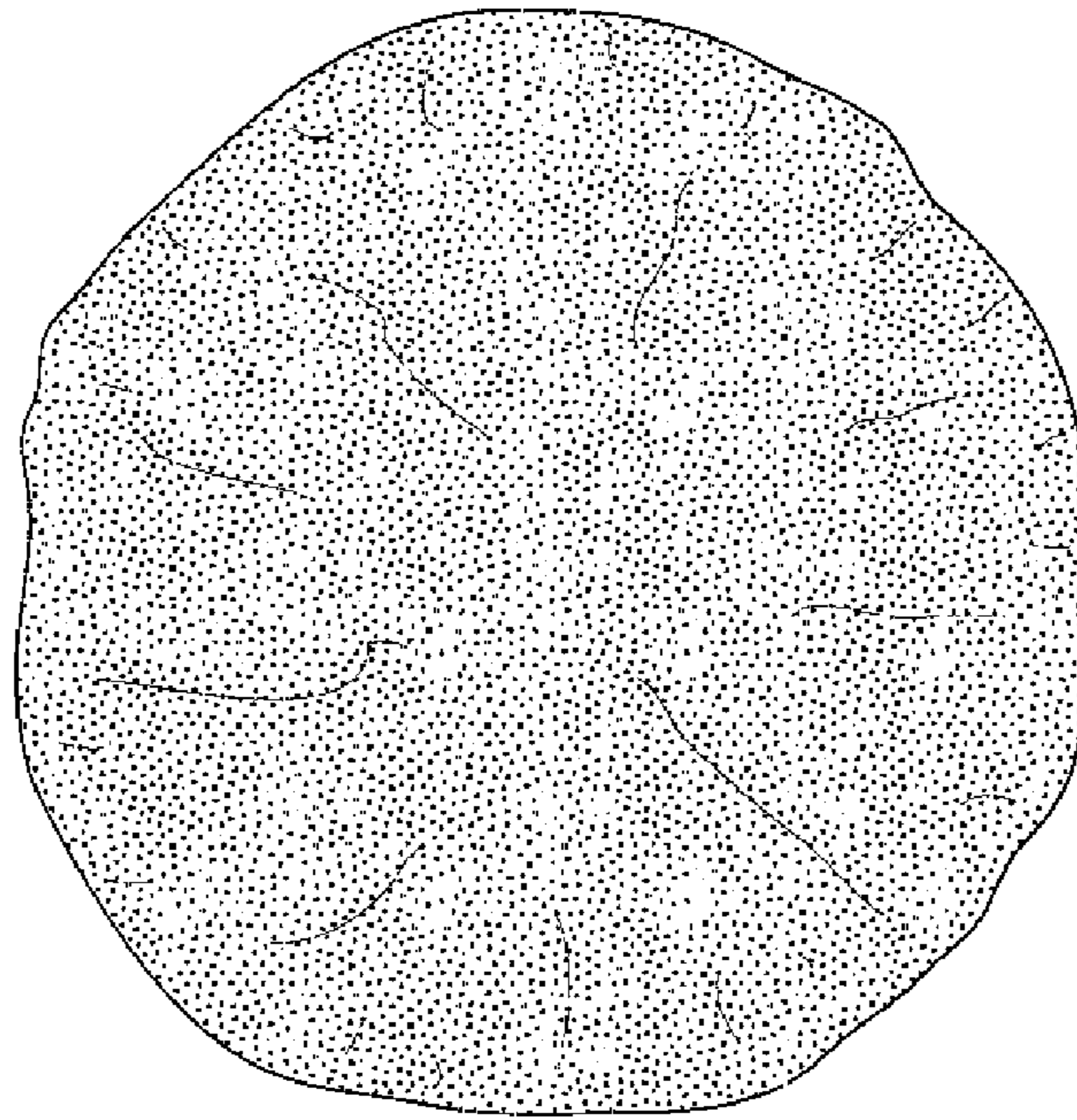

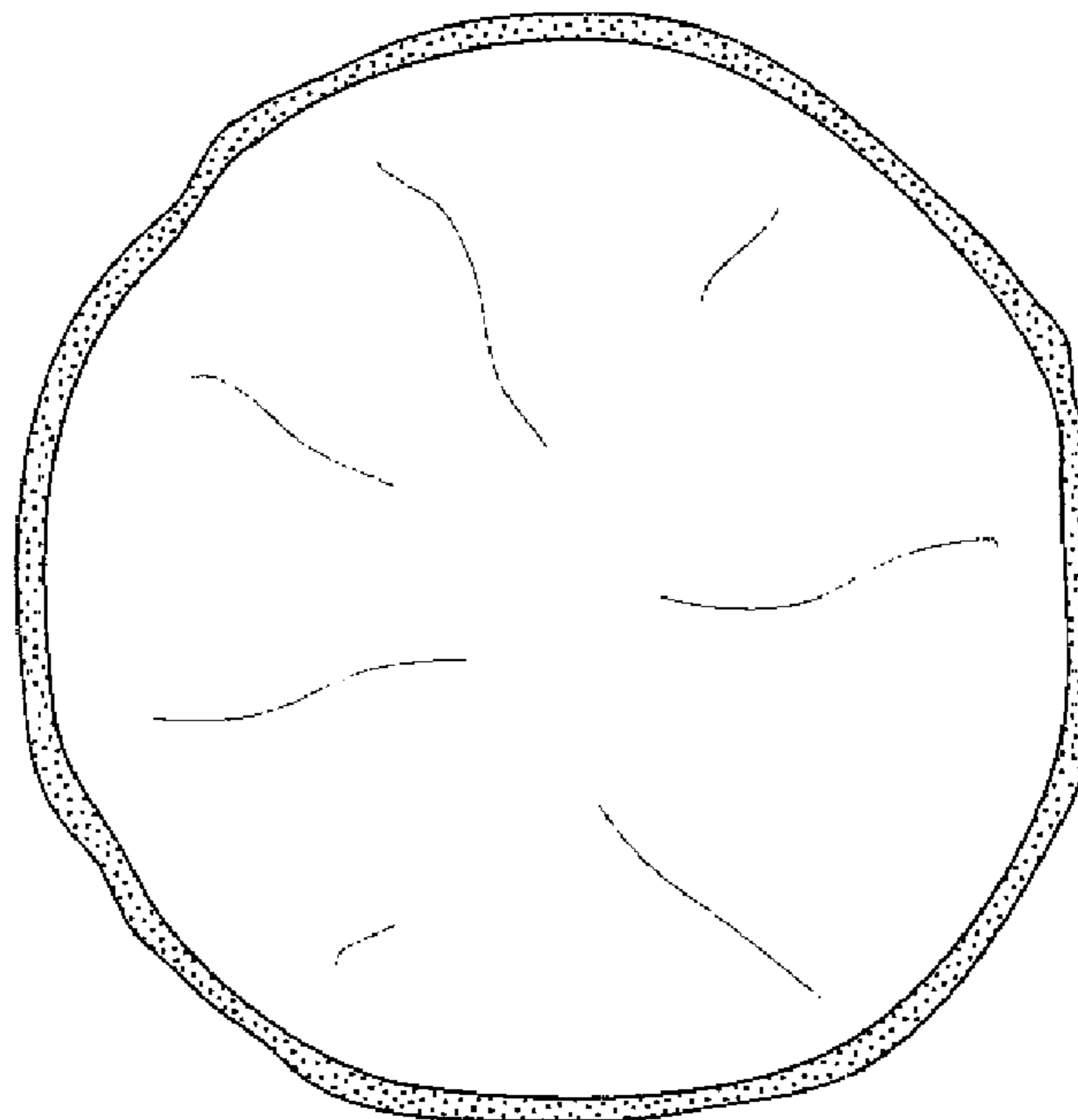
