(57) **CLAIM**

What is claimed is the ornamental design for a horizontal holster, as shown and described.

DESCRIPTION

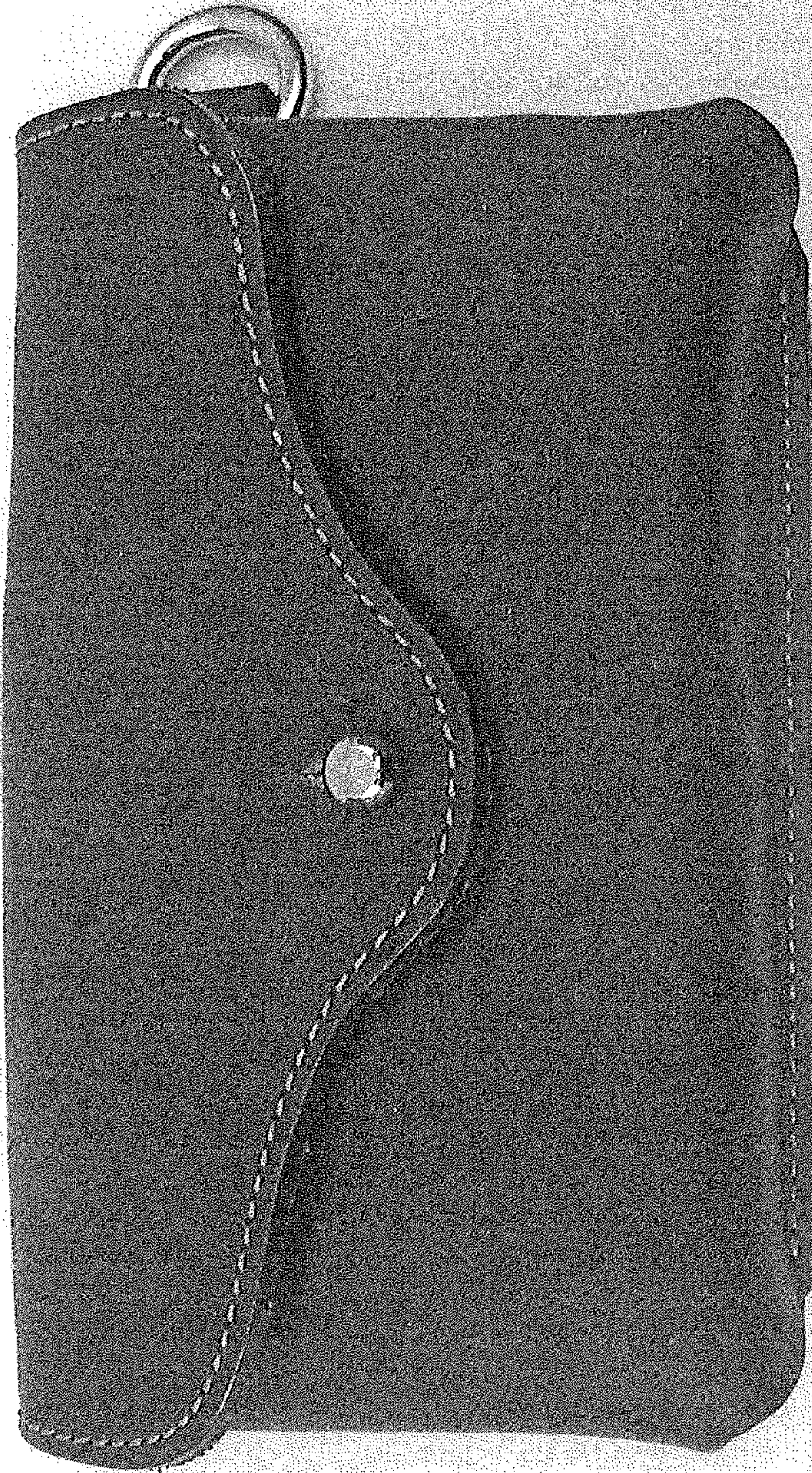


Fig. 1 - Front View/Flap
Closed

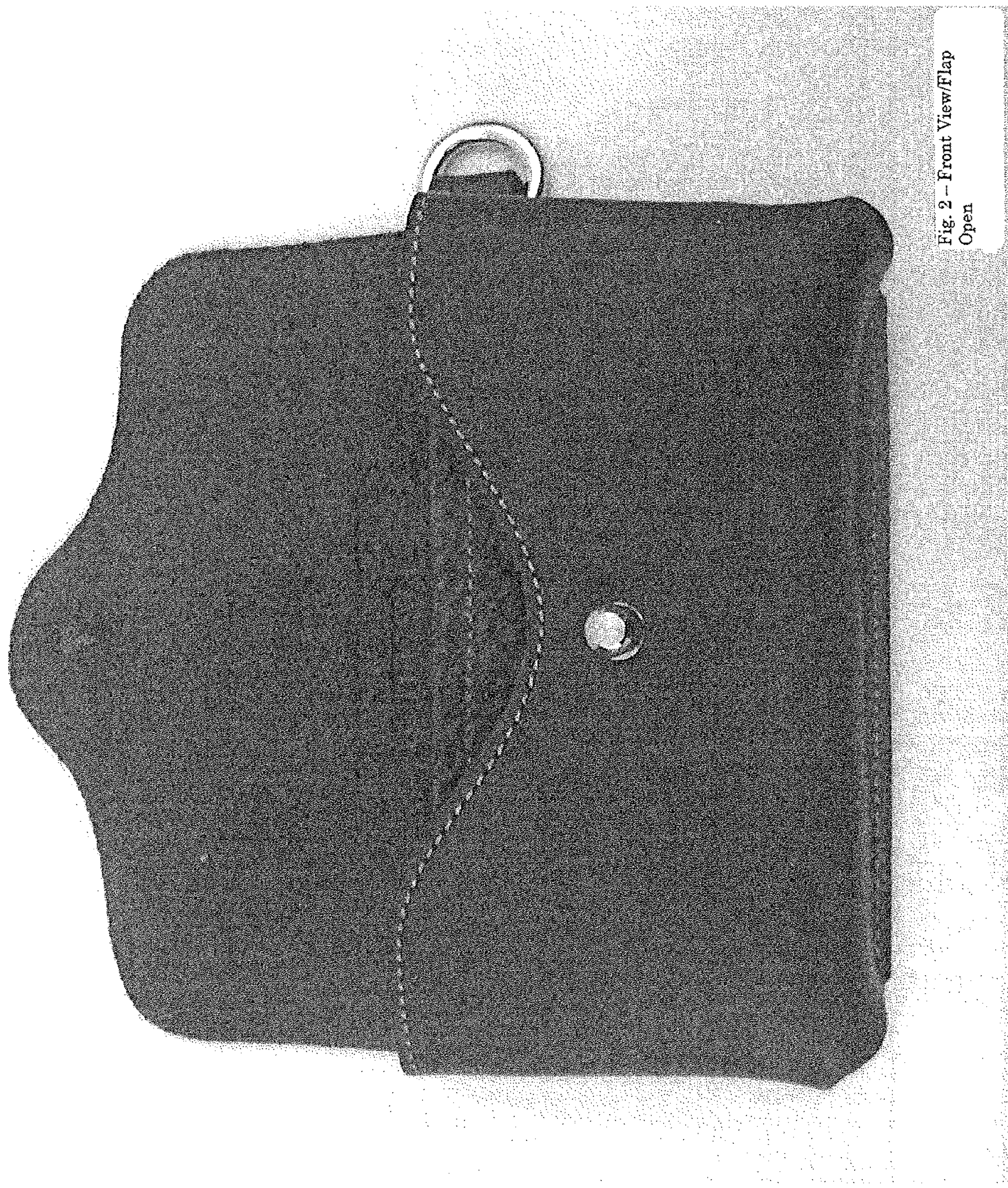


Fig. 2 - Front View/Flap

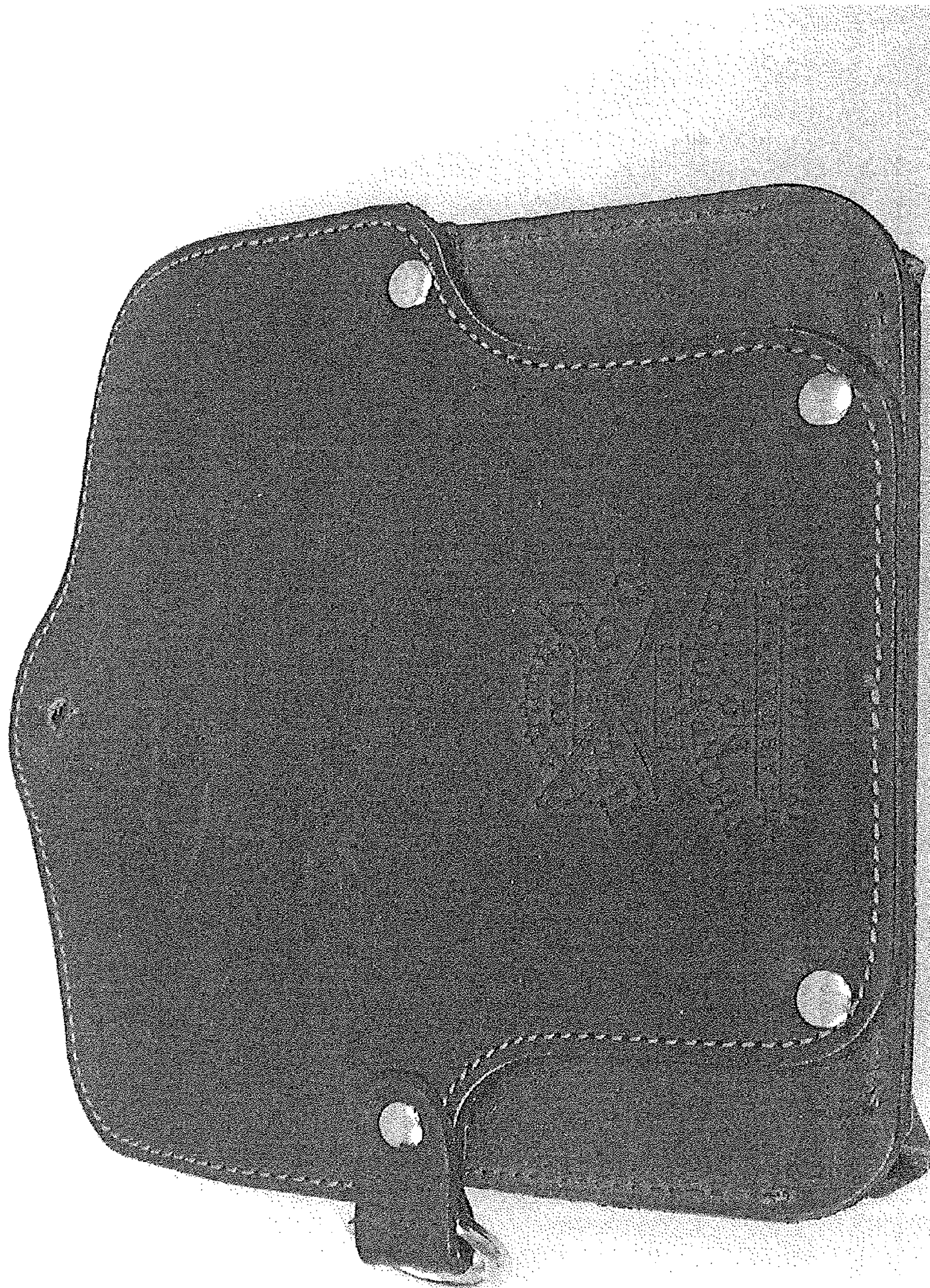


Fig. 4 - Back View/Flap
Open

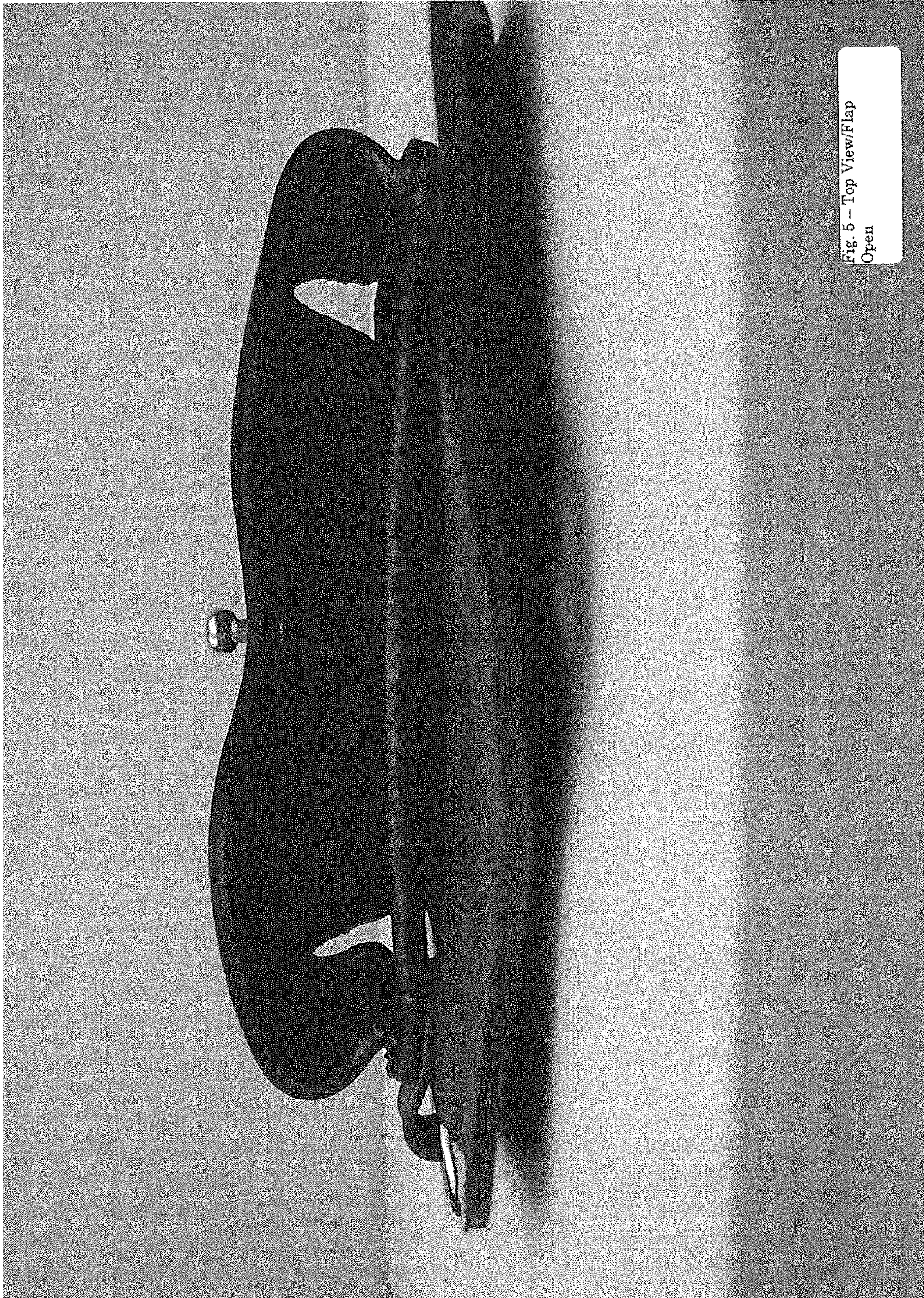
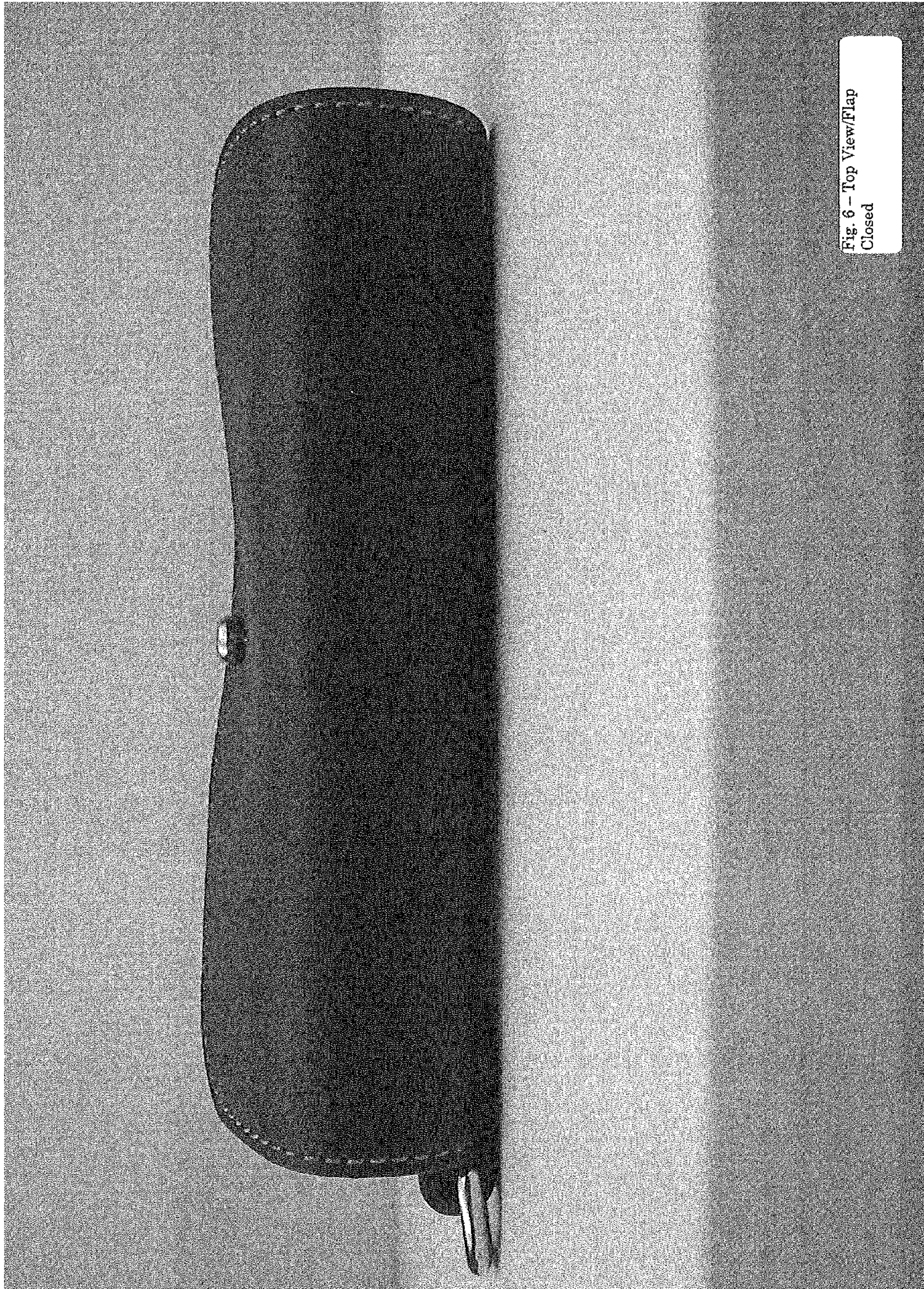


Fig. 5 - Top View/Flap
Open



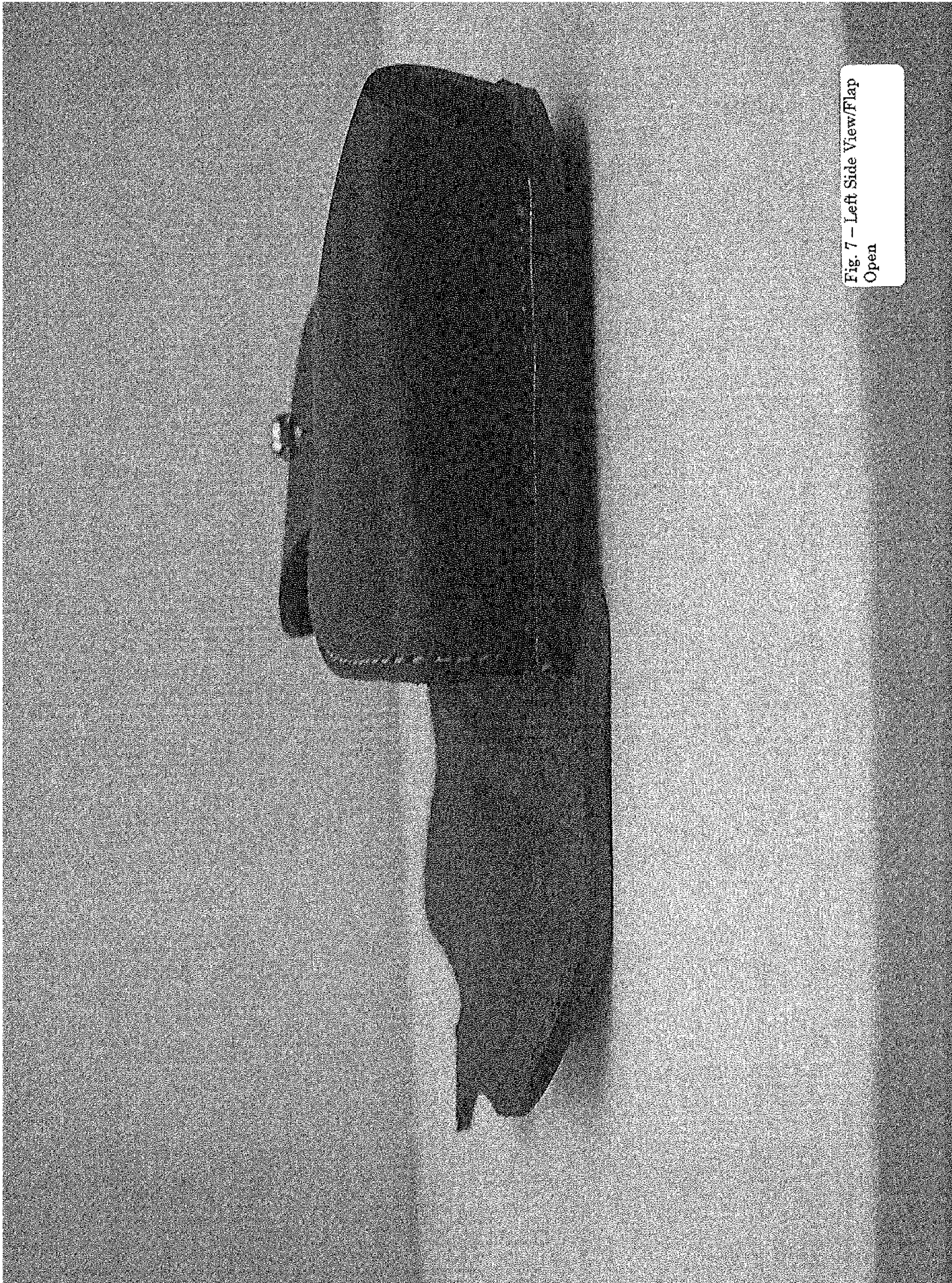




Fig. 8 - Left Side View/Flap
