FIG. 1 is a perspective view of a multiple tier wire frame baker's rack with four tiers.

FIG. 2 is a front view of the rack of FIG. 1.

FIG. 3 is a rear view of the rack of FIG. 1.

FIG. 4 is a left side view of the rack of FIG. 1.

FIG. 5 is a right side view of the rack of FIG. 1.

FIG. 6 is a top view of the rack of FIG. 1.

FIG. 7 is a bottom view of the rack of FIG. 1.

FIG. 8 is a perspective view of an alternate embodiment of a multiple tier wire frame baker's rack with two tiers.

FIG. 9 is a front view of the rack of FIG. 8.

FIG. 10 is a rear view of the rack of FIG. 8.

FIG. 11 is a left side view of the rack of FIG. 8.

FIG. 12 is a right side view of the rack of FIG. 8.

FIG. 13 is a top view of the rack of FIG. 8; and,

FIG. 14 is a bottom view of the rack of FIG. 8.

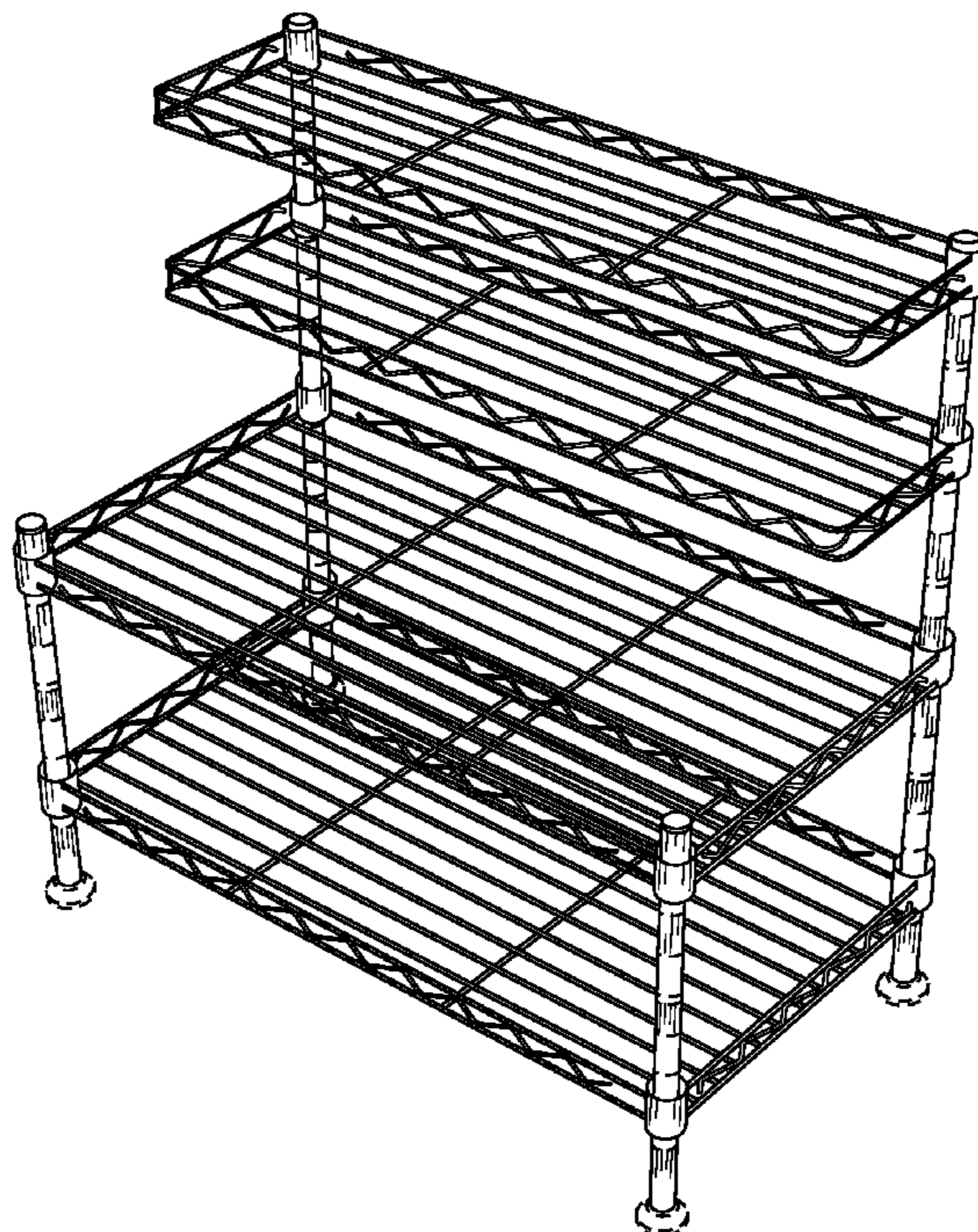

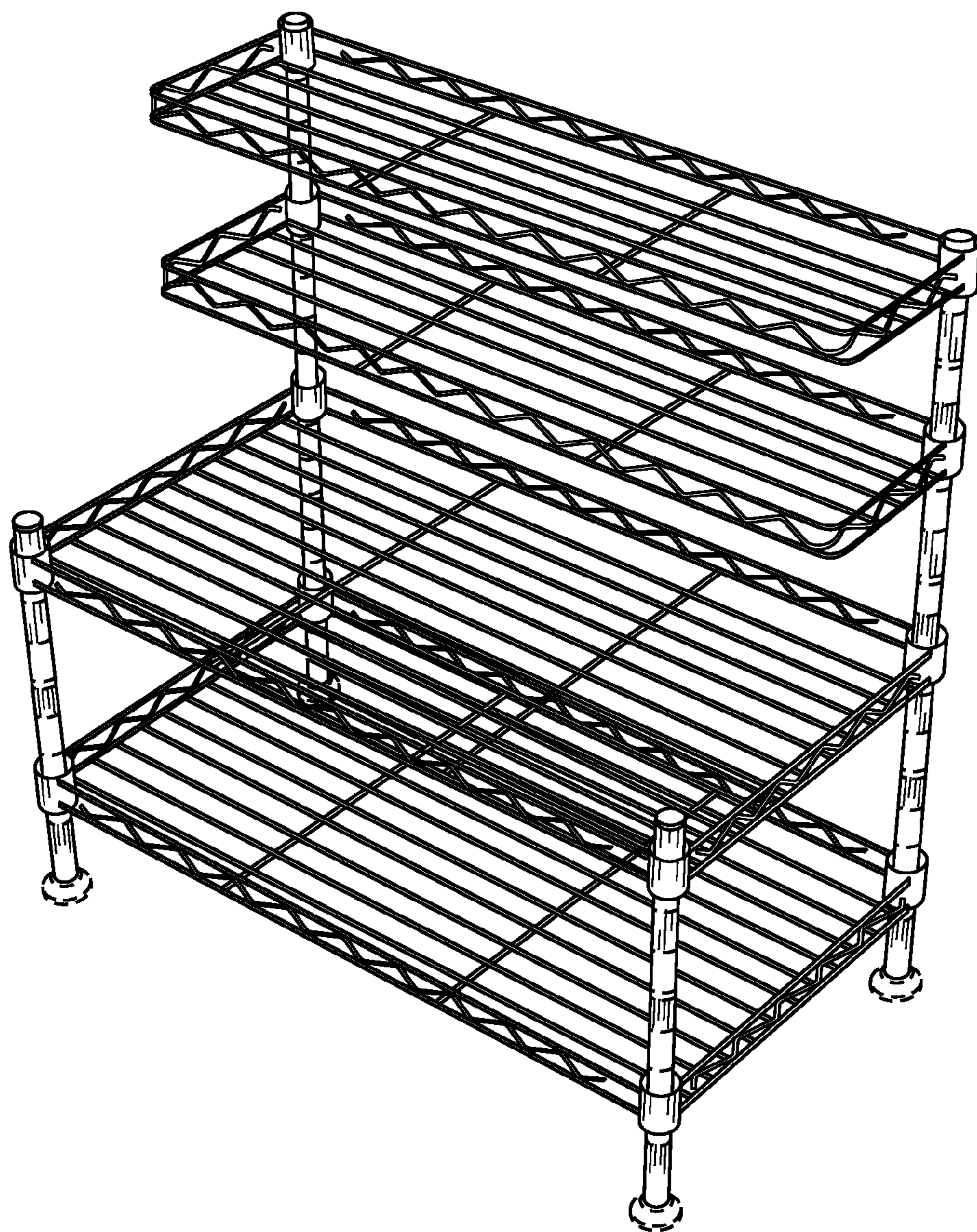

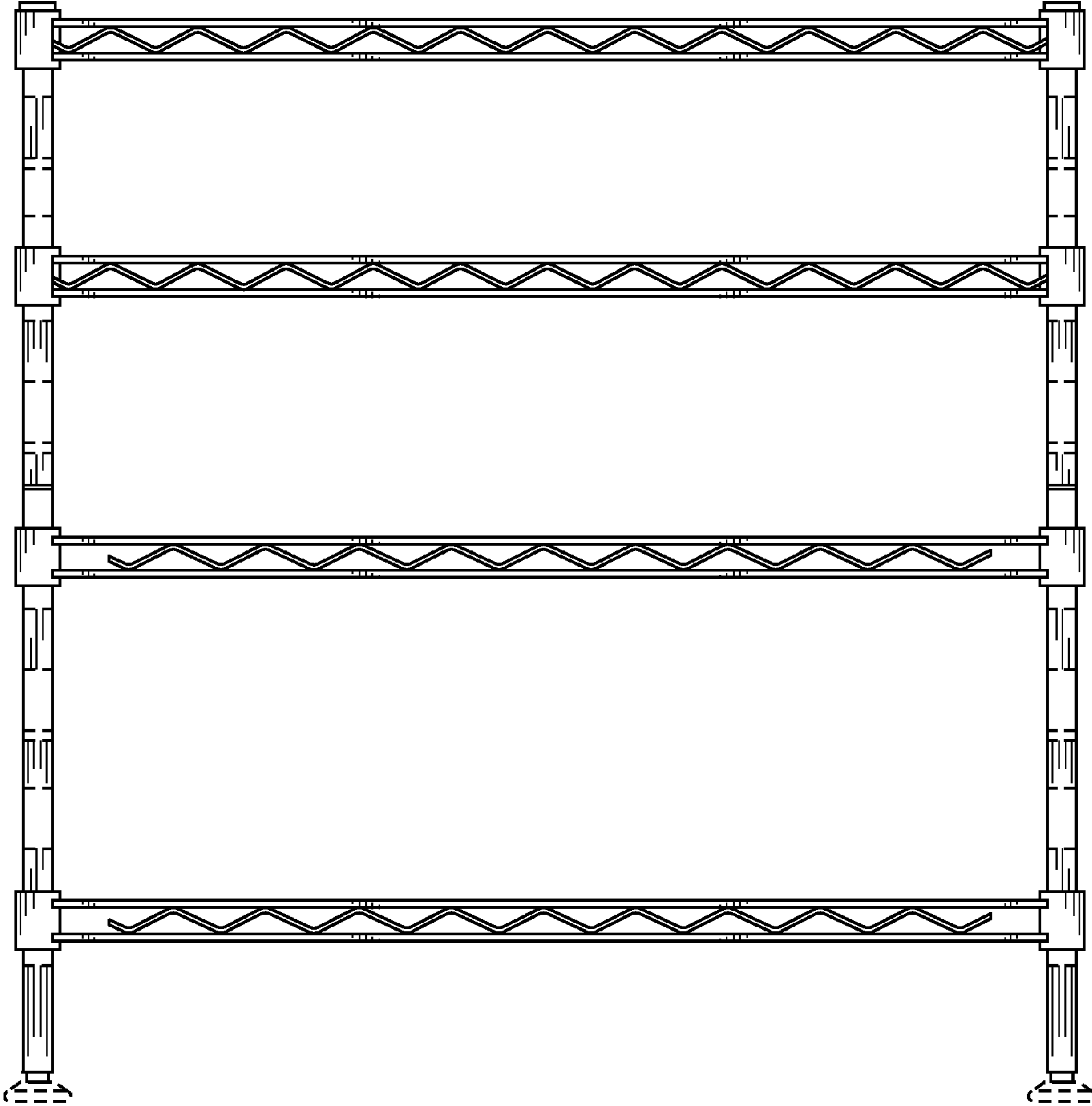

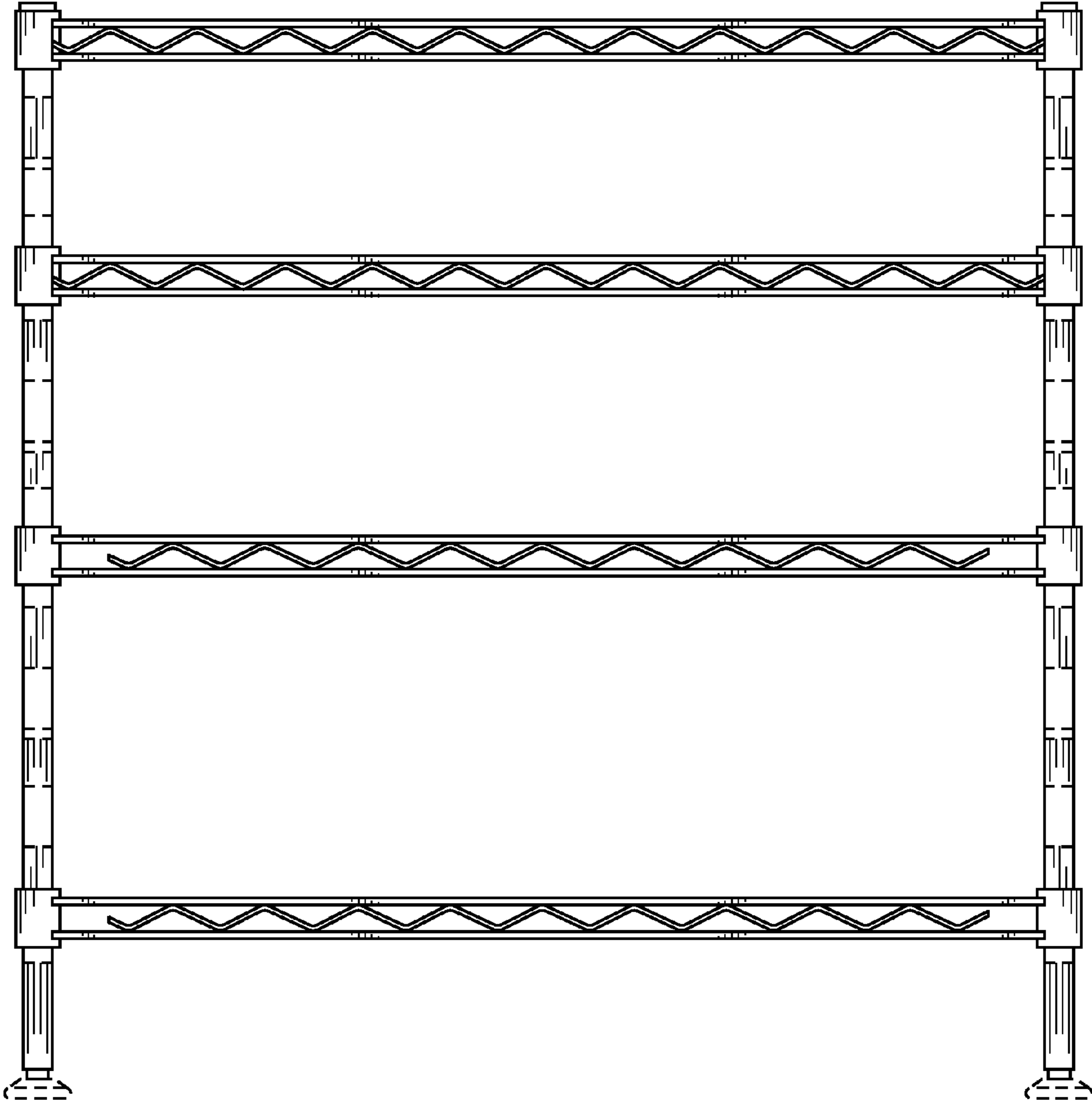

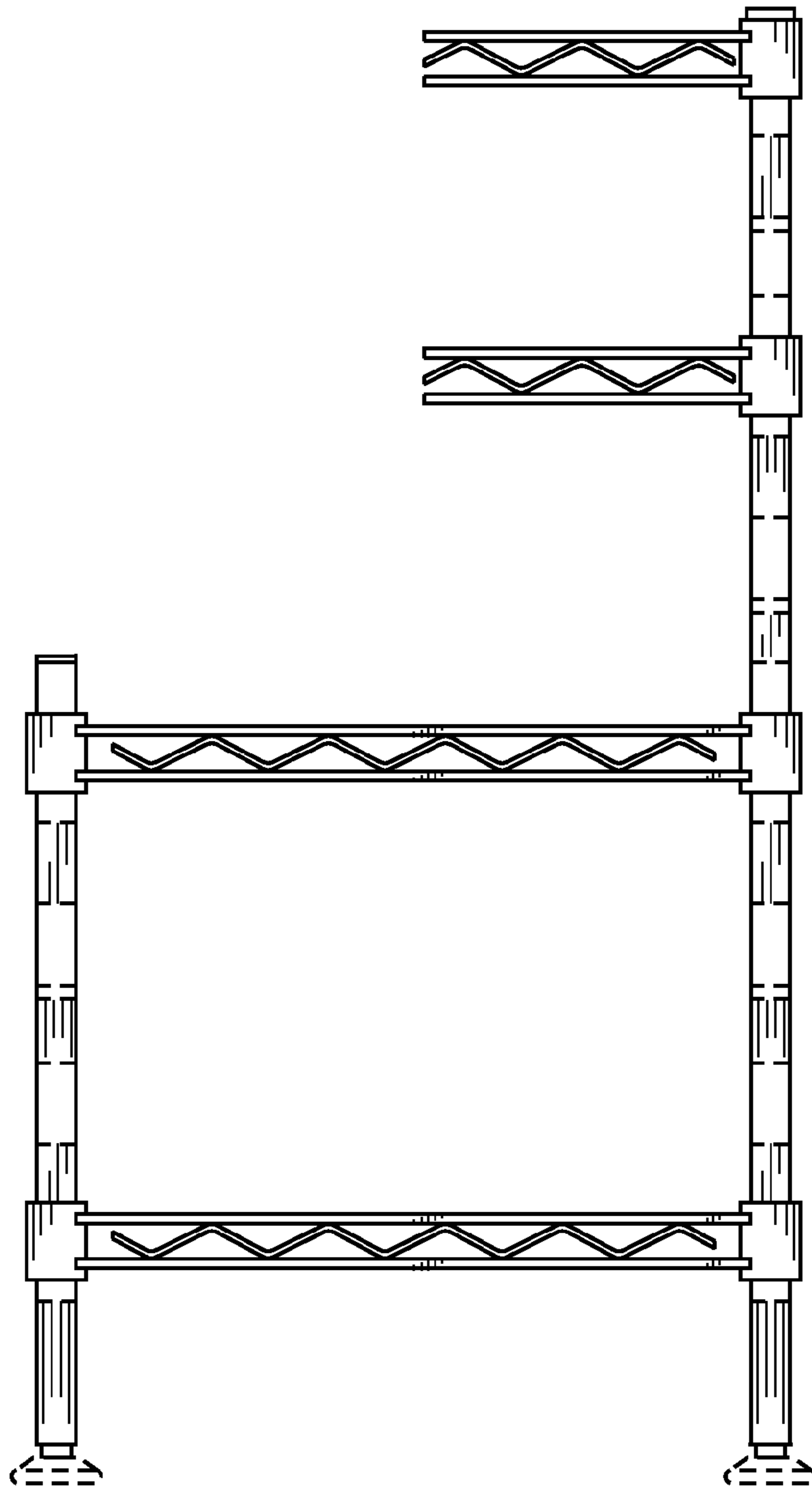

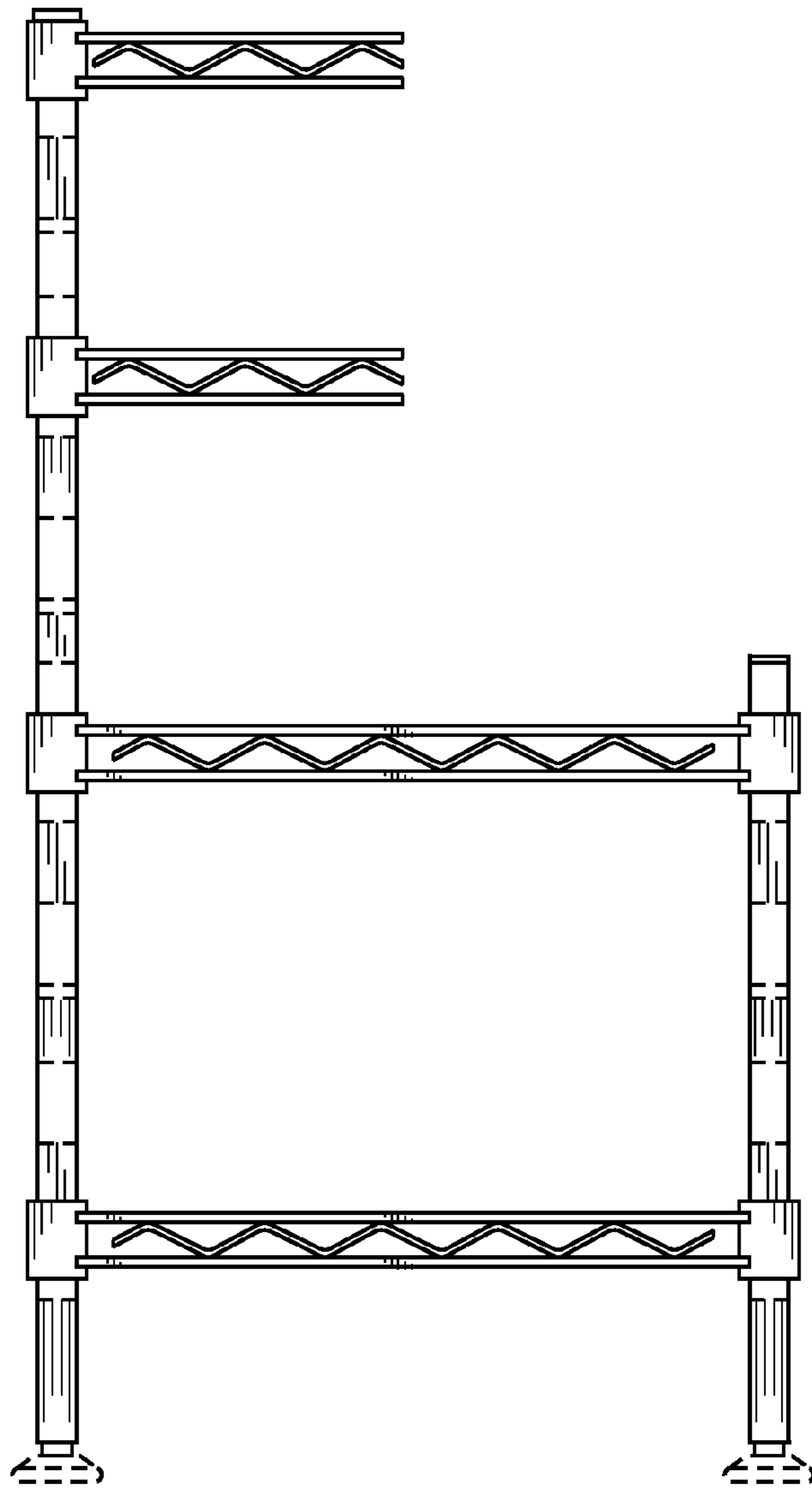

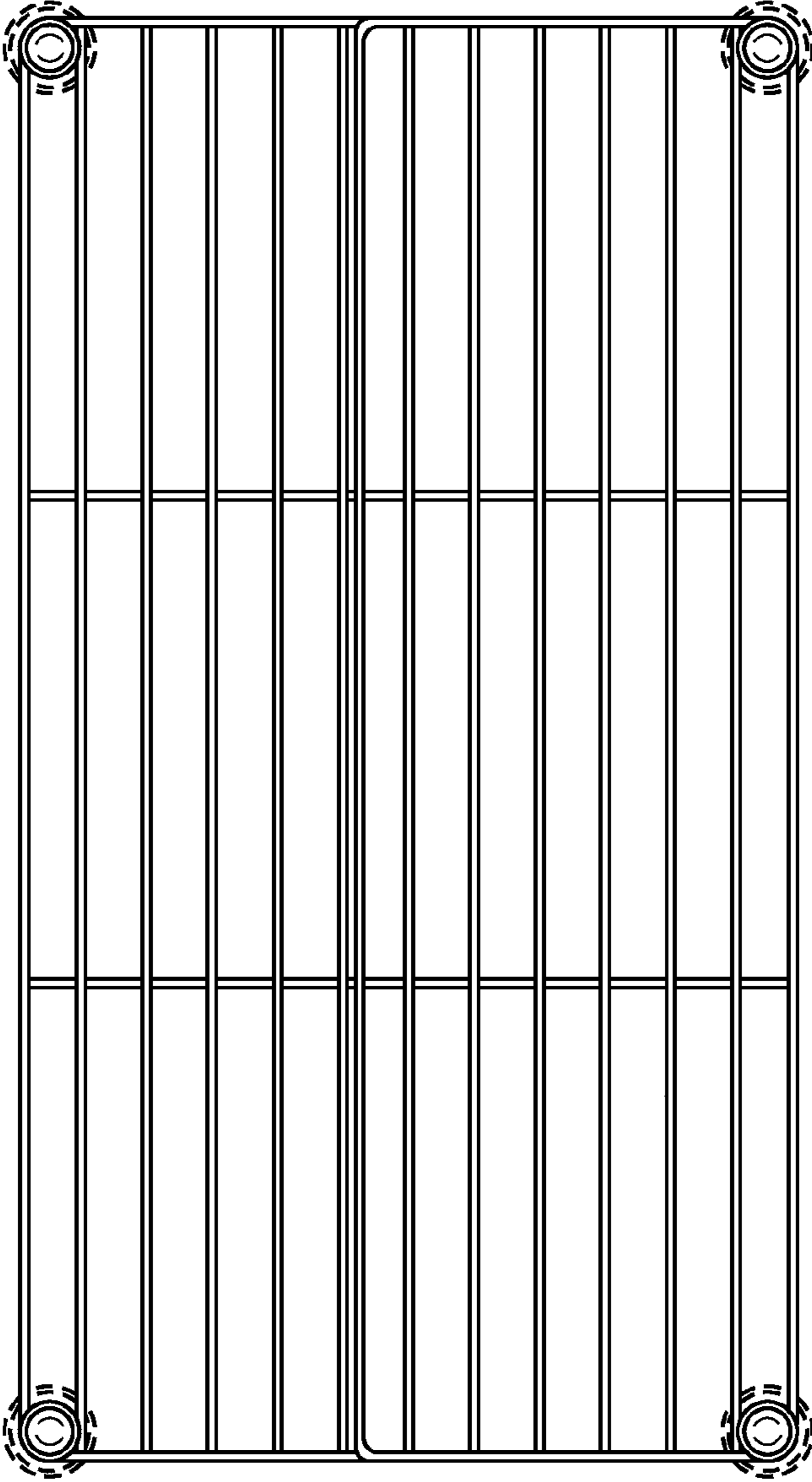

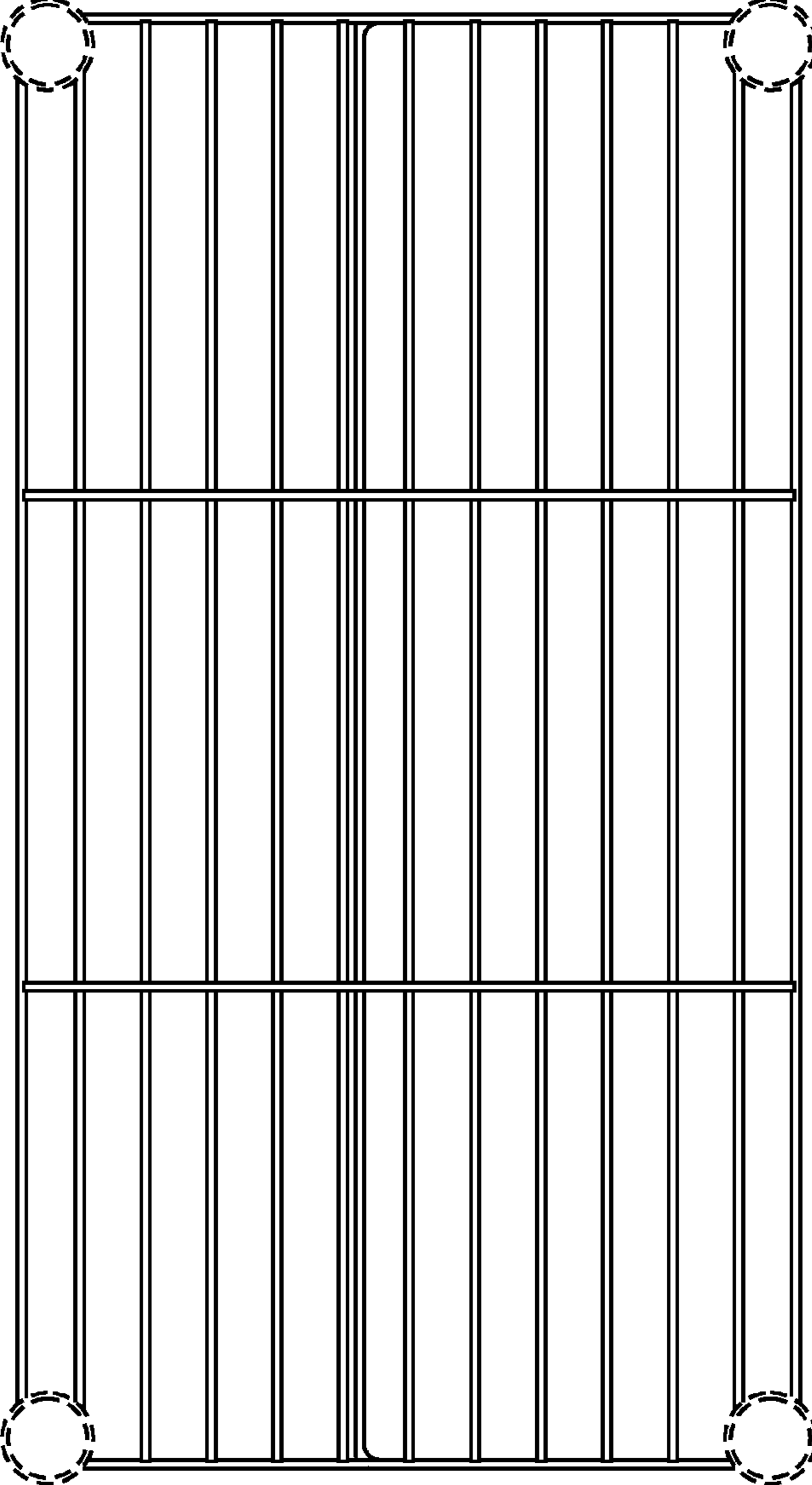

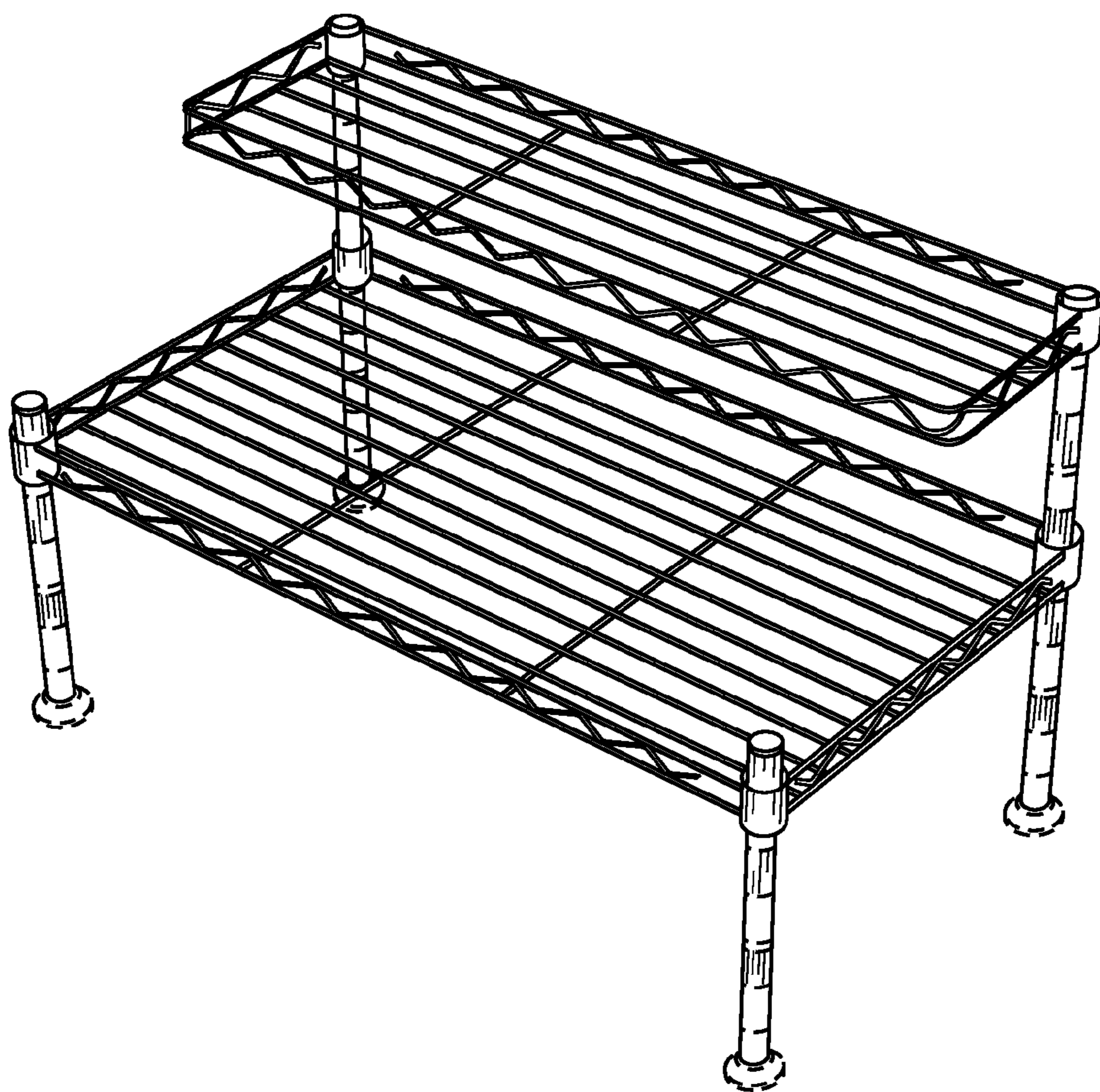

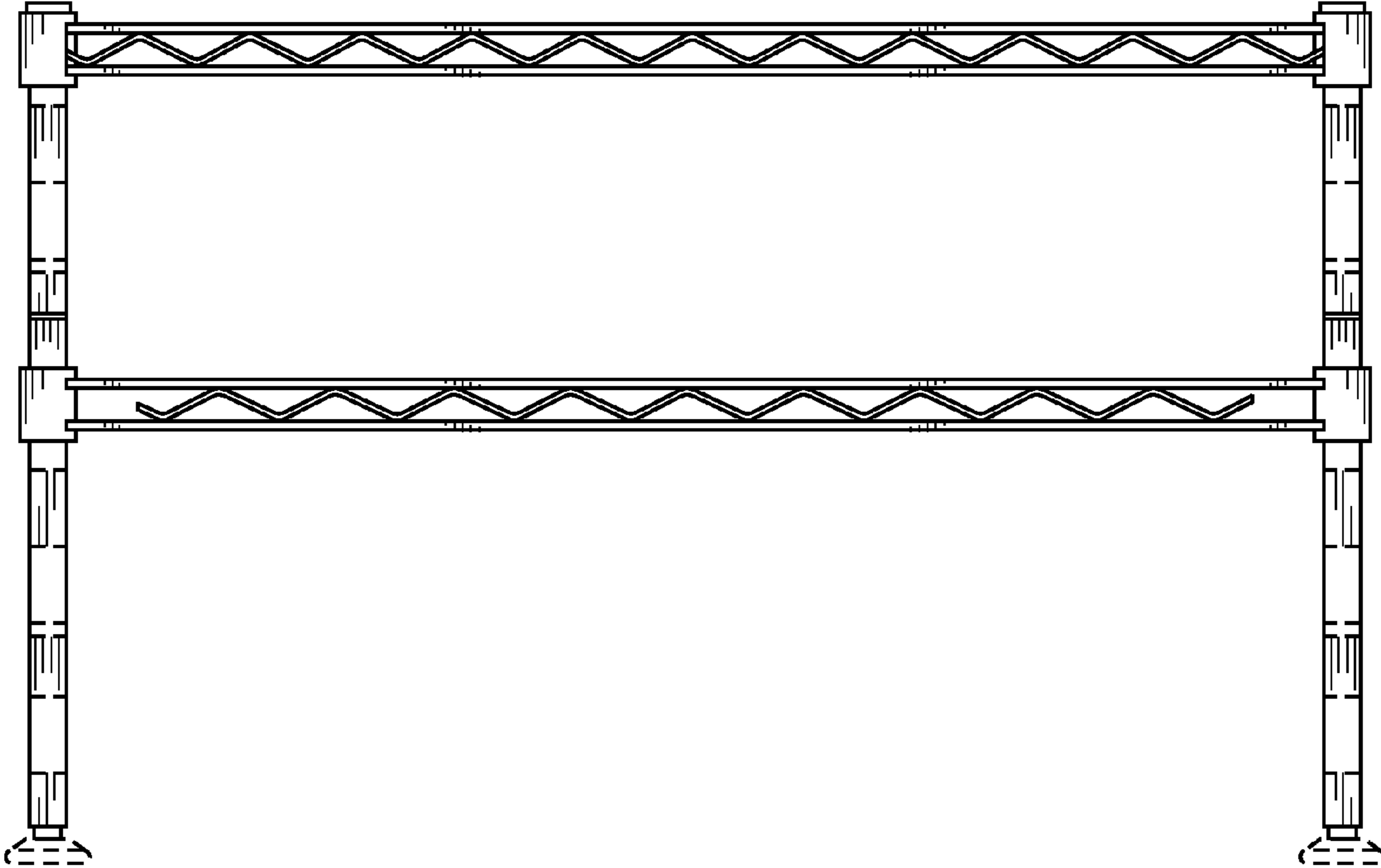

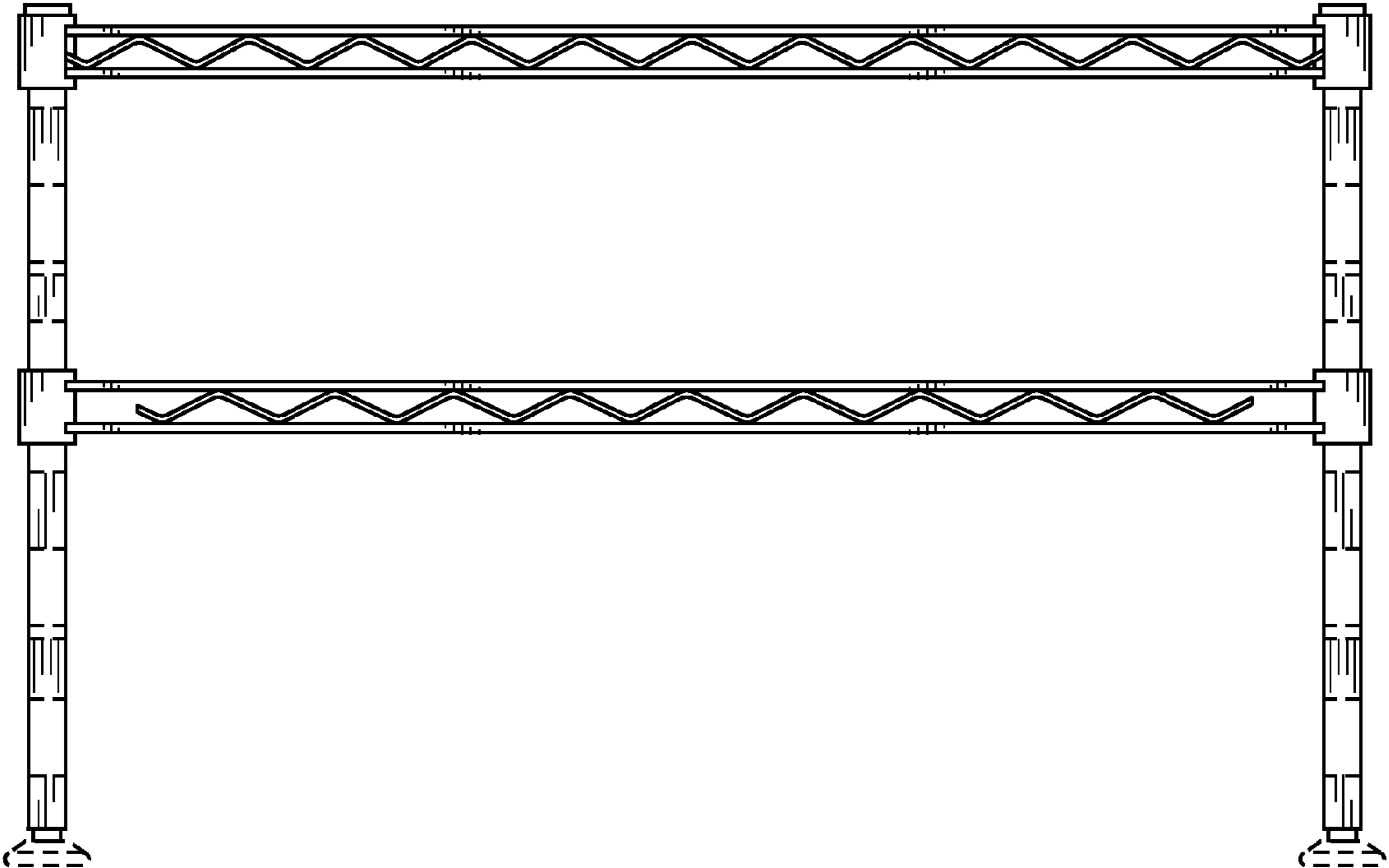

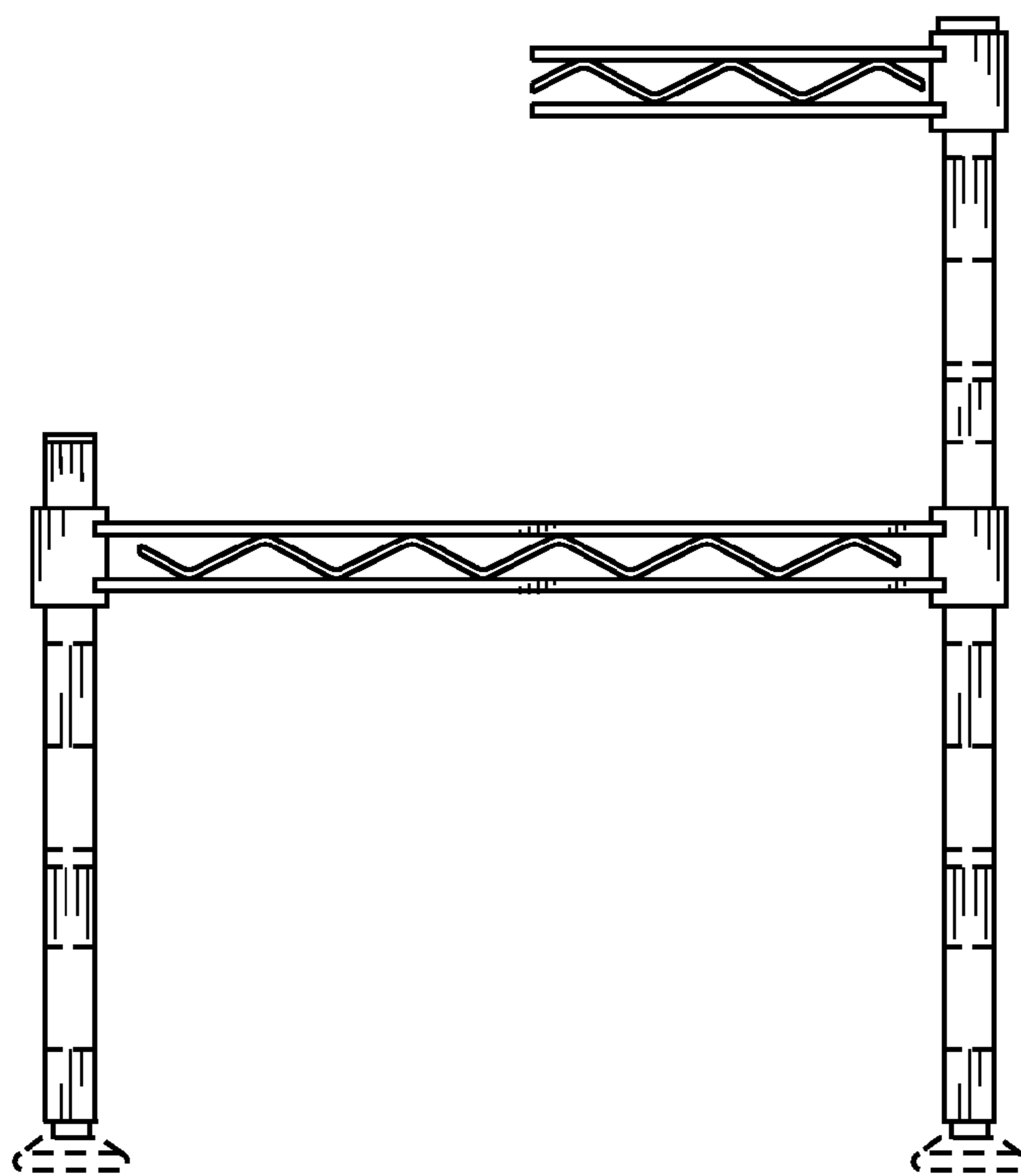

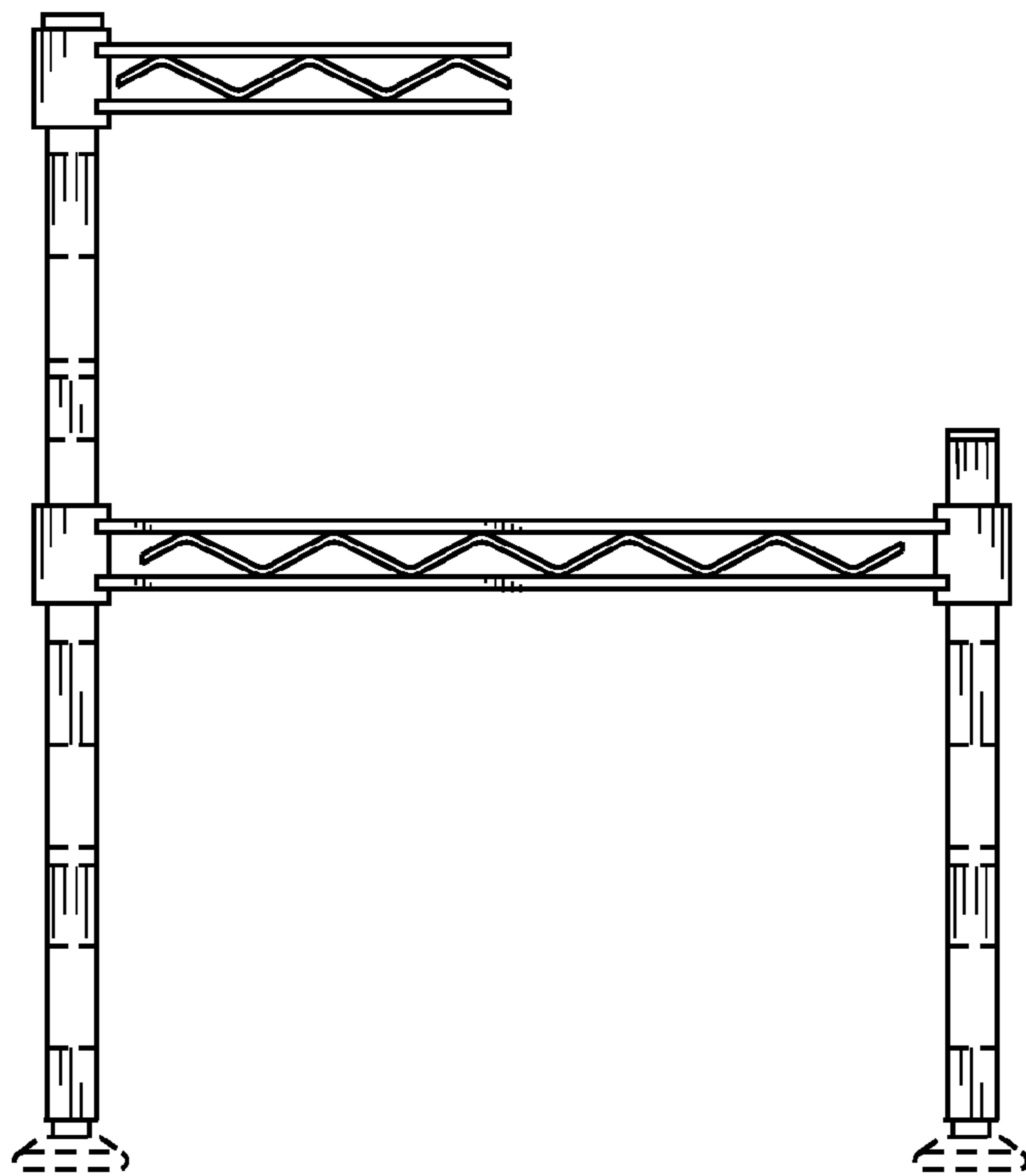

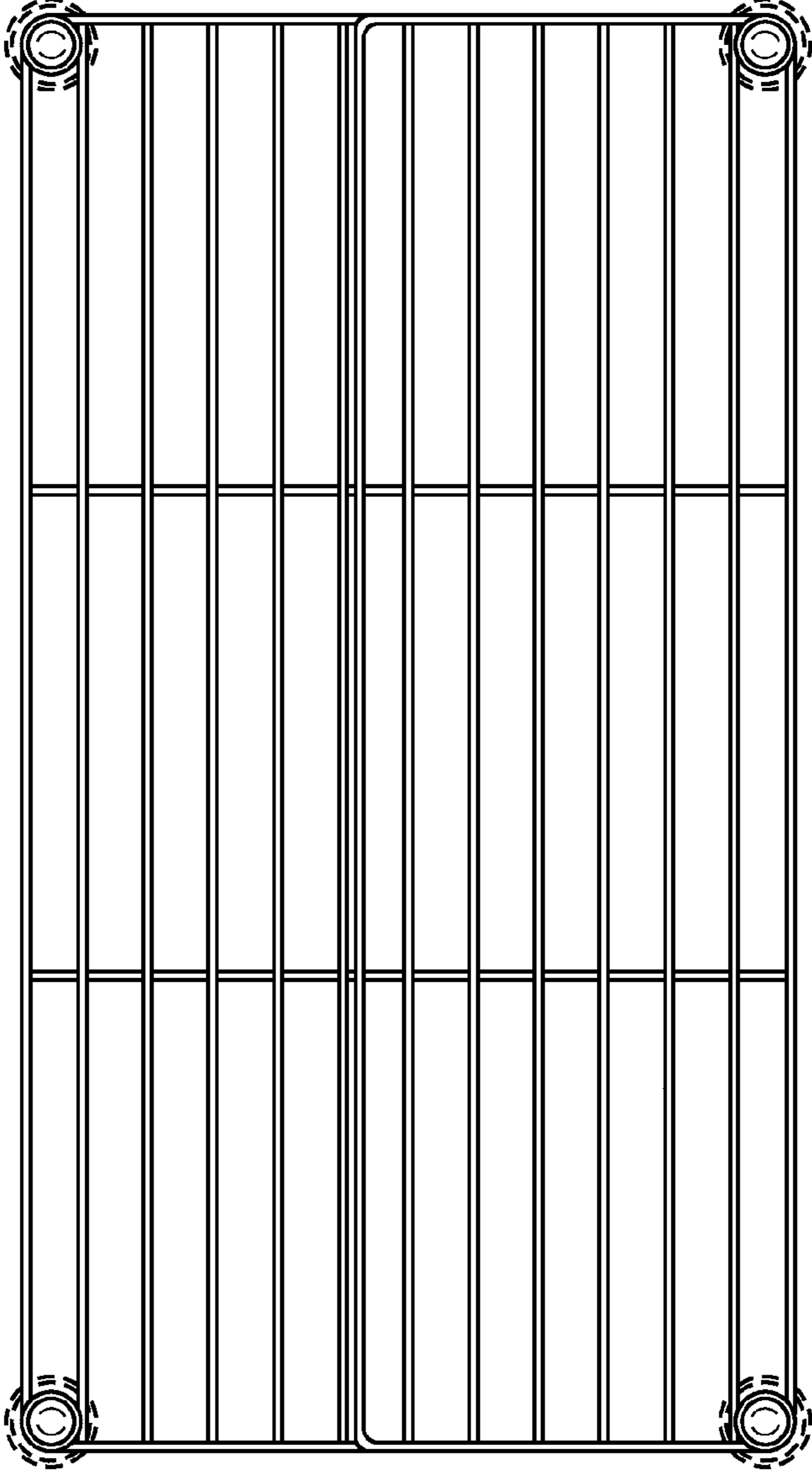

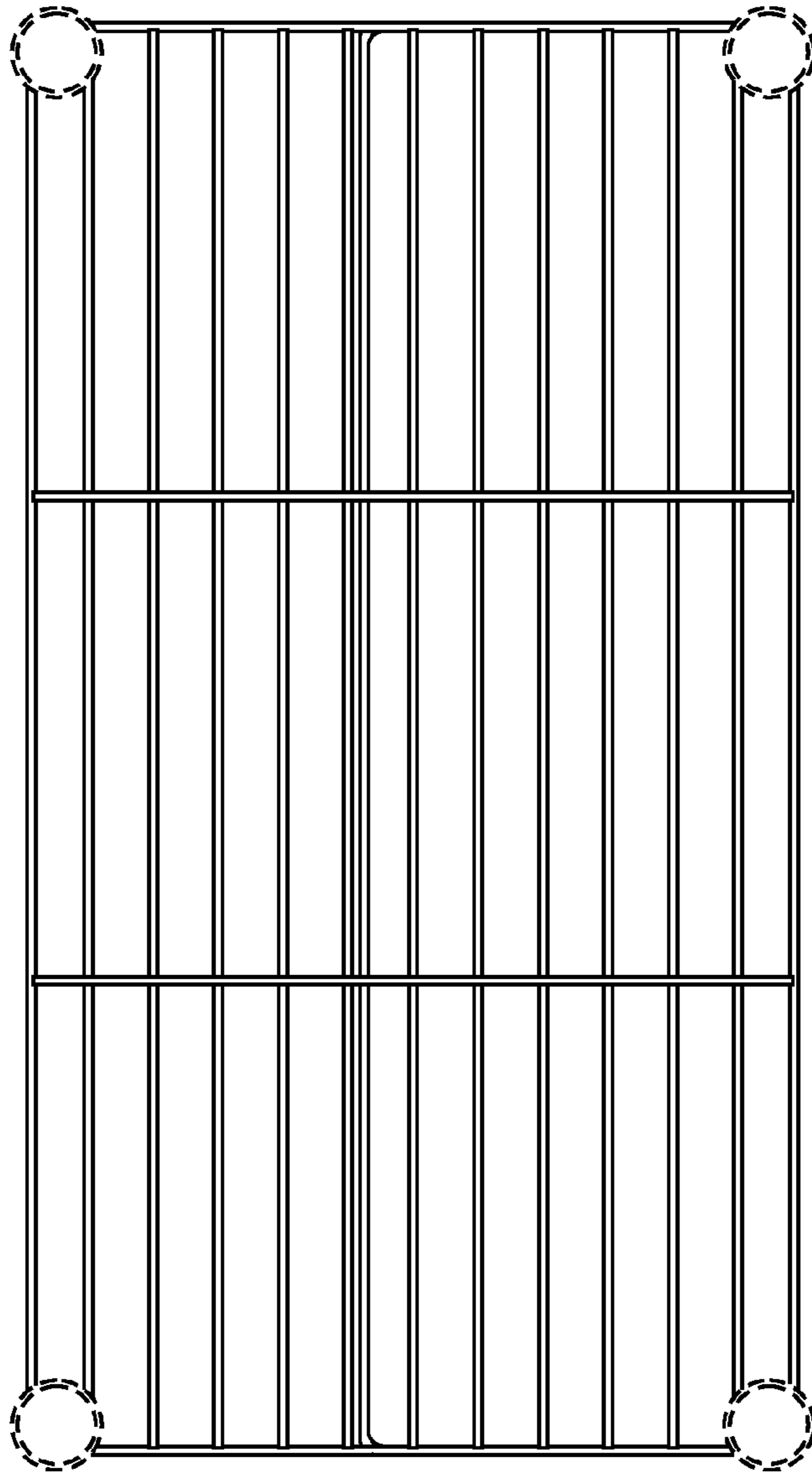
