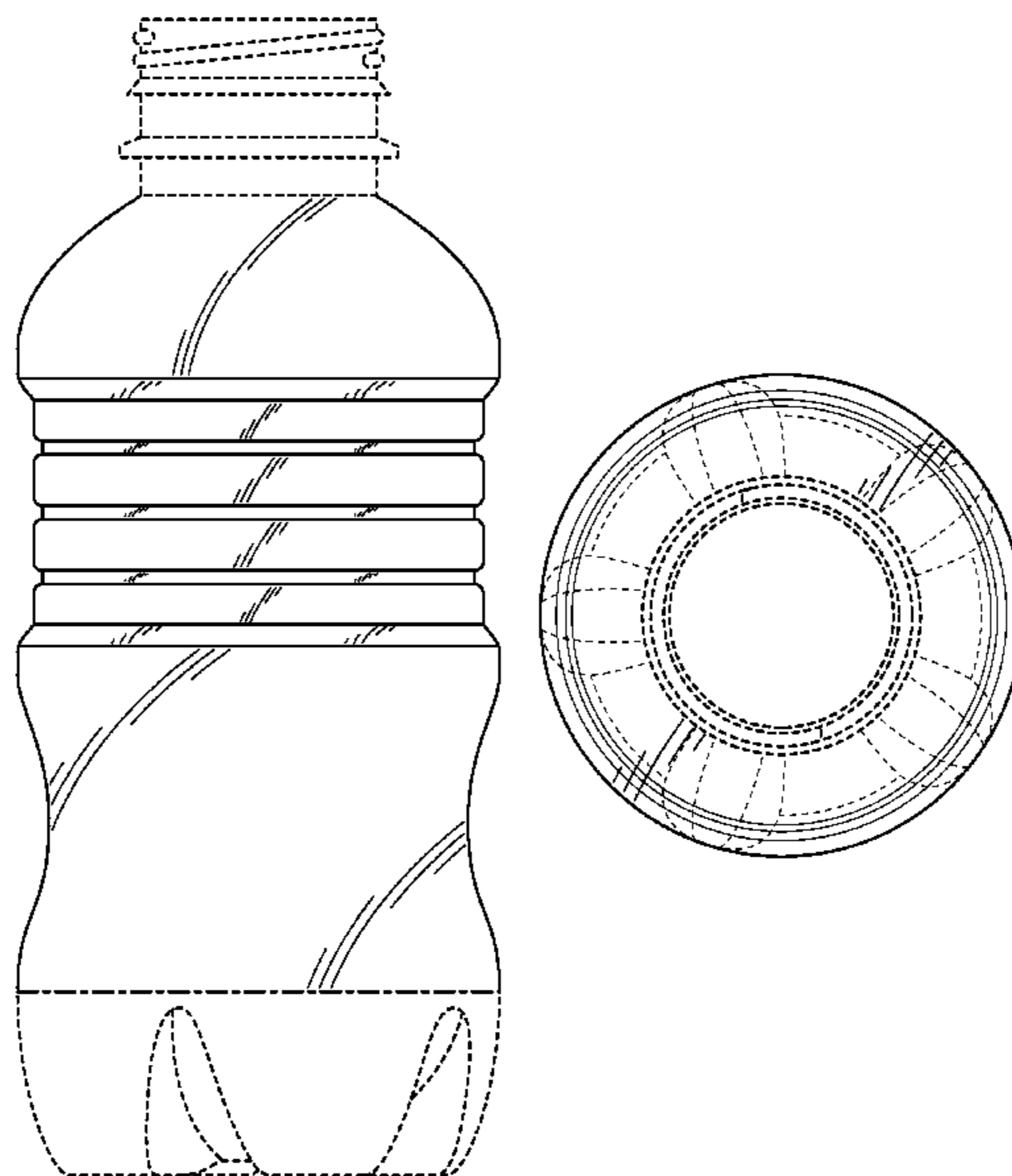
(57) **CLAIM**

The ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left perspective view of a container showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The evenly dashed broken lines in the drawings illustrate the portions of the design that form no part of the claim. The dot-dash broken lines in the drawings define the bounds of the claim and form no part thereof.

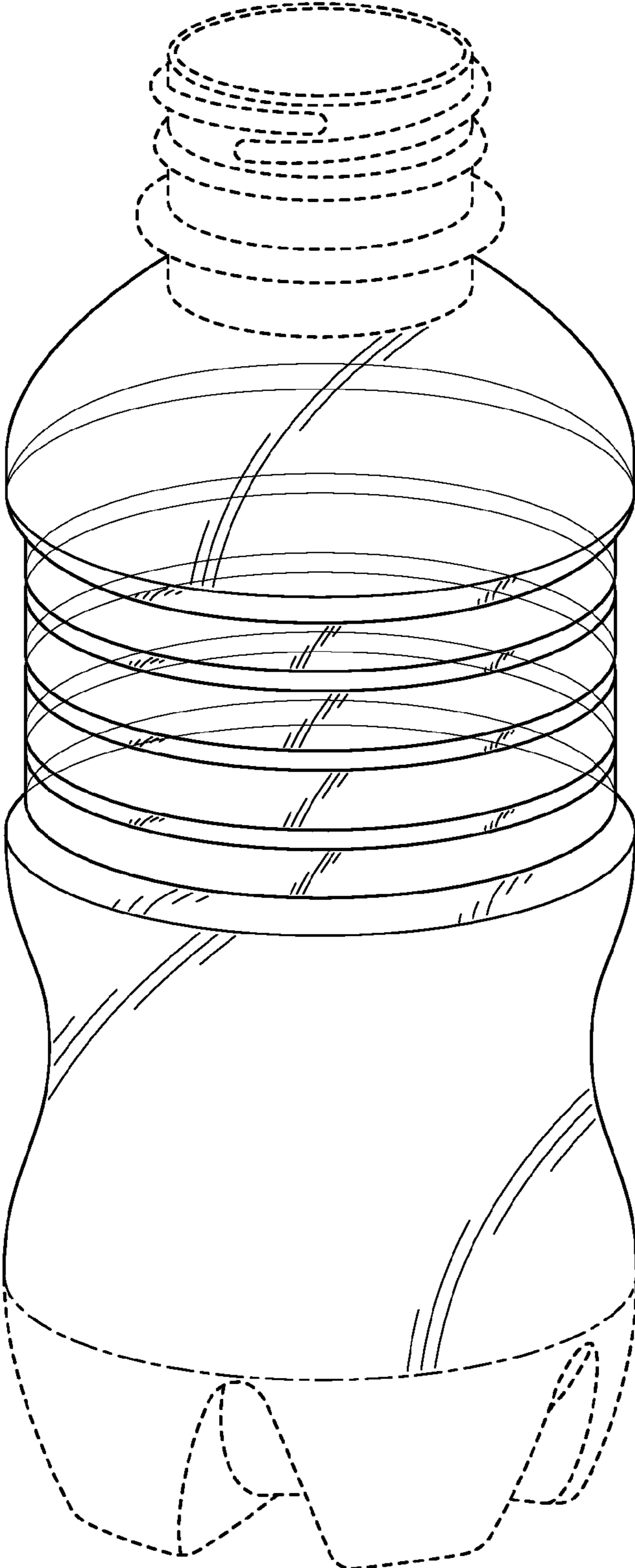

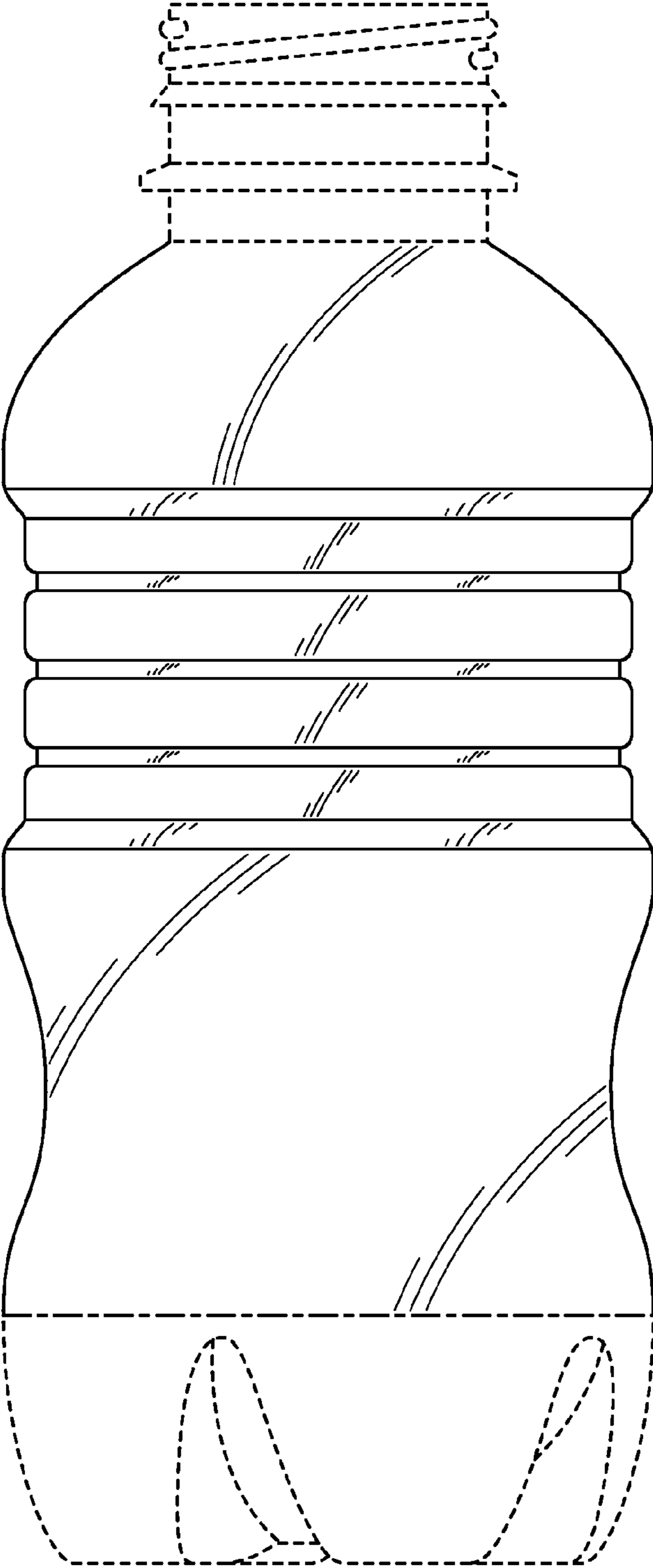

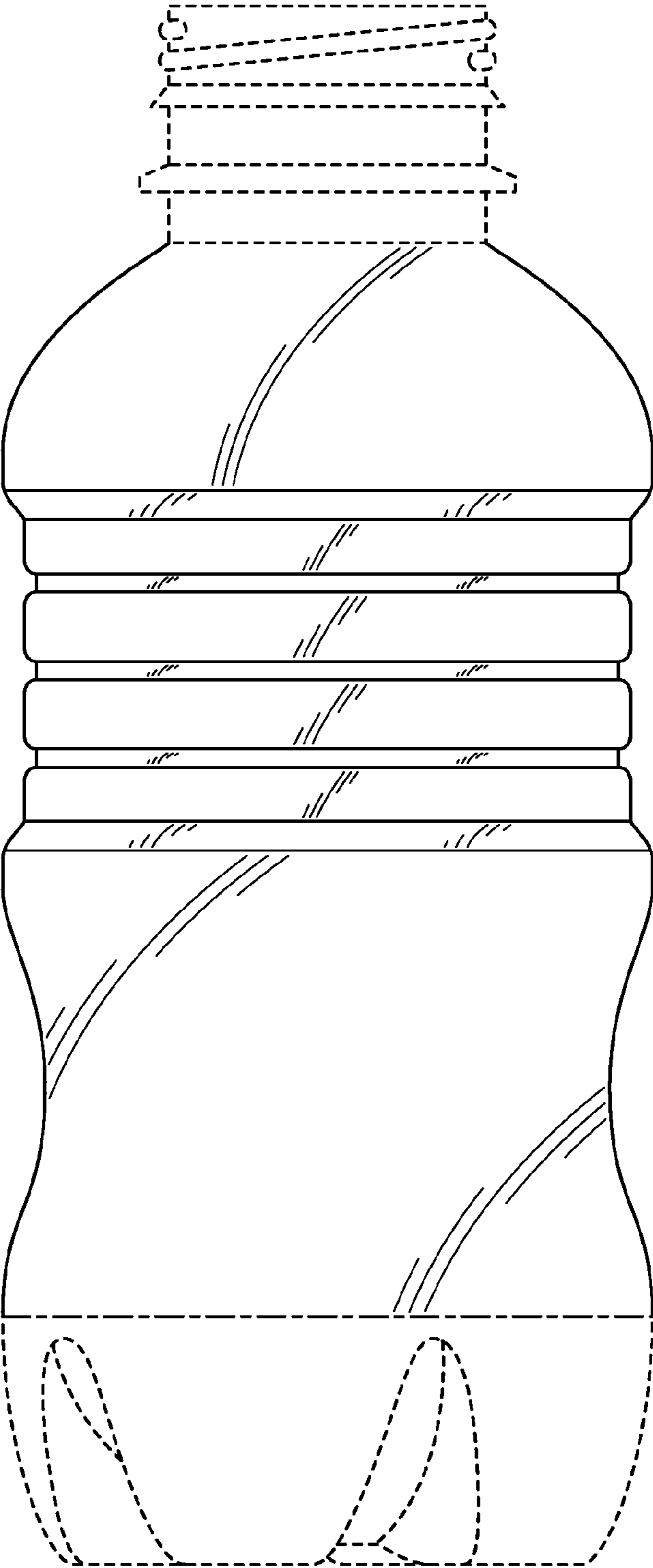

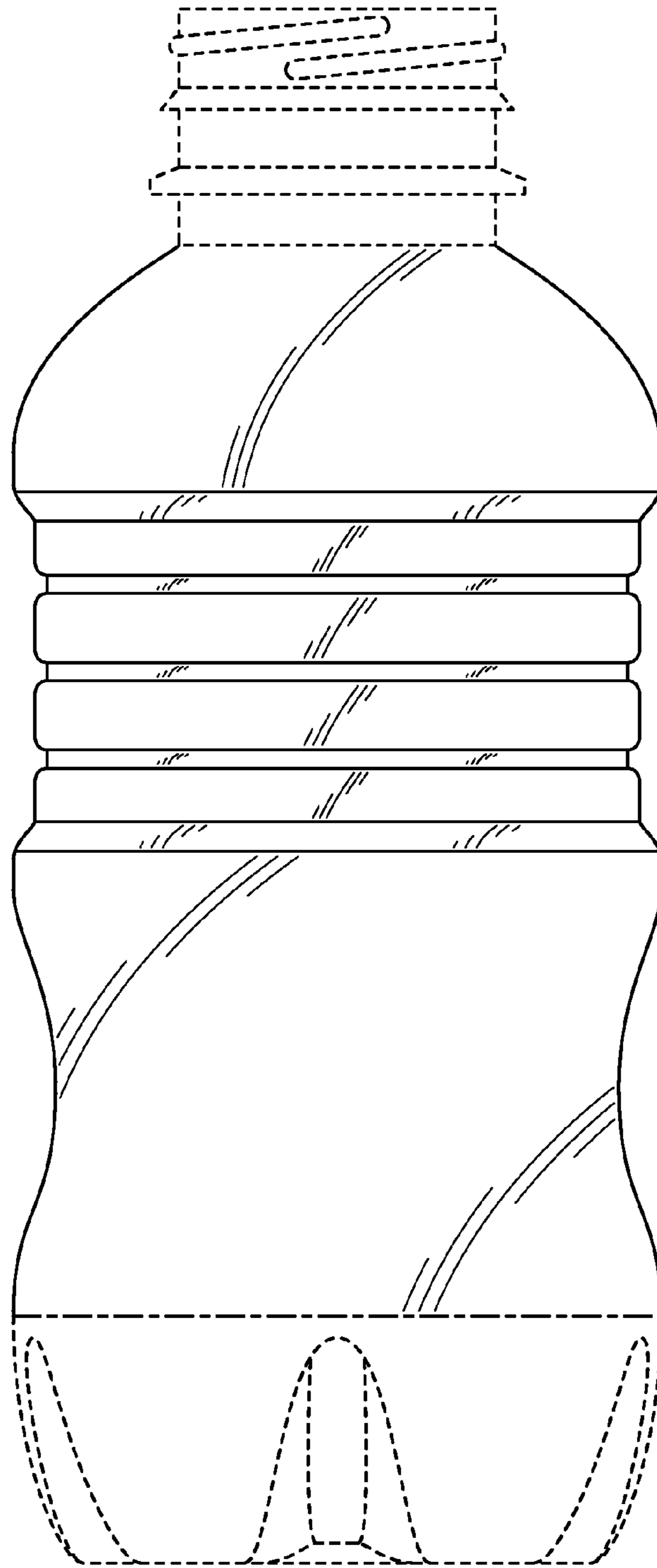

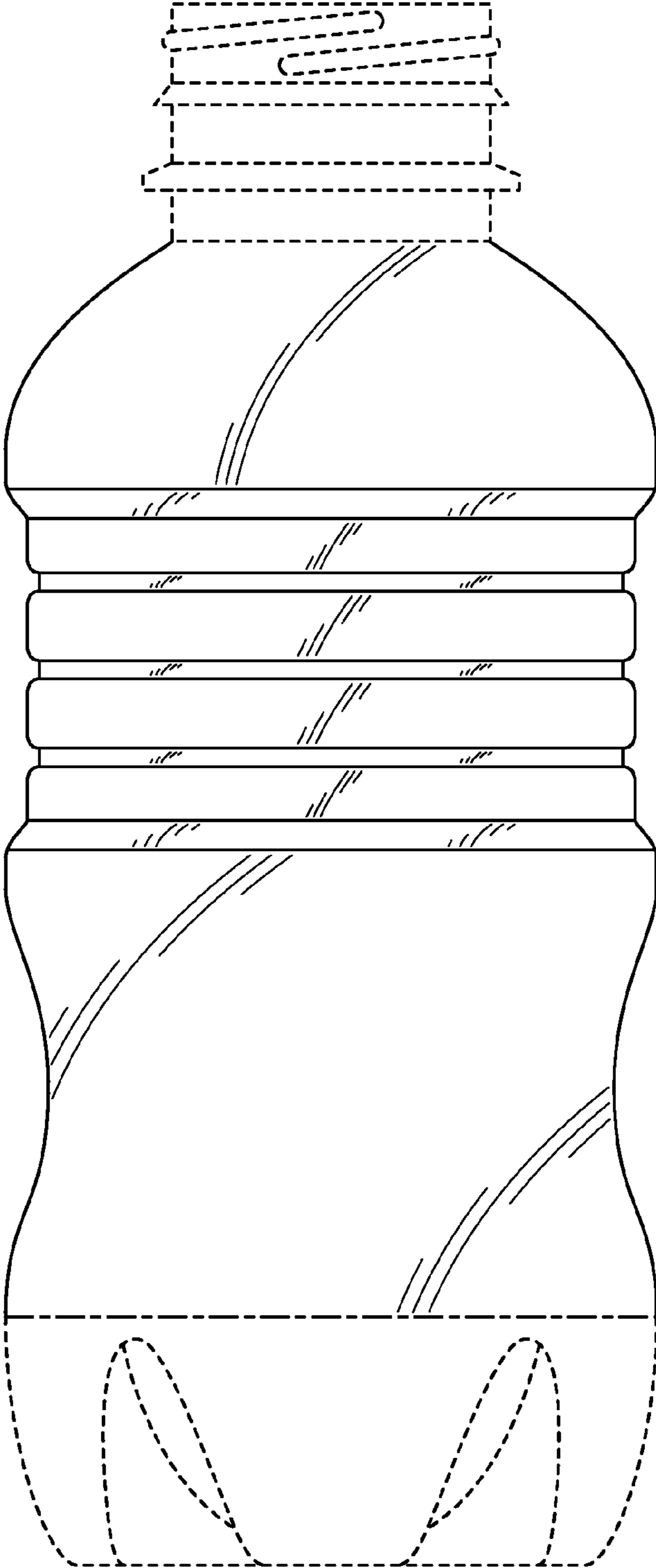

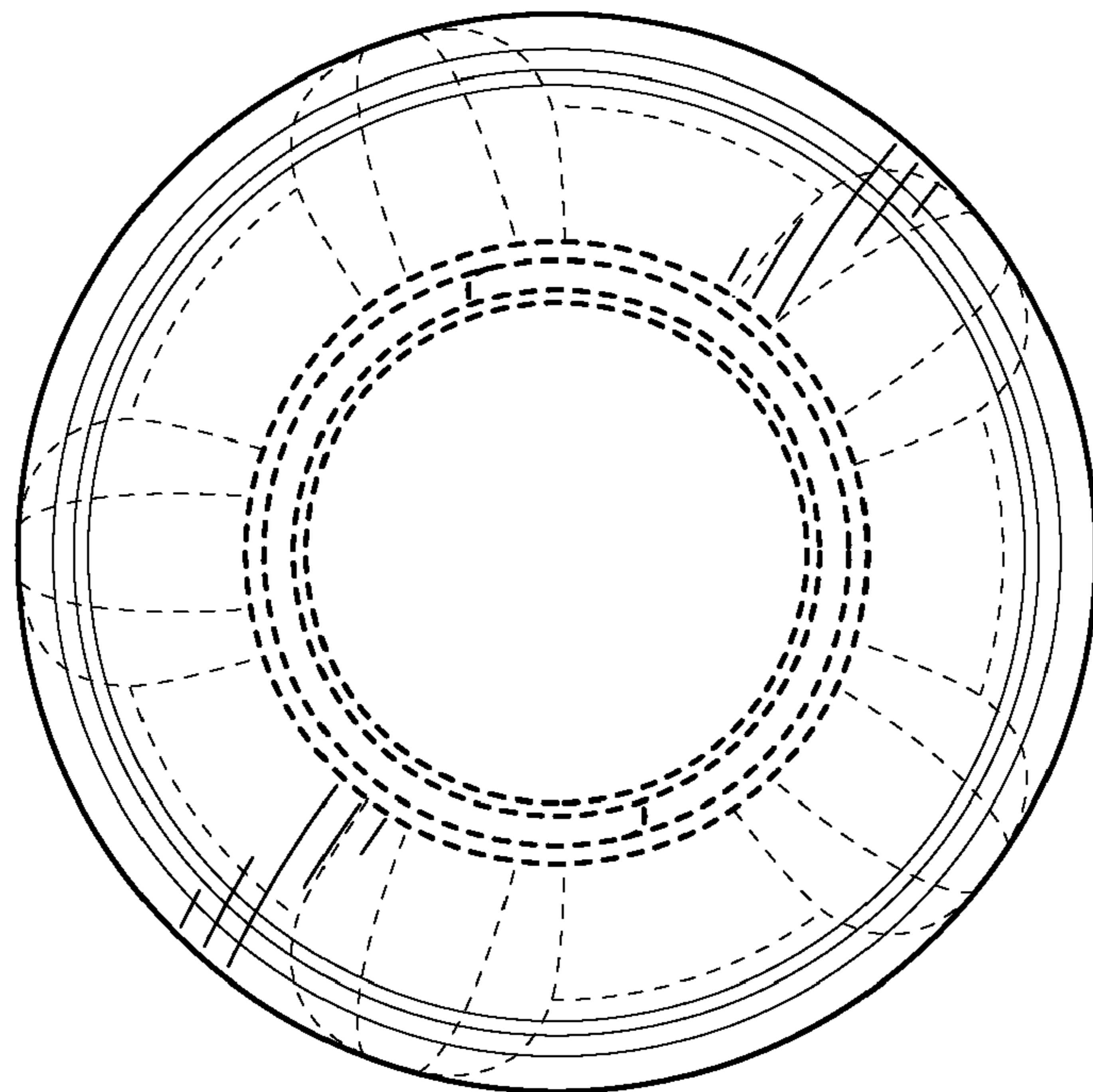

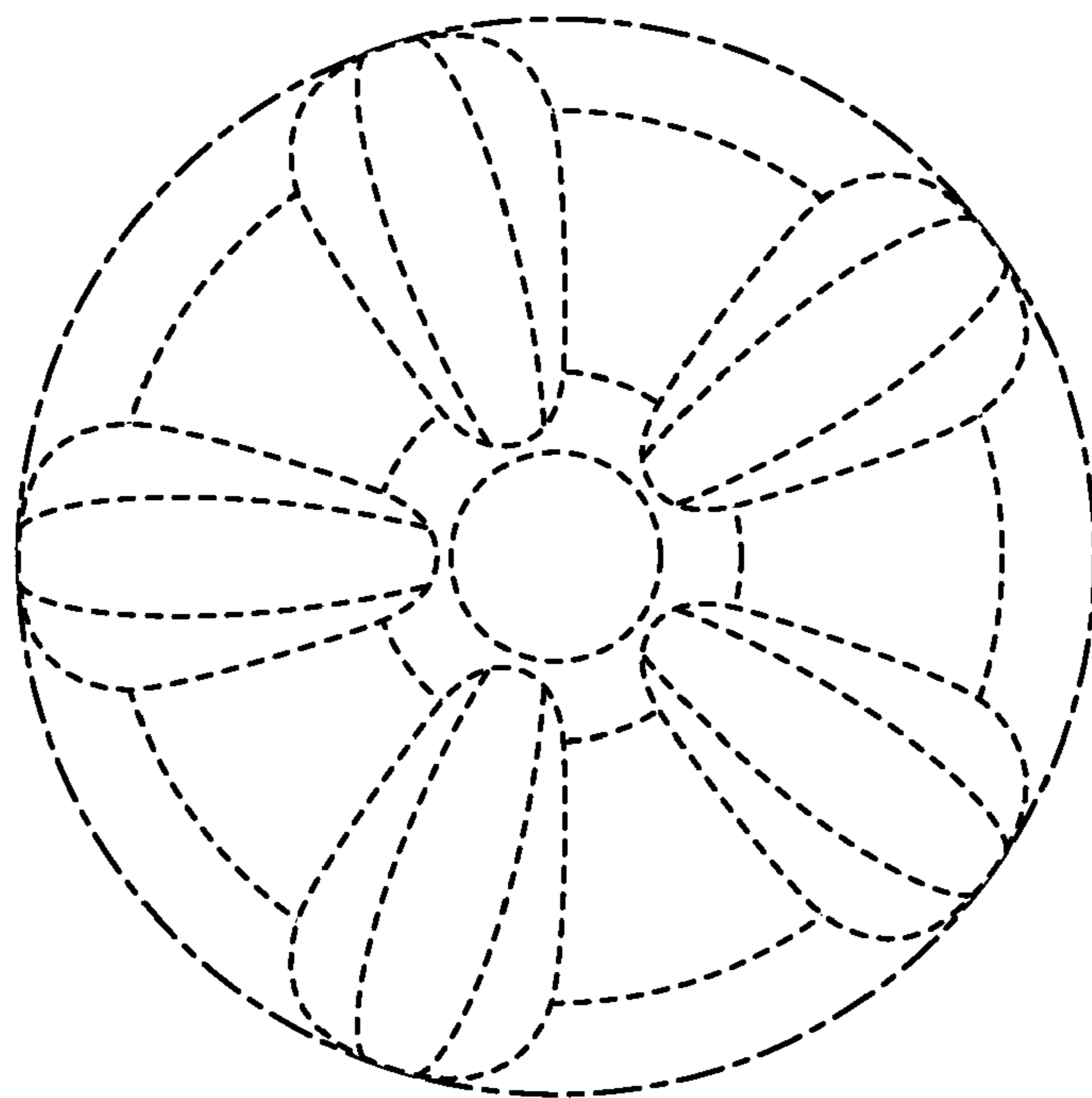
