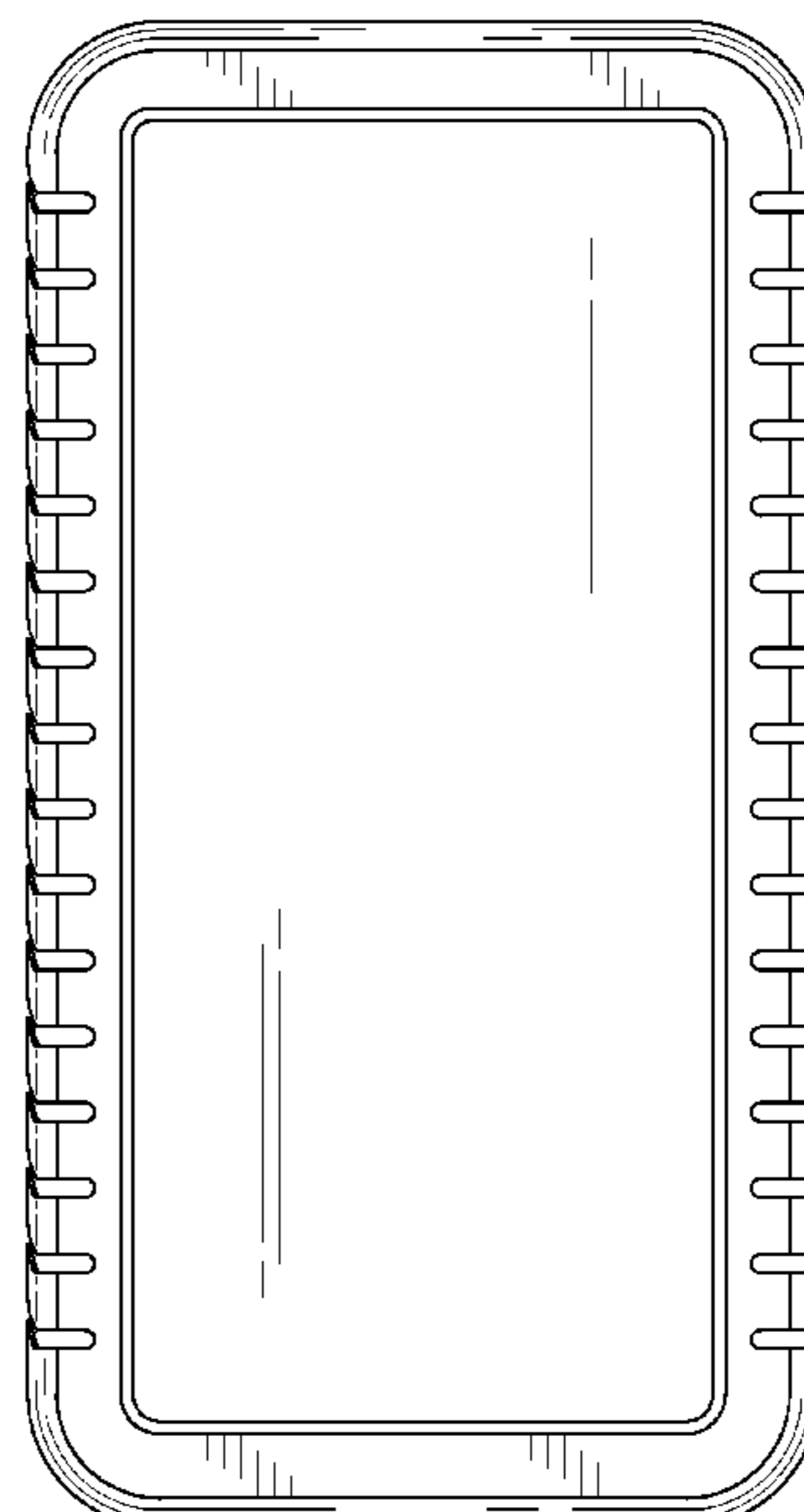
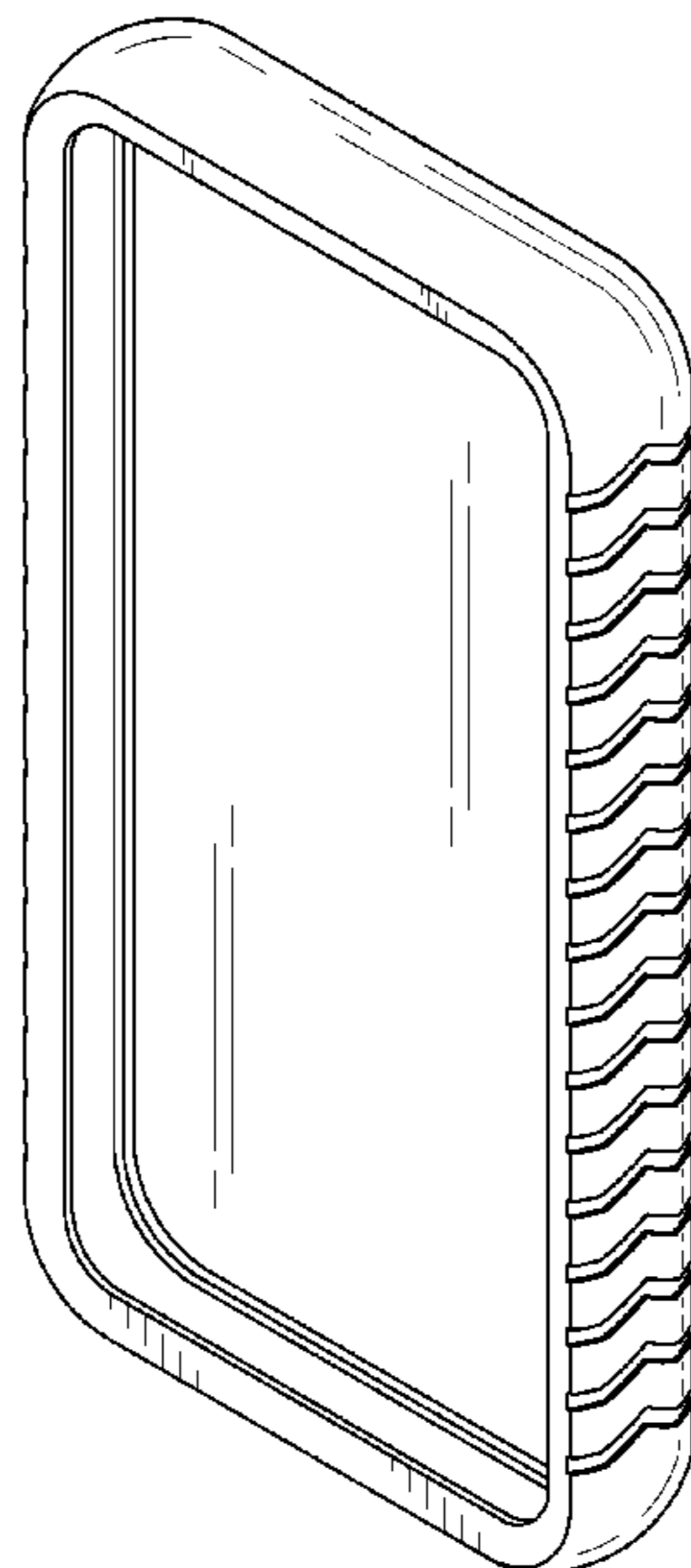
(57) **CLAIM**

The ornamental design for a mobile phone protective cover, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a mobile phone protective cover showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a rear perspective view thereof; and, FIG. 9 is a cross-section view of FIG. 8 thereof.

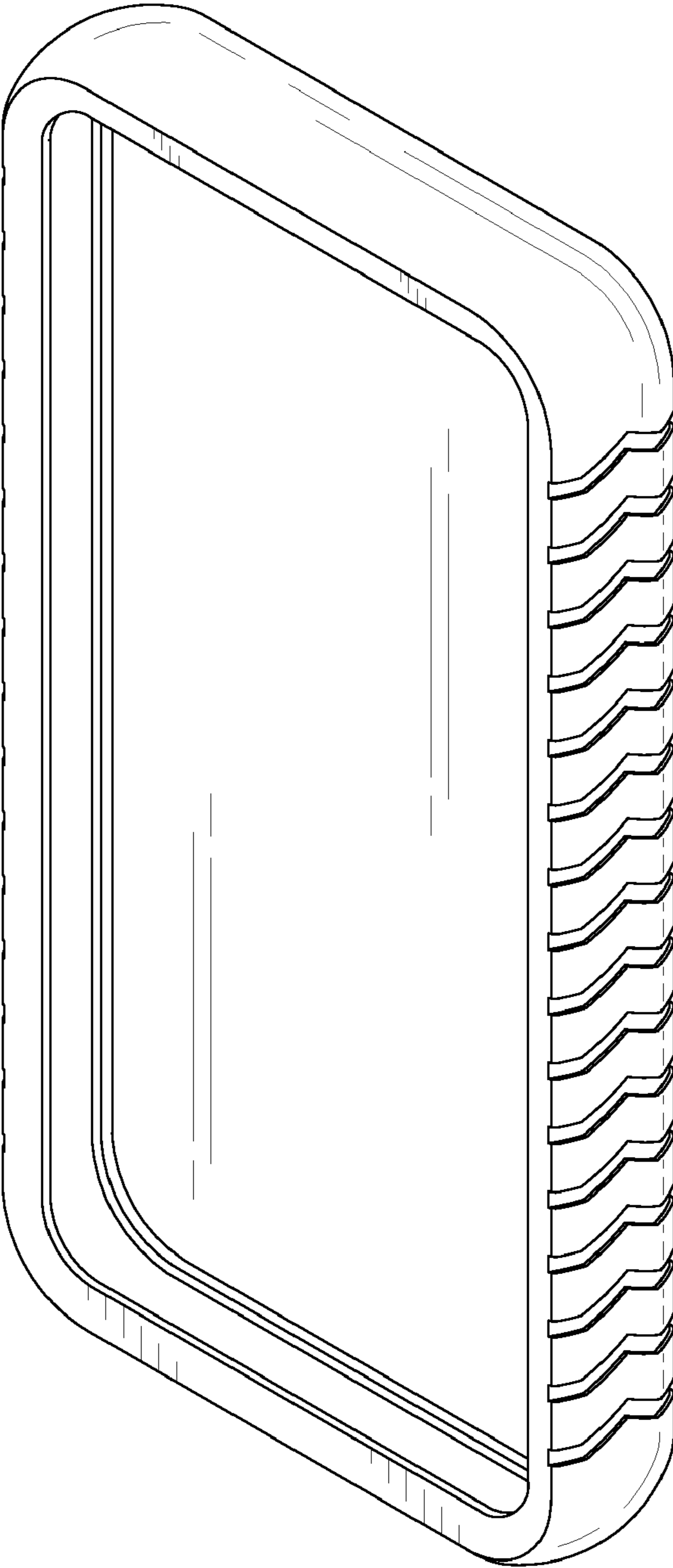

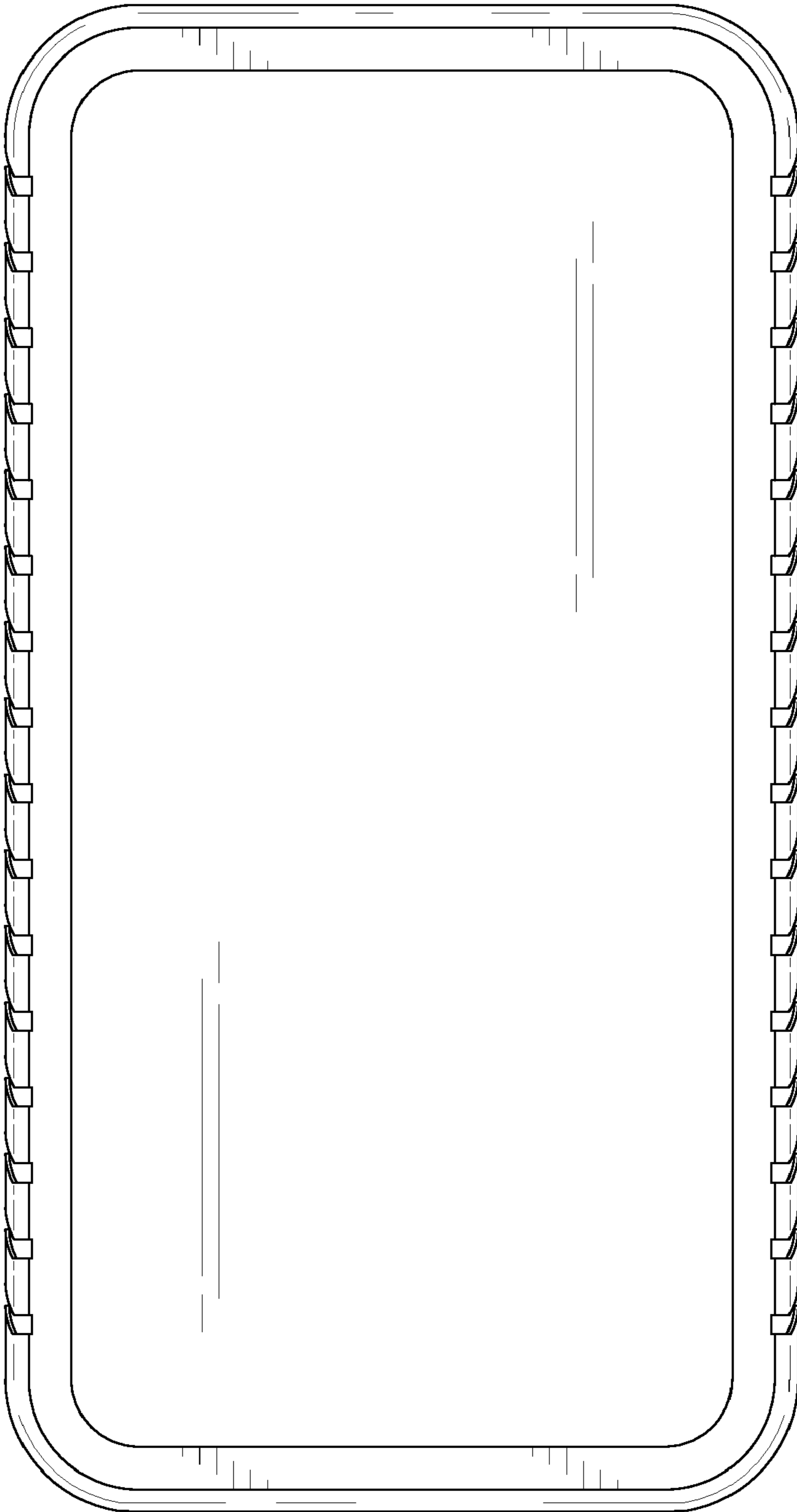

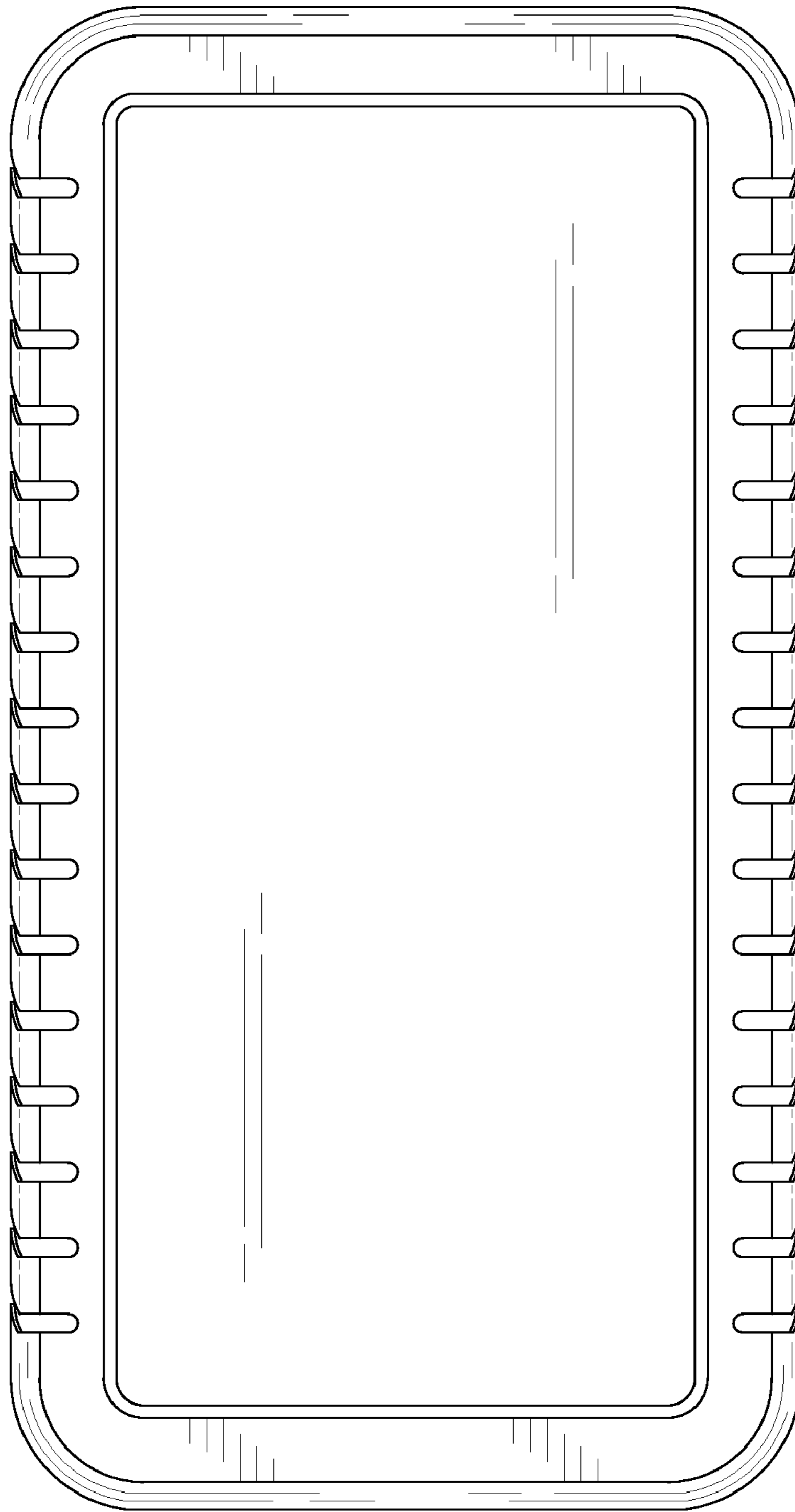

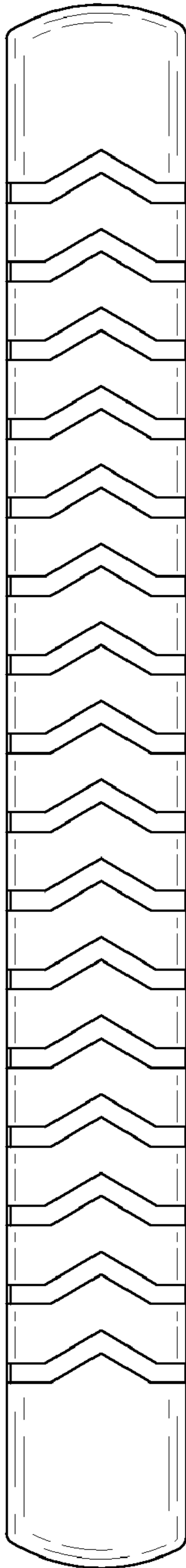

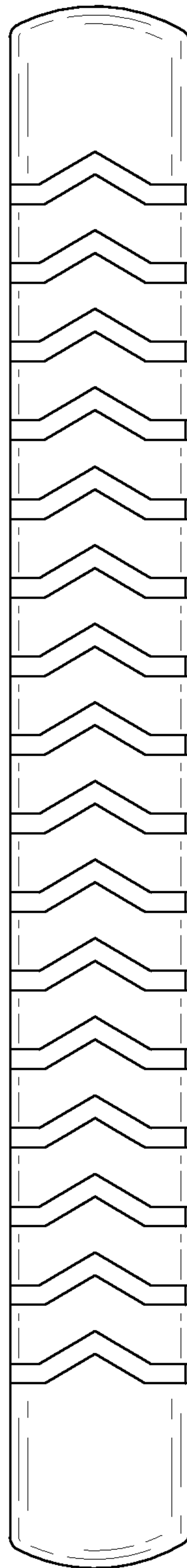

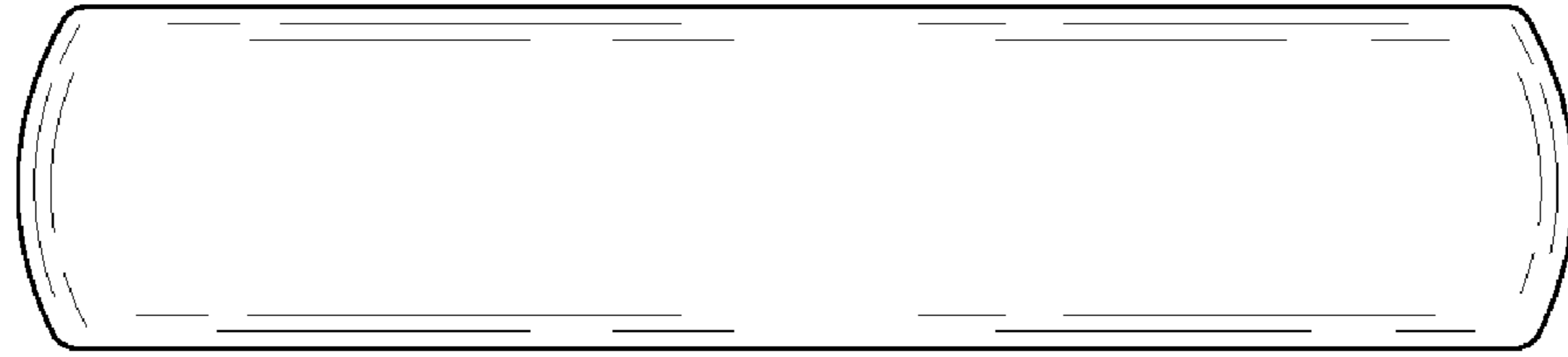

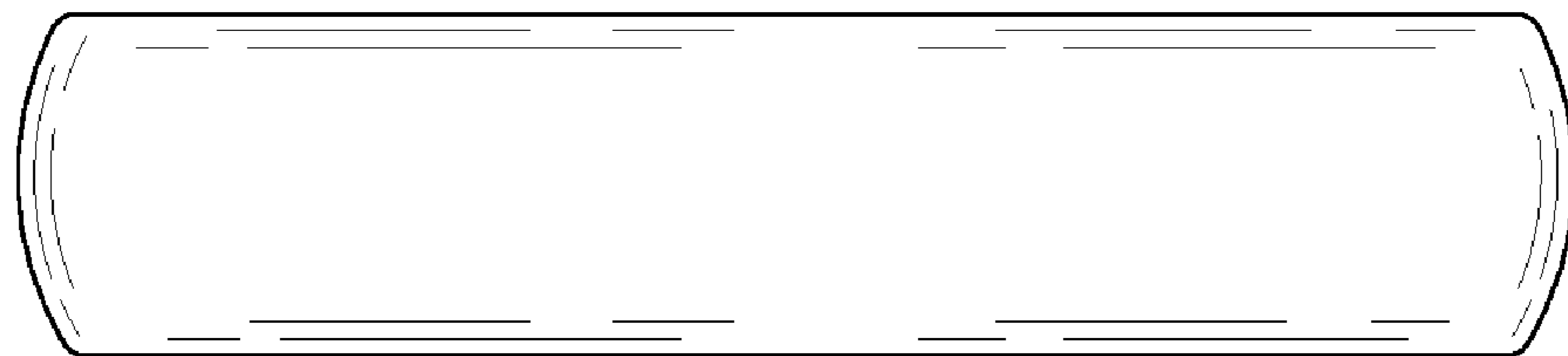

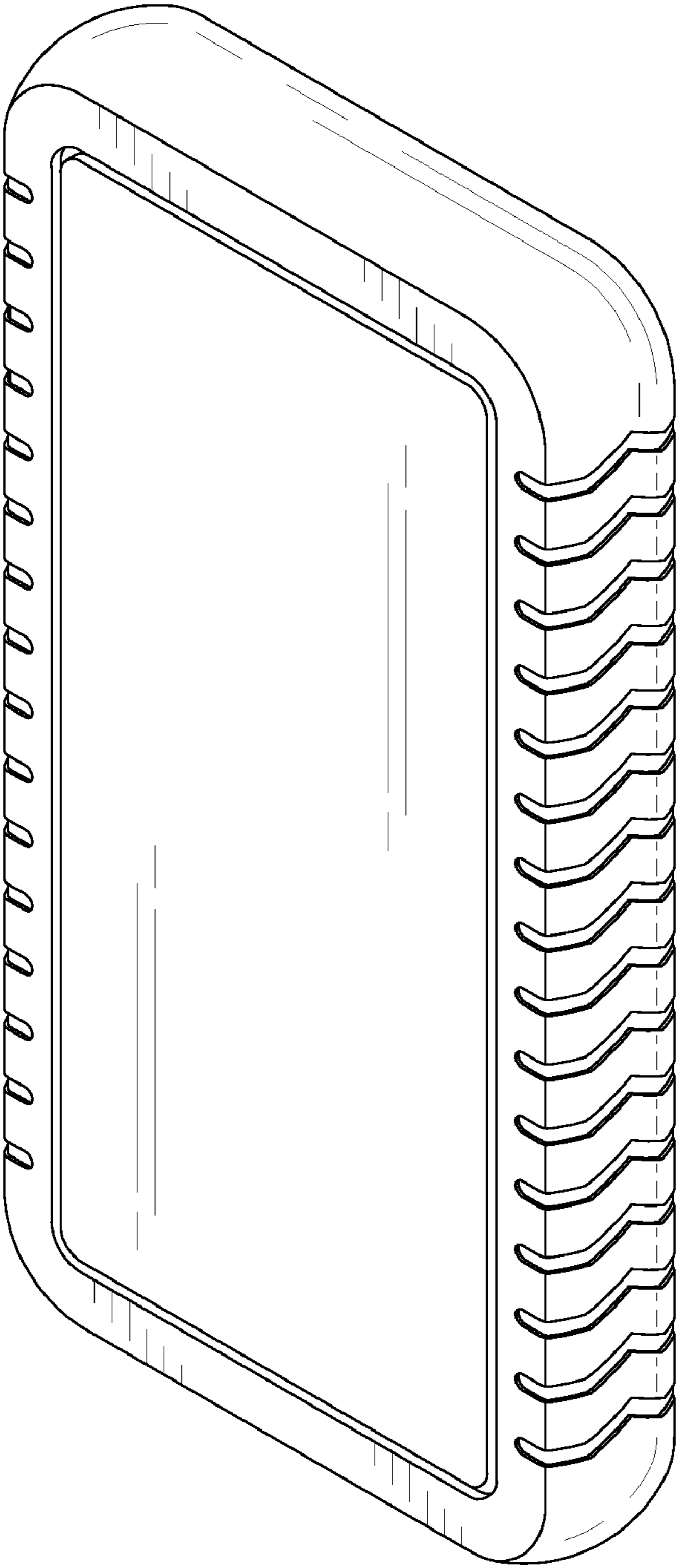

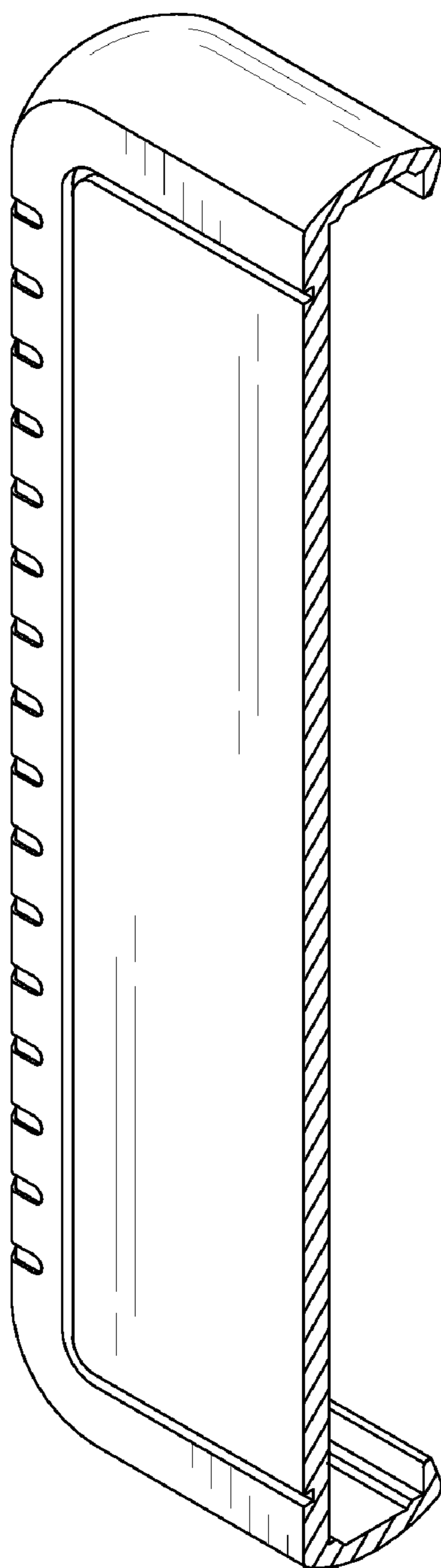
