(57) **CLAIM**

The ornamental design of a toolbar for a user interface for a display screen, as shown and described.

**DESCRIPTION**

The FIGURE is a front view of a toolbar for a user interface for a display screen showing our new design.

The outer rectangular broken line illustrates the unclaimed display screen and is included for the purpose of illustrating unclaimed environment and forms no part of the claimed design. The broken line text on the claimed design is included for the purpose of illustrating unclaimed portions of the toolbar for a user interface on a display screen and forms no part of the claimed design.
