FIG. 9 is a front view of the fourth image thereof; and,

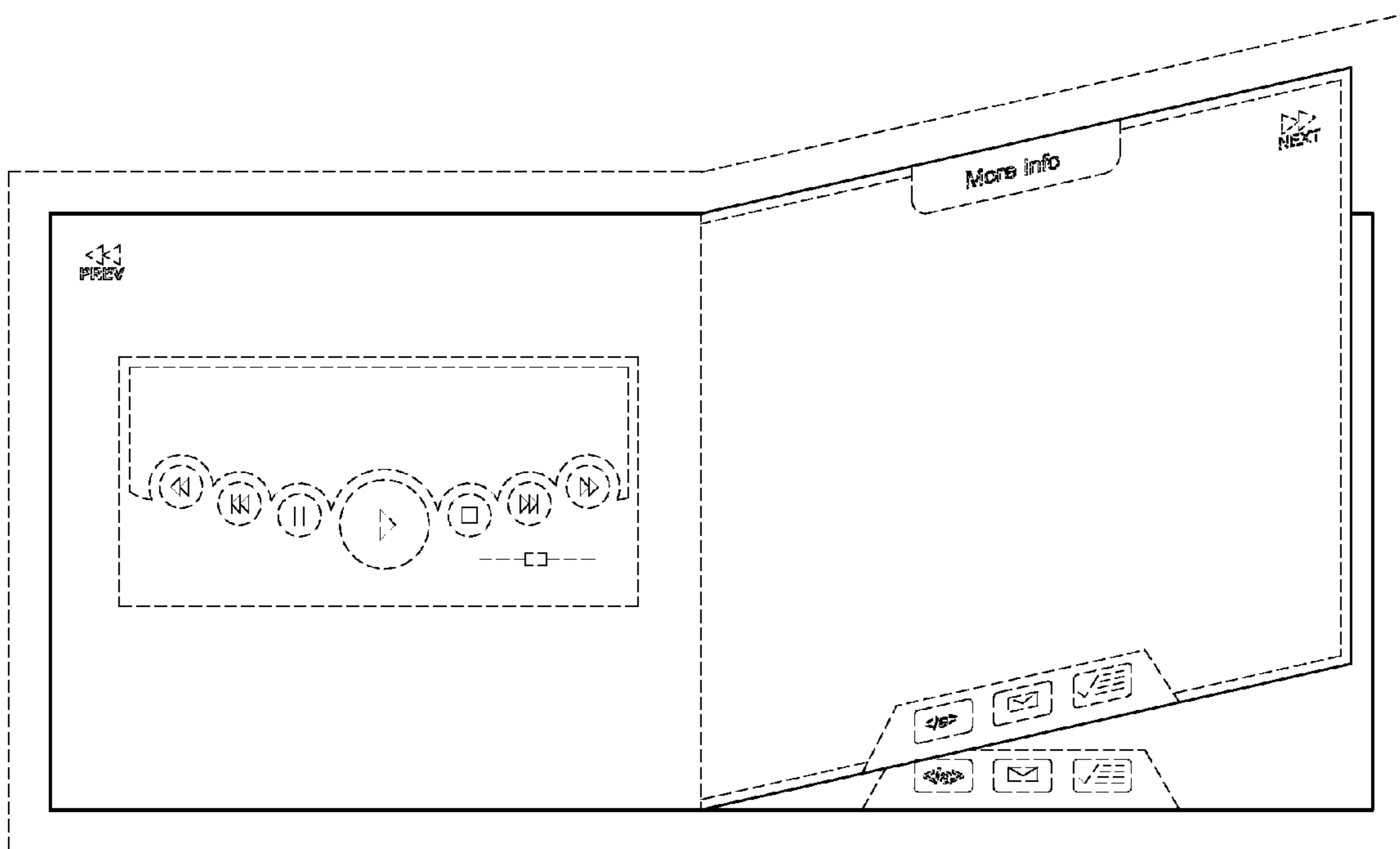
FIG. 10 is a front view of the fifth image thereof.

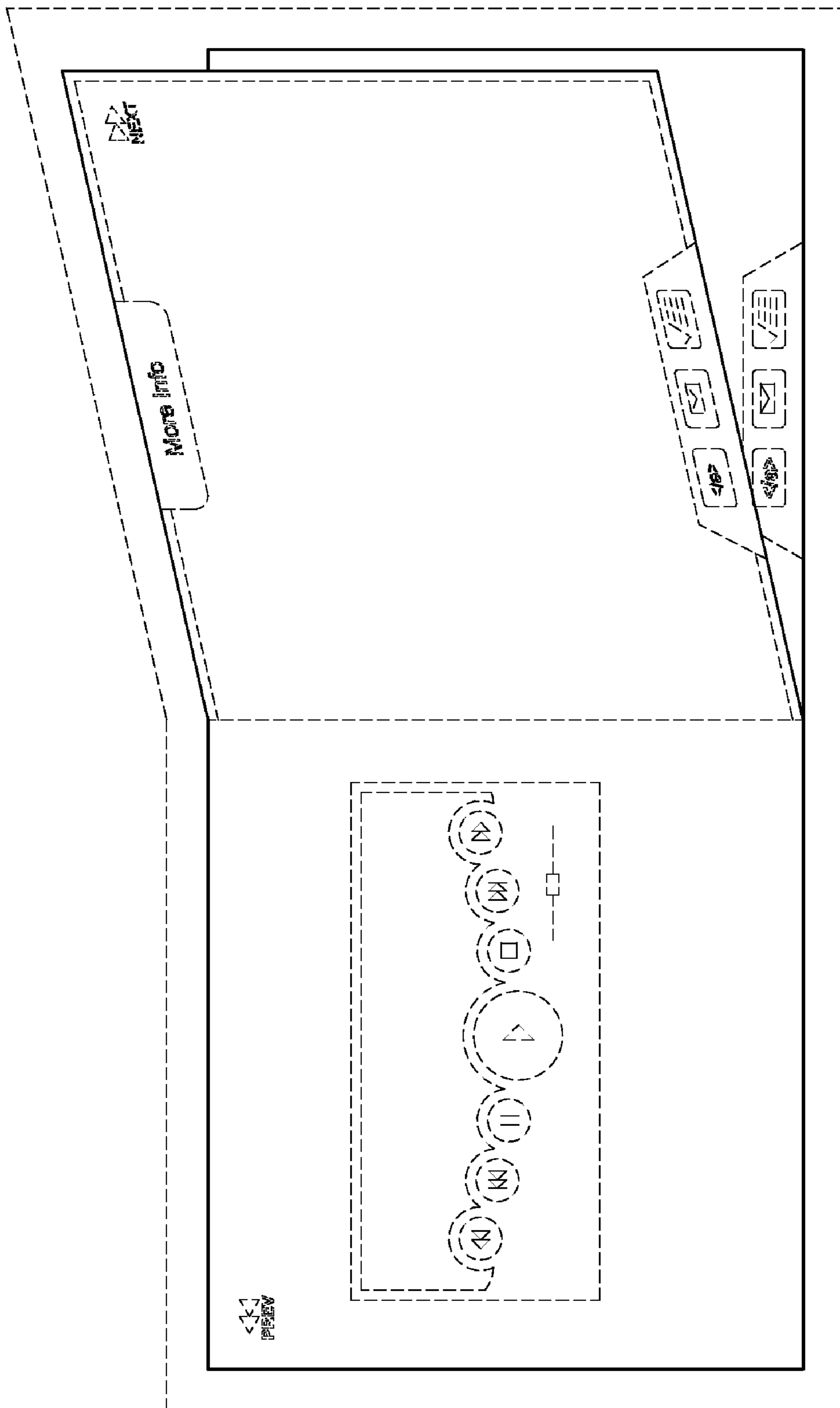

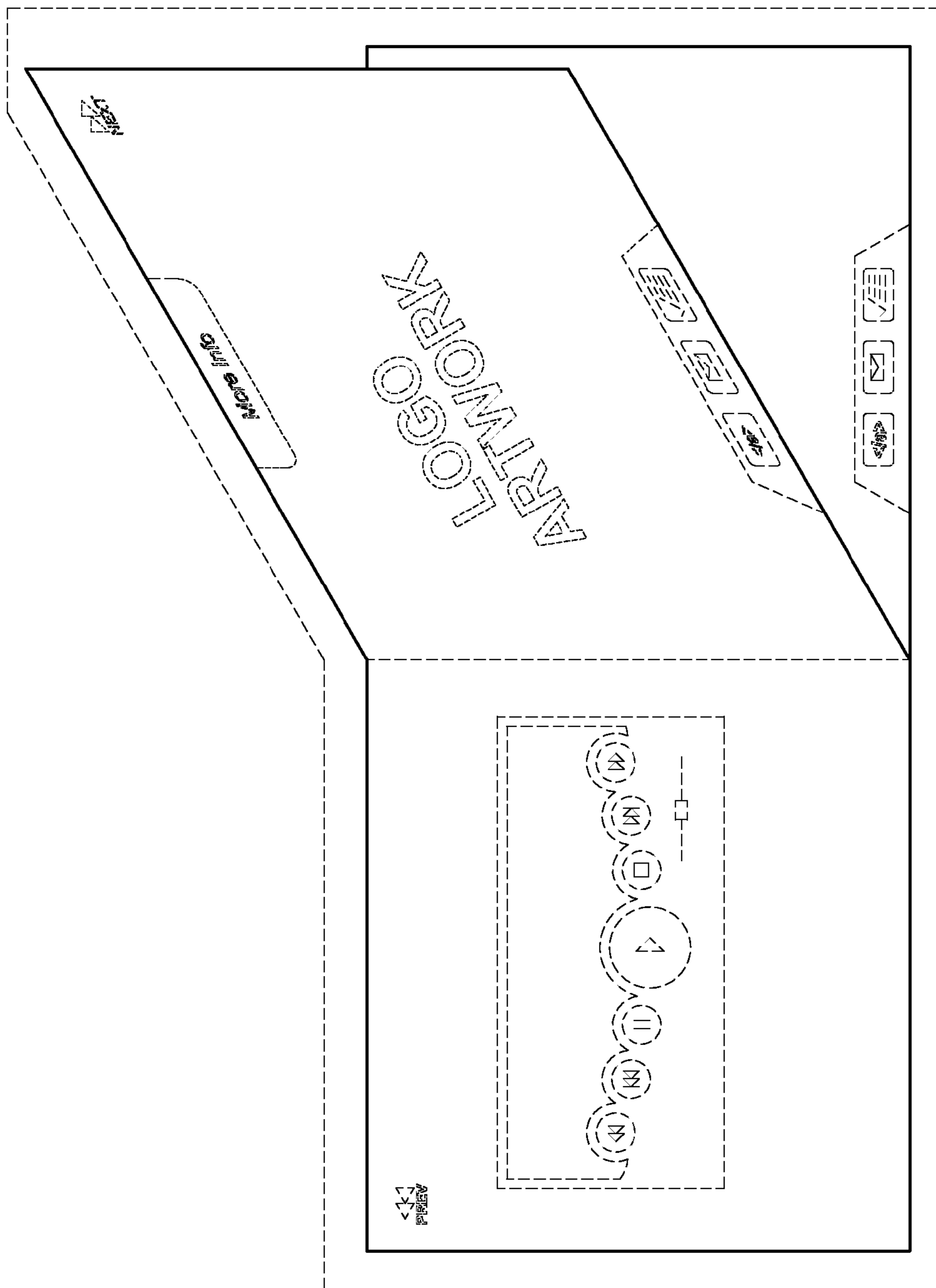

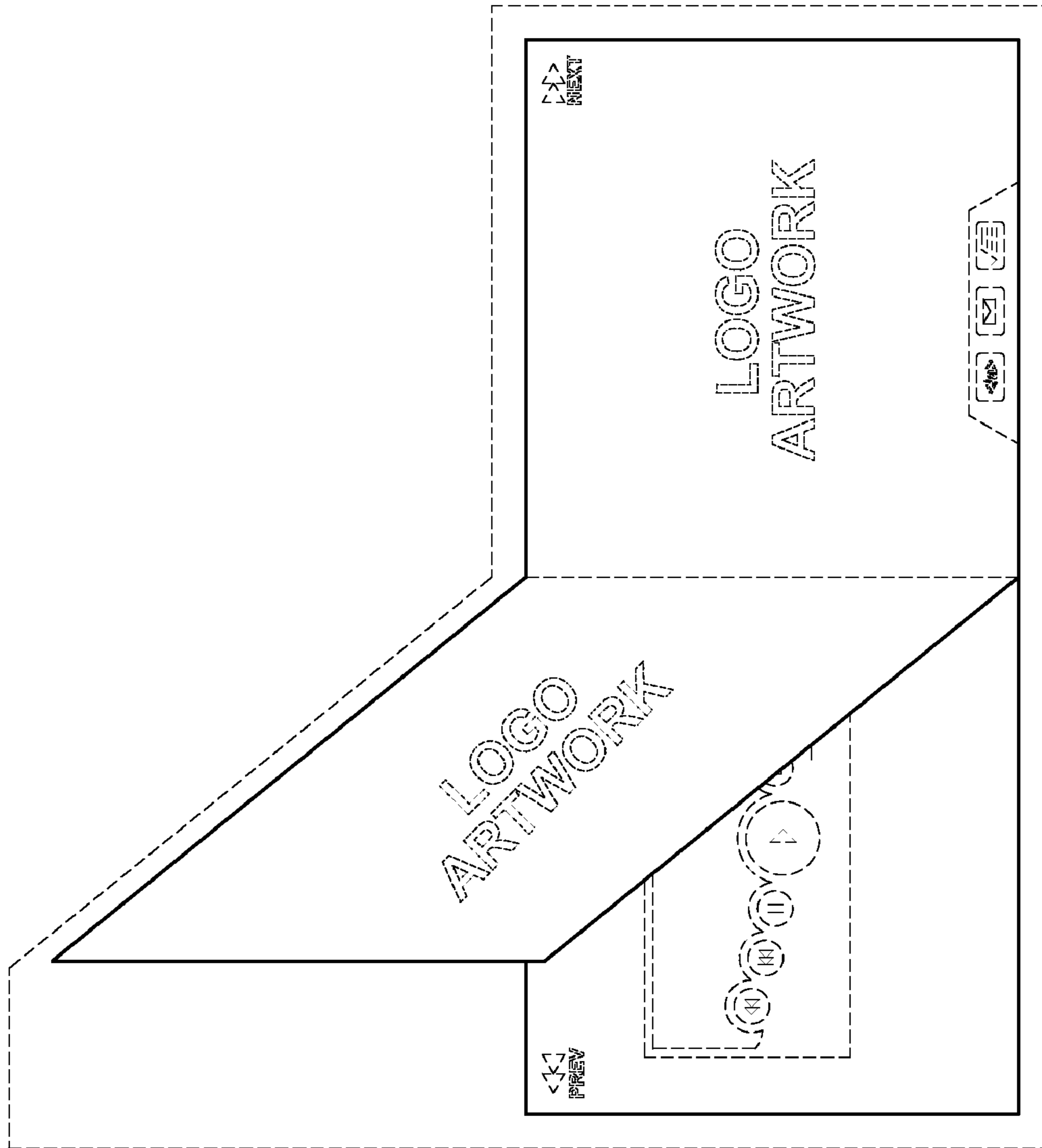

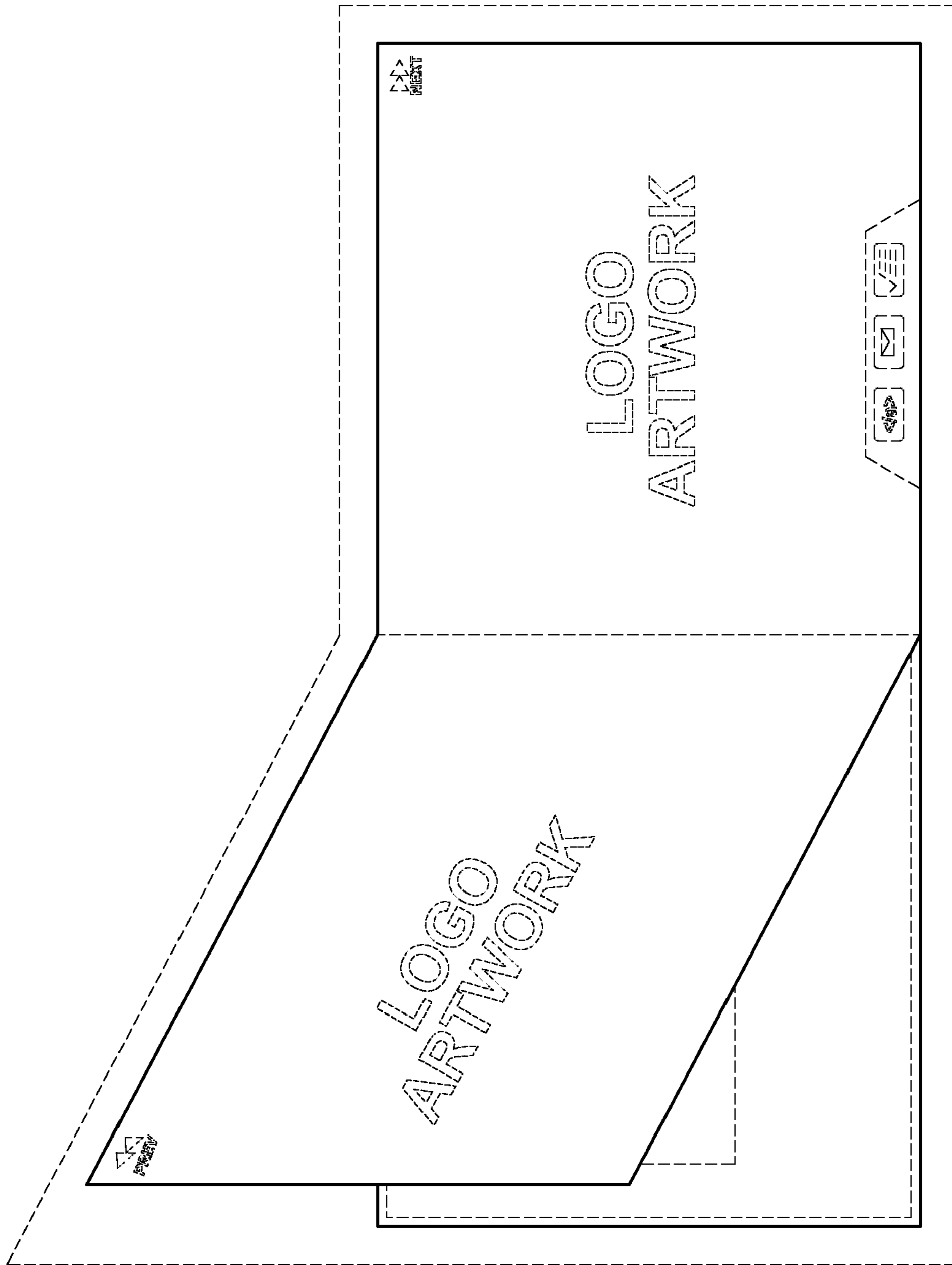

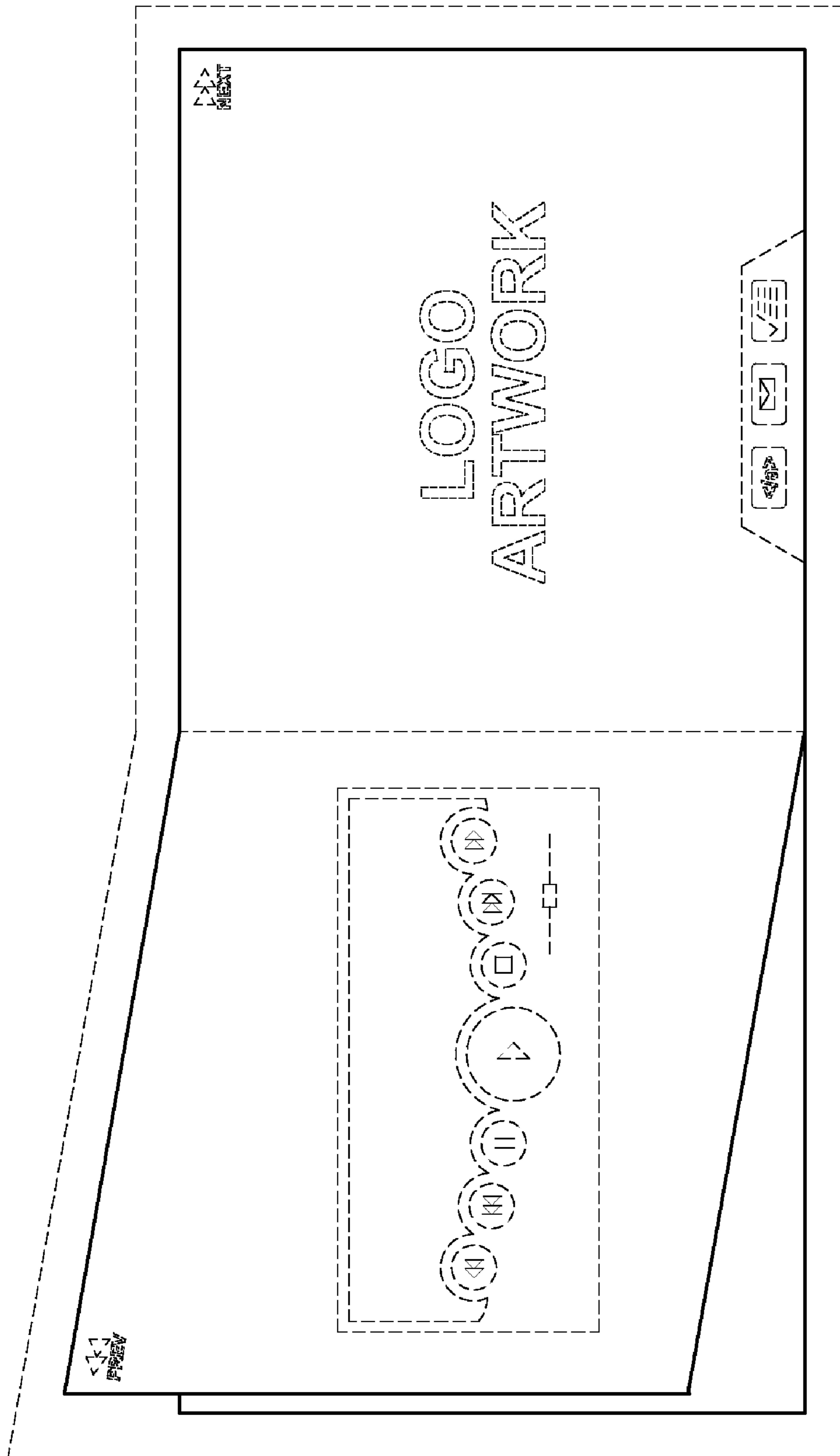

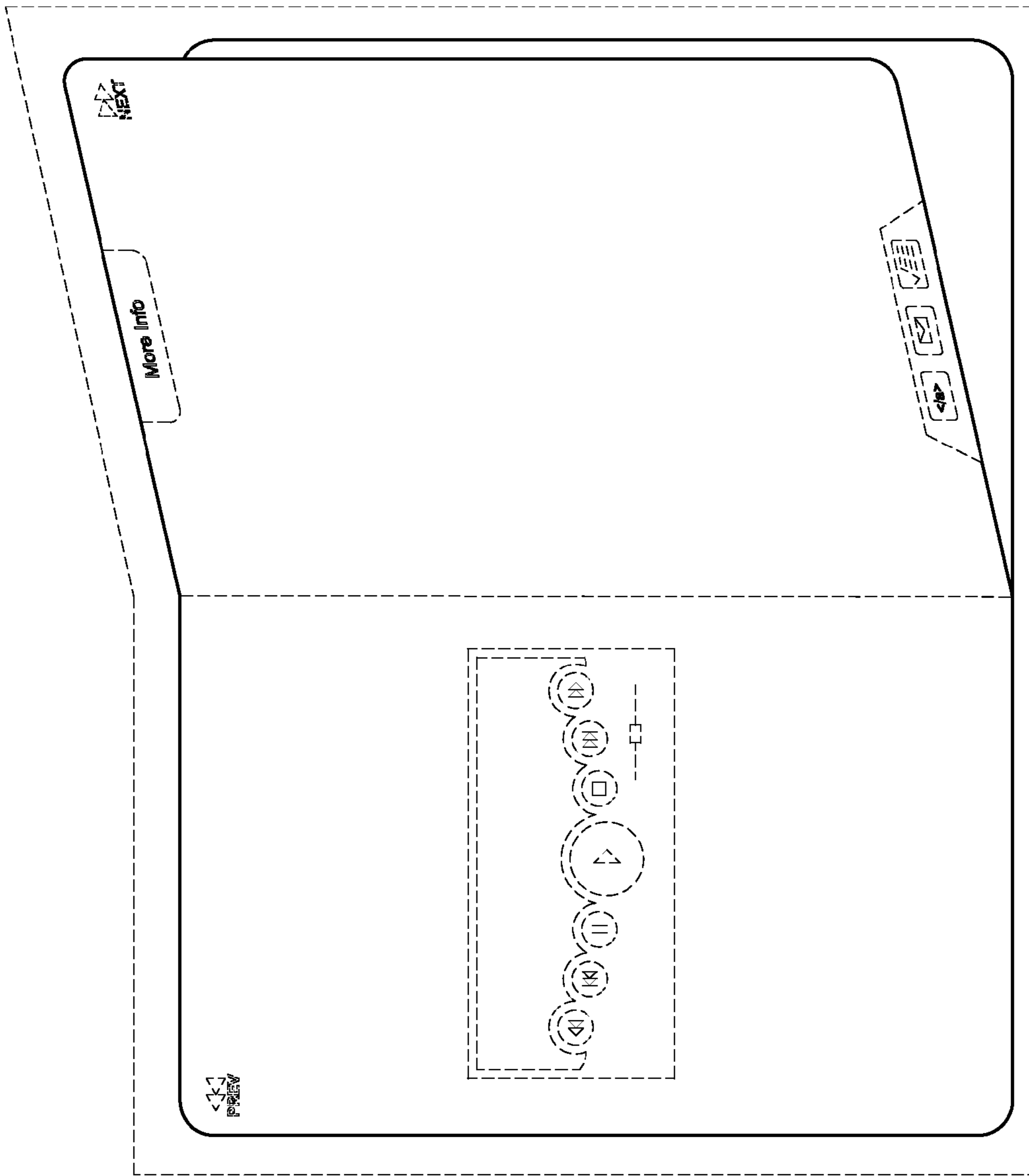

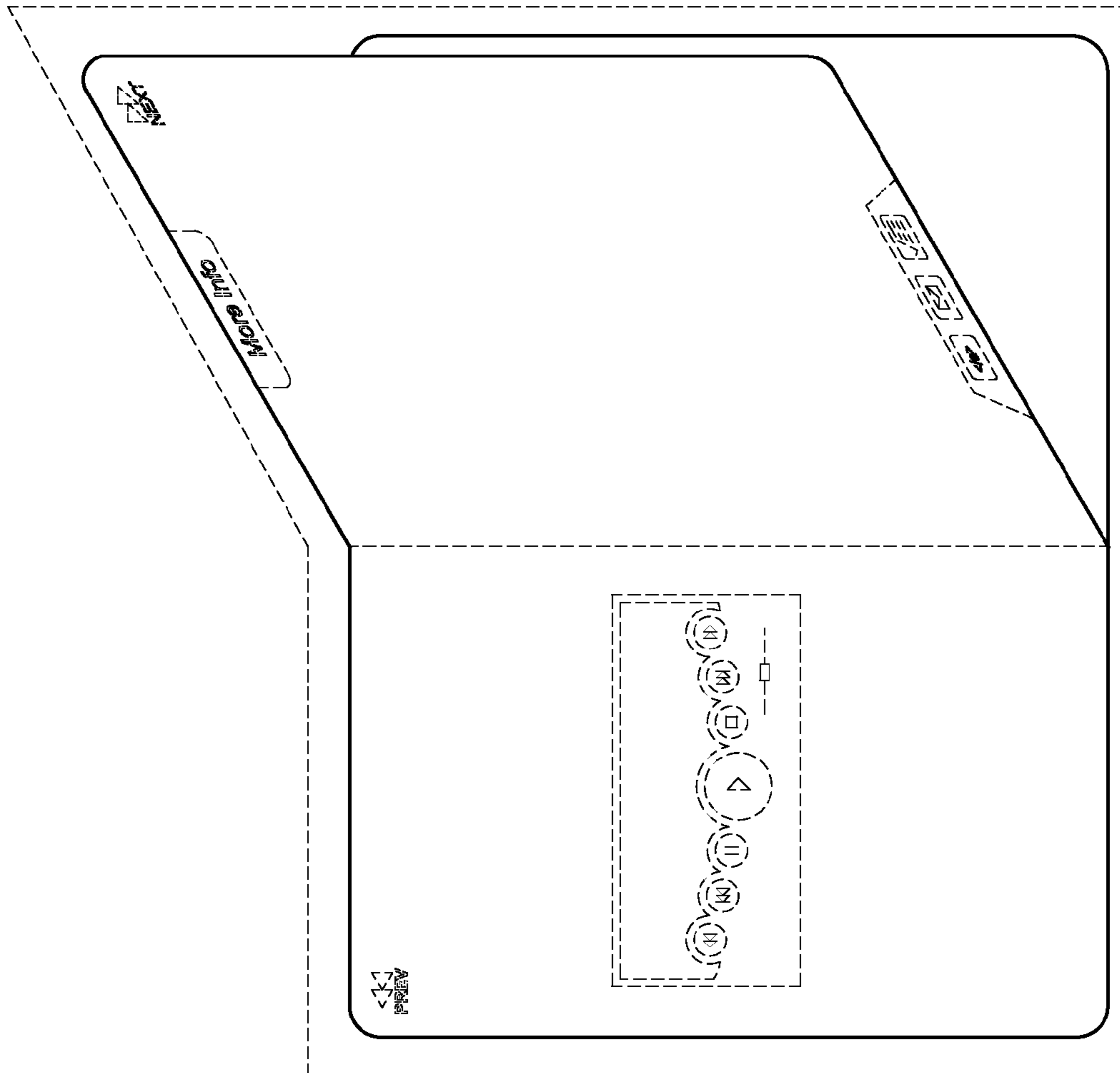

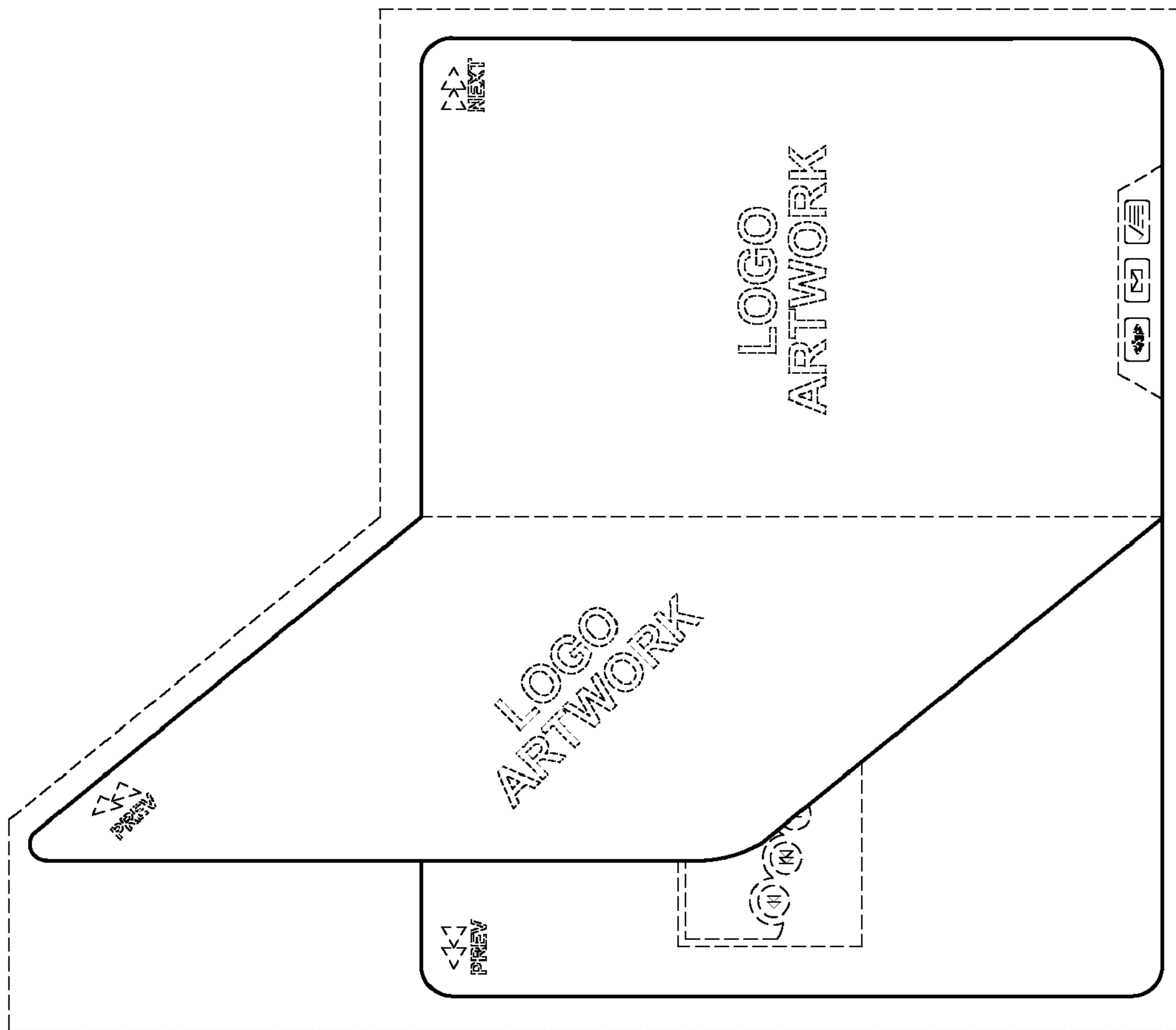

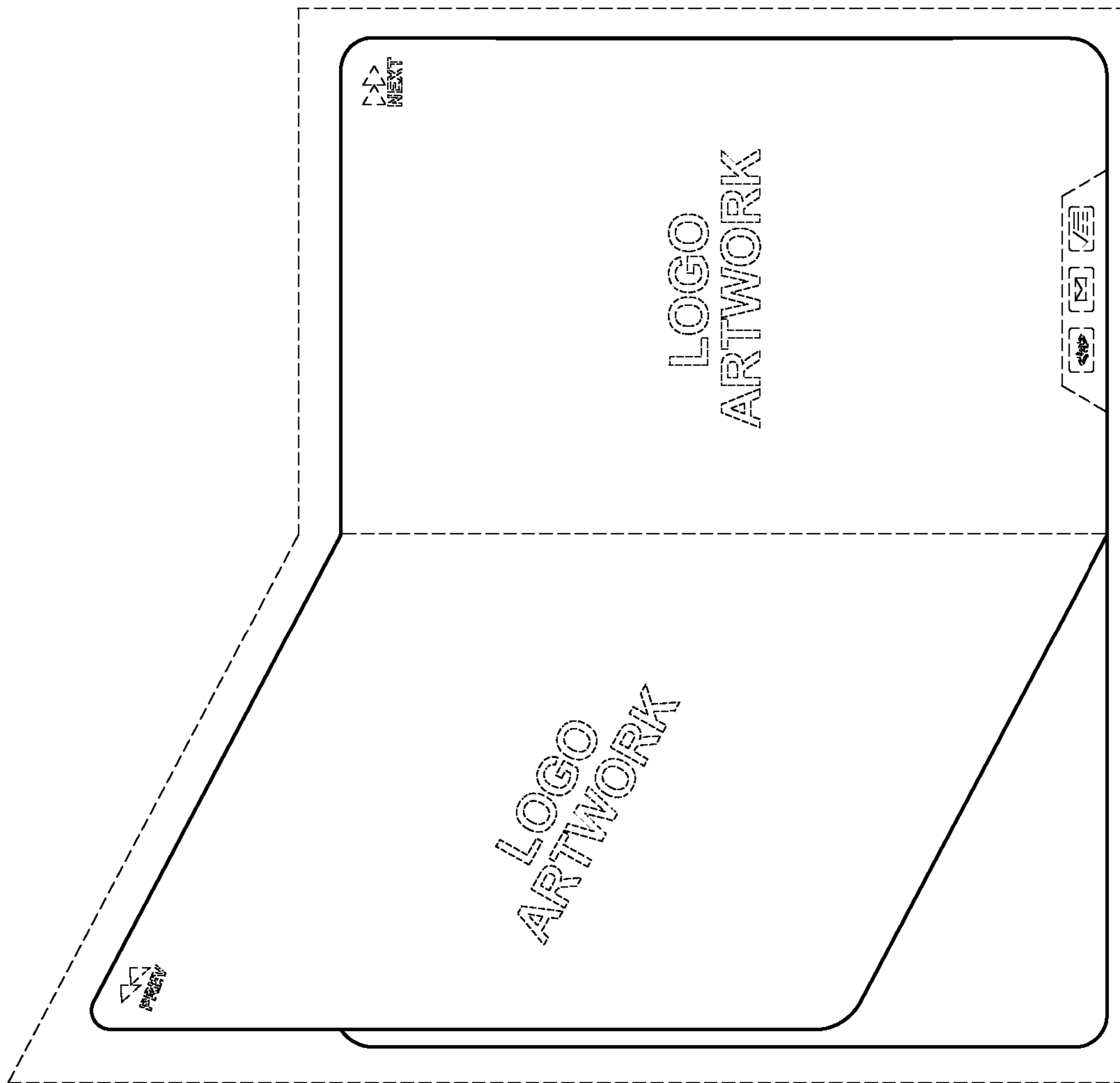

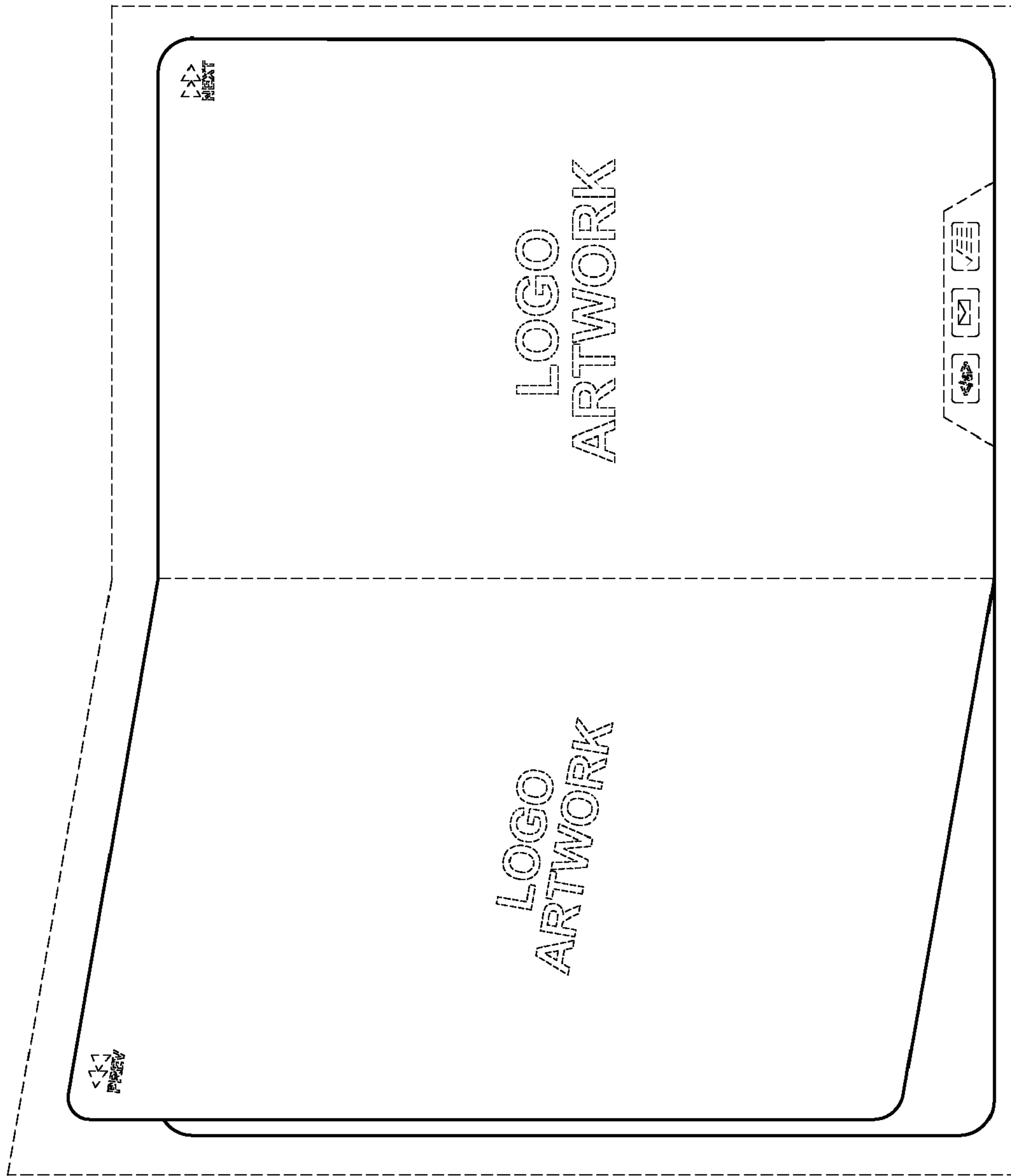
