The ornamental design for a hair-removing appliance, as shown and described.

DESCRIPTION

FIG. 1 is a top, right side perspective view of a hair-removing appliance showing my new design;

FIG. 2 is a front elevation view of the hair-removing appliance of FIG. 1;

FIG. 3 is a rear elevation view of the hair-removing appliance of FIG. 1;

FIG. 4 is a right side elevation view of the hair-removing appliance of FIG. 1;

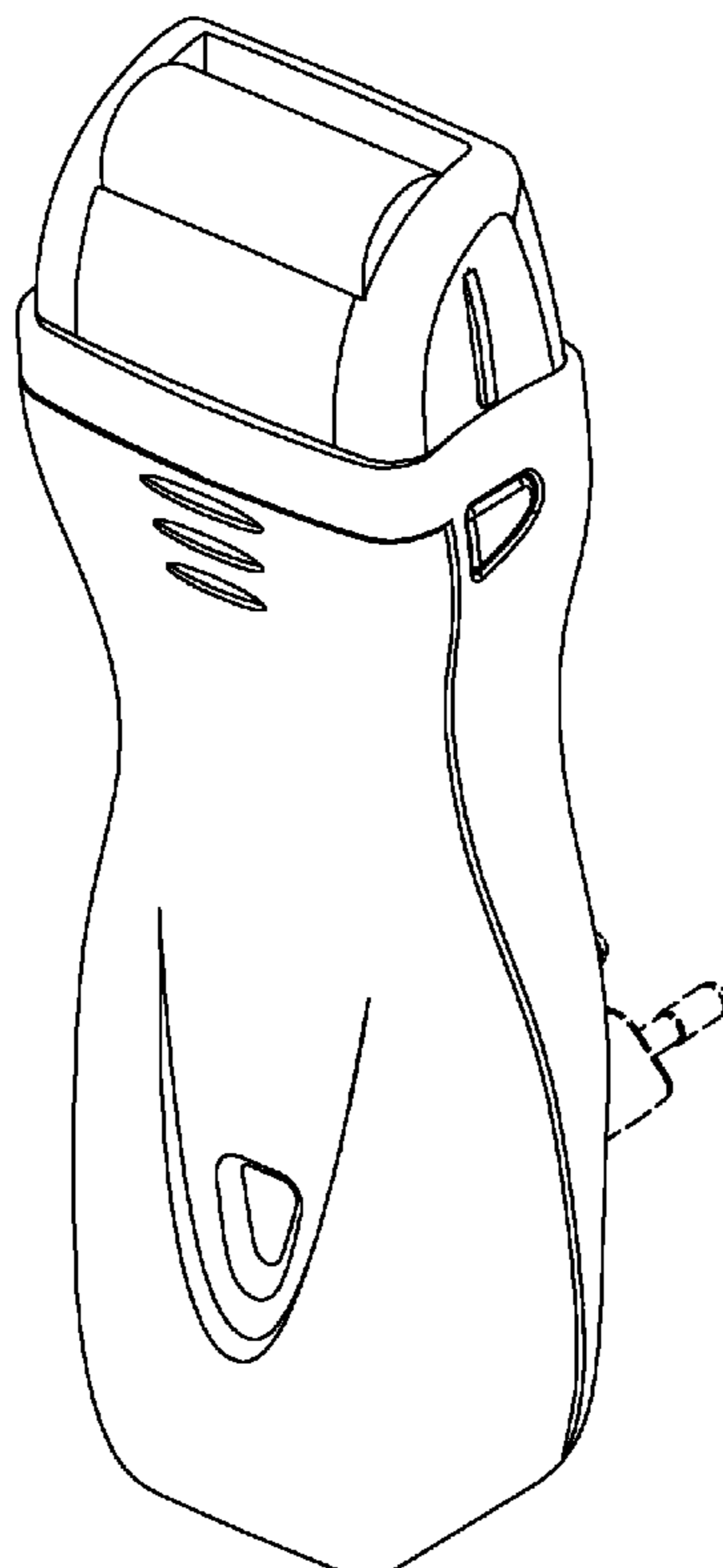
FIG. 5 is a left side elevation view of the hair-removing appliance of FIG. 1;

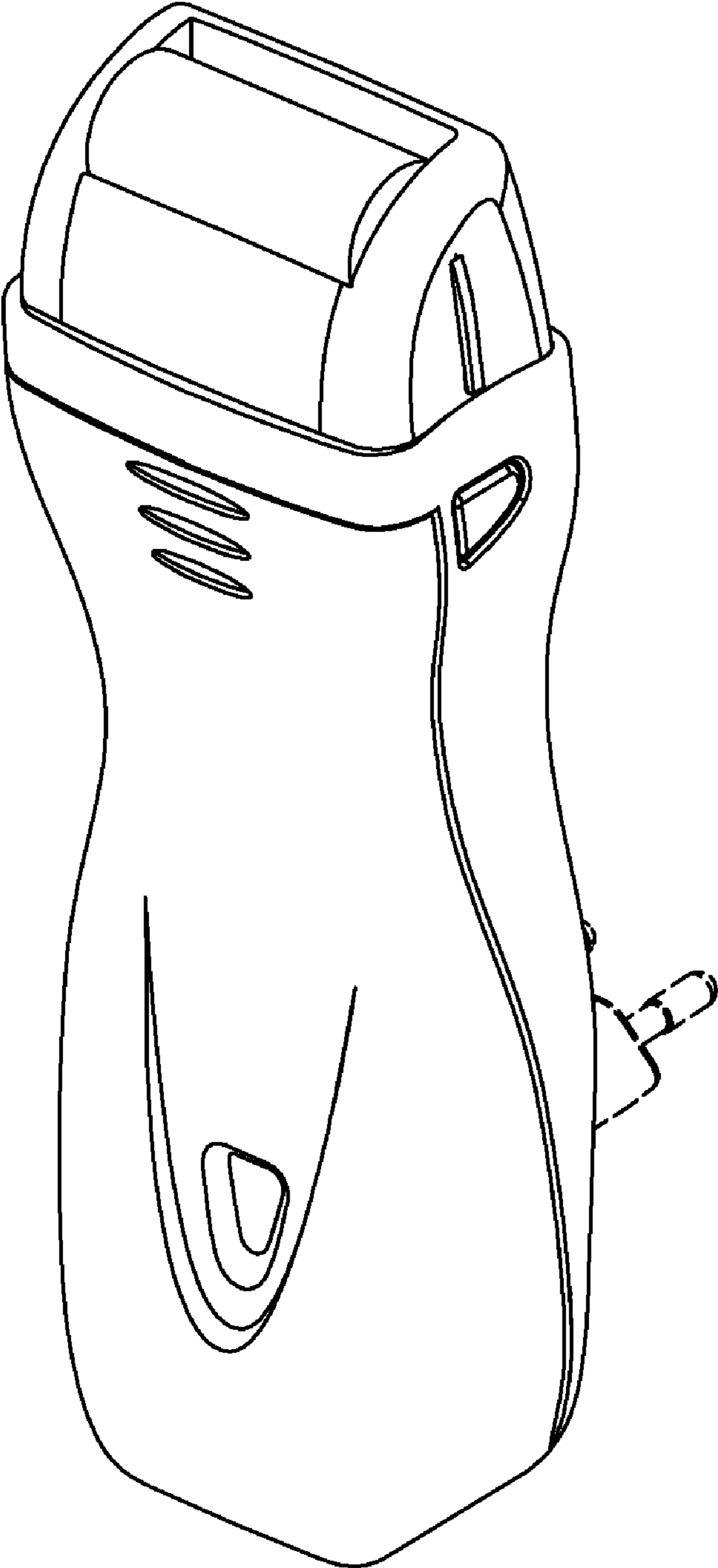

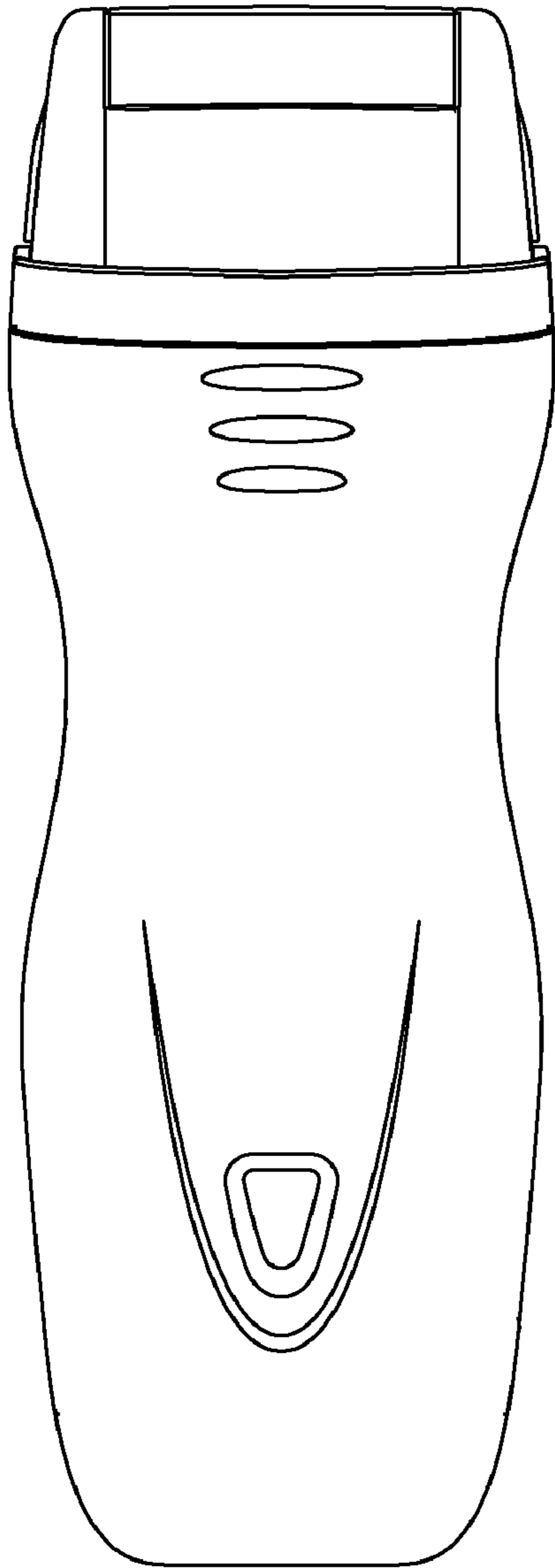

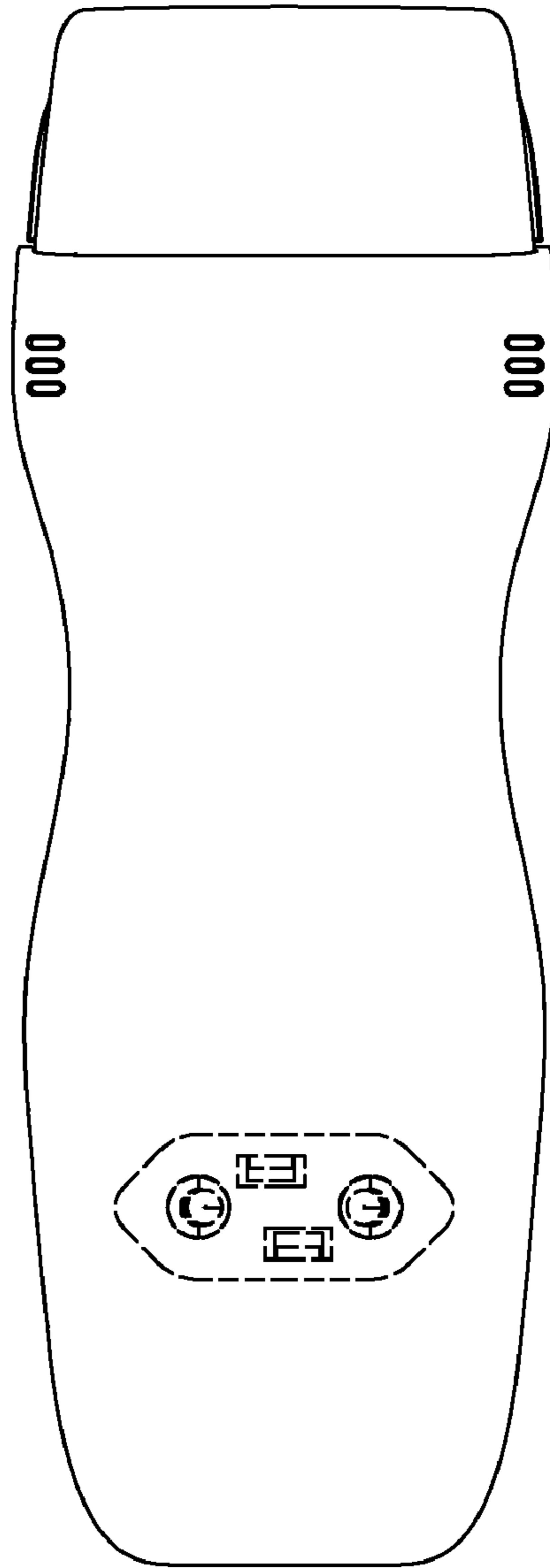

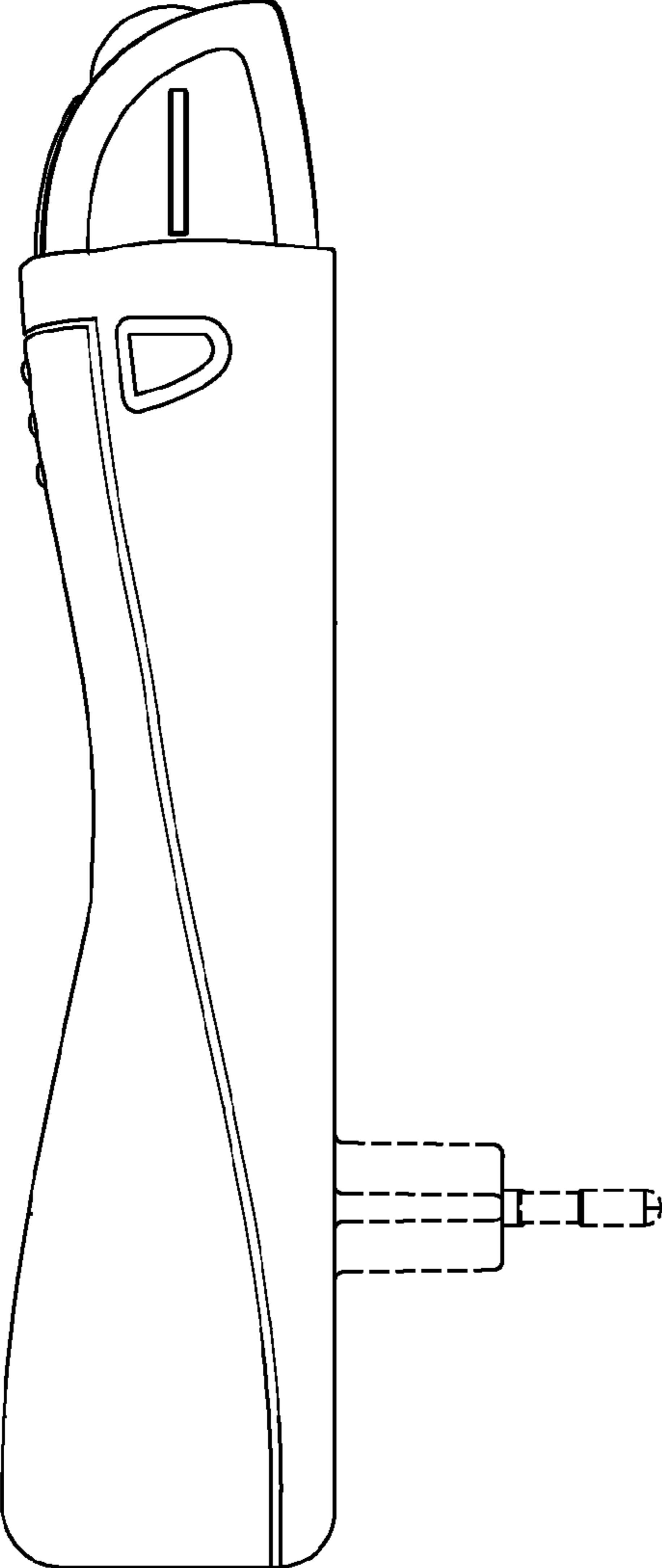

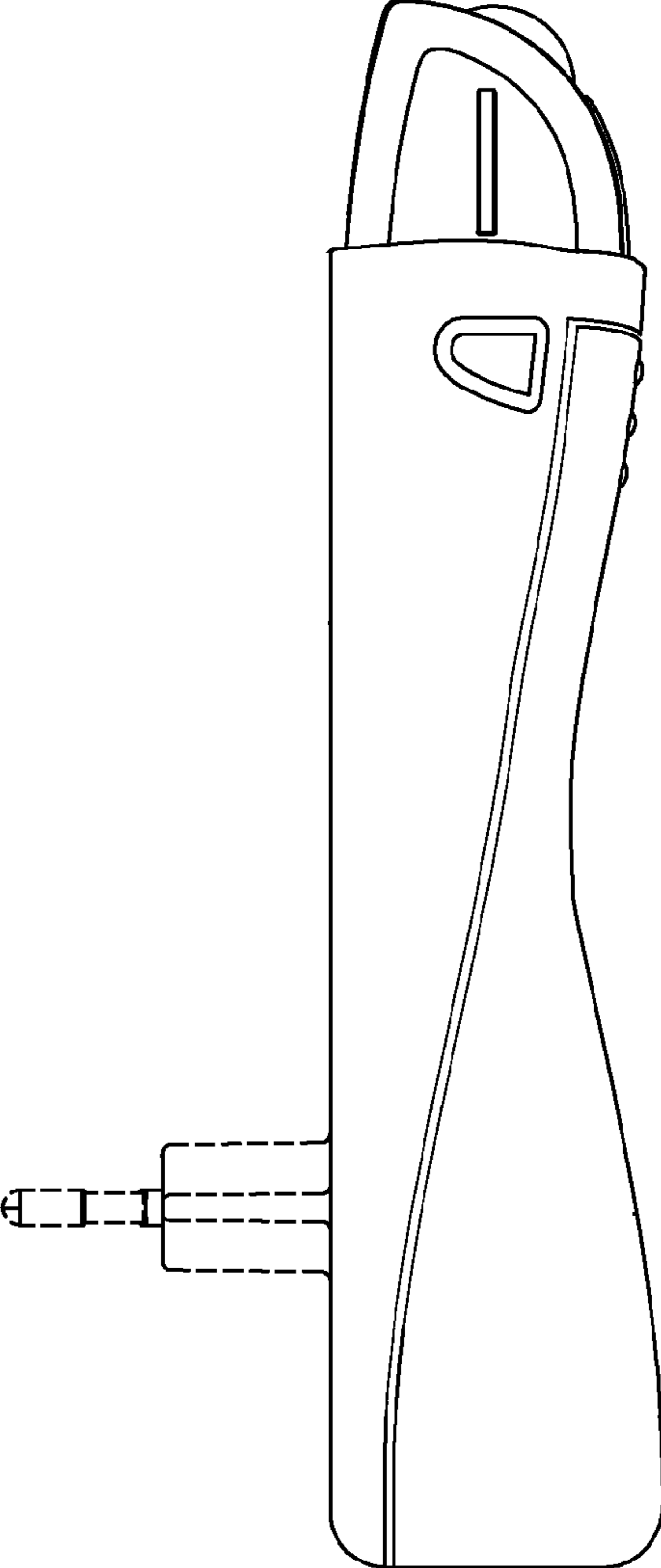

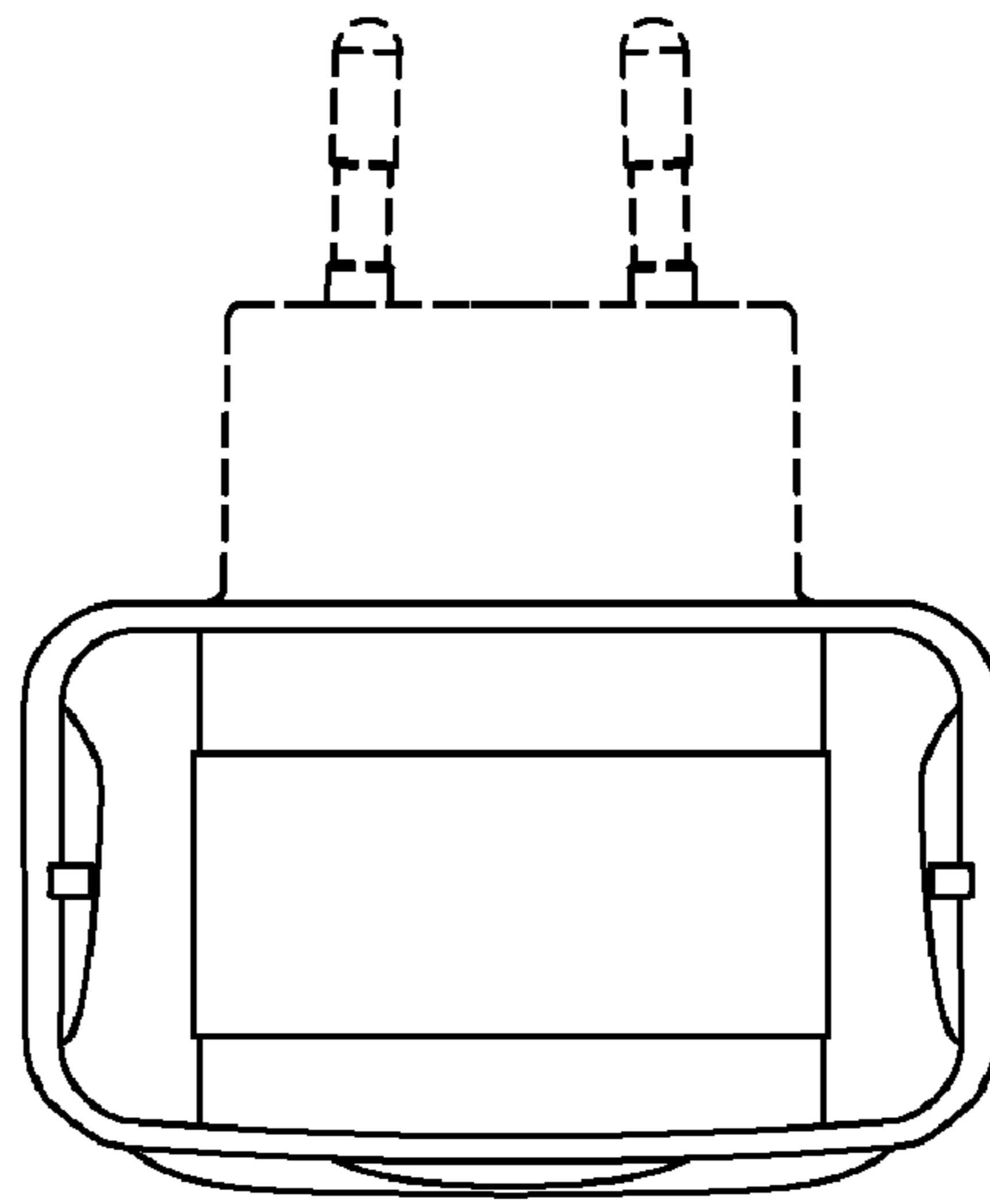

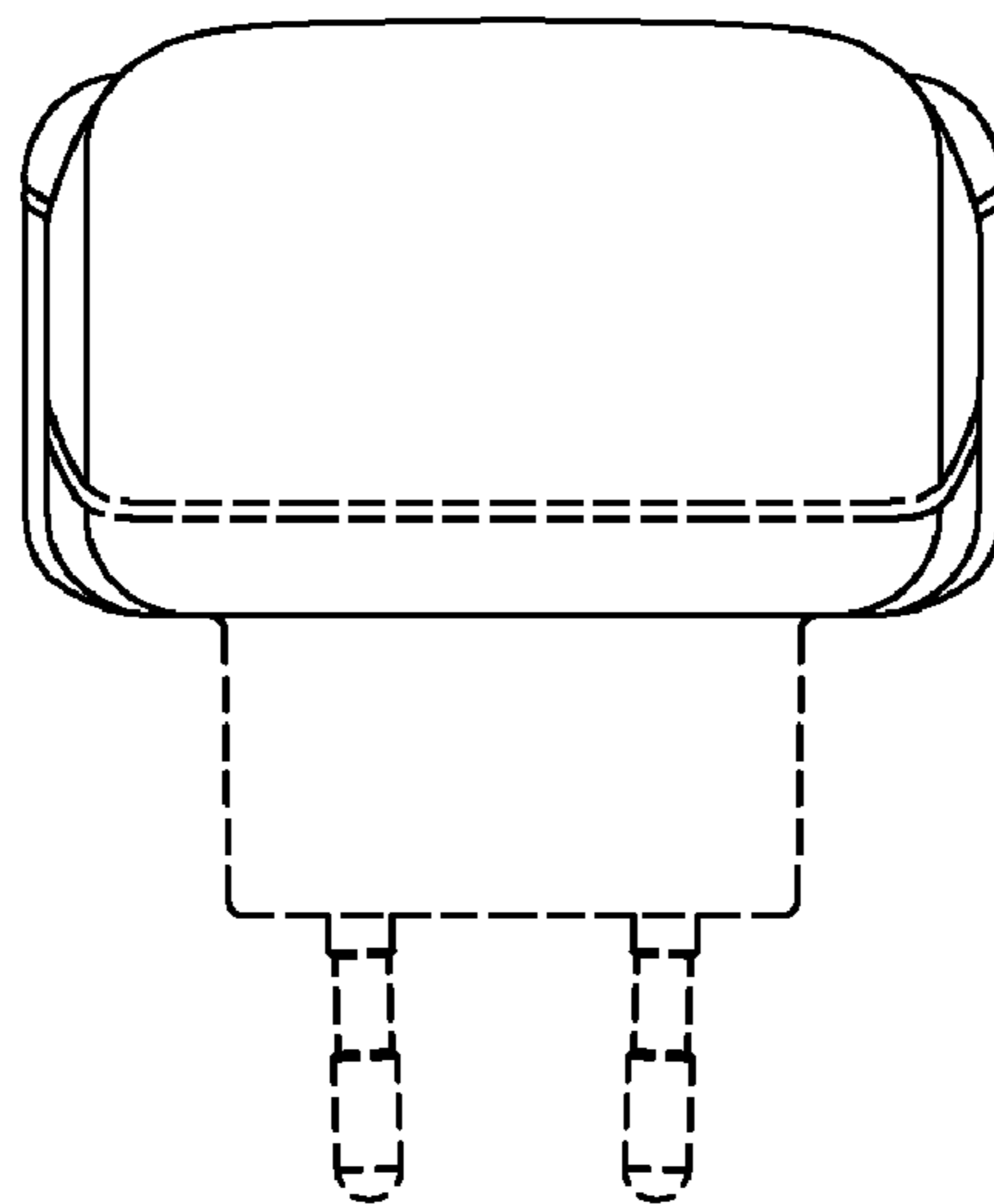
