DESCRIPTION

FIG. 1 is a perspective view of a helmet and face shield assembly;

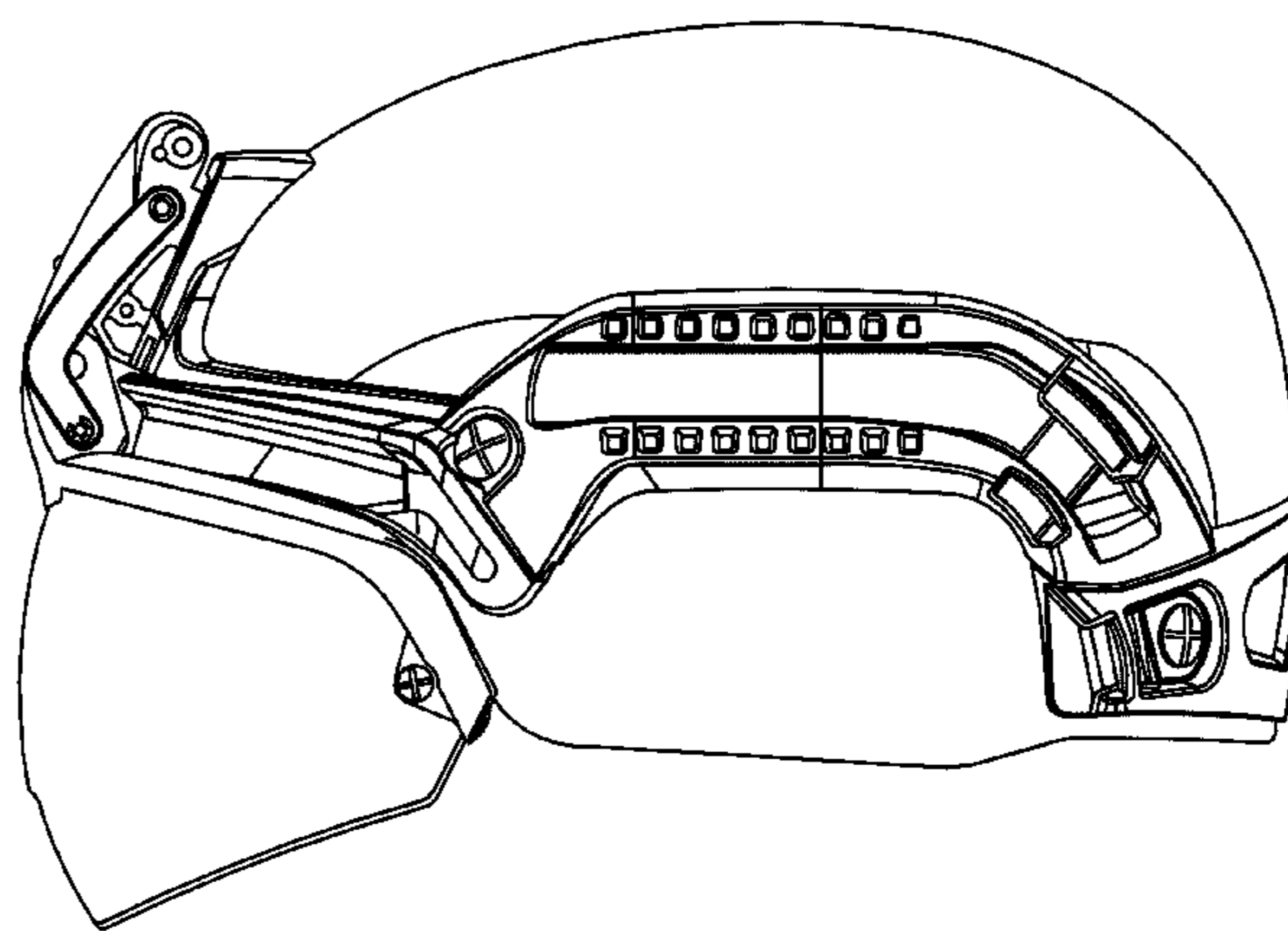
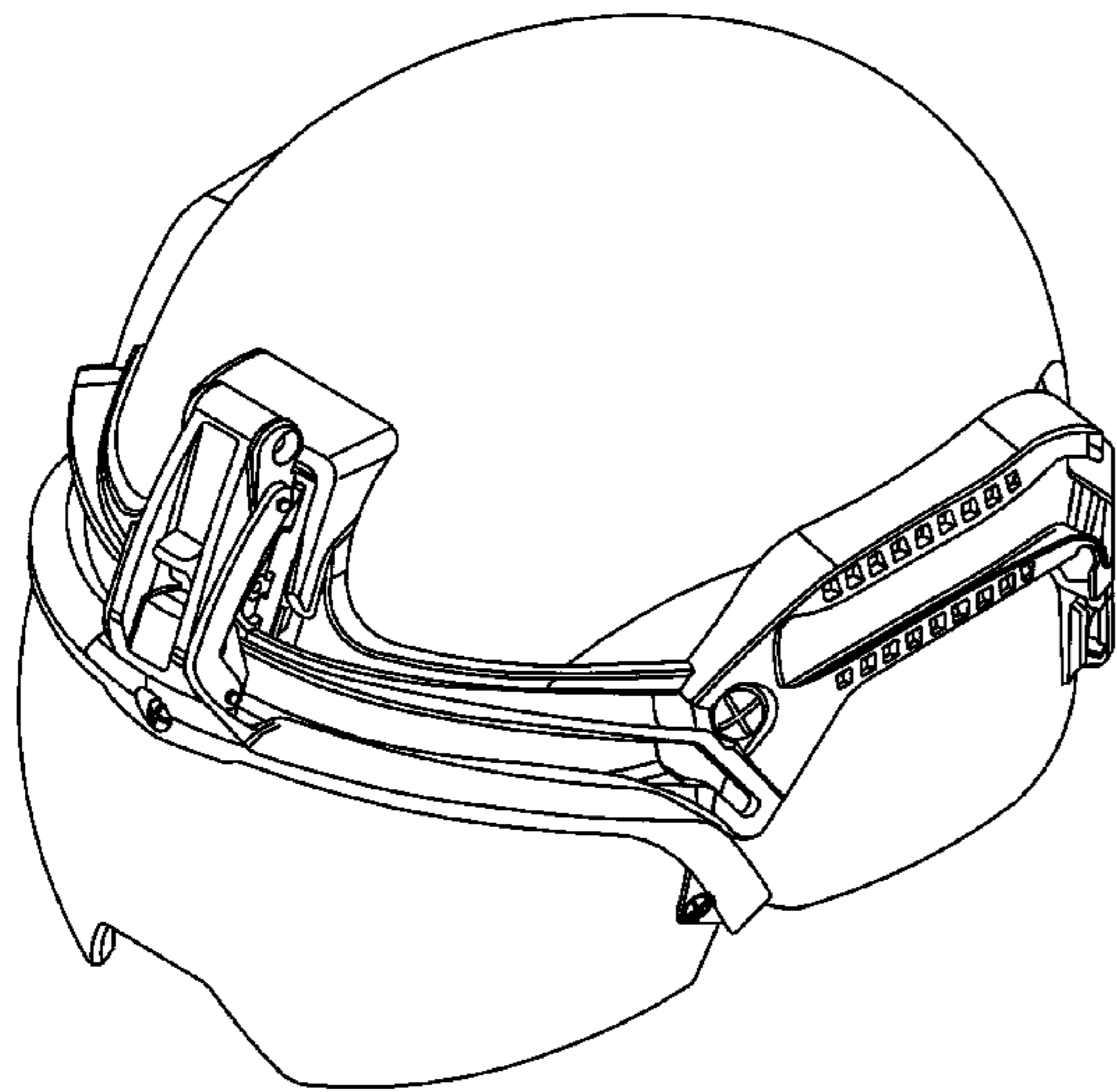

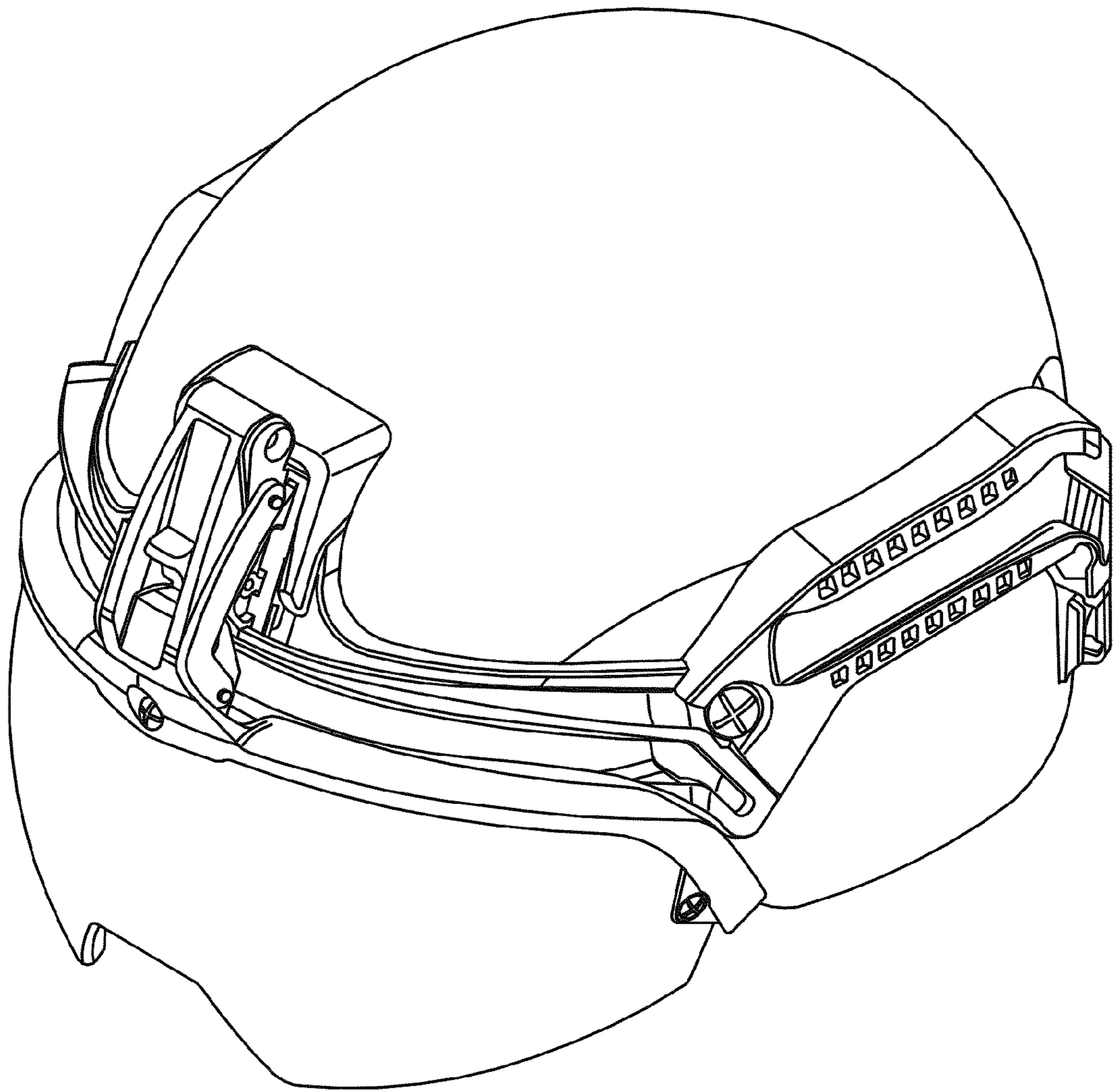

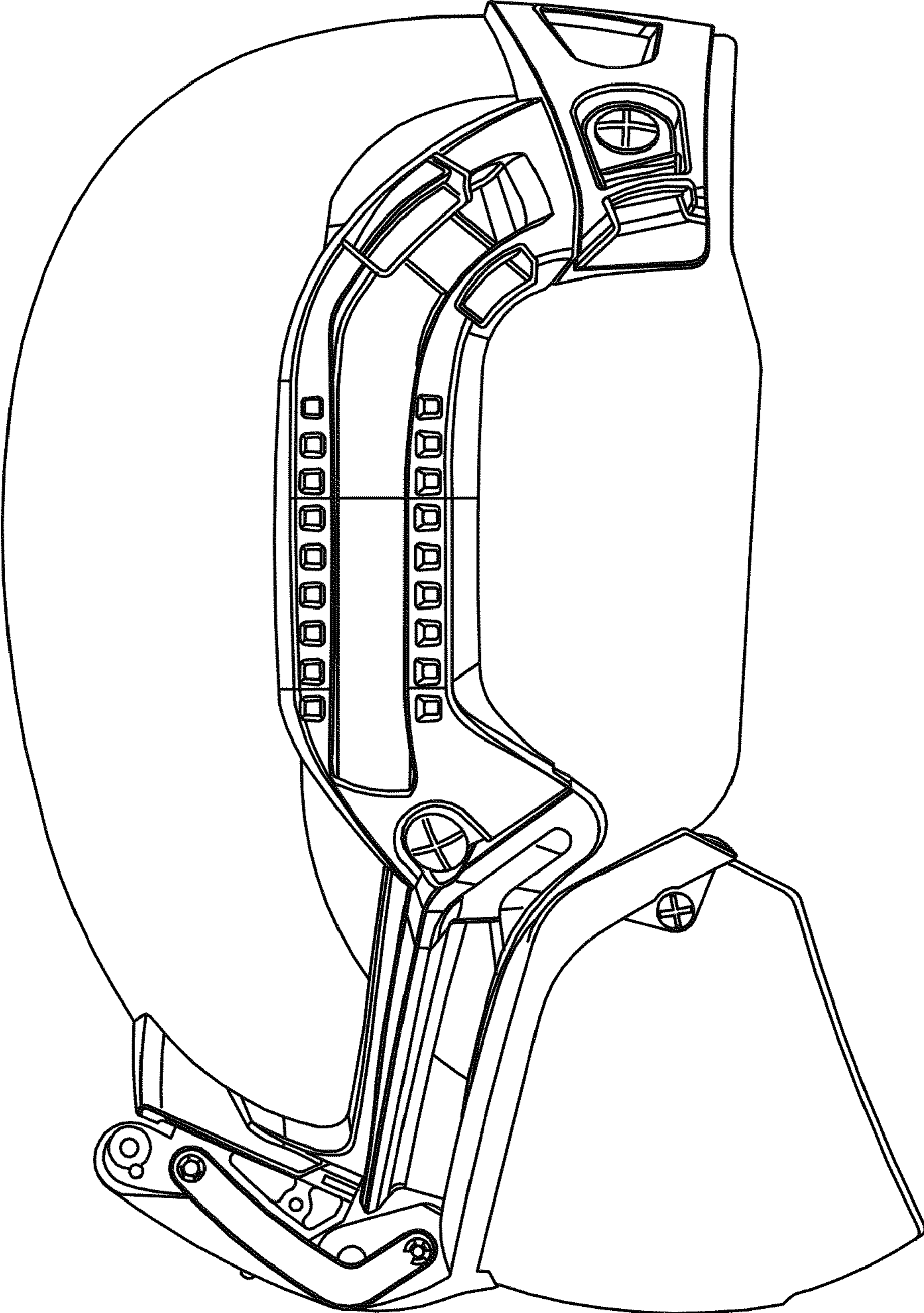

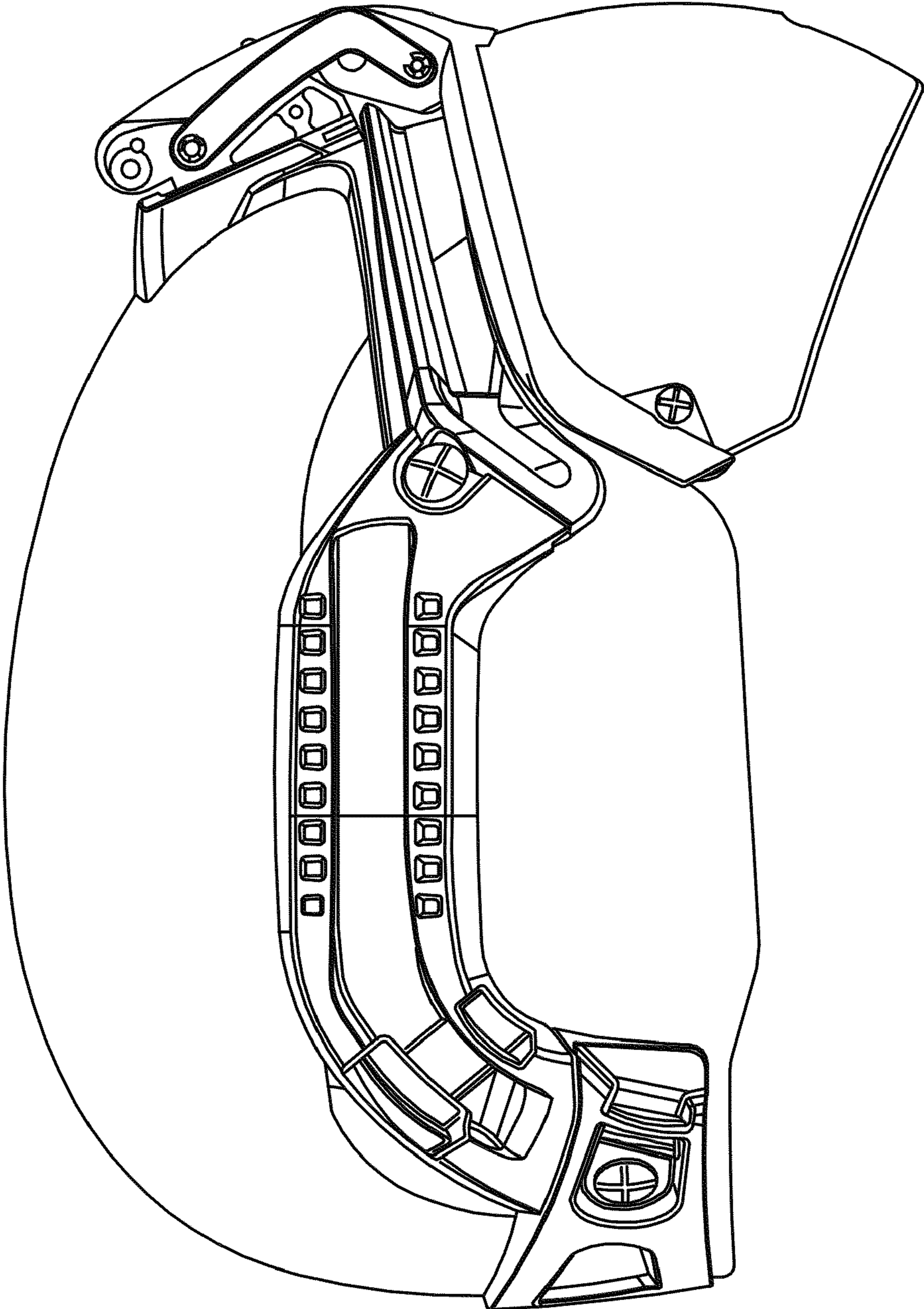

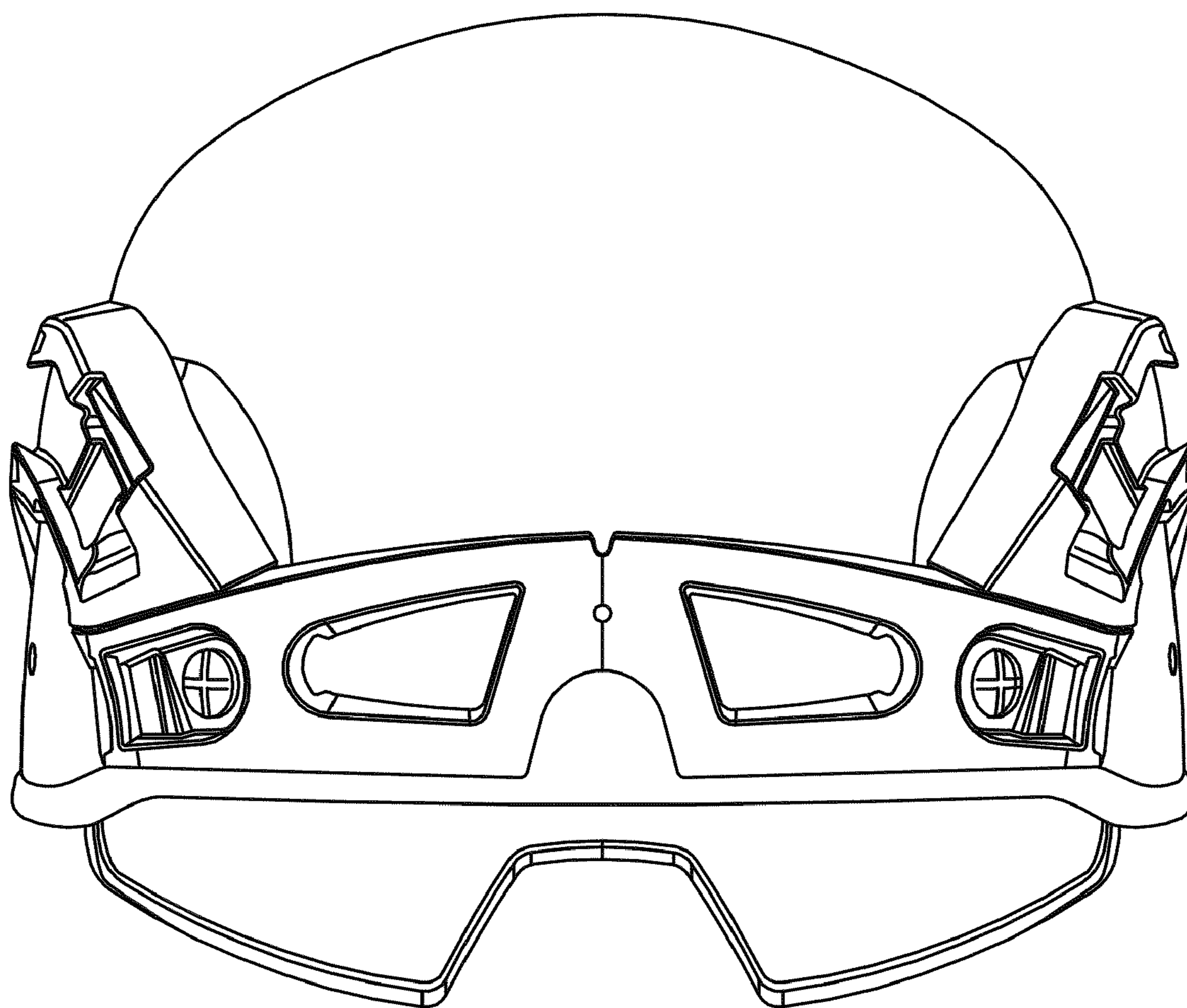

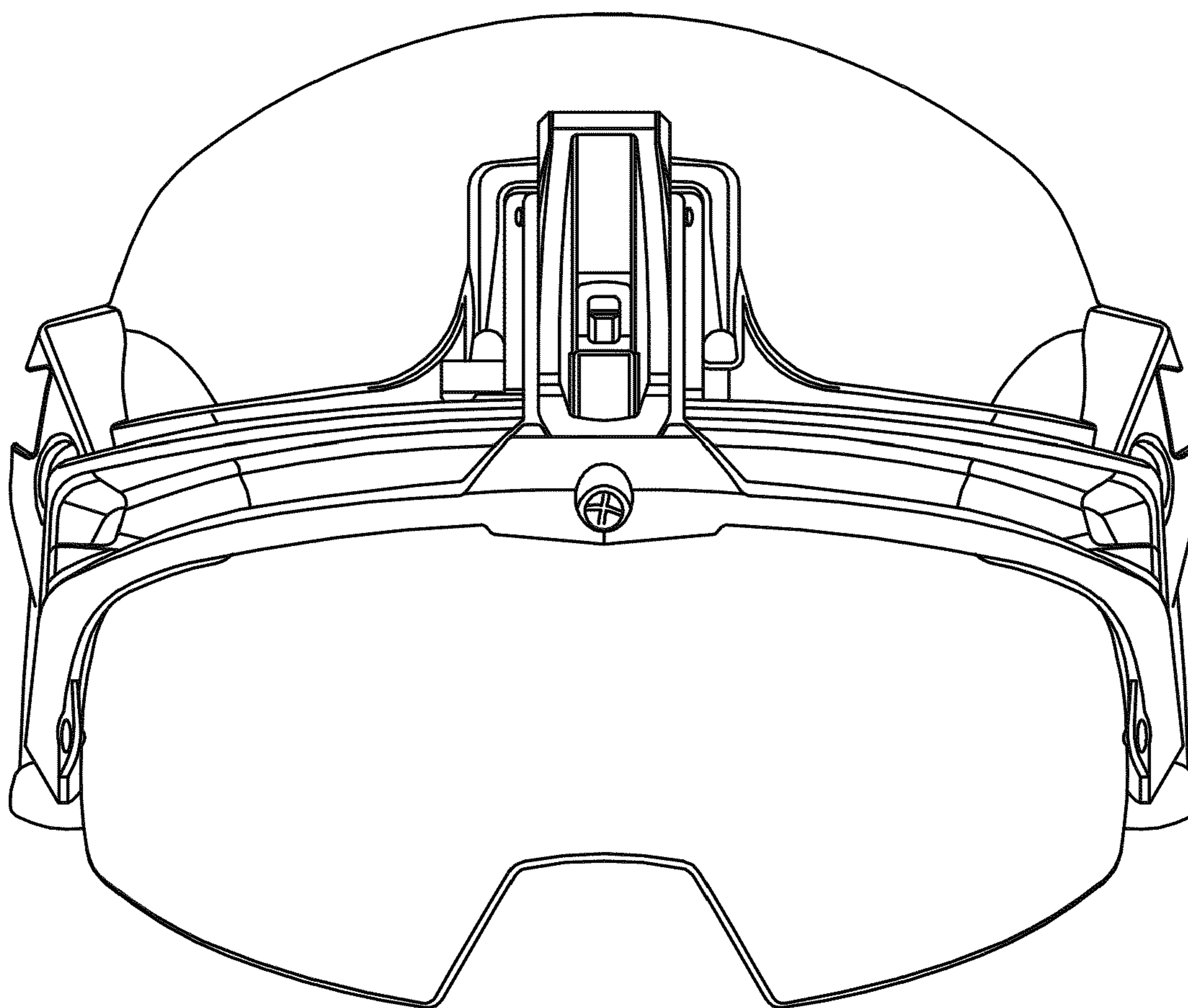

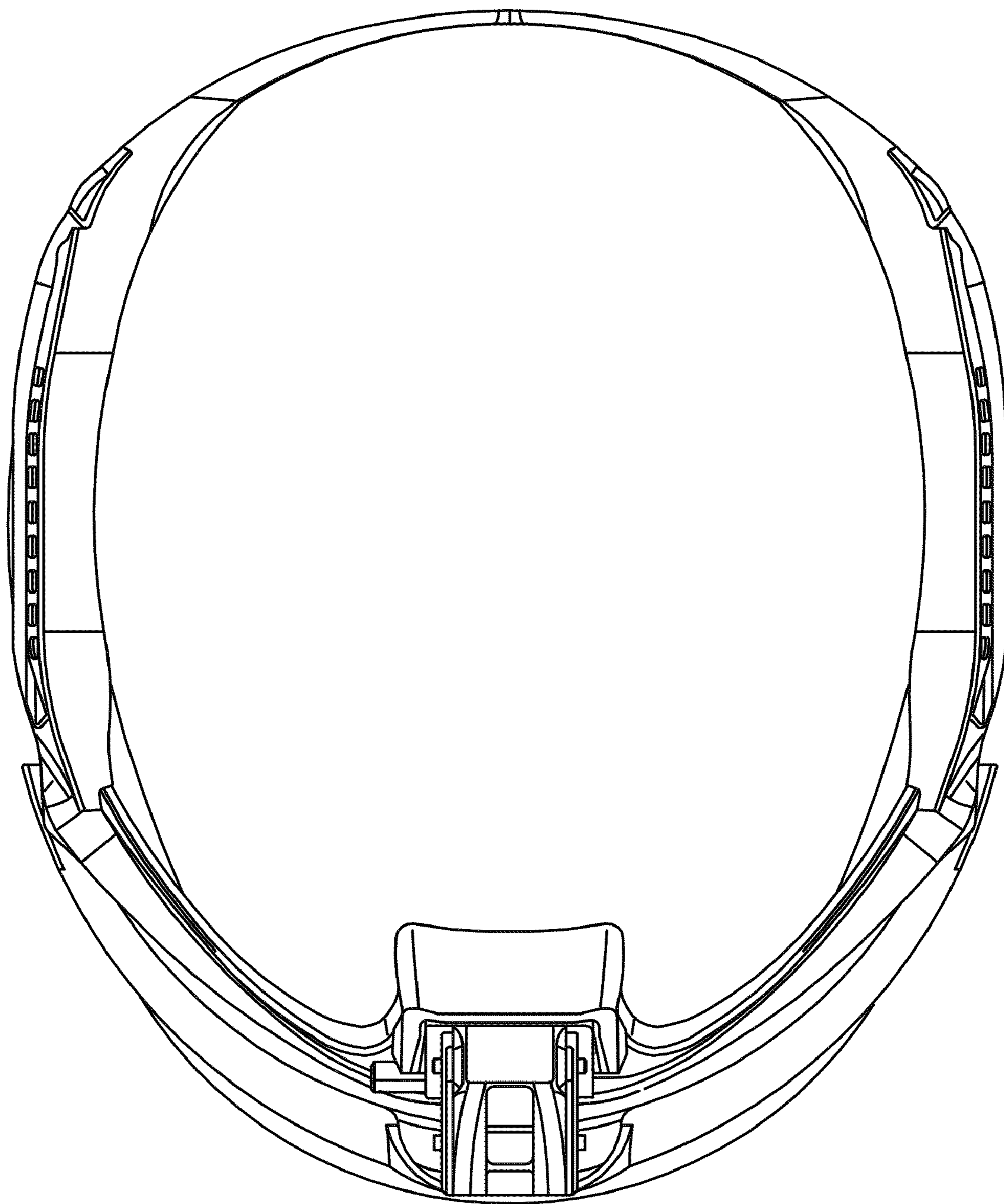
