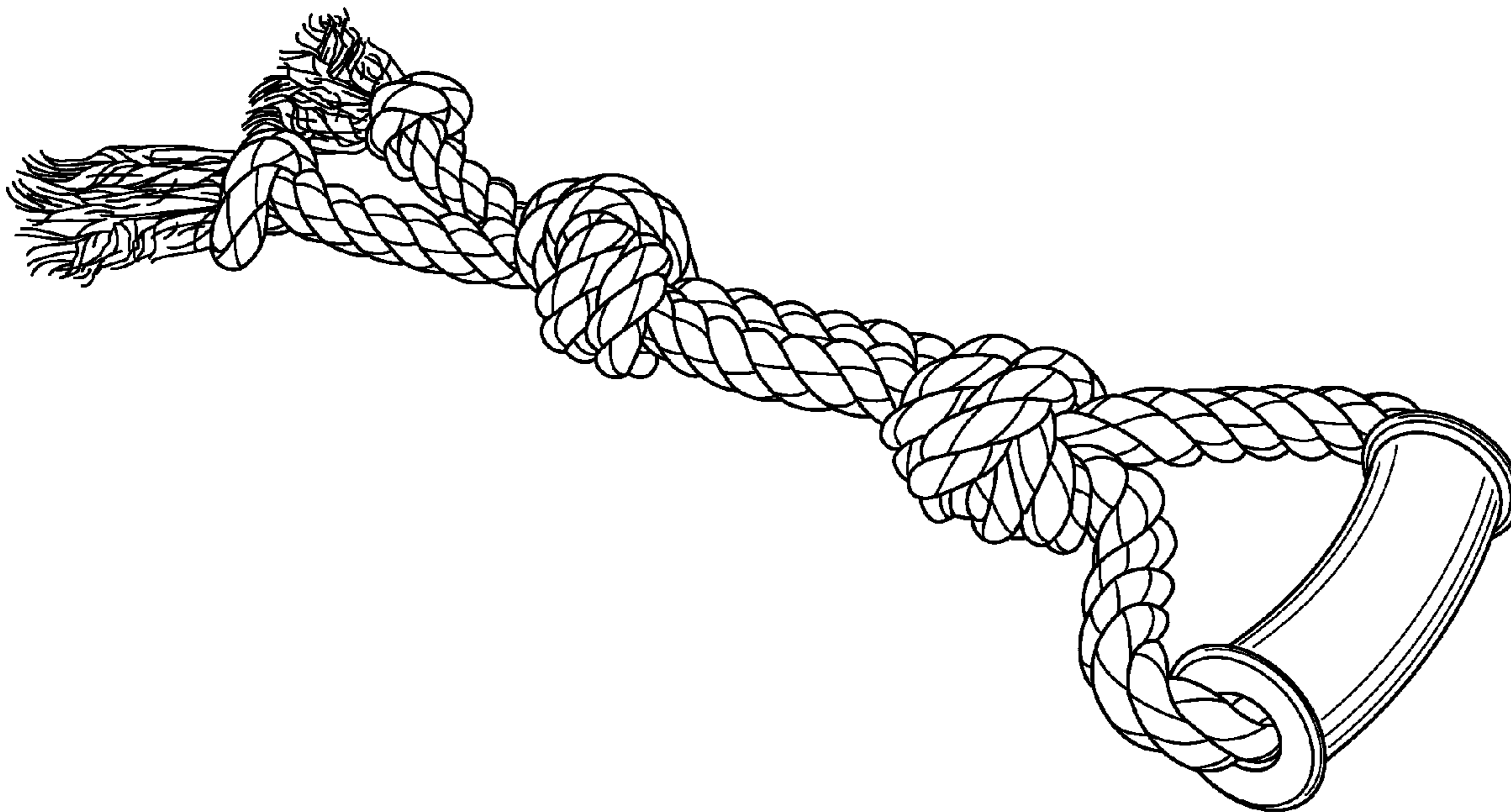
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is front, top and left side perspective view of a pet chew toy embodying my new design;

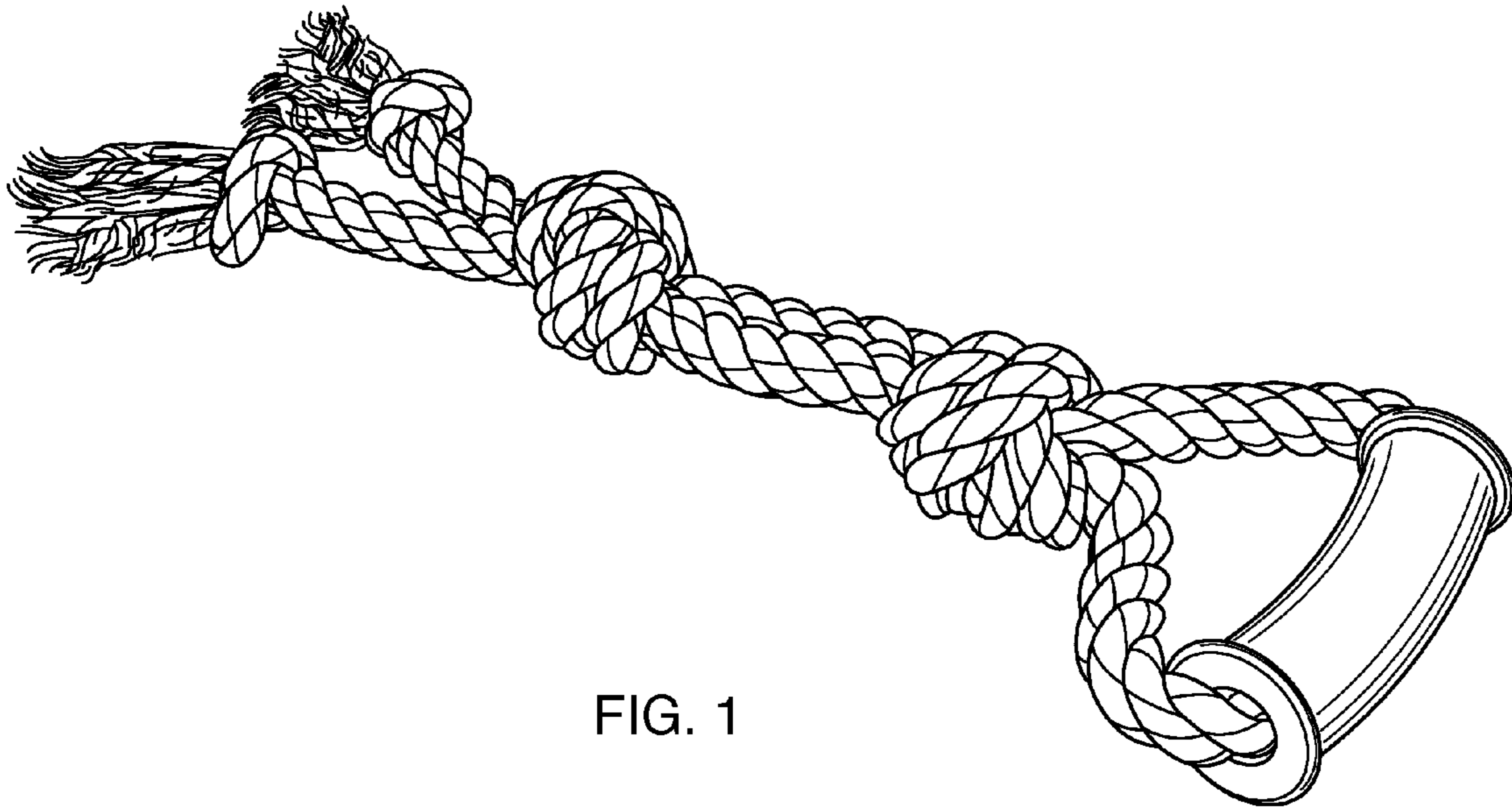

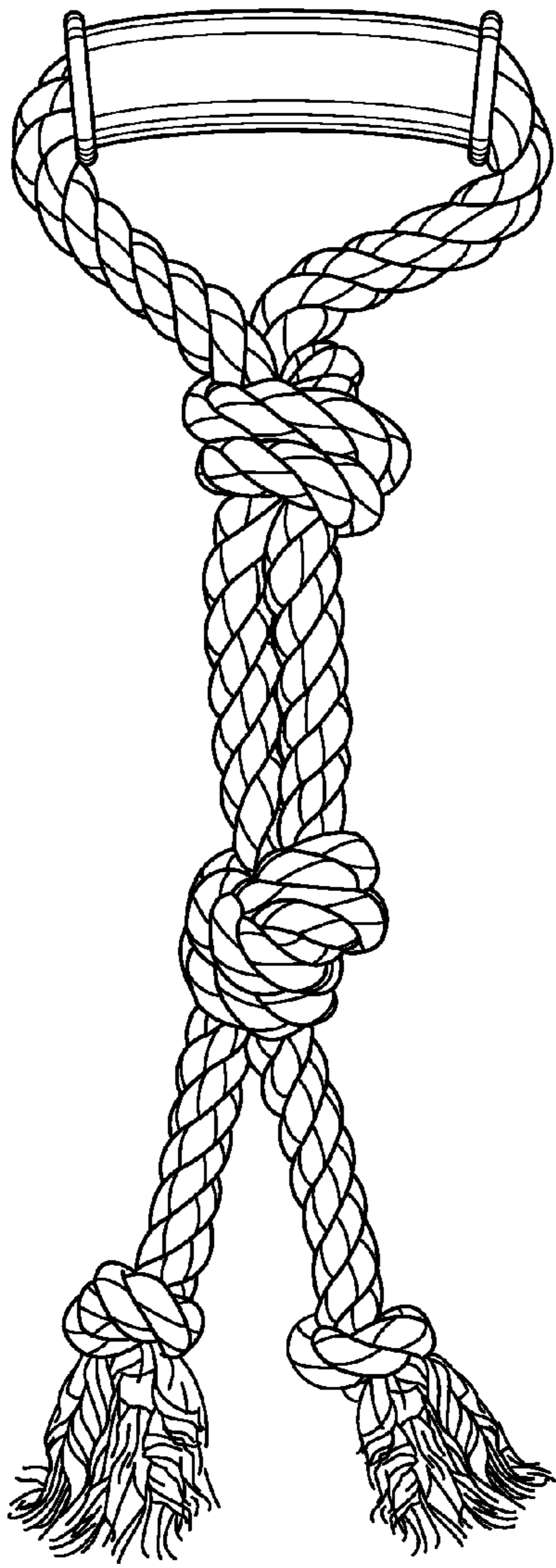

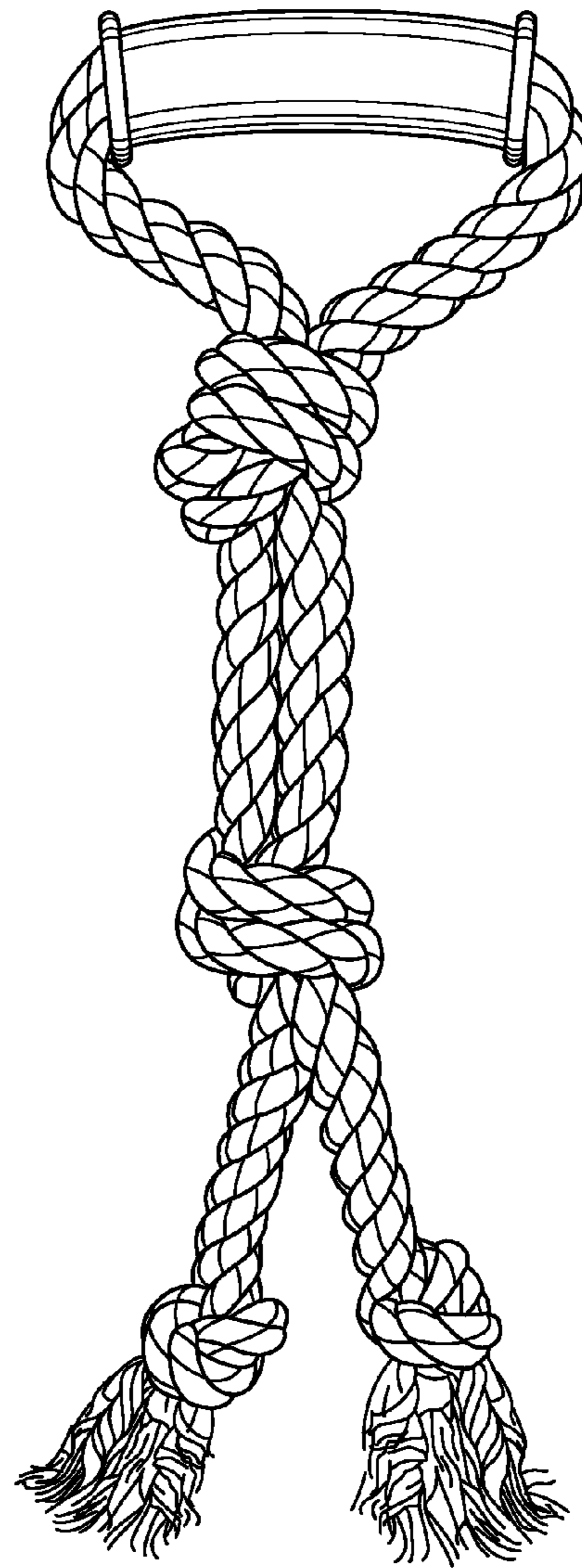

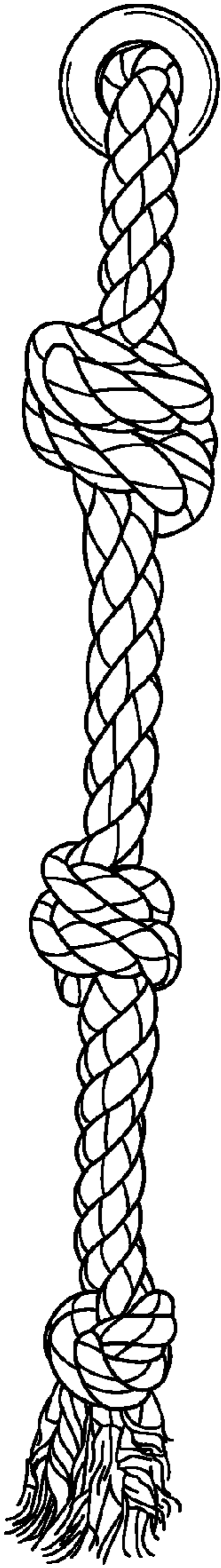

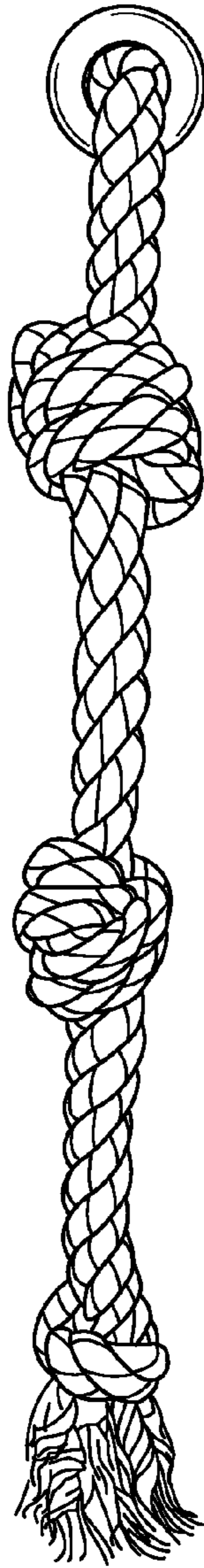

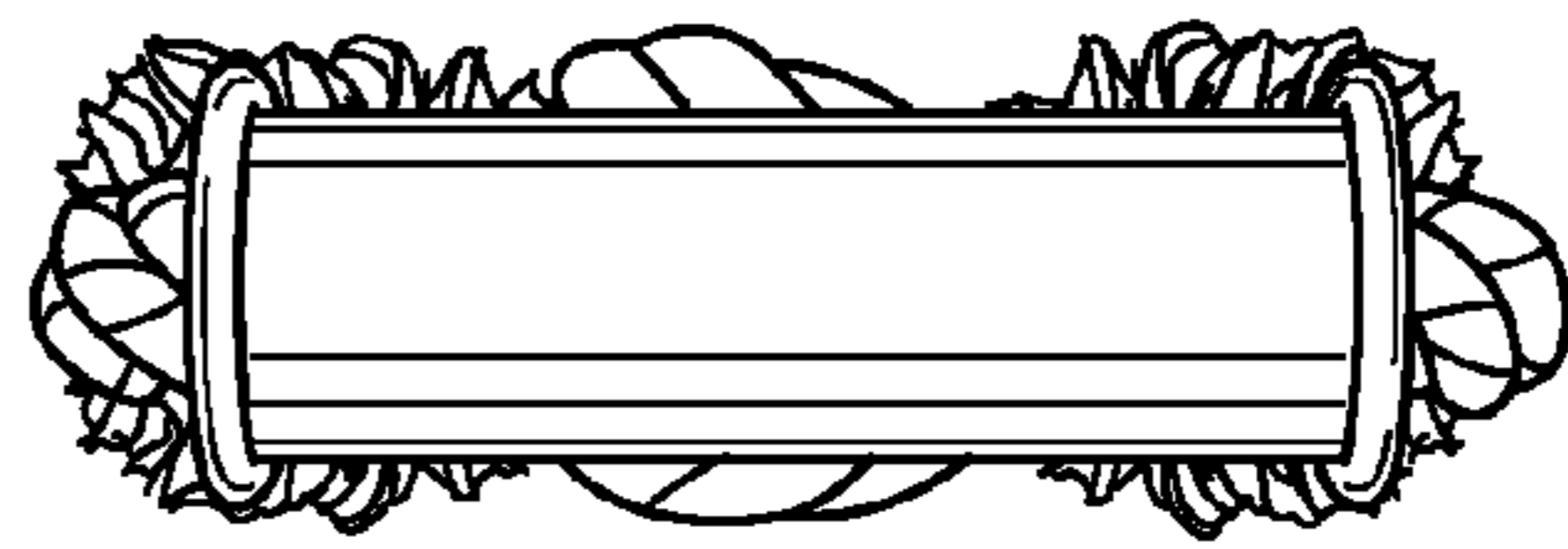

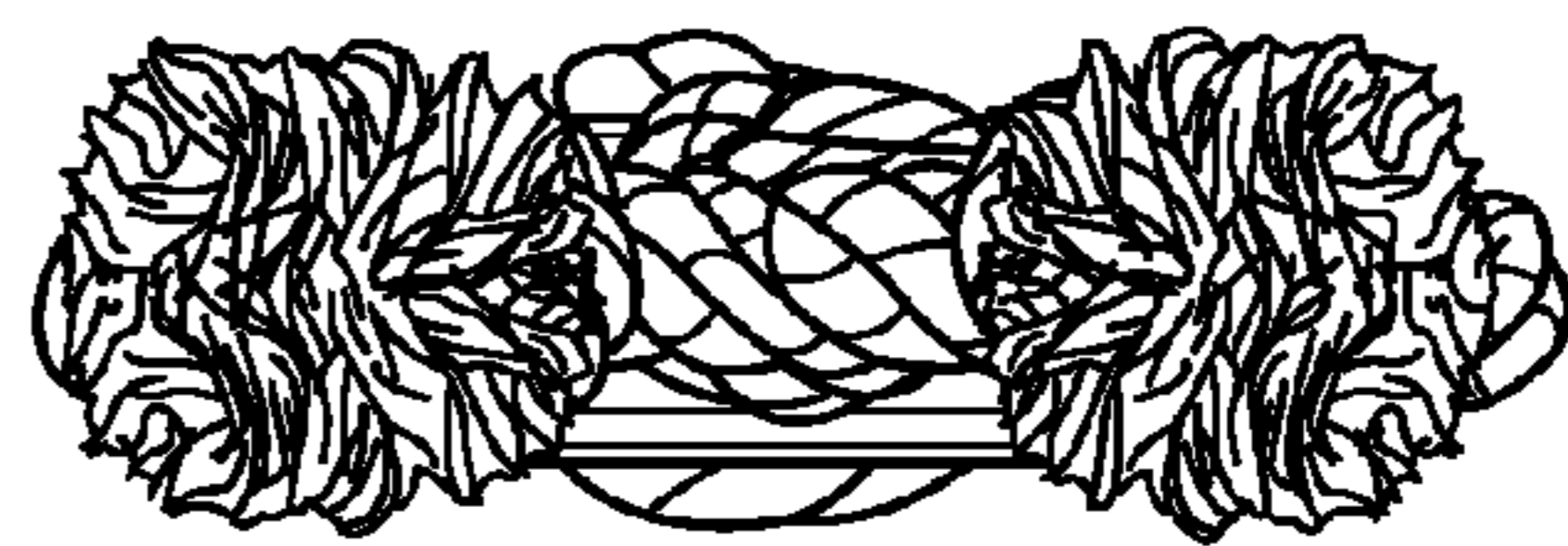
