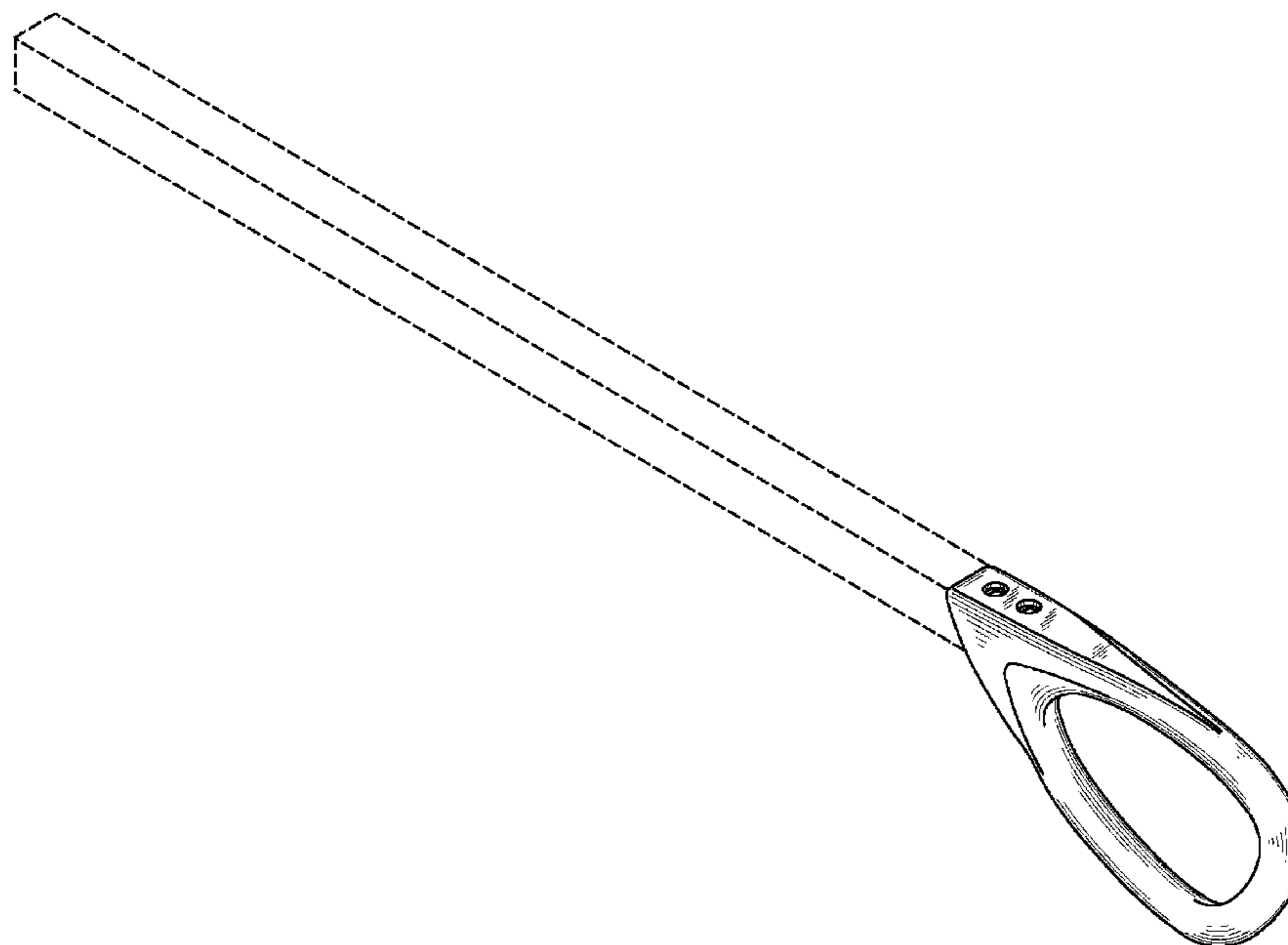
(57) **CLAIM**

The ornamental design for a loop grip handle for wheelbarrows, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of the loop grip handle for wheelbarrows;
FIG. 2 is a left side view of the loop grip handle for wheelbarrows;
FIG. 3 is a right side view of the loop grip handle for wheelbarrows;
FIG. 4 is a top view of the loop grip handle for wheelbarrows;
FIG. 5 is a bottom view of the loop grip handle for wheelbarrows;
FIG. 6 is a back side view of the loop grip handle for wheelbarrows; and,
FIG. 7 is a front side view of the loop grip handle for wheelbarrows.
The broken line of shown in FIG. 1 is included for the purpose of illustrating environment and forms no part of the claimed design.

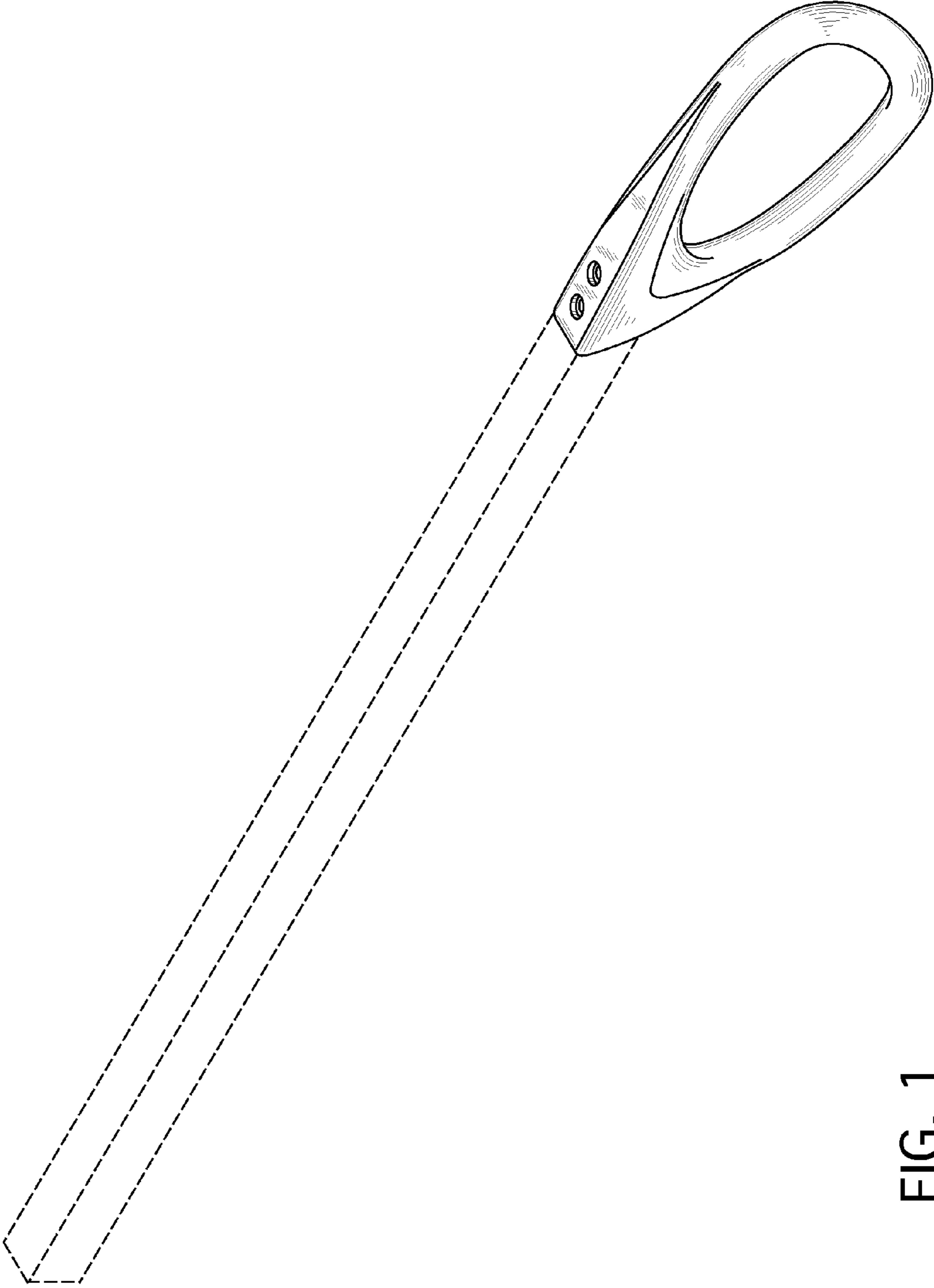

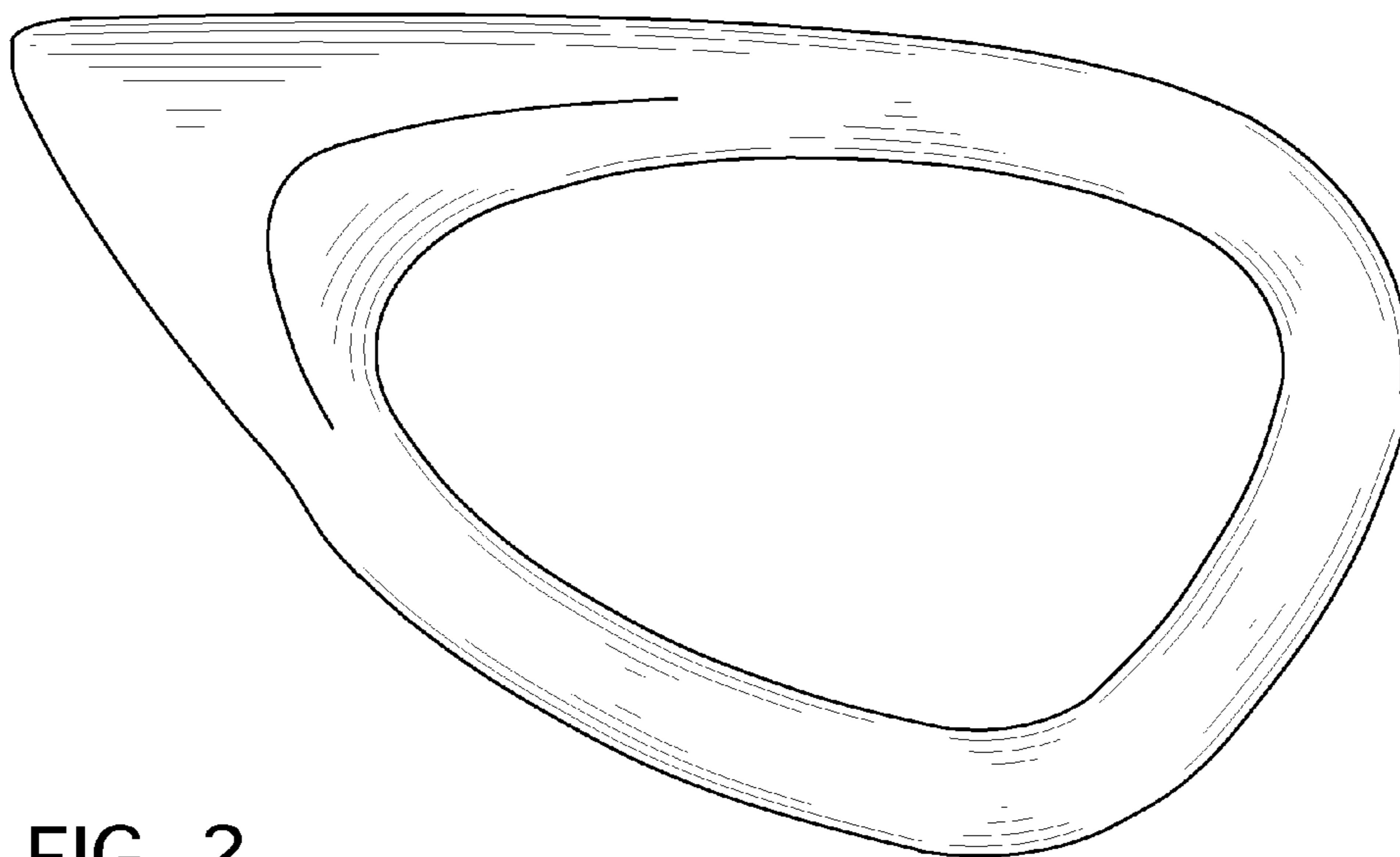

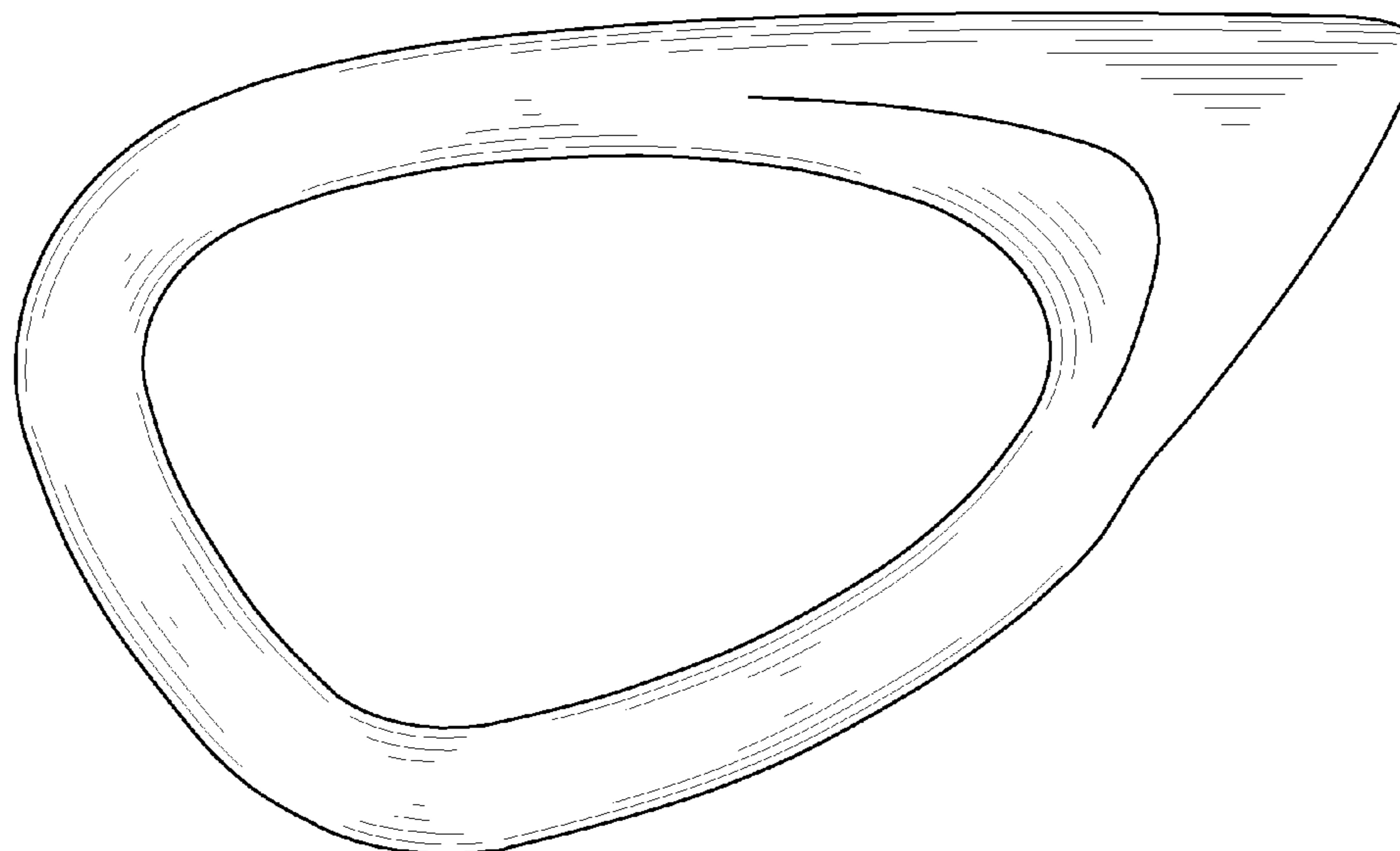

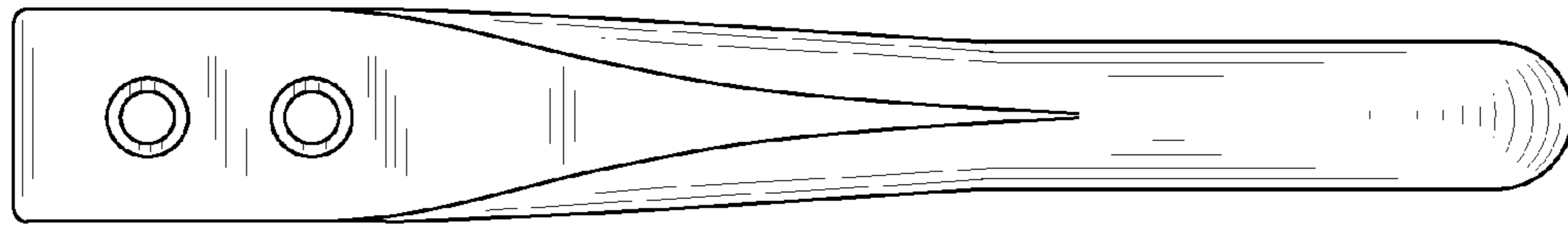

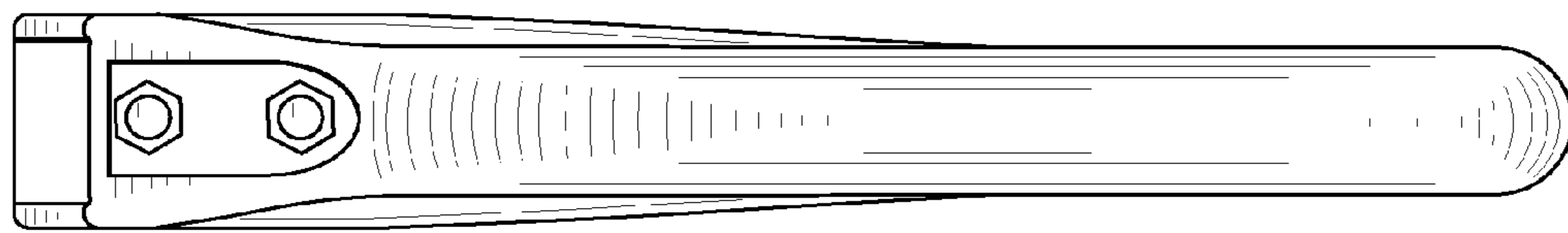

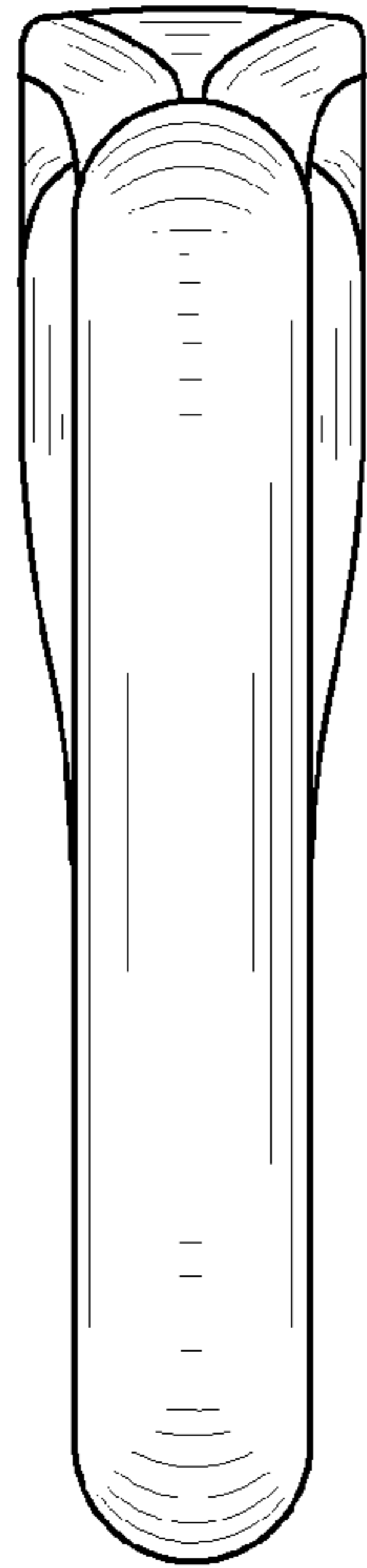

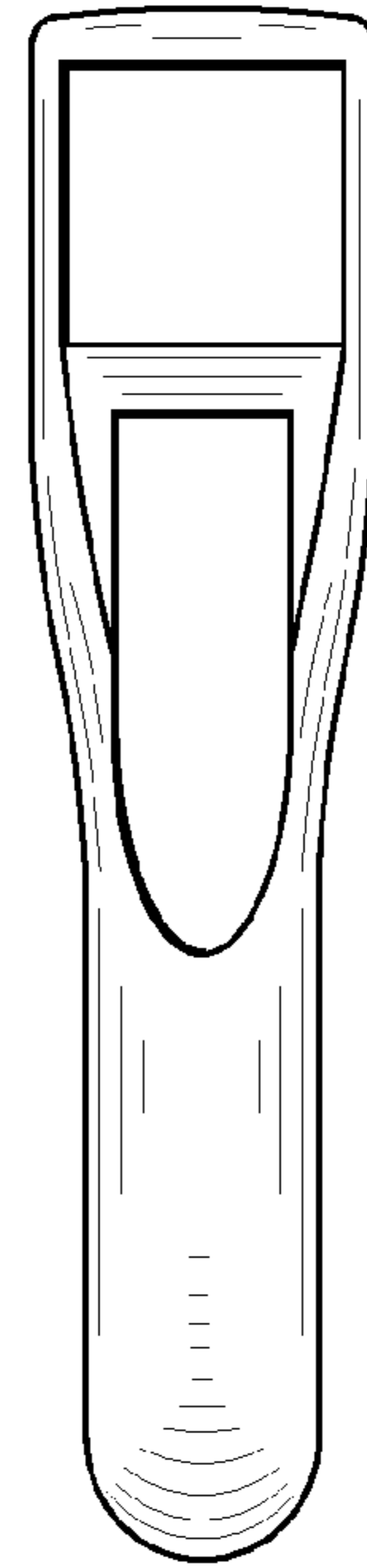
