DESCRIPTION

FIG. 1 is a front elevation view according to an embodiment of the present invention;

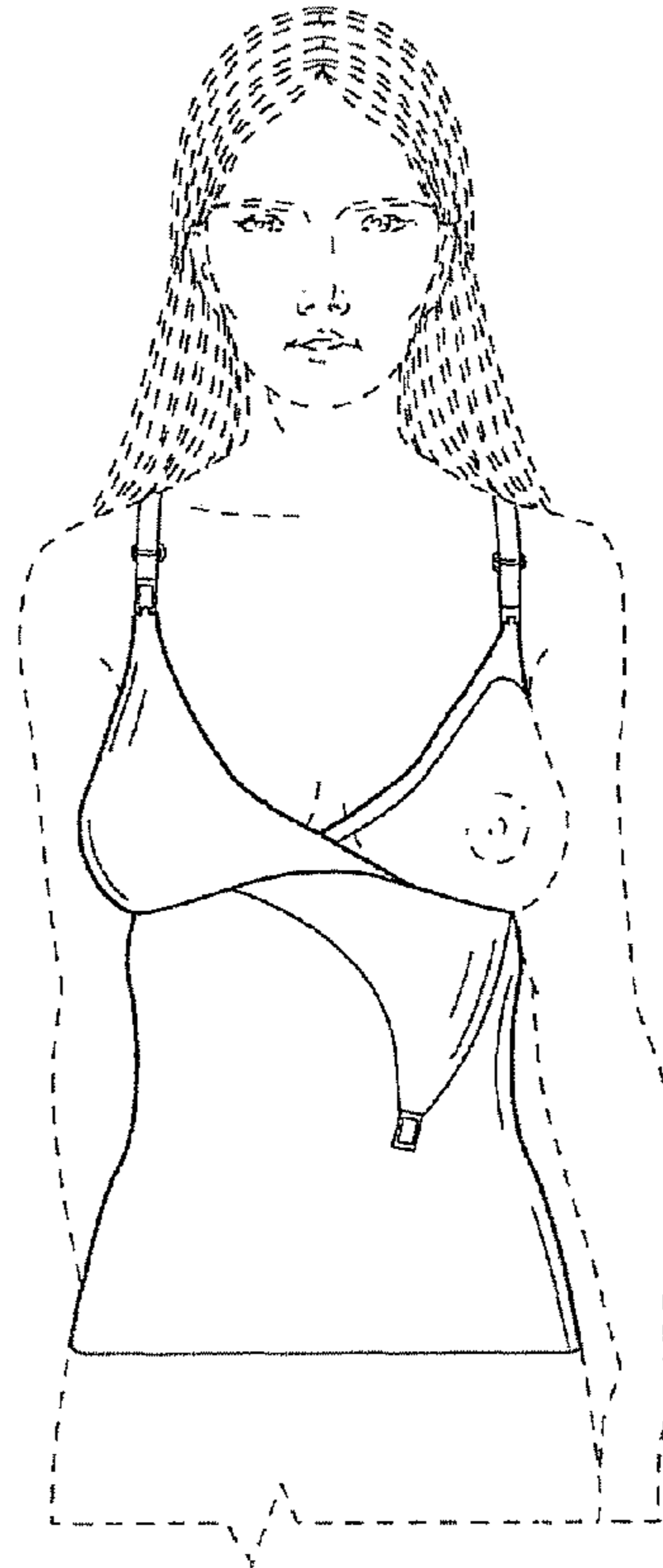
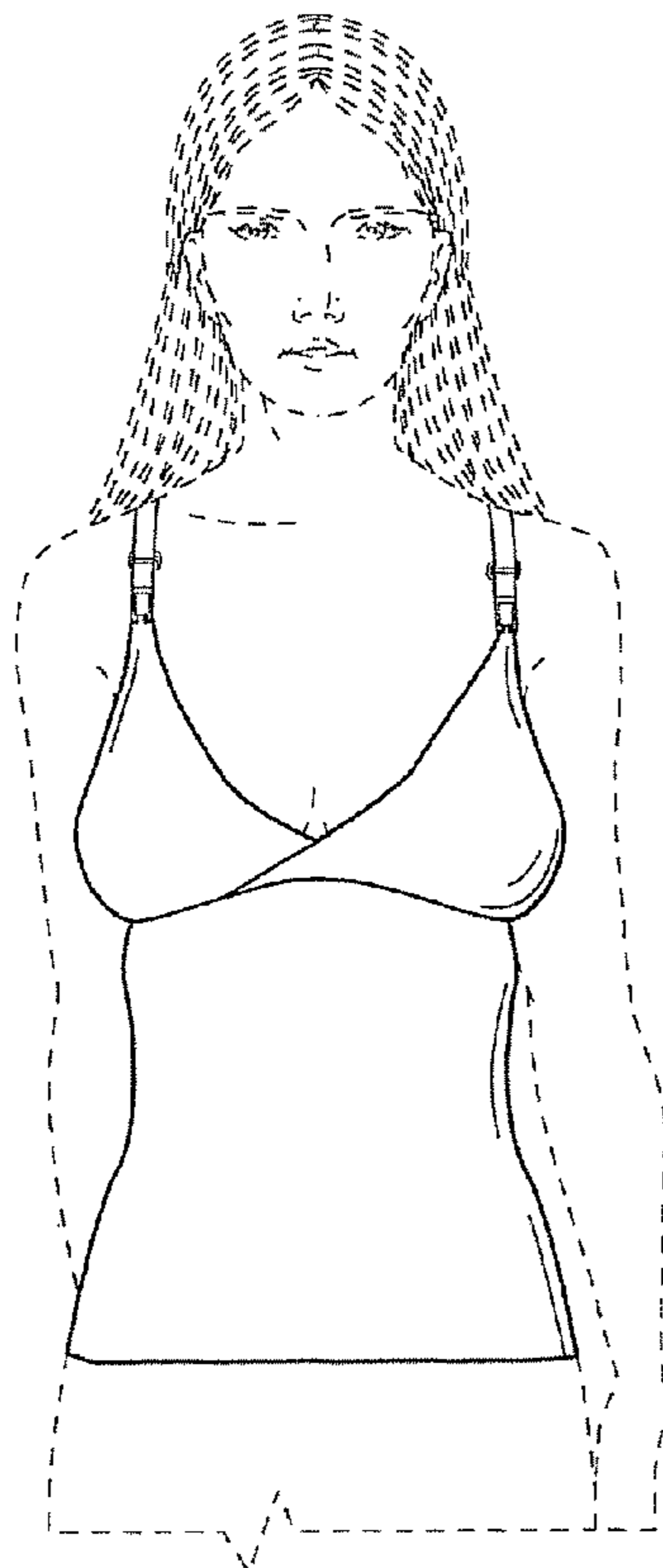
FIG. 2 is a front elevation view thereof, with one side of the nursing bra shown in an open position;

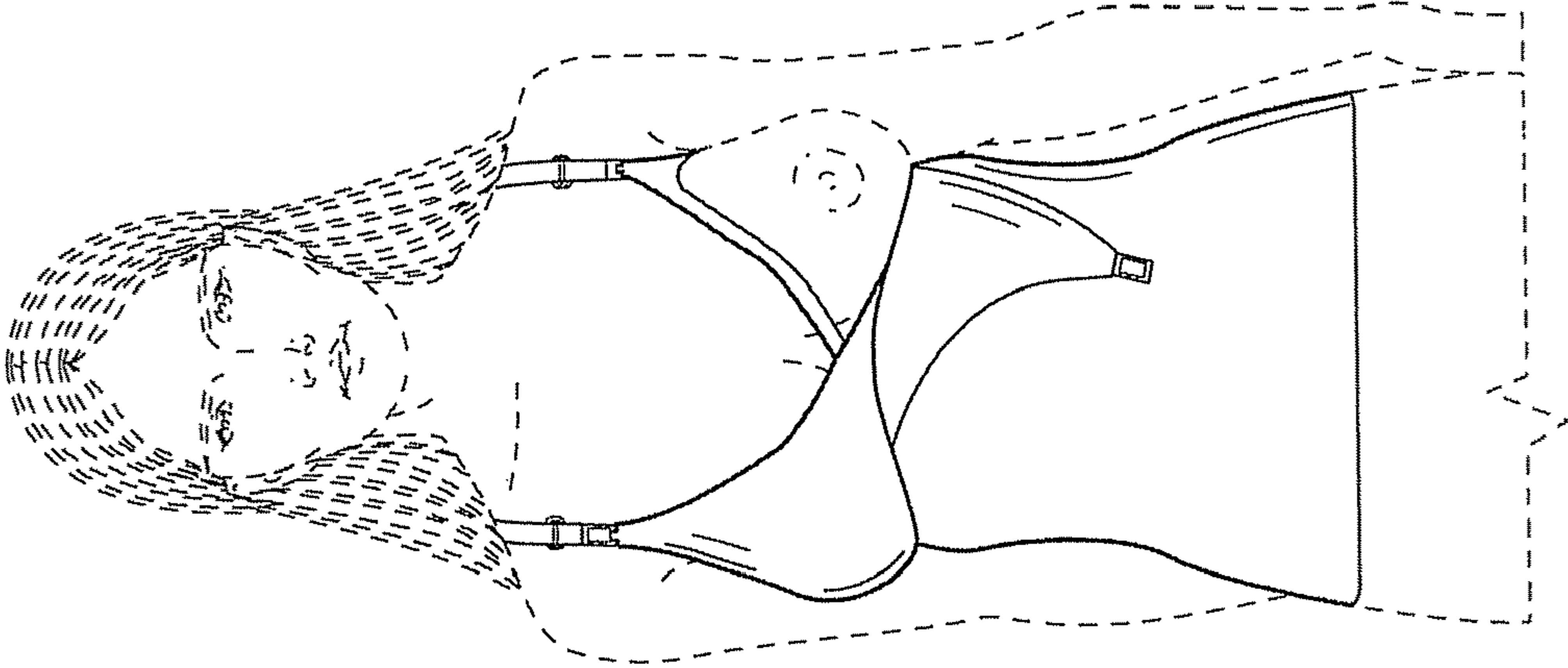

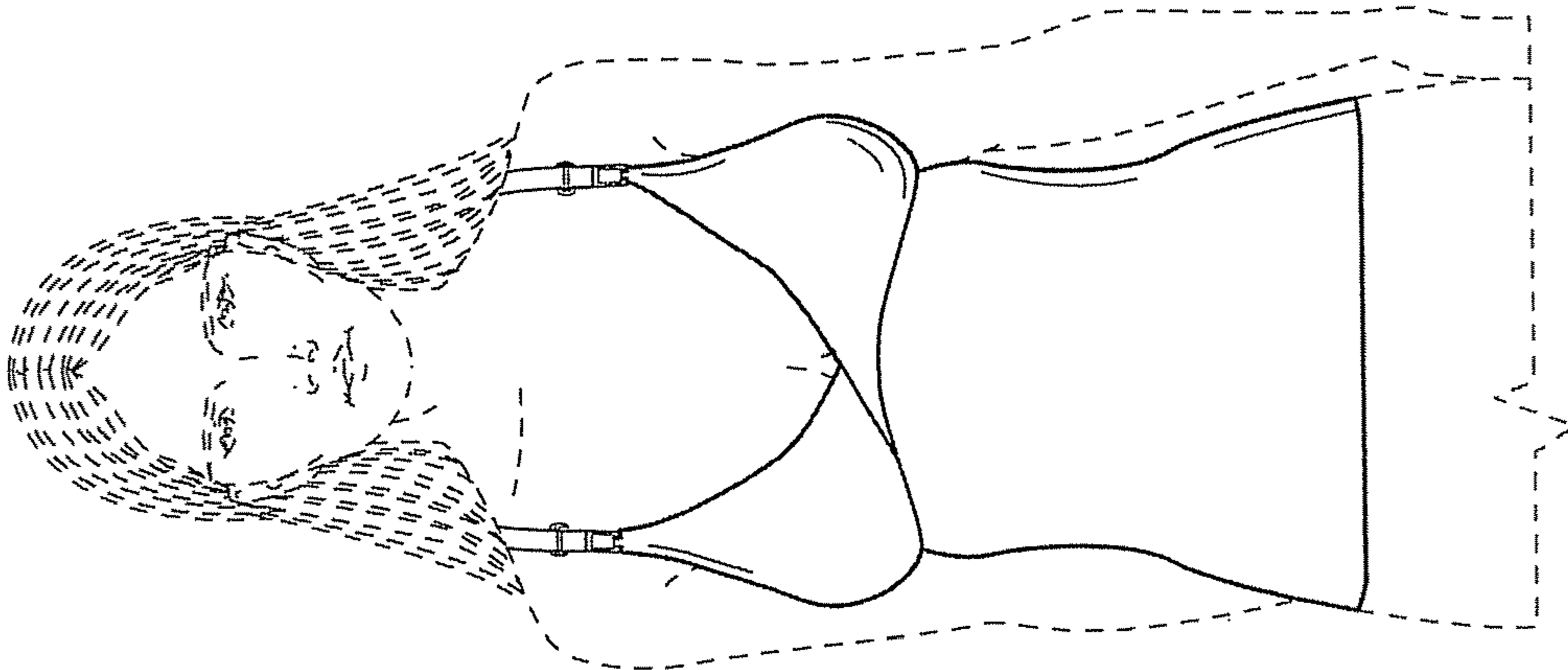

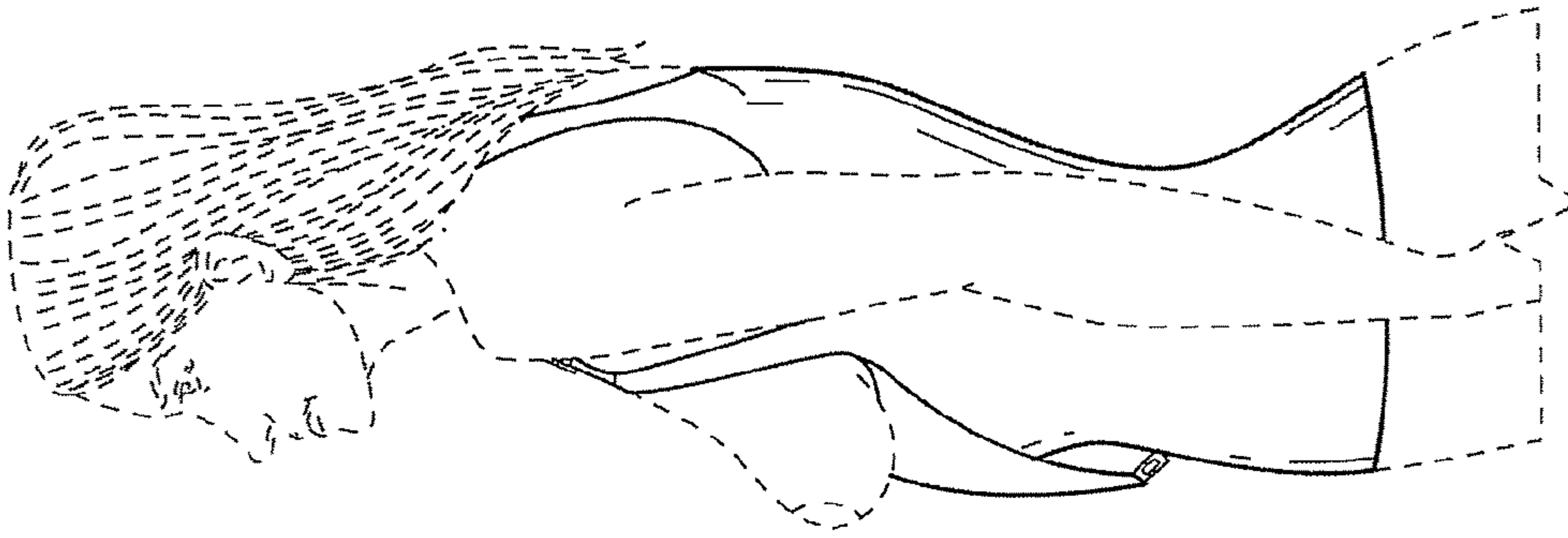

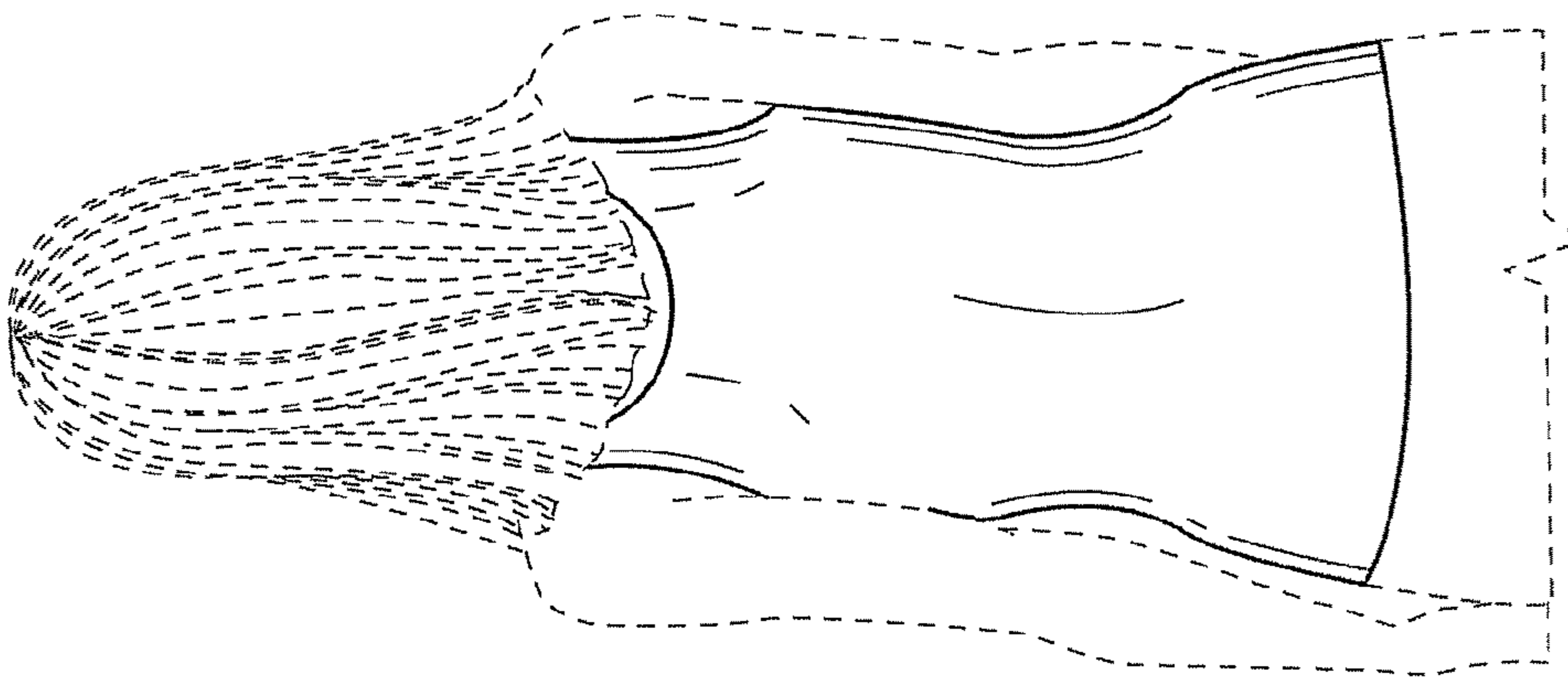
