(57) **CLAIM**

I claim the ornamental design for underpants, as shown and described.

DESCRIPTION

FIG. 1 is a front and right side perspective view of an underpants in accordance with an embodiment of my new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side view of the underpants, a right side view being a mirror image thereof; FIG. 5 is a top plan view thereof; and, FIG. 6 is bottom plan view thereof.

In the aforementioned figures, the leg cuffs are shown in broken lines in order to better depict that they are made of lace; the leg cuffs form part of the claimed design. The stippling represents fabric texture, and while shown intermittently is understood to extend uniformly across the entire surface of the design upon which it is applied.

For clarity of illustration and to aid understanding of the design, environmental features (namely the waistband and the two rear seams) are shown in broken lines and form no part of the claimed design.

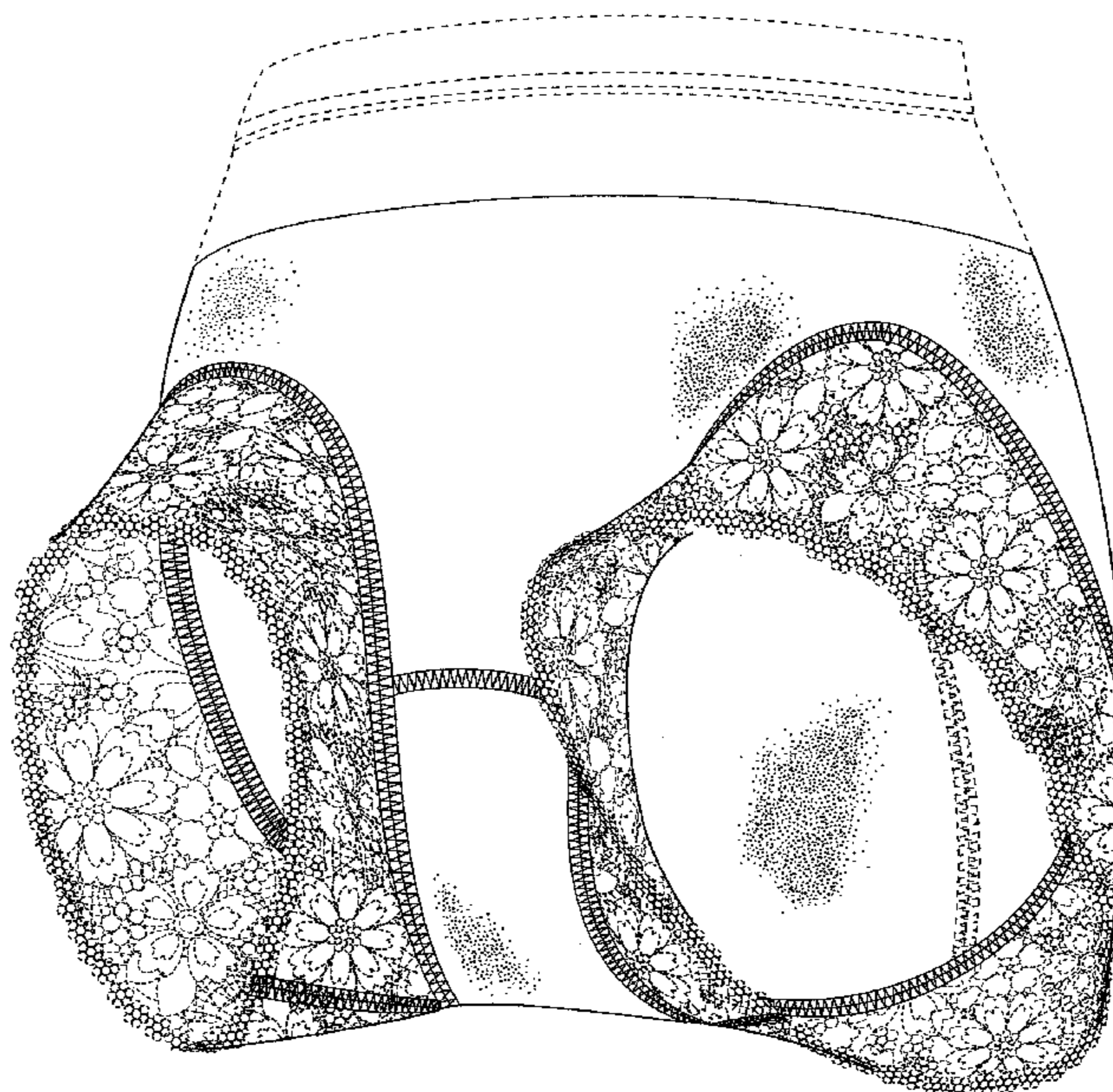

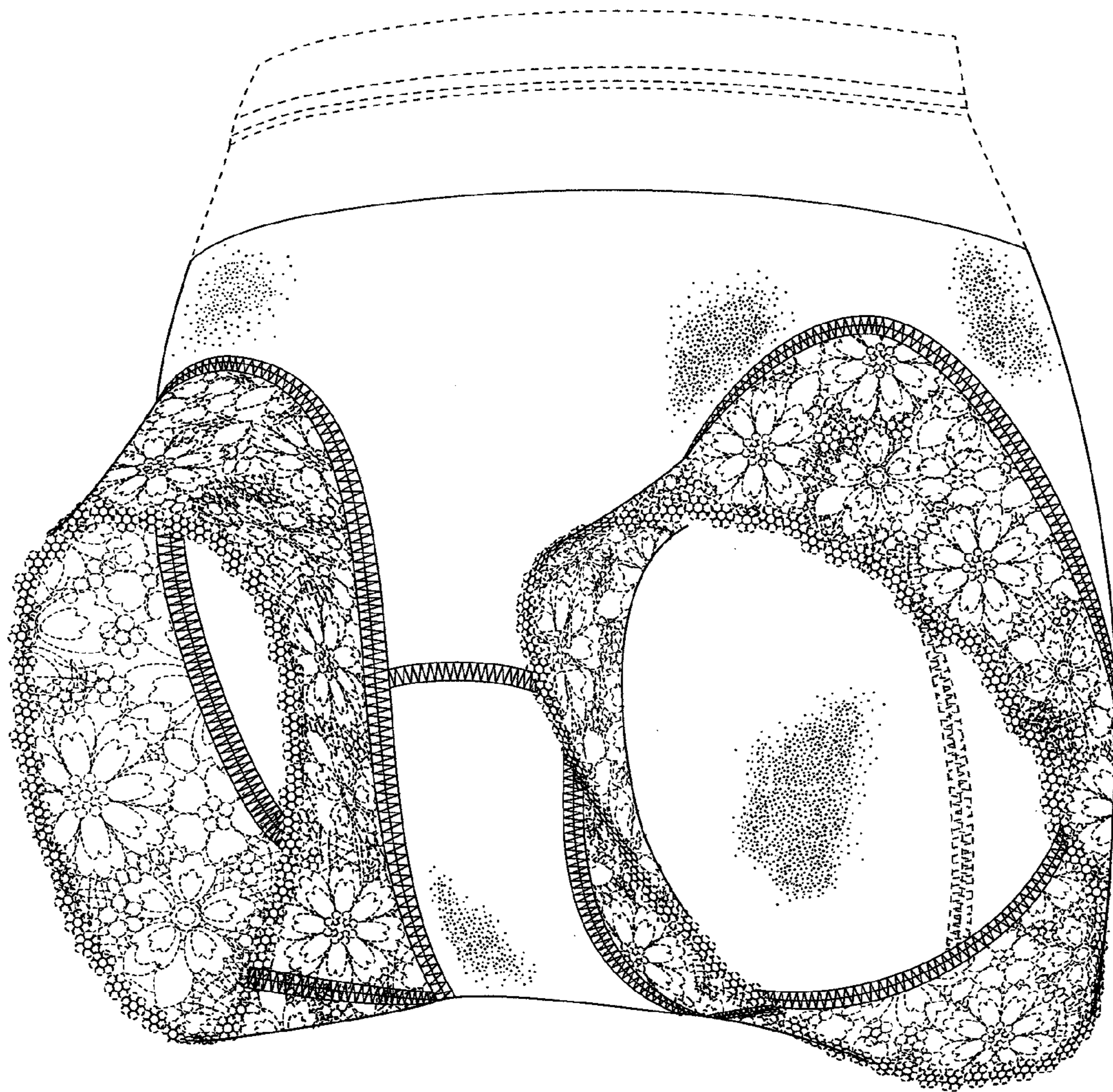

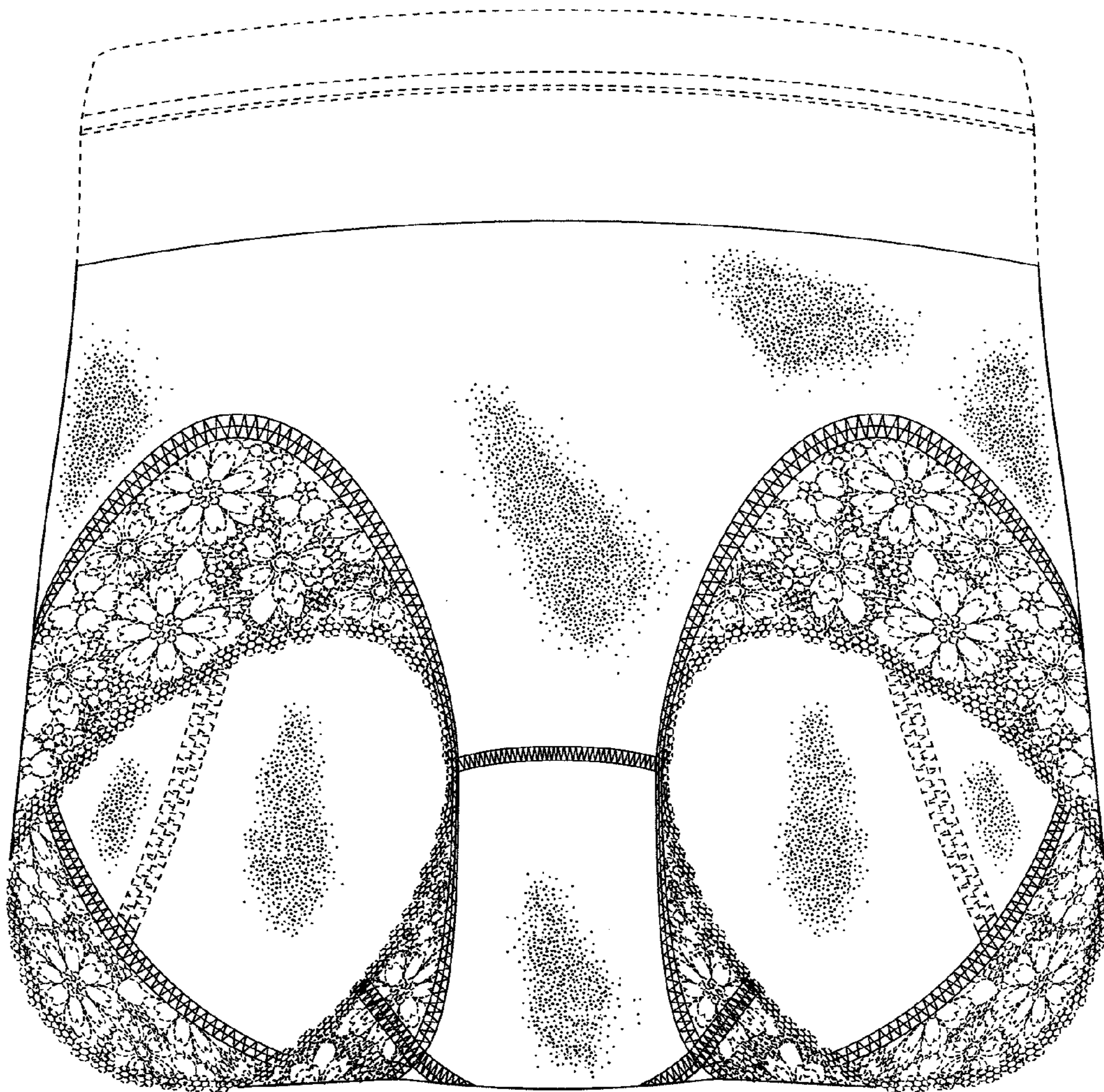

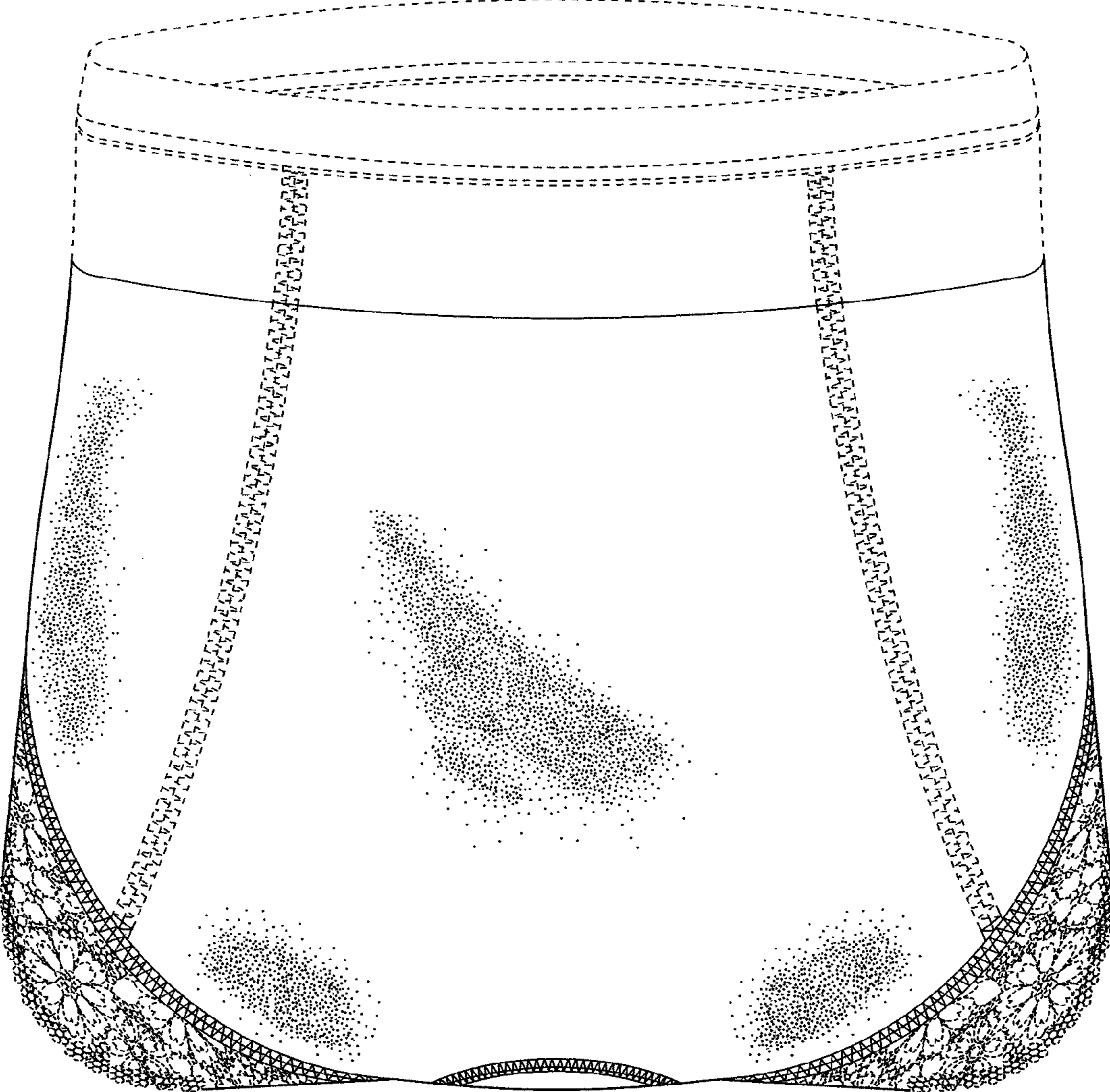

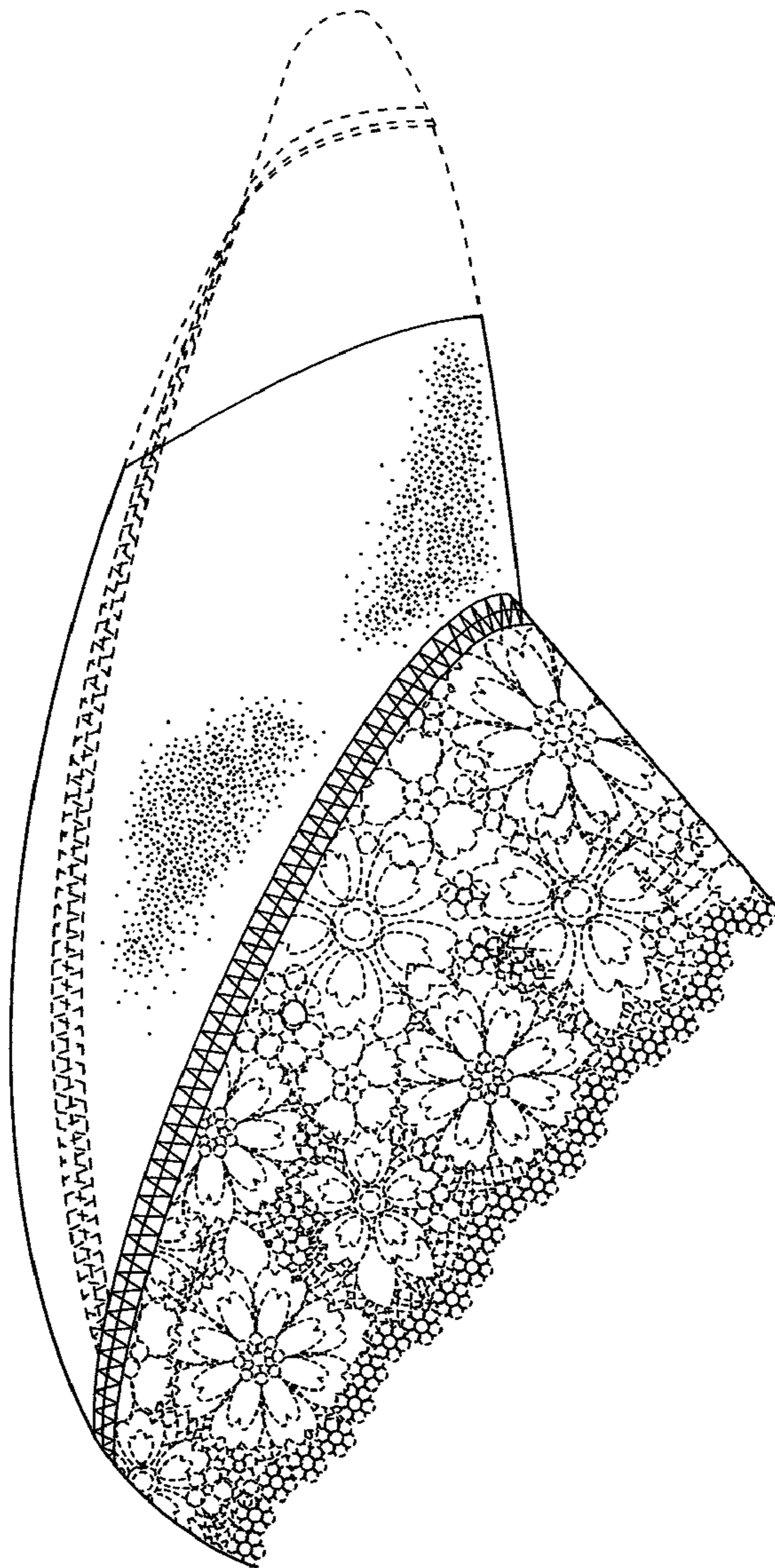

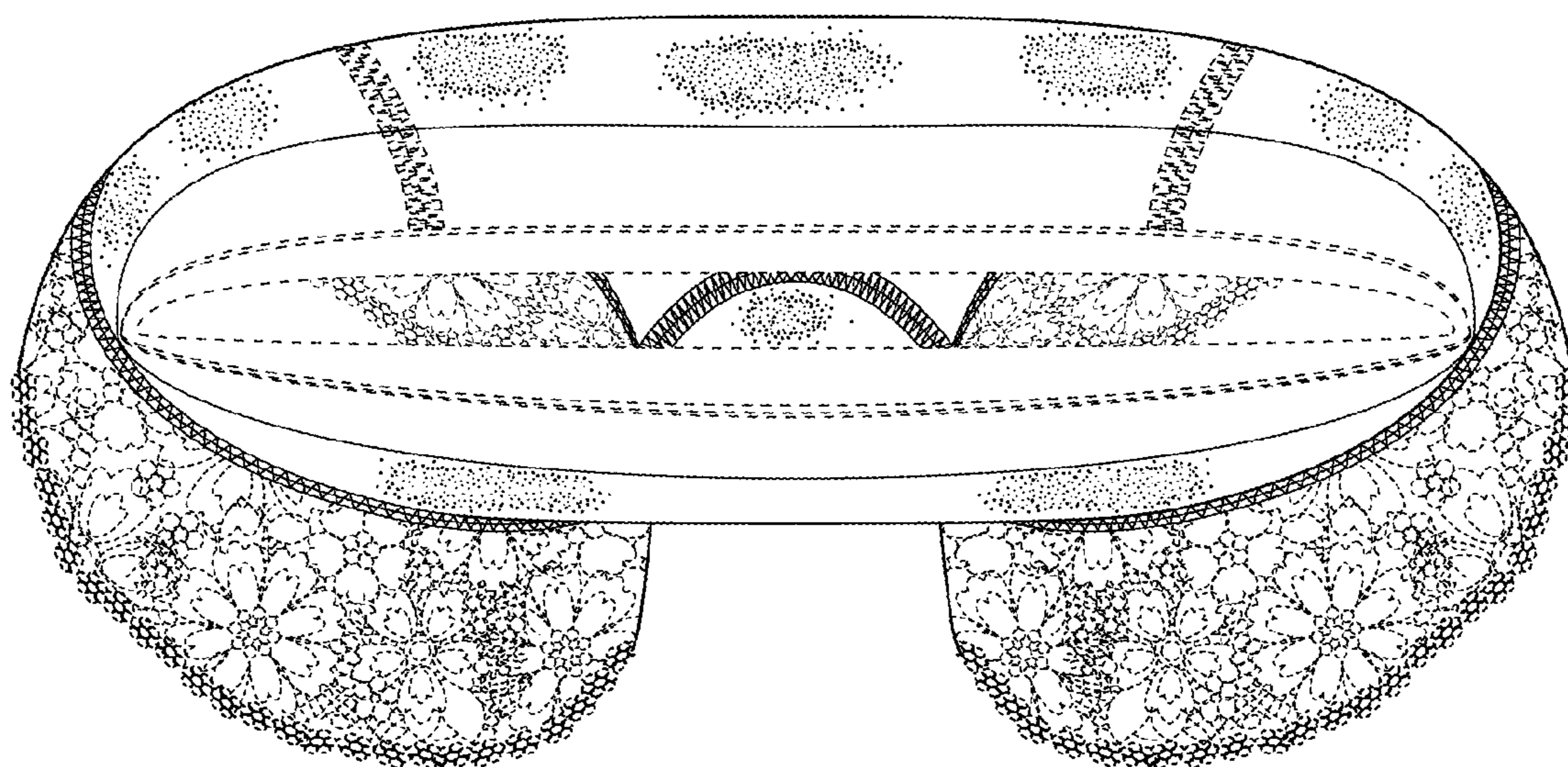
