(57) **CLAIM**

The ornamental design for a garment, as shown and described.

DESCRIPTION

The FIGURE is a front view of a garment shown with a circle-shaped, colored, semi-transparent center surrounded by a black mesh, see-through periphery, which is surrounded by a solid black border, with a logo located inside and near the center.

The hatched markings show garment material in the FIGURE, are included for the purpose of illustrating environmental structure, and form no part of the claimed design. The evenly-spaced dash line along the perimeter of the FIGURE is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

The drawing is lined for the color black. The patterned portions shown a portion of the circle-shaped, colored, semi-transparent center of the FIGURE illustrate the design that is not limited to any color, color contrast or color combination, where the color extends across the entire circle-shaped, colored, semi-transparent center, and forms a part of the claimed design.
