FIG. 7 is a back view of the footwear illustrated in FIG. 1.

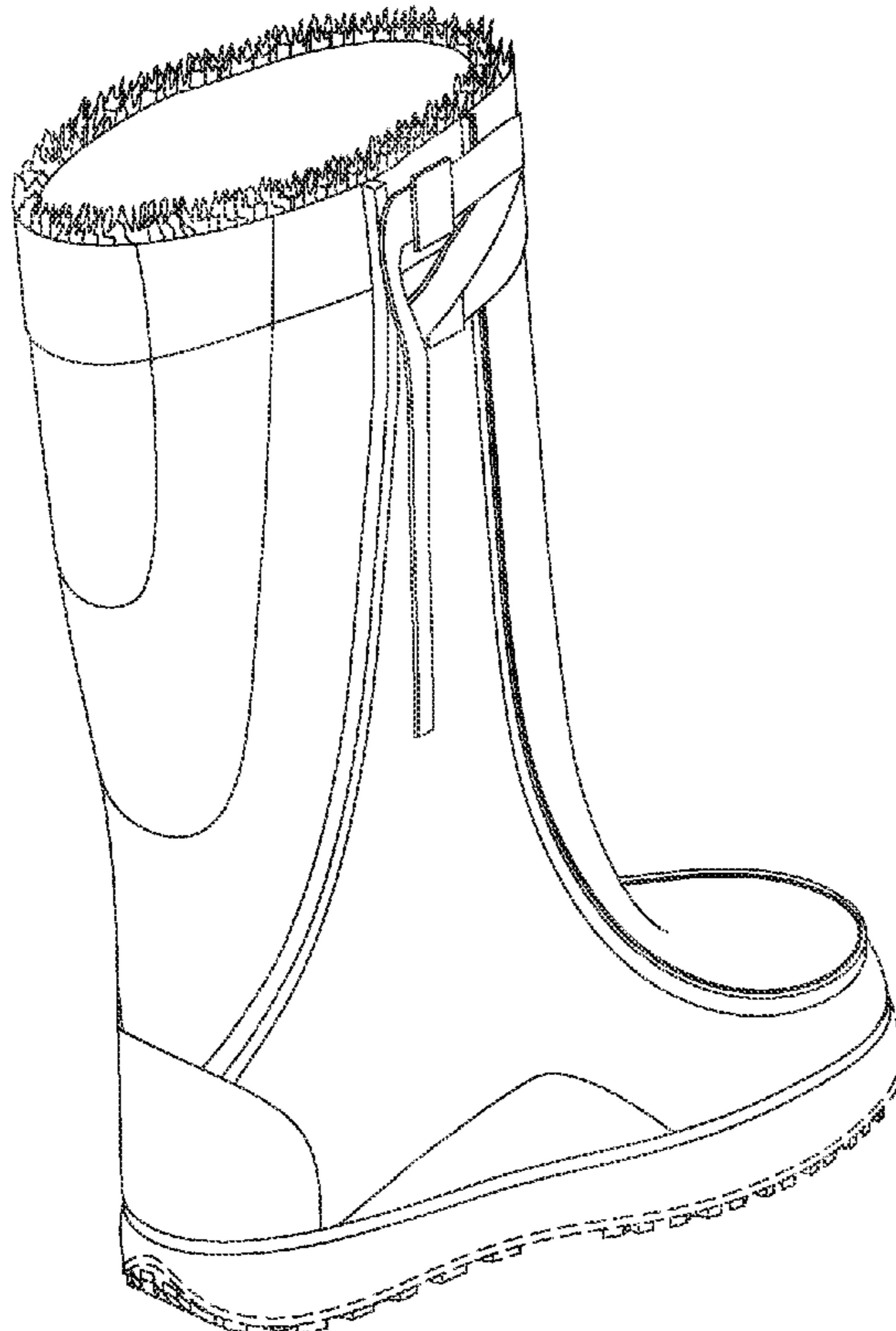

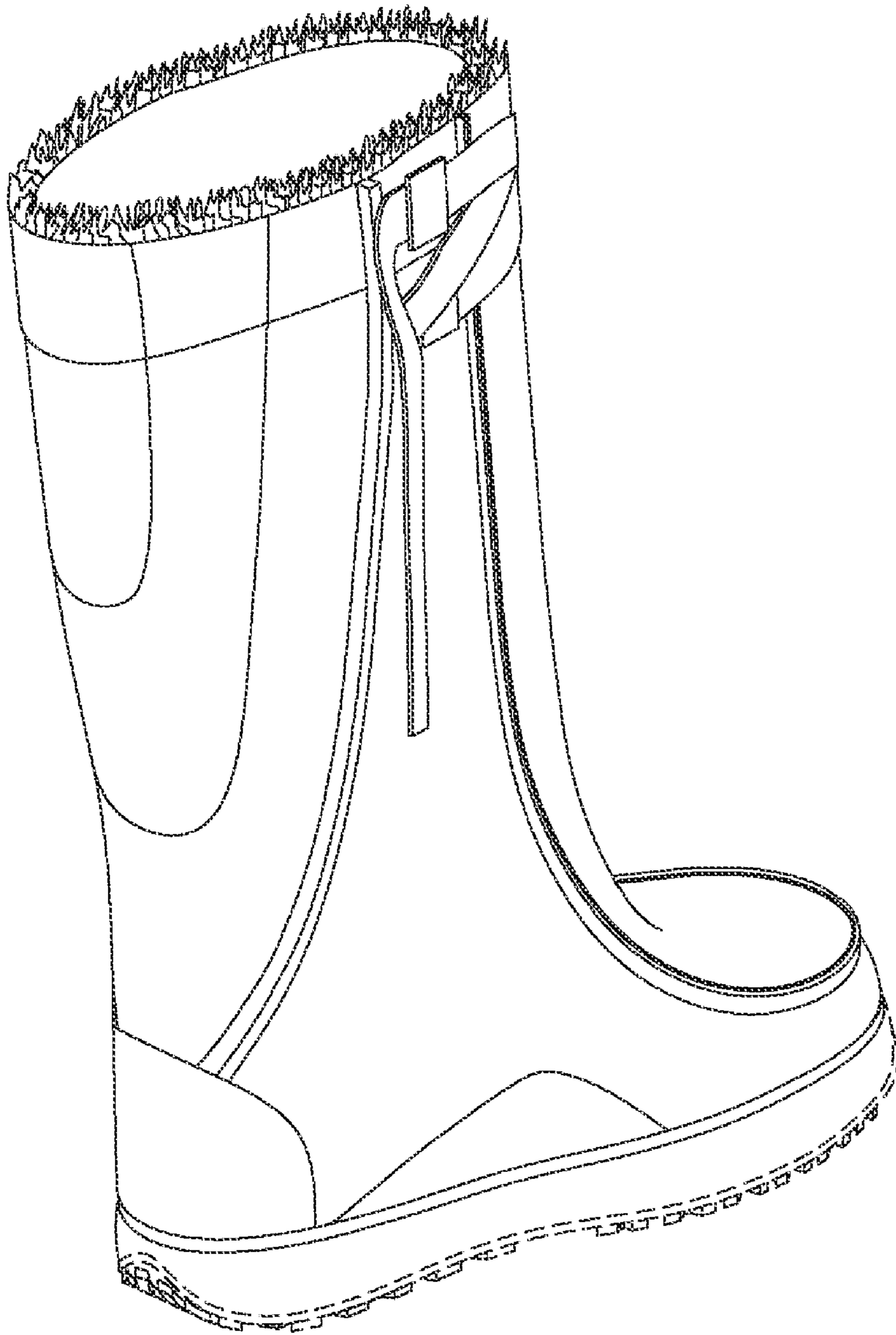

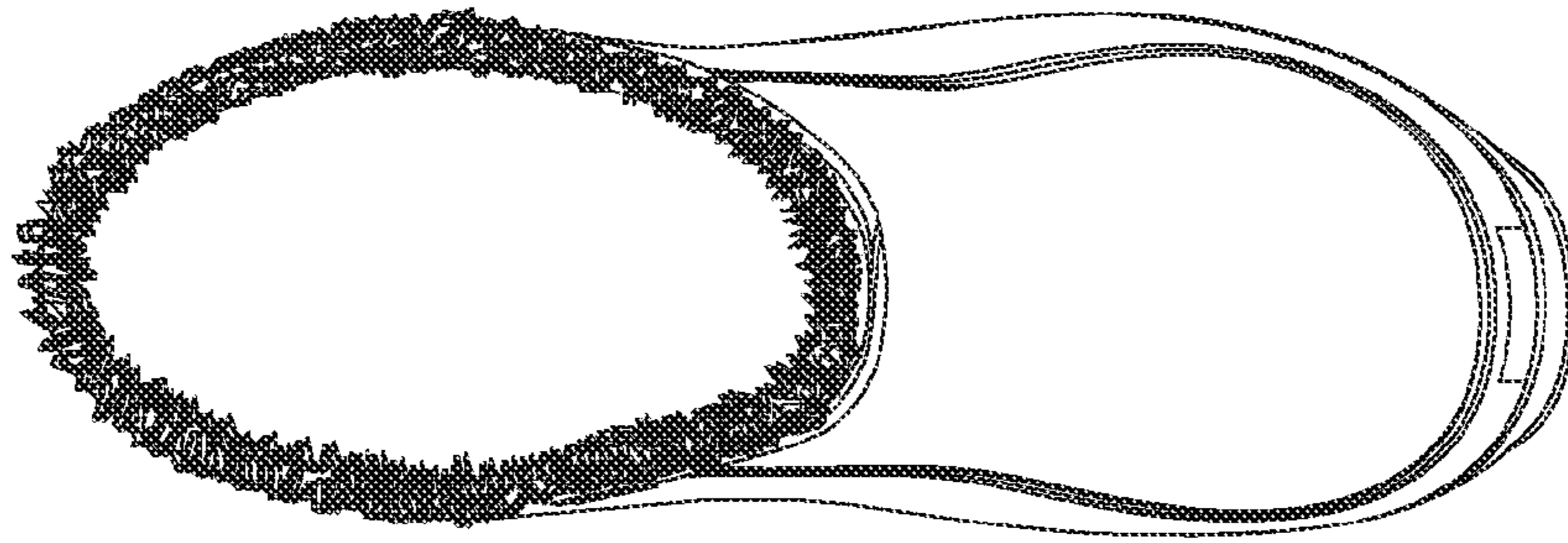

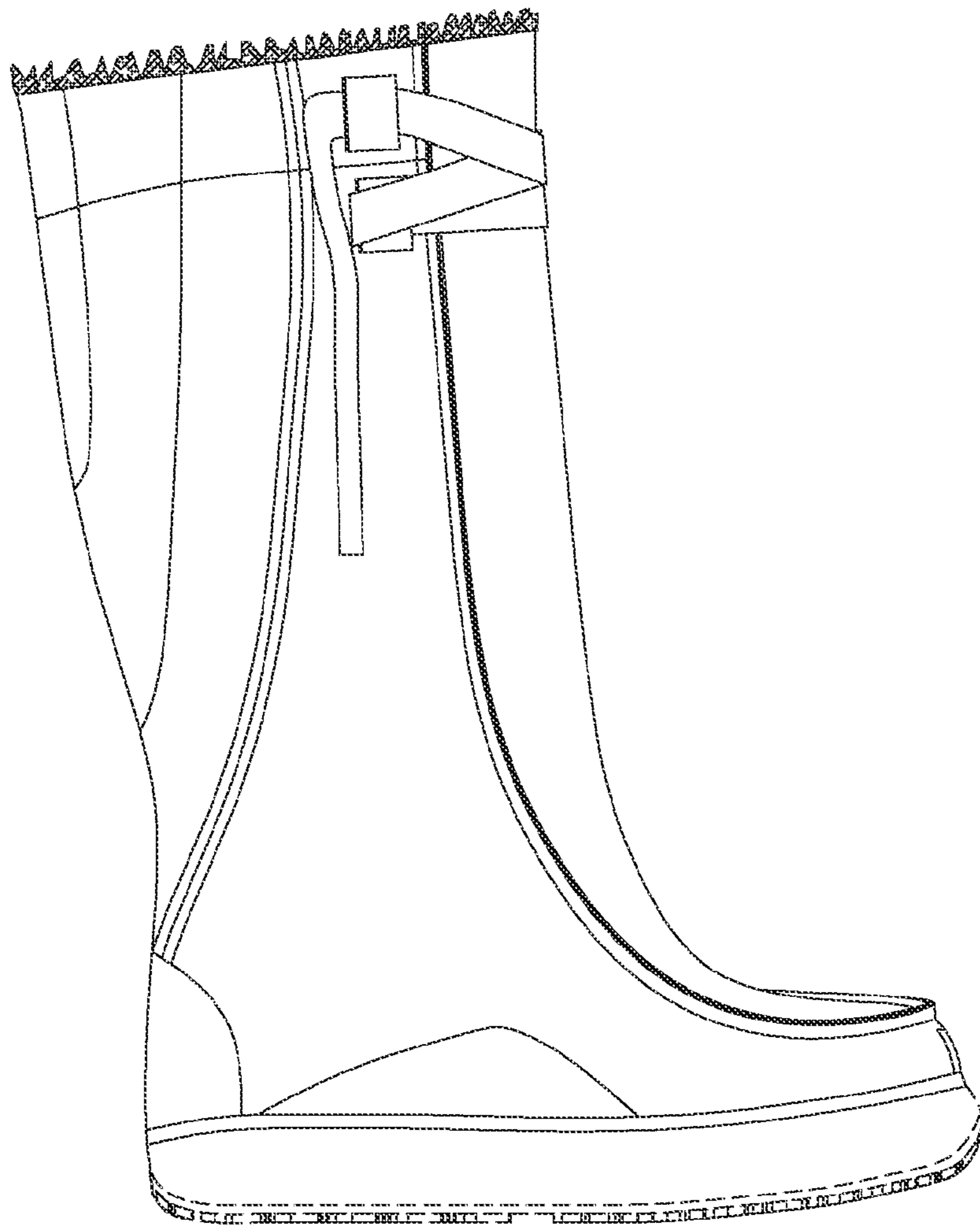

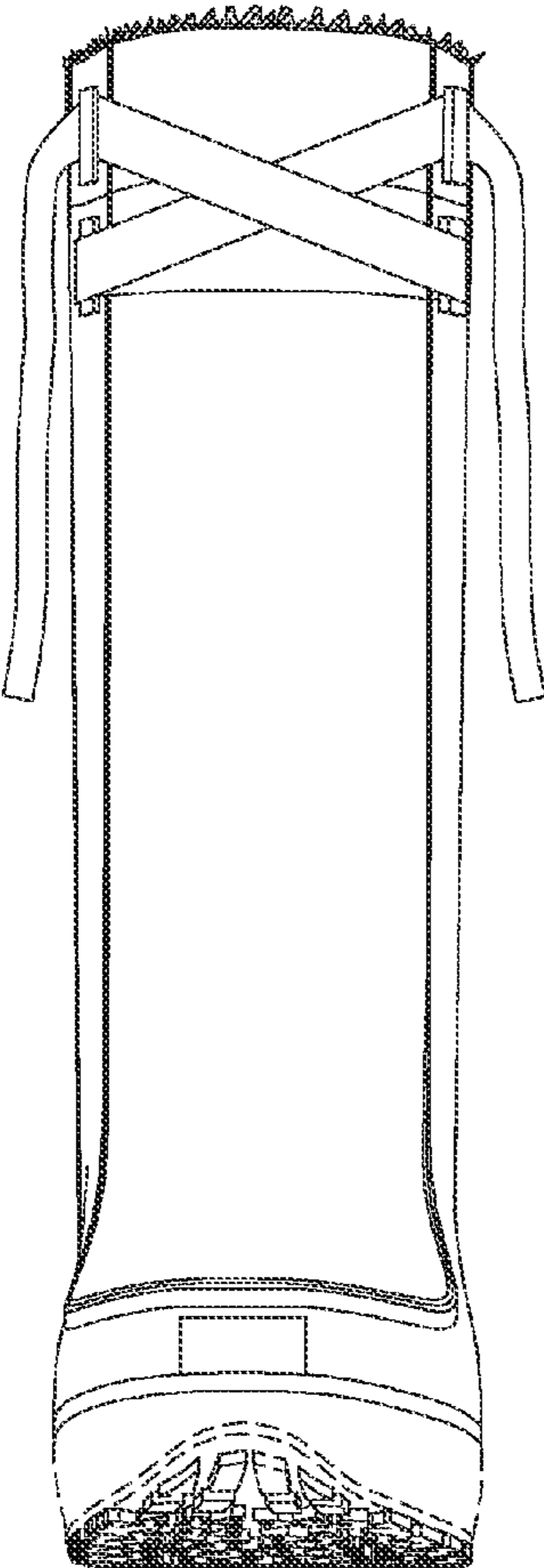
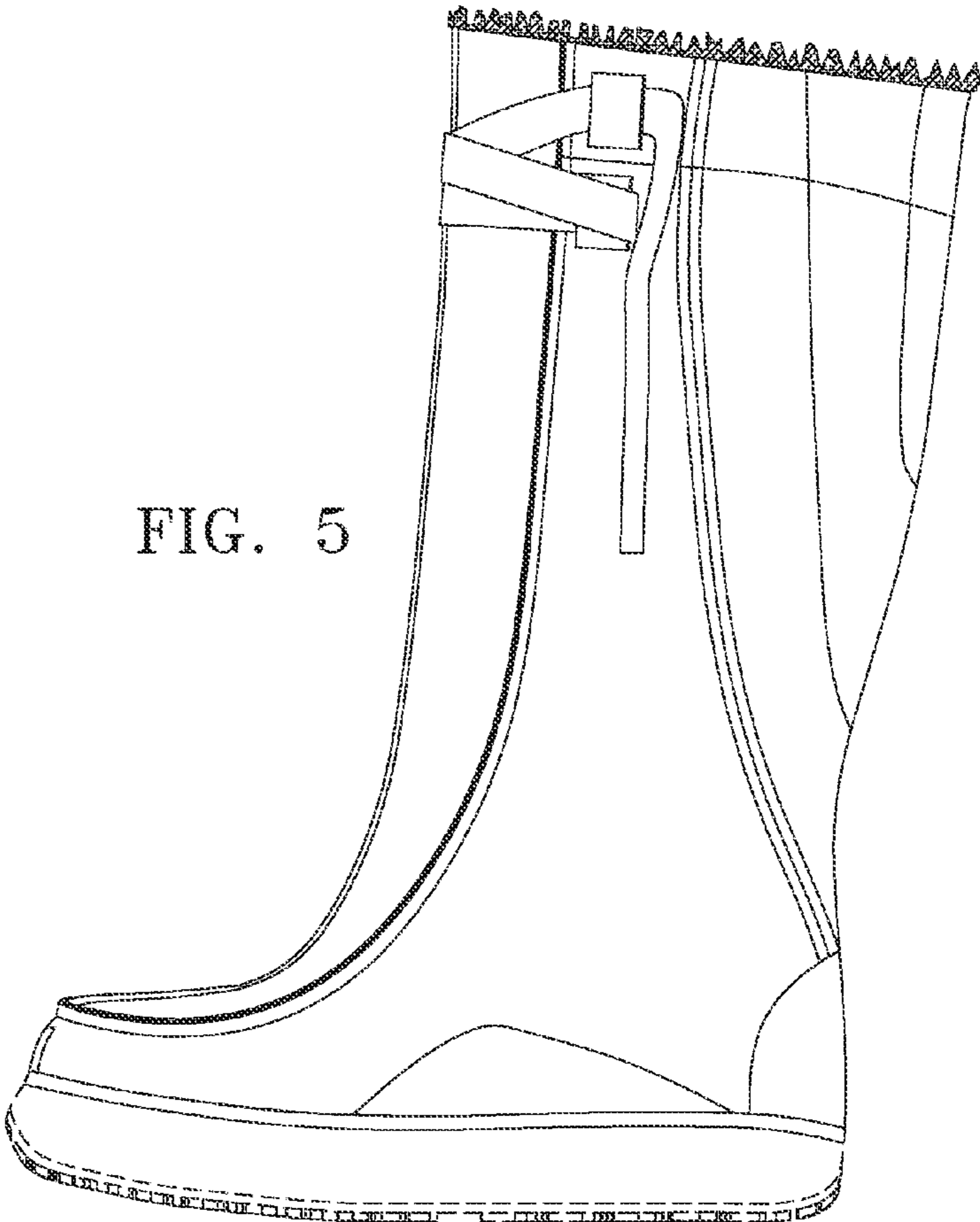

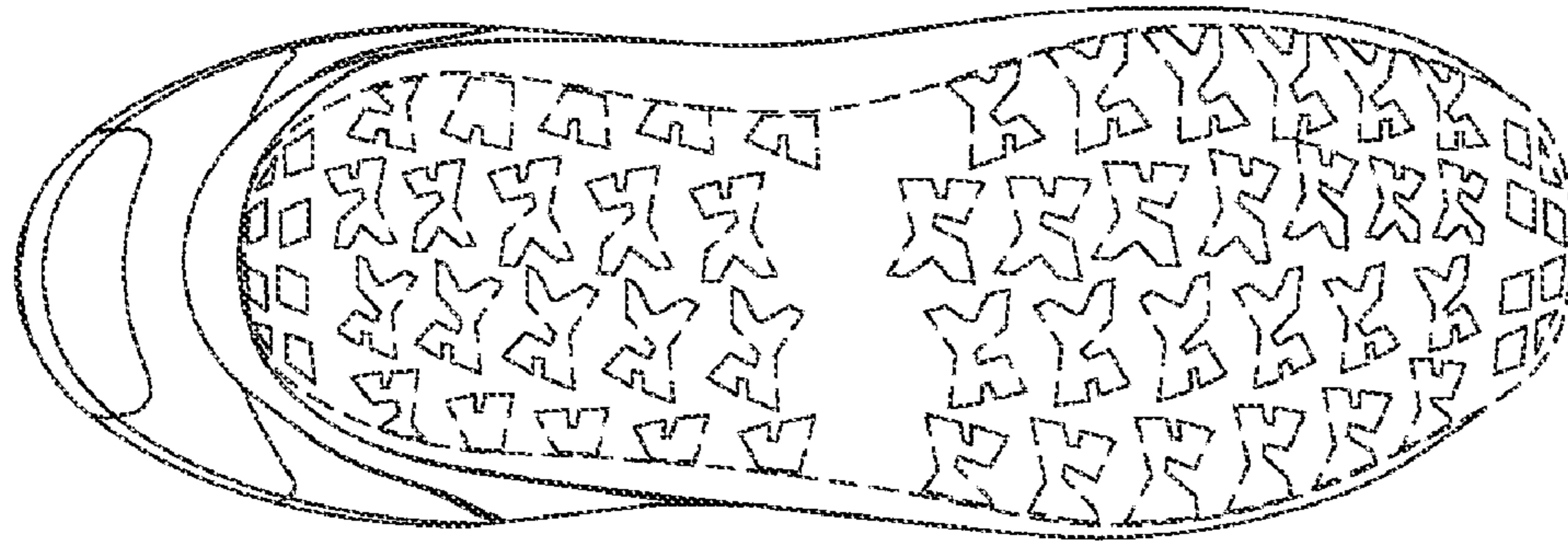

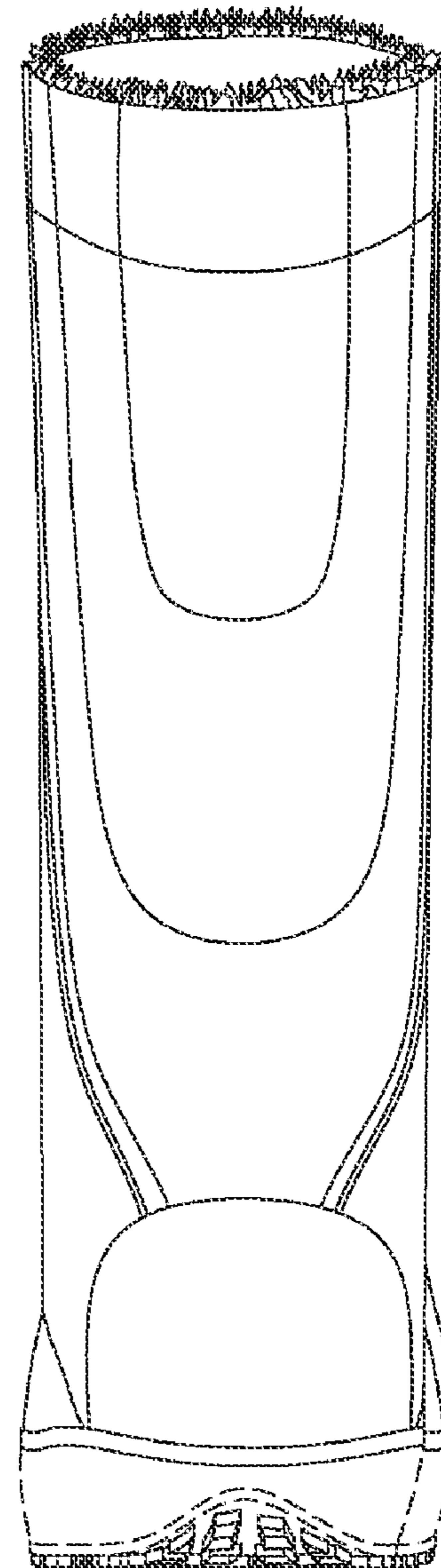
