(57) **CLAIM**

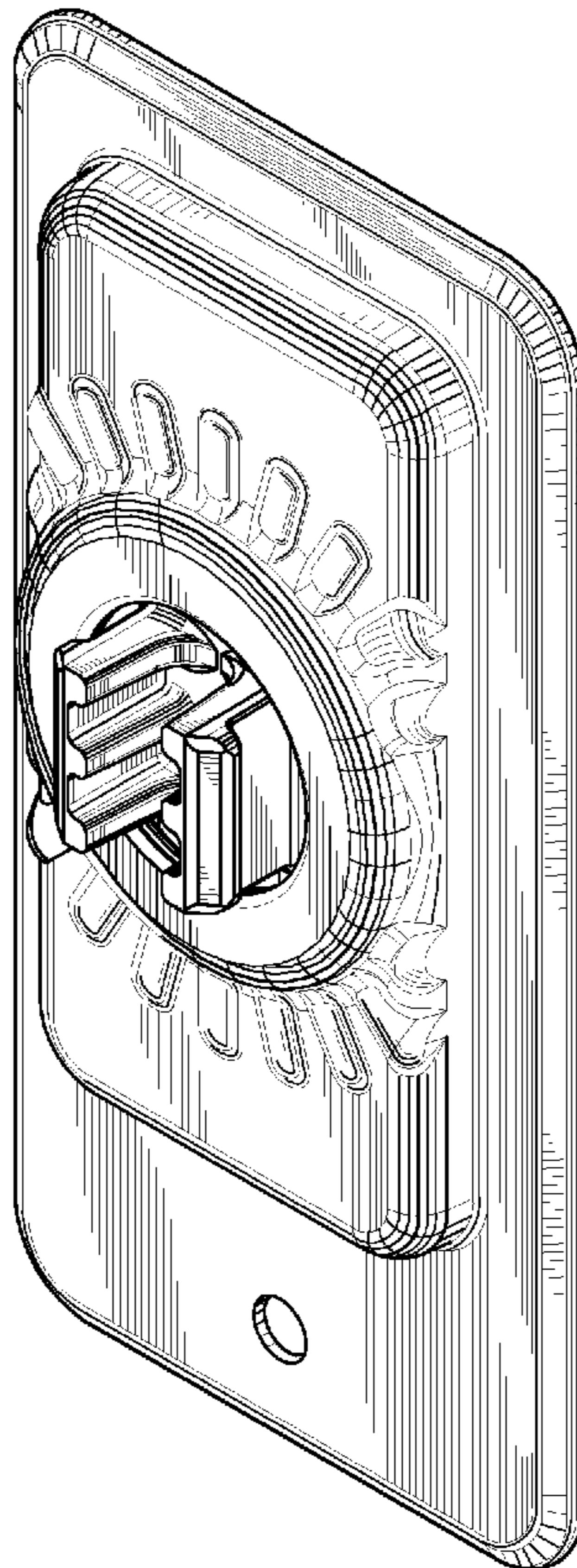
We claim the ornamental design for a stitch plate for a clip, as shown and described.

DESCRIPTION

FIG. 1 is a back perspective view of a stitch plate for a clip;
FIG. 2 is a front perspective view of the stitch plate;
FIG. 3 is a back plan view thereof;
FIG. 4 is a front plan view thereof;
FIG. 5 is a left elevational view thereof;
FIG. 6 is a right elevational view thereof;
FIG. 7 is a top plan view thereof;
FIG. 8 is a bottom plan view thereof; and,
FIG. 9 is another back perspective view of the stitch plate
attached at one side to a clip and at the other side to a holster
for a handheld electronic device.

The broken lines shown in the drawings of the stitch plate for
a clip are for the purpose of illustrating portions of the article
and form no part of the claimed design.

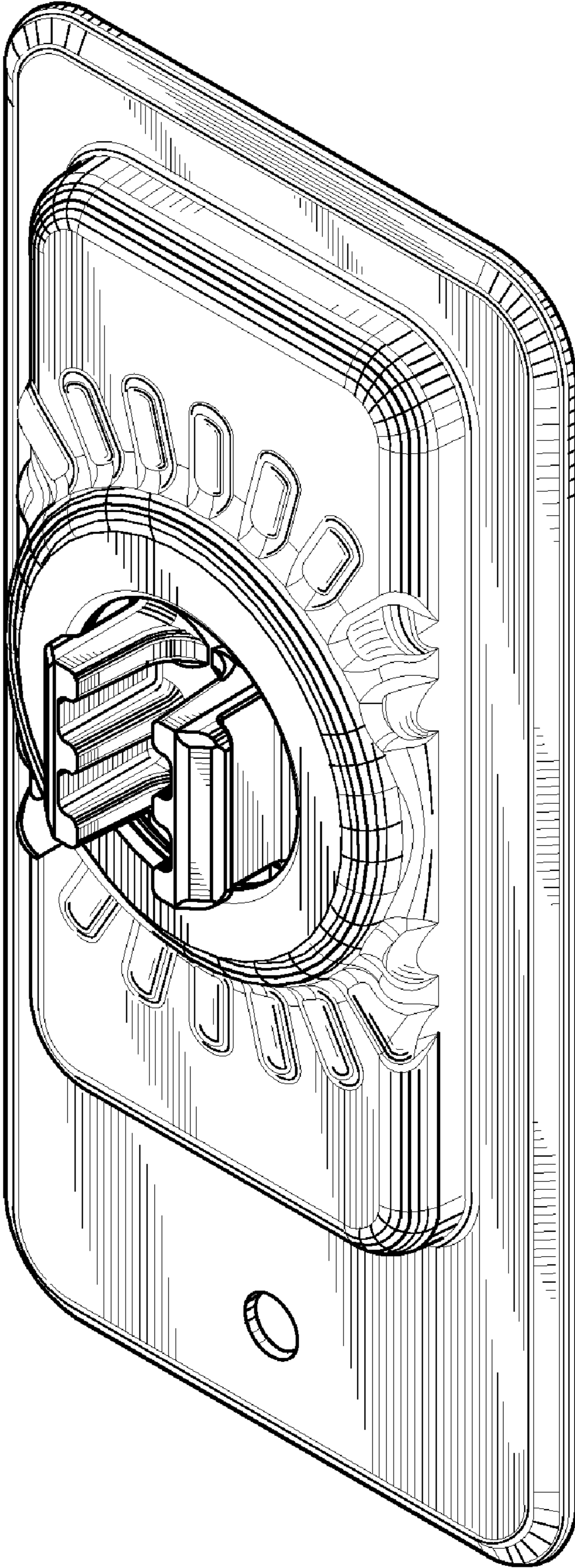

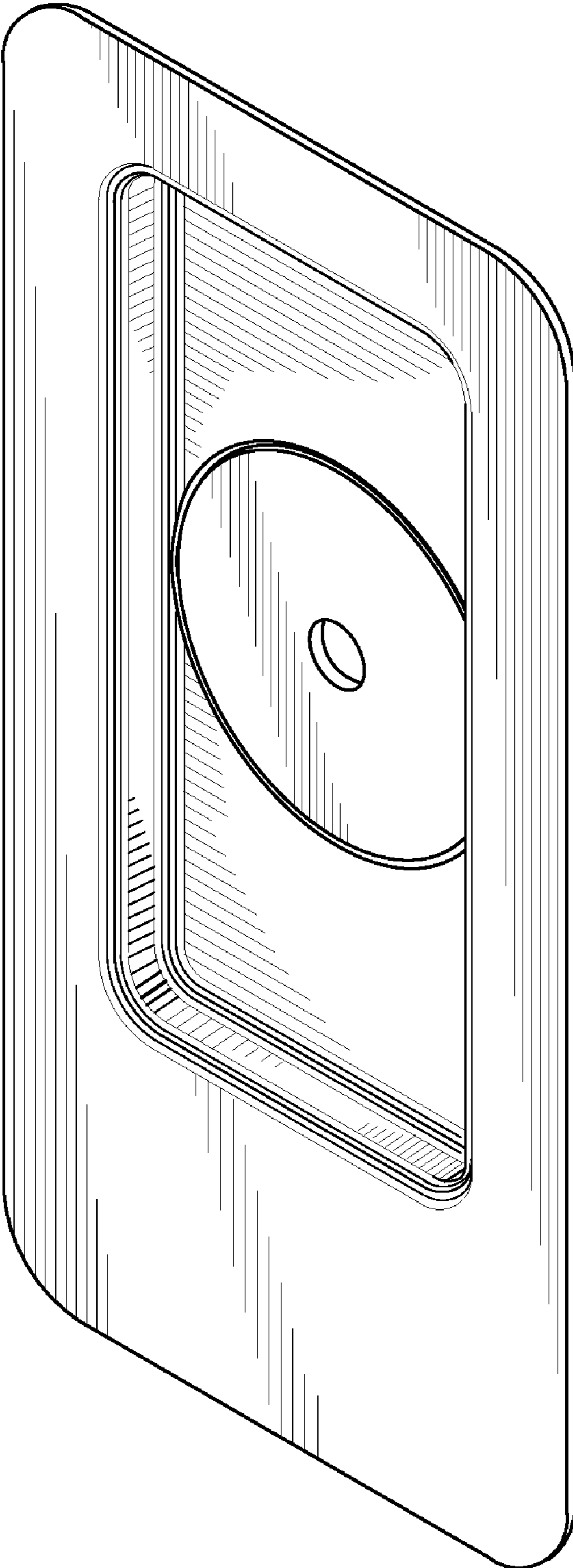

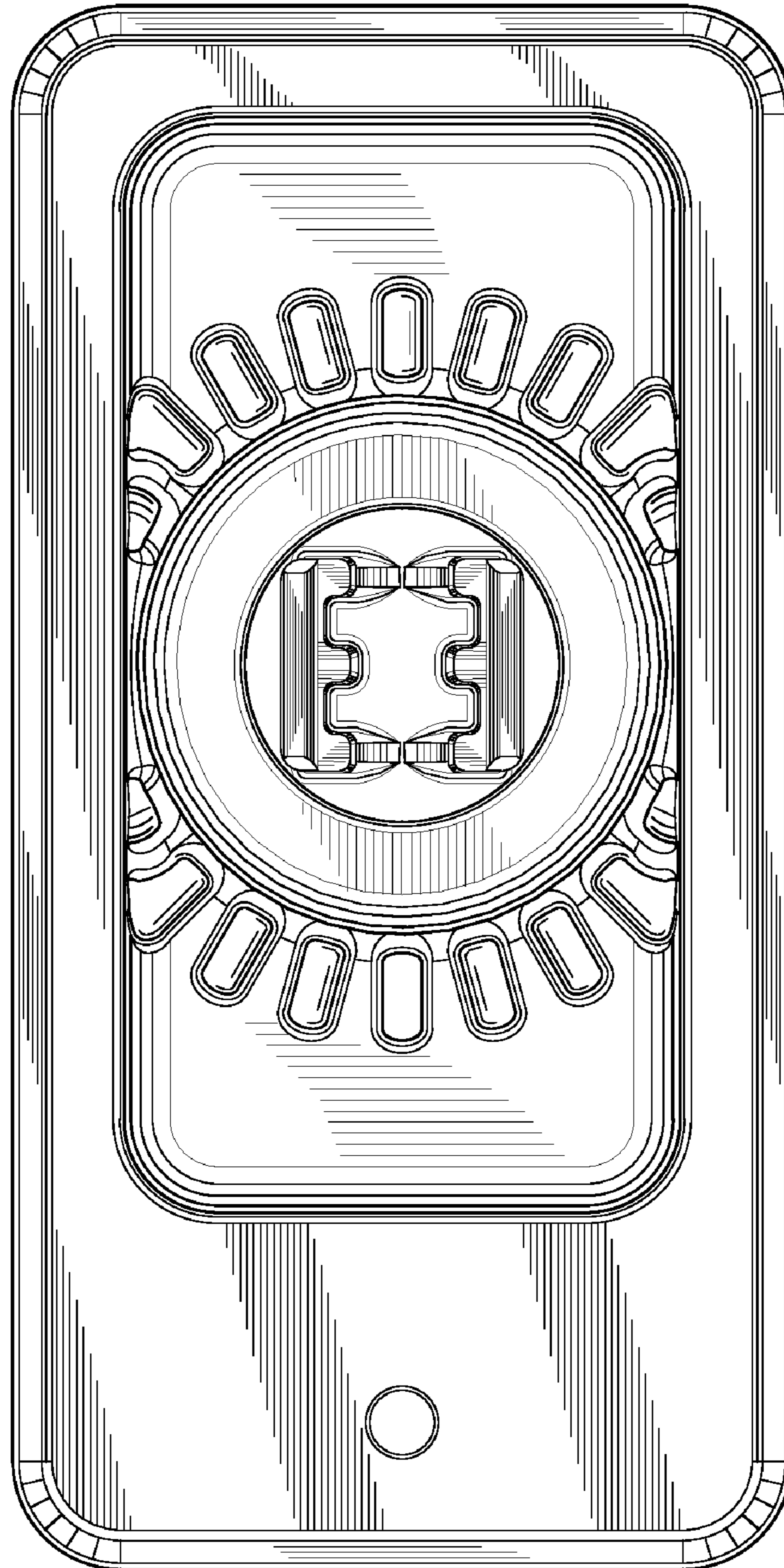

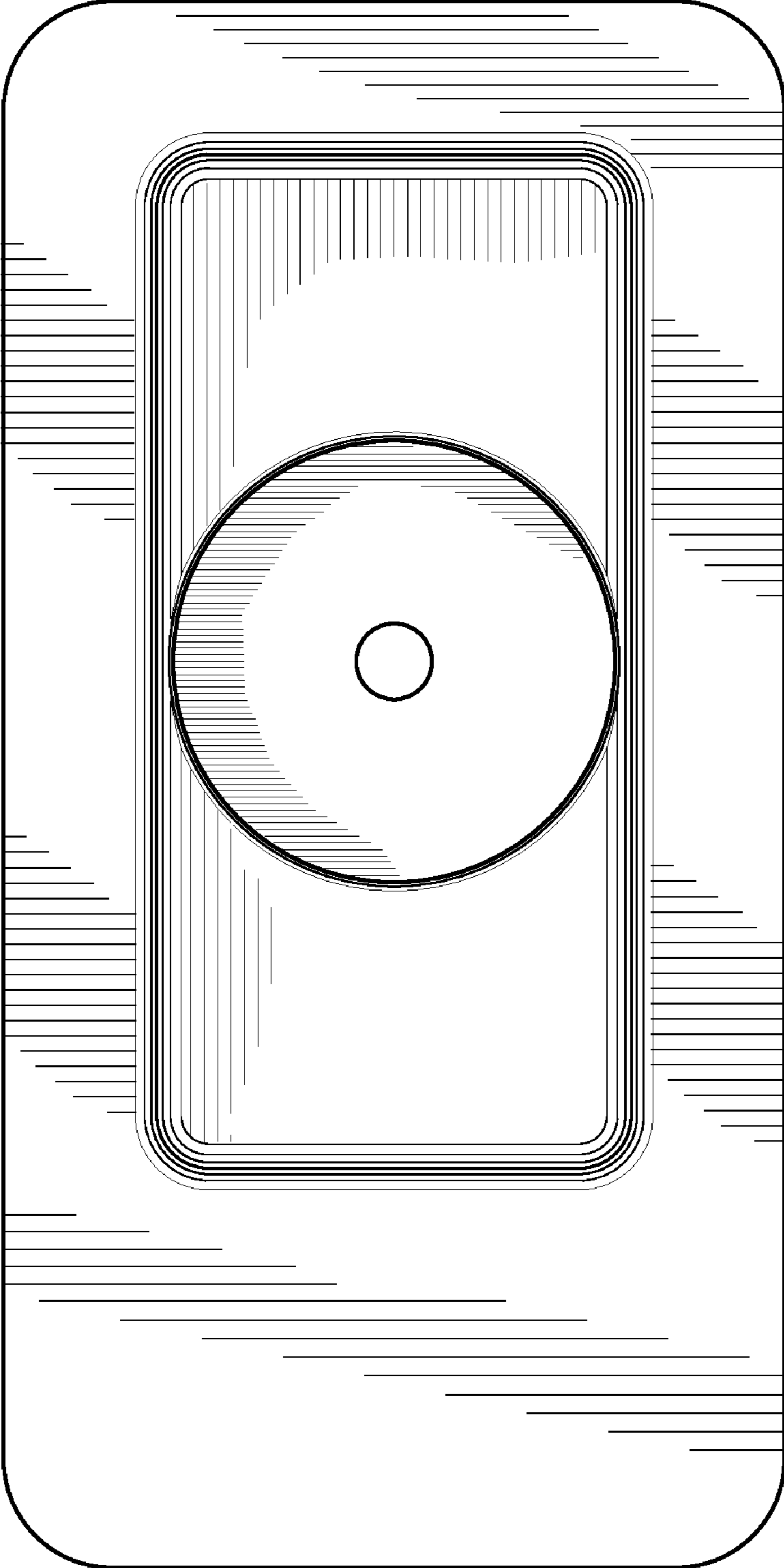

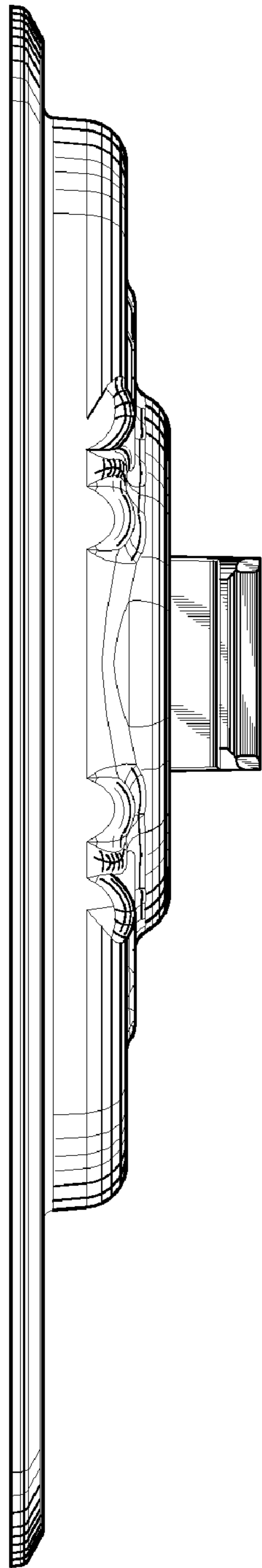

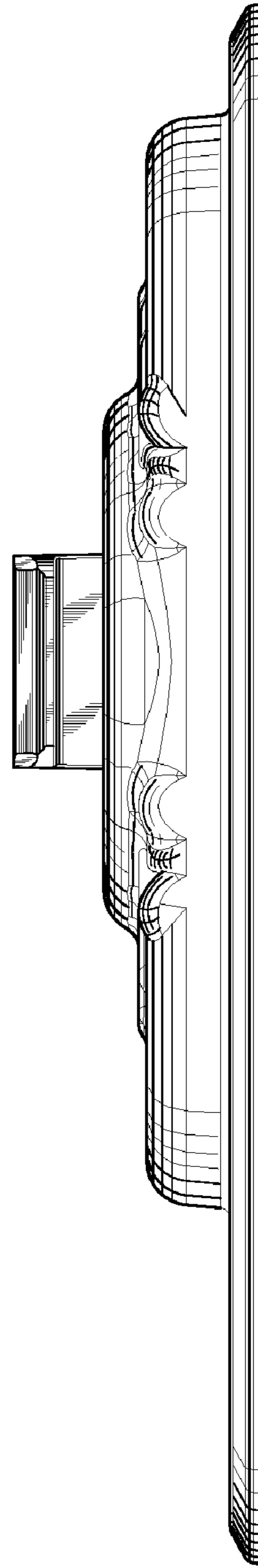

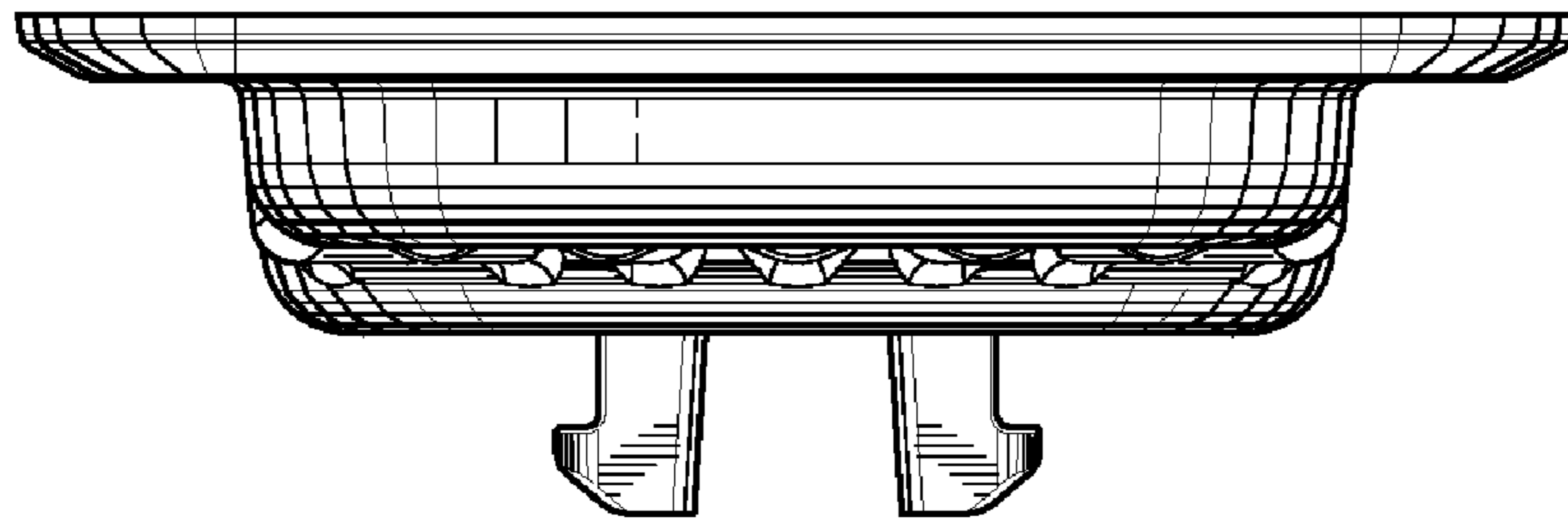

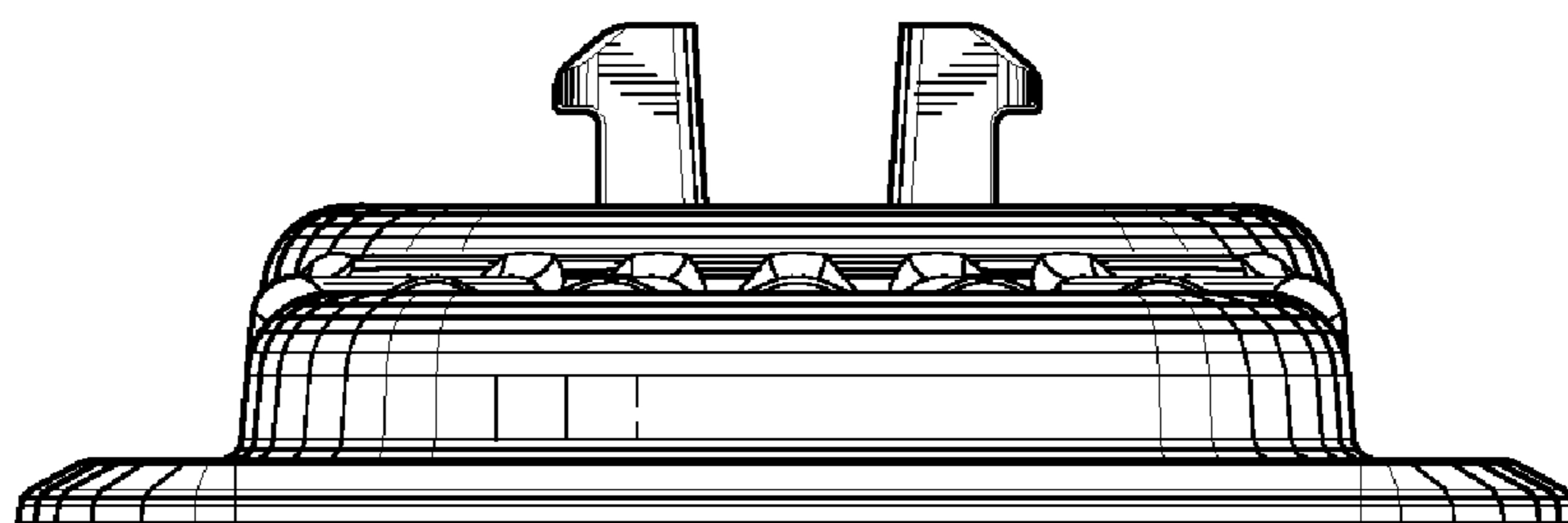

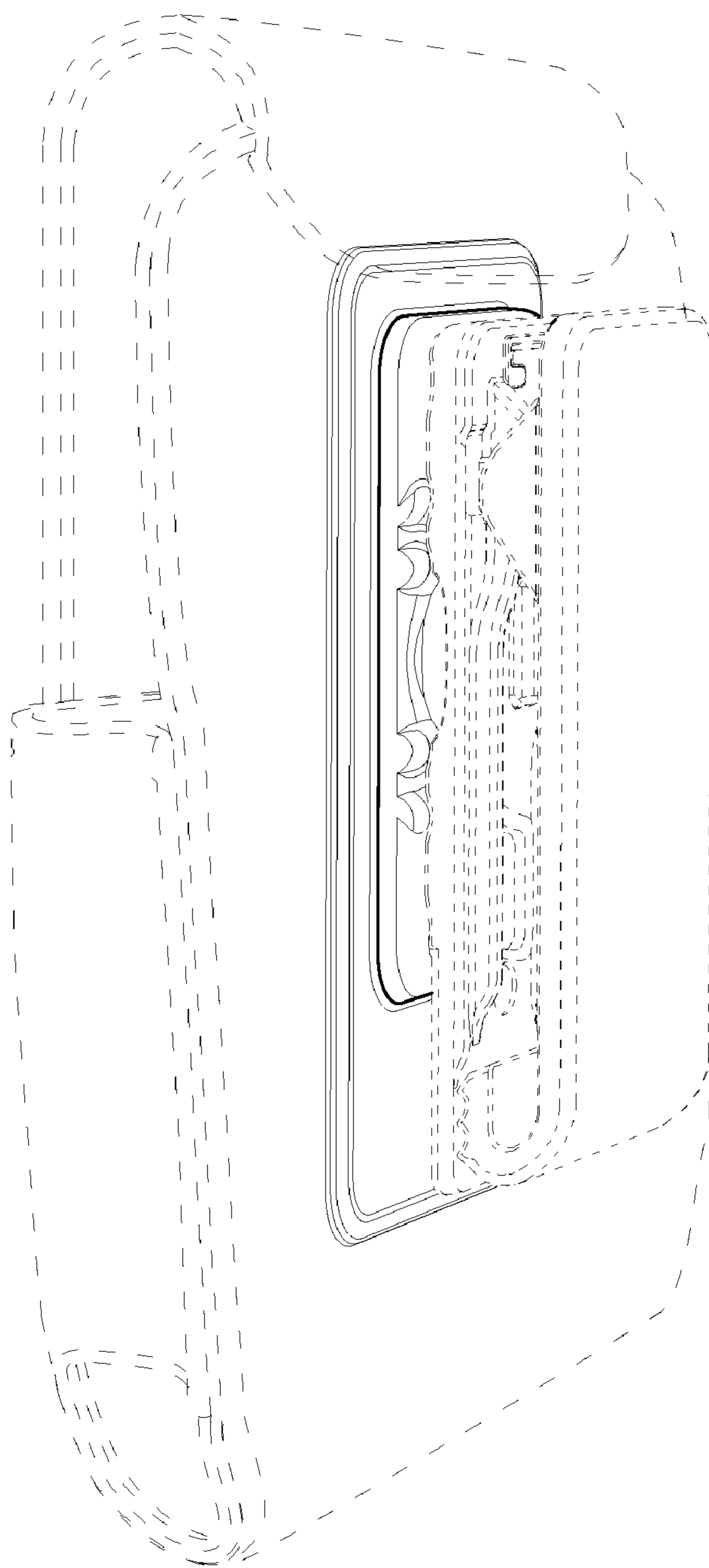
