(57) **CLAIM**

The ornamental design for a messenger bag with fastening straps, as shown and described.

FIG. 4 is left side view of the messenger bag of FIG. 1.

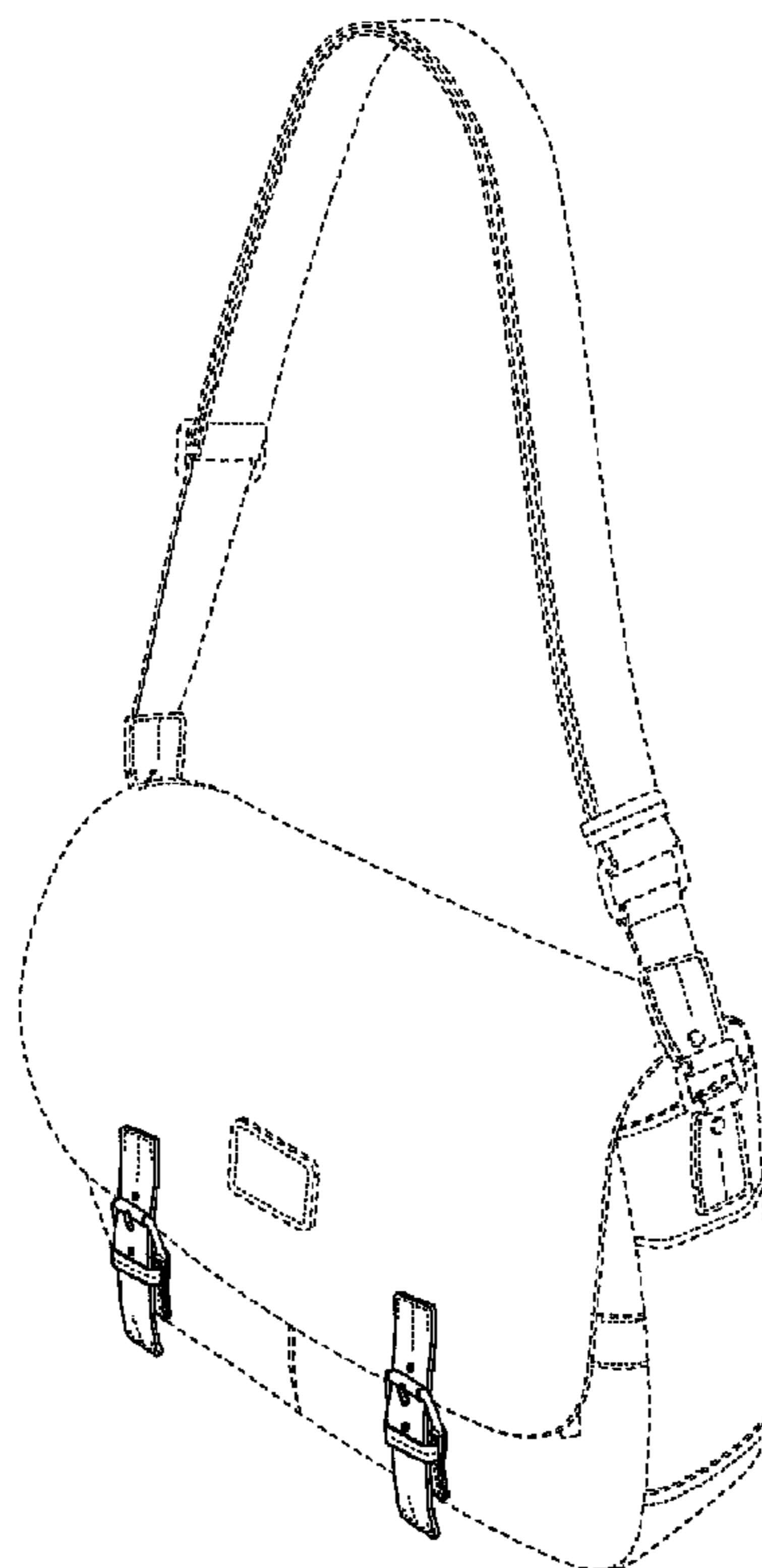
FIG. 5 is right side view of the messenger bag of FIG. 1.

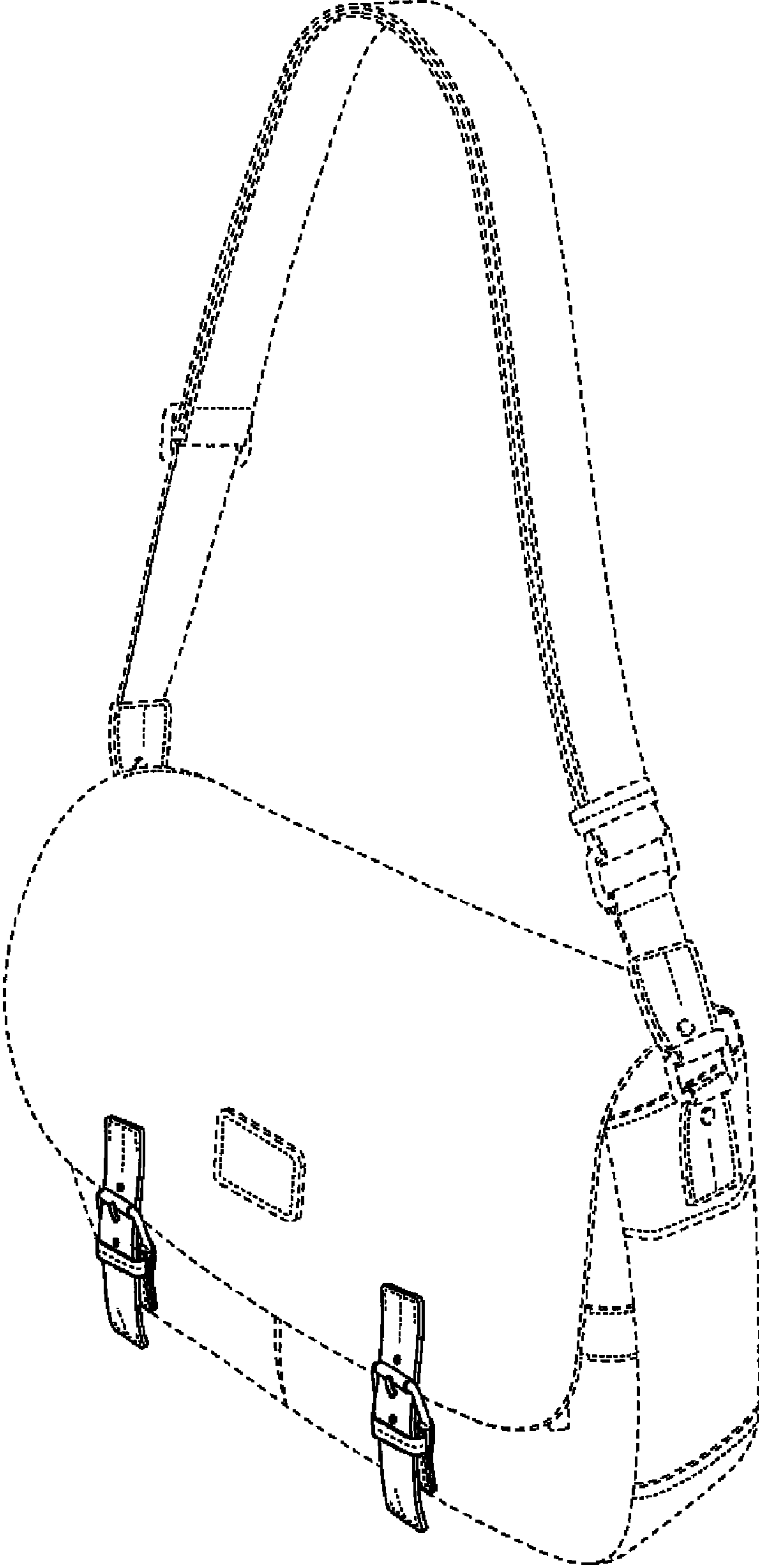

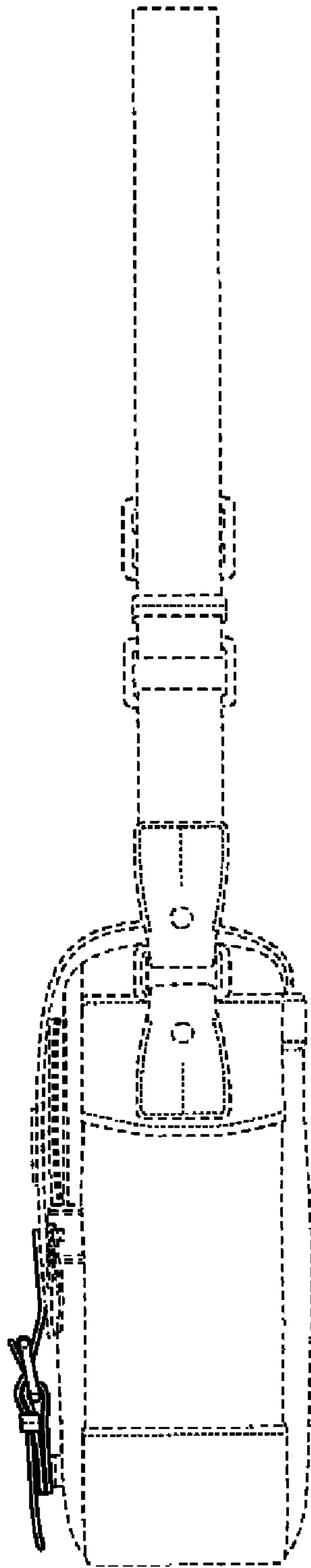

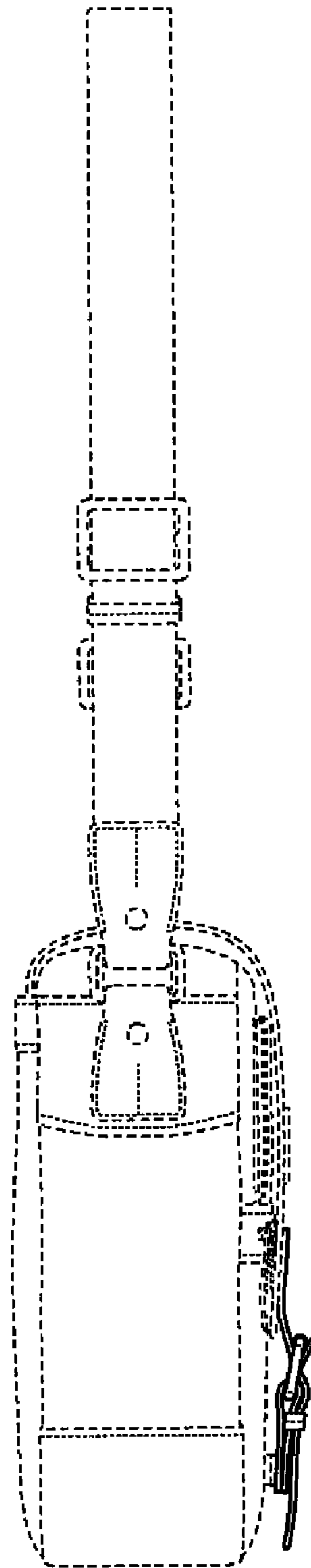

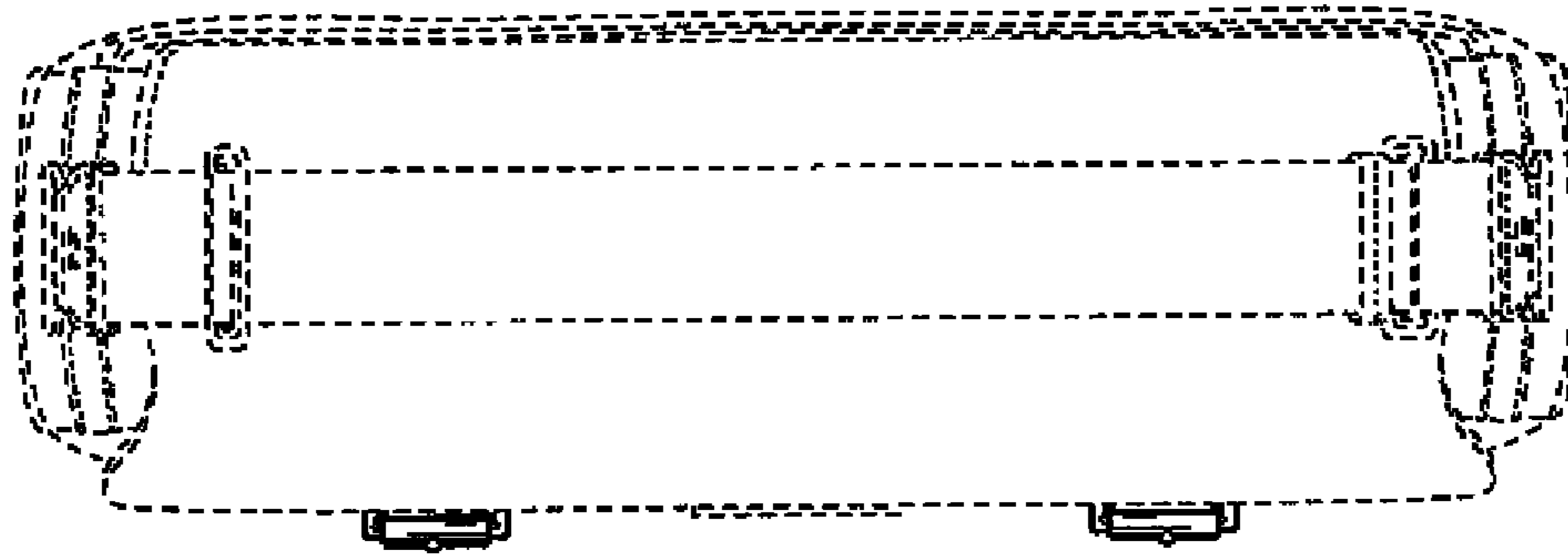

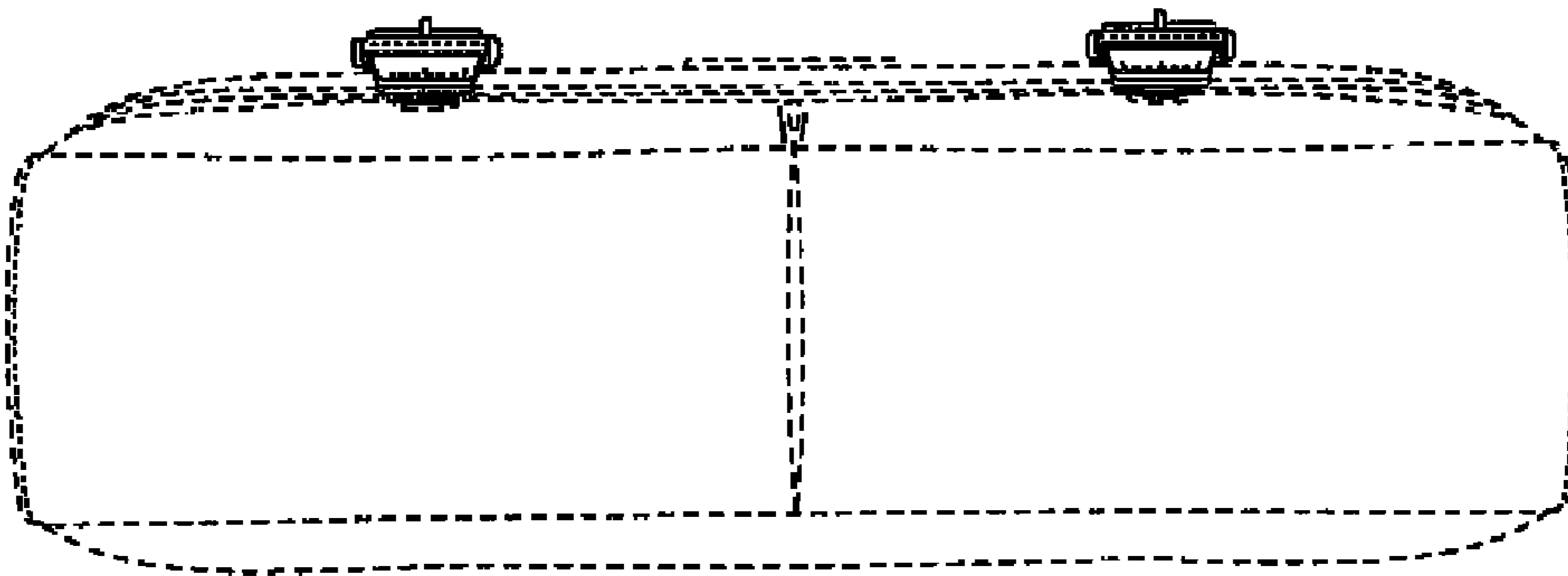
