FIG. 3 is a rear view thereof in which the broken line is for illustrative purposes only and forms no part of the claimed design;

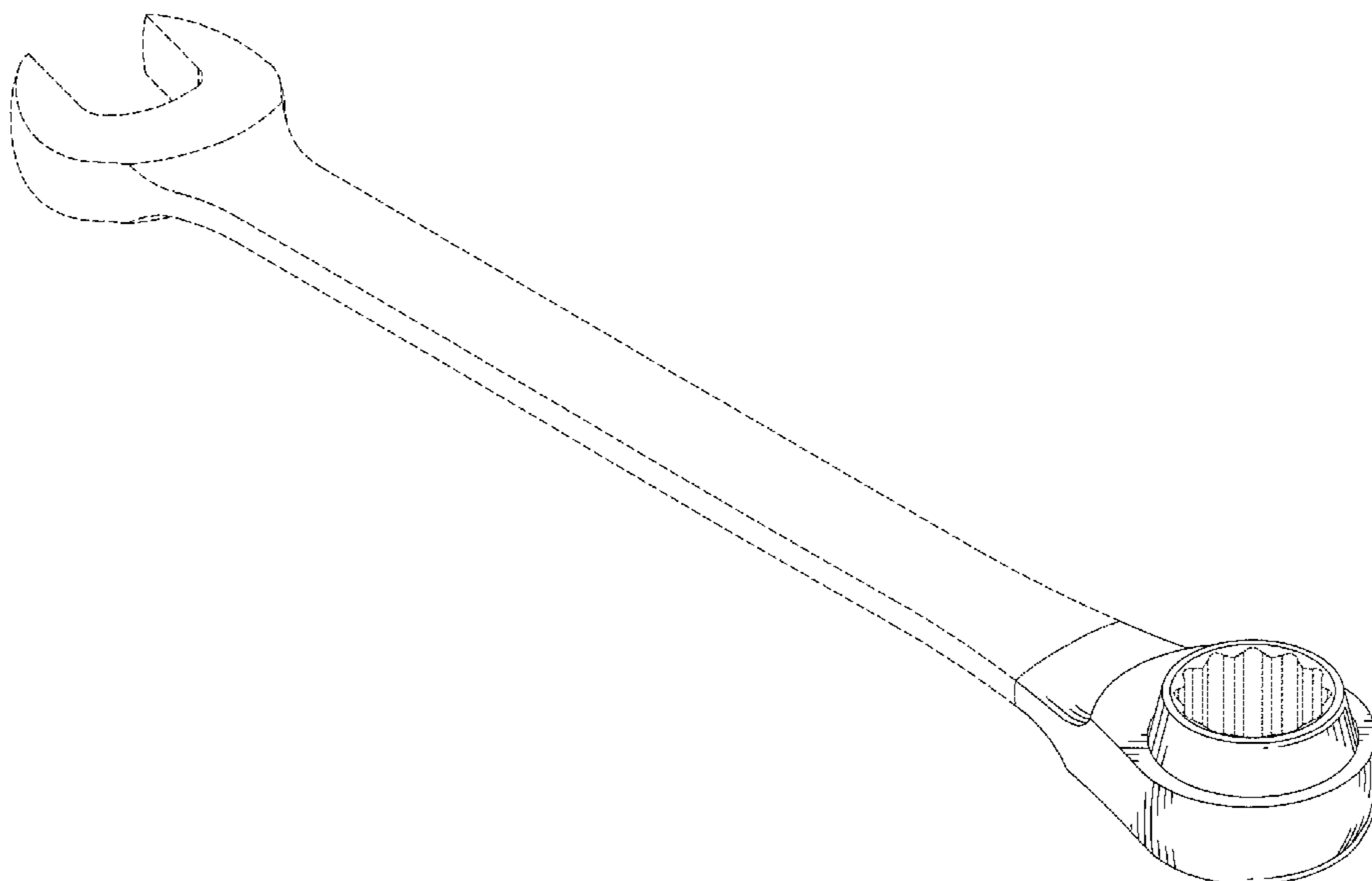
FIG. 4 is a left view thereof in which the broken line is for illustrative purposes only and forms no part of the claimed design;

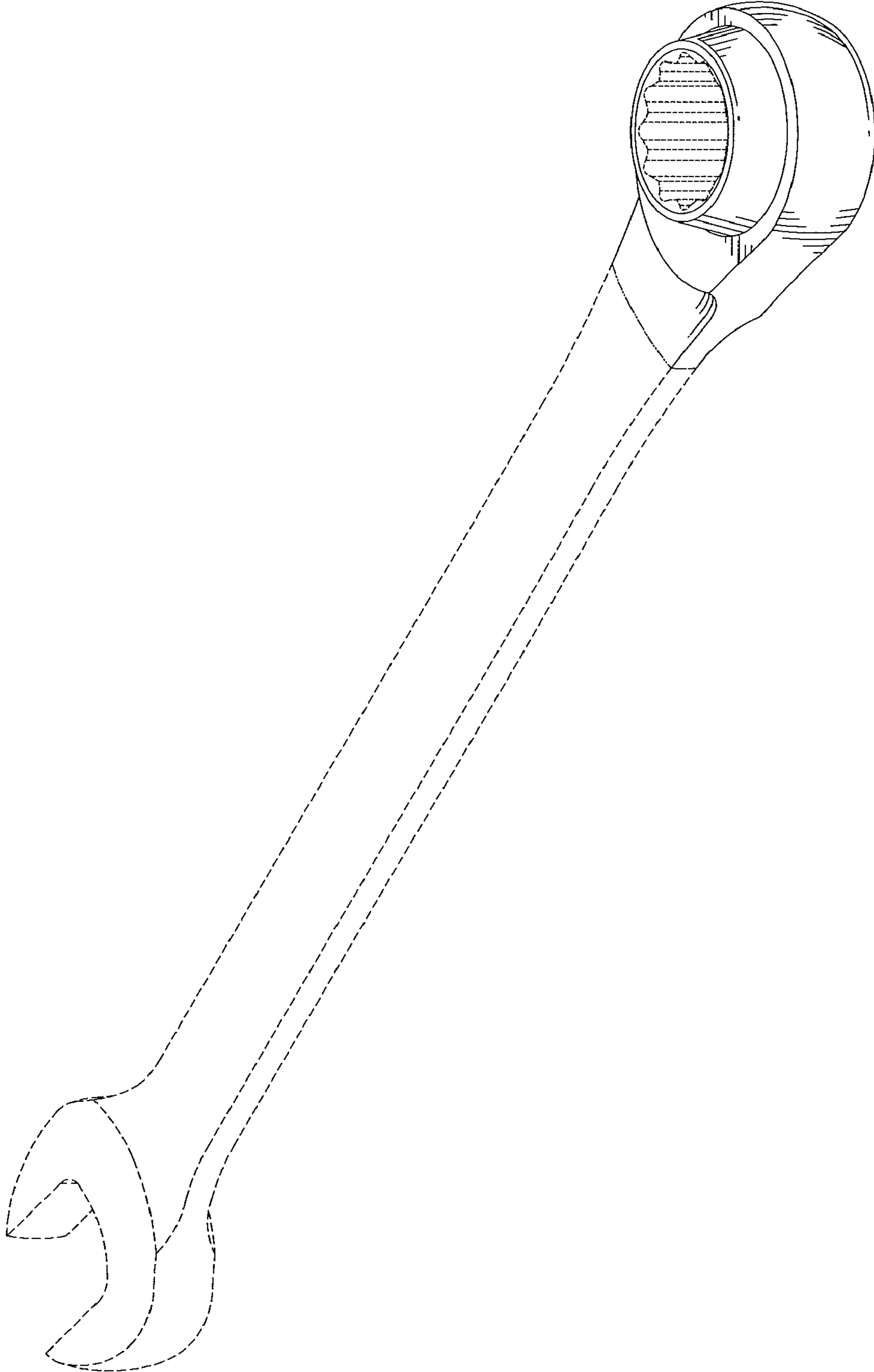

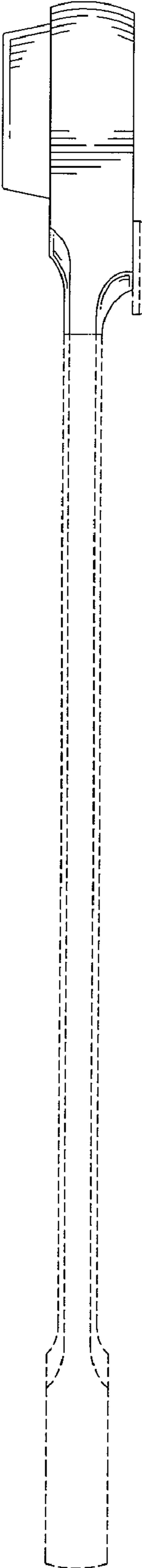

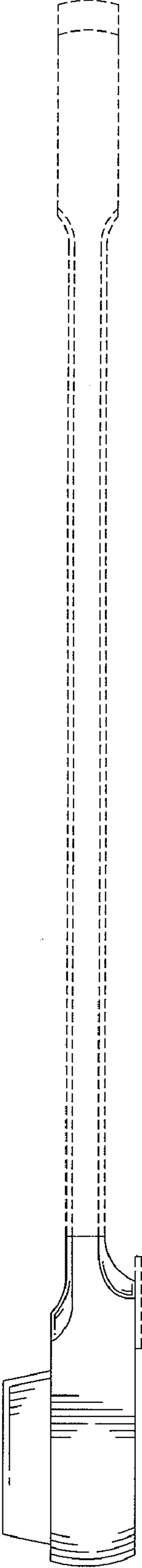

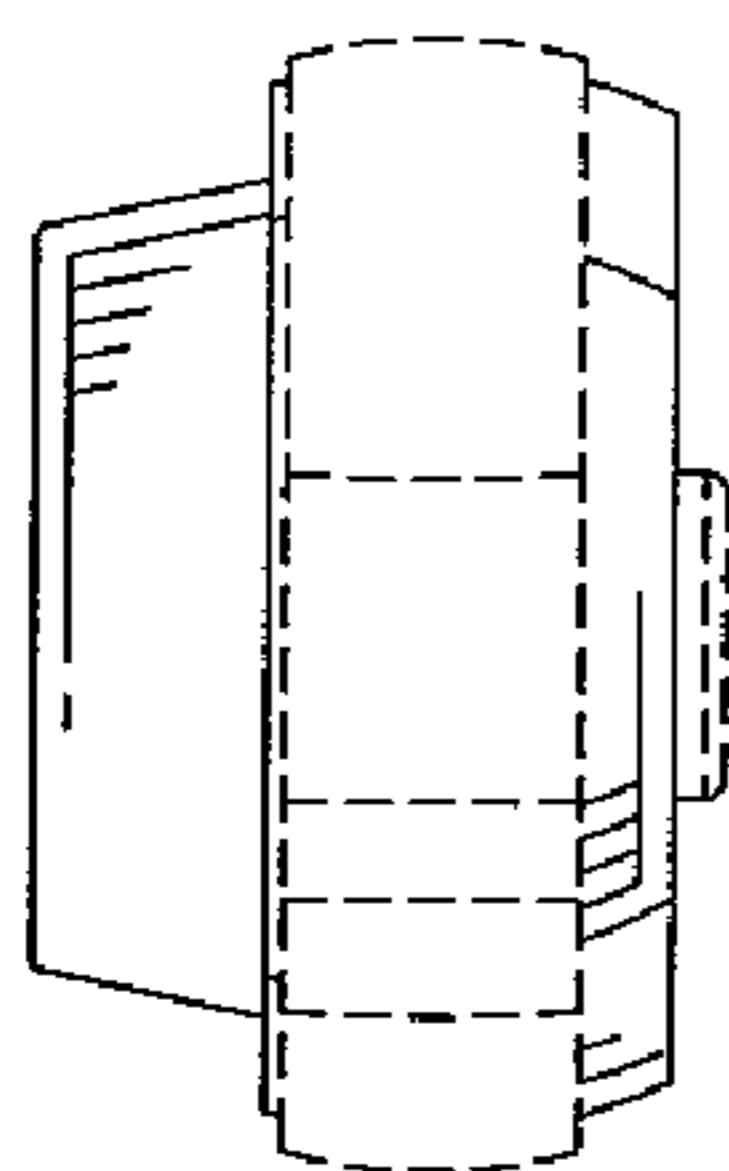

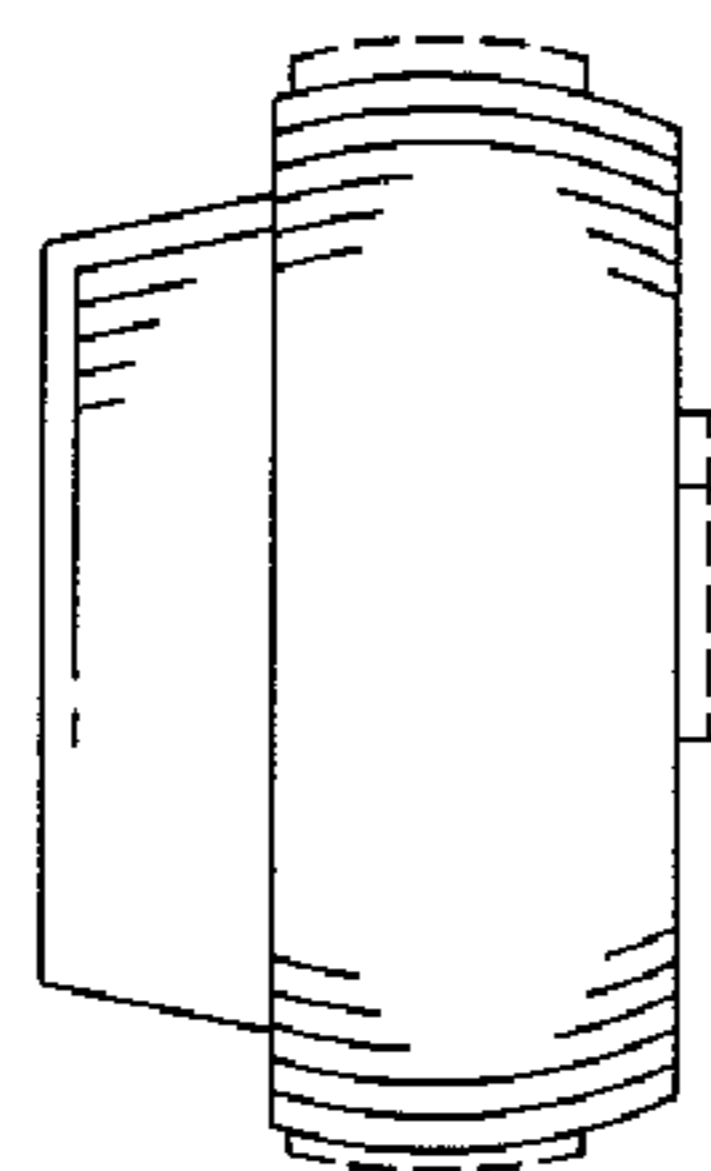

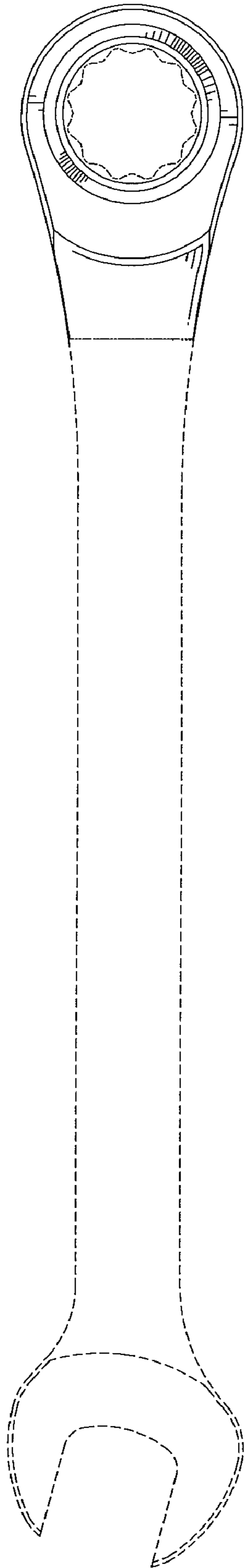

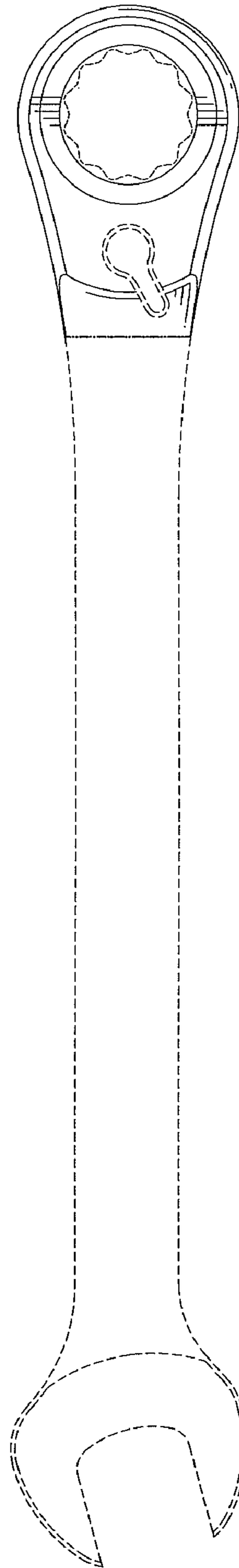
