FIG. 3 is a side view thereof;

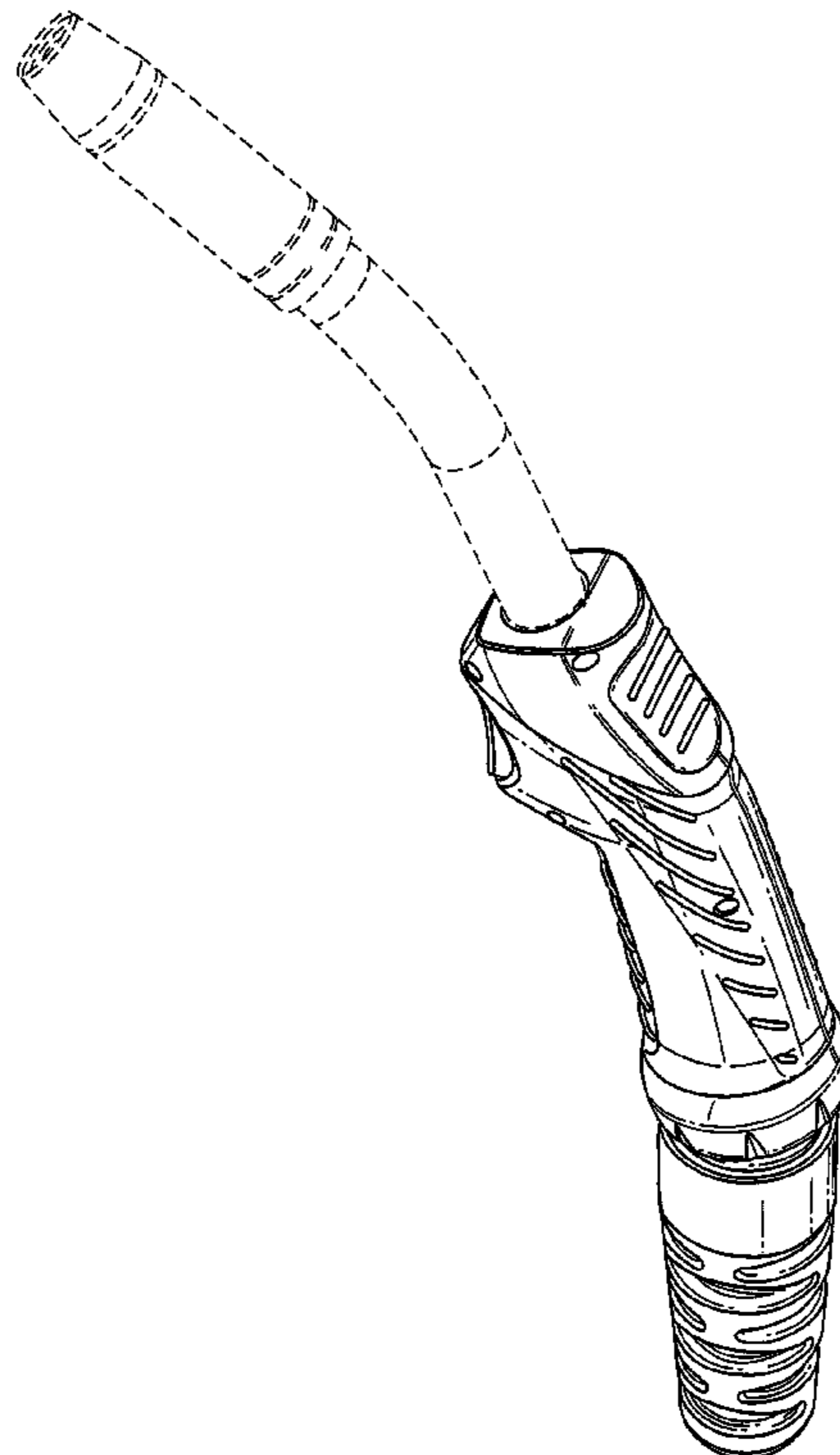
FIG. 4 is a top, side and rear perspective view thereof;

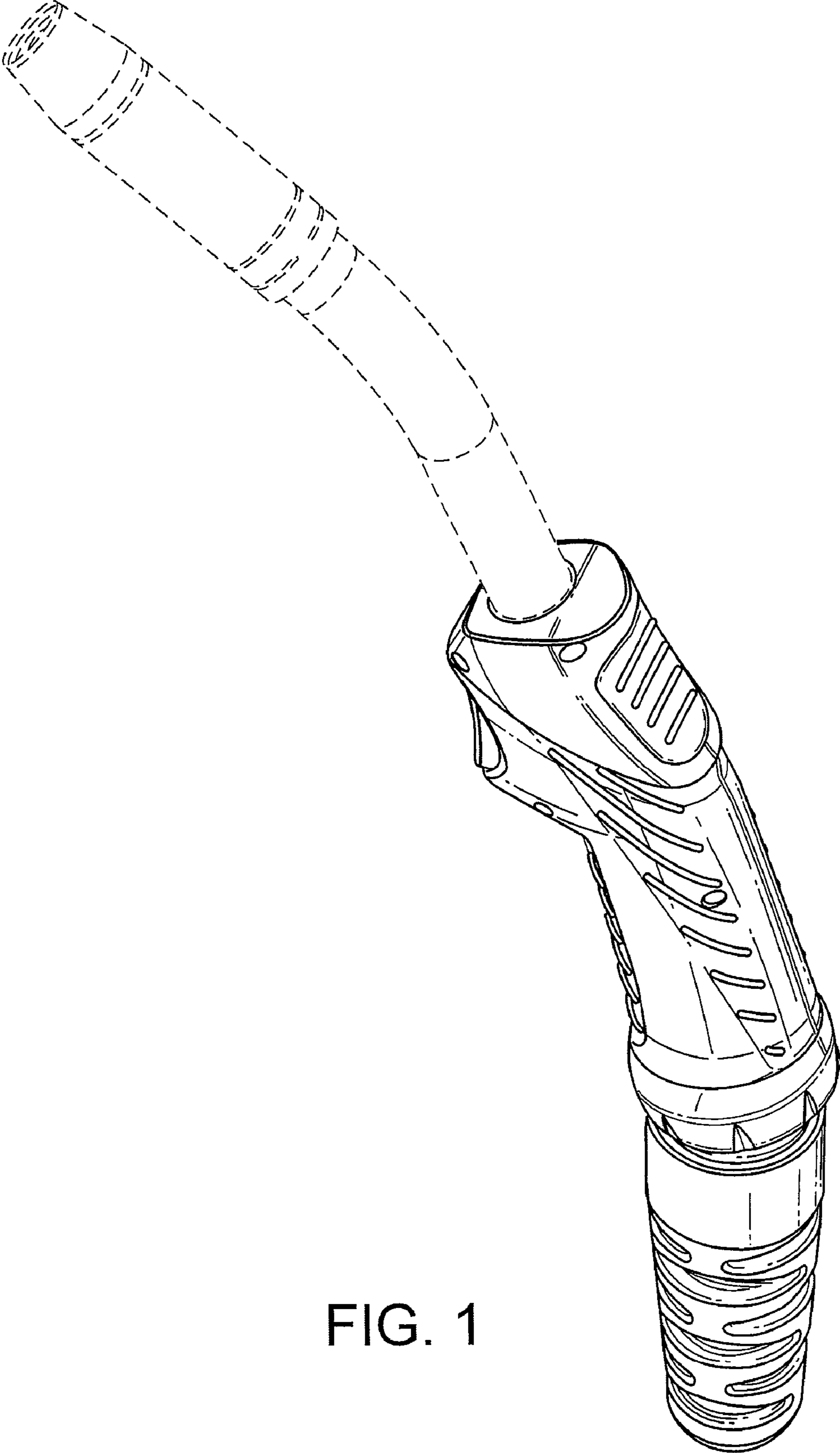

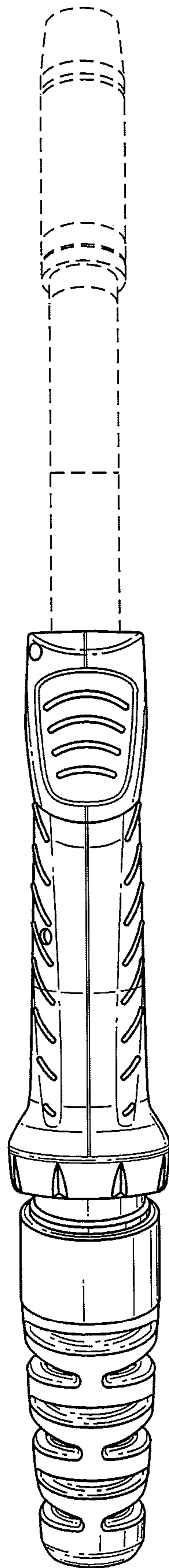

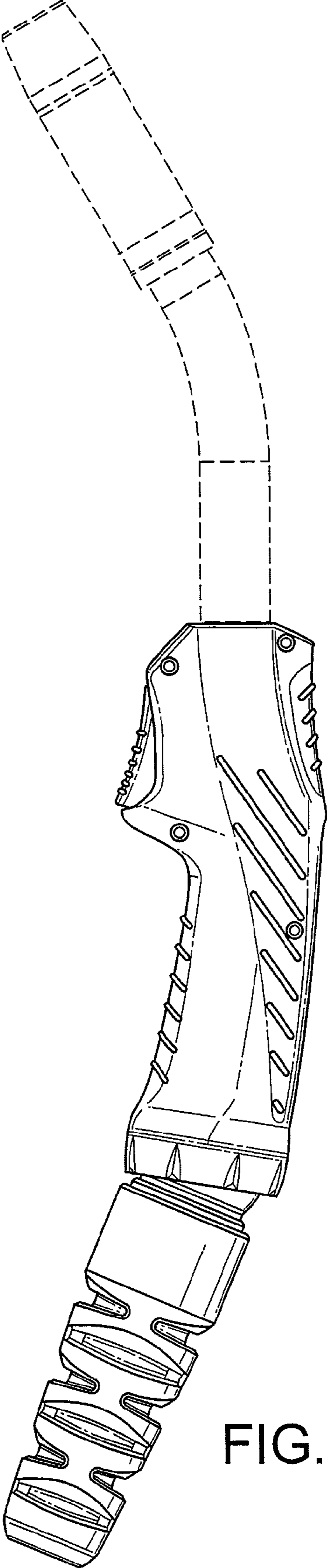

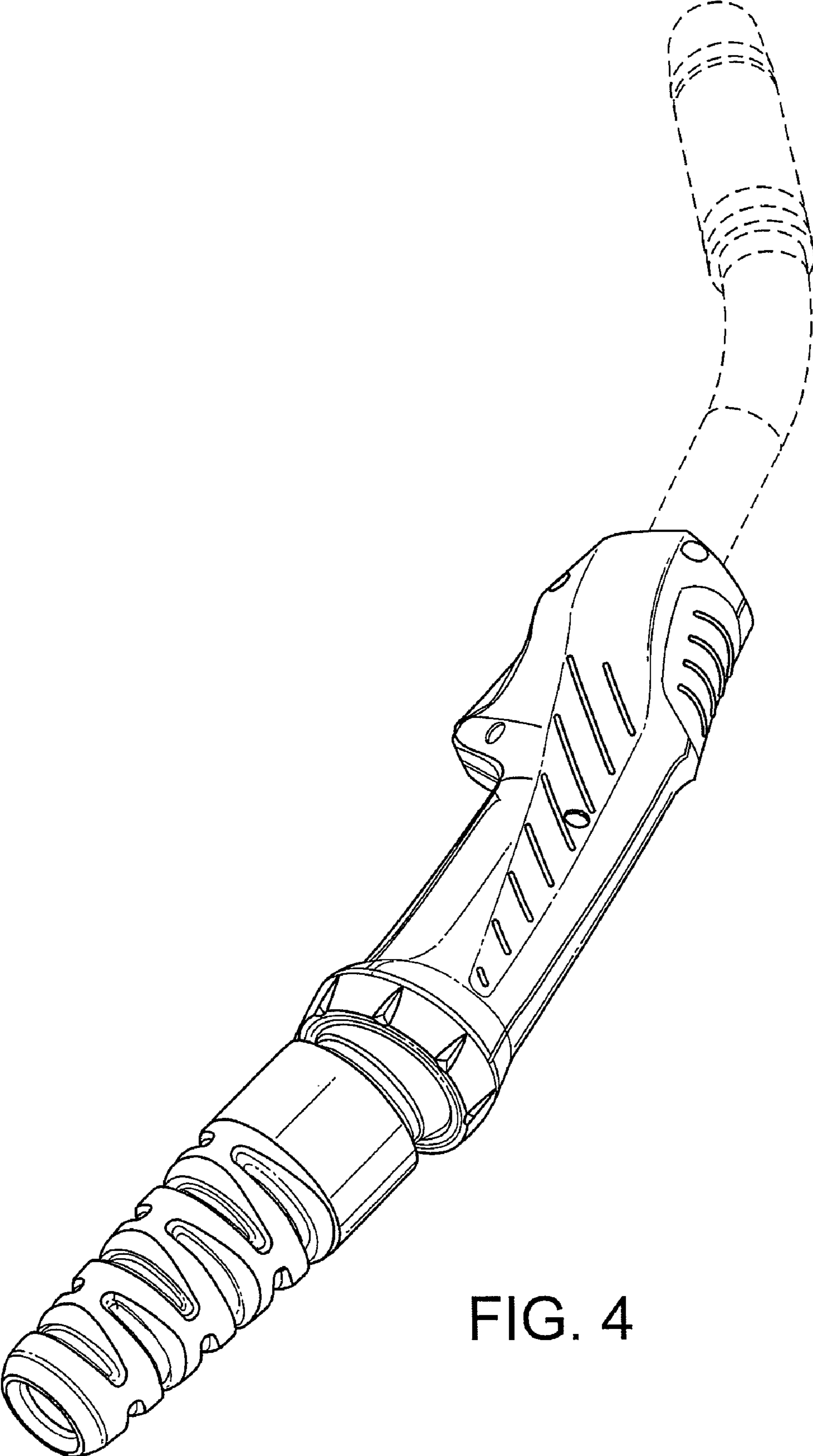

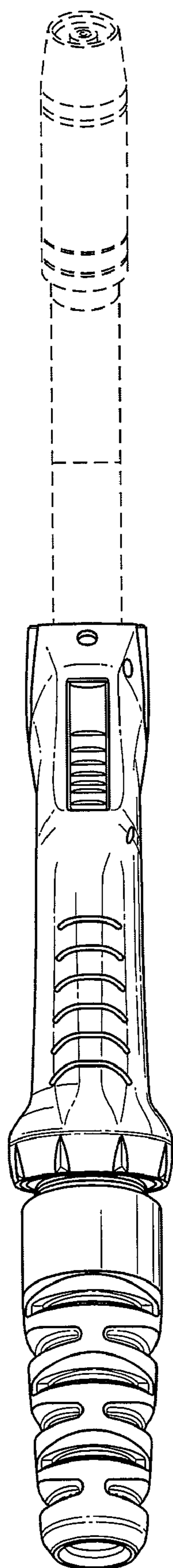

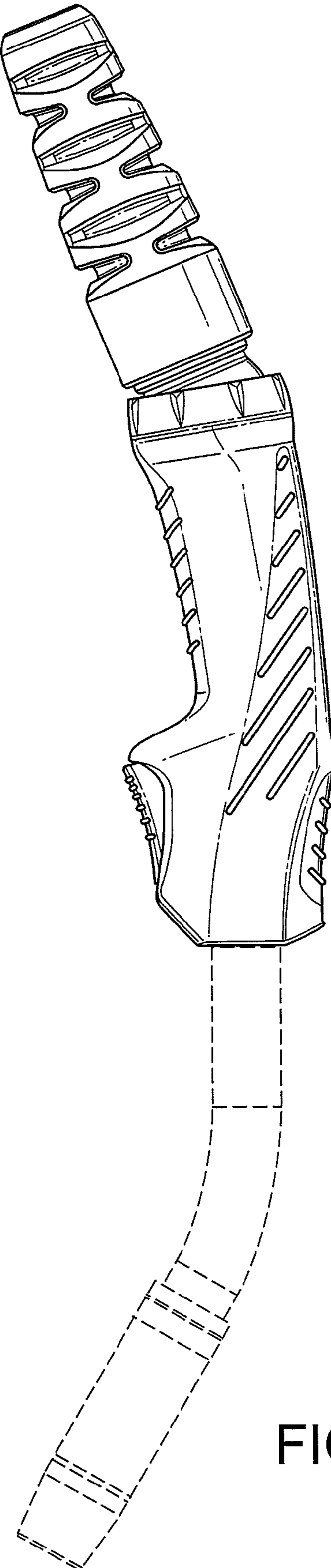

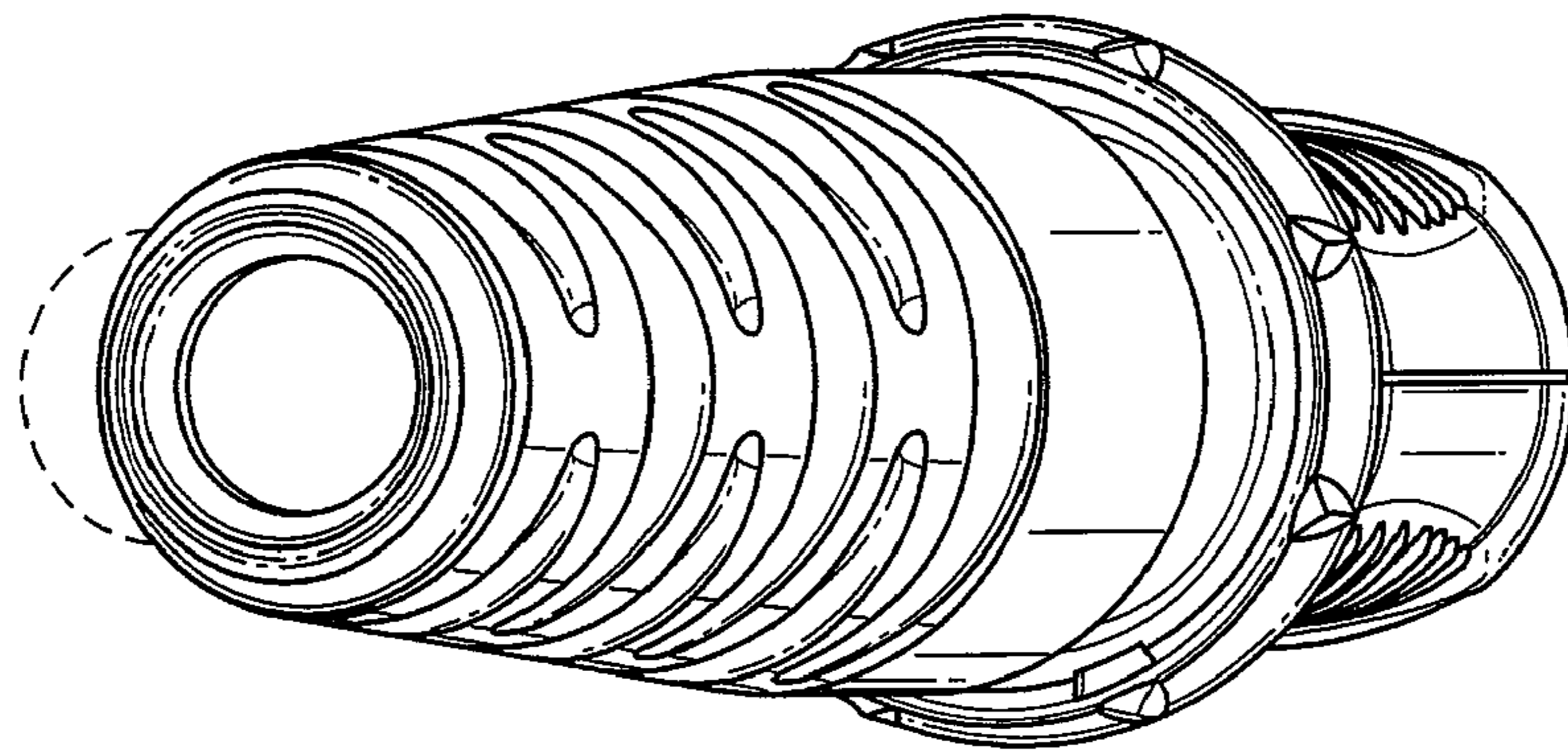
