FIG. 2 is a longitudinal side elevation view of the cabinet knob in accordance with the present invention.

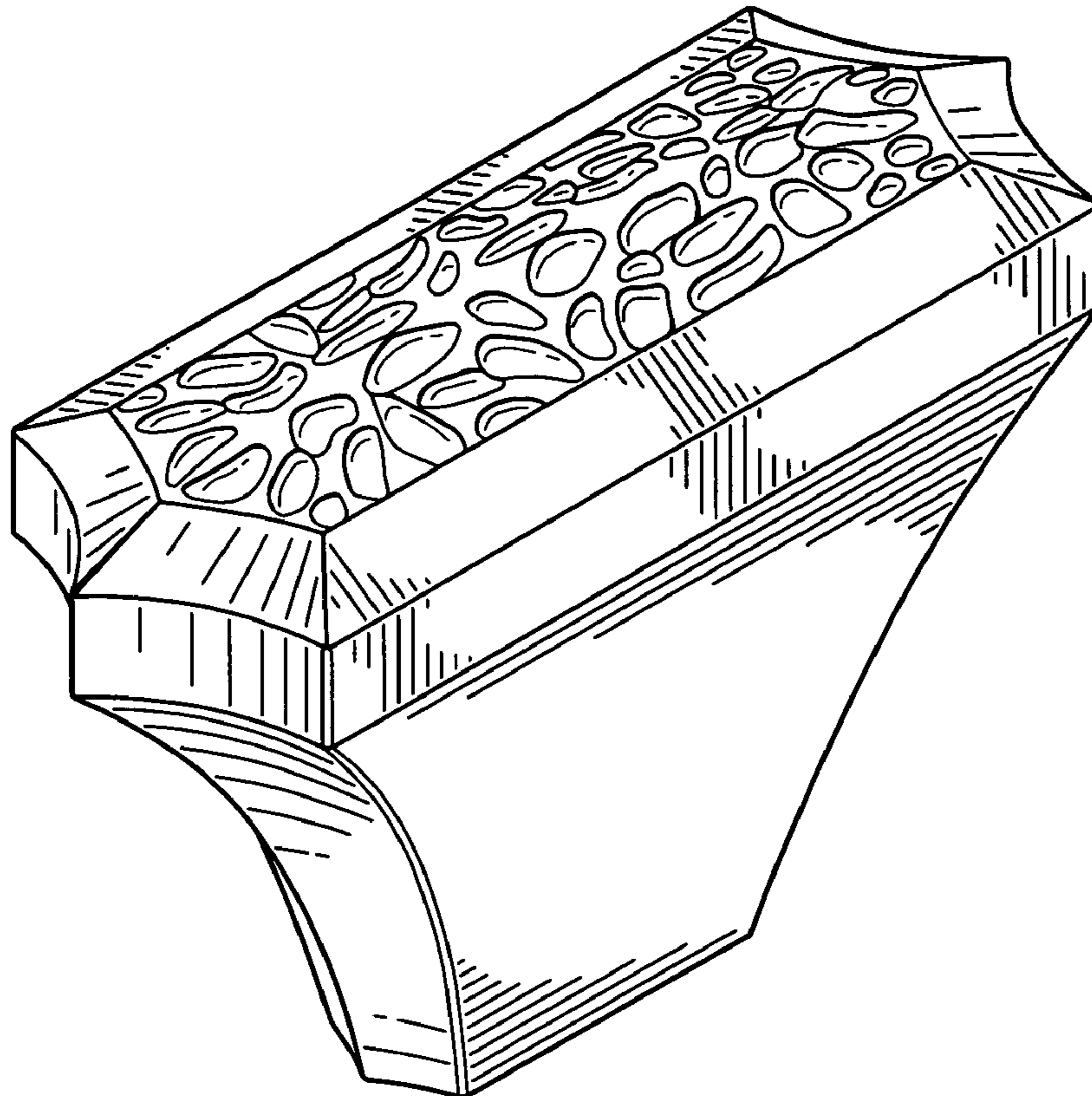
FIG. 3 is a top view of the cabinet knob in accordance with the present invention.

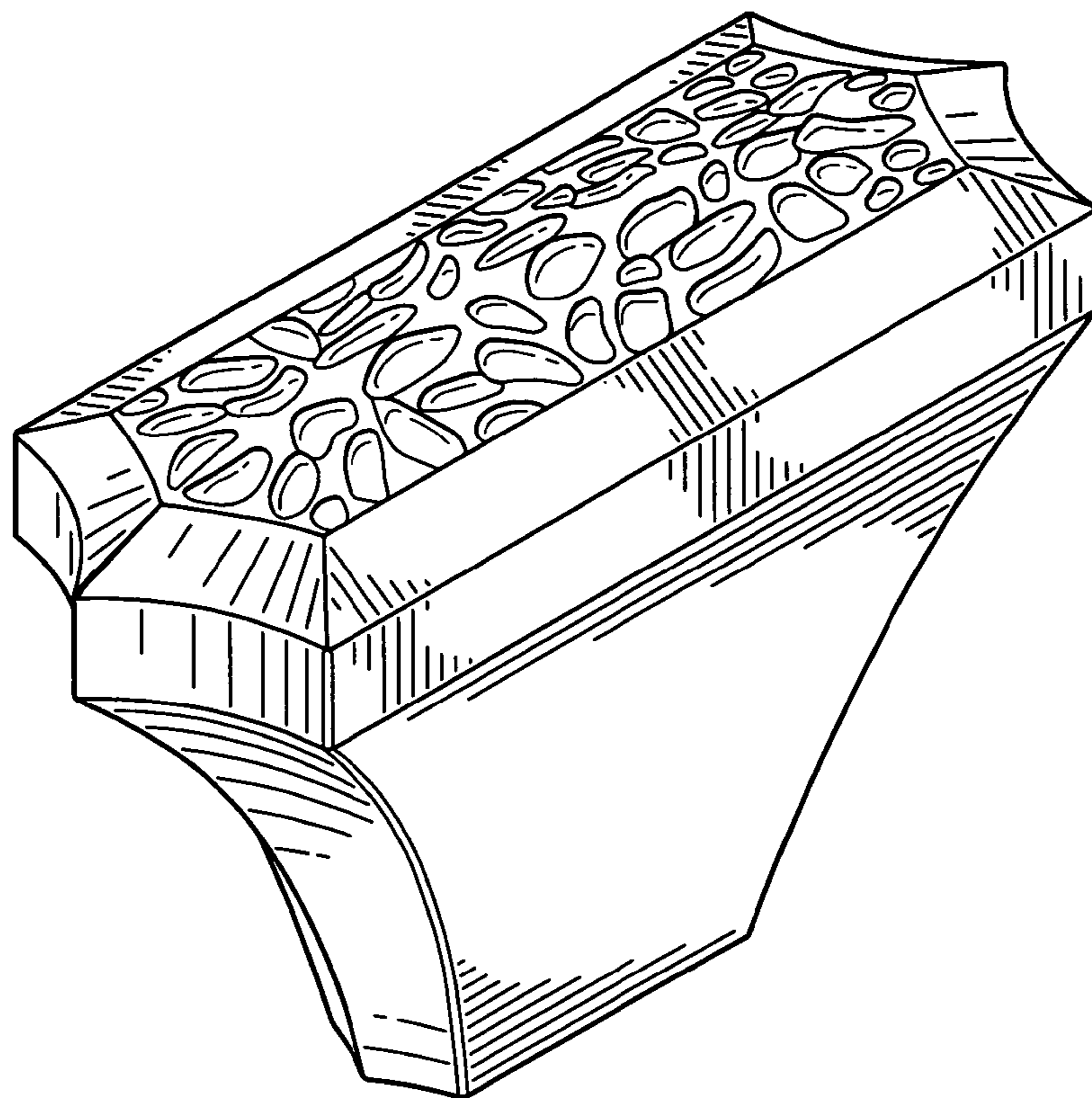
FIG. 4 is a lateral side elevation view of the cabinet knob in accordance with the present invention; and,

FIG. 5 is a bottom view of the cabinet knob in accordance with the present invention.

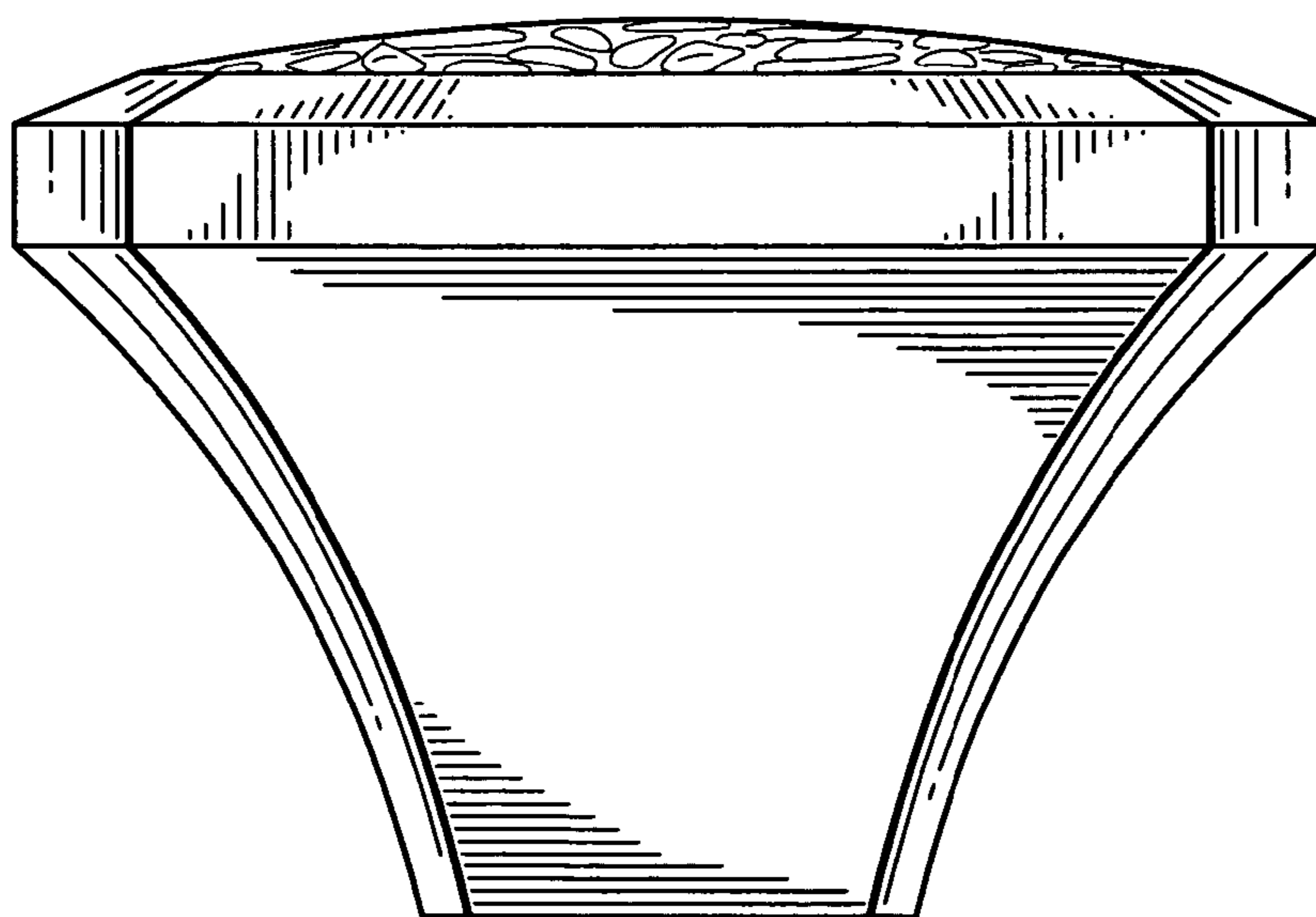

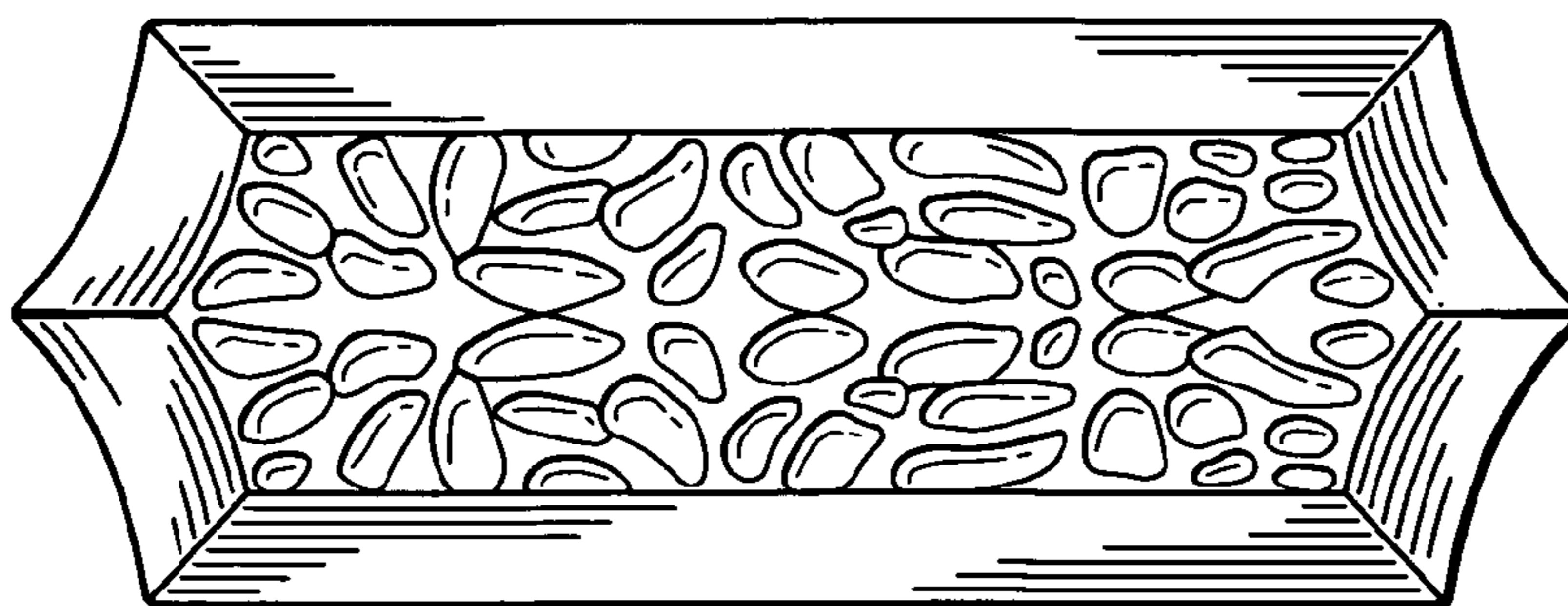




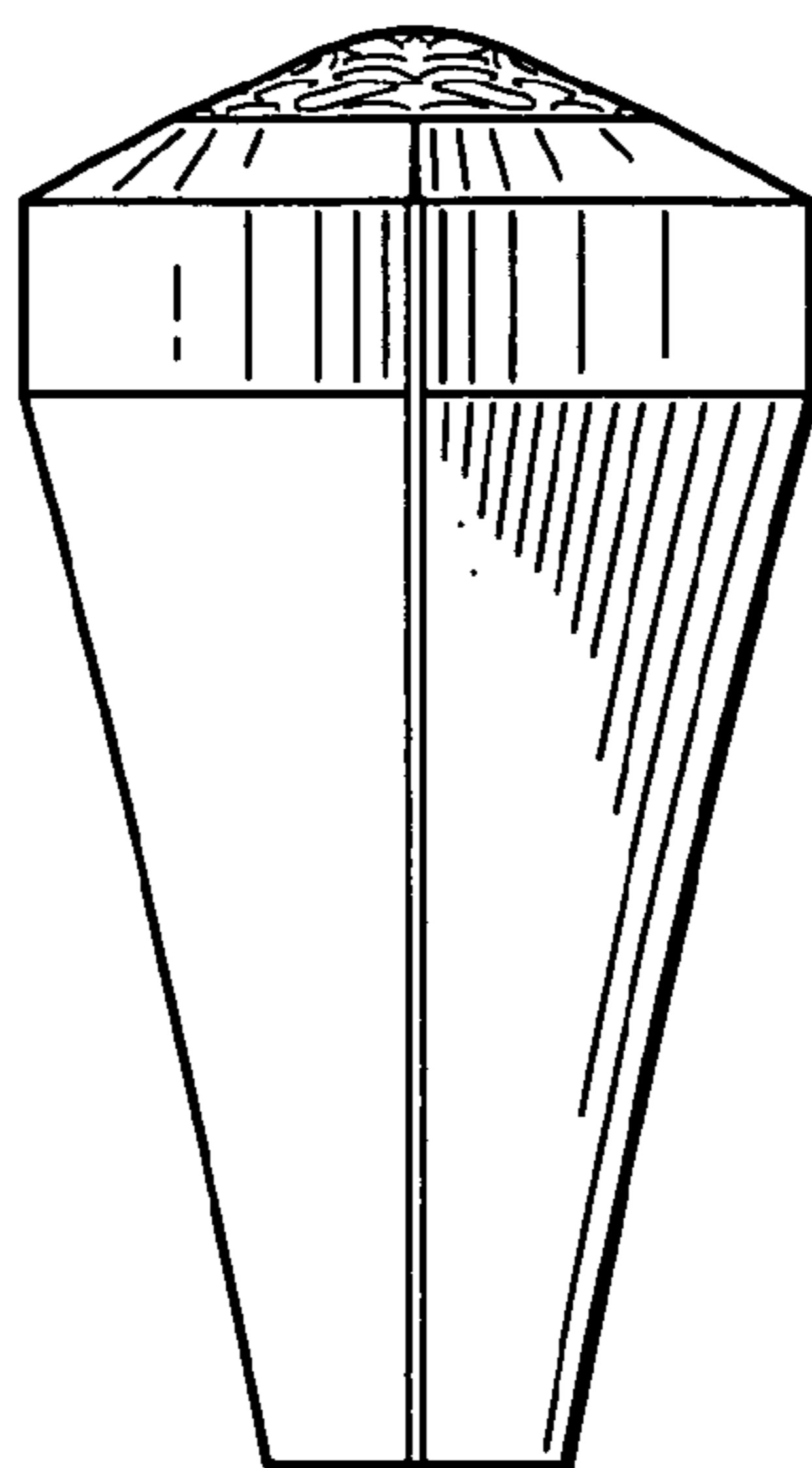

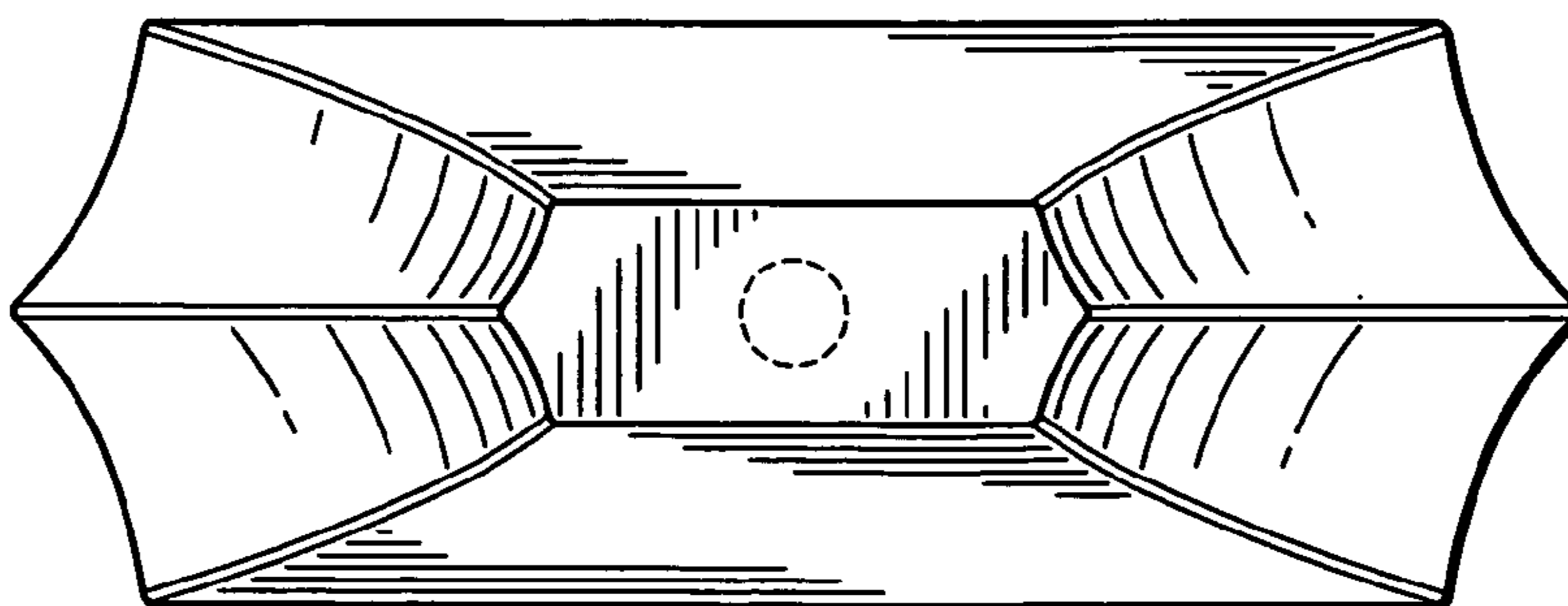
