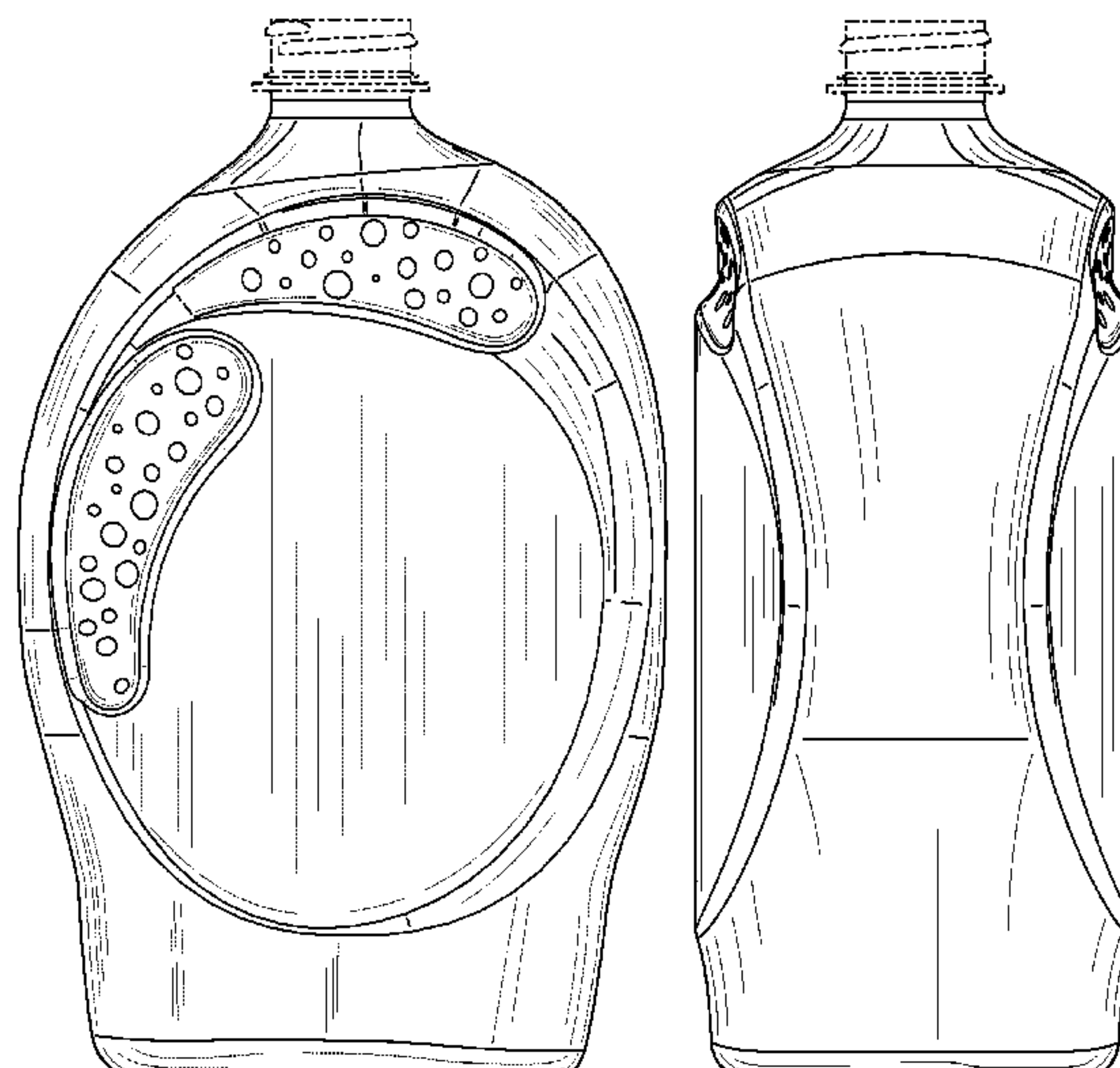
(57) **CLAIM**

The ornamental design for a container, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, and right side perspective view of a container according to the new design; FIG. 2 is a top, front, and left side perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof. The broken lines in the drawings of a pour spout/ thread and of the bottom surface are included for the purpose of showing environmental structure that forms no part of the claimed design.

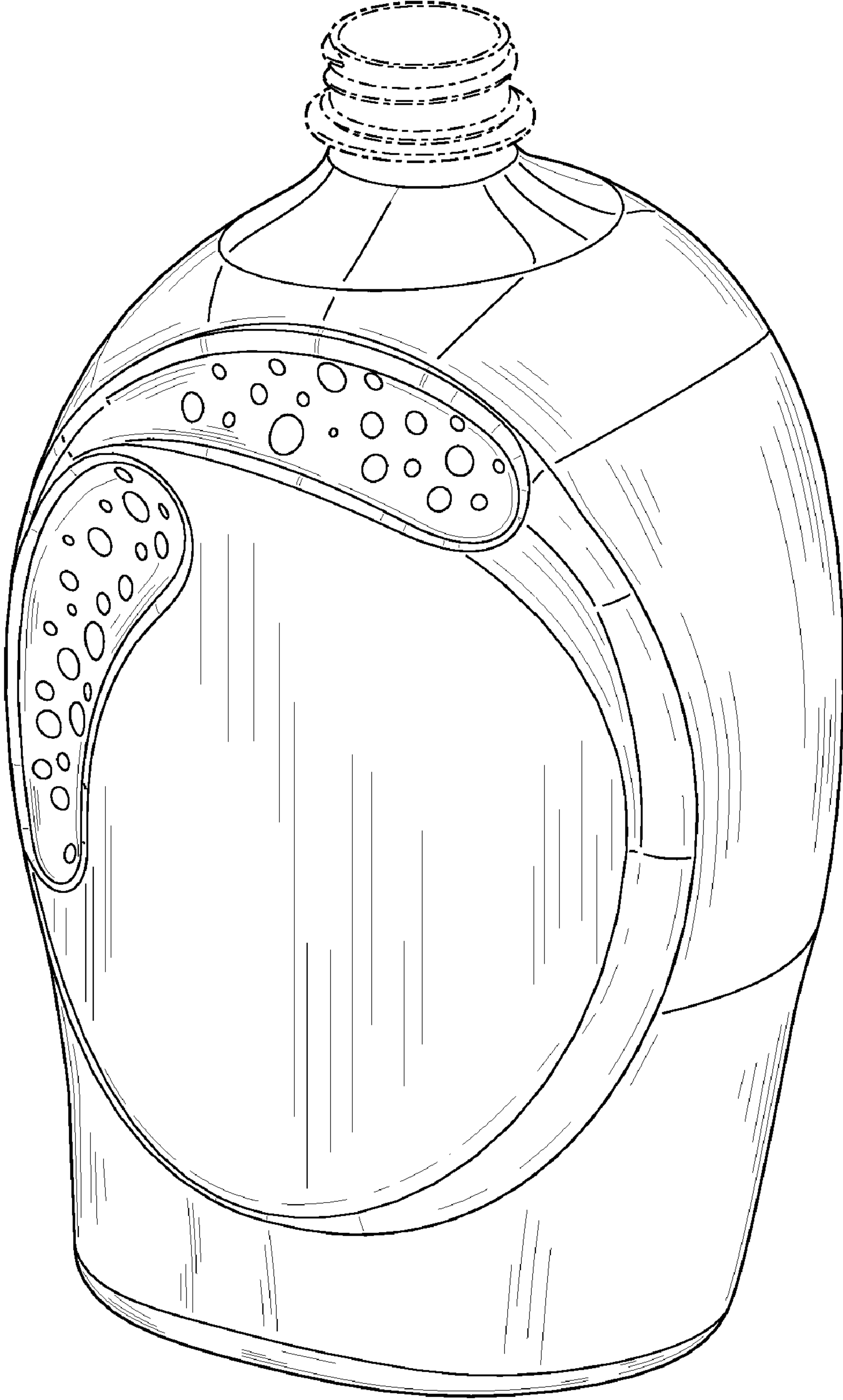

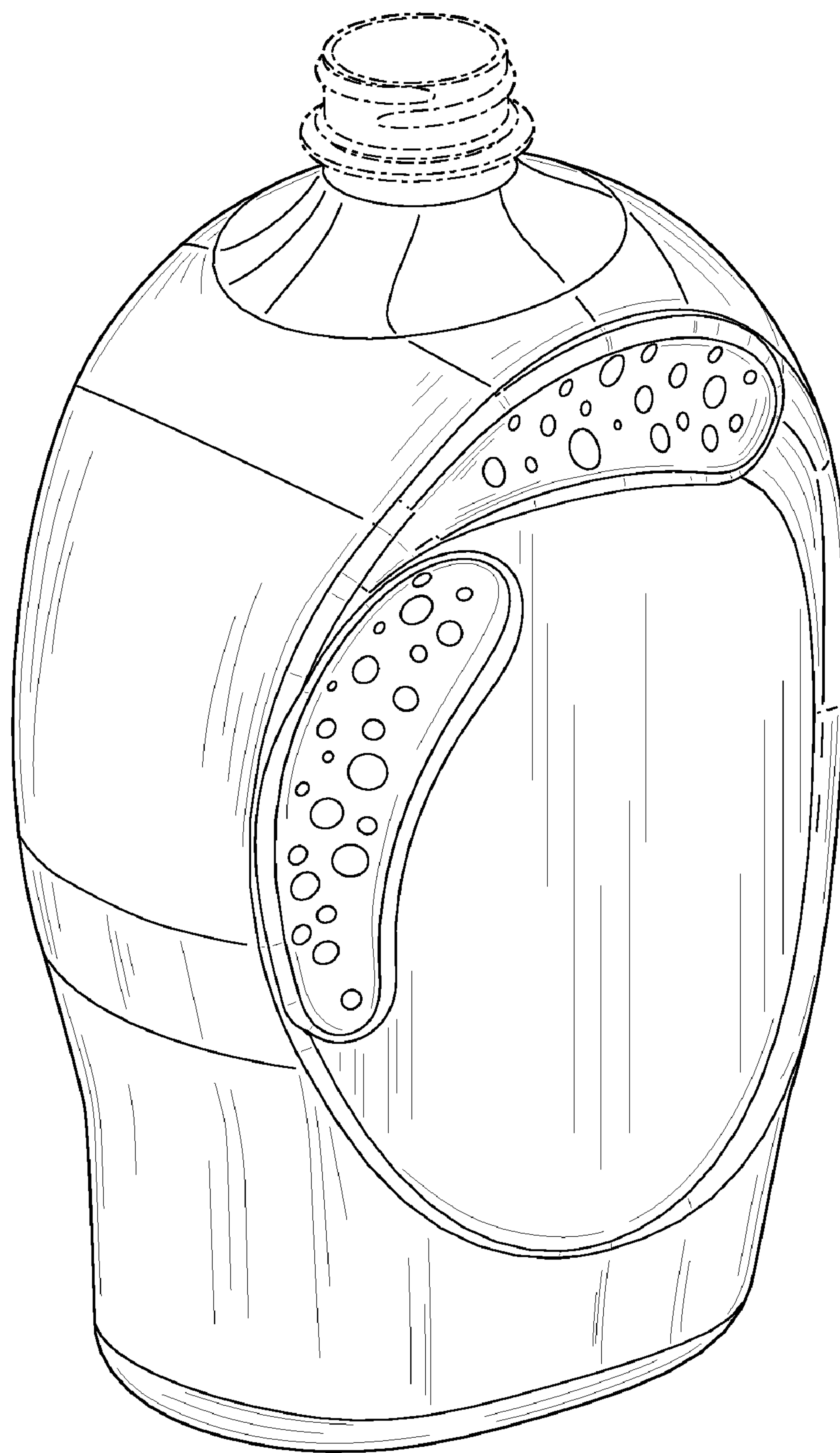

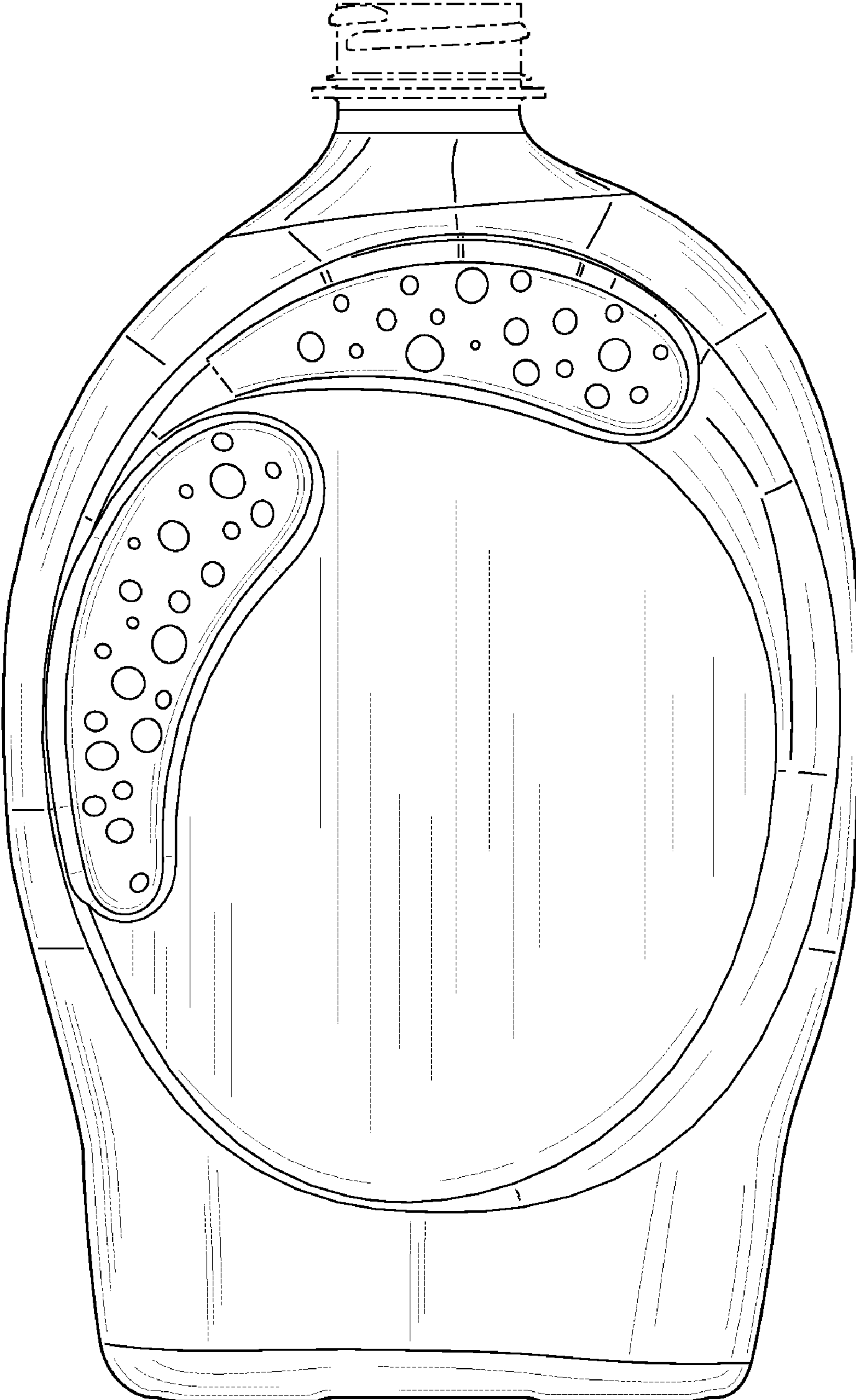

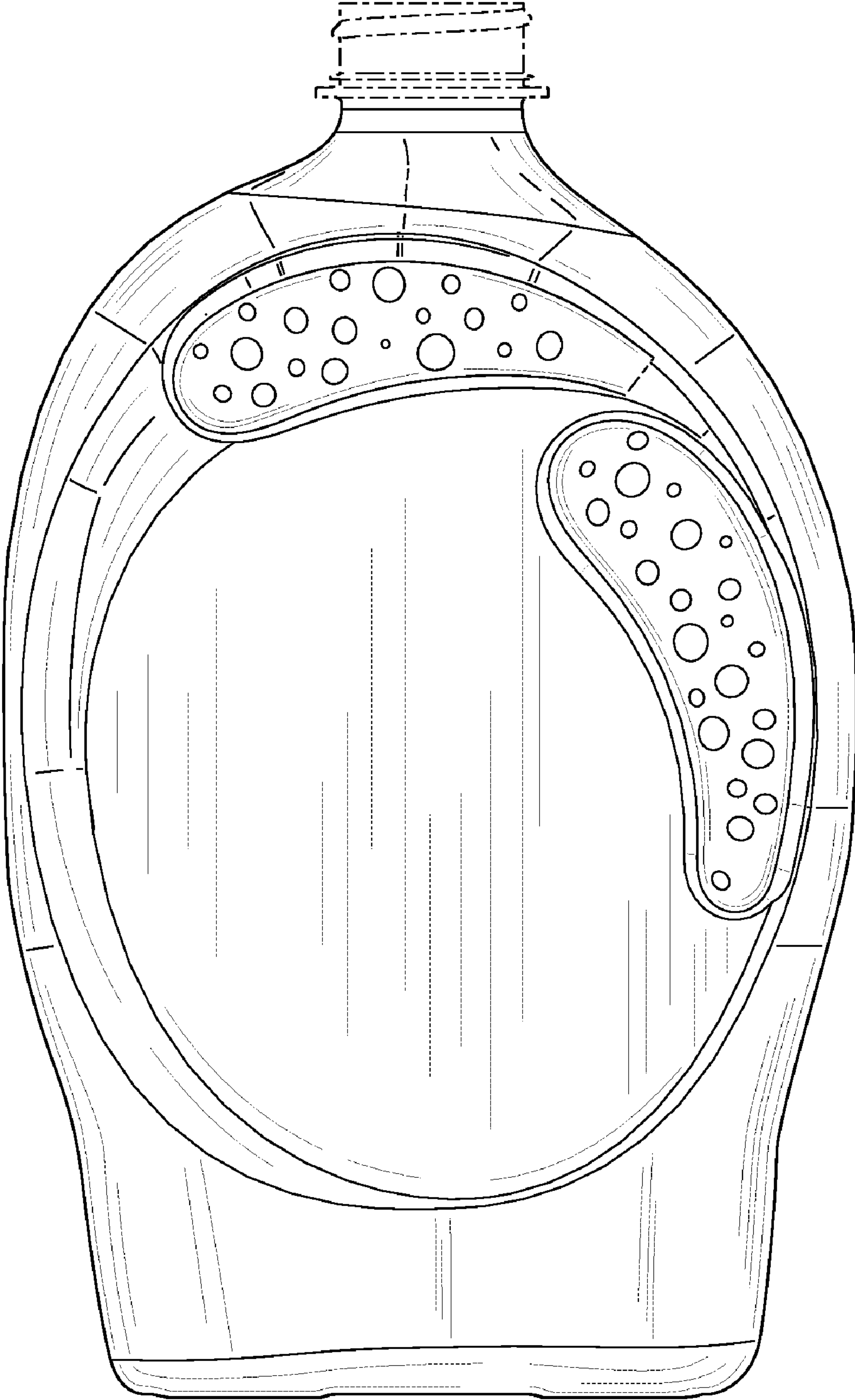

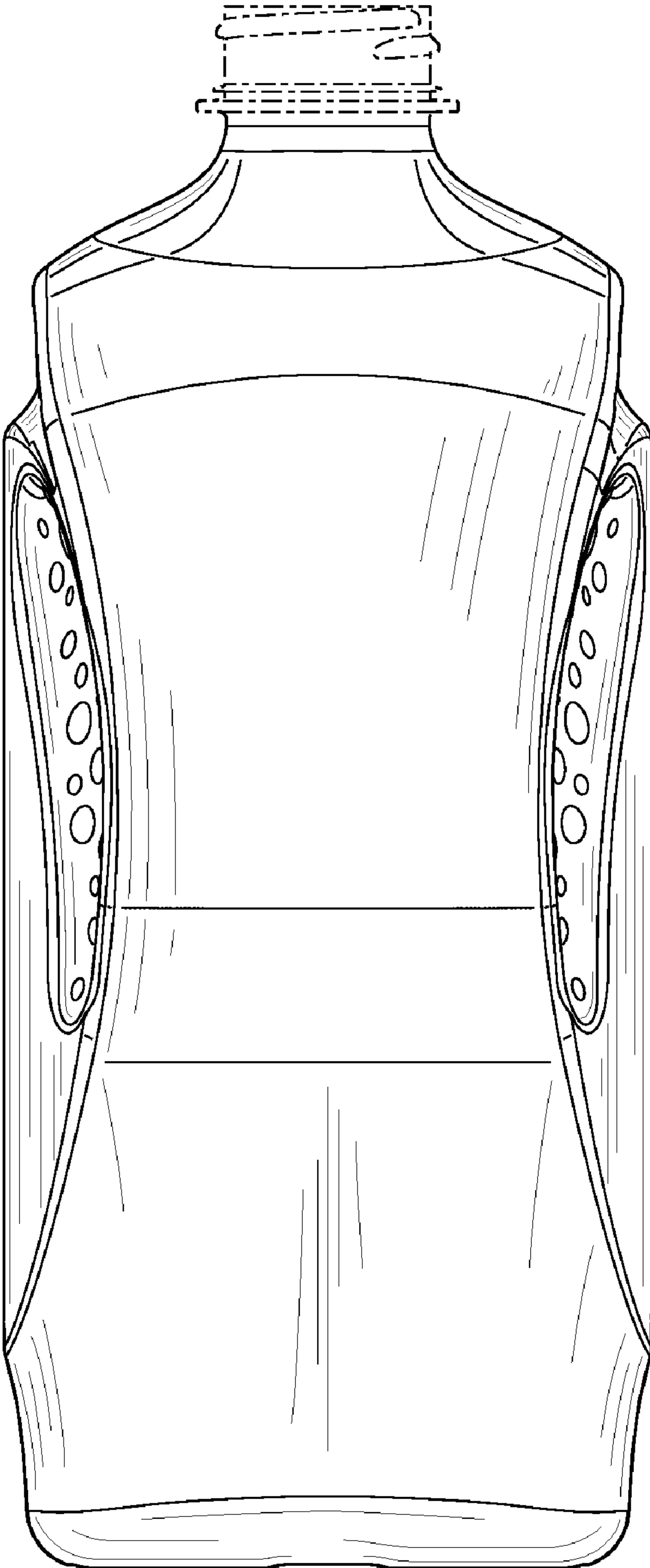

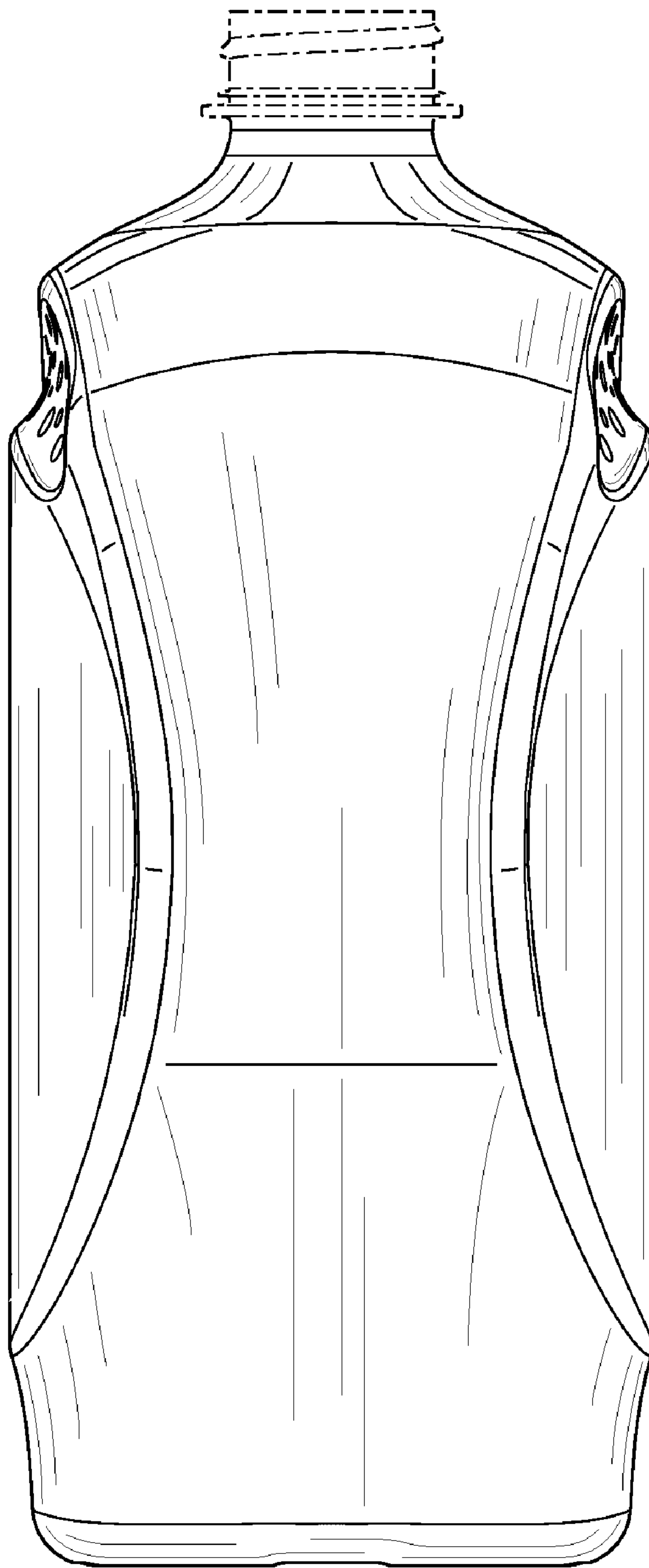

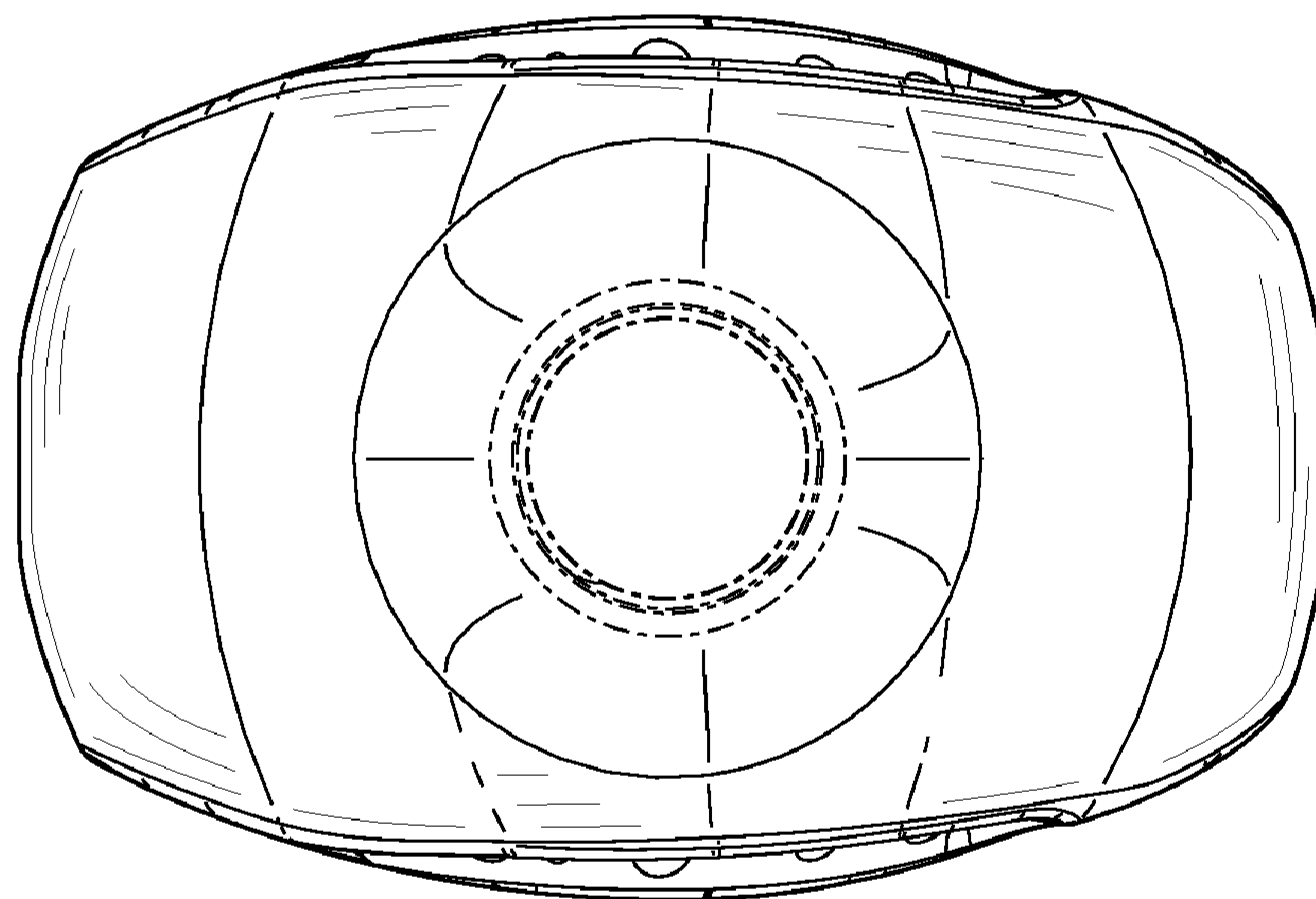

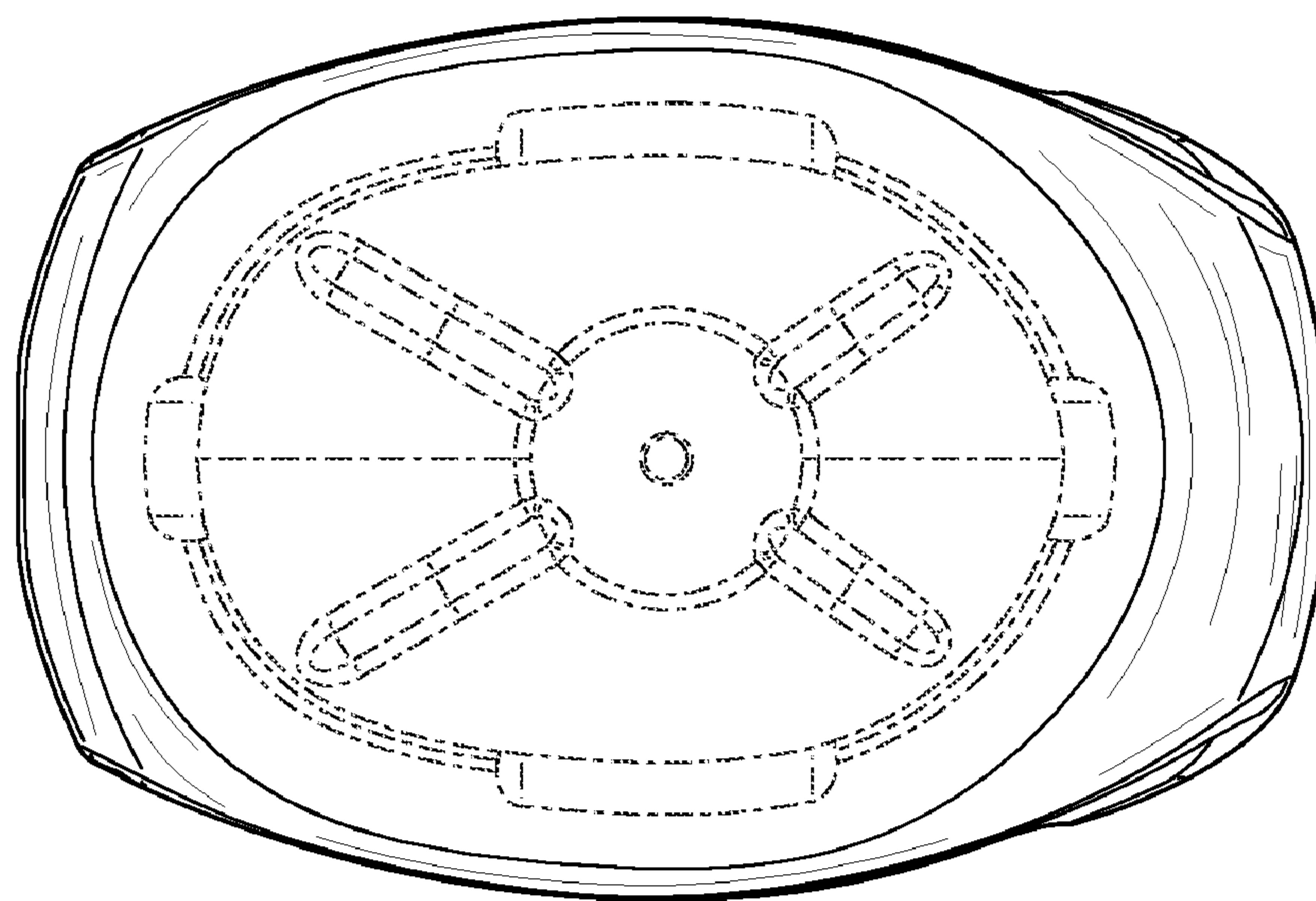
