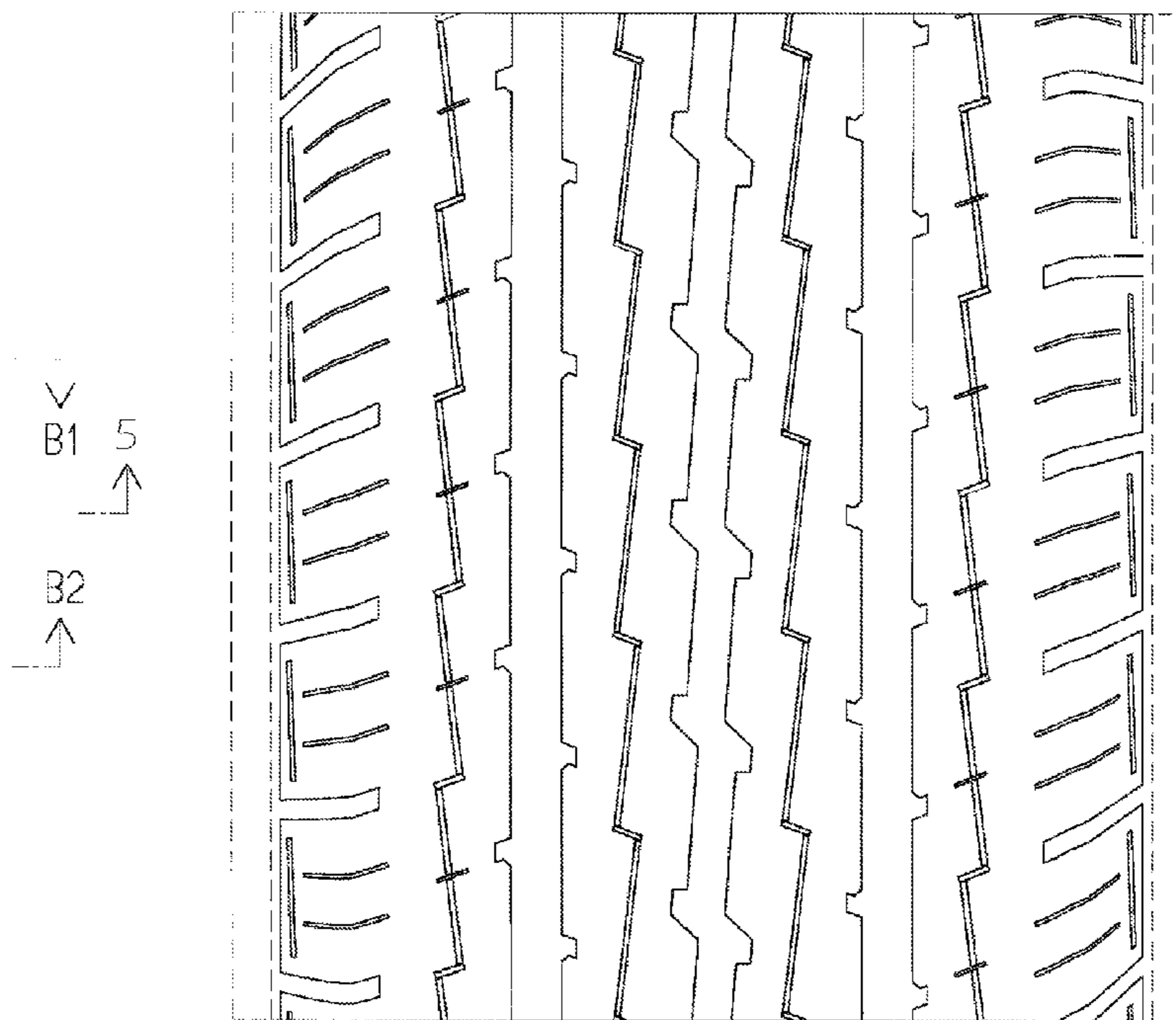
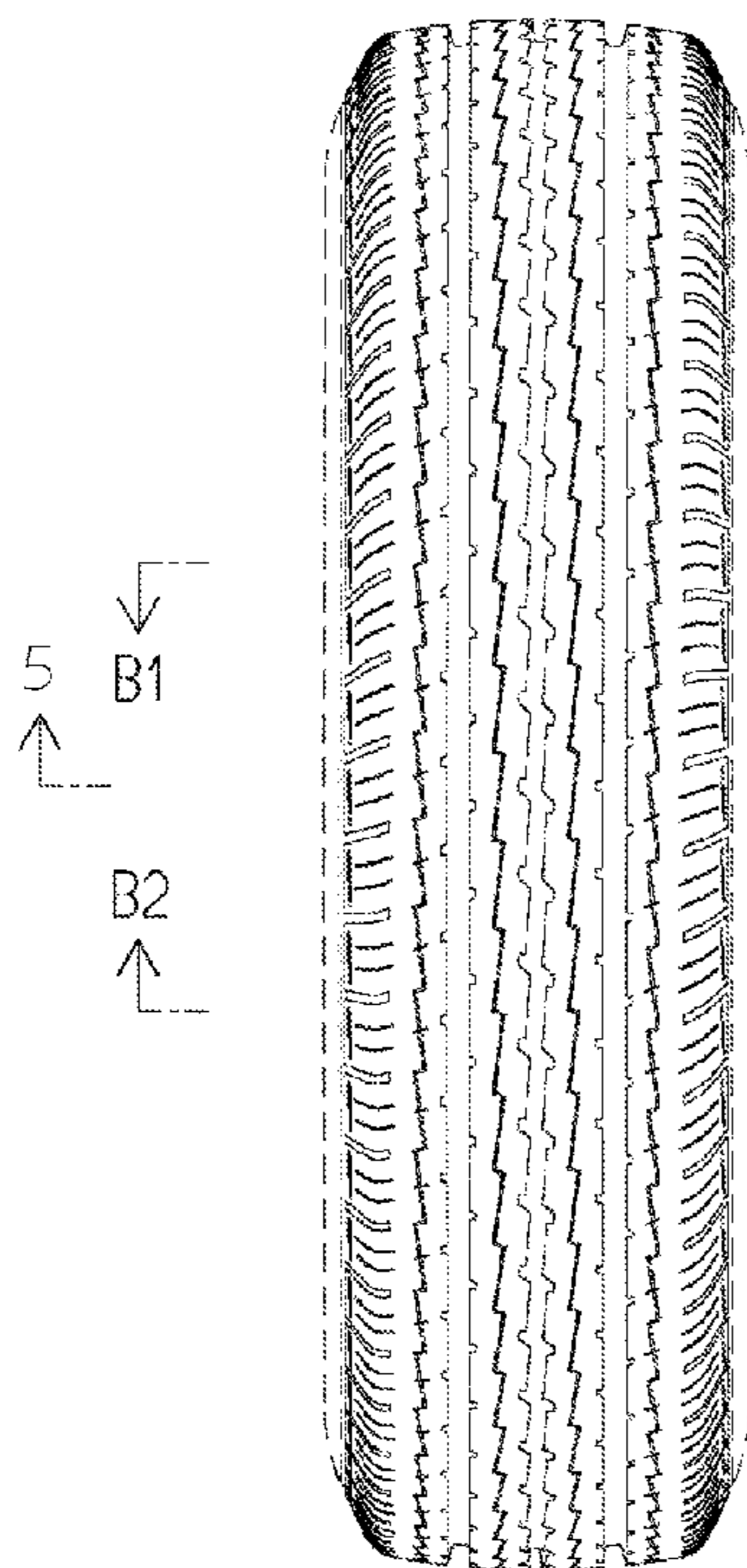
The ornamental design for an automobile tire, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view thereof;  
FIG. 2 is a right side view thereof;  
FIG. 3 is a top view thereof;  
FIG. 4 is a perspective view thereof;  
FIG. 5 is an enlarged cross-section view taken along the line 5-5 in FIG. 1; and,

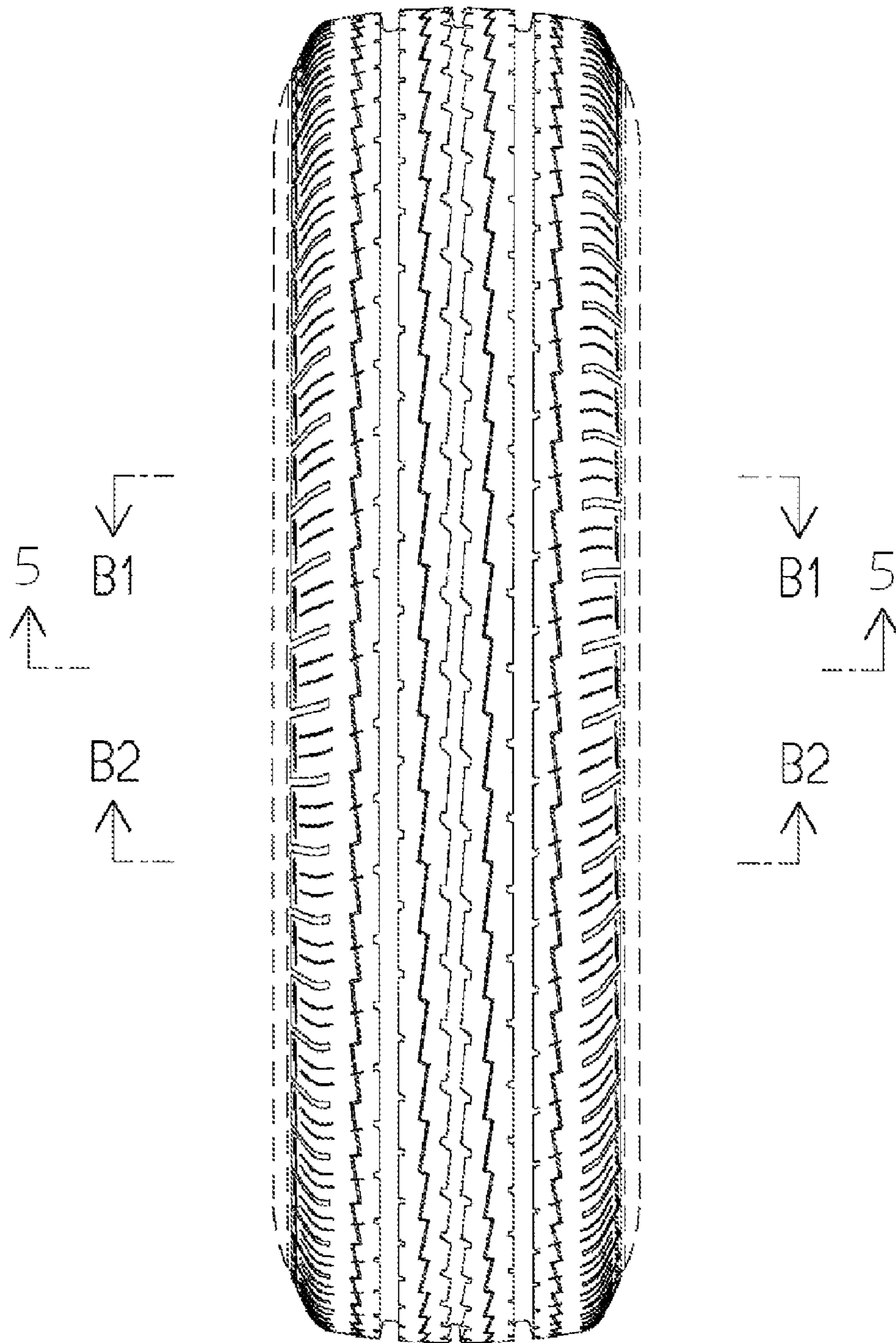

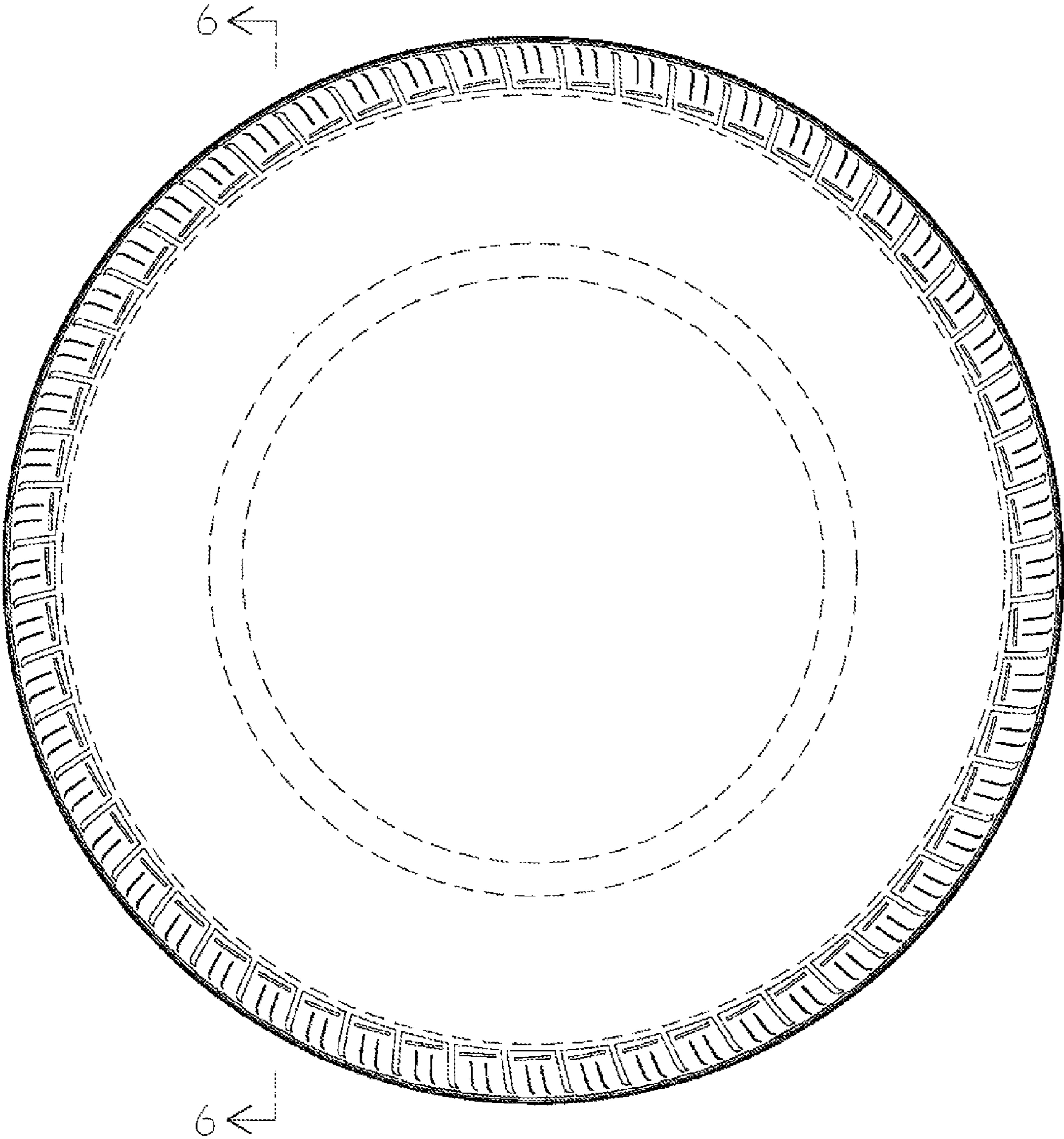

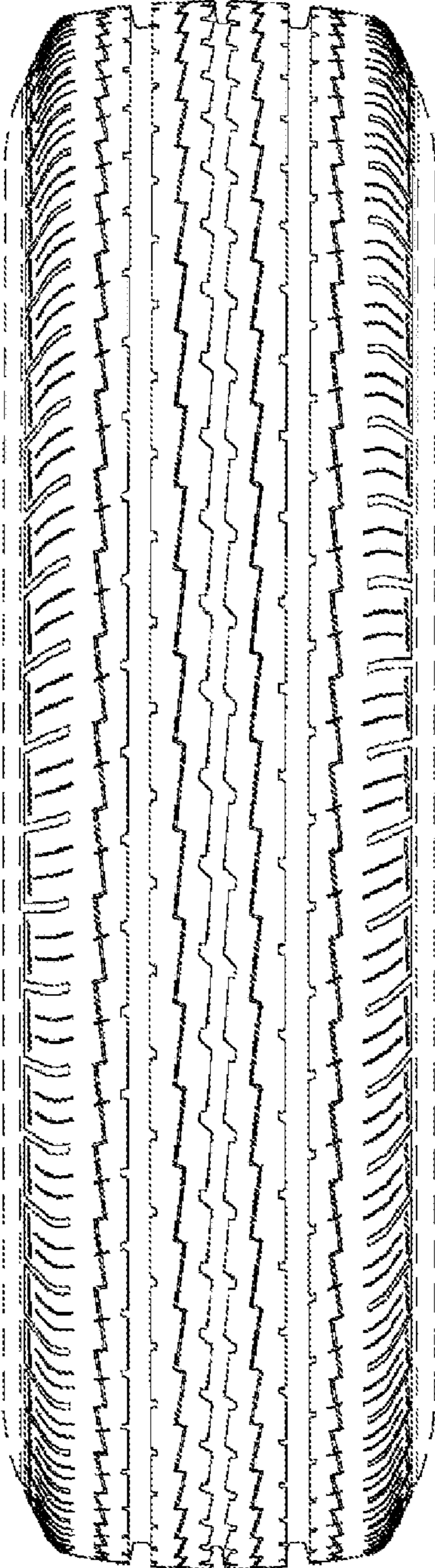

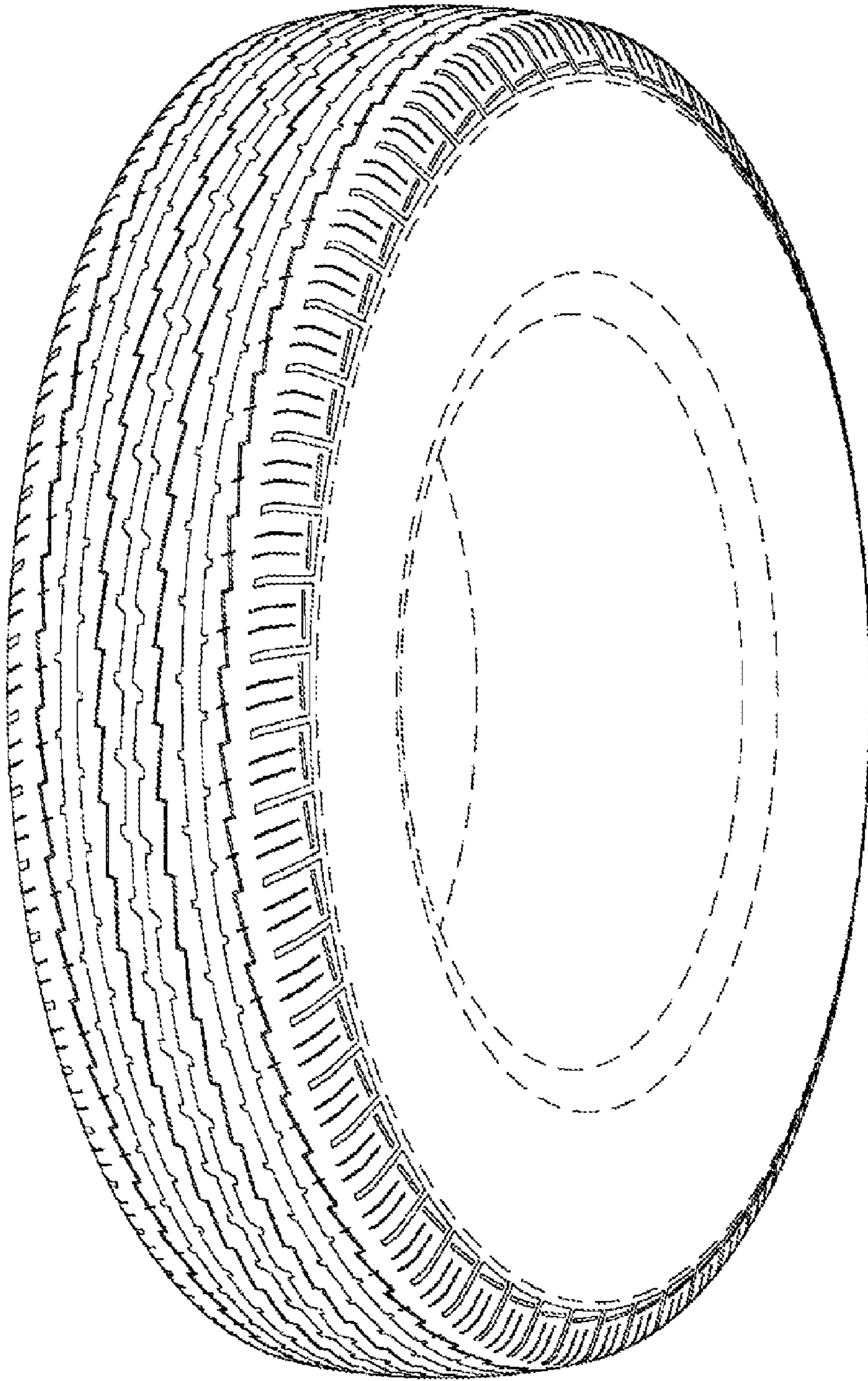

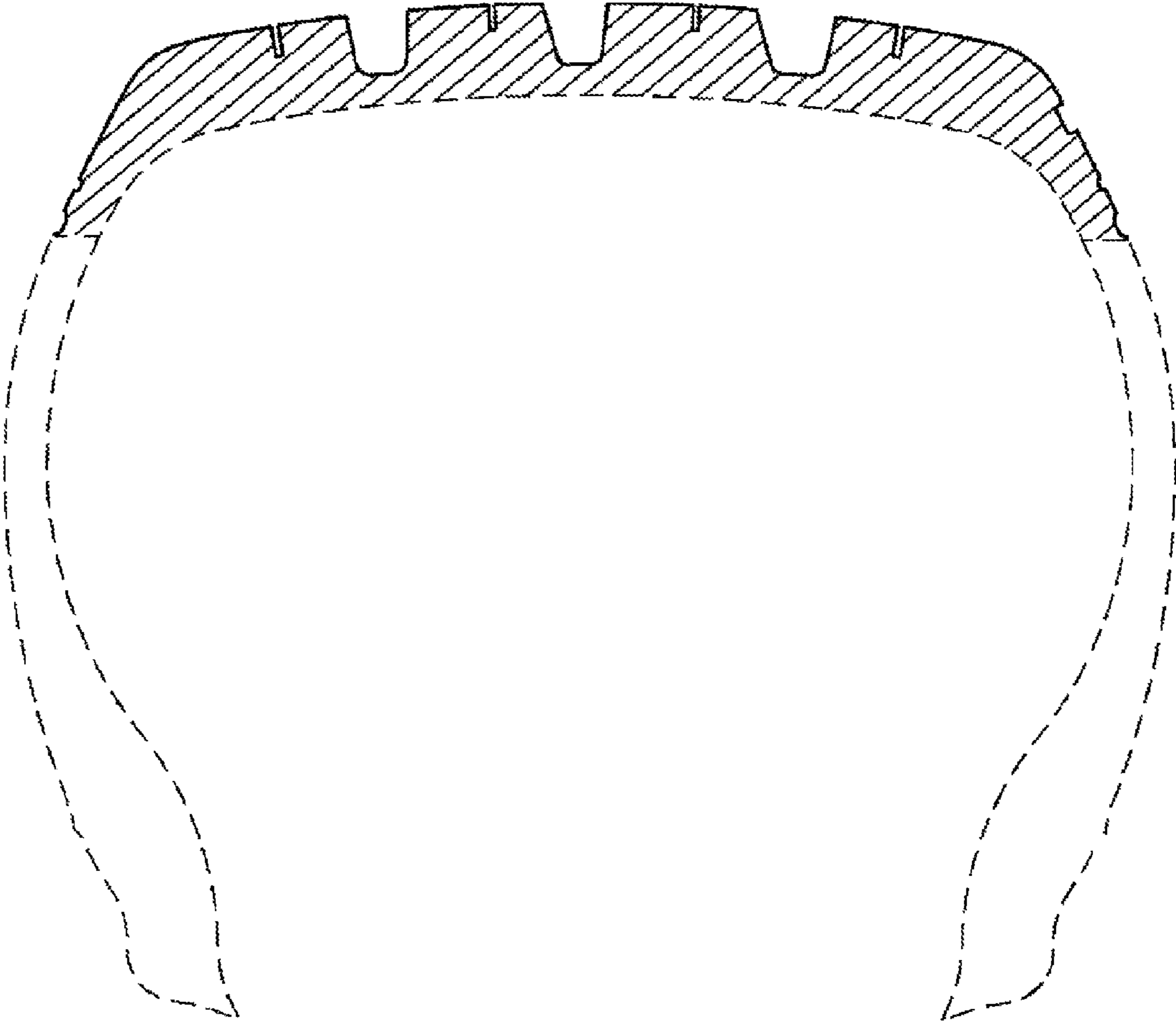

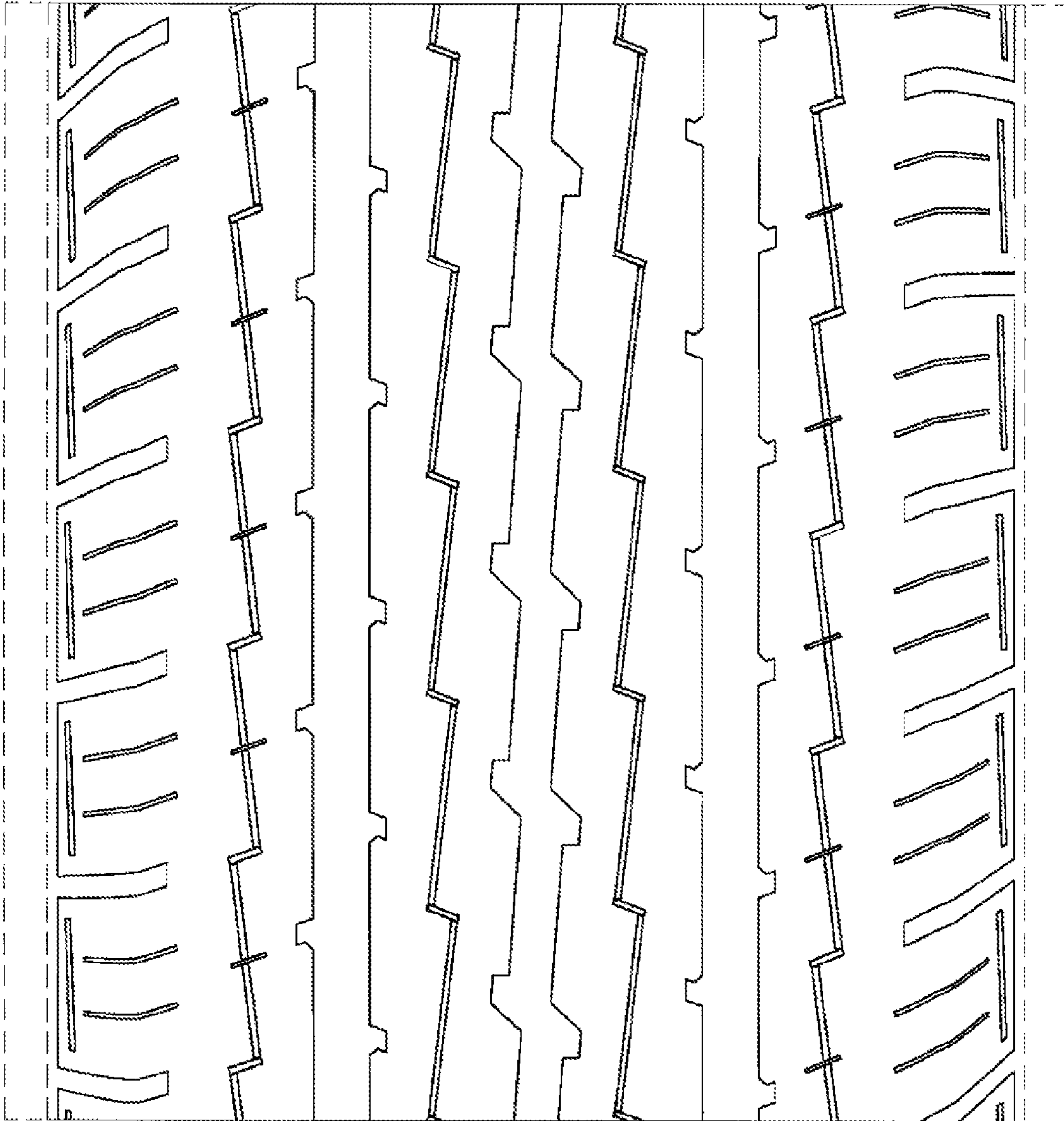
