DESCRIPTION

FIG. 1 is a front perspective view of a secure cable distribution box with an a first and second access door in a closed position;

FIG. 6 is a top plan view thereof;

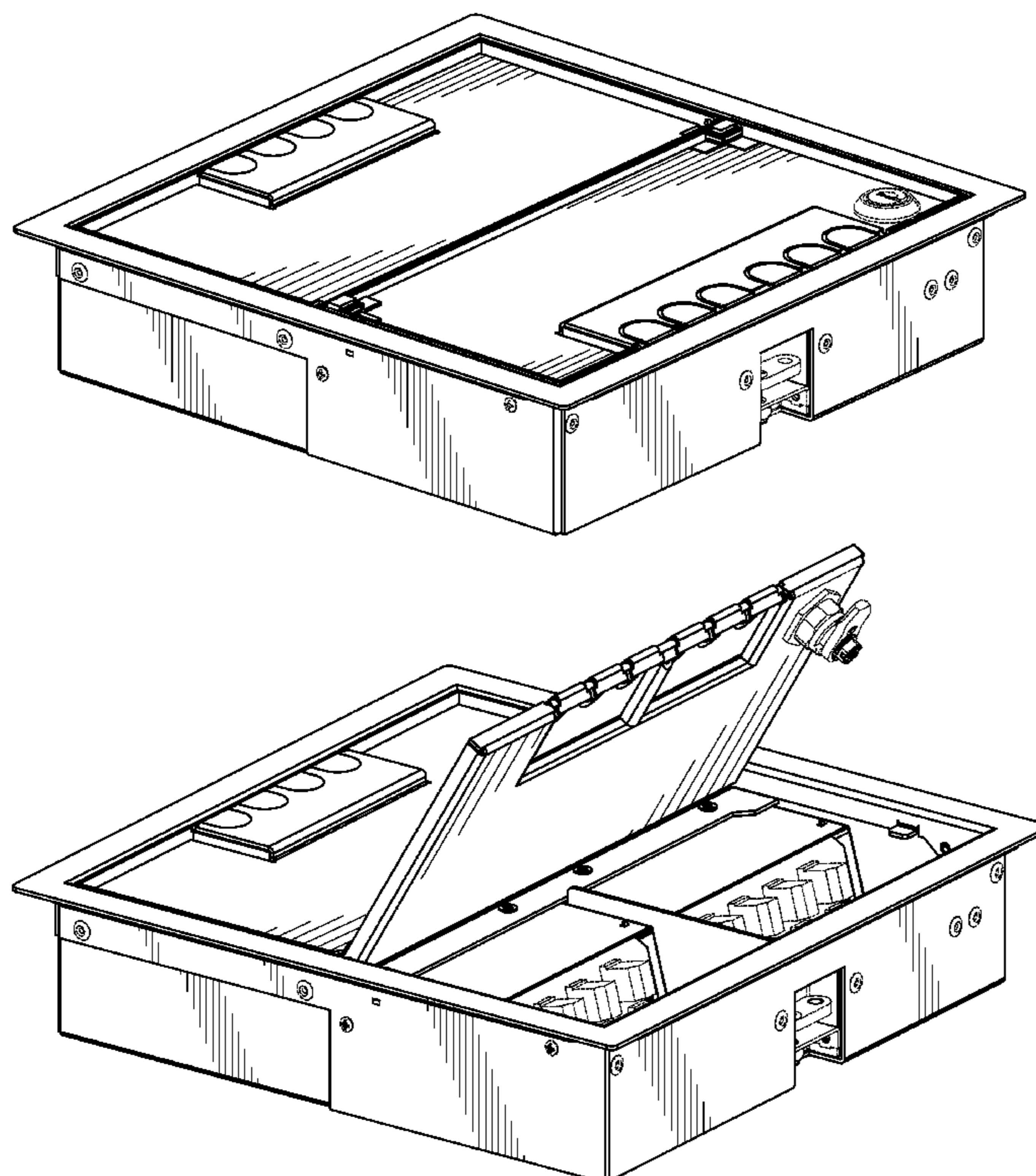
FIG. 7 is a bottom plan view thereof;

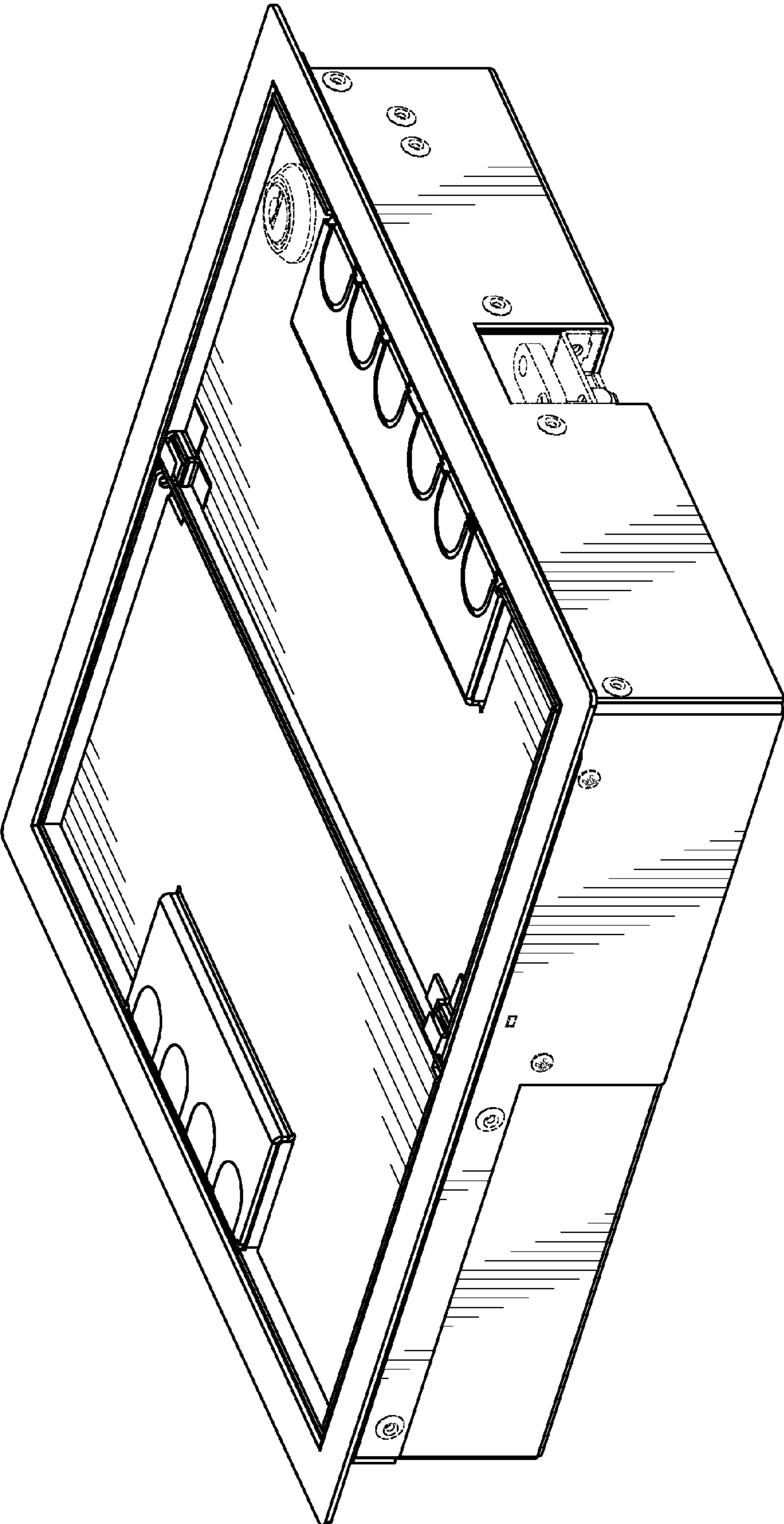

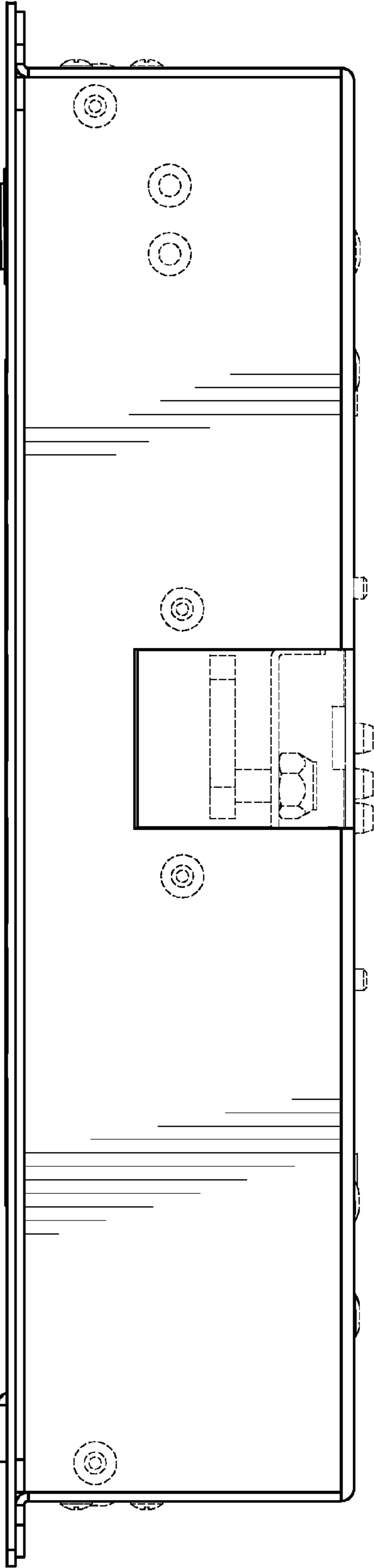

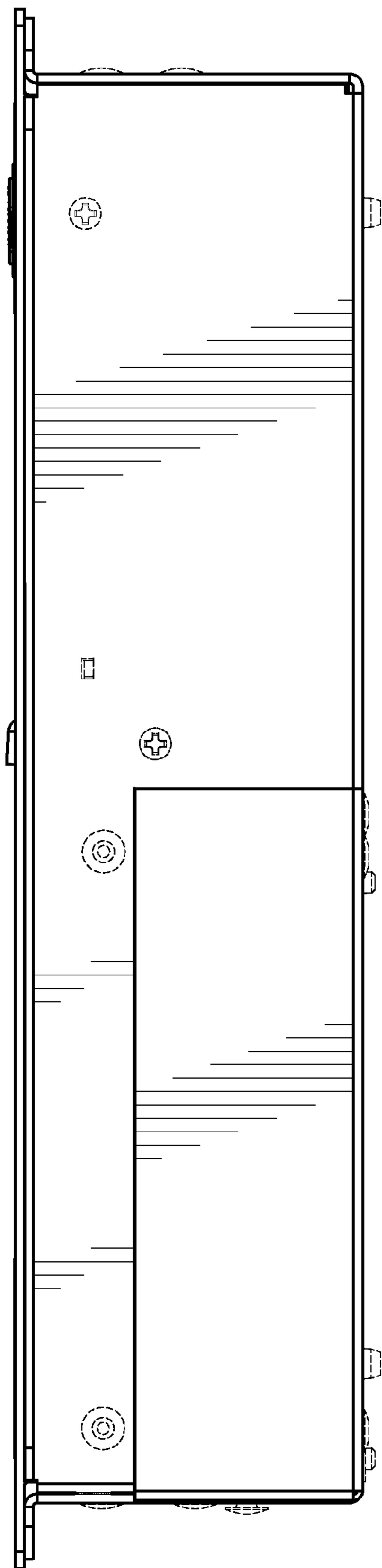

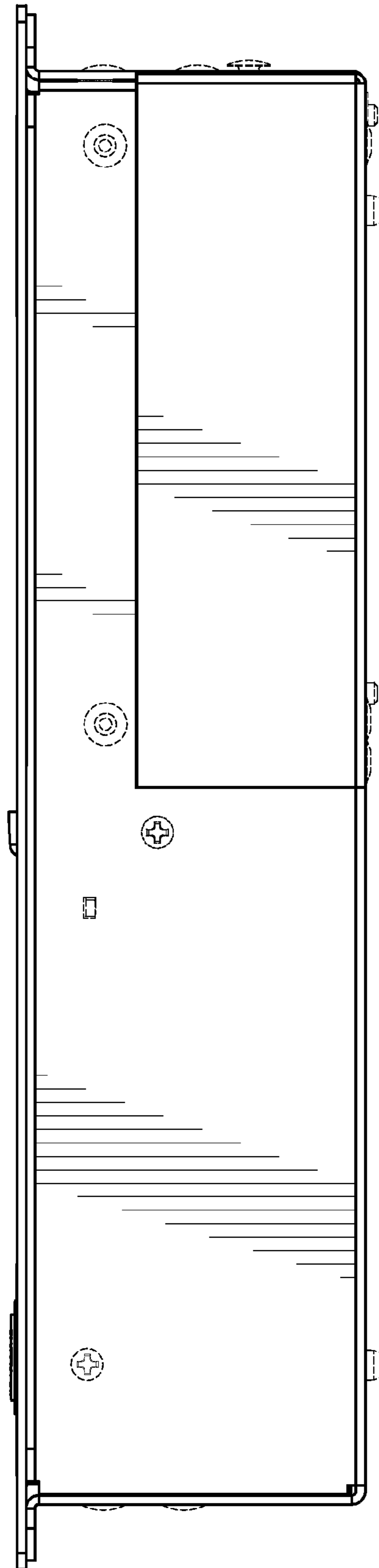

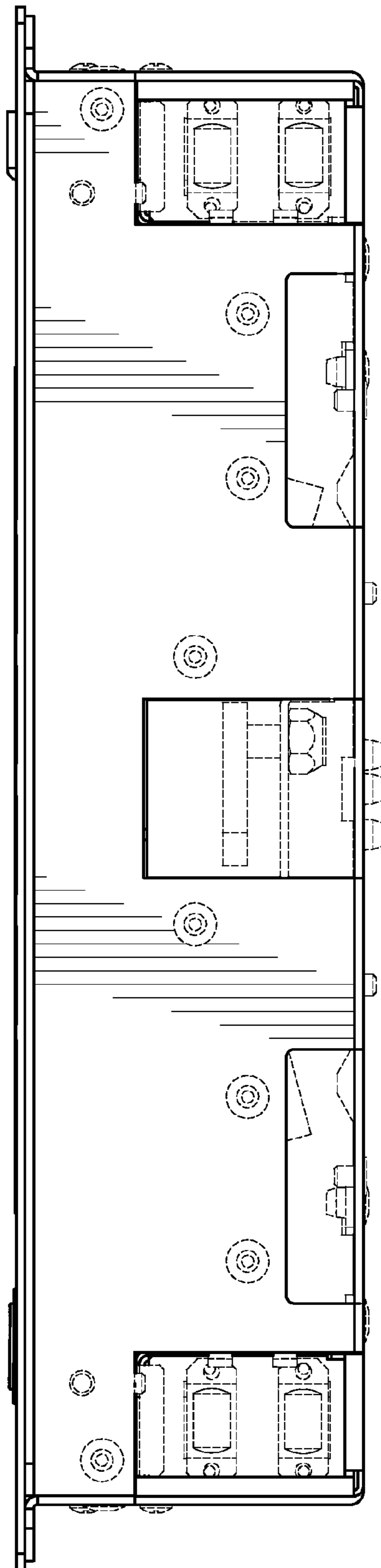

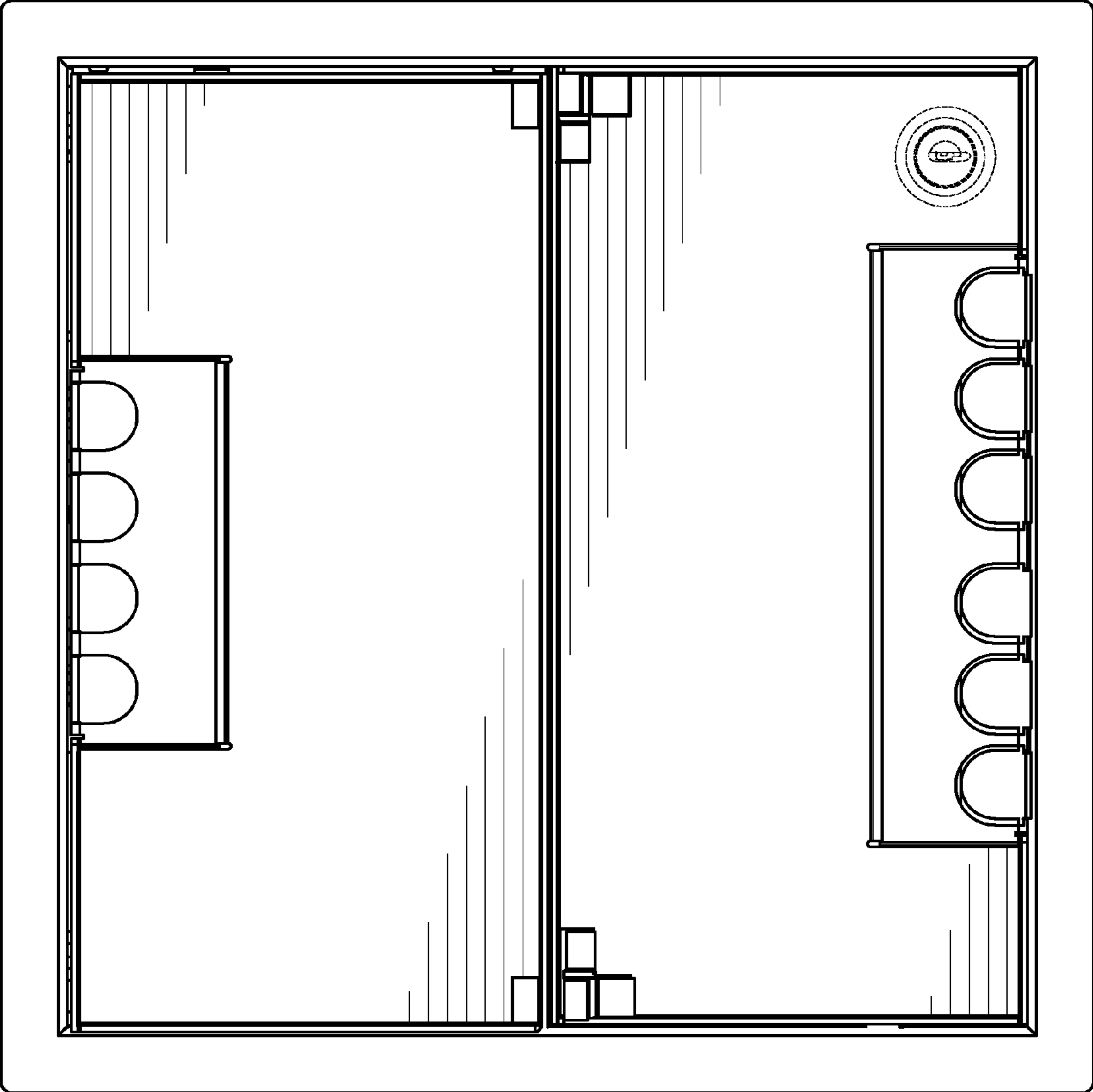

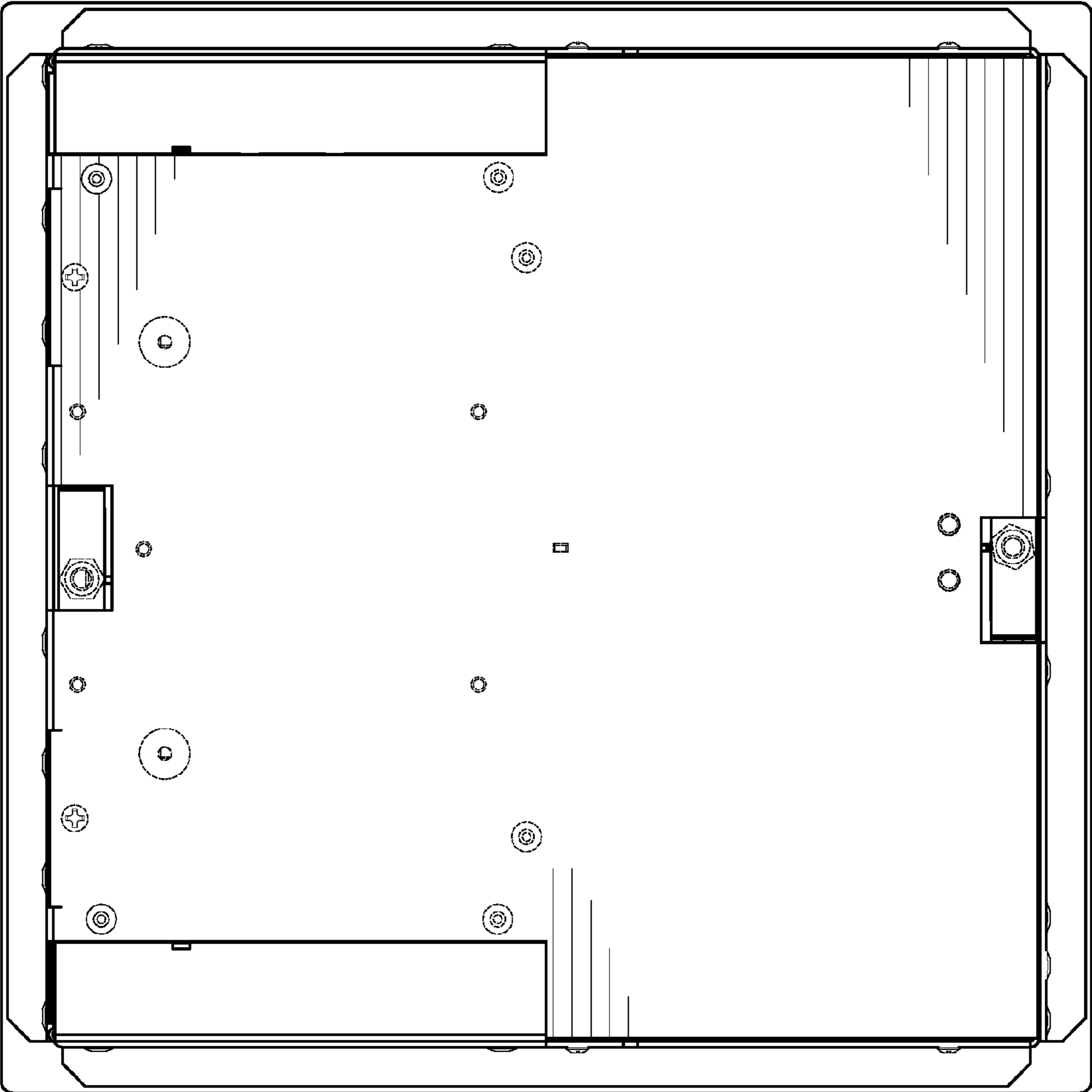

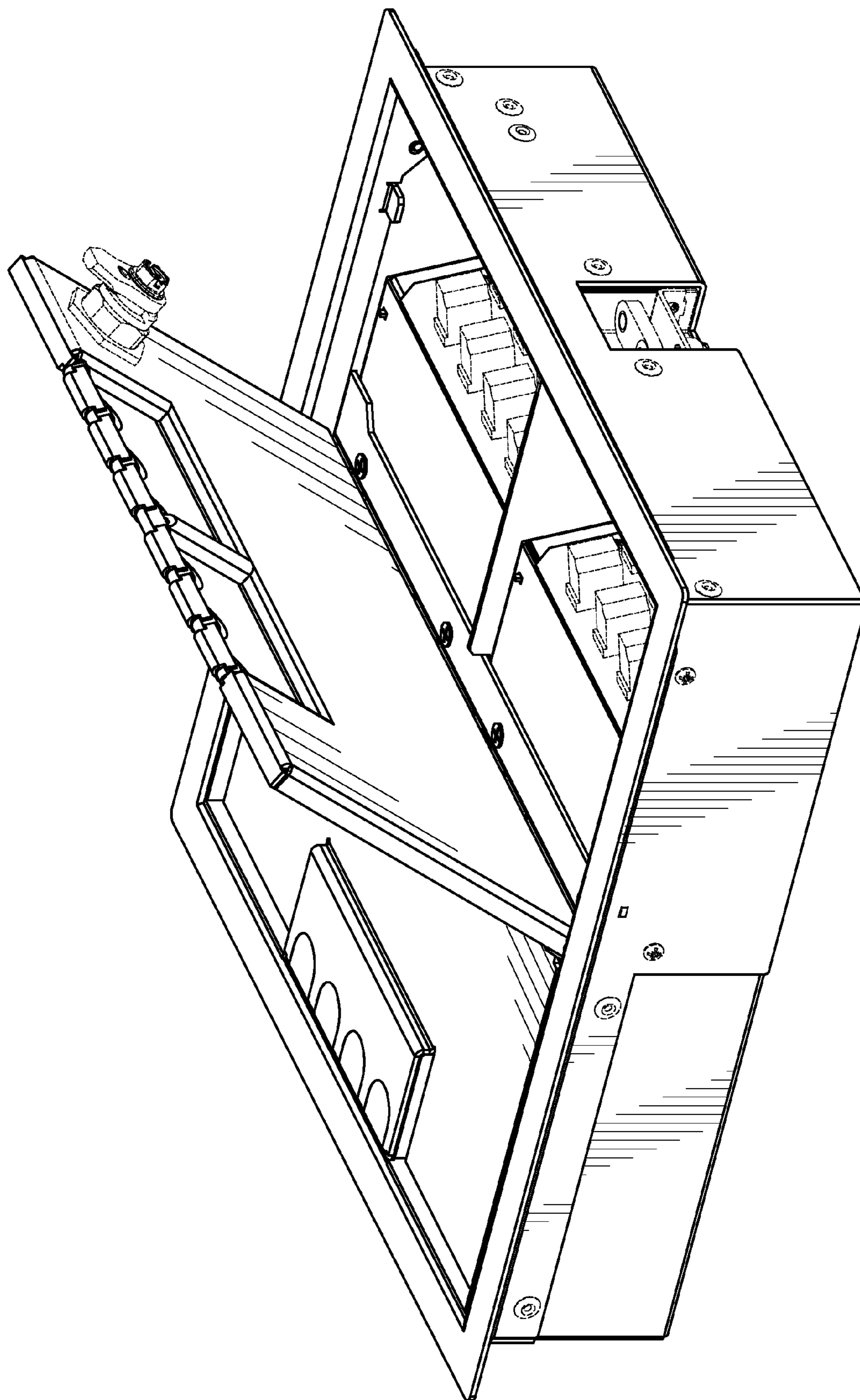

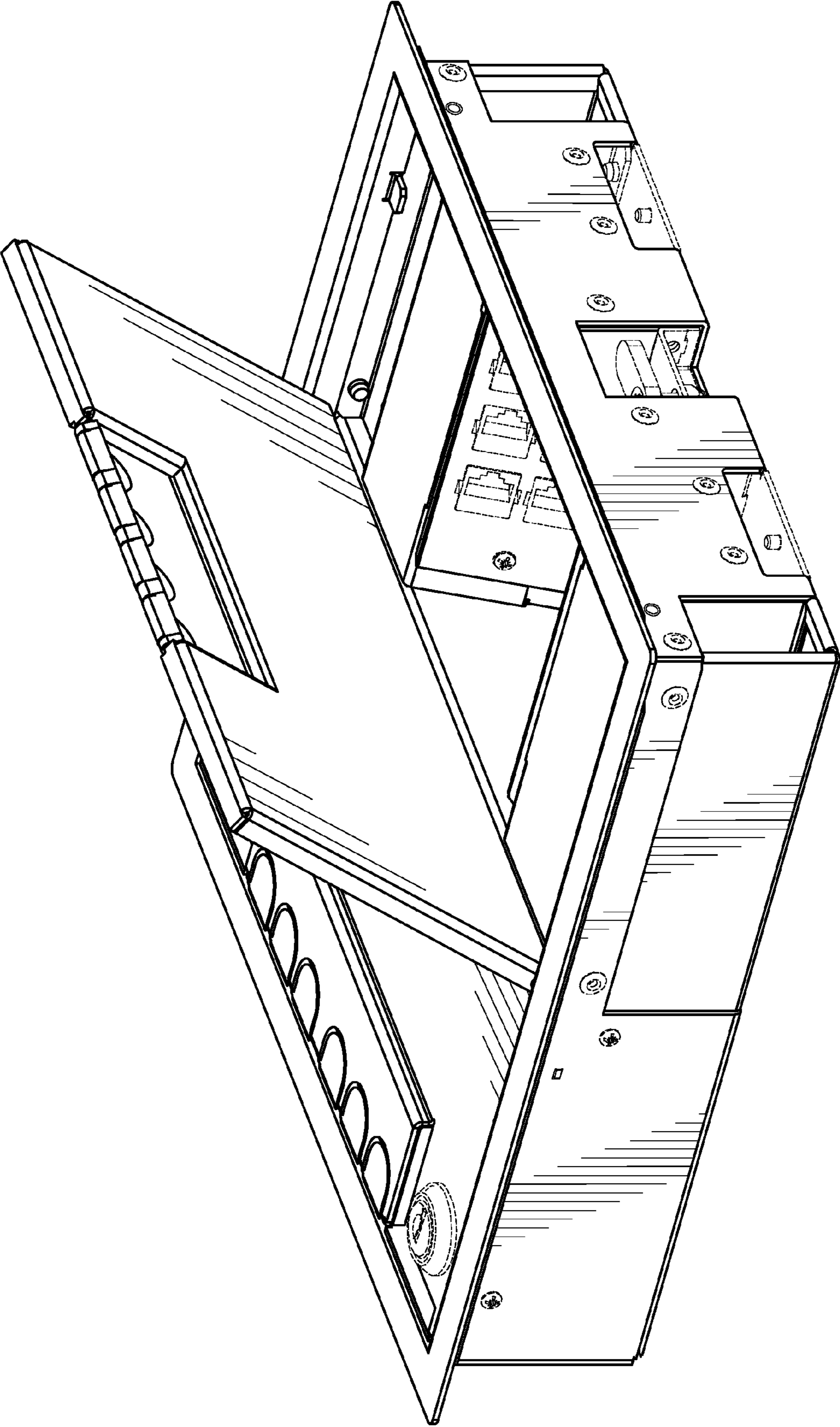
