(57) **CLAIM**

The ornamental design for a hand-held electronic controller, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a hand-held electronic controller which forms our new design;

FIG. 2 is a bottom plan view thereof wherein the broken lines showing portions of the controller is for illustrative purposes only and forming no part of the claimed design;

FIG. 3 is a front elevational view thereof;

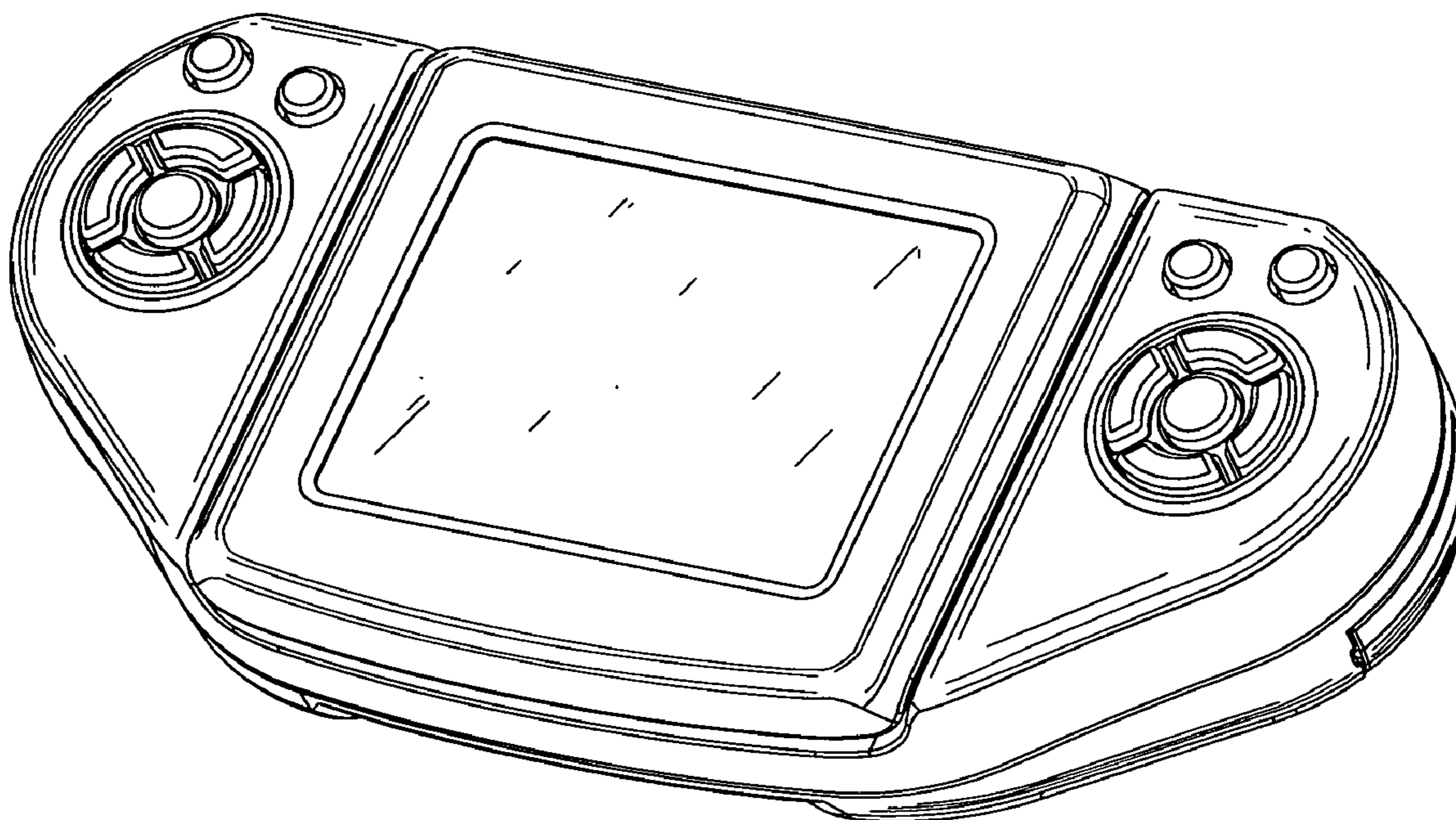
FIG. 4 is a rear elevational view thereof wherein the broken lines showing portions of the controller are for illustrative purposes only and forming no part of the claimed design;

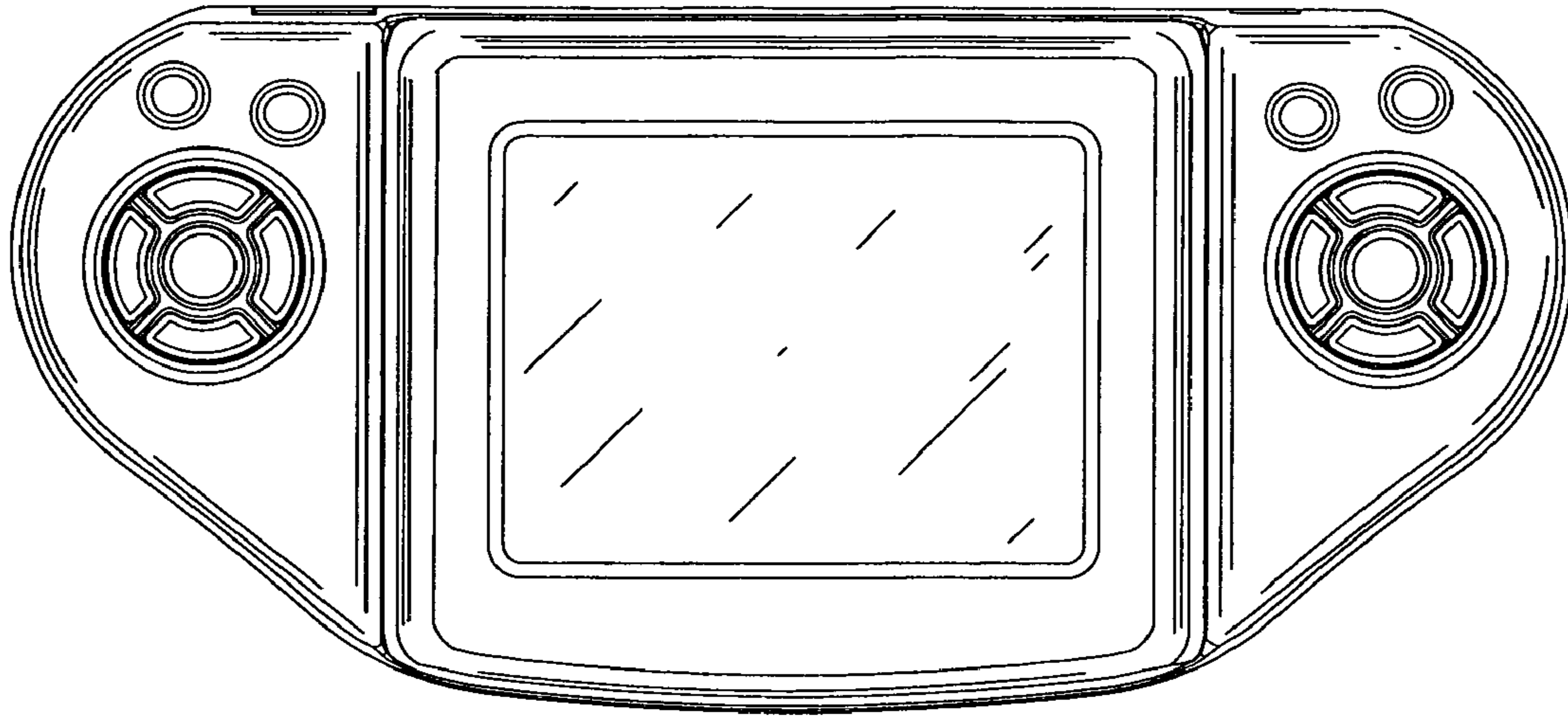

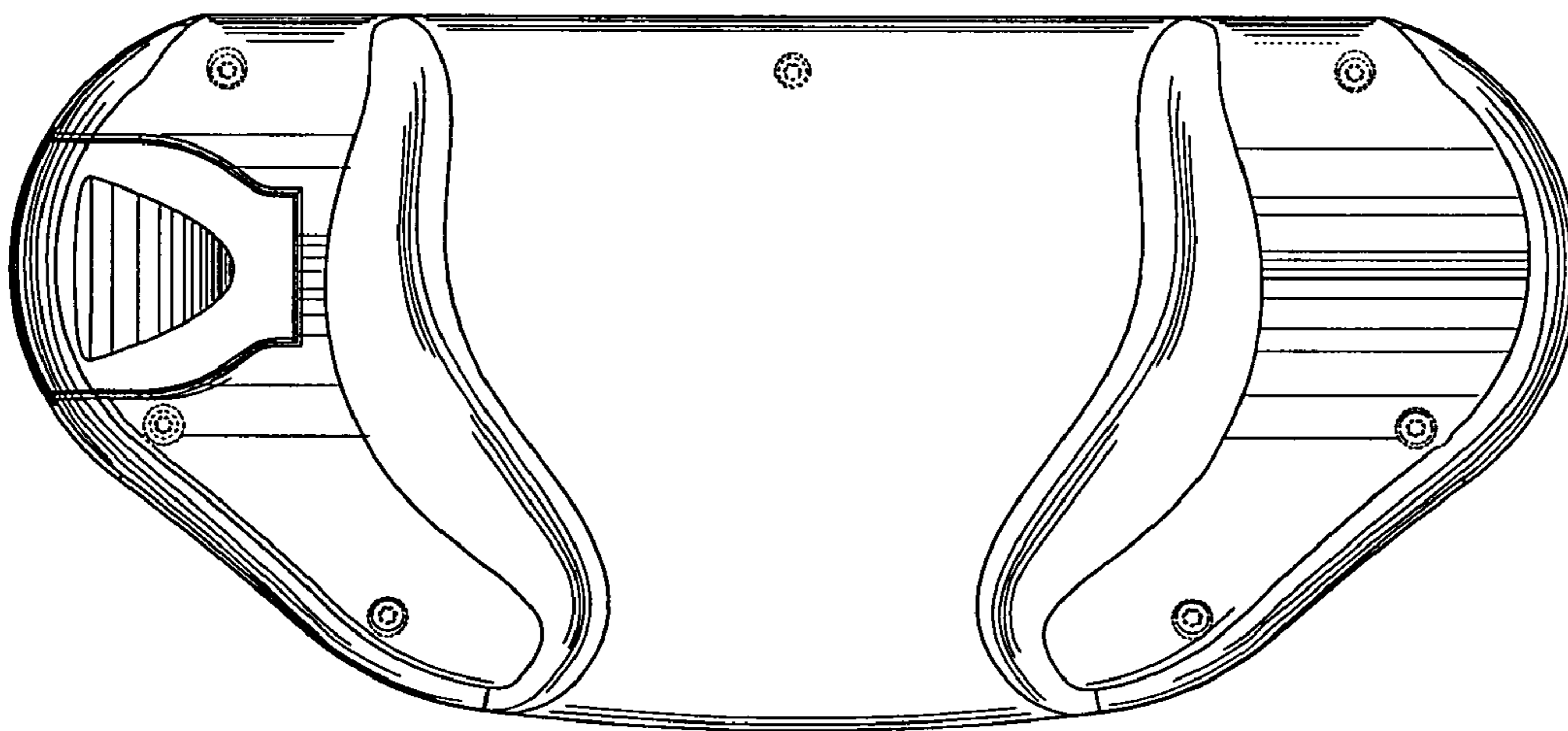

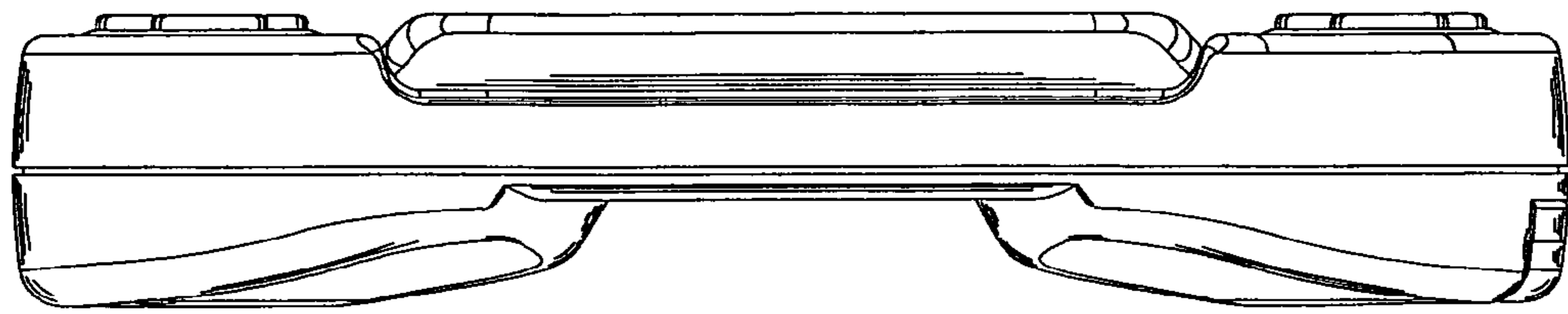

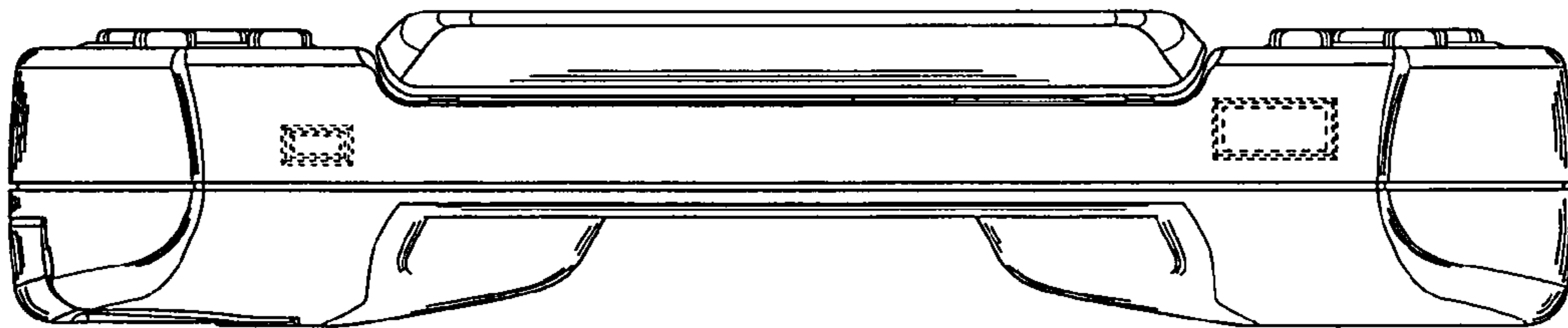

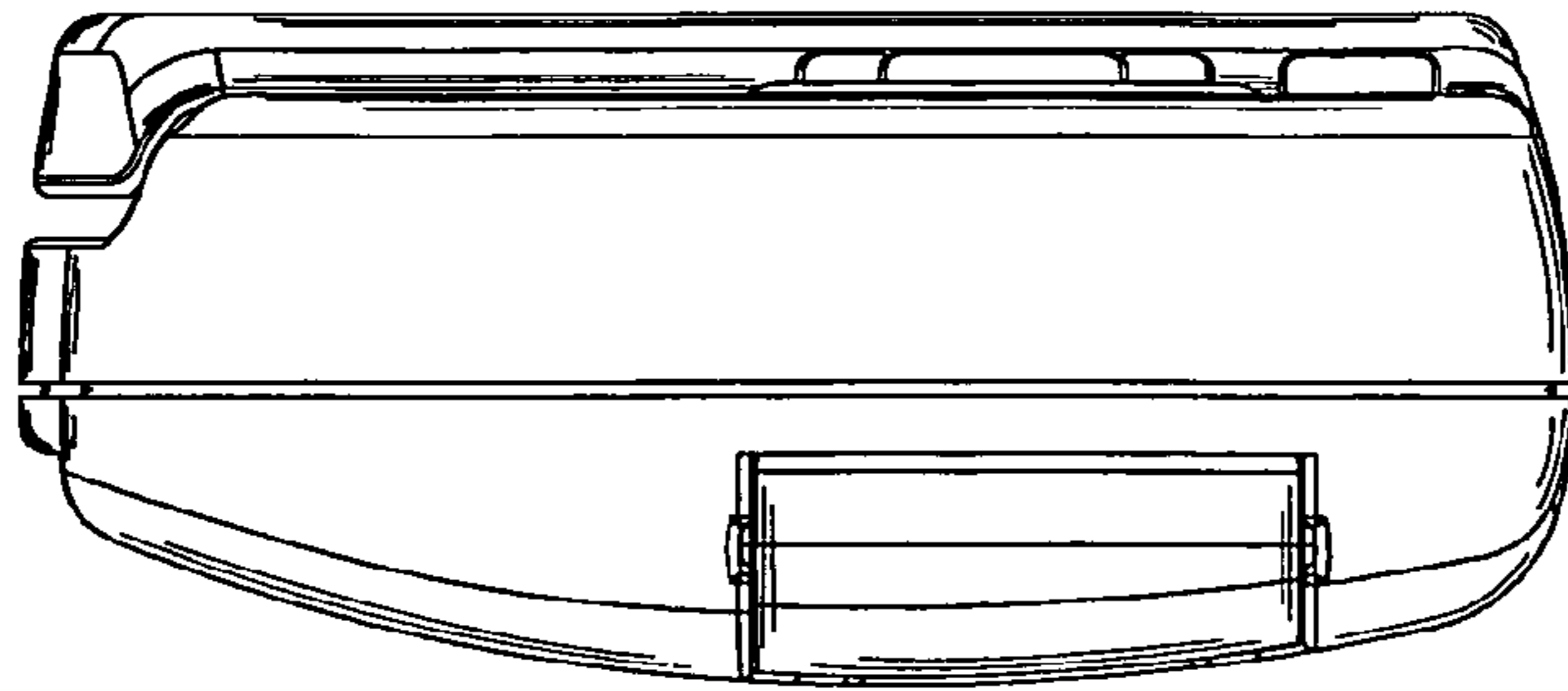

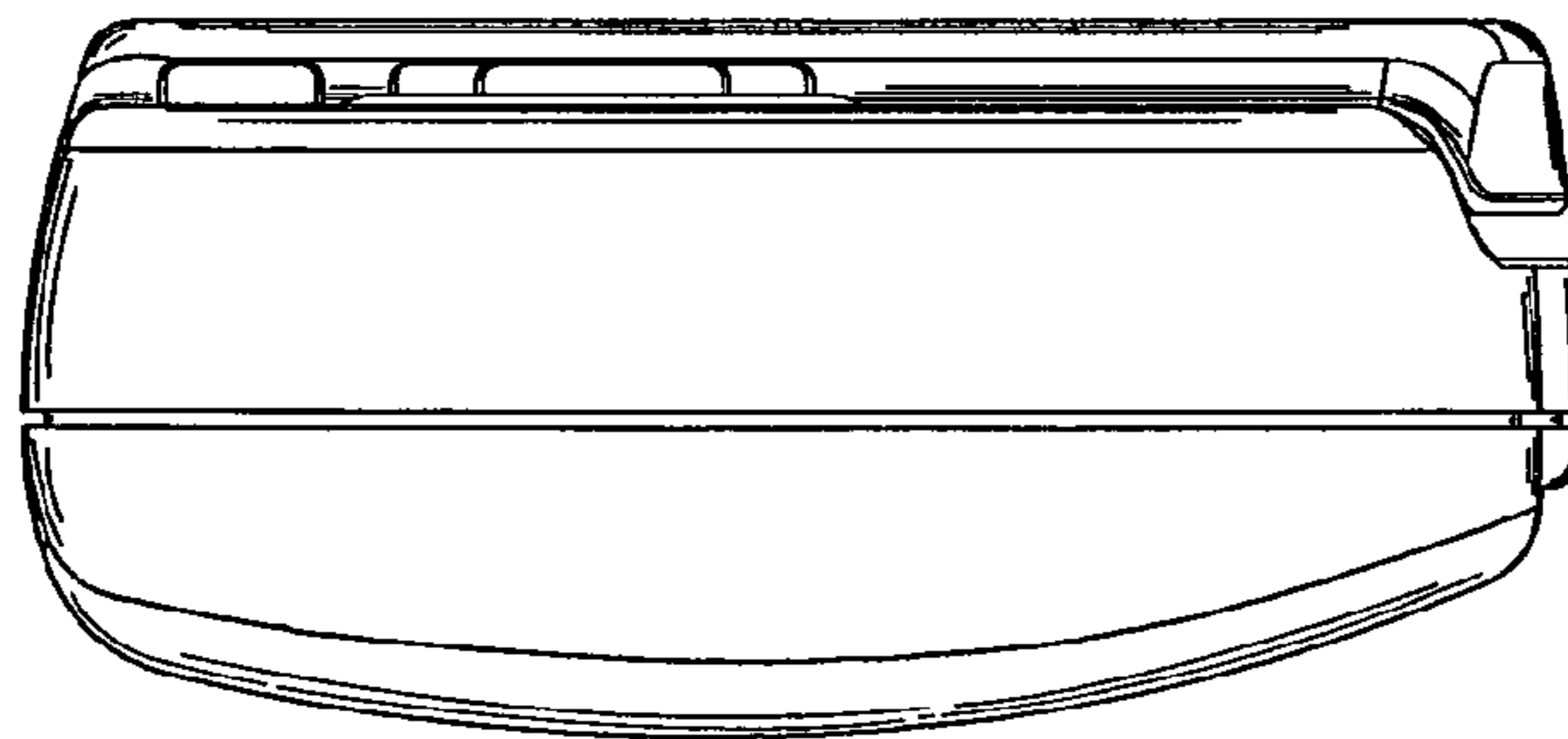

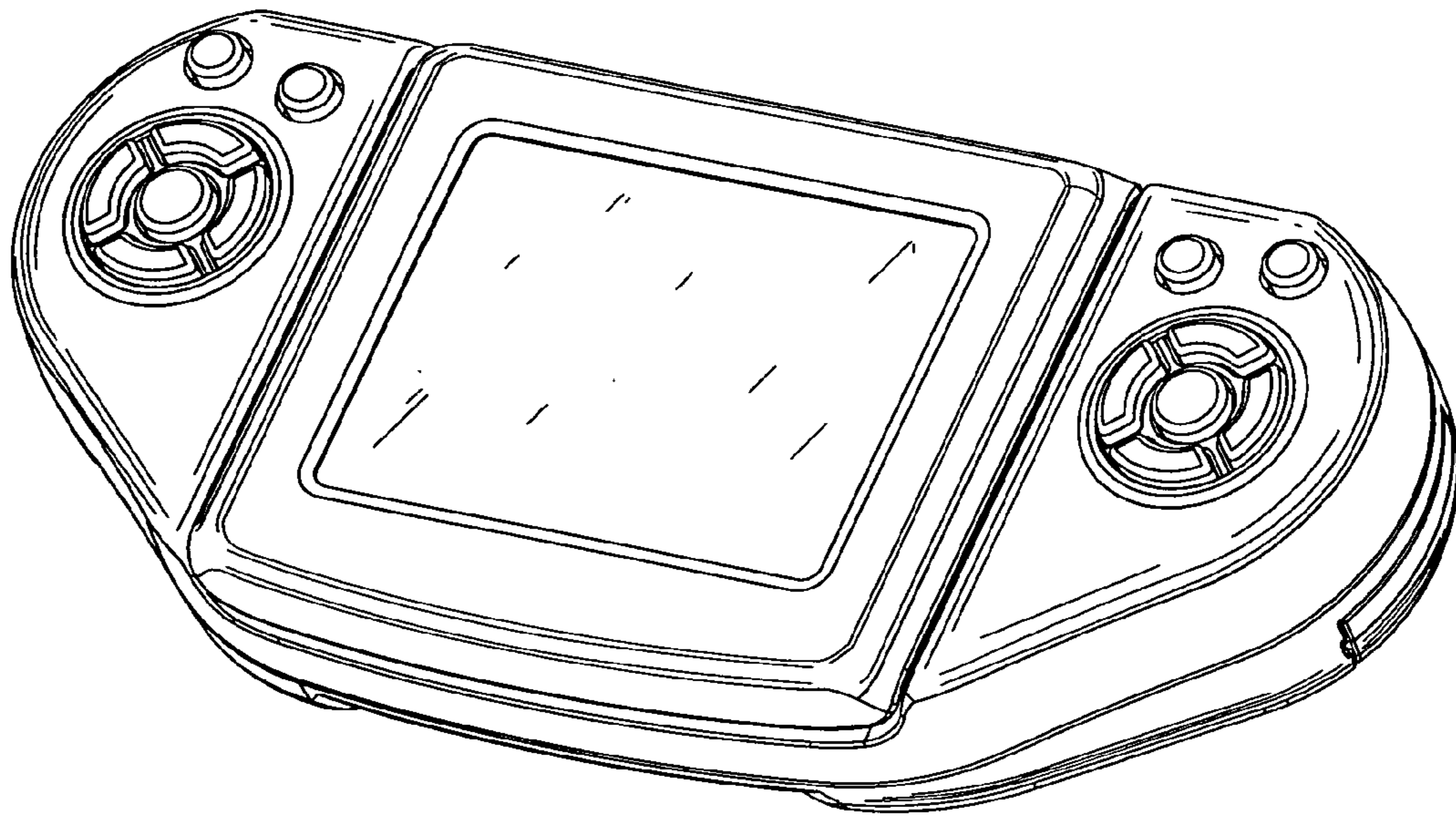
