(57) **CLAIM**

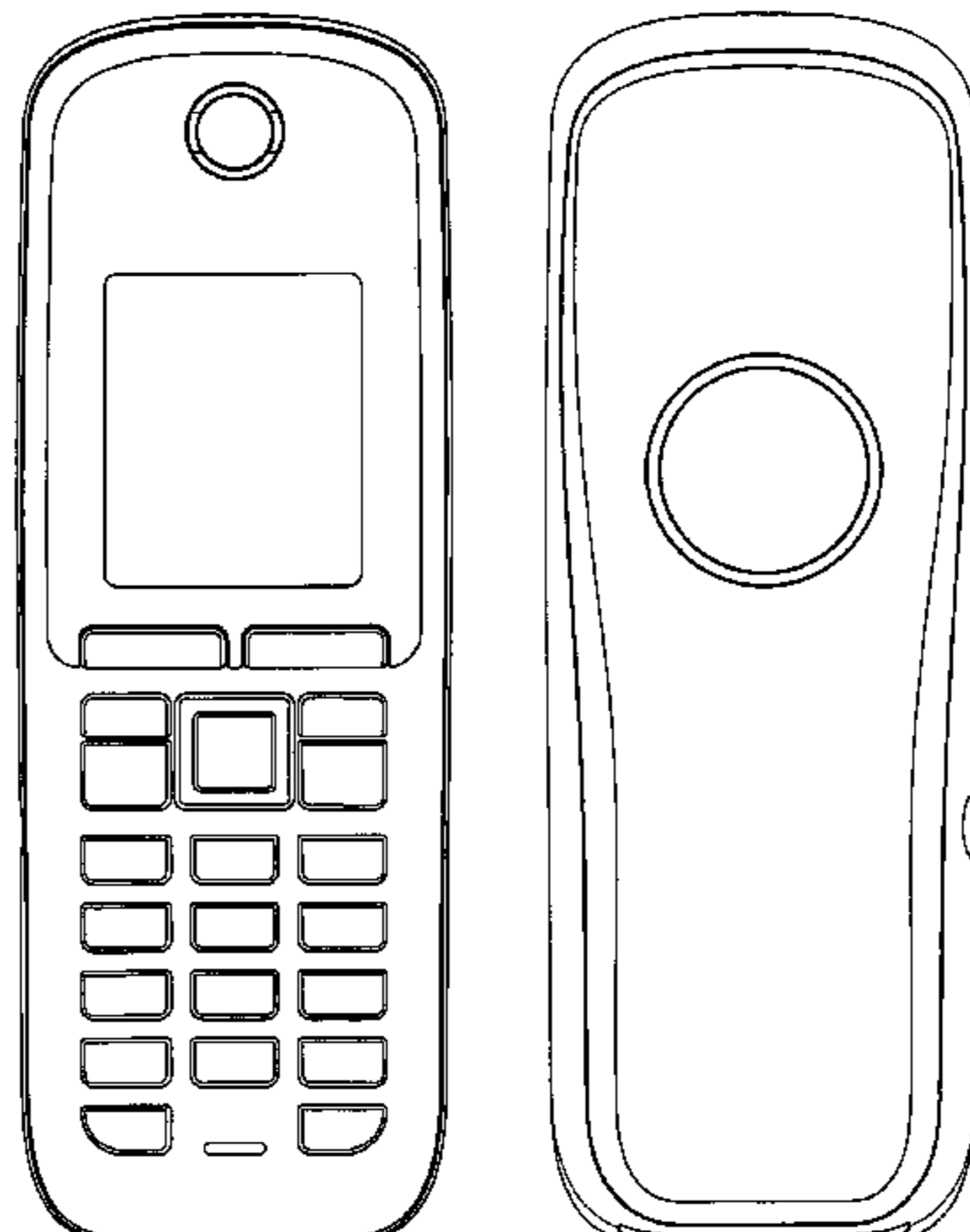
The ornamental design for a cordless telephone, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a cordless telephone showing our new design;
 FIG. 2 is a rear elevational view thereof;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a bottom plan view thereof;
 FIG. 5 is a right side view thereof;
 FIG. 6 is a left side view thereof; and,
 FIG. 7 is a perspective view thereof.

In FIG. 6, two concentric circles, a vertical line, and an inner perimeter of a feature surrounding the circles are shown in broken lines for illustrative purposes only and form no part of the claimed design.

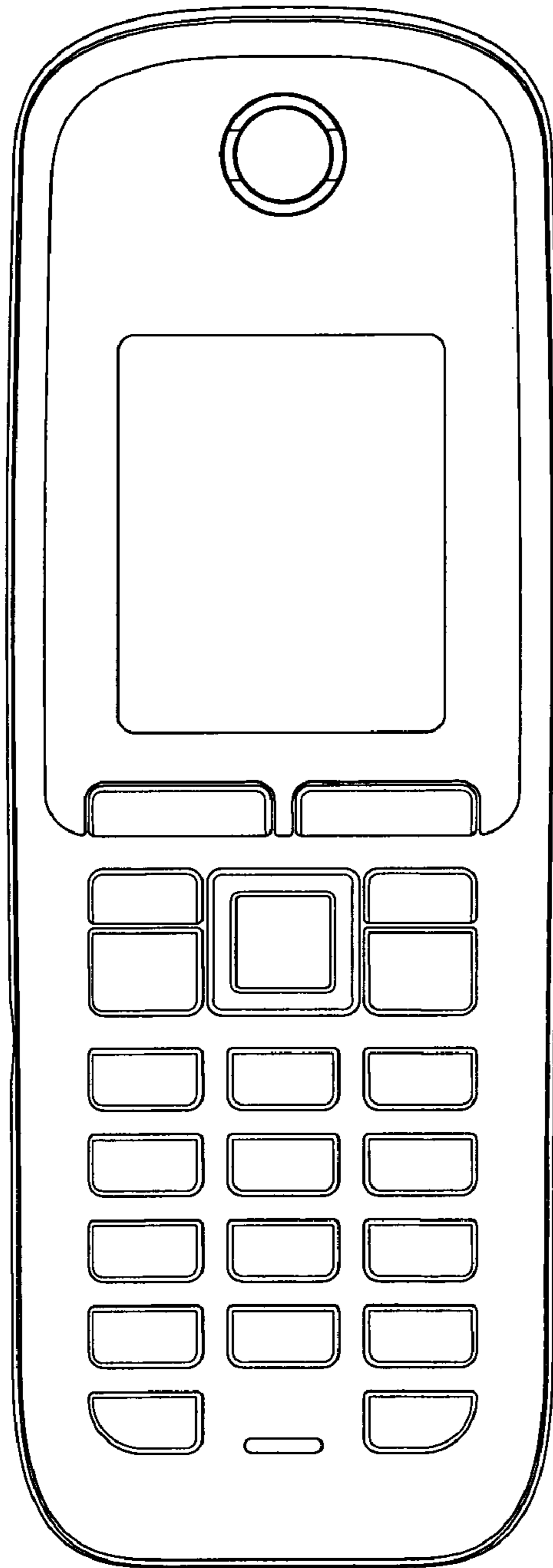

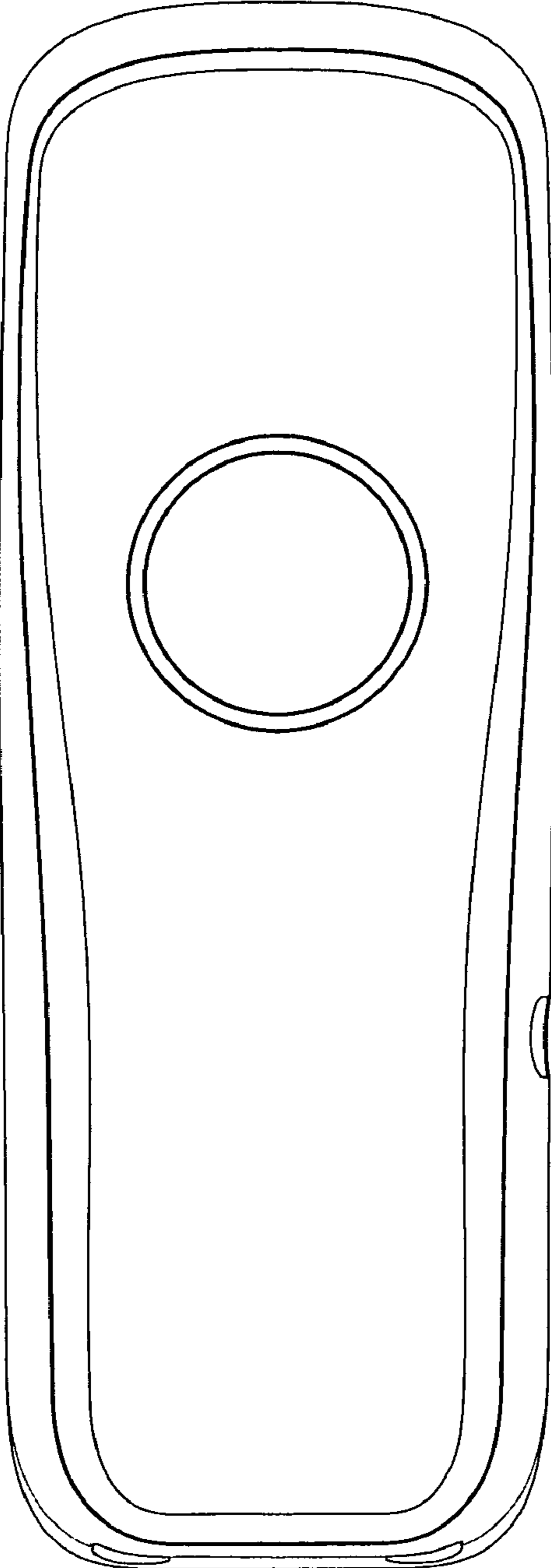

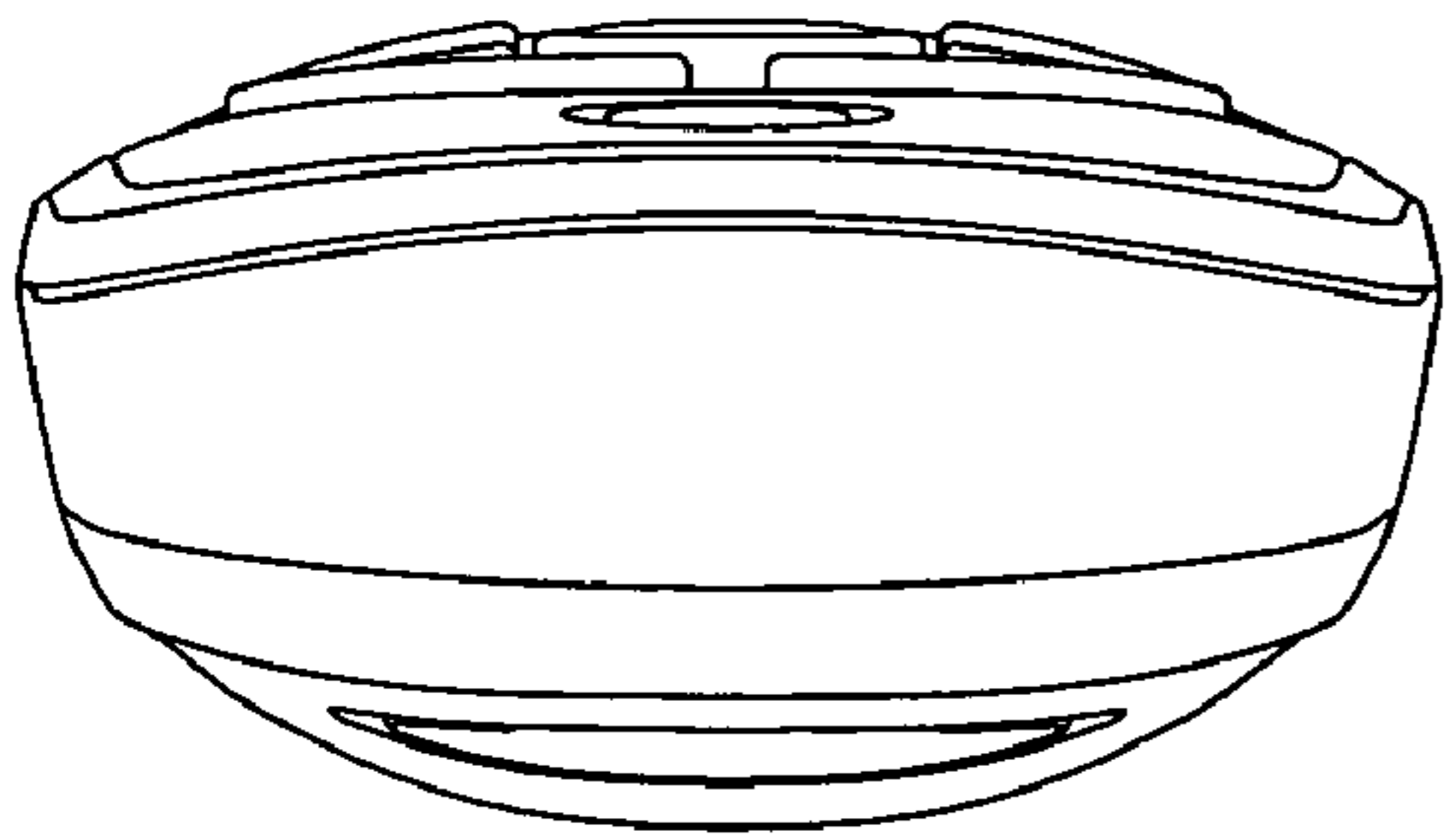

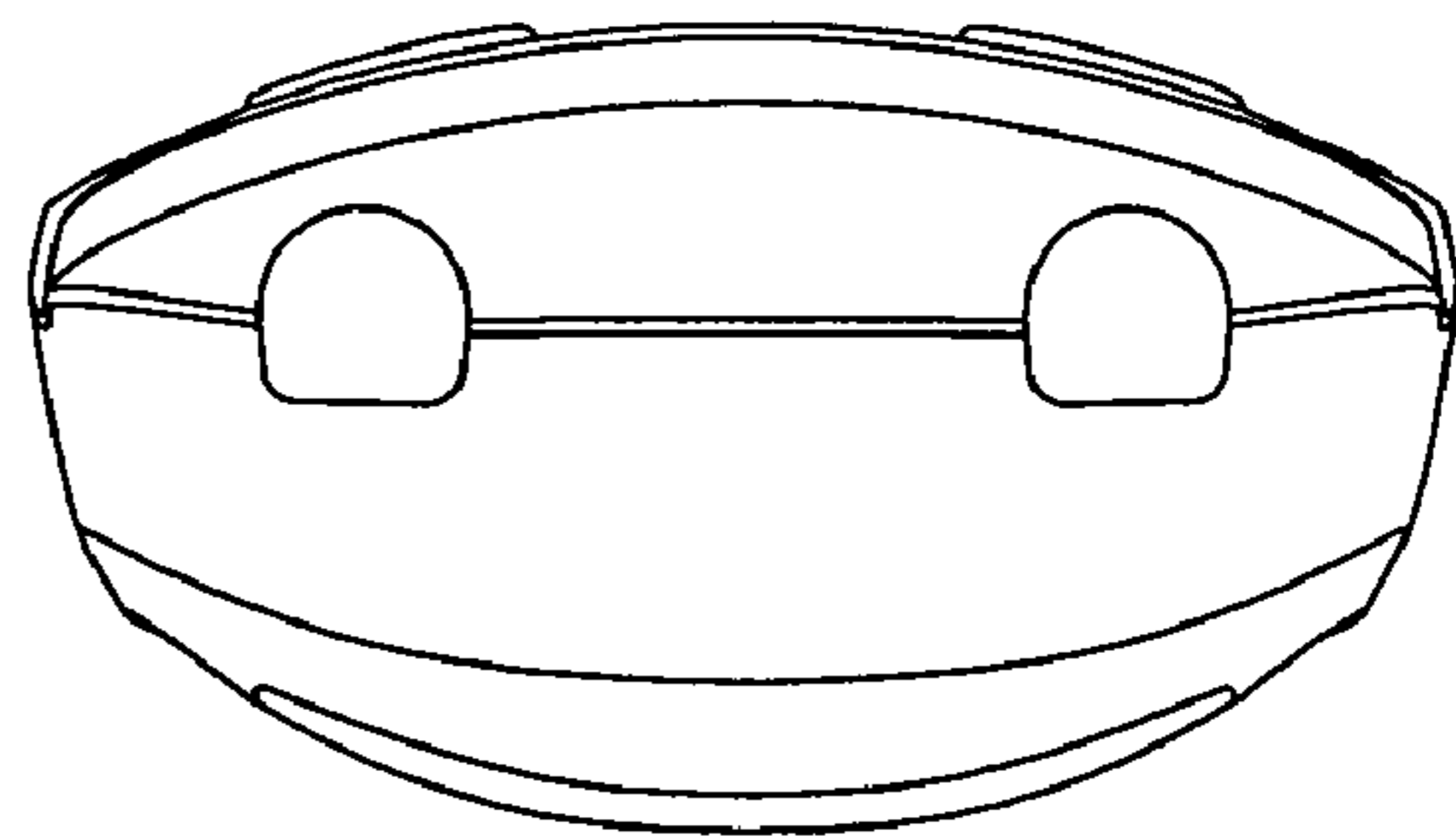

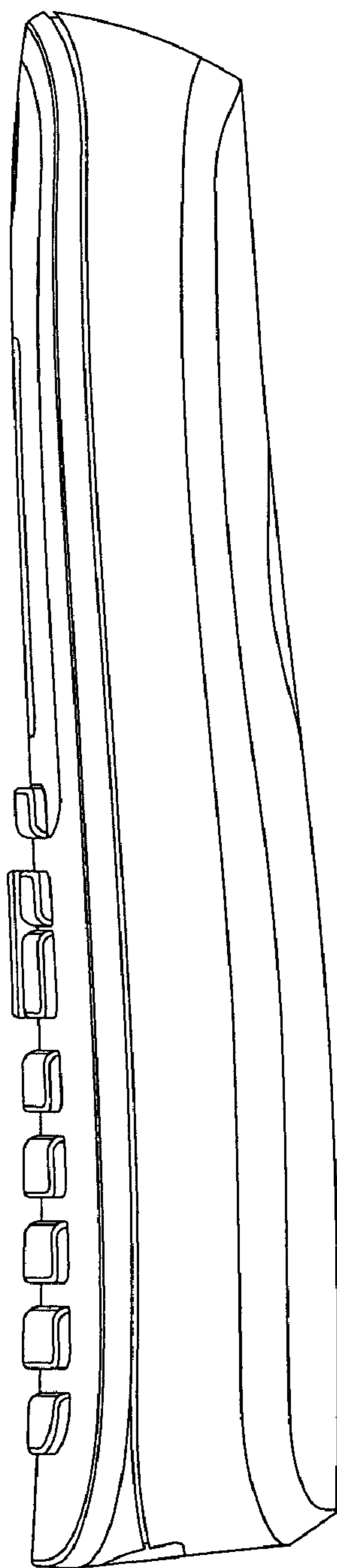

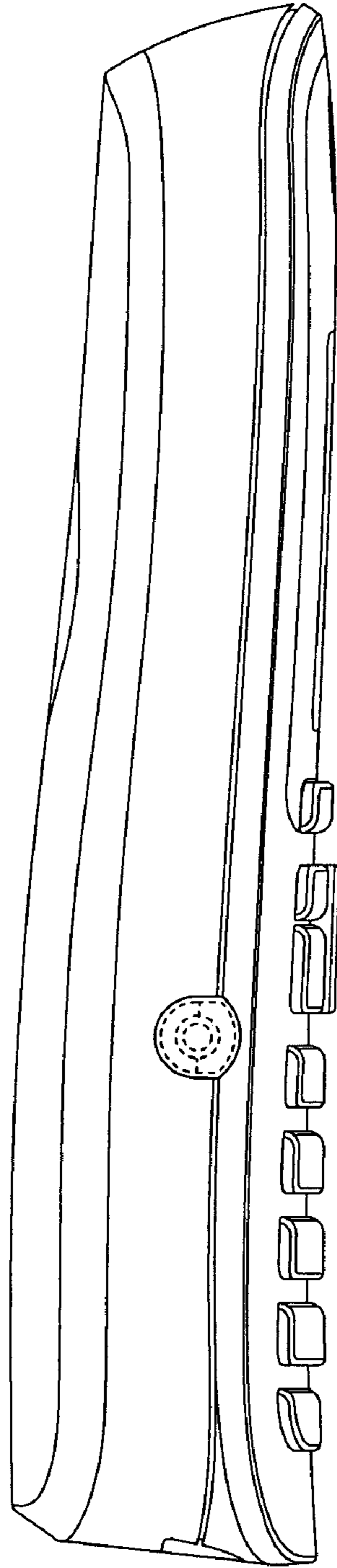

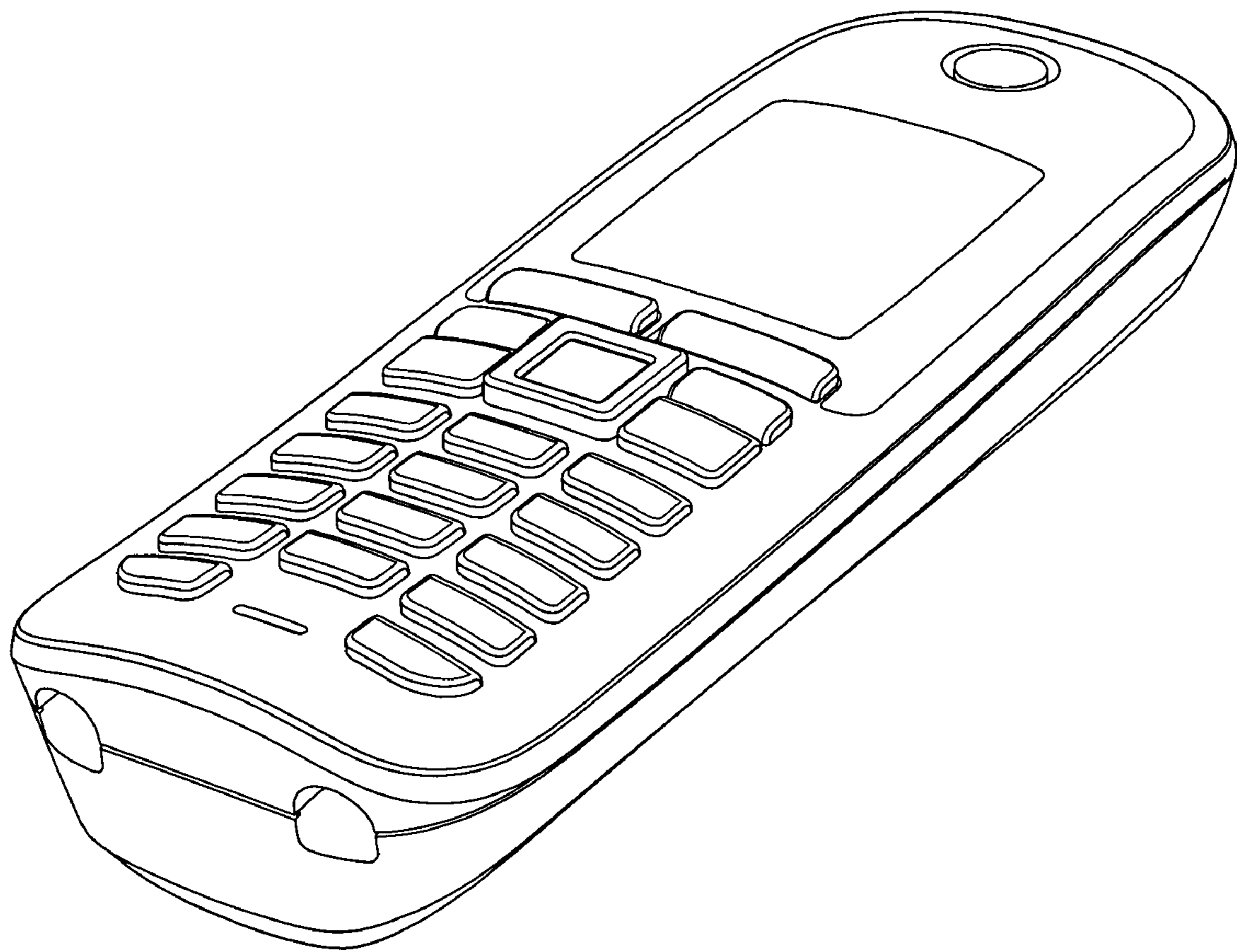
