(57) **CLAIM**

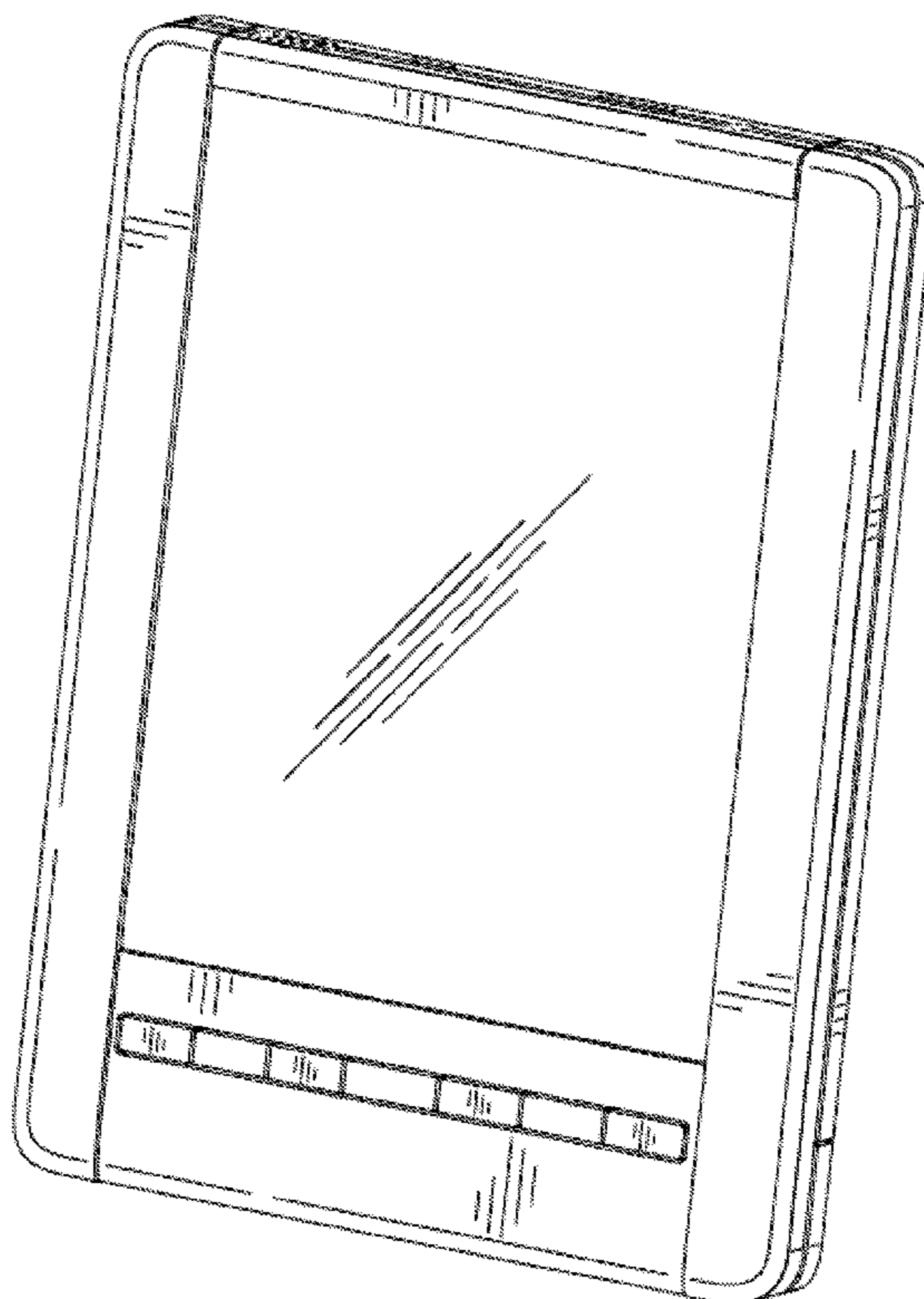
The ornamental design for a digital device housing, as shown and described.

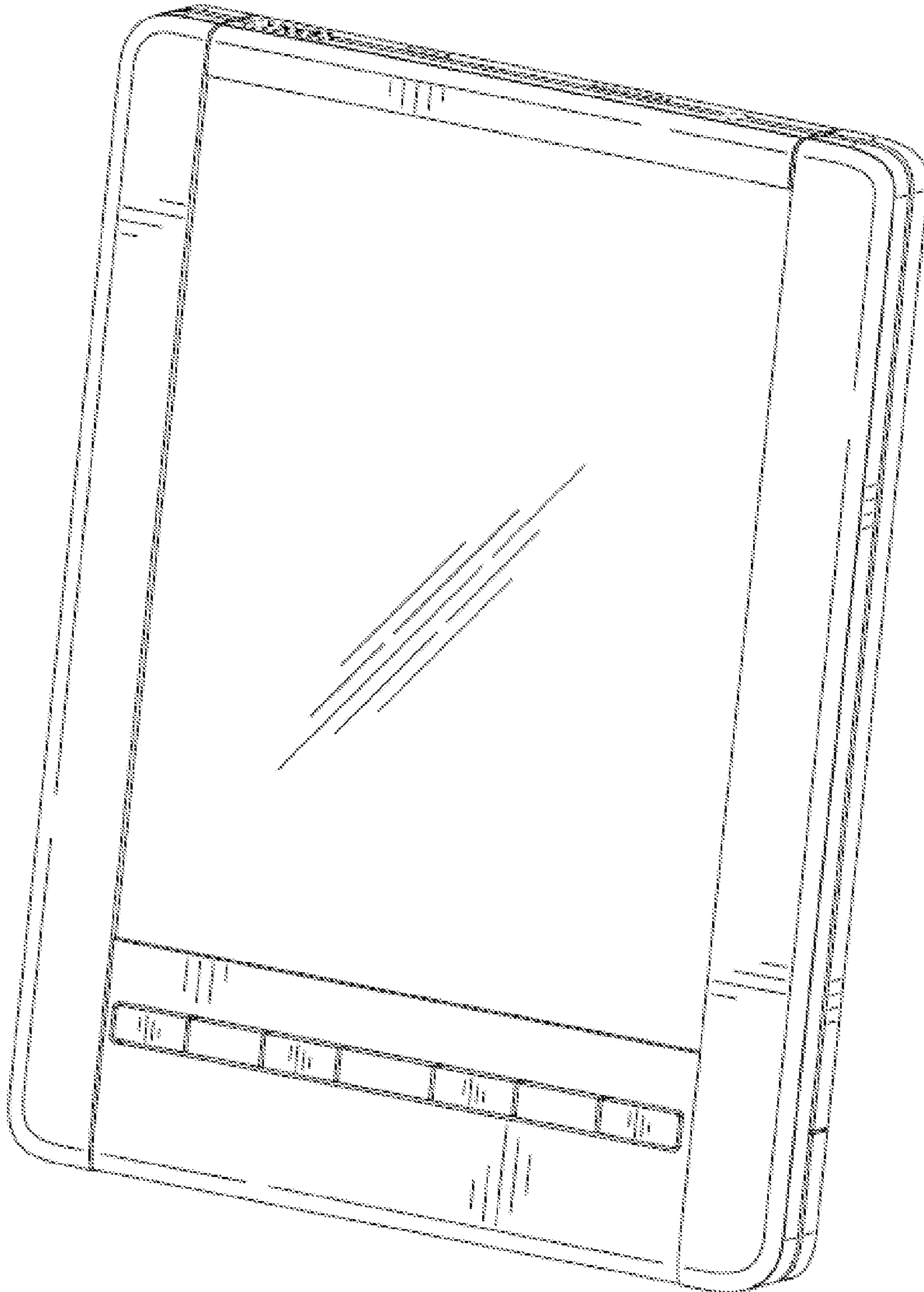

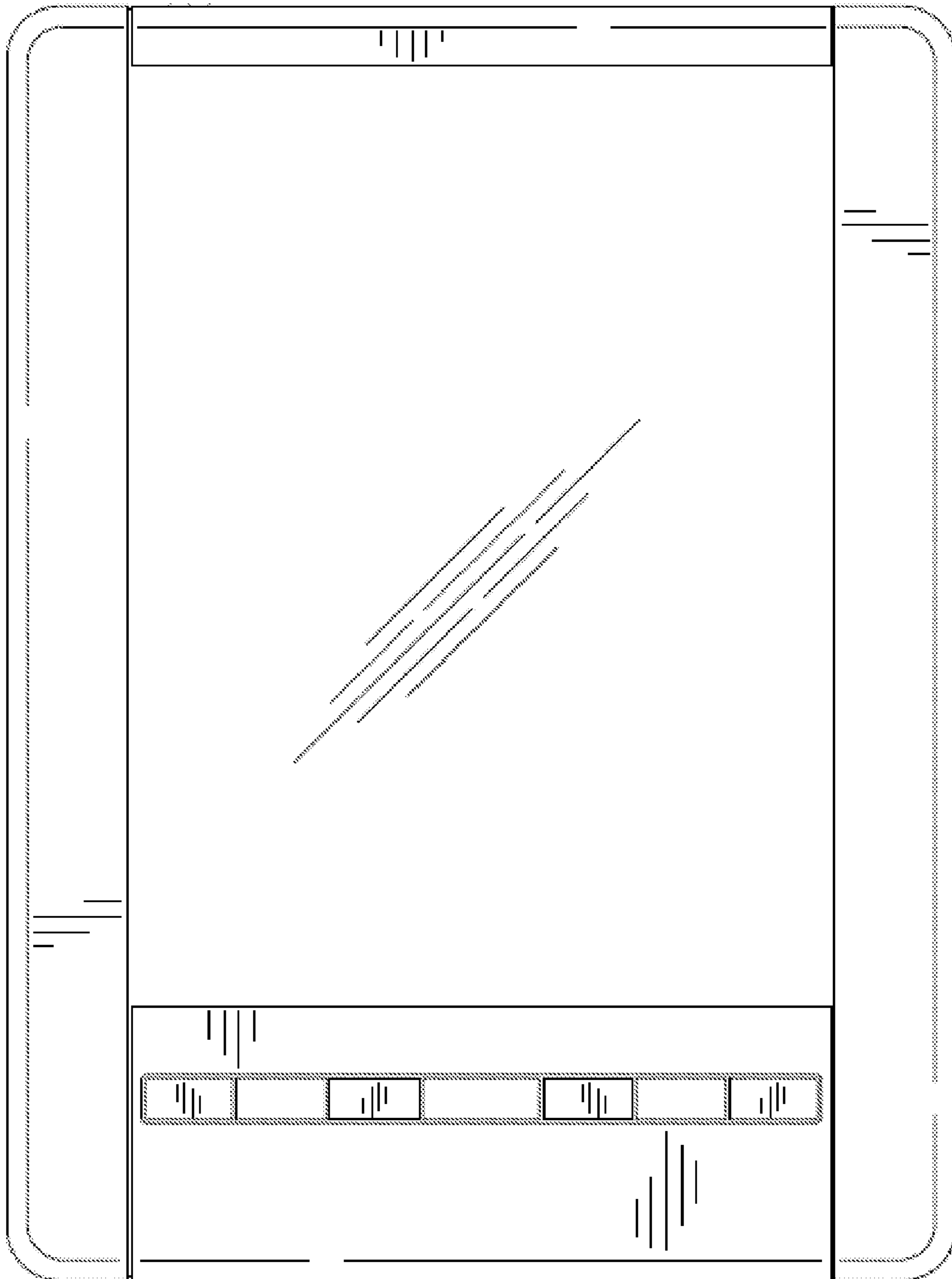

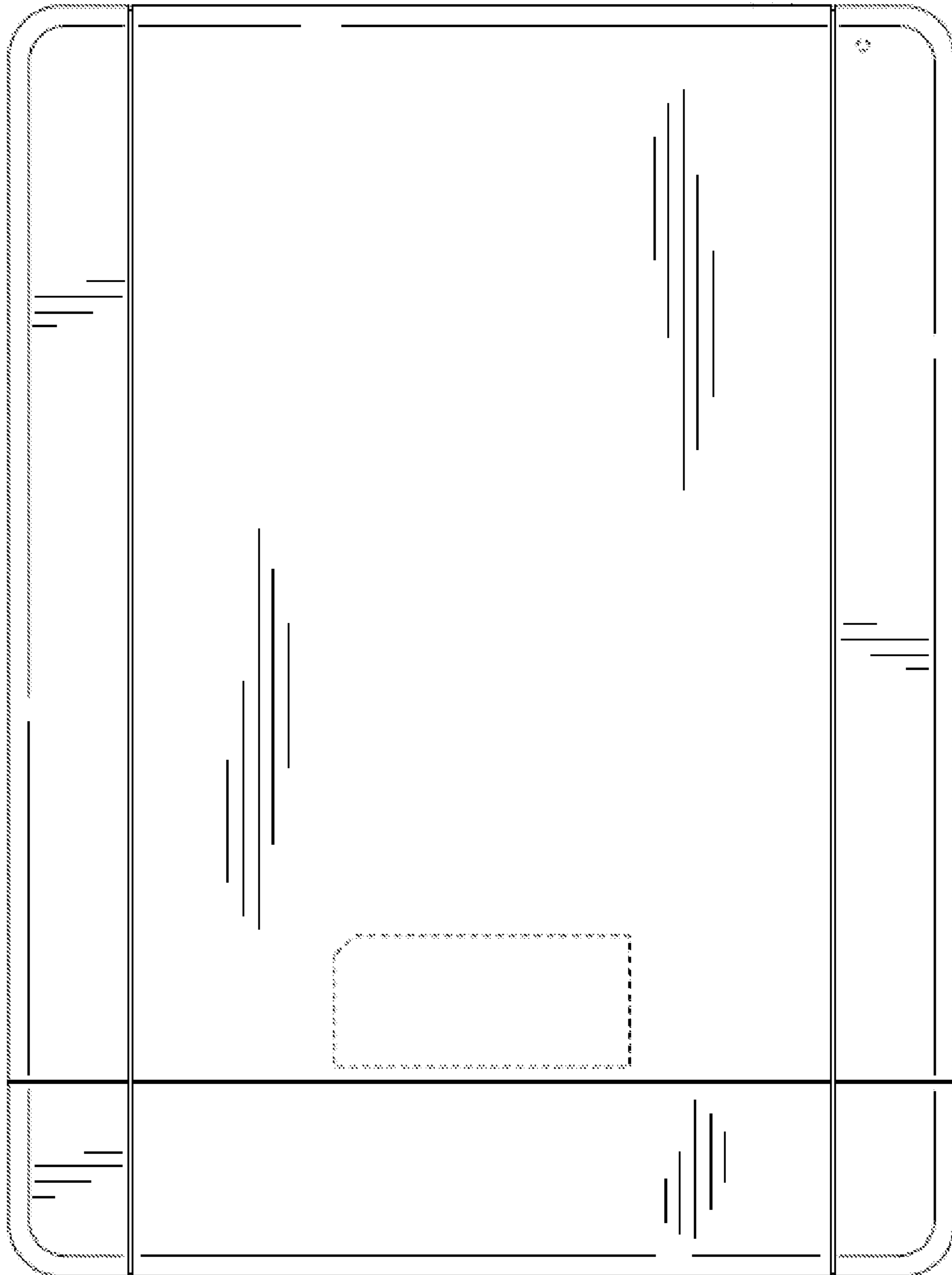

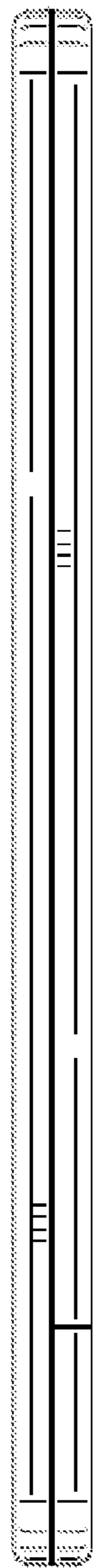

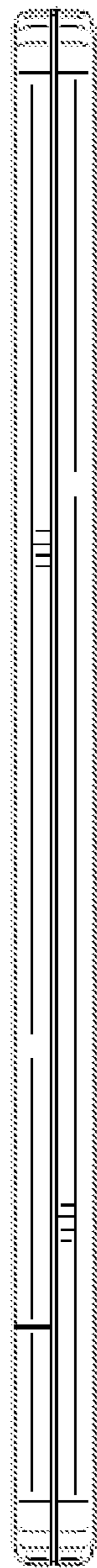

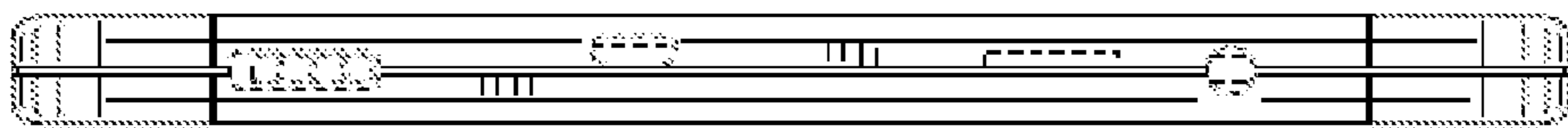

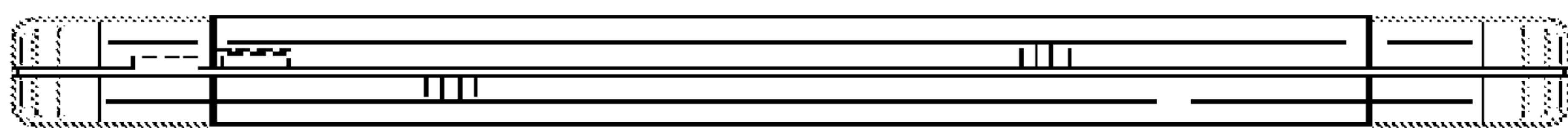

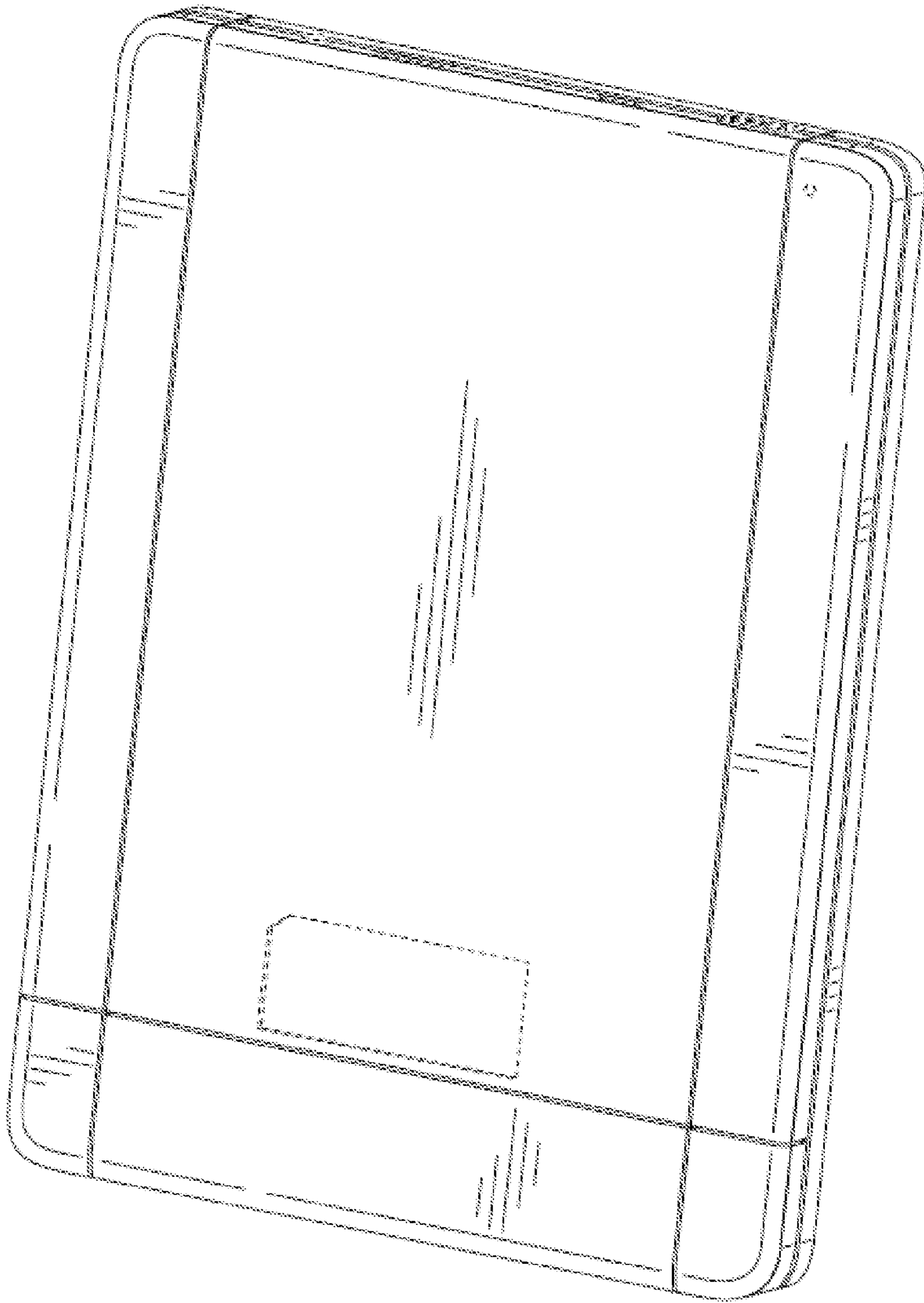
