(57) **CLAIM**

The ornamental design for an external storage device, as shown.

**DESCRIPTION**

FIG. 1 is a front perspective view showing the top, front and left side of an external storage device;

FIG. 2 is a rear perspective view showing the top, rear and right side of the external storage device of FIG. 1;

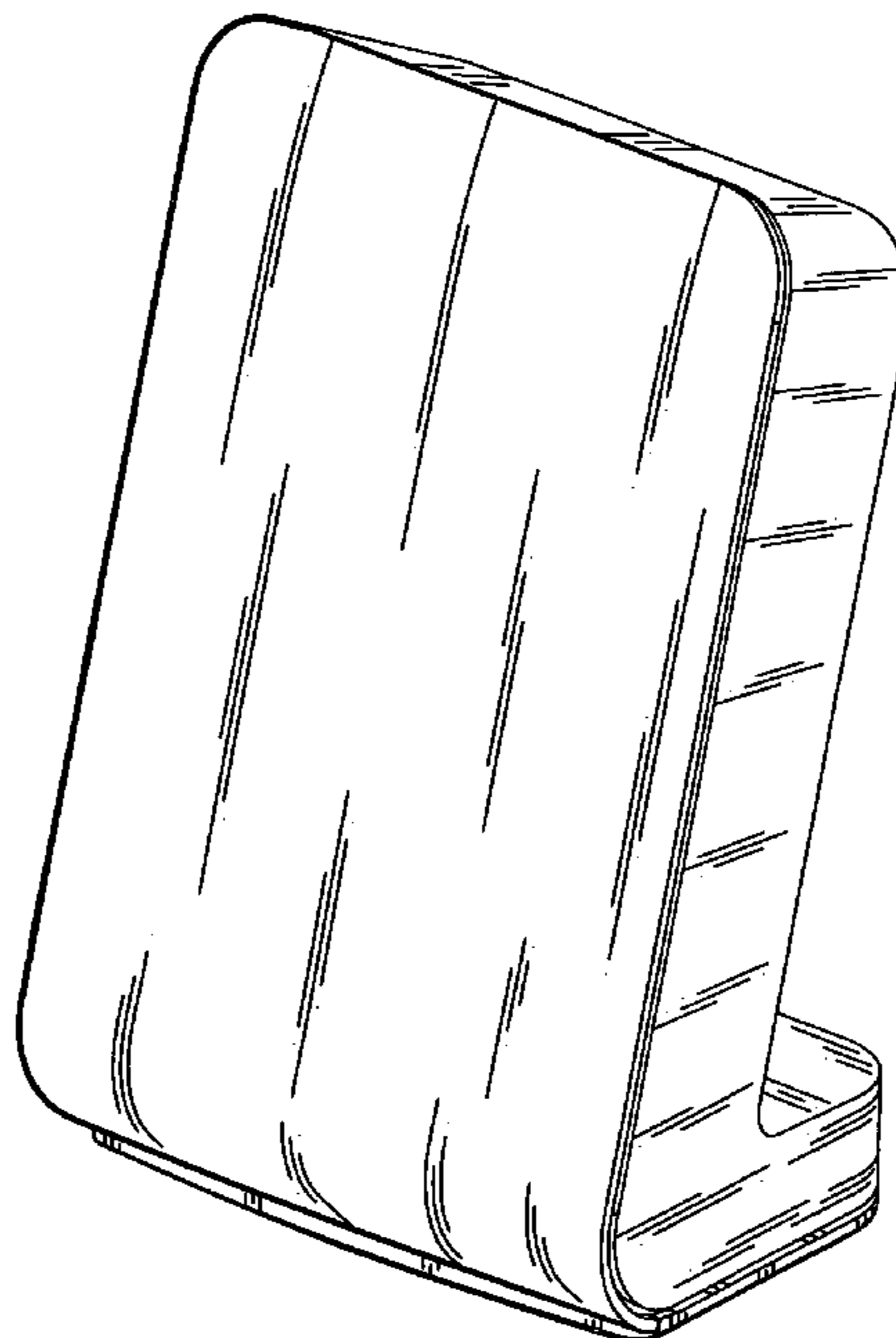
FIG. 3 is a top view of the external storage device of FIG. 1, showing the front facing the bottom of the page;

FIG. 4 is a bottom view of the external storage device of FIG. 1, showing the front facing the top of the page;

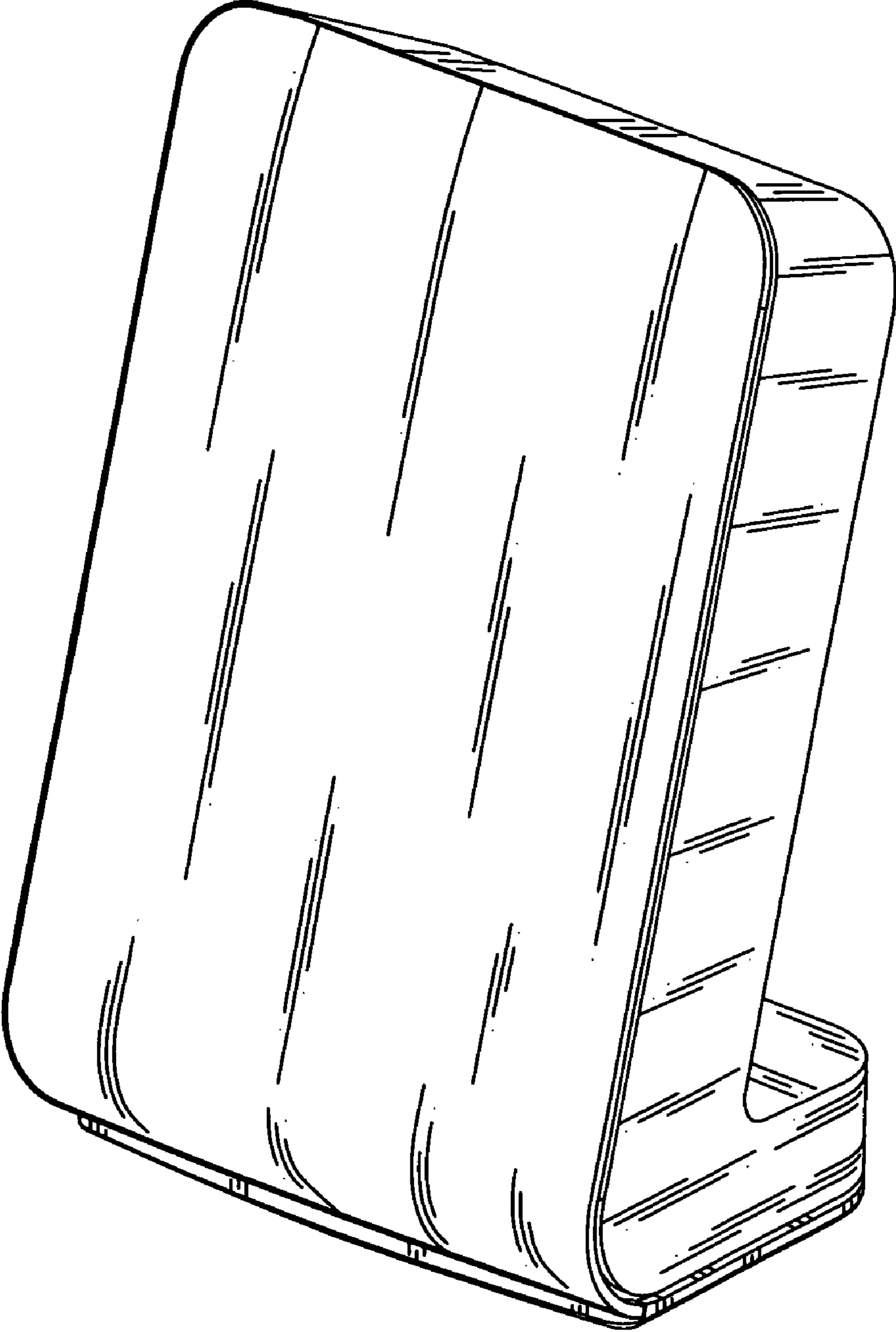
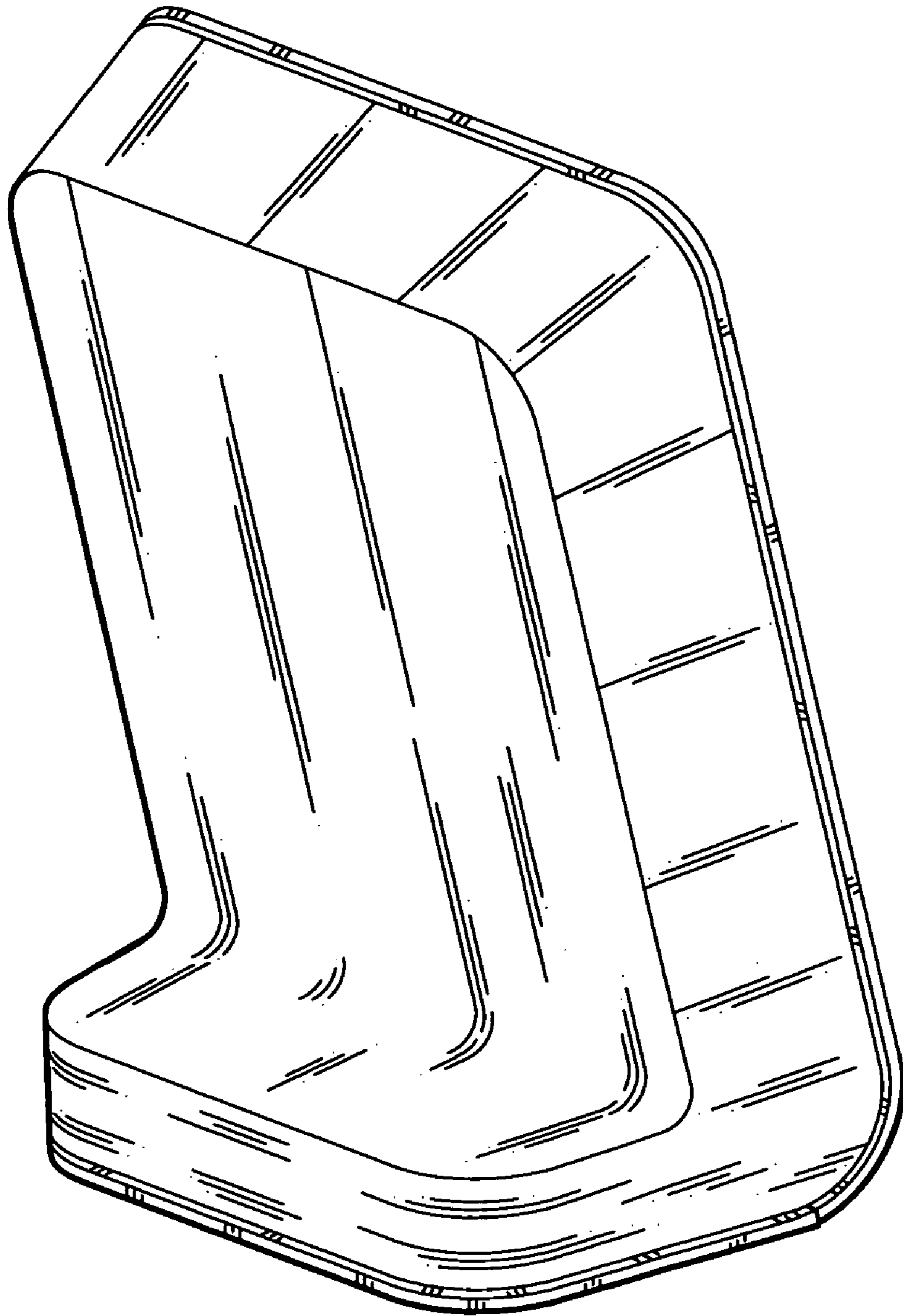
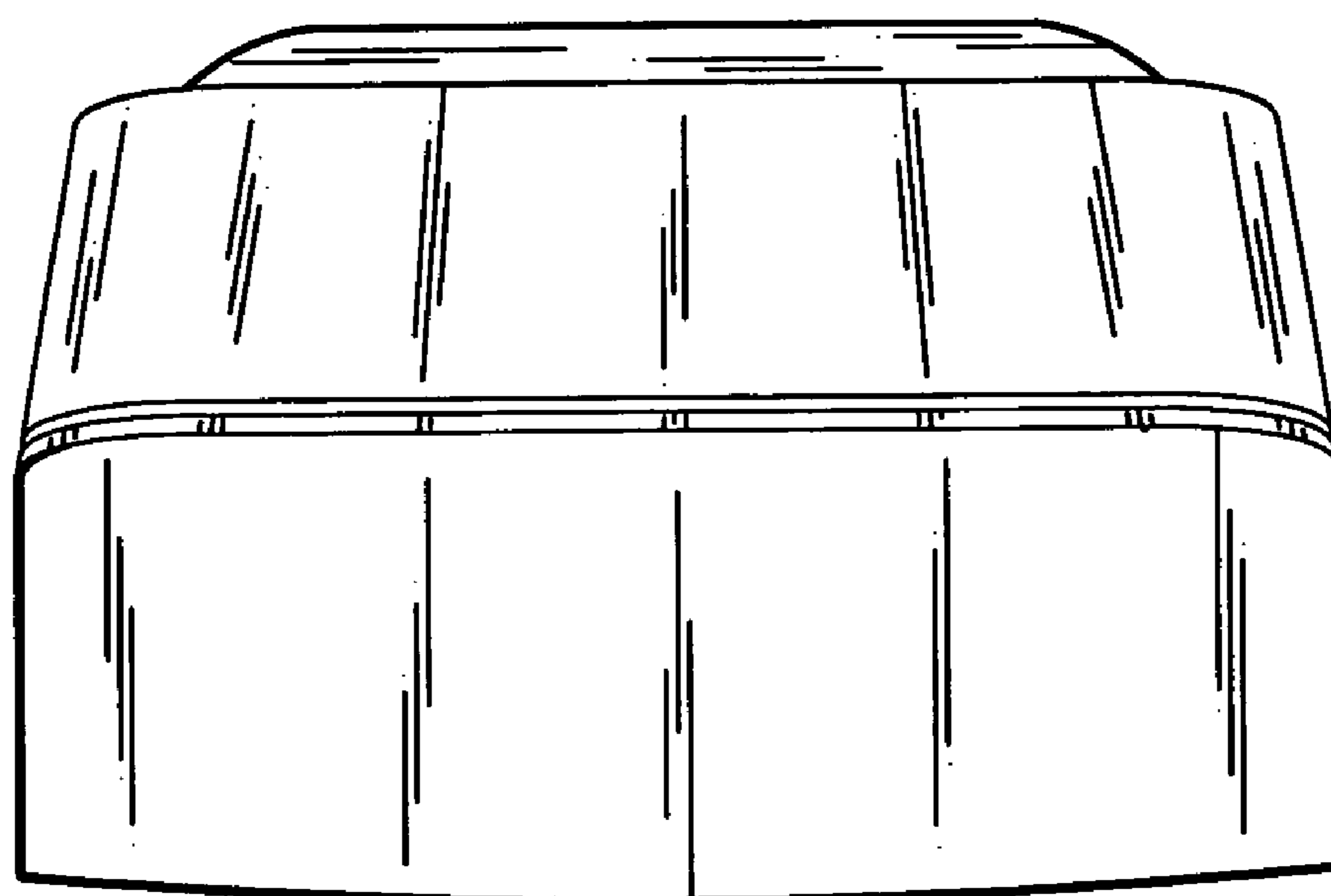


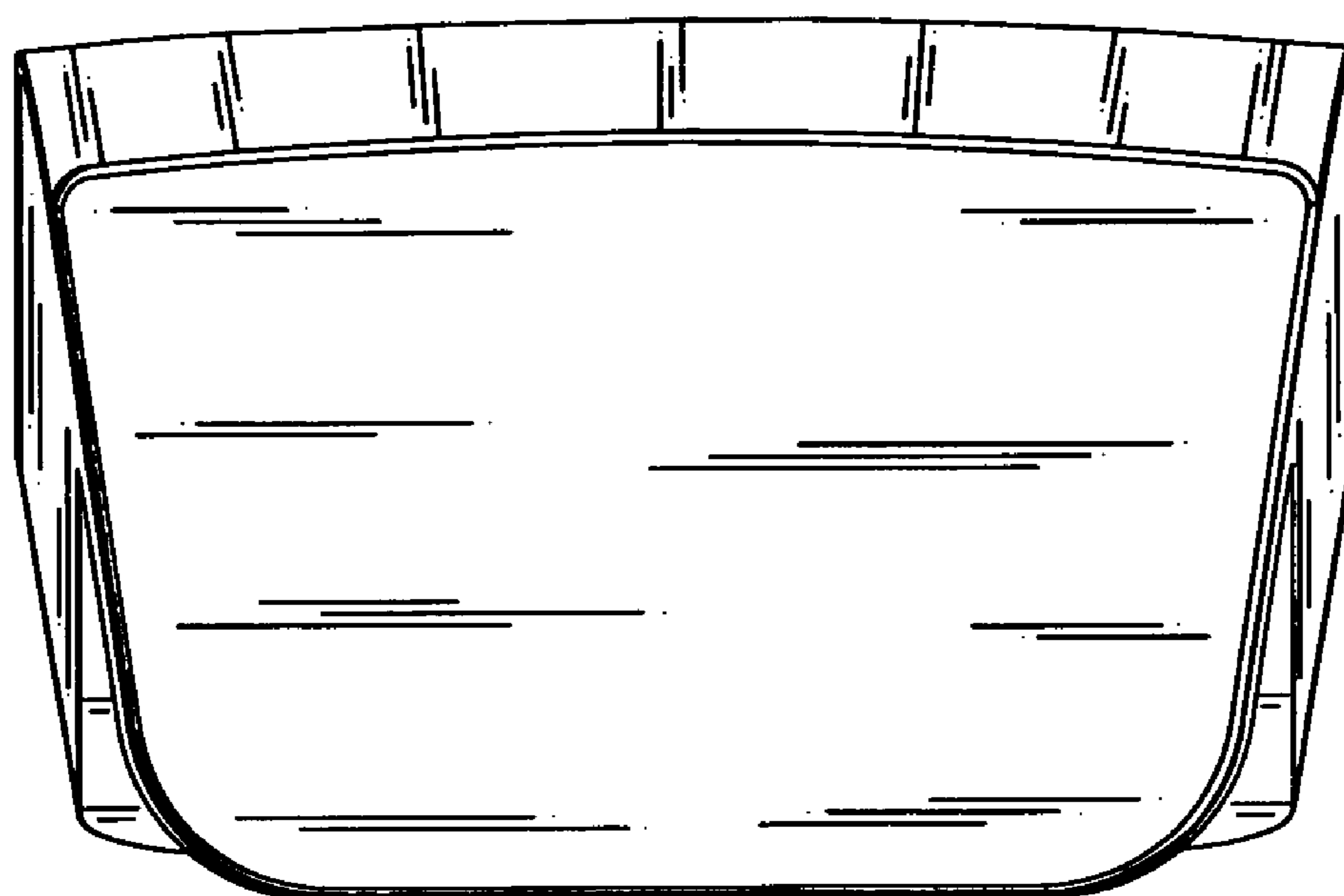

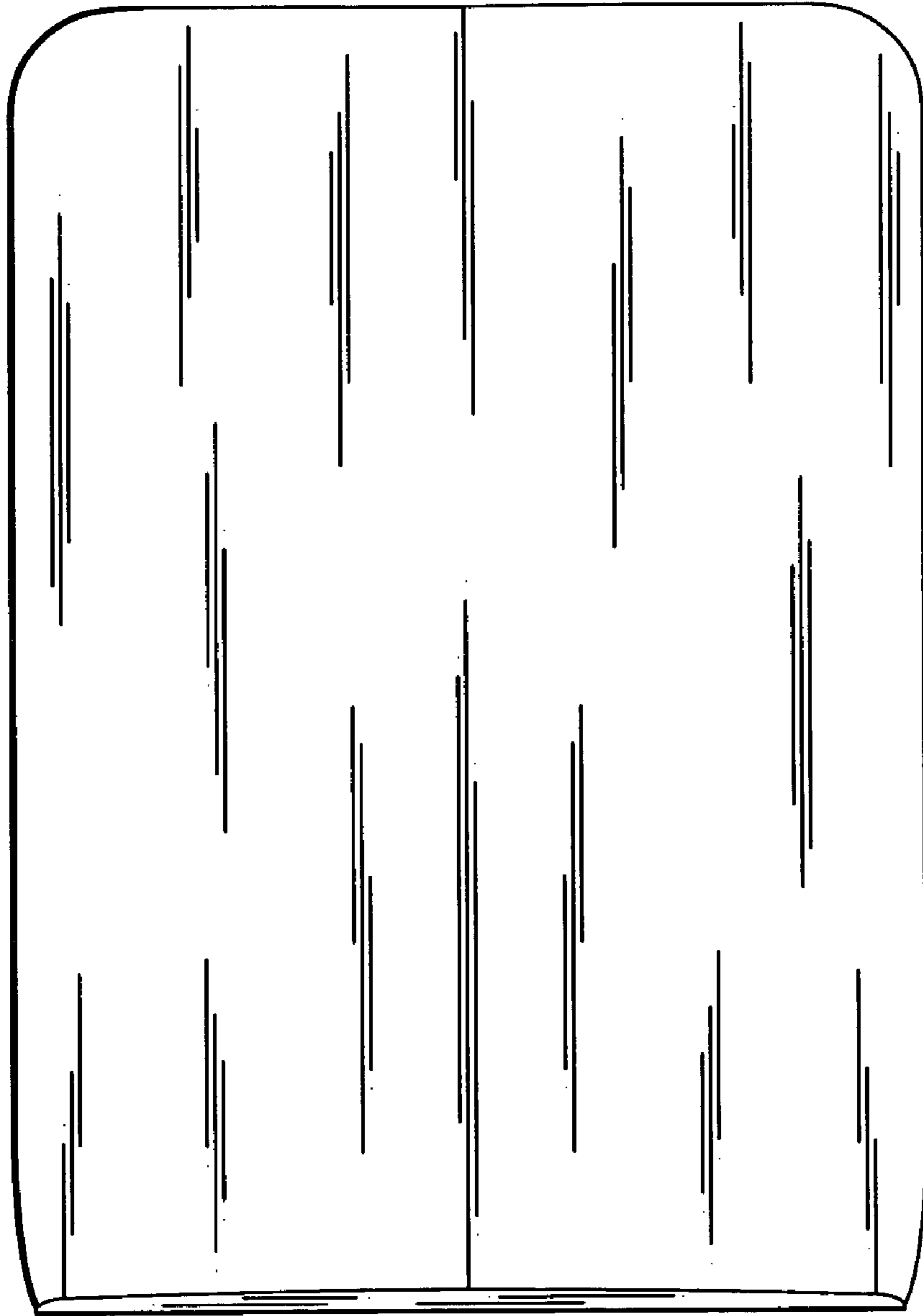

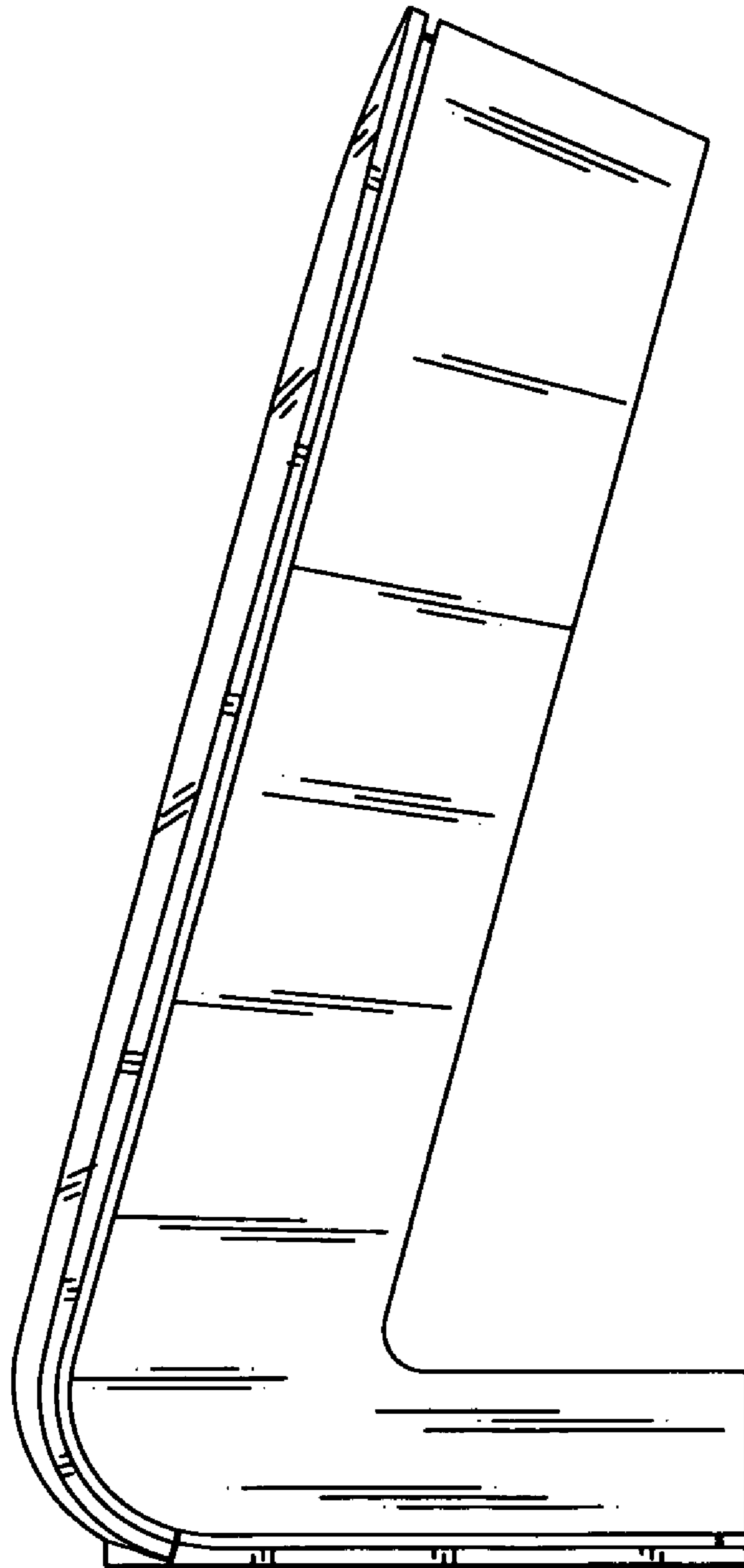
