(57) **CLAIM**

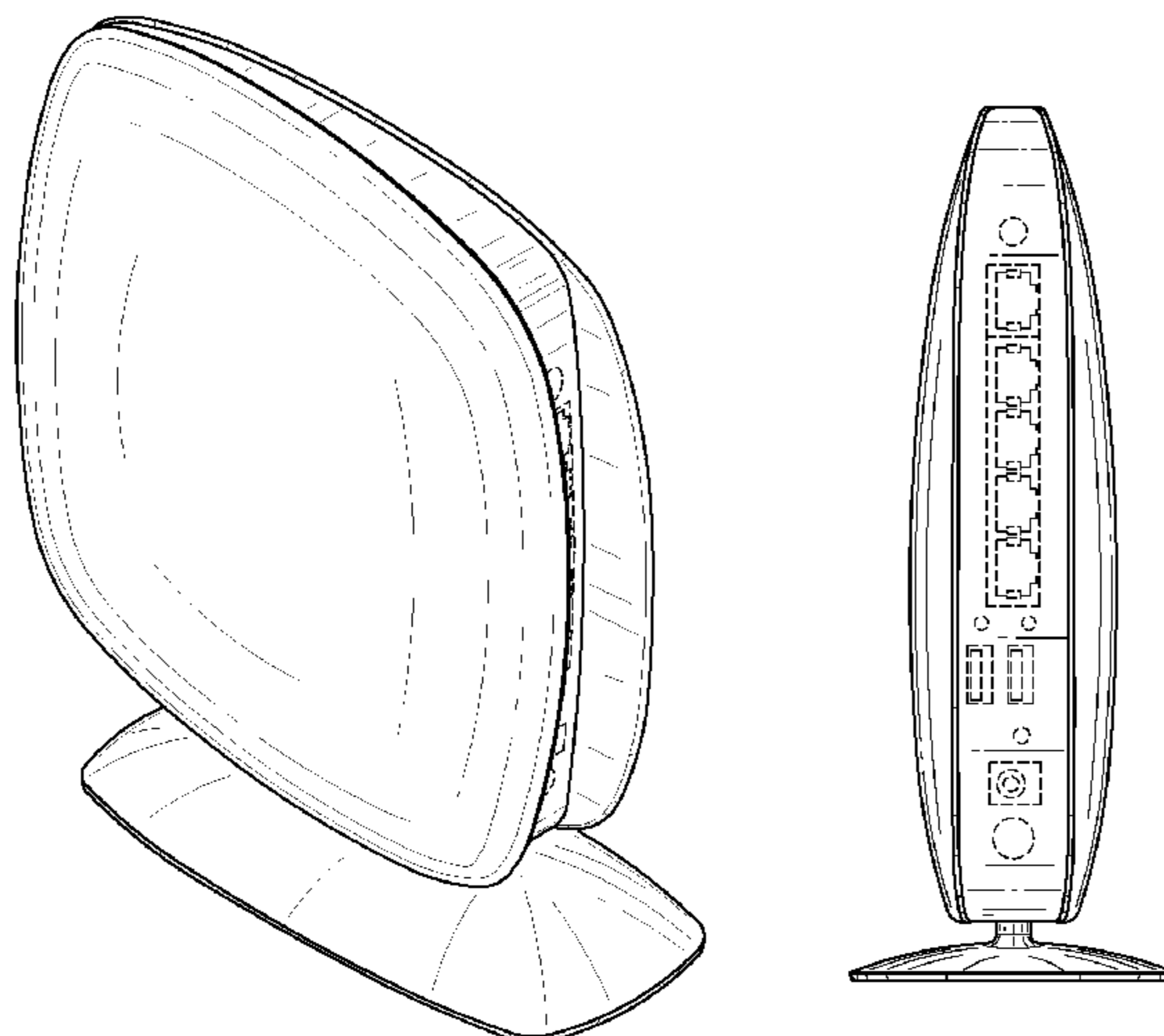
We claim the ornamental design for a router, as shown.

**DESCRIPTION**

FIG. 1 is a front, top, right side isometric view of the router; FIG. 2 is a front, top, left side isometric view thereof; FIG. 3 is a right side view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a back view thereof; FIG. 6 is a front view thereof; FIG. 7 is a top view thereof; and, FIG. 8 is a bottom view thereof.

The broken lines shown throughout the views, which are immediately adjacent to the shaded areas and define unshaded regions, represent the bounds of the claimed design, while all other broken lines are directed to environment and are for illustrative purposes only; the broken lines form no part of the claimed design.

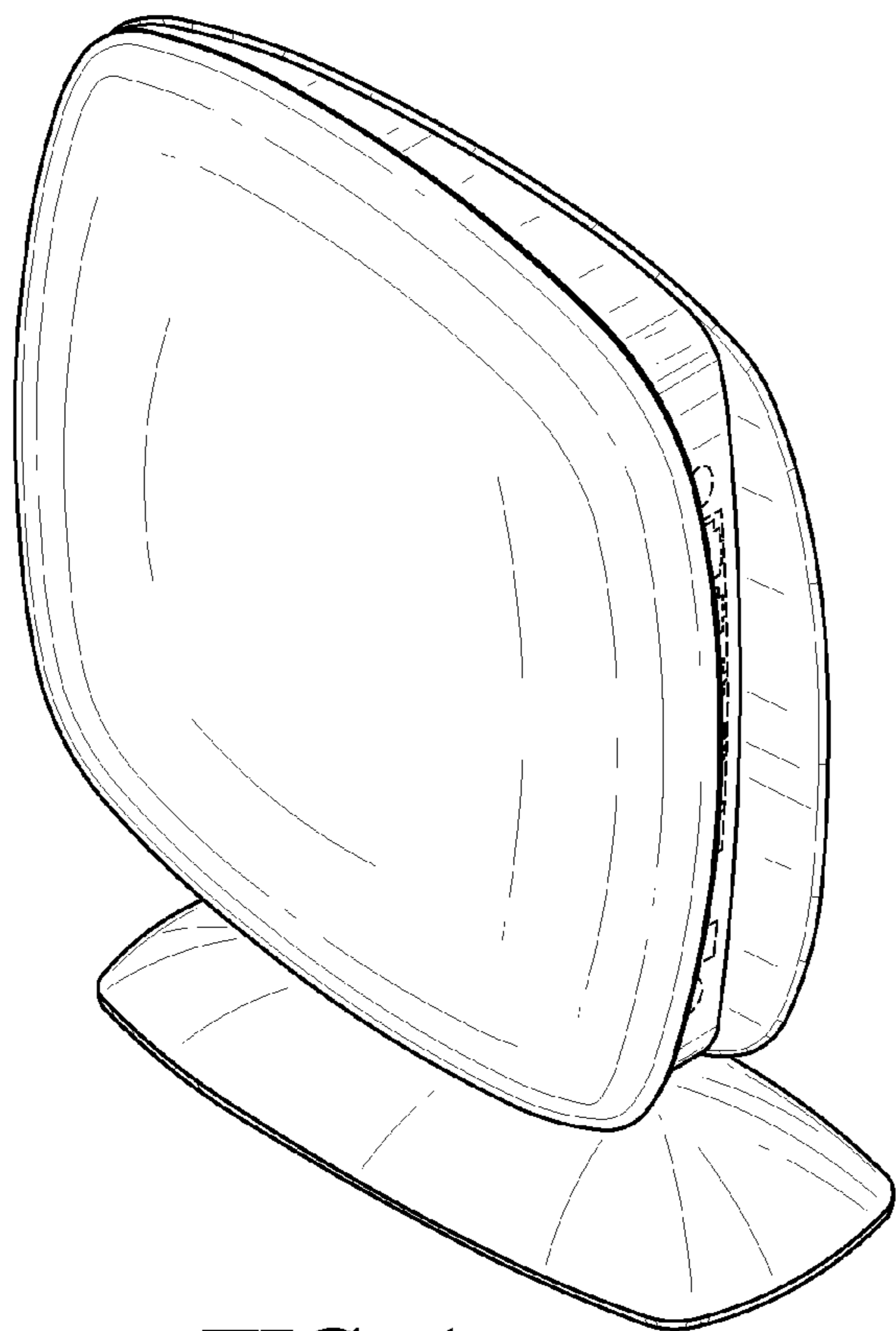

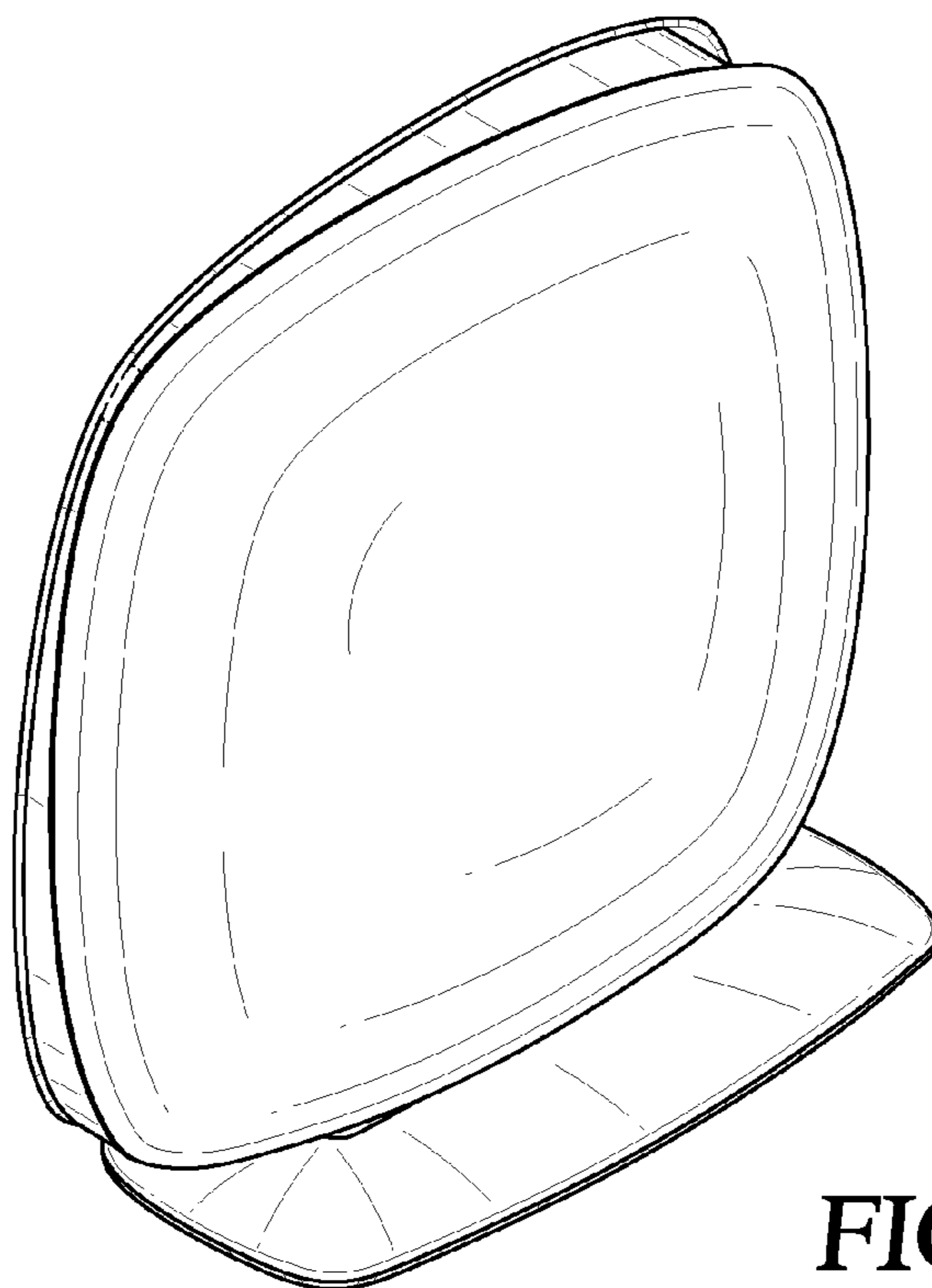

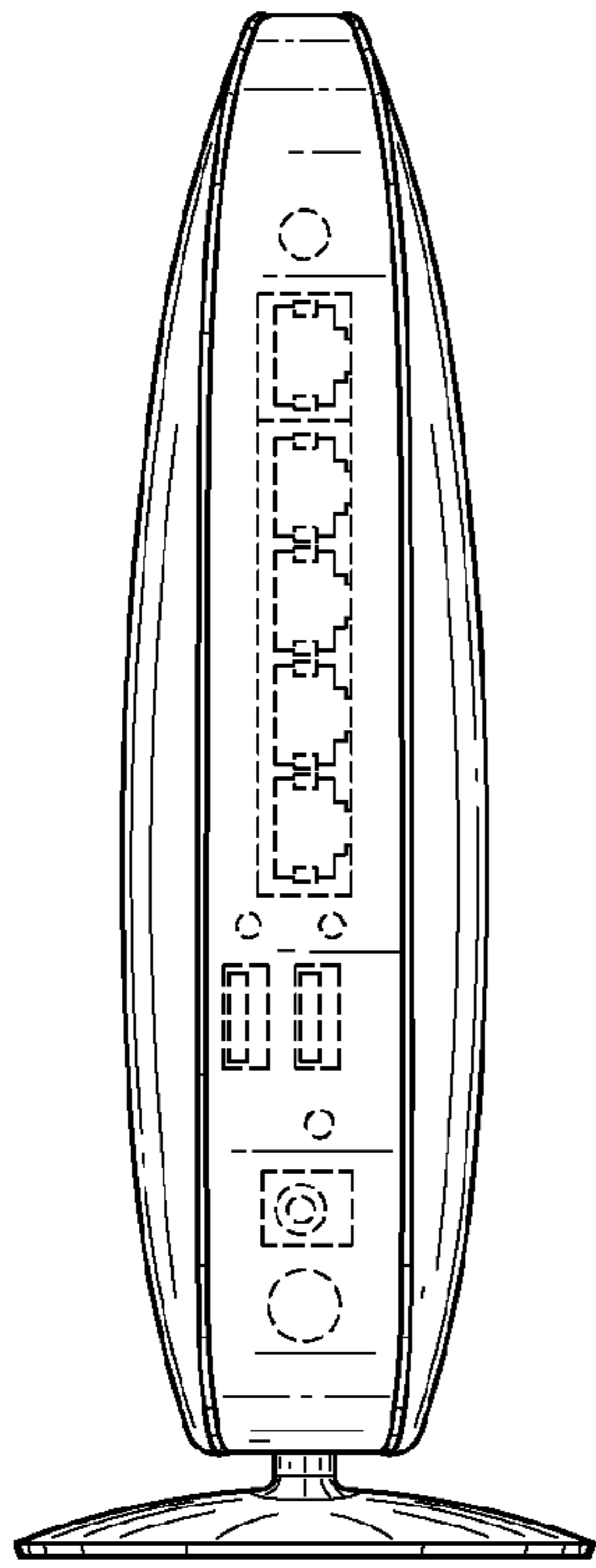

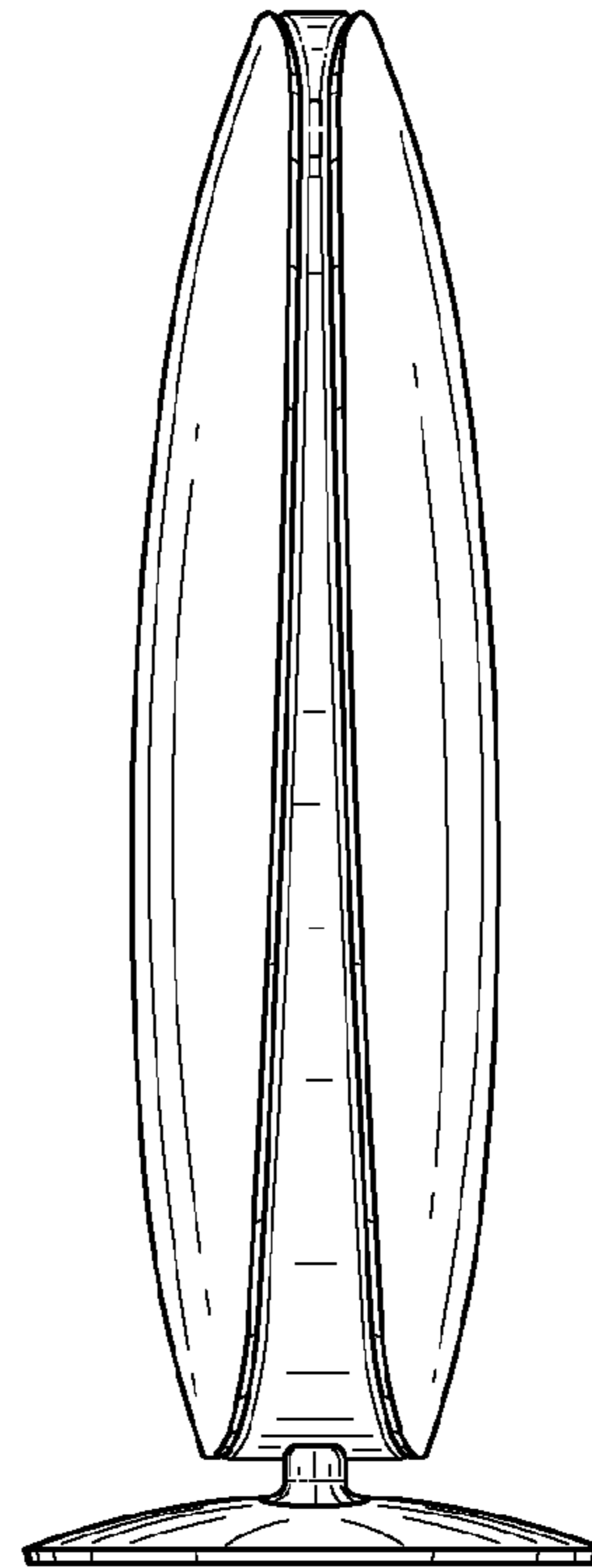

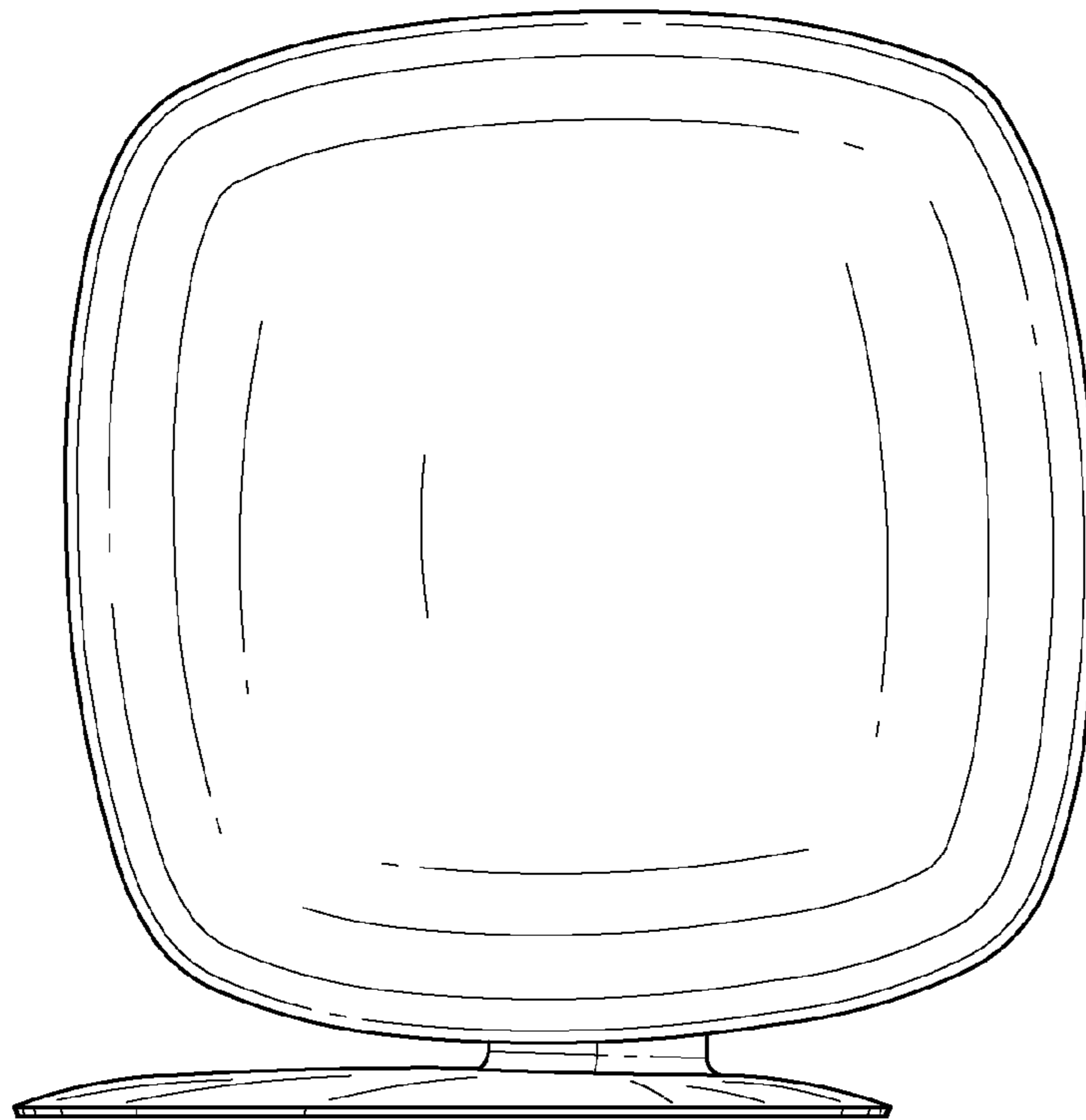

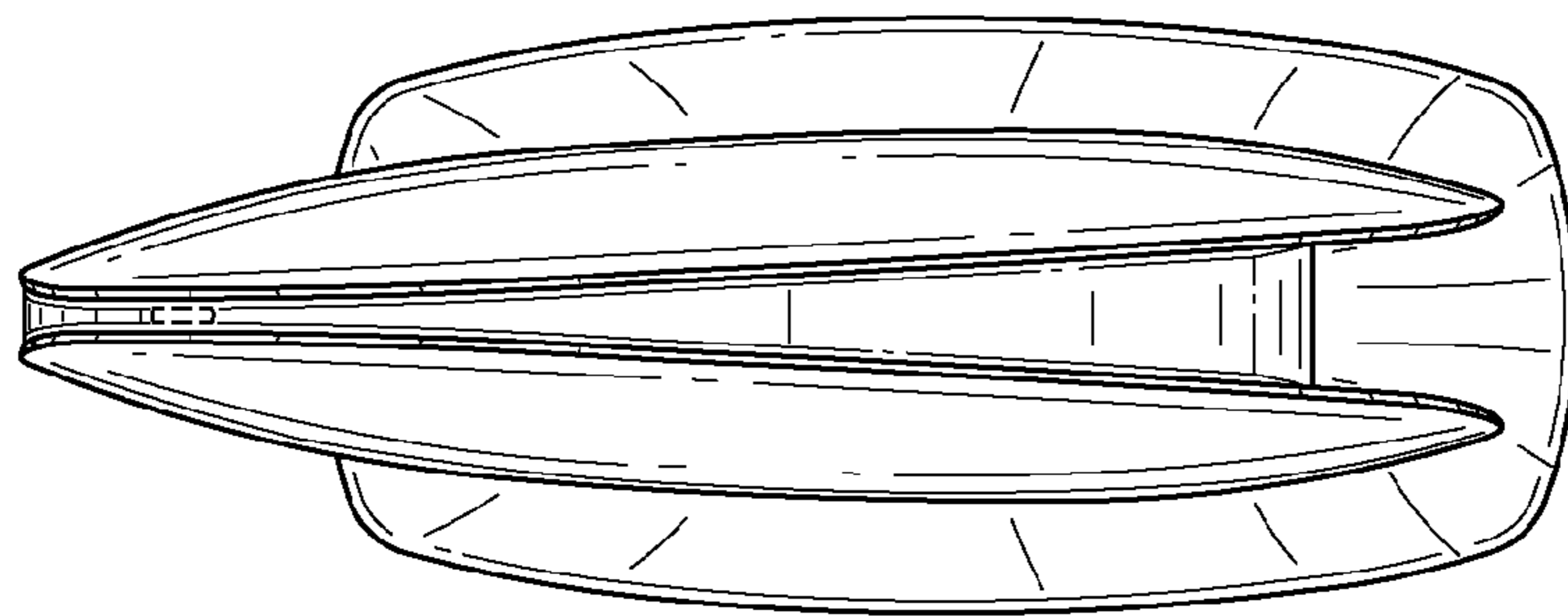

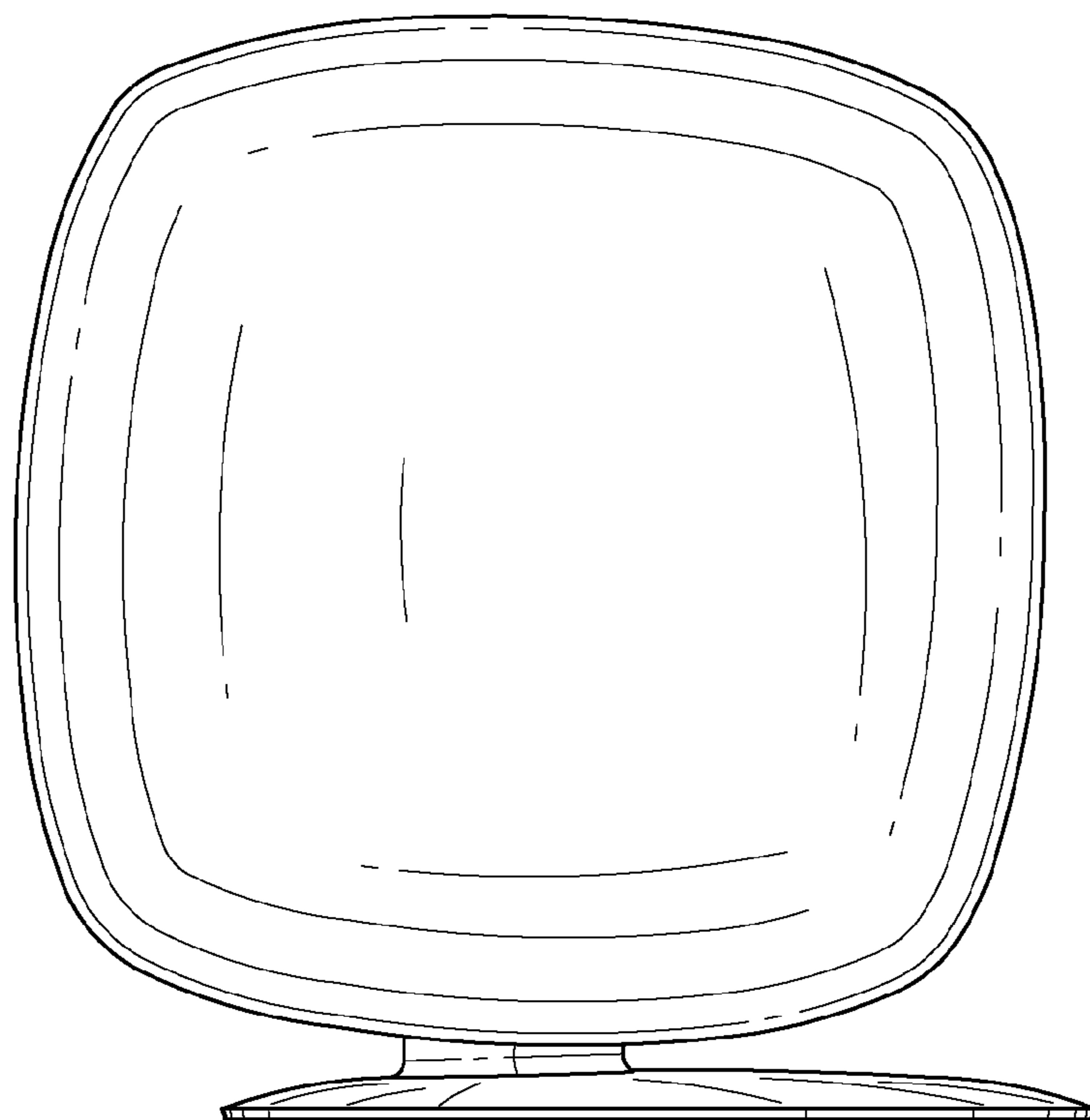

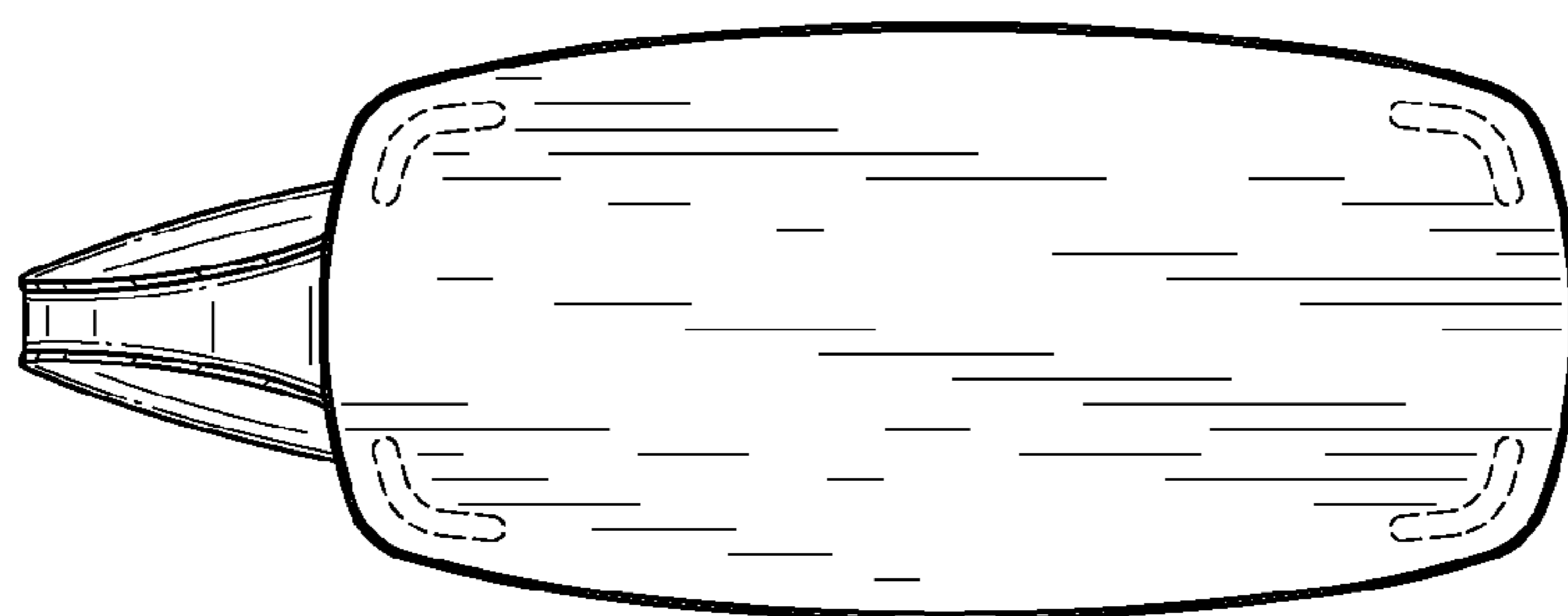
