FIG. 2 is a front view thereof (Rear view is mirror image);

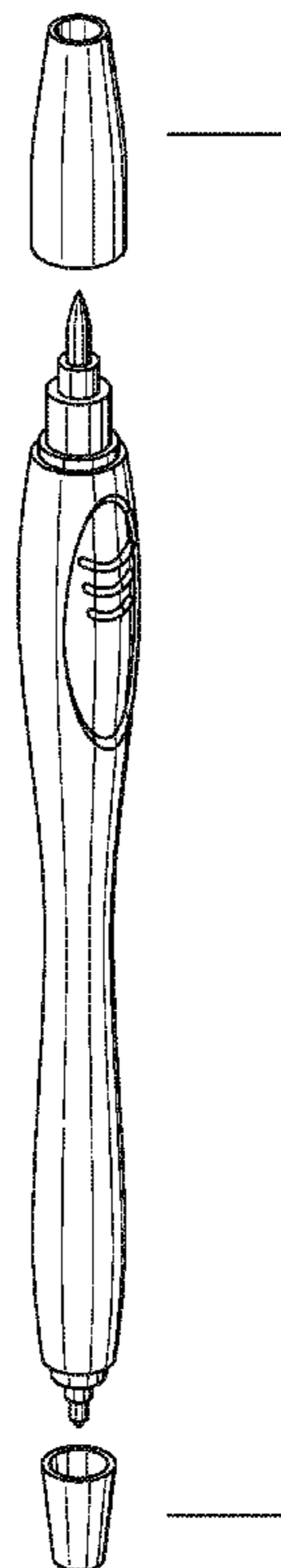
FIG. 3 is a left side view thereof (Right side view is mirror image);

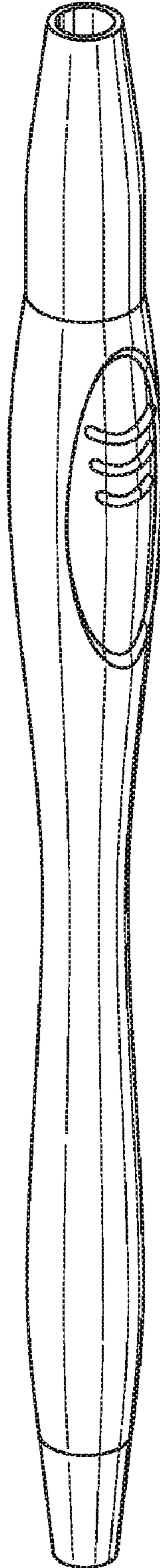

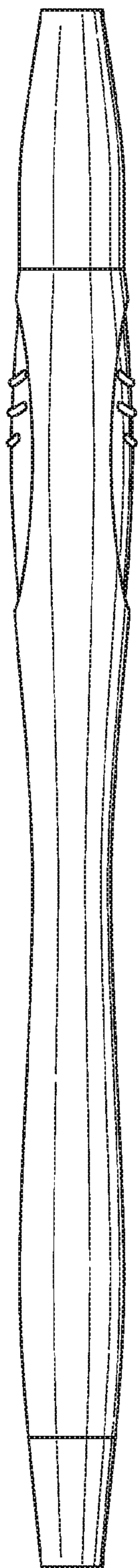

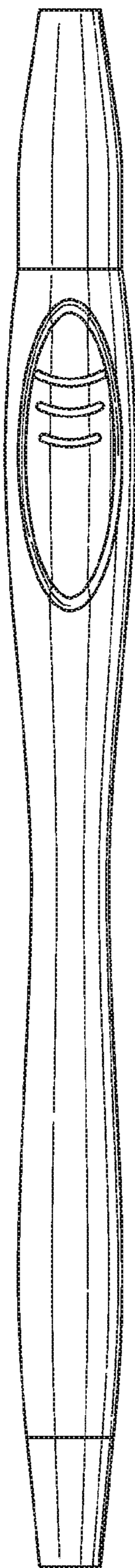

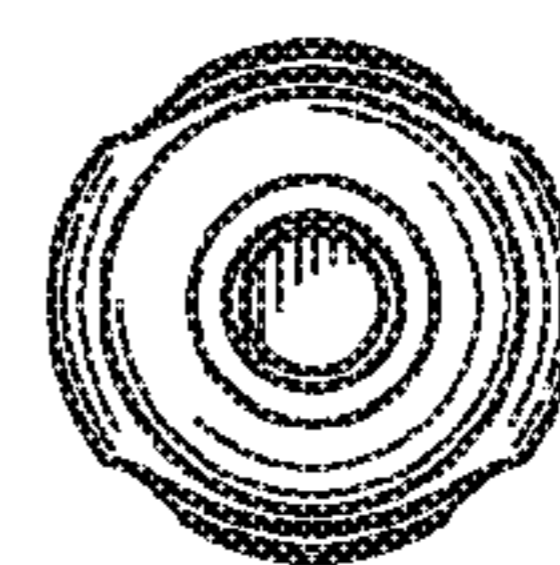

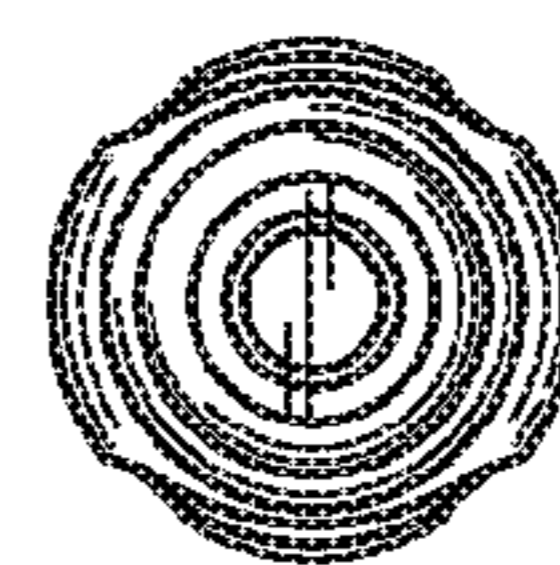

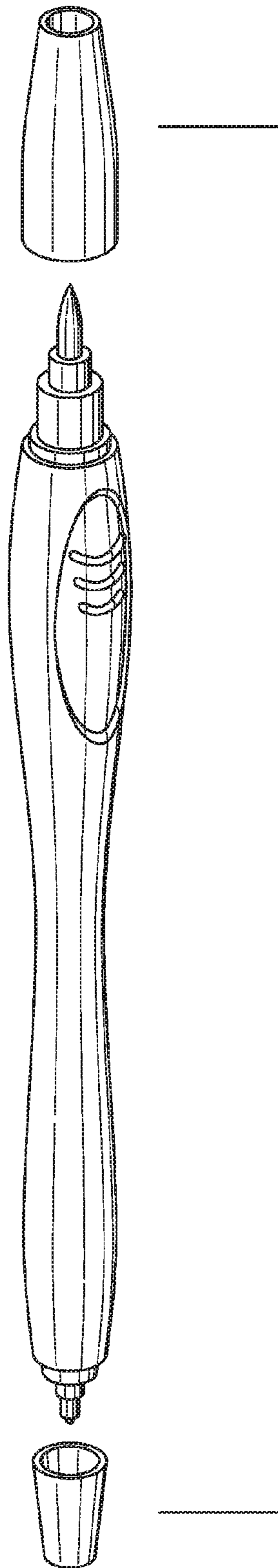
