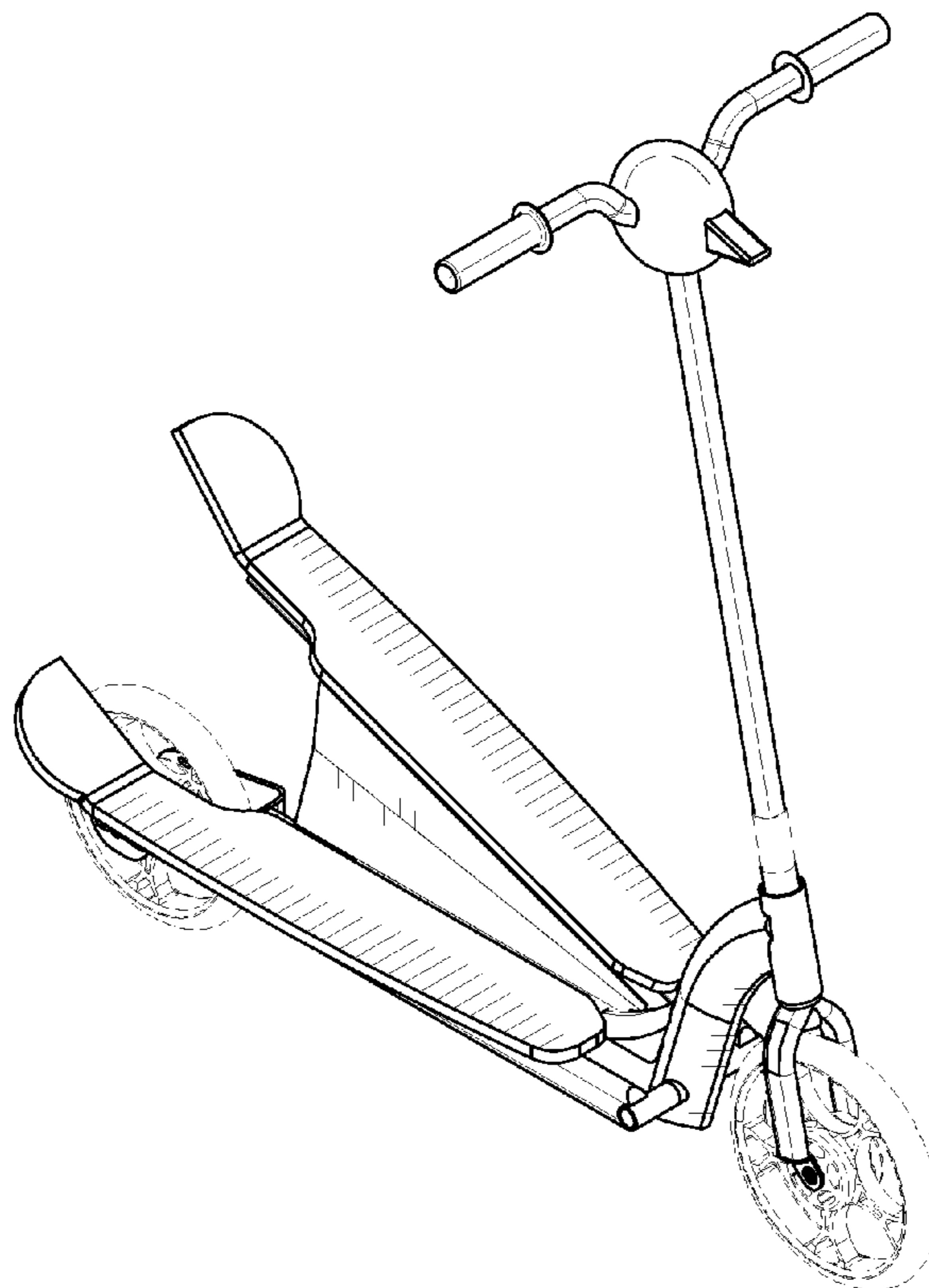
The ornamental design for a scooter, as shown and described.

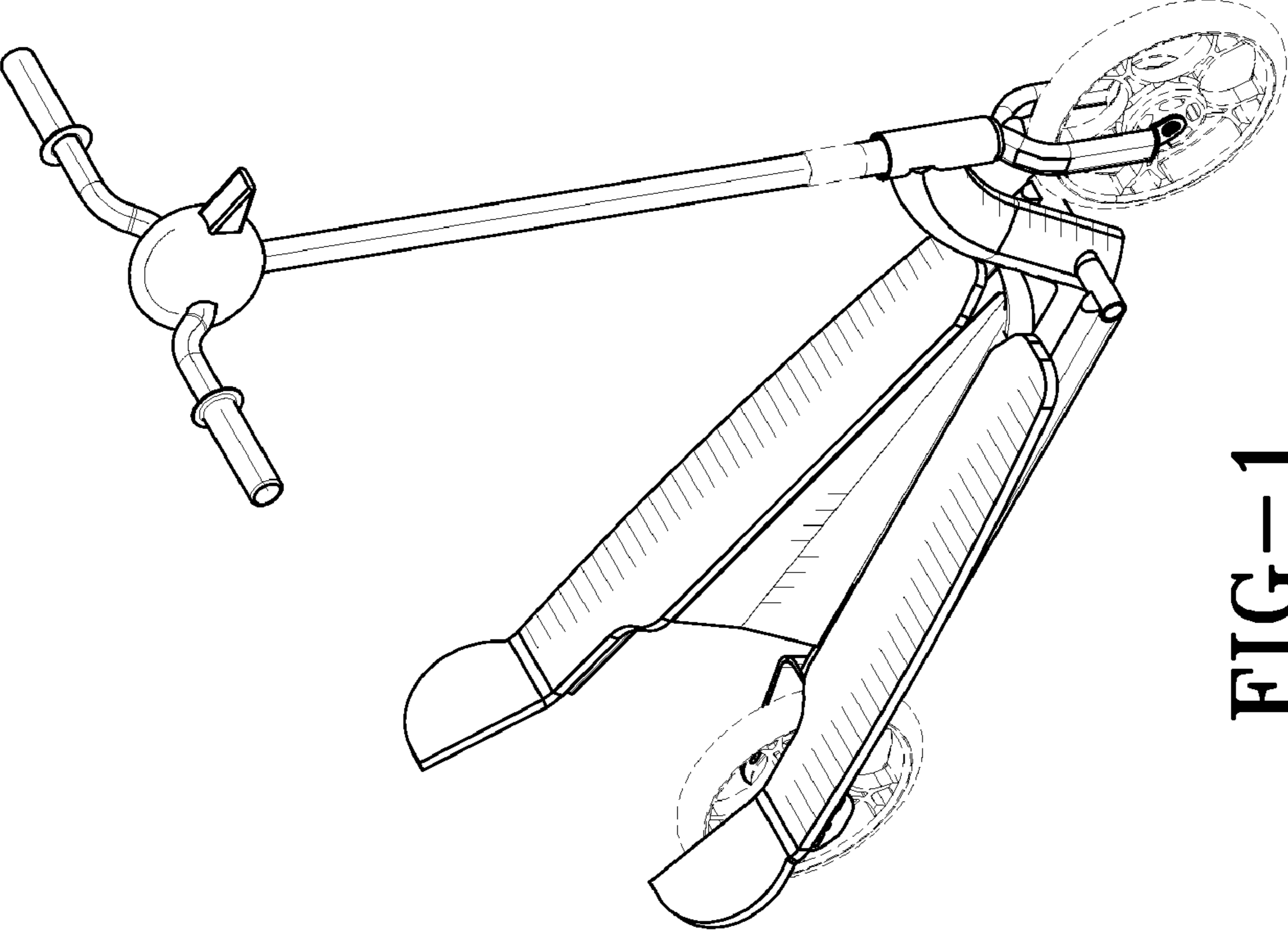

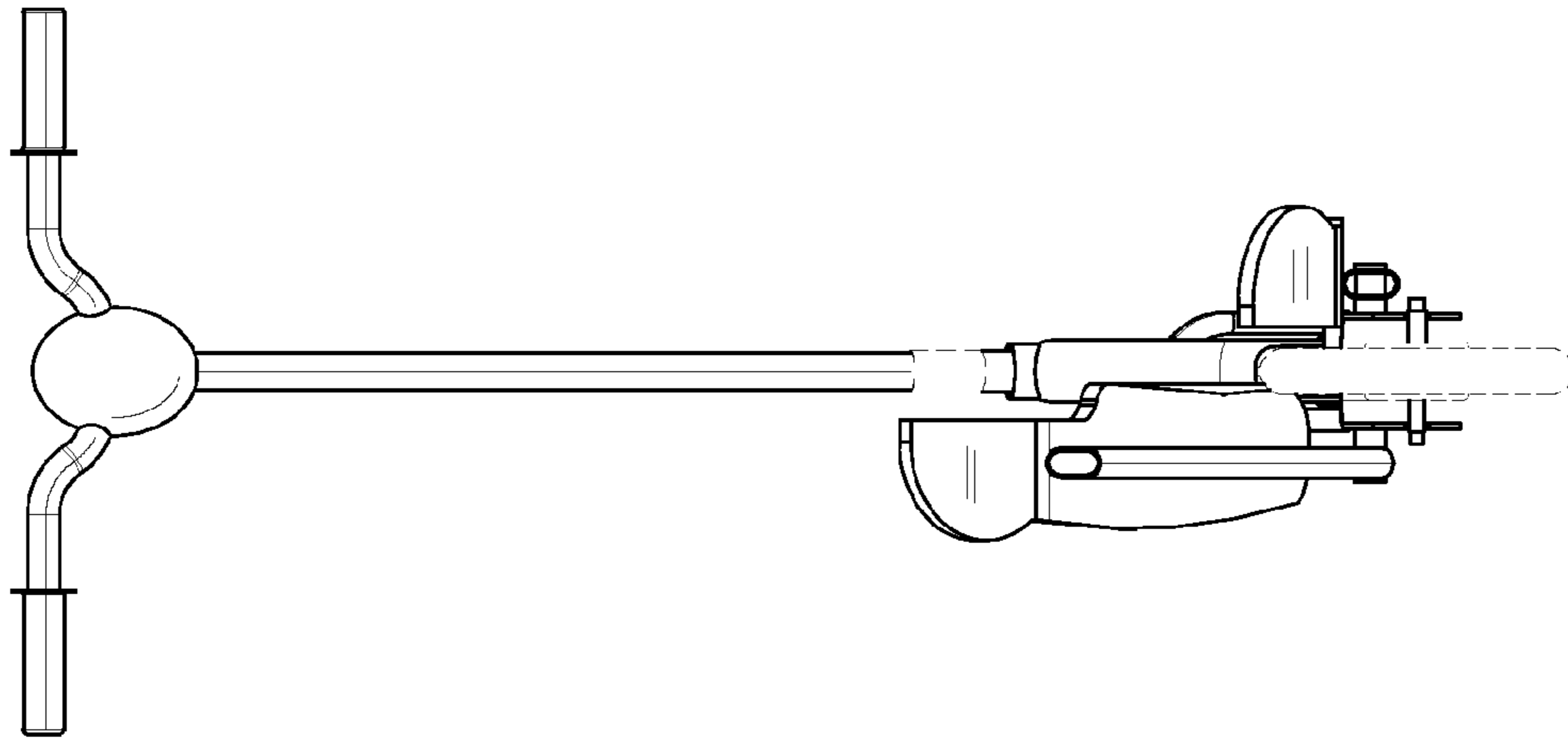

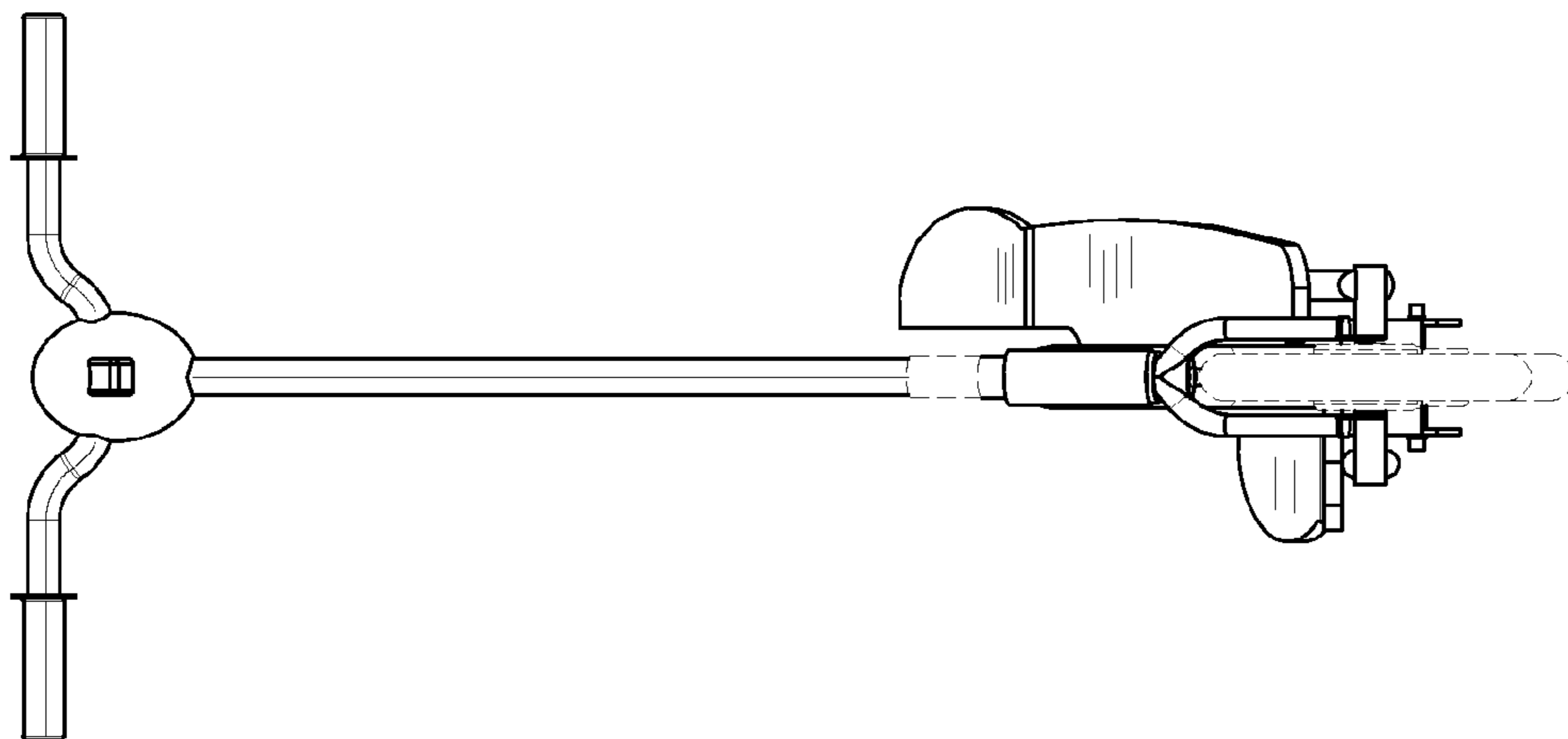

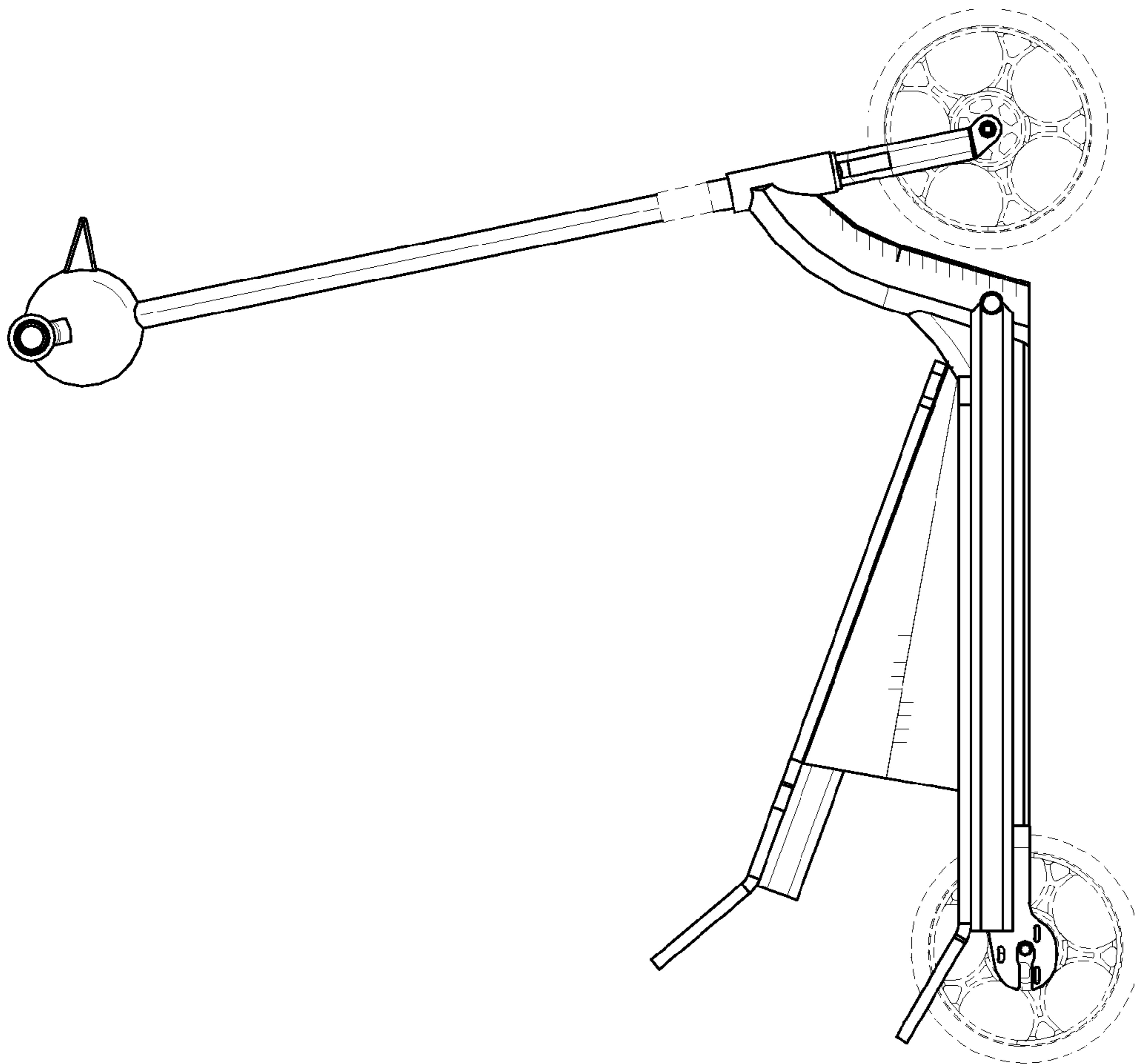

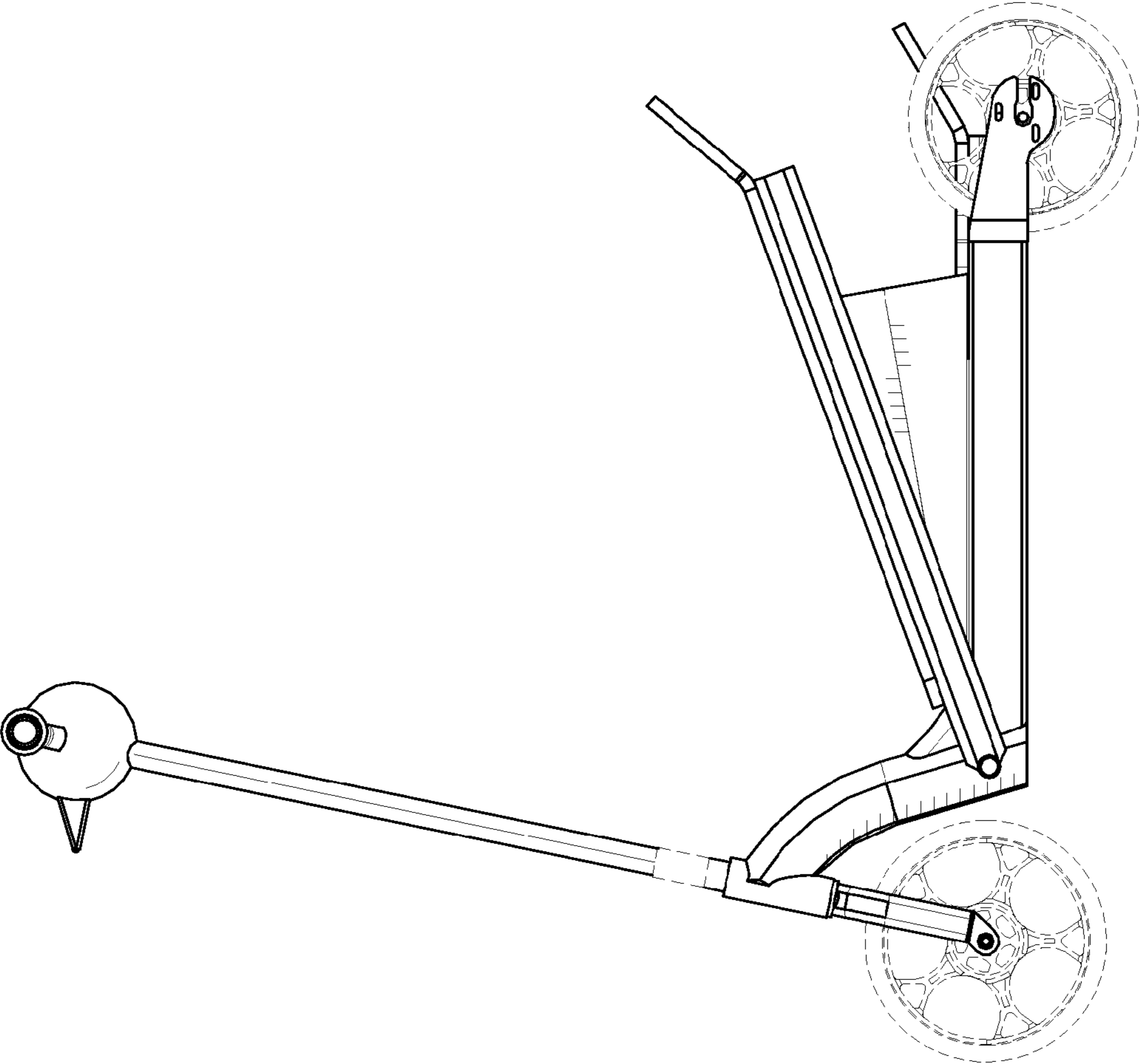

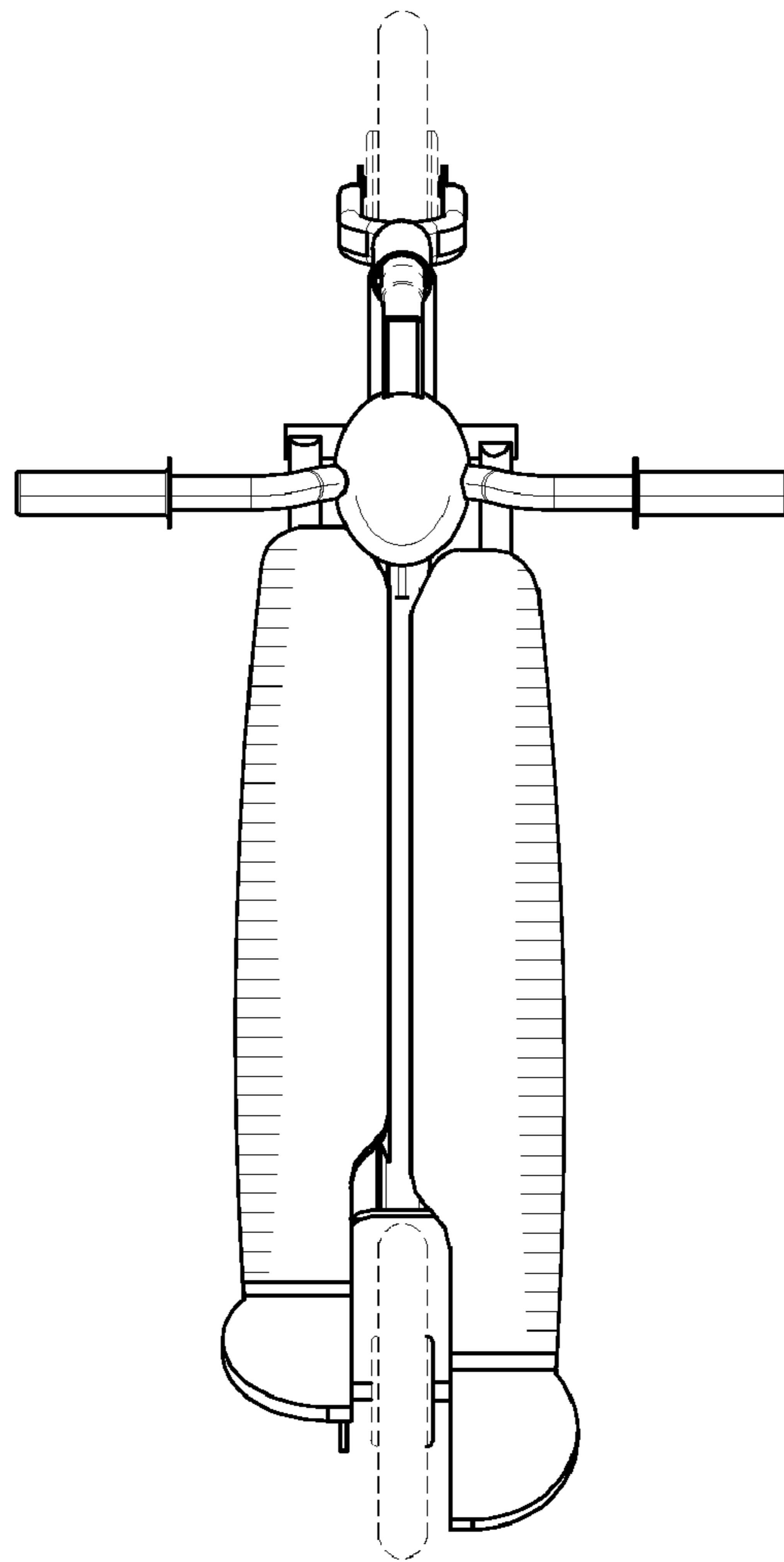

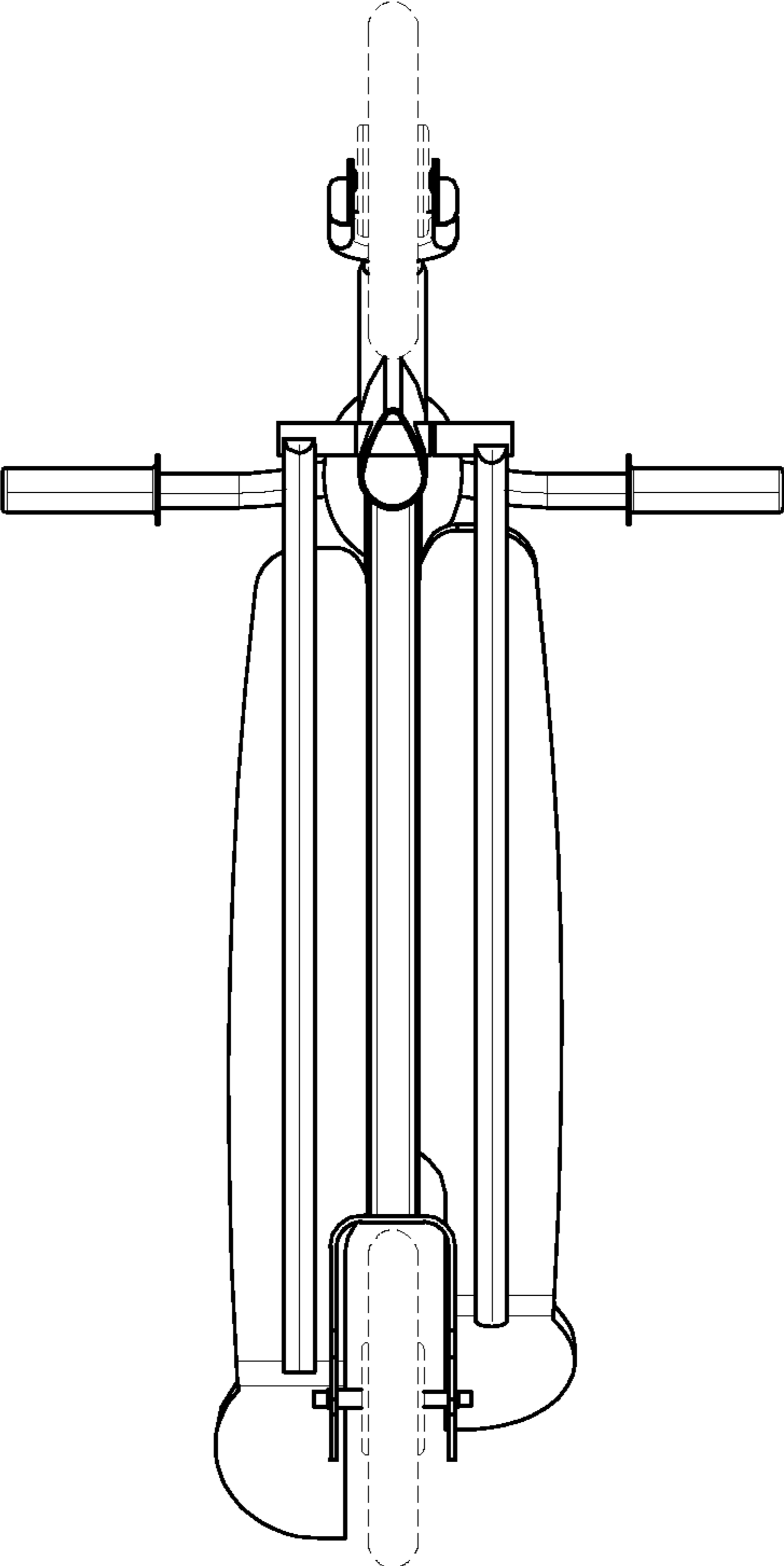
