DESCRIPTION

FIG. 1 is a front perspective view of the cover panel of the furnace showing our new design;

FIG. 2 is a front elevational view of the cover panel;

FIG. 3 is rear elevational view of the cover panel;

FIG. 4 is a right side elevational view of the cover panel;

FIG. 6 is top plan view of the cover panel;

FIG. 11 is a right side elevational view of the cover panel positioned on the furnace;

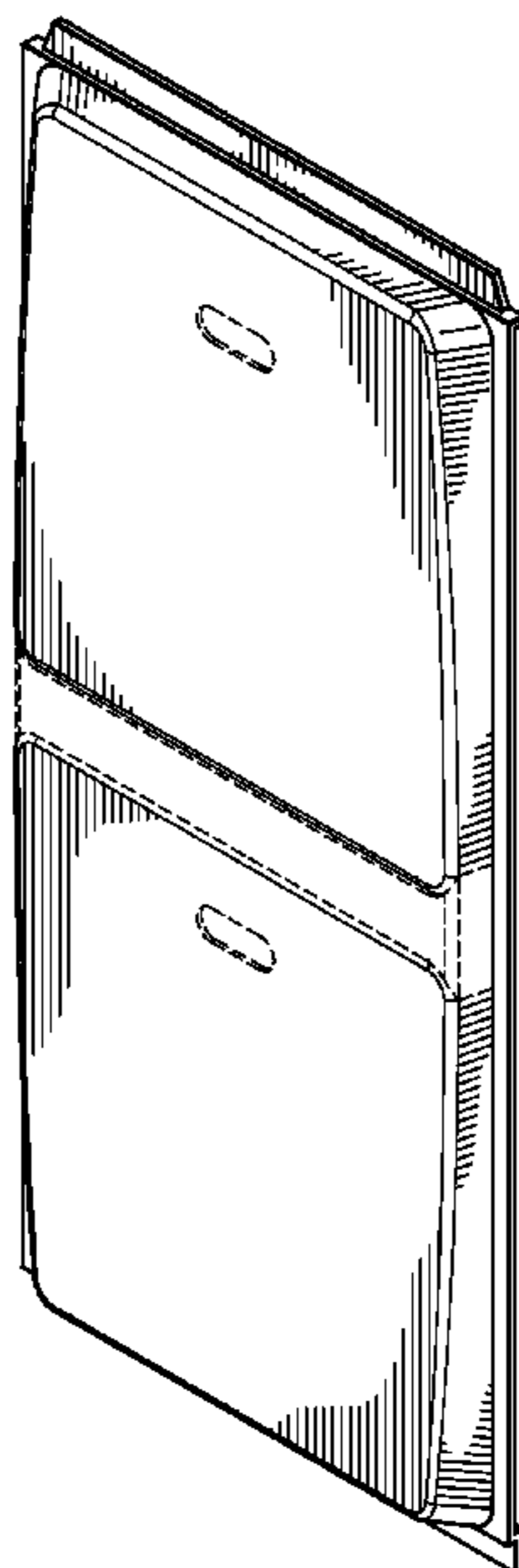
FIG. 12 is a left side elevational view of the cover panel positioned on the furnace;

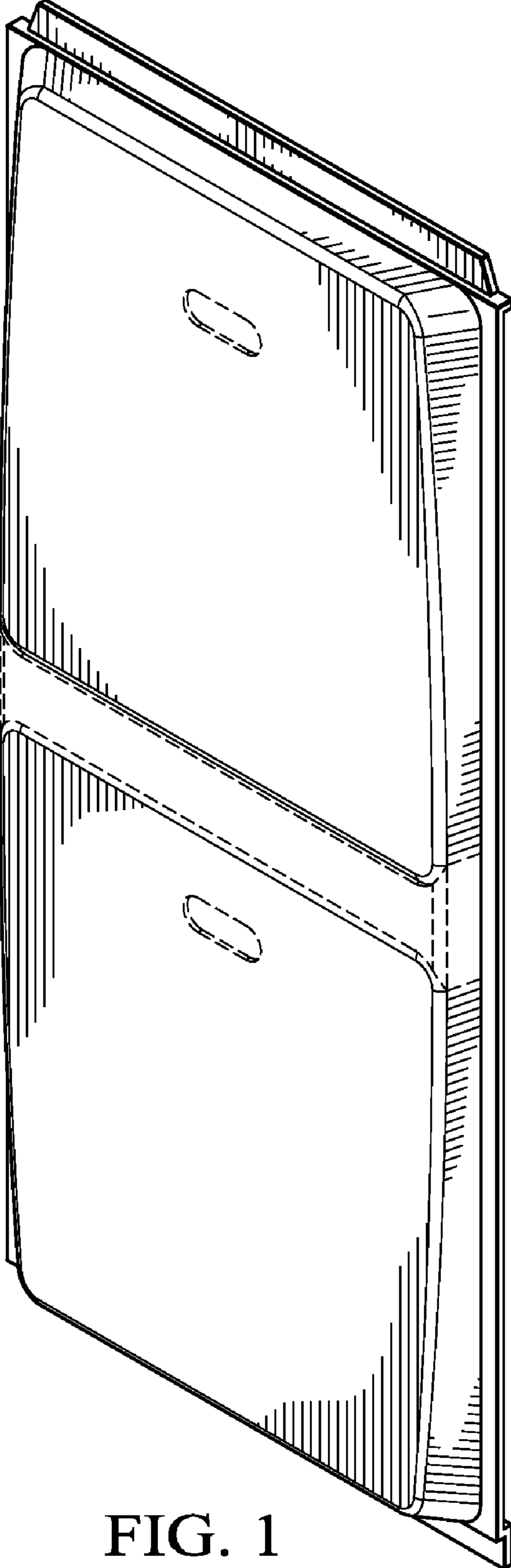

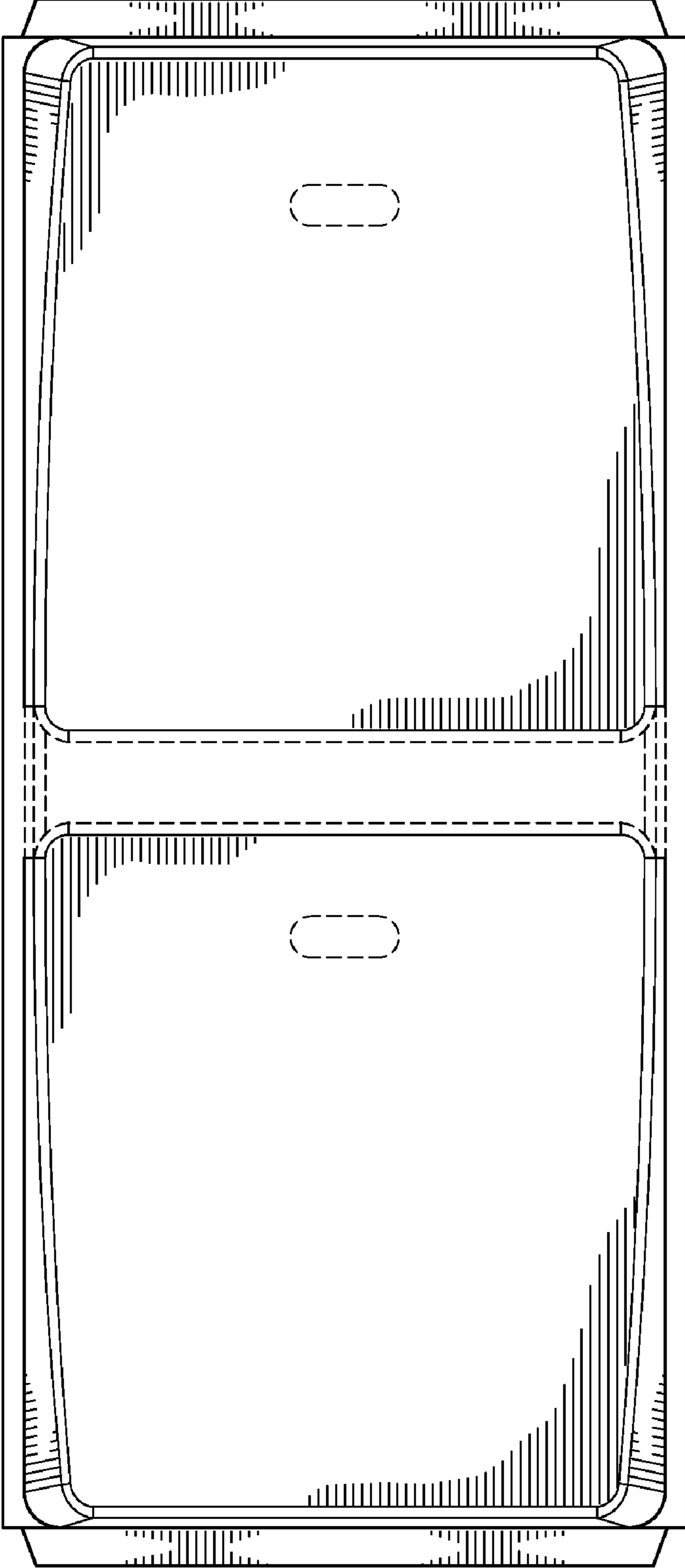

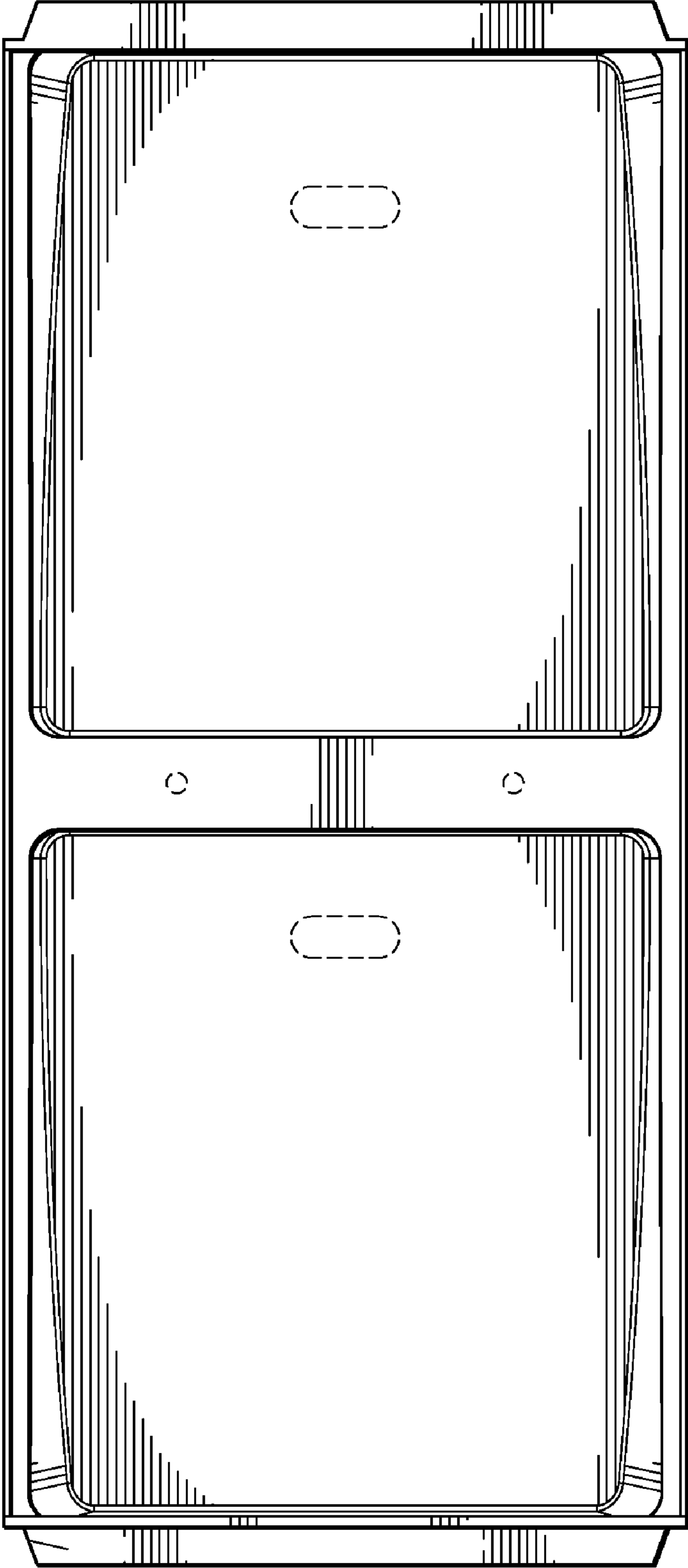

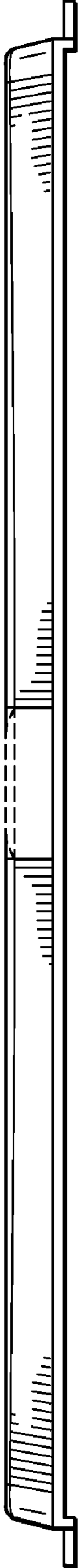

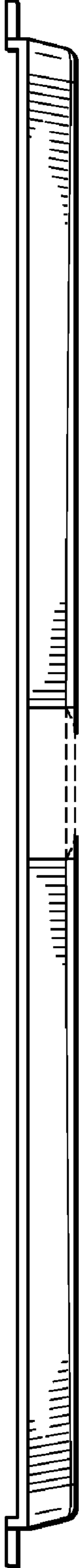

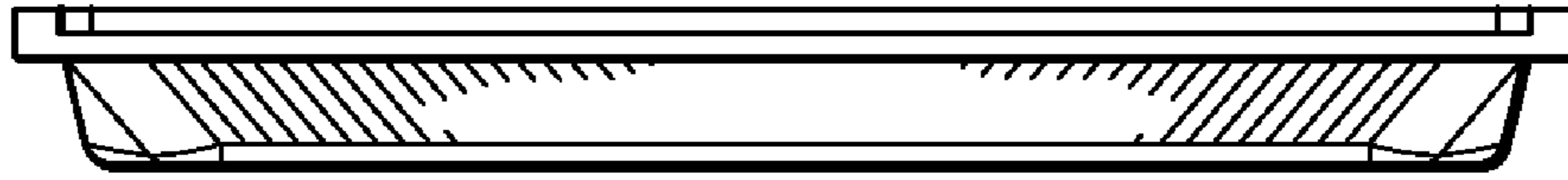

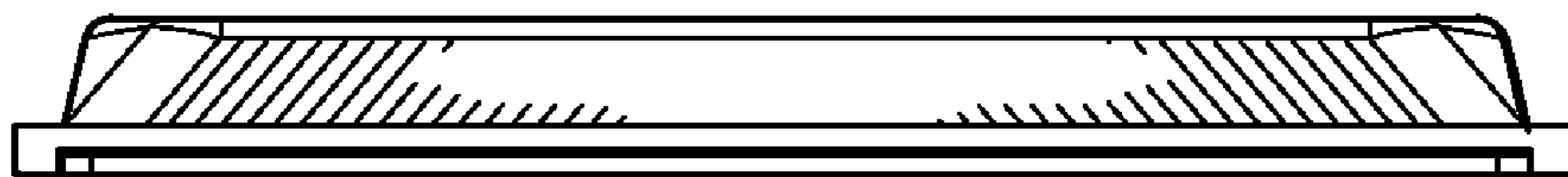

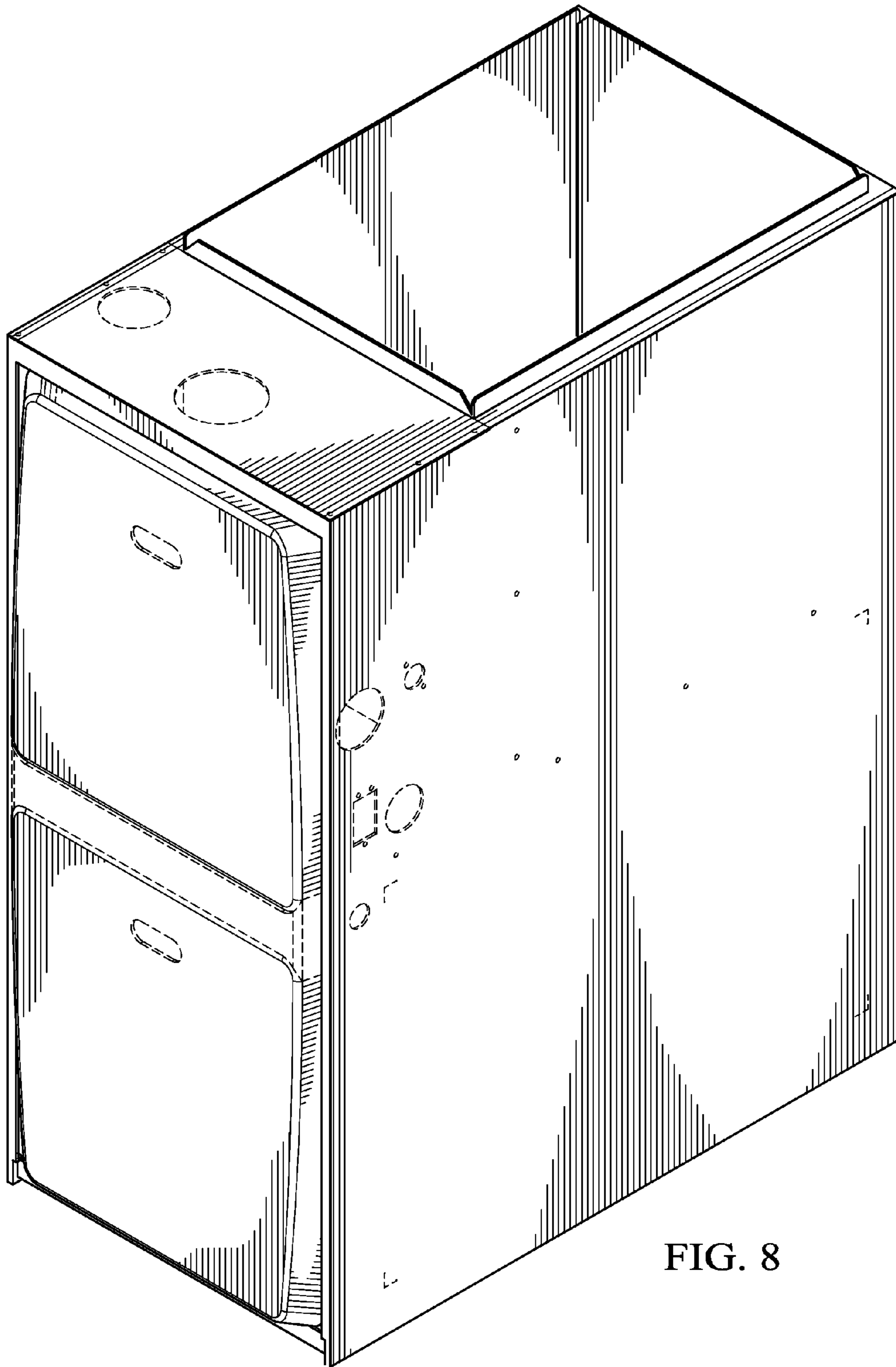

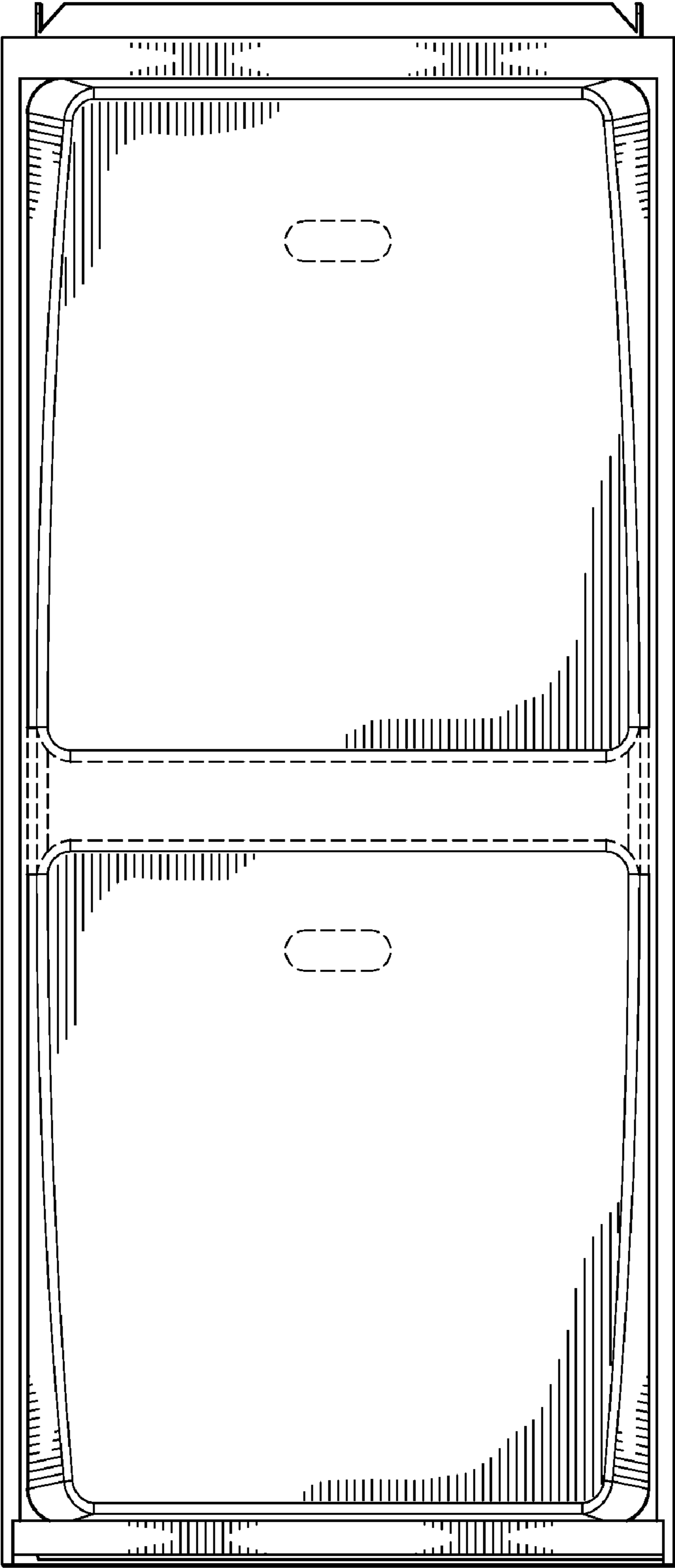

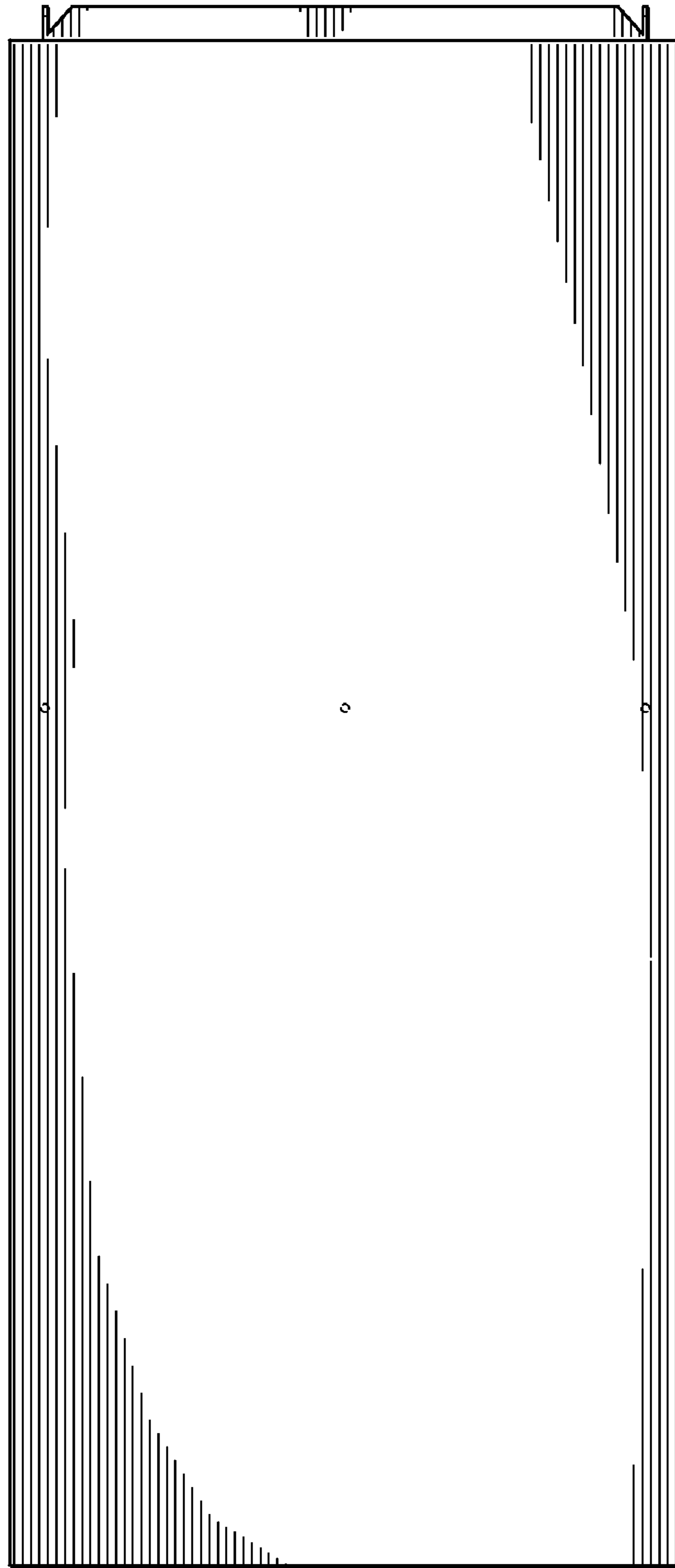

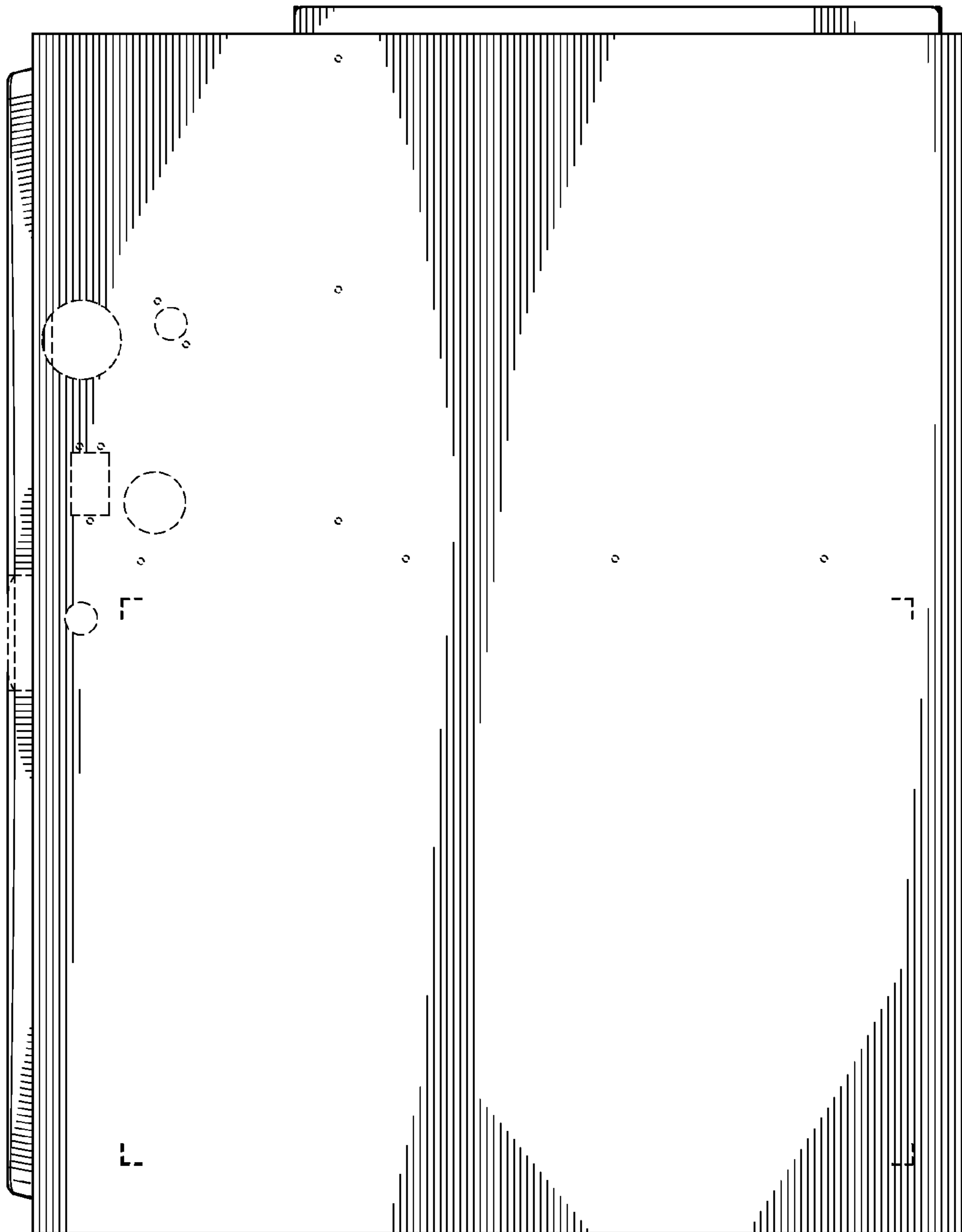

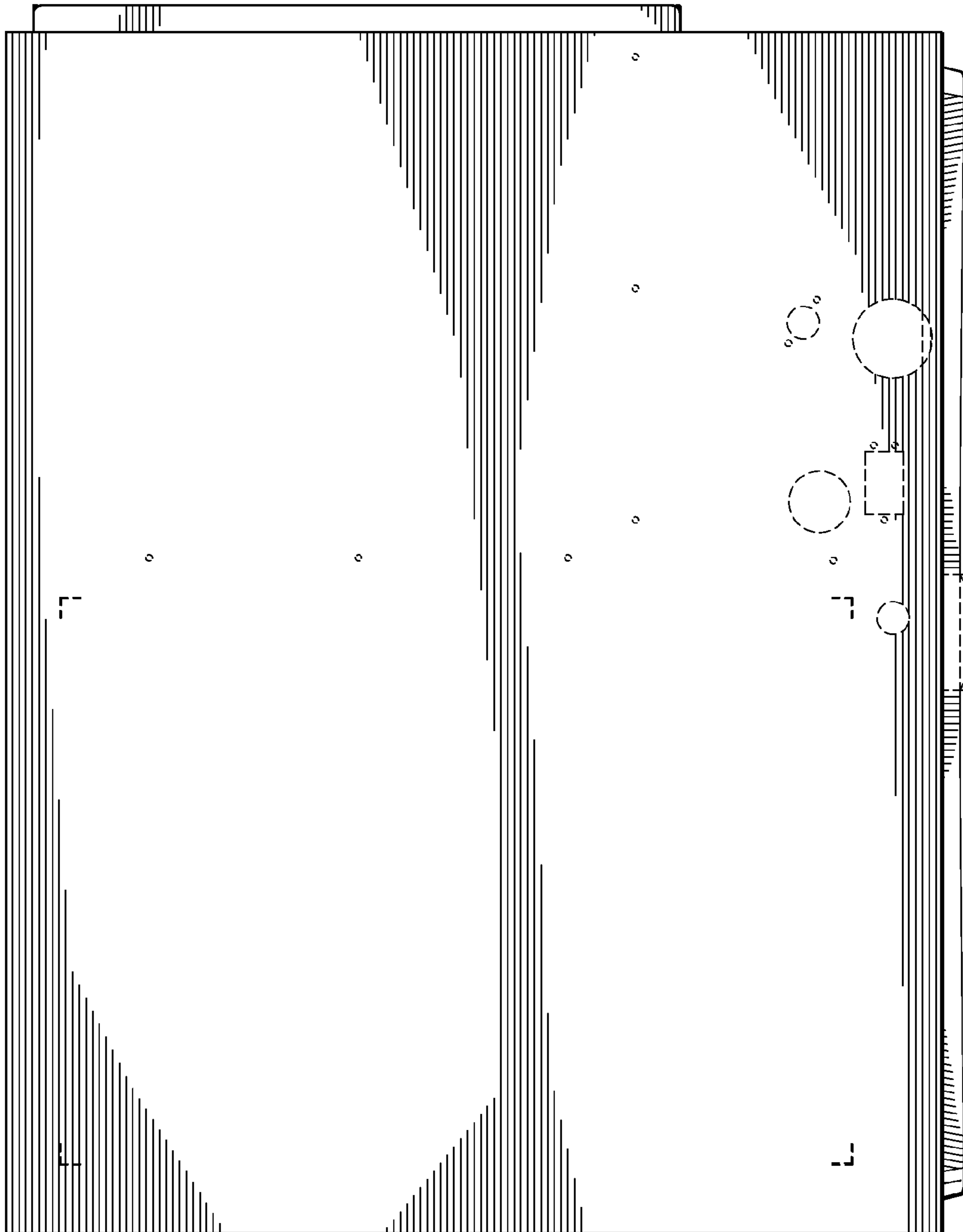

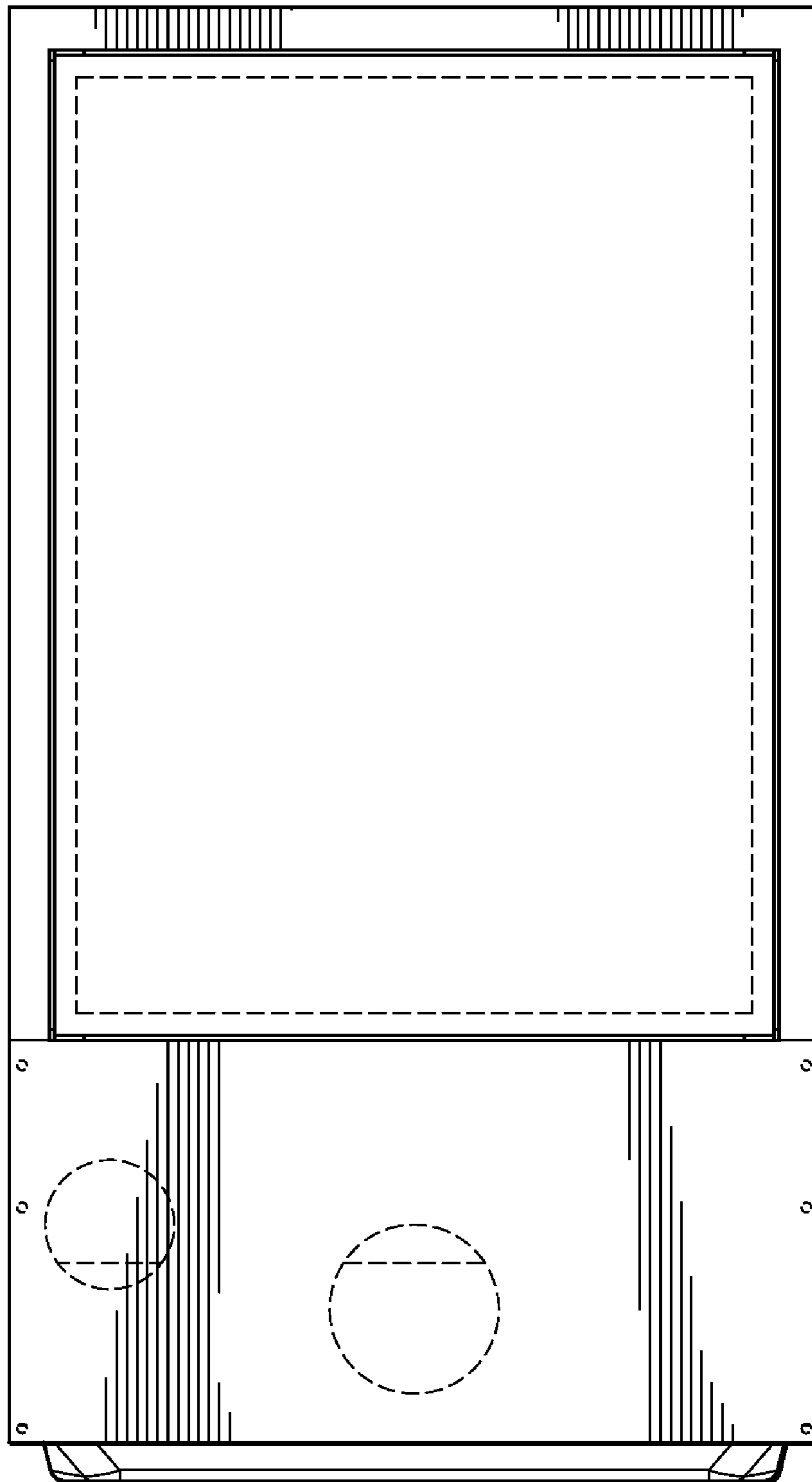

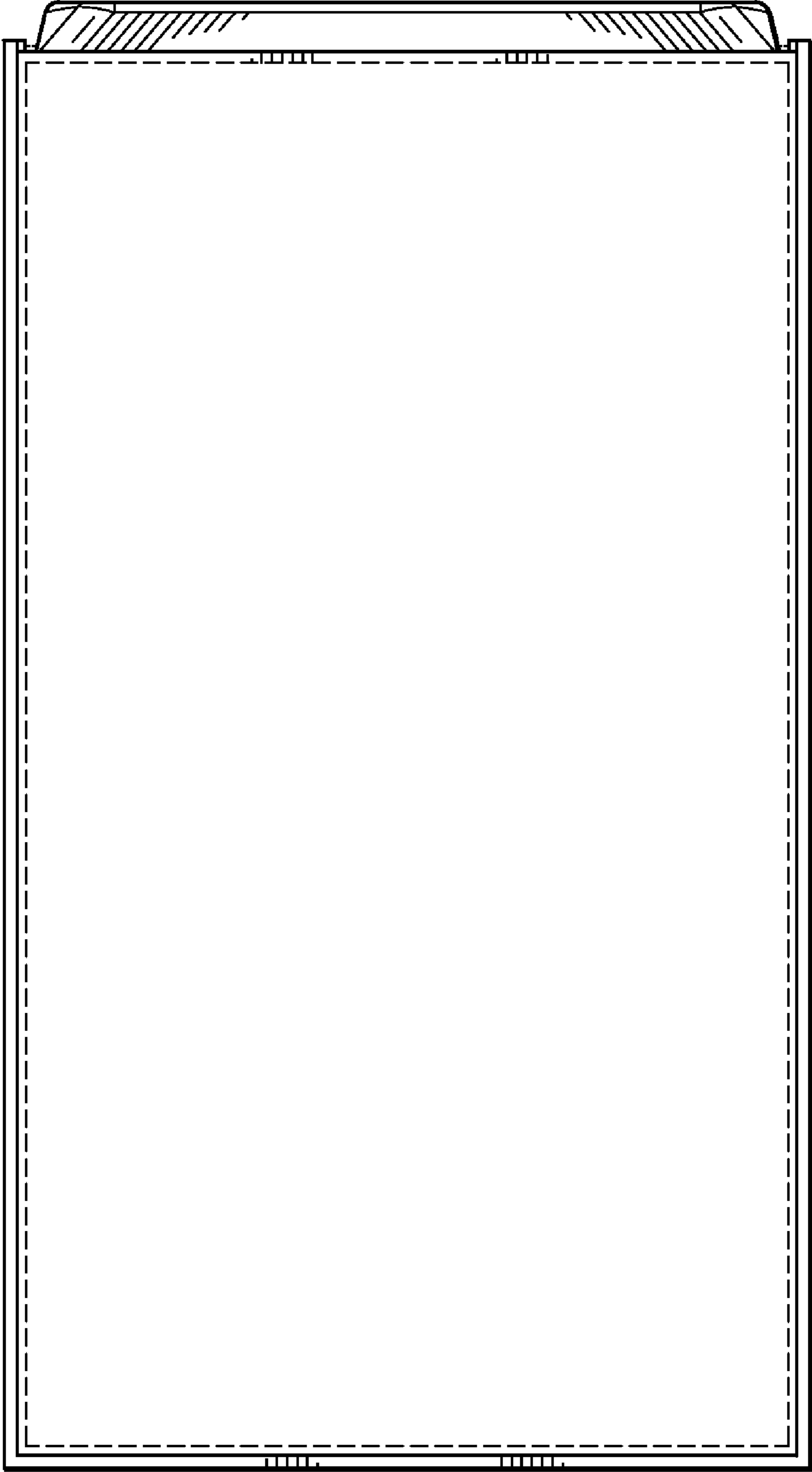
