pattern, showing my new design;

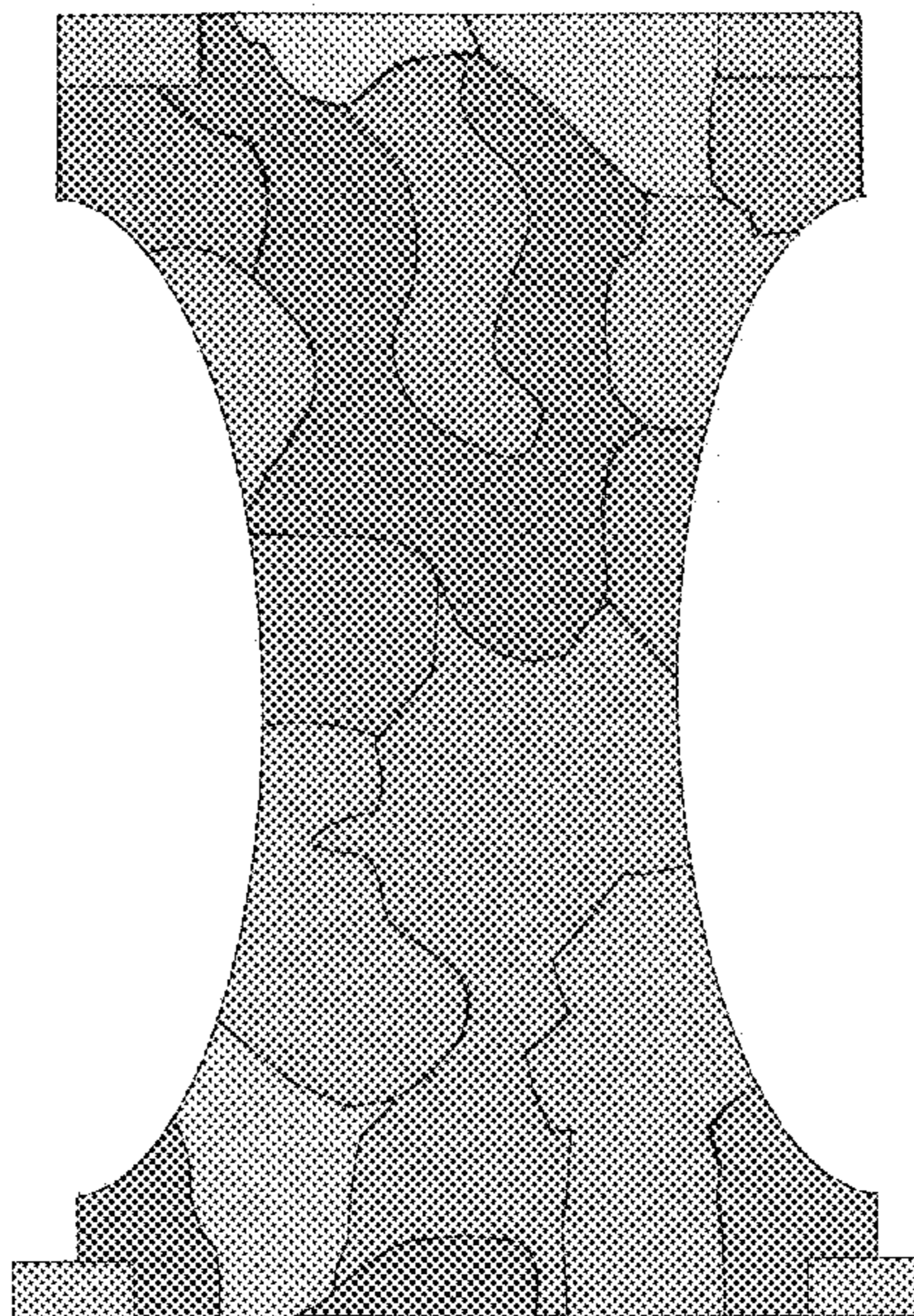
FIG. 2 is a bottom view thereof;

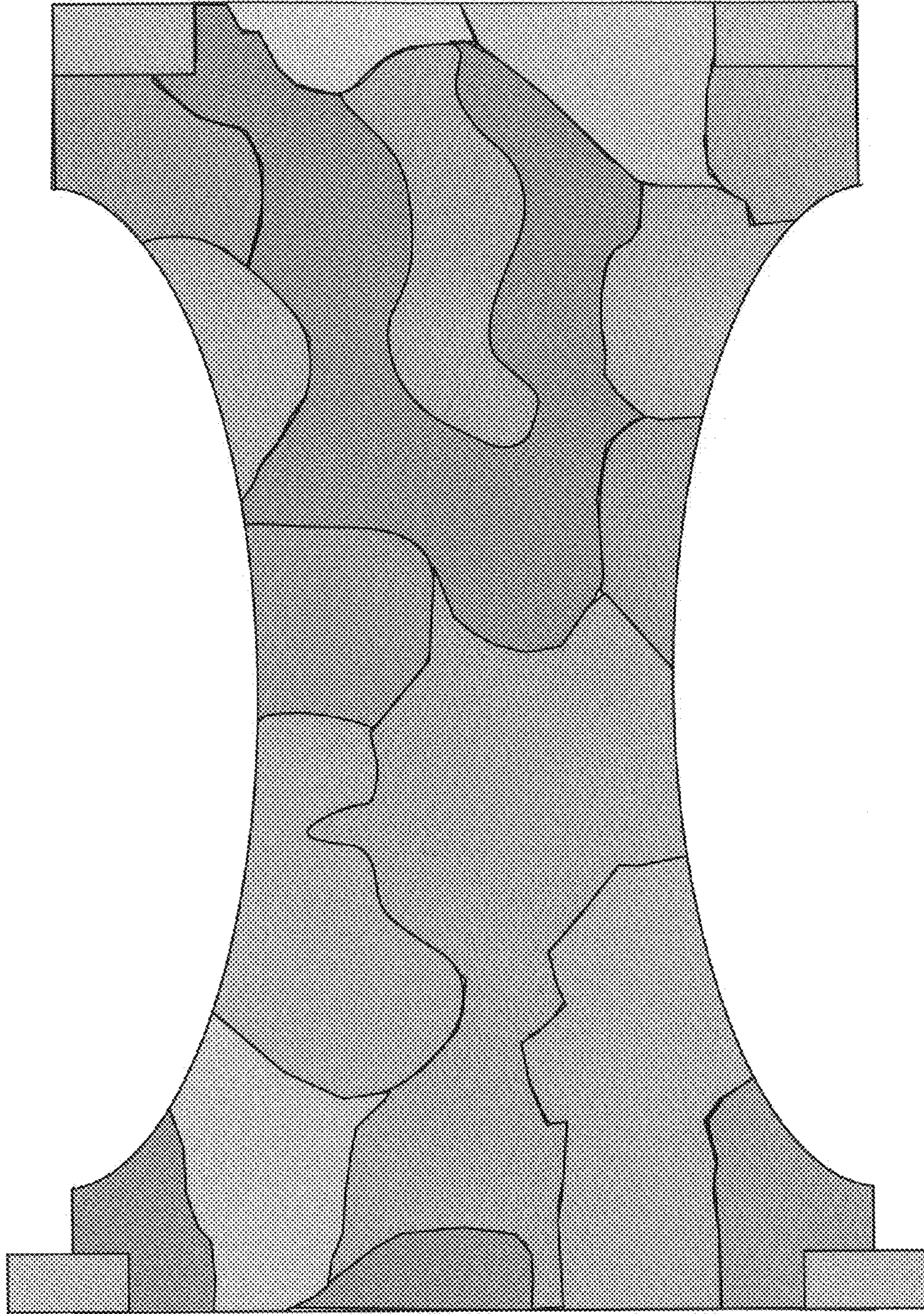

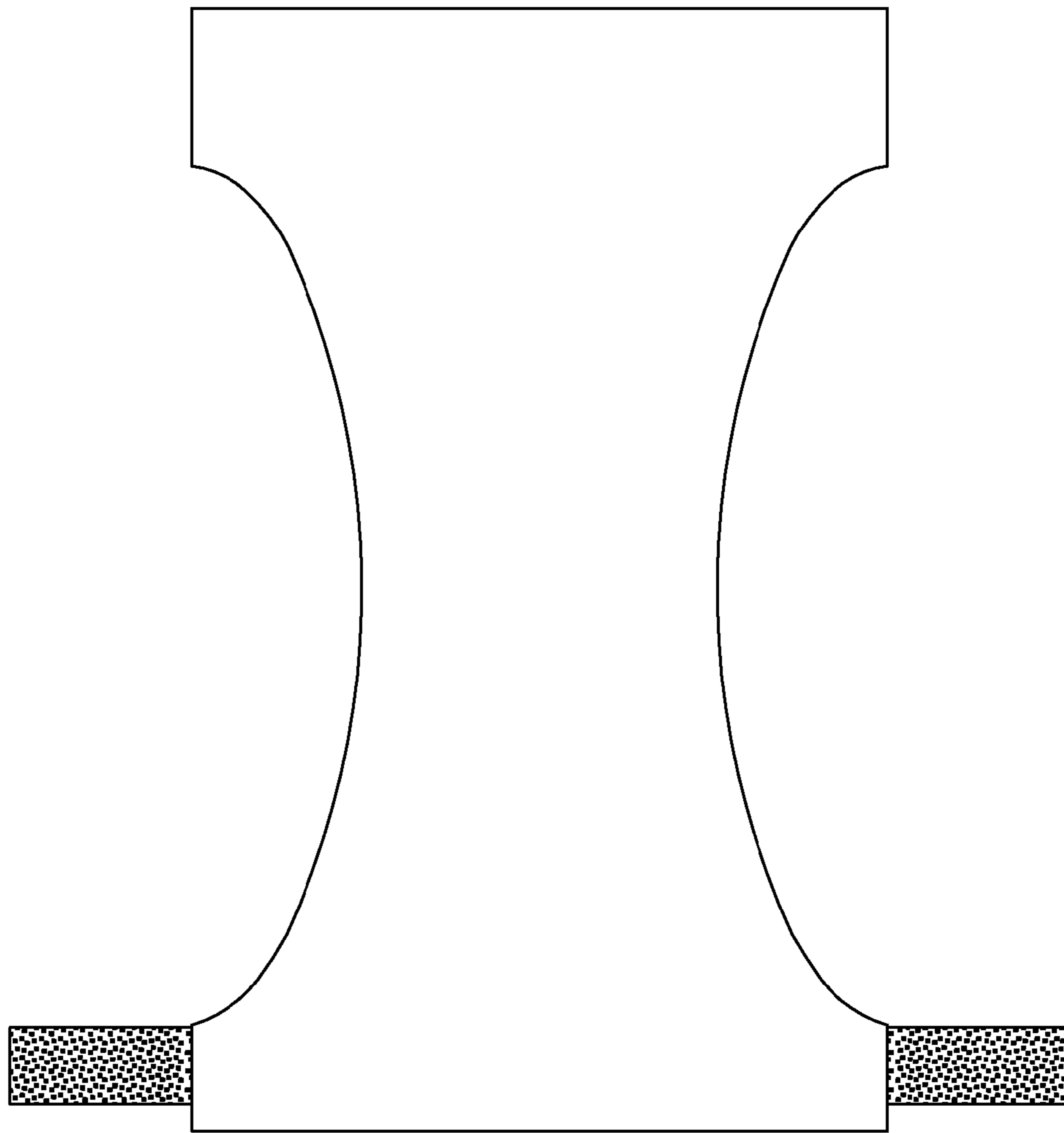

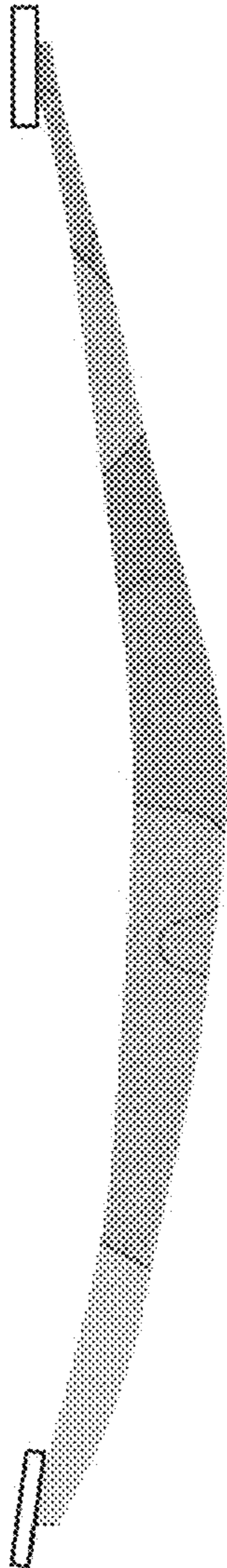

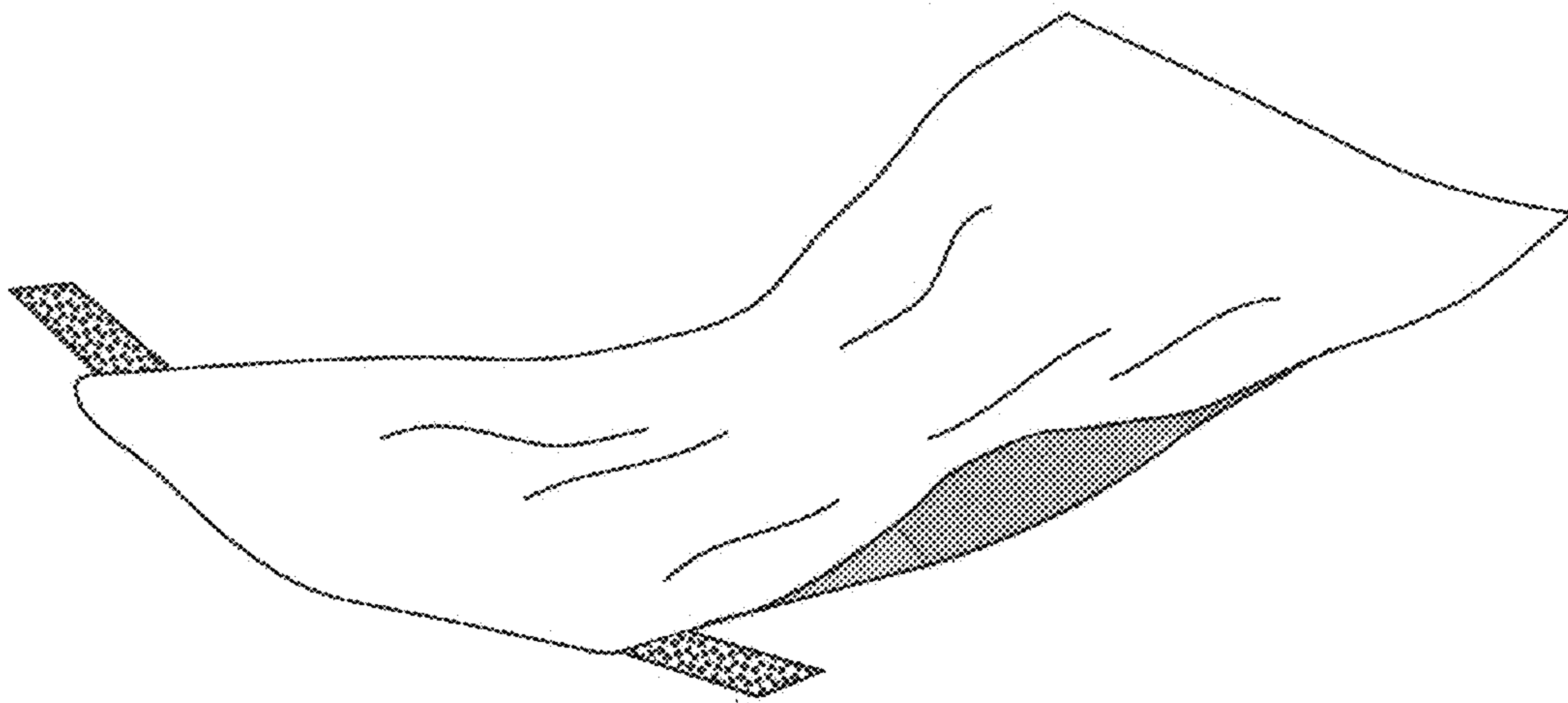
