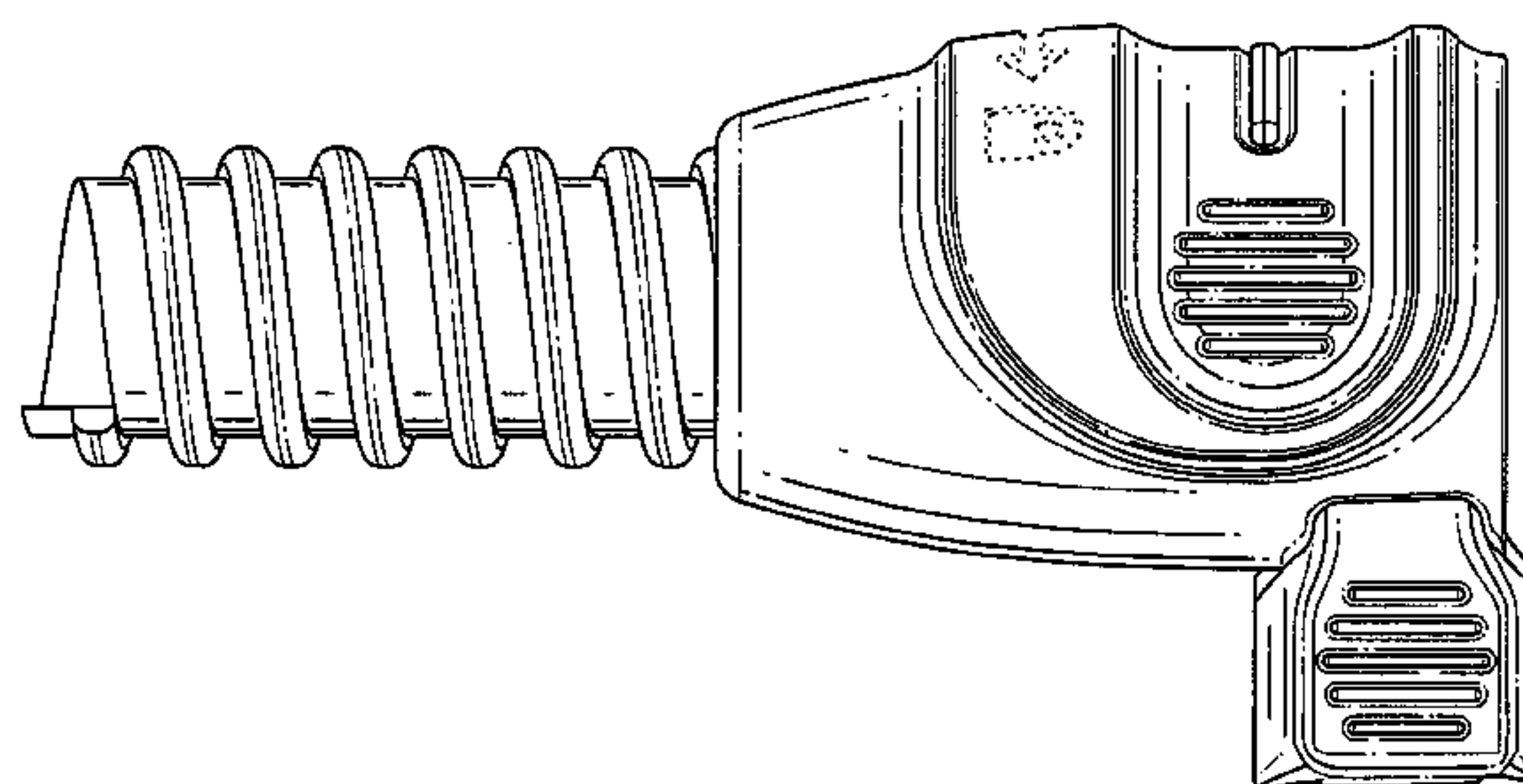
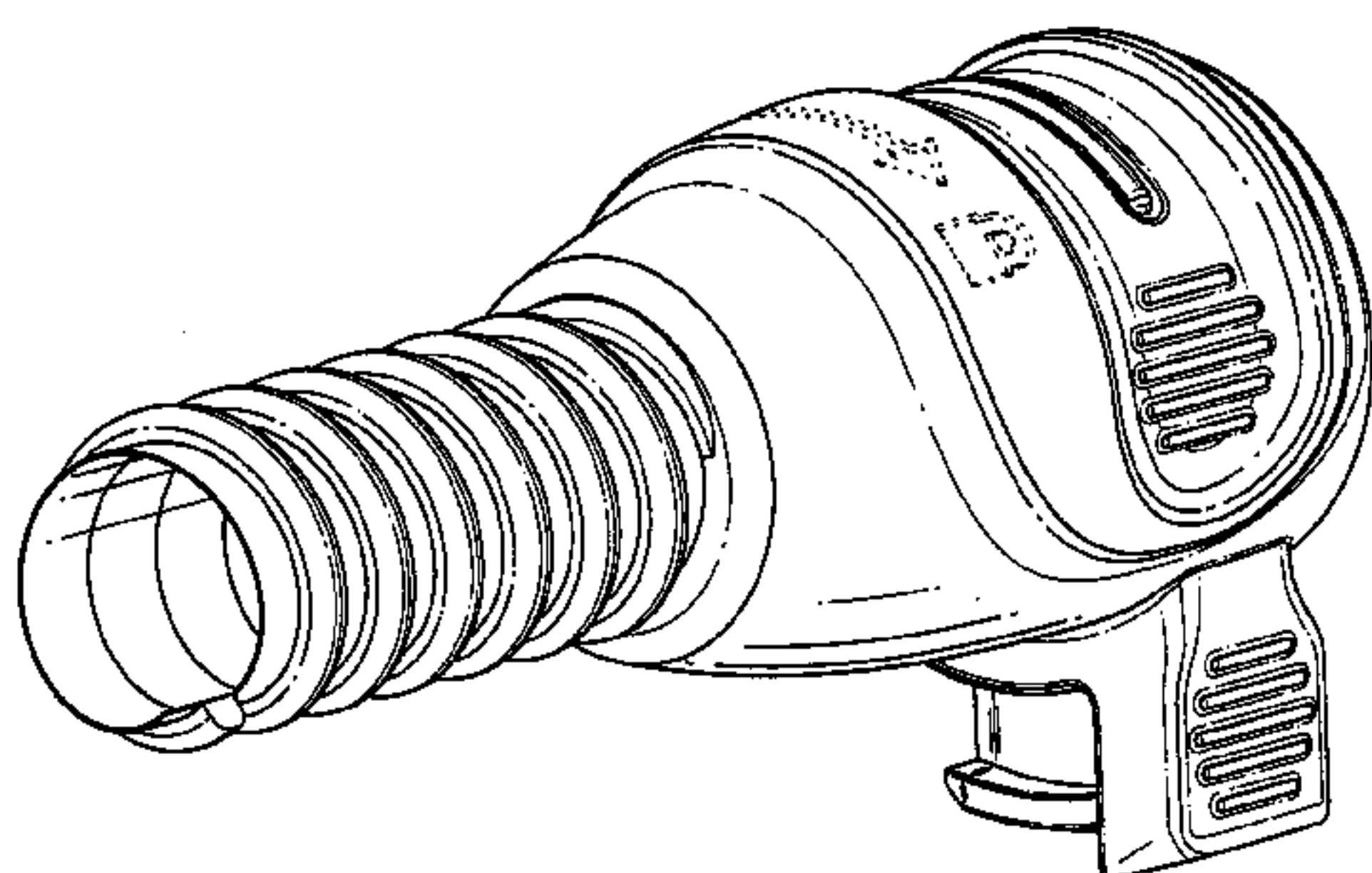
The ornamental design for a cuff with air delivery tube, as shown and described.

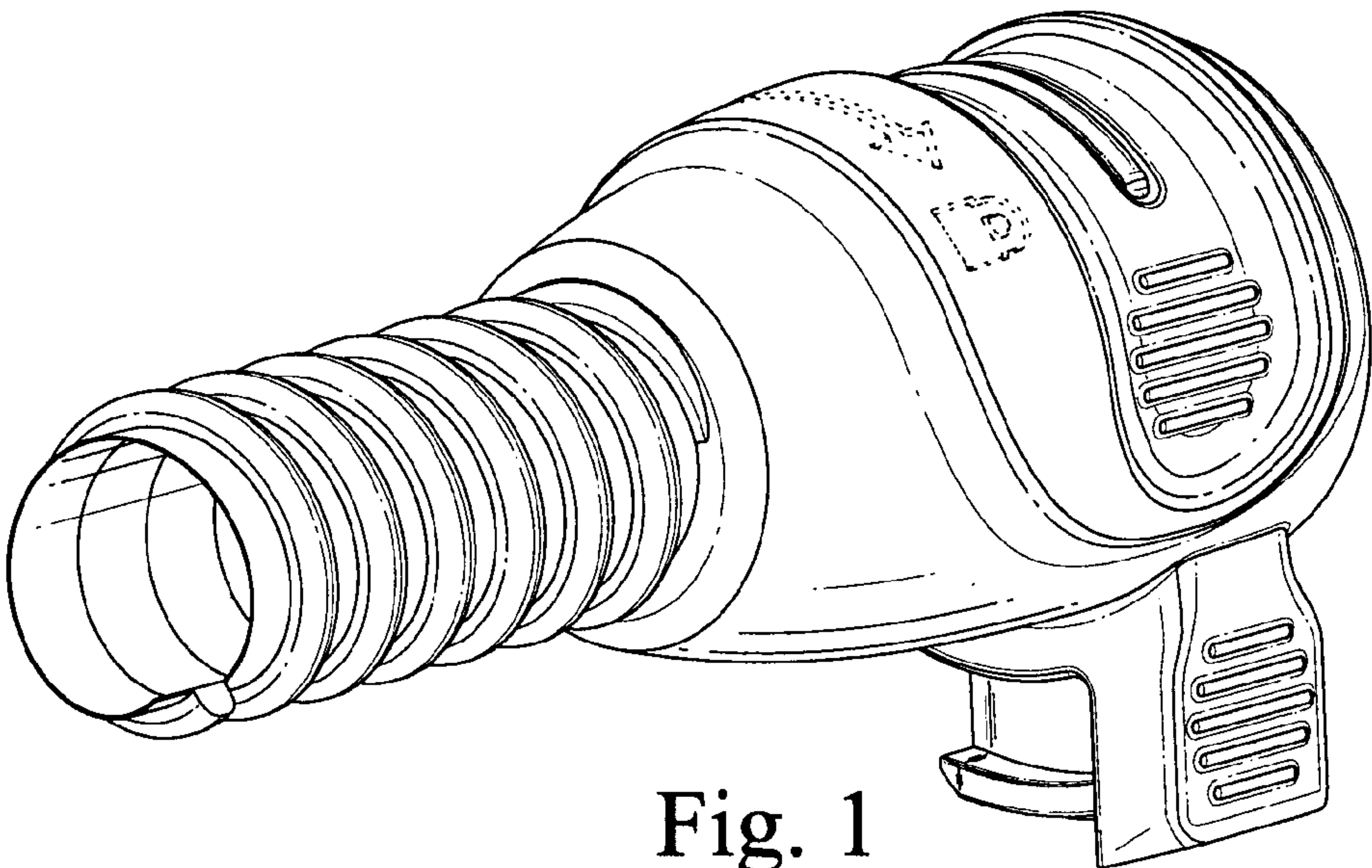

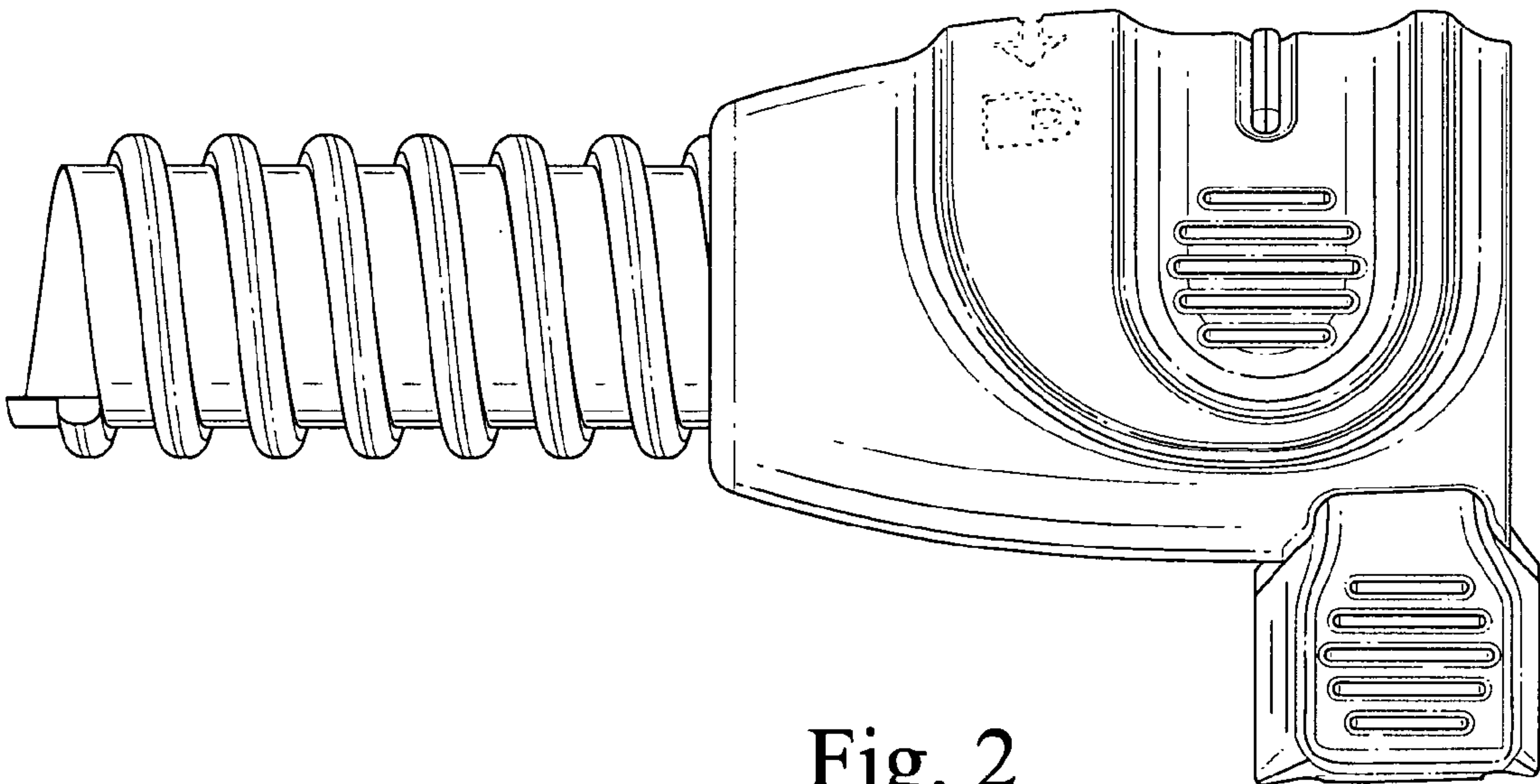
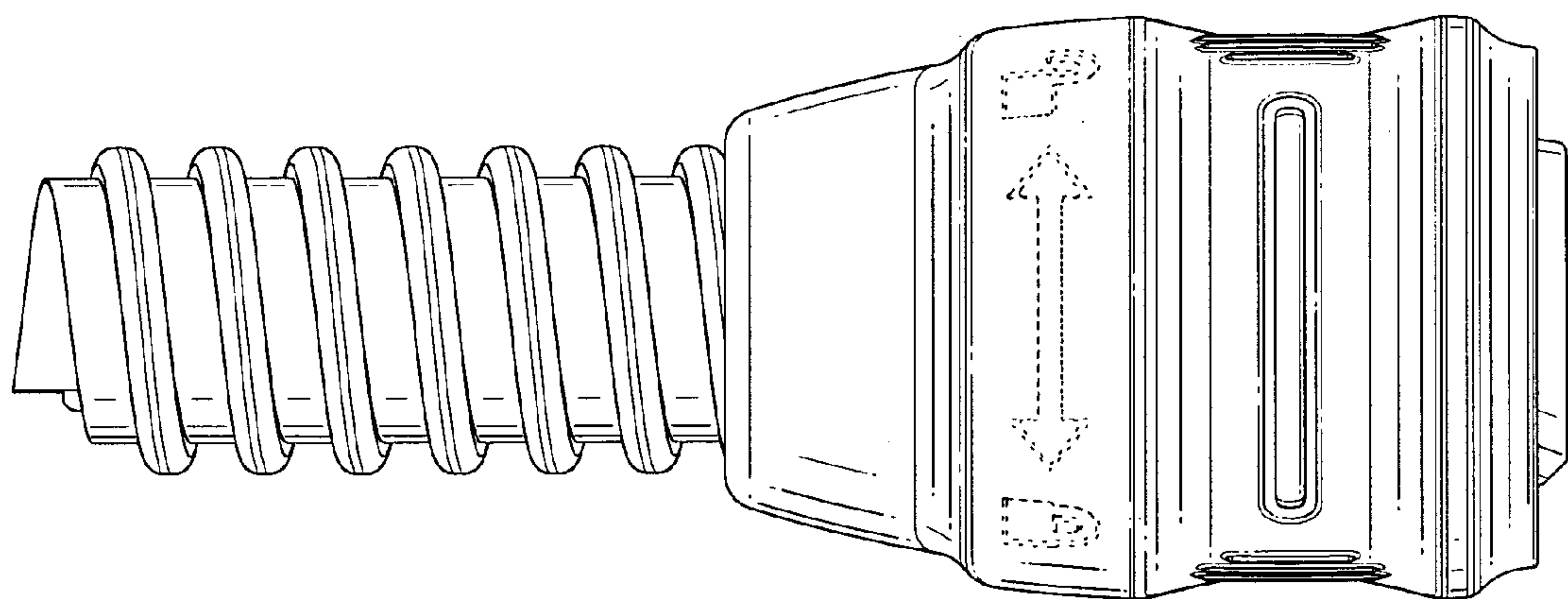
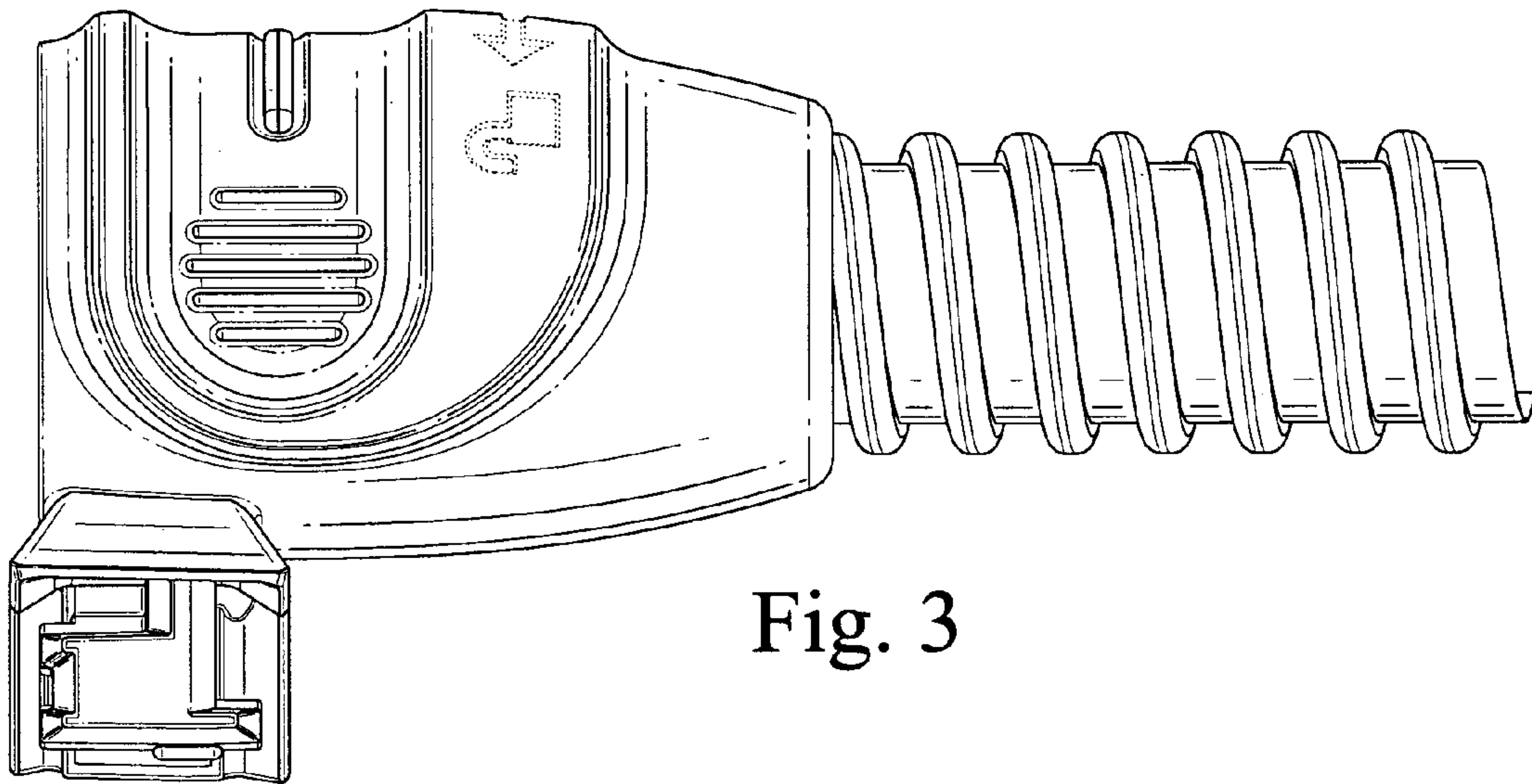

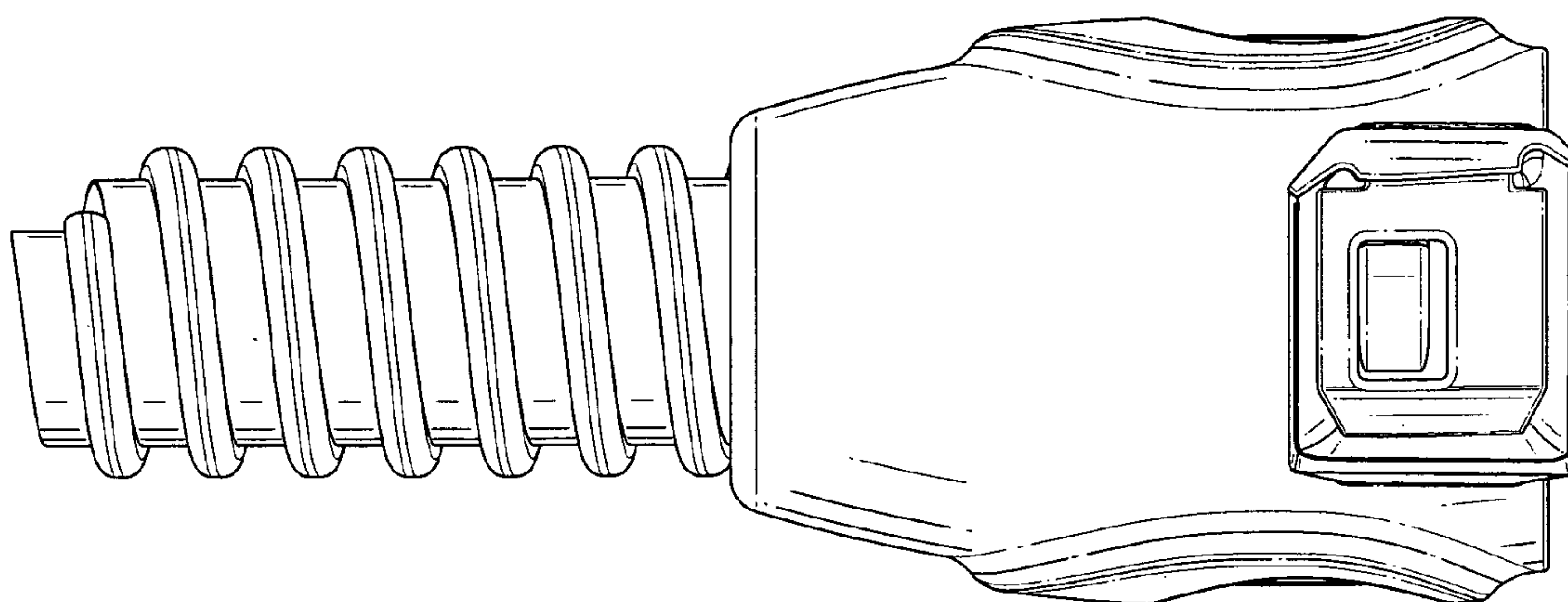

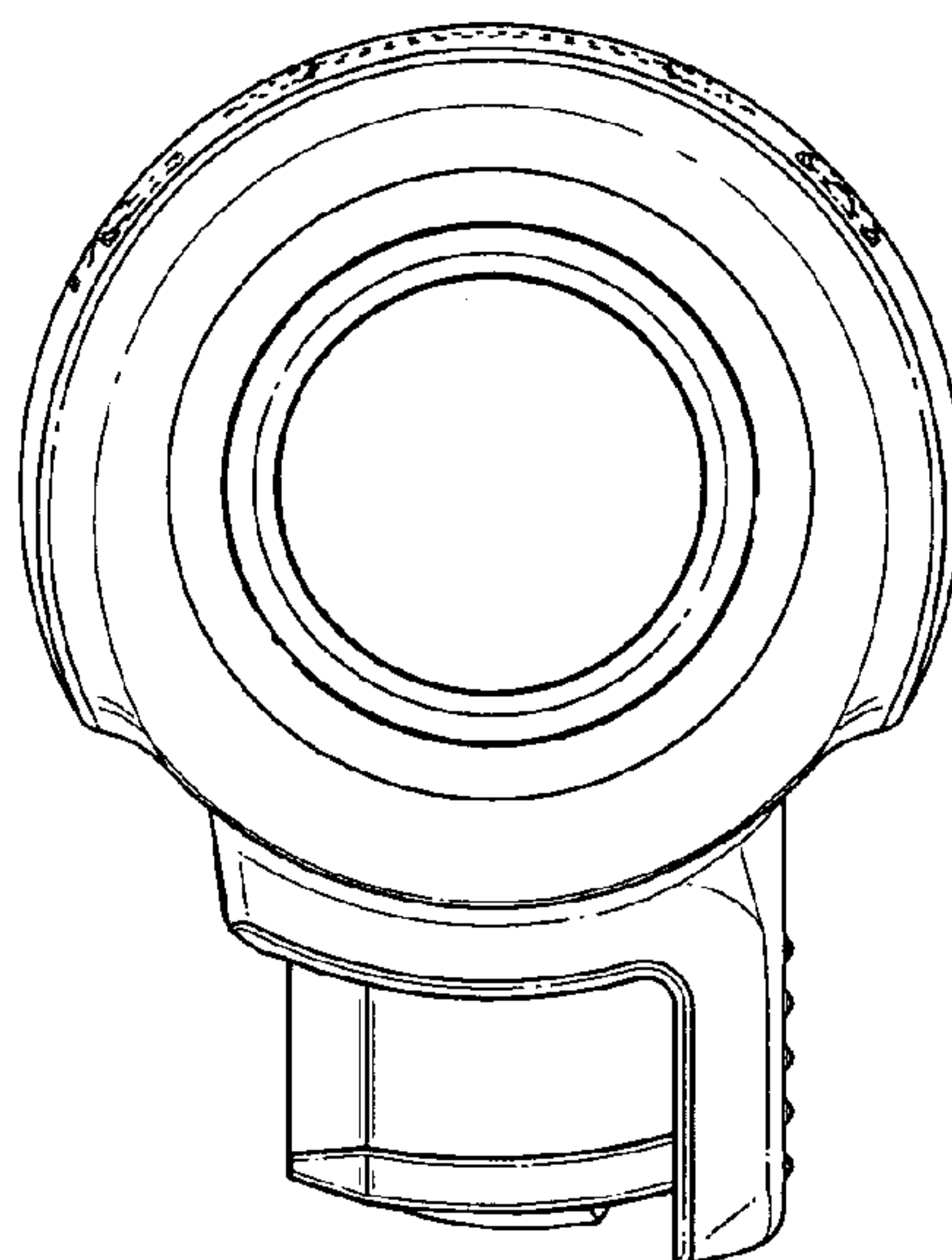

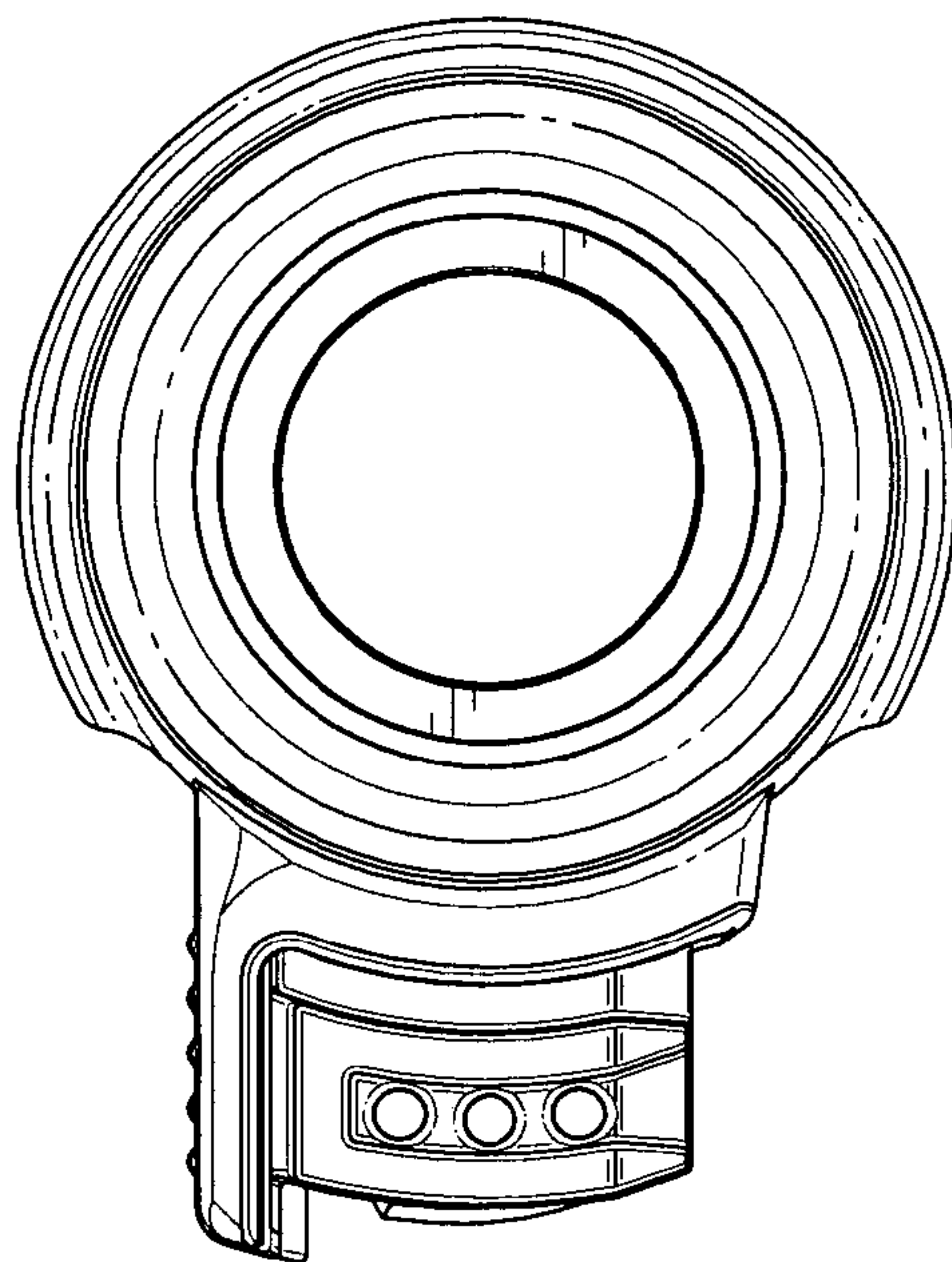

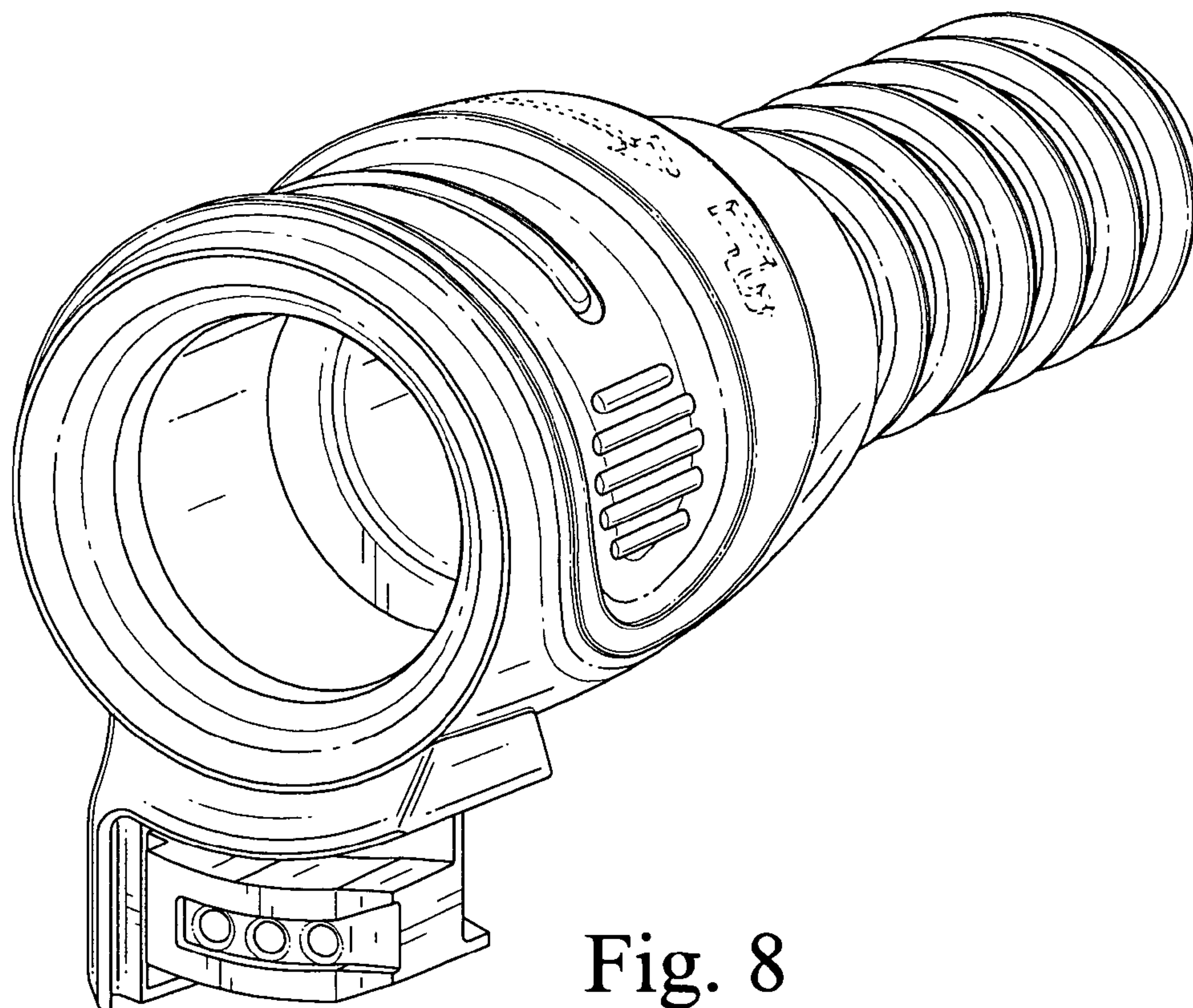
